I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Lesotho perceive the WBG. The survey explored:

- *General Issues Facing Lesotho*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Lesotho*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From March to May 2018, 342 stakeholders of the WBG in Lesotho were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs and community-based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

A total of 175 stakeholders participated in the survey (51% response rate). Respondents received the questionnaires via courier or completed the questionnaires with a representative from the local fielding agency.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

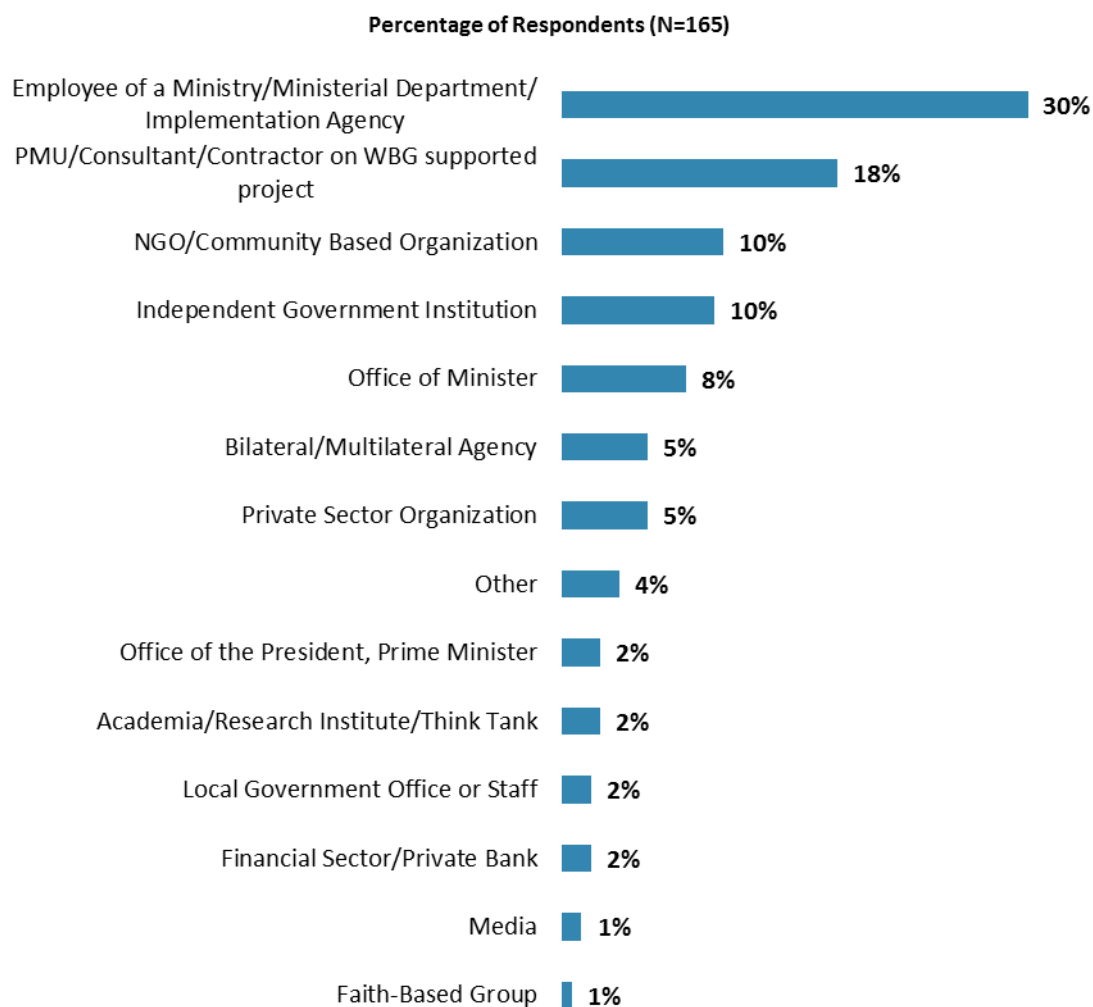
The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'14 (response rate was 75%, N=106). Data were weighted to reach the same stakeholder composition in both years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'14 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 86).



III. Demographics of the Sample

Current Position

- For further analyses, respondents from the Office of the President, Prime Minister and the office of a minister were combined; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/community-based organizations and faith-based groups were combined in the “CSO” category; and the small number of respondents from local government, the media, and academia/research institute/think tank were included in the “Other” category. There were no respondents from the office of a parliamentarian, private foundations, trade unions, youth groups, and the judiciary branch.

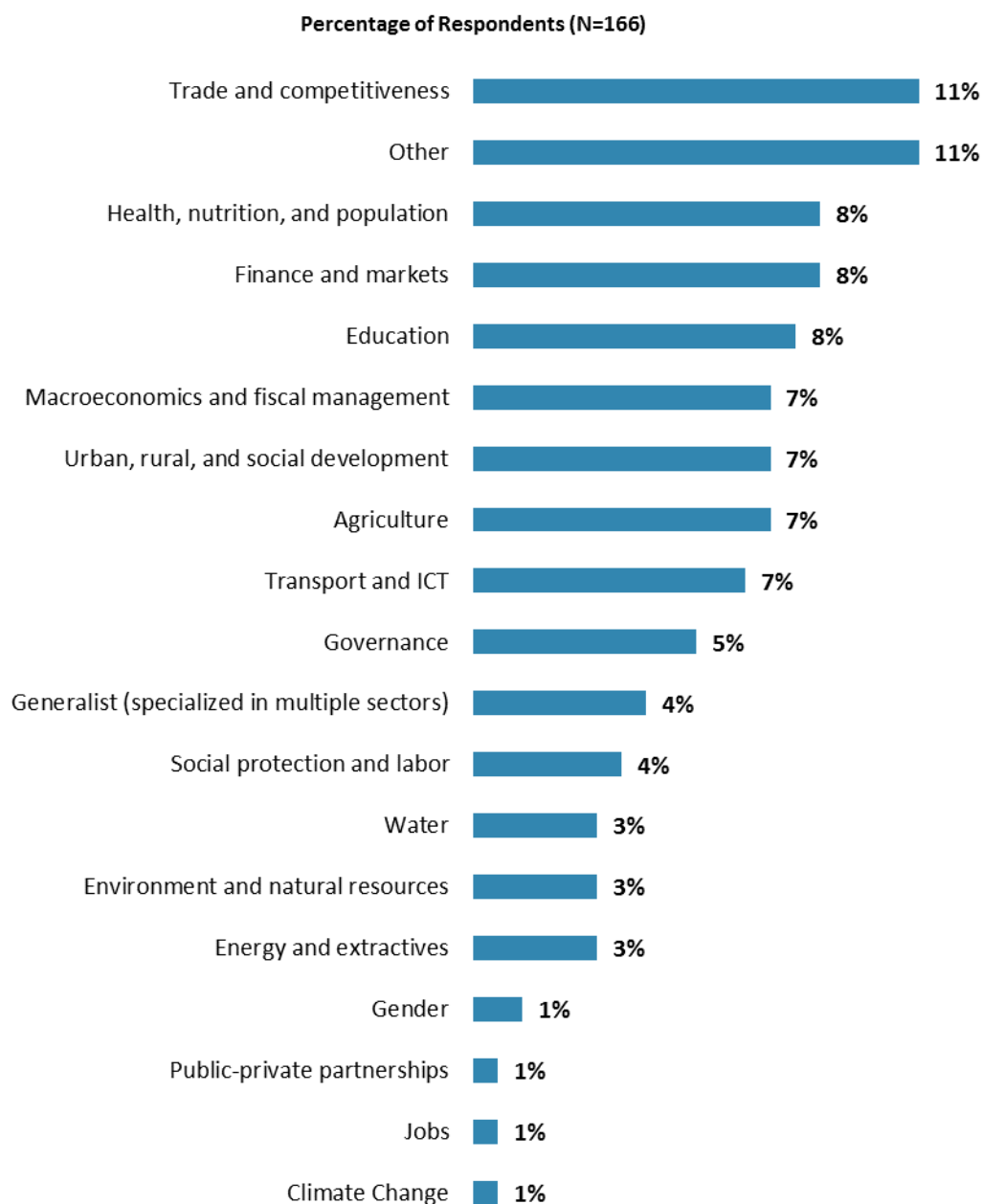


“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization

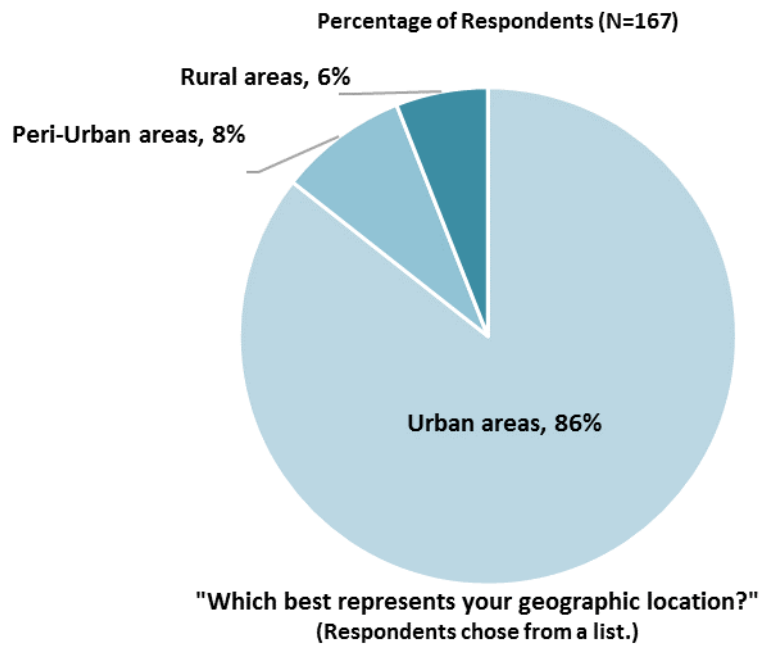


"Please identify the primary specialization of your work." (Respondents chose from a list.)

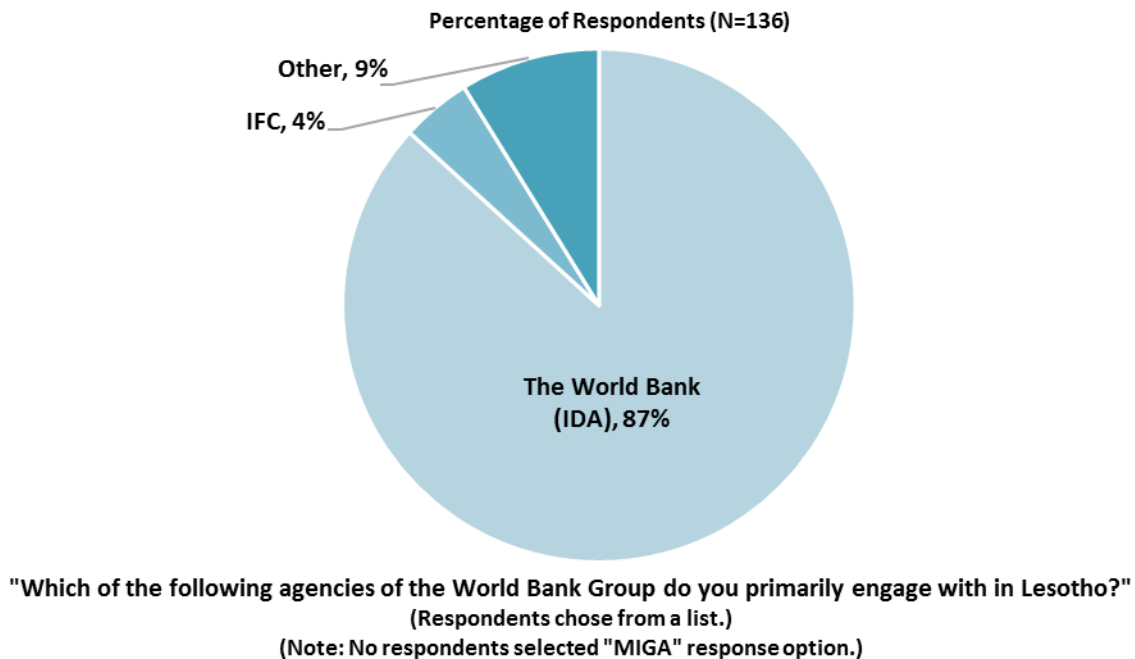

Exposure to Agencies within the World Bank Group

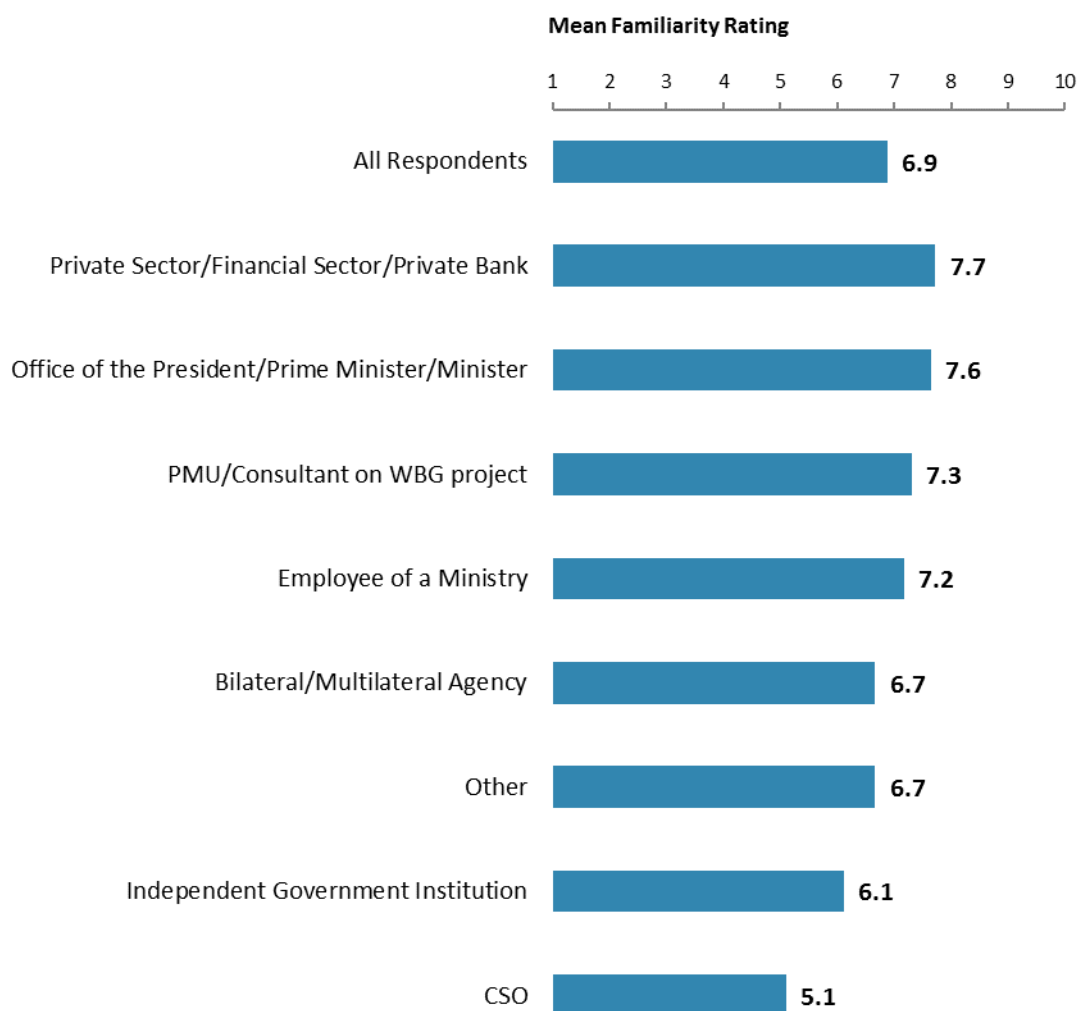

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of familiarity with the WBG than respondents in the FY'14 Country Survey (weighted mean in FY'18 = 6.7; weighted mean in FY'14 = 6.0)¹.
- Respondents' levels of familiarity with the WBG were significantly correlated with their ratings of the WBG's overall effectiveness in Lesotho.



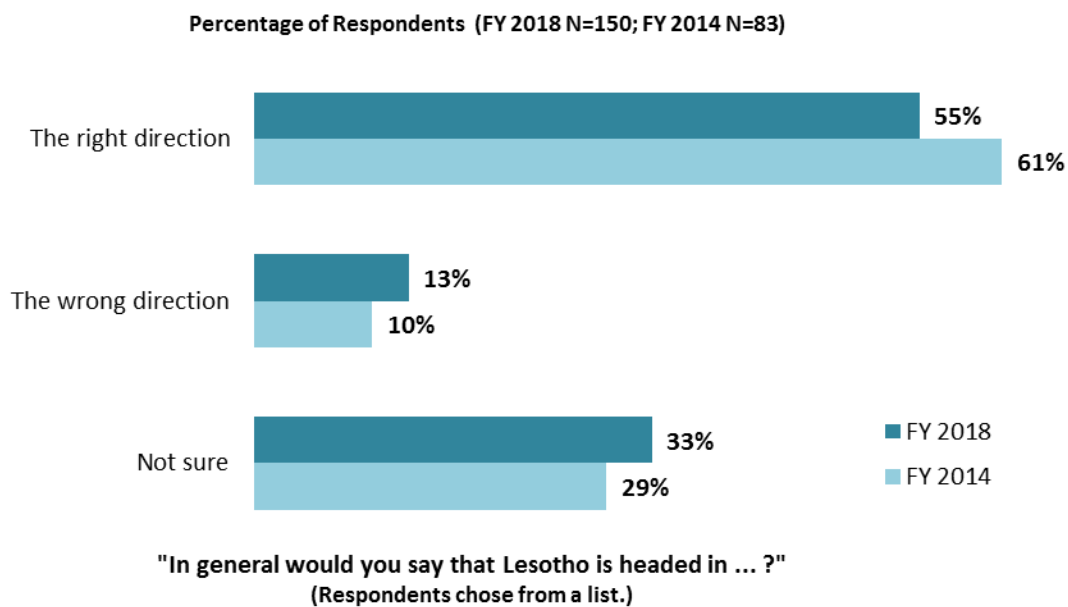
"How familiar are you with the work of the World Bank Group in Lesotho?"

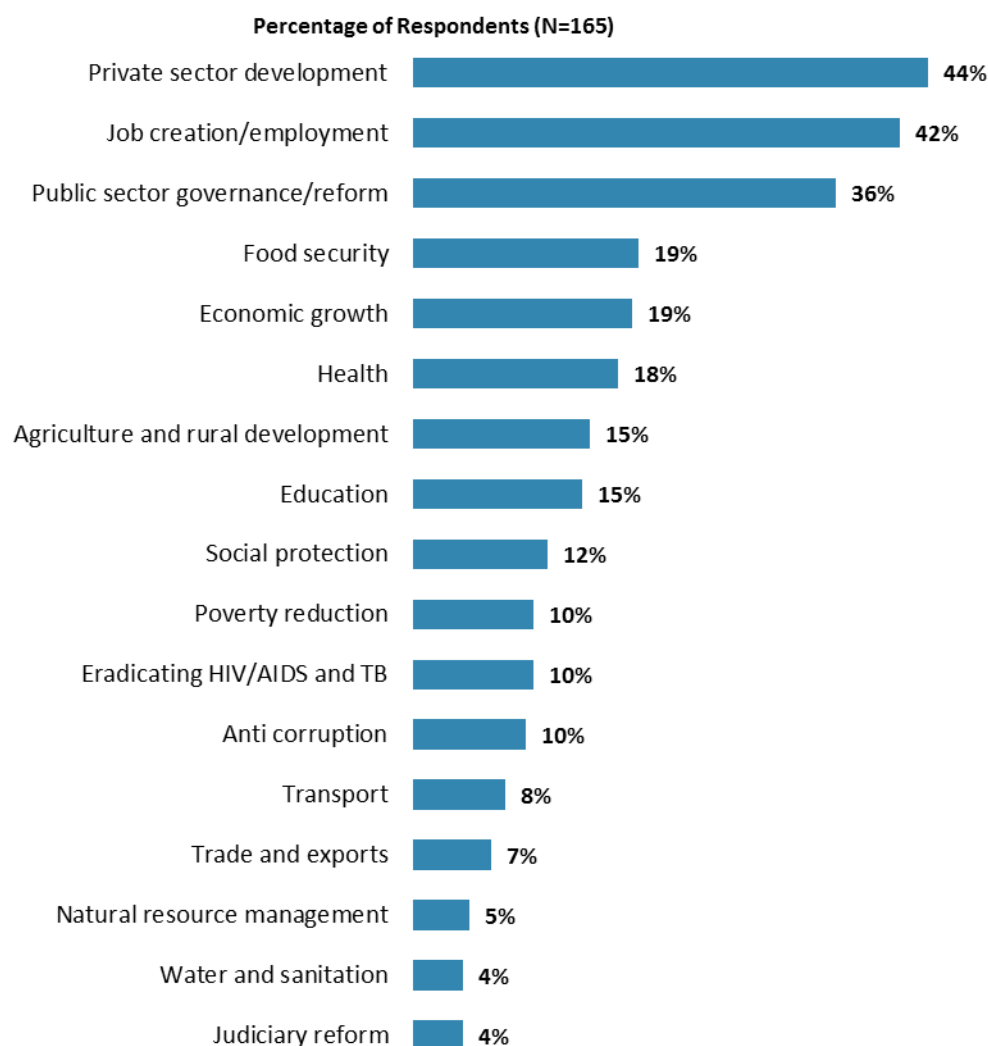

Development Priority

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the most important development priorities in Lesotho were “*job creation/employment*” (39%), “*health*” (27%), “*education*” (26%), and “*economic growth*” (25%).
- **Specialization:** Respondents who identified their primary specialization of work as “*trade and competitiveness*” (11% of the sample) were significantly more likely to indicate that “*private sector development*” was the most important development priority in Lesotho, compared to the rest of respondents in other areas of work (trade and competitiveness specialists = 81%; others = 41%).

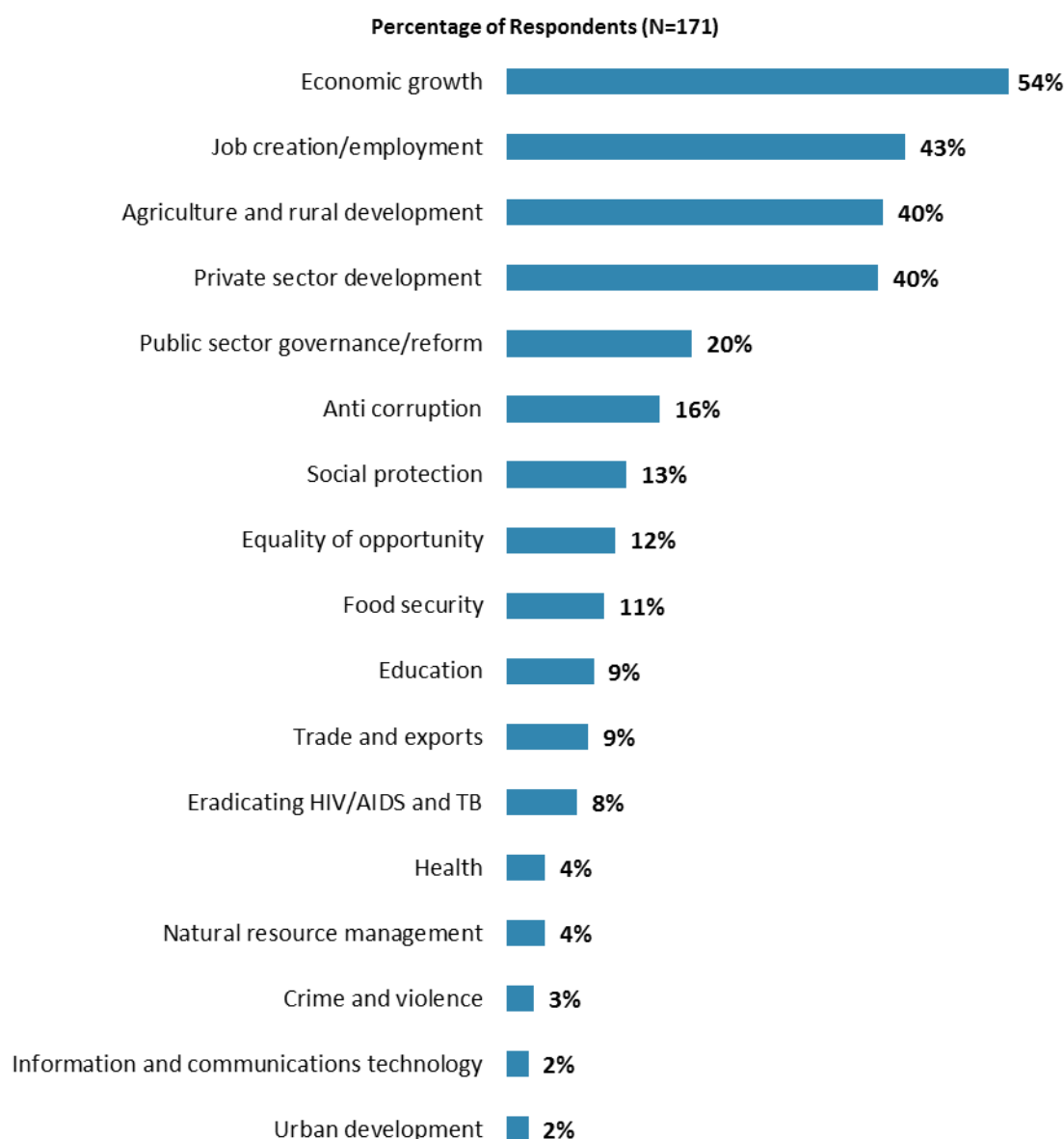

What Would Contribute Most to Reducing Poverty

- **Year comparison:** In the previous FY'14 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Lesotho were “*economic growth*” (43%), “*job creation/employment*” (43%), and “*agricultural development and food security*” (30%).

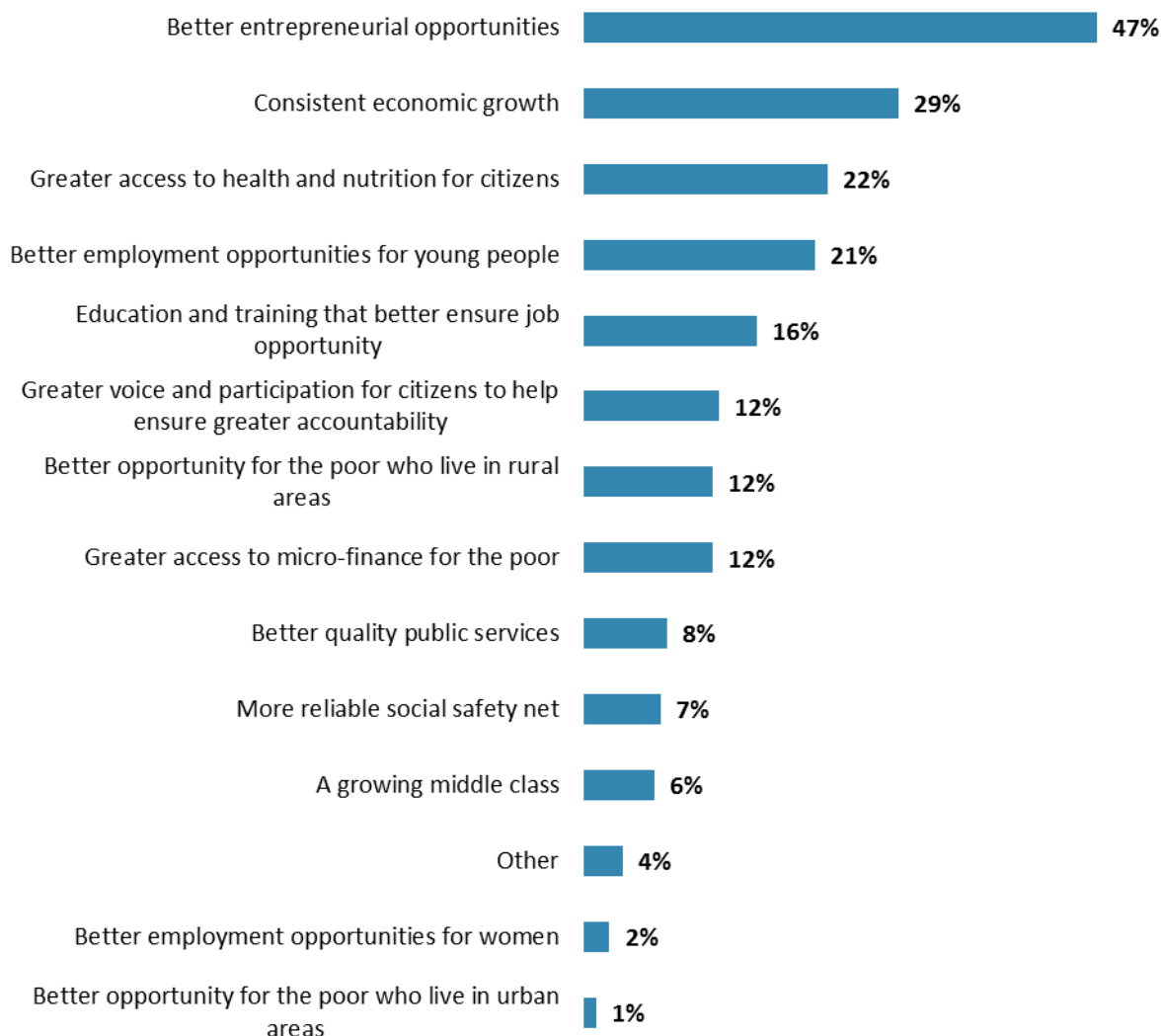

Percentage of Respondents (N=170)

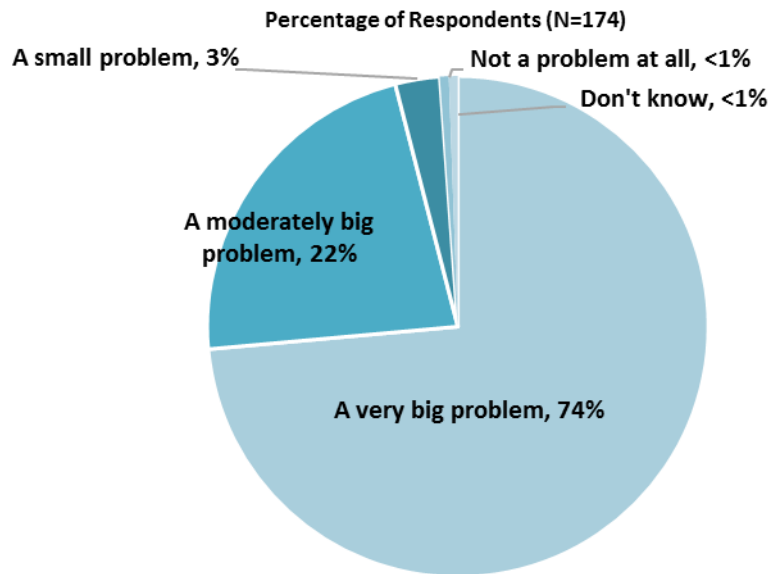

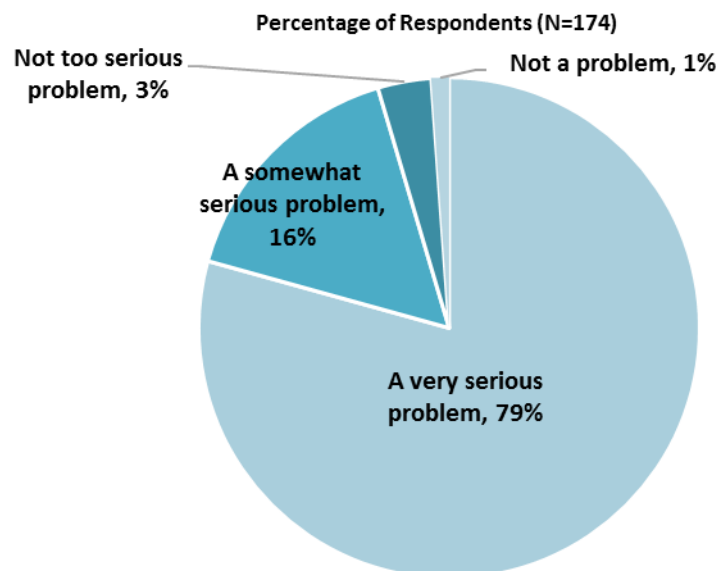
Gap between the Rich and the Poor

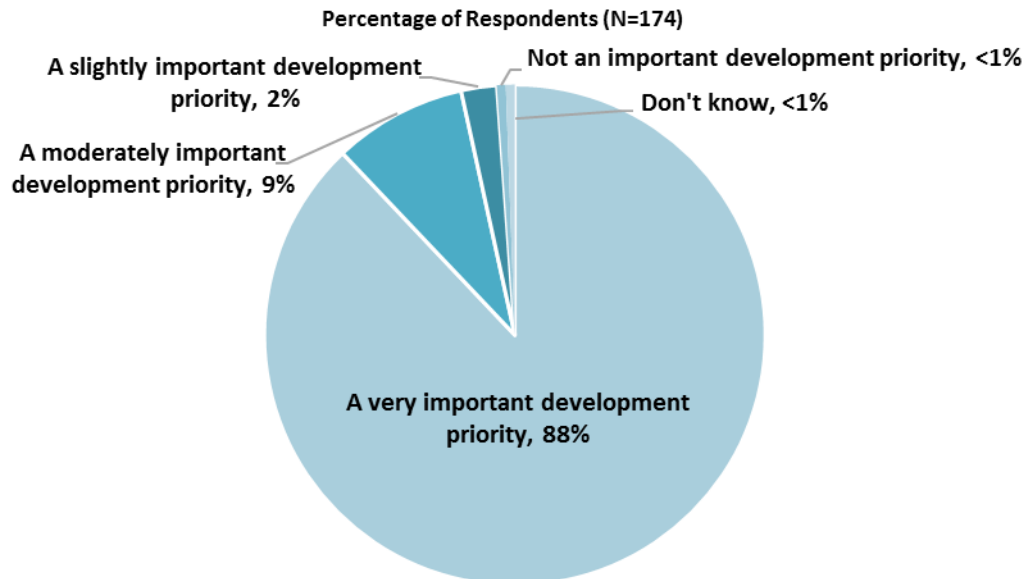

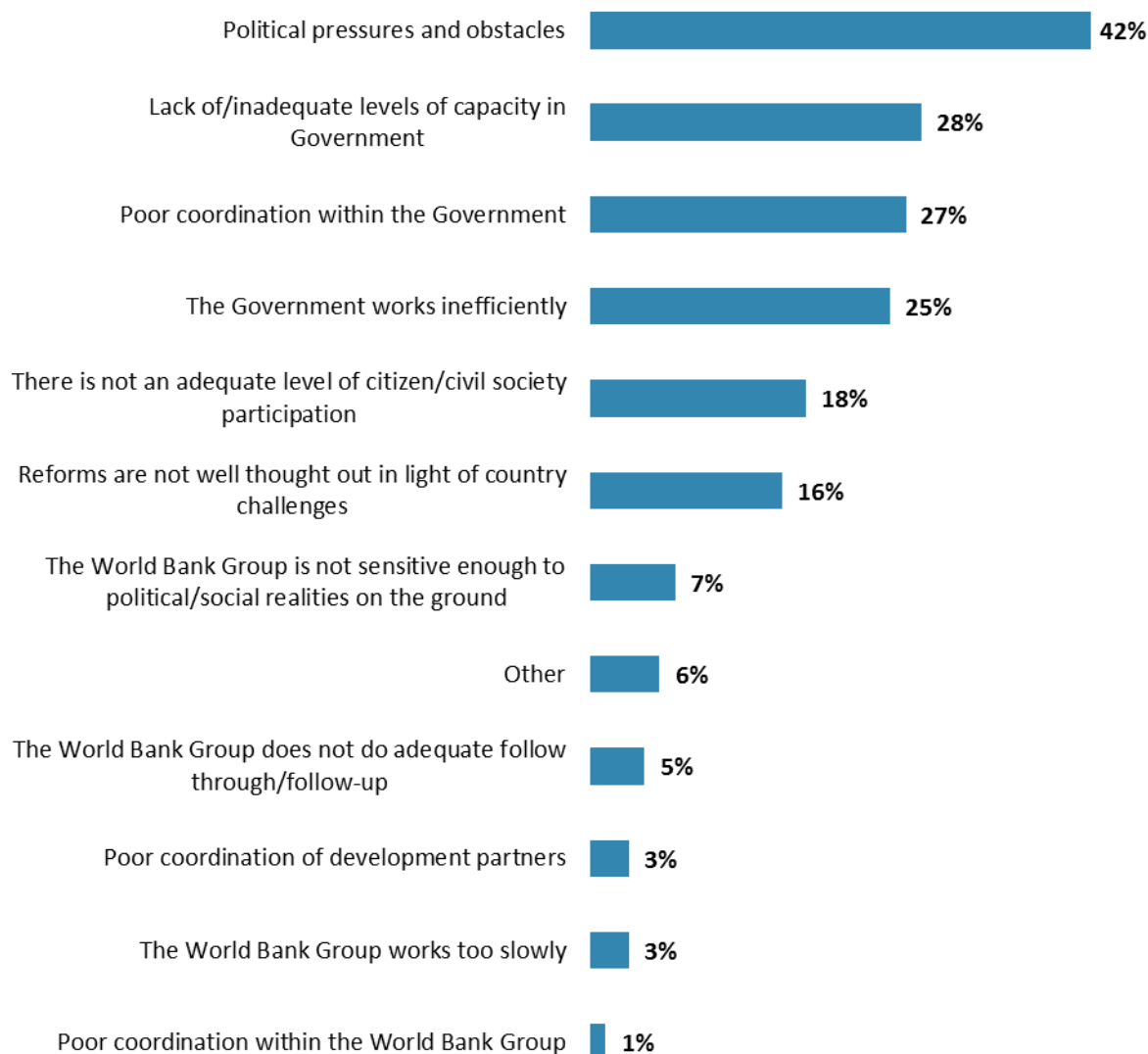

Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the previous FY'14 Country Survey most often attributed failed or slow WBG assisted reform efforts to “*lack of/inadequate levels of capacity in Government*” (33%), to that “*there is not an adequate level of citizen/civil society participation*” (31%), and to that “*the Government works inefficiently*” (27%).

Percentage of Respondents (N=153)



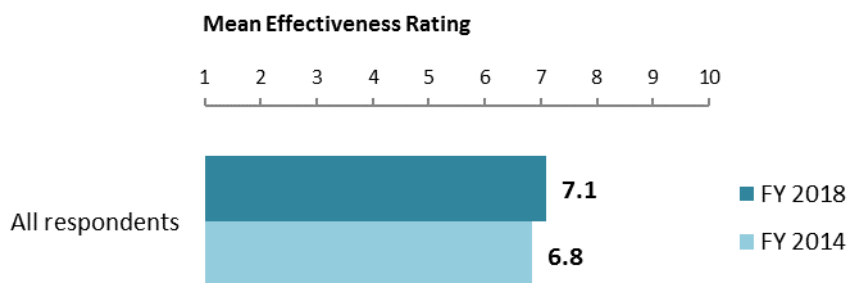
"When World Bank Group assisted reform efforts fail or are slow to take place, which of the following would you attribute this to? (Choose no more than TWO)"

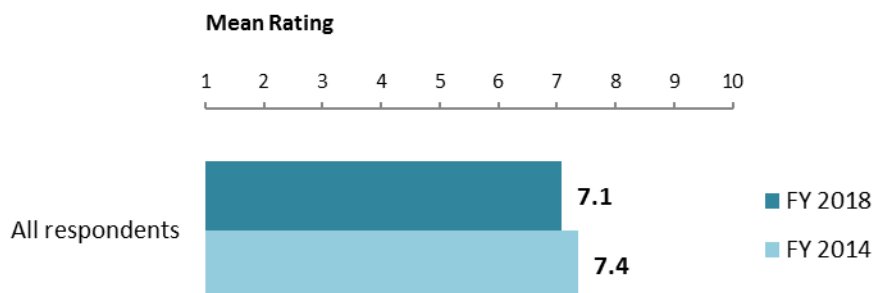

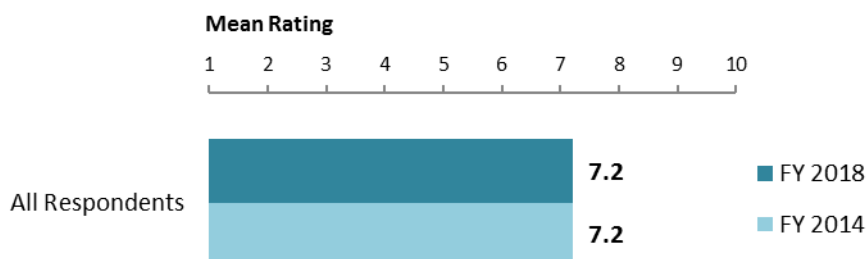

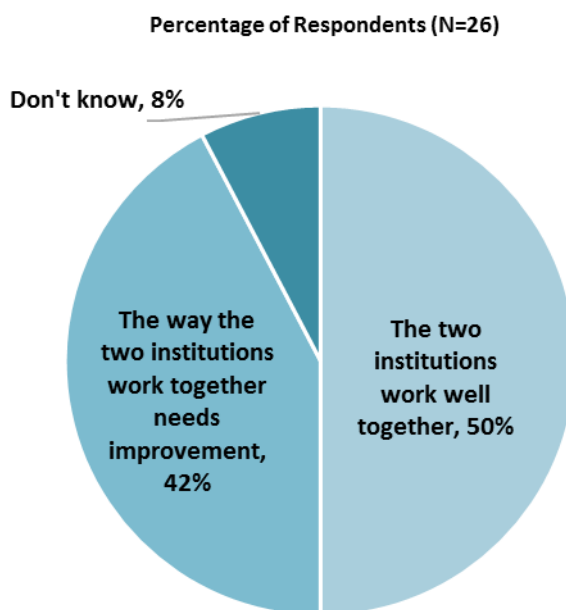
WBG Staff Preparedness⁴

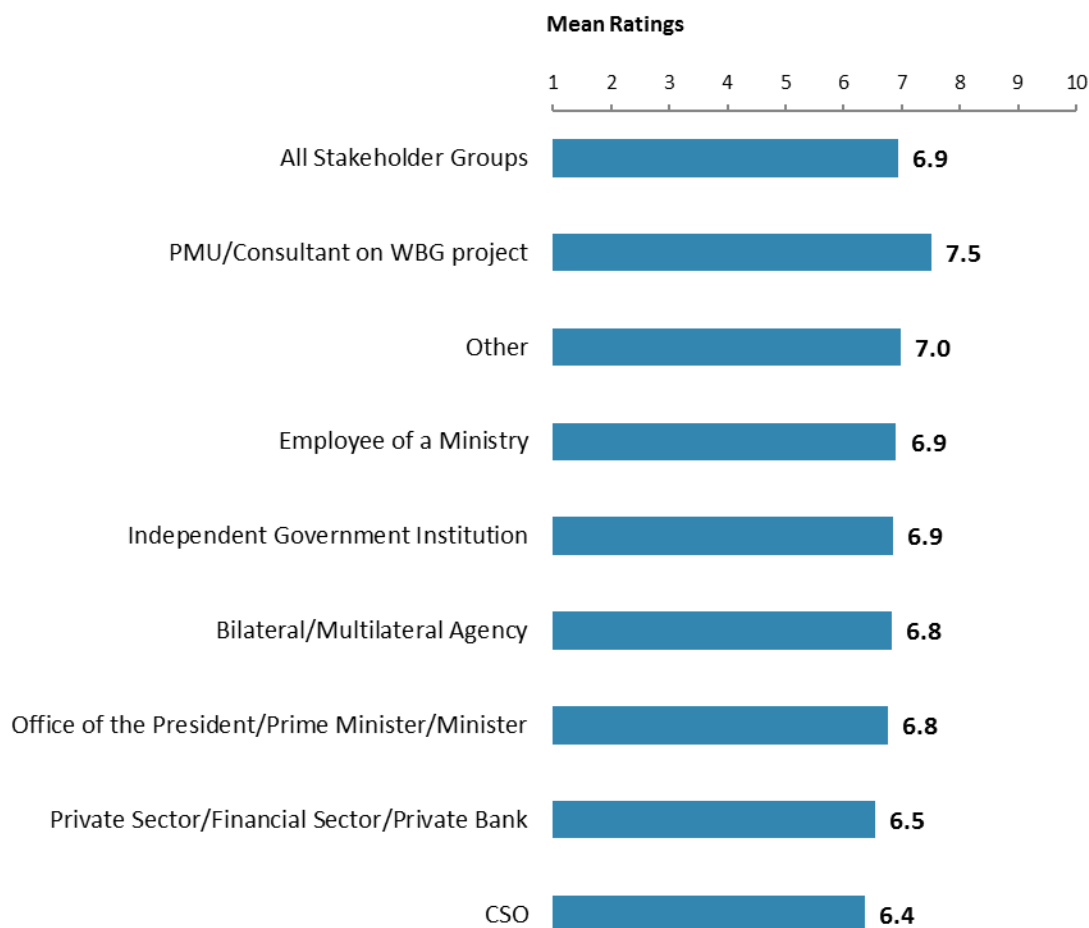

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-six COS indicator questions (mean rating = 7.1) compared to respondents who do not collaborate with the WBG (mean rating = 6.5). 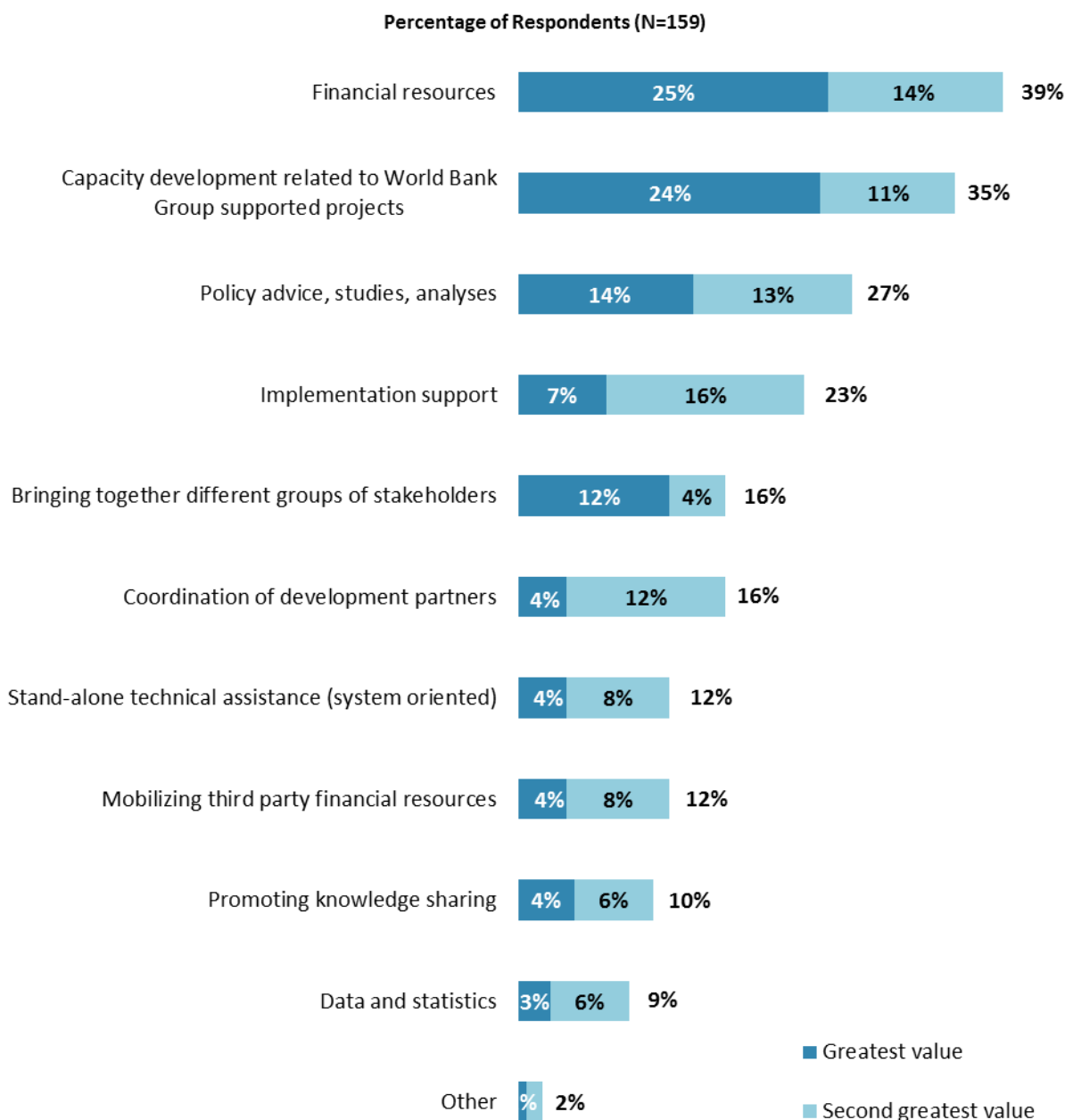
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the WBG's greatest values to Lesotho were its "*financial resources*" (60%) and "*policy advice, studies, analyses*" (43%).



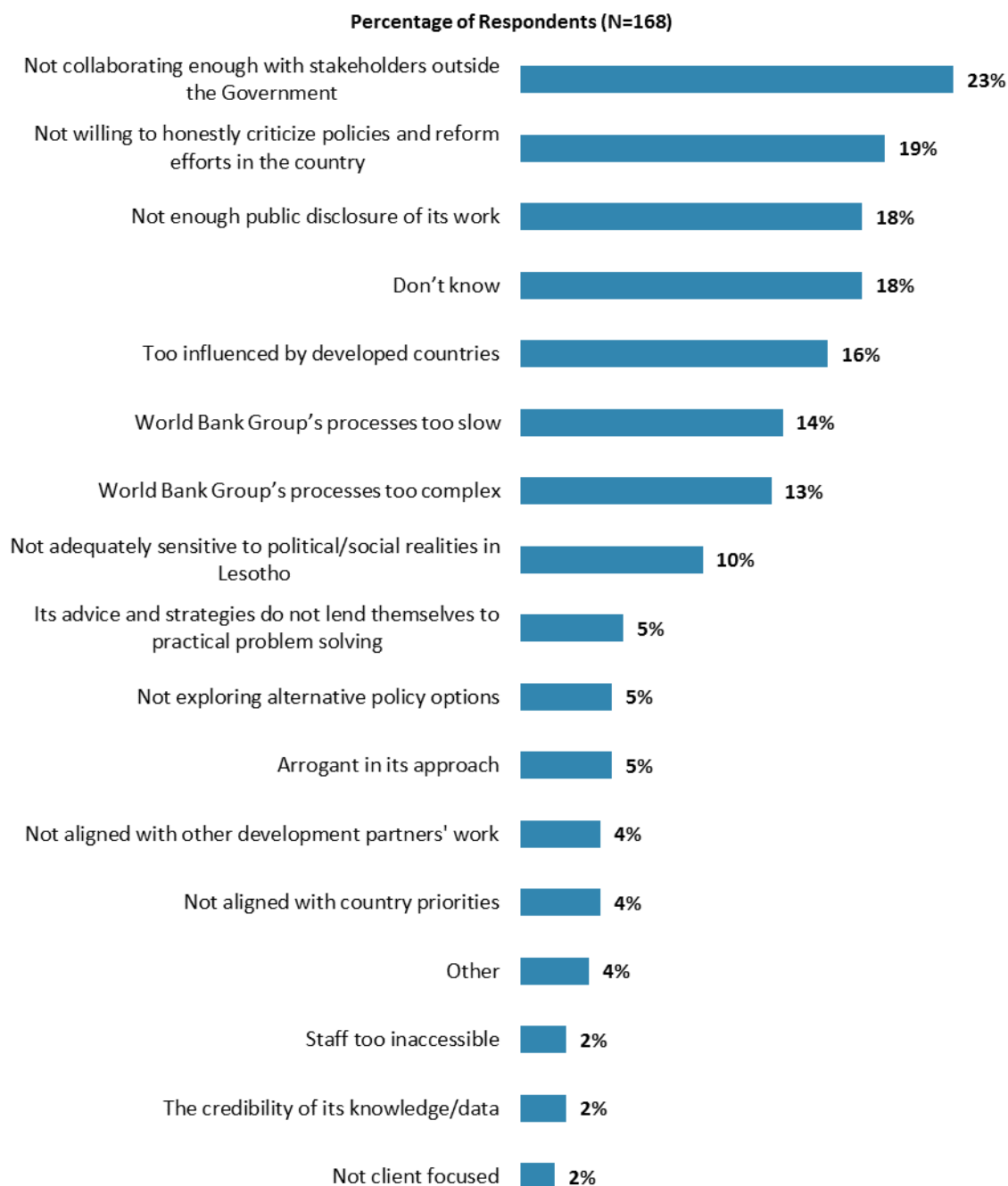
"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Lesotho?"

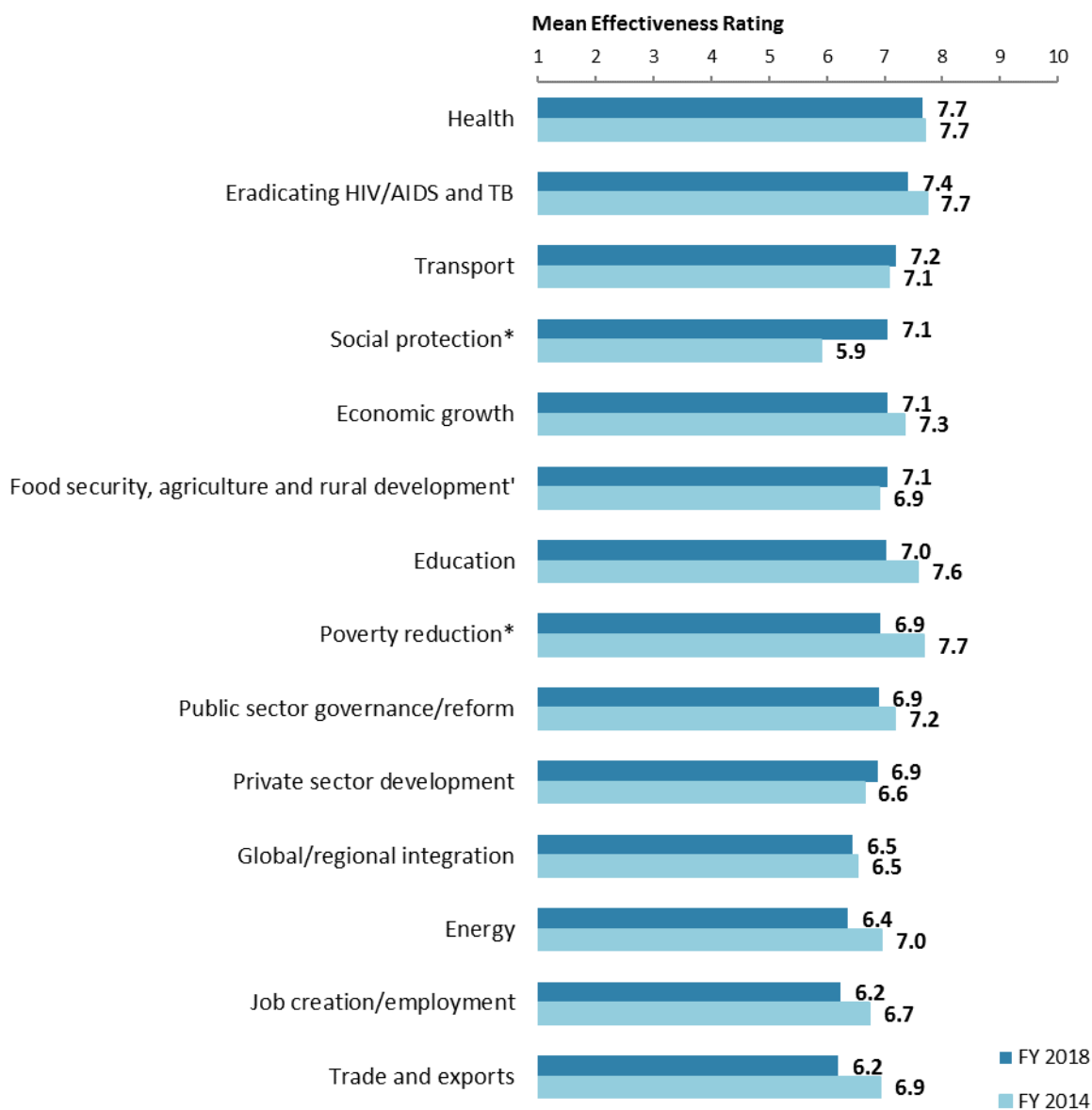

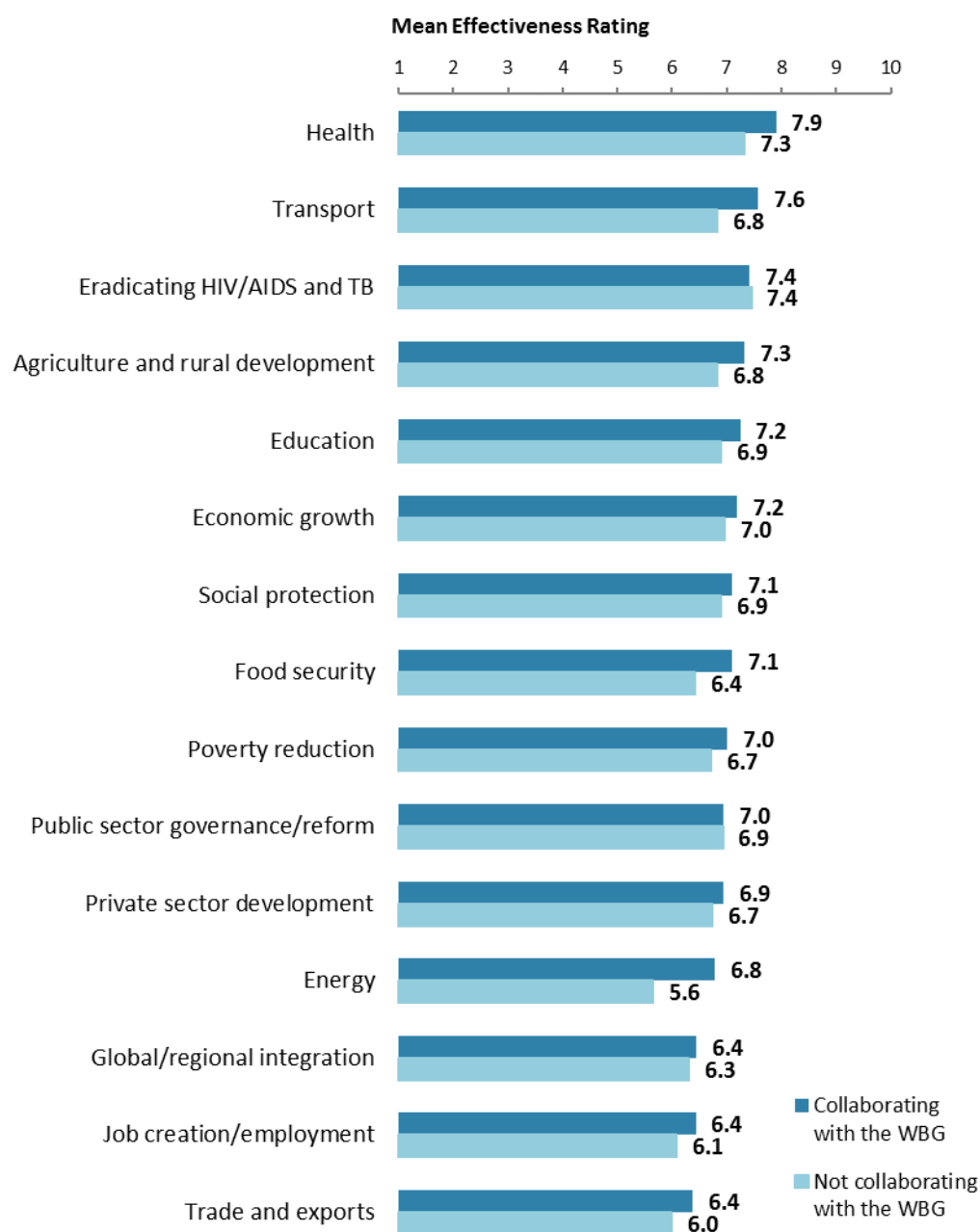

VI. Sectoral Effectiveness (continued)

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Lesotho, bivariate correlational analyses were conducted using respondents' ratings of the fifteen specific areas of effectiveness.

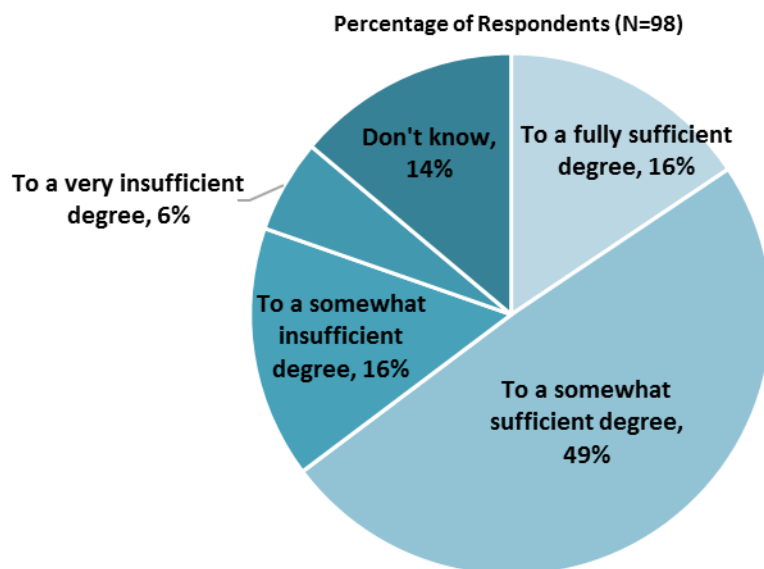
Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Lesotho. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at social protection; and
 - The WBG's effectiveness at public sector governance/reform.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Lesotho, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The area determined to be key driver from these analyses was:
 - The WBG's effectiveness at poverty reduction;
 - The WBG's effectiveness at job creation/employment;
 - The WBG's effectiveness at energy; and
 - The WBG's effectiveness at economic growth.

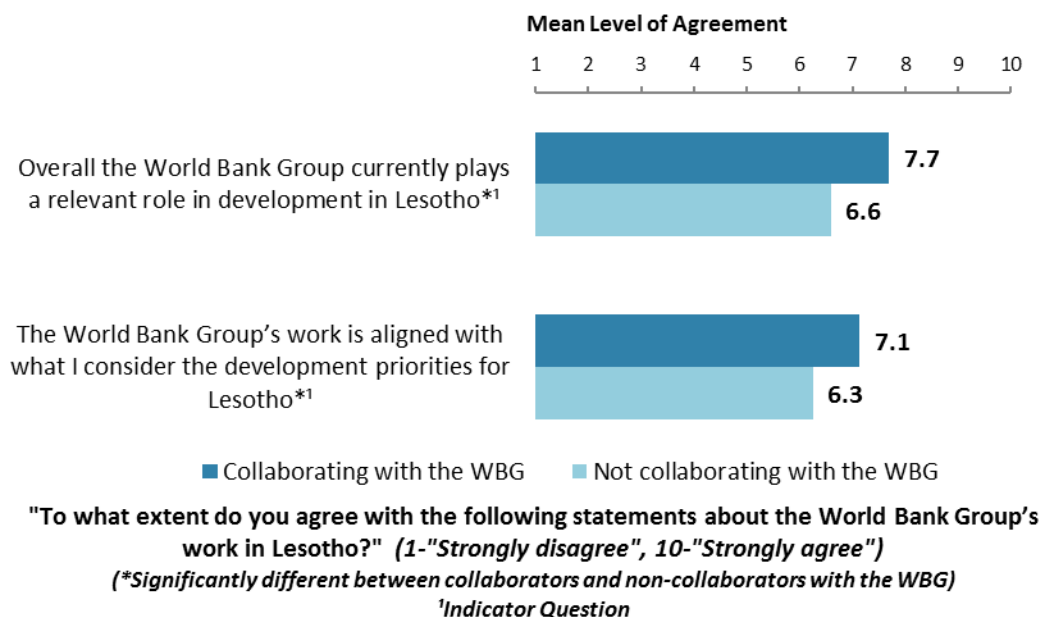

The World Bank Group's Work in Lesotho: Collaboration

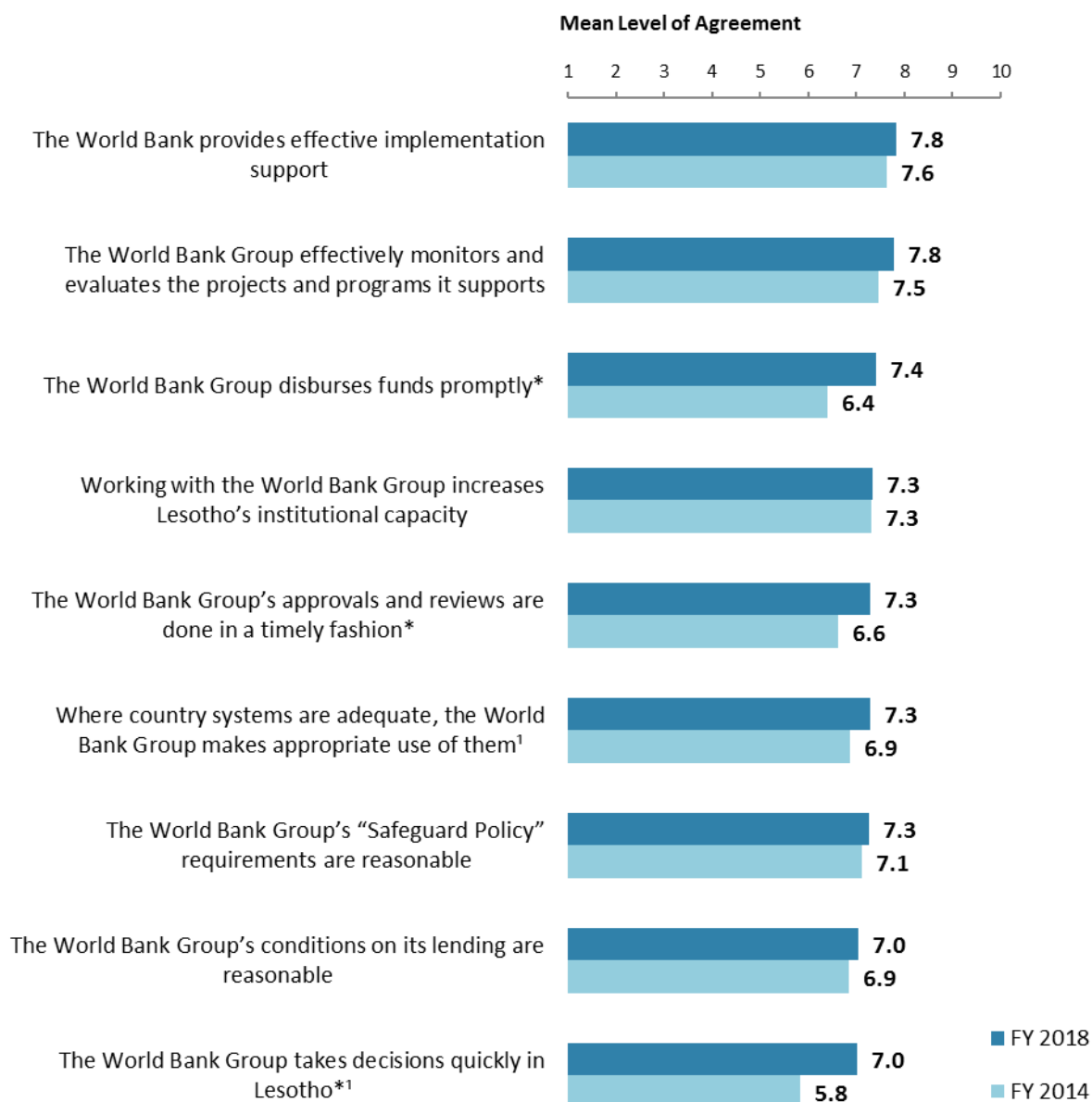

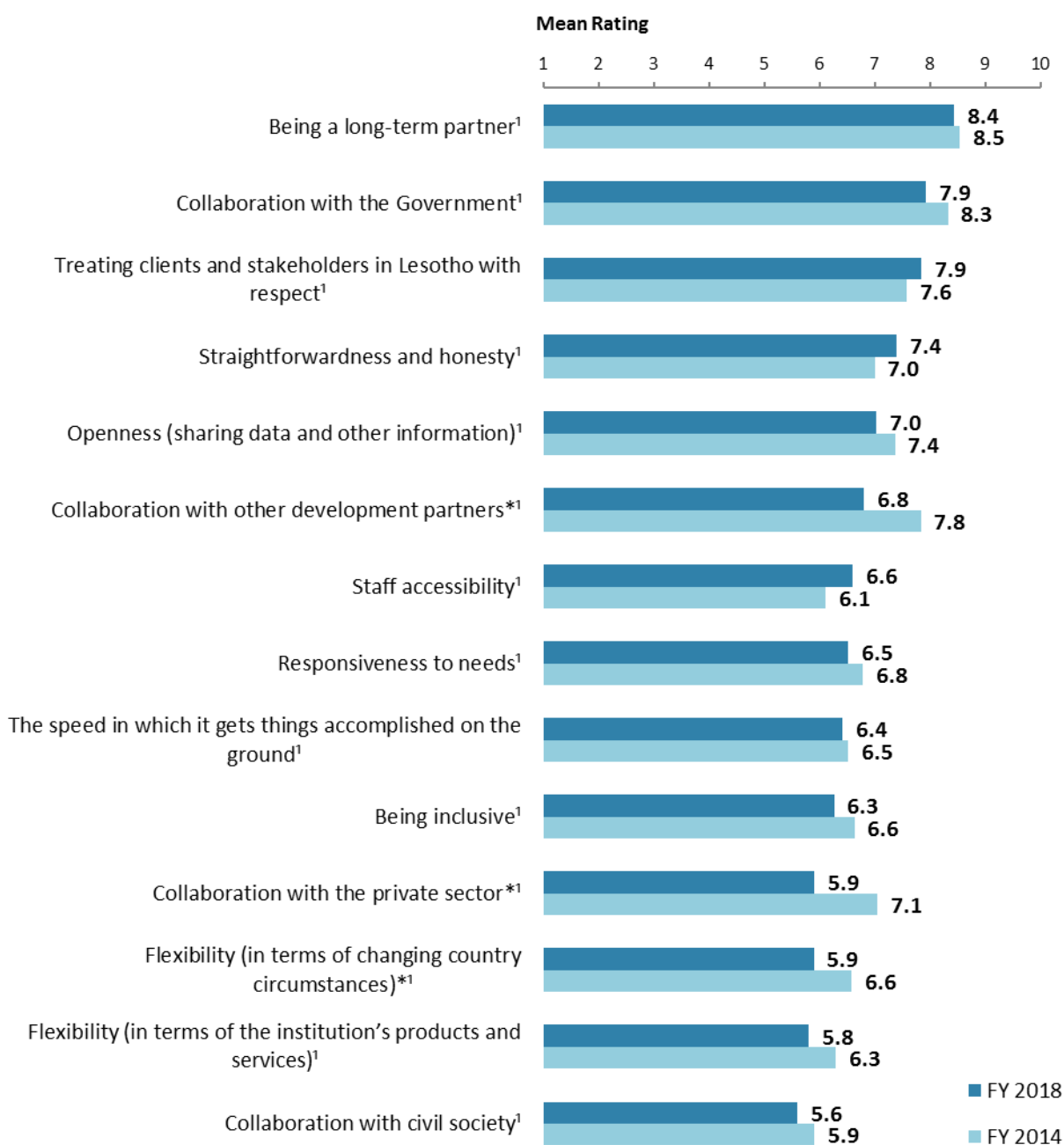


"To what extent do you agree/disagree with the following statements?"

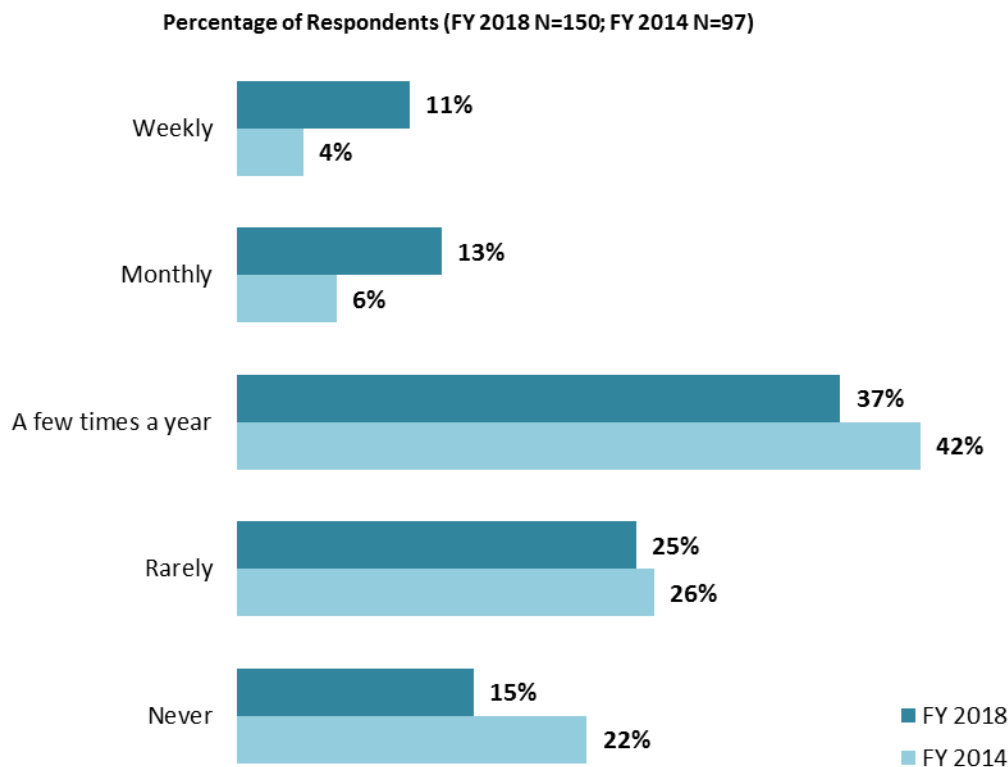

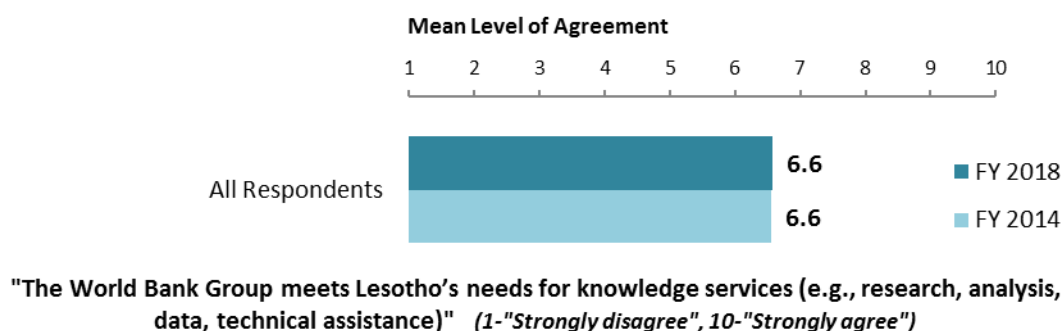
"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?" (Respondents chose from a list.)

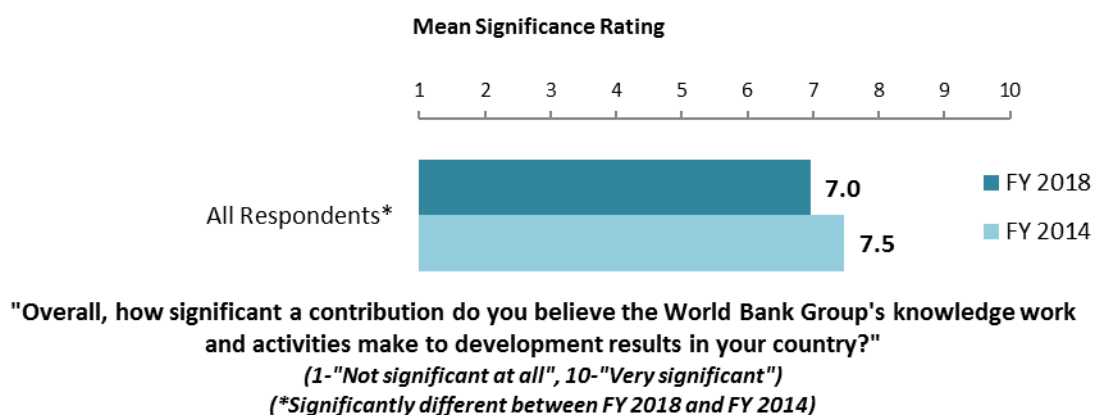

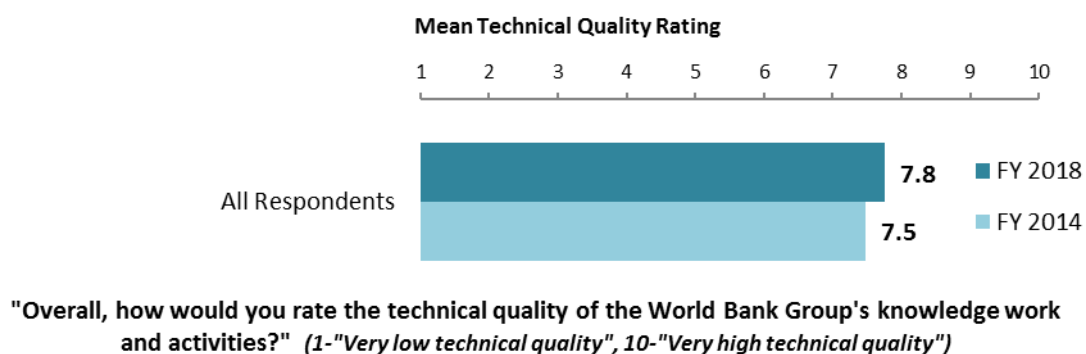
Meeting Lesotho's Knowledge Needs¹¹ (Indicator Question)

Technical Quality of the WBG's Knowledge Work and Activities (Indicator Question)

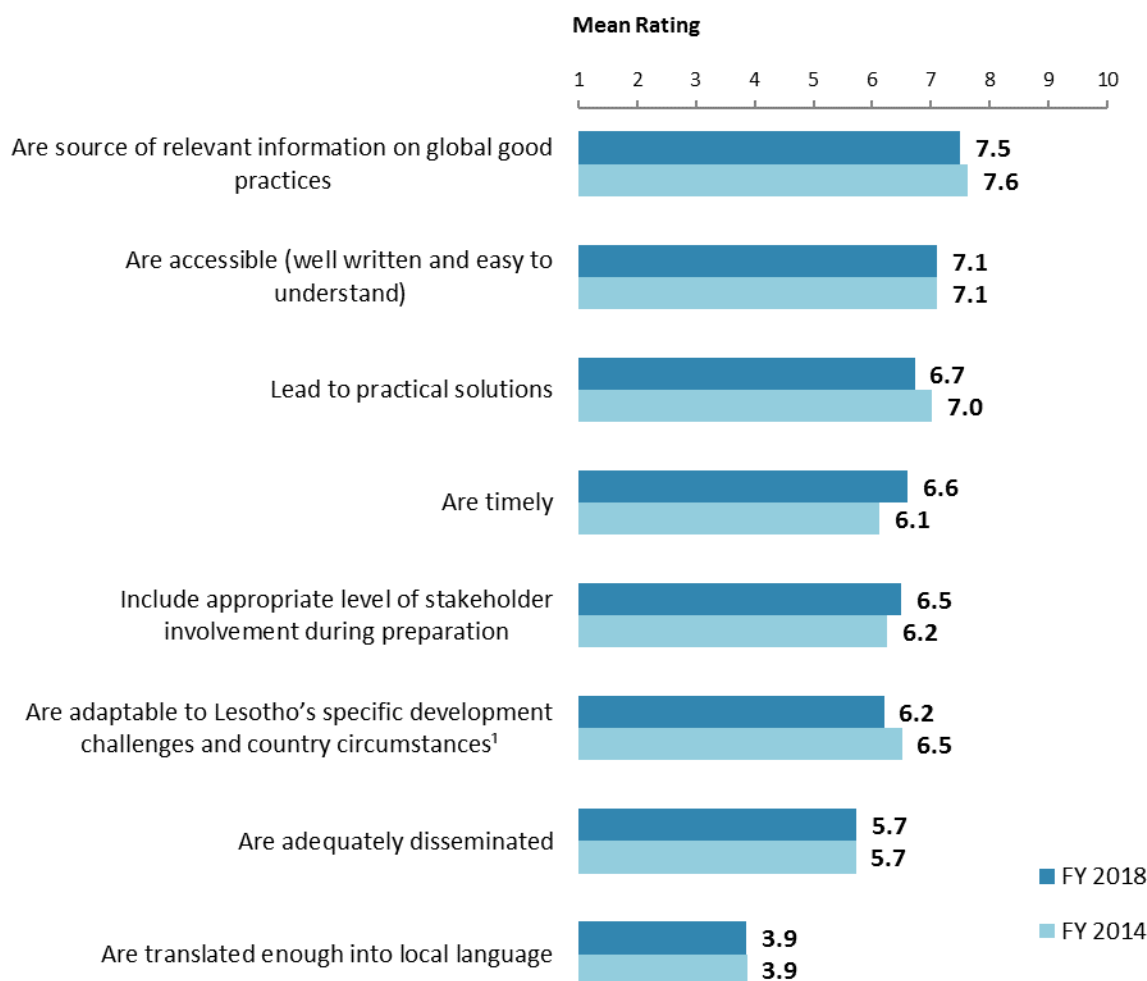

Qualities of the WBG's Knowledge Work and Activities¹²



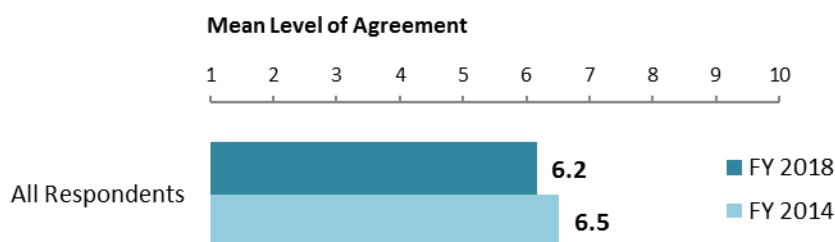
"In Lesotho, to what extent do you believe that the World Bank Group's knowledge work and activities:" (1-"To no degree at all", 10-"To a very significant degree")

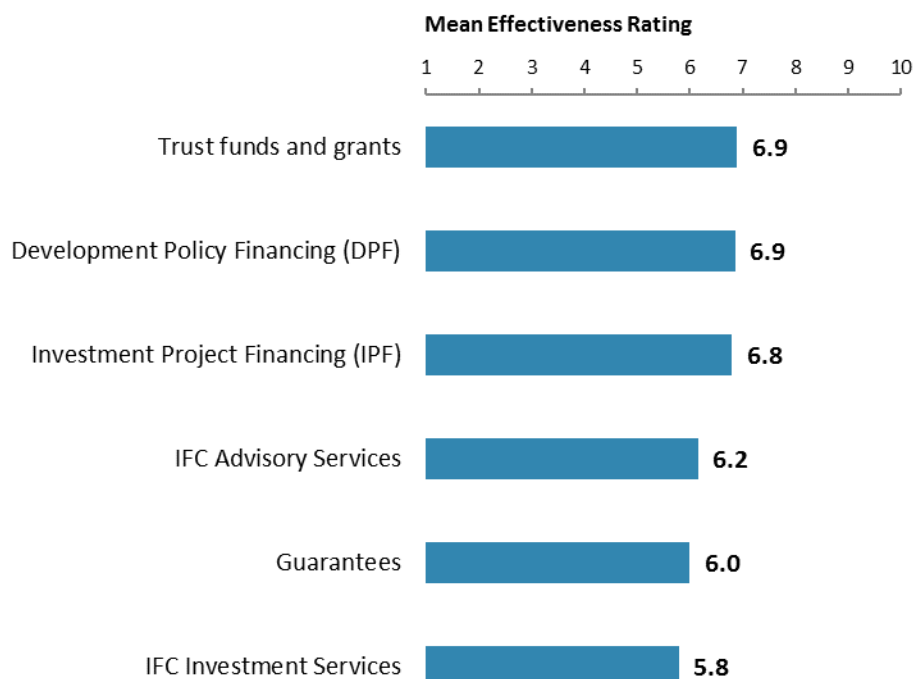

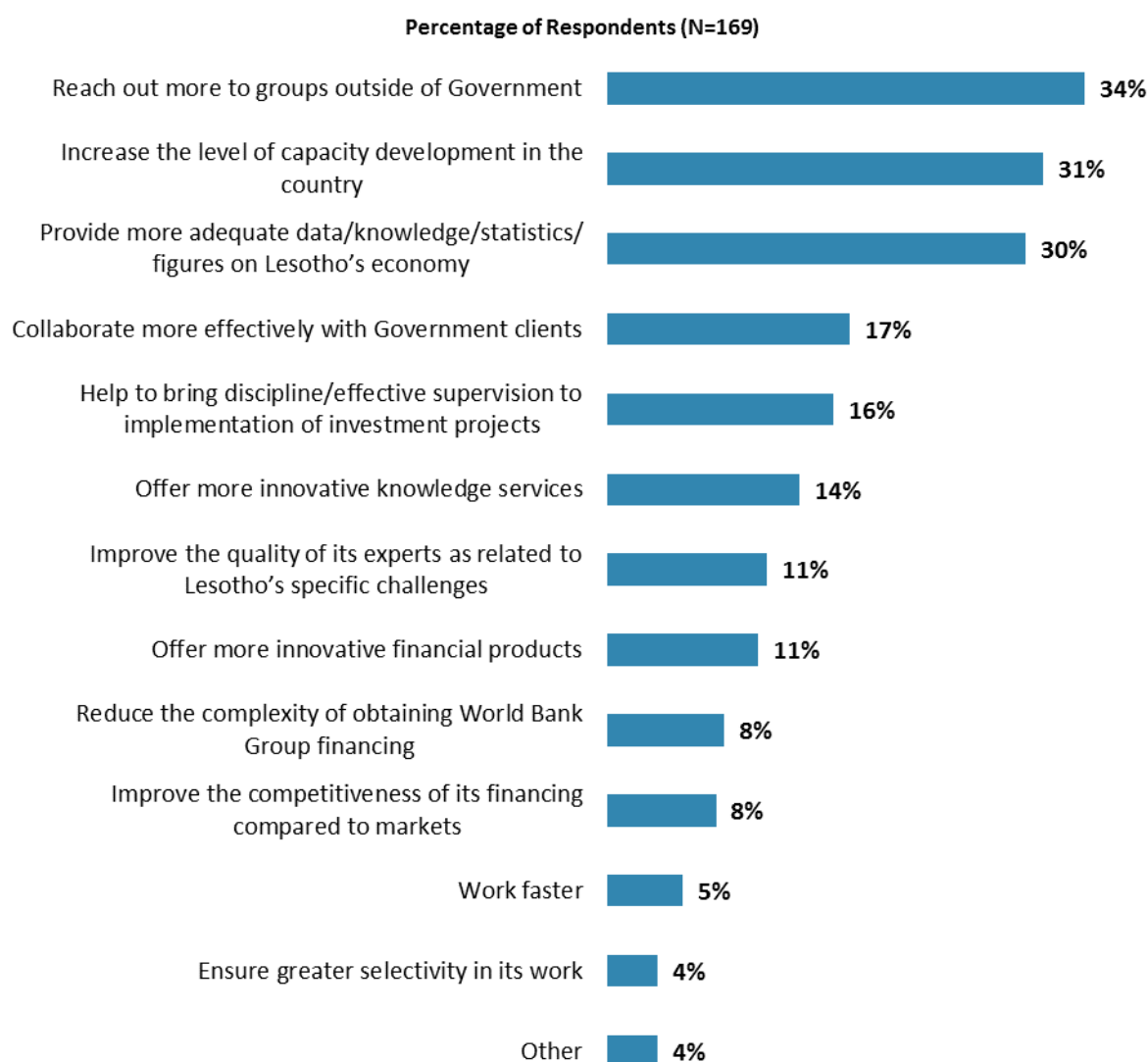

Making the World Bank Group of Greater Value

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the World Bank Group should “*reach out more to groups outside of Government*” (43%) and “*increase the level of capacity development in the country*” (42%) to make itself of greater value in Lesotho.
- **Stakeholders:** In this year’s Country Survey respondents from the private sector and the Office of the President/Prime Minister/Minister were significantly more likely than representatives from other groups to believe that the WBG should “*provide more adequate data/knowledge/statistics/figures on Lesotho’s economy*” to make itself of greater value in Lesotho.



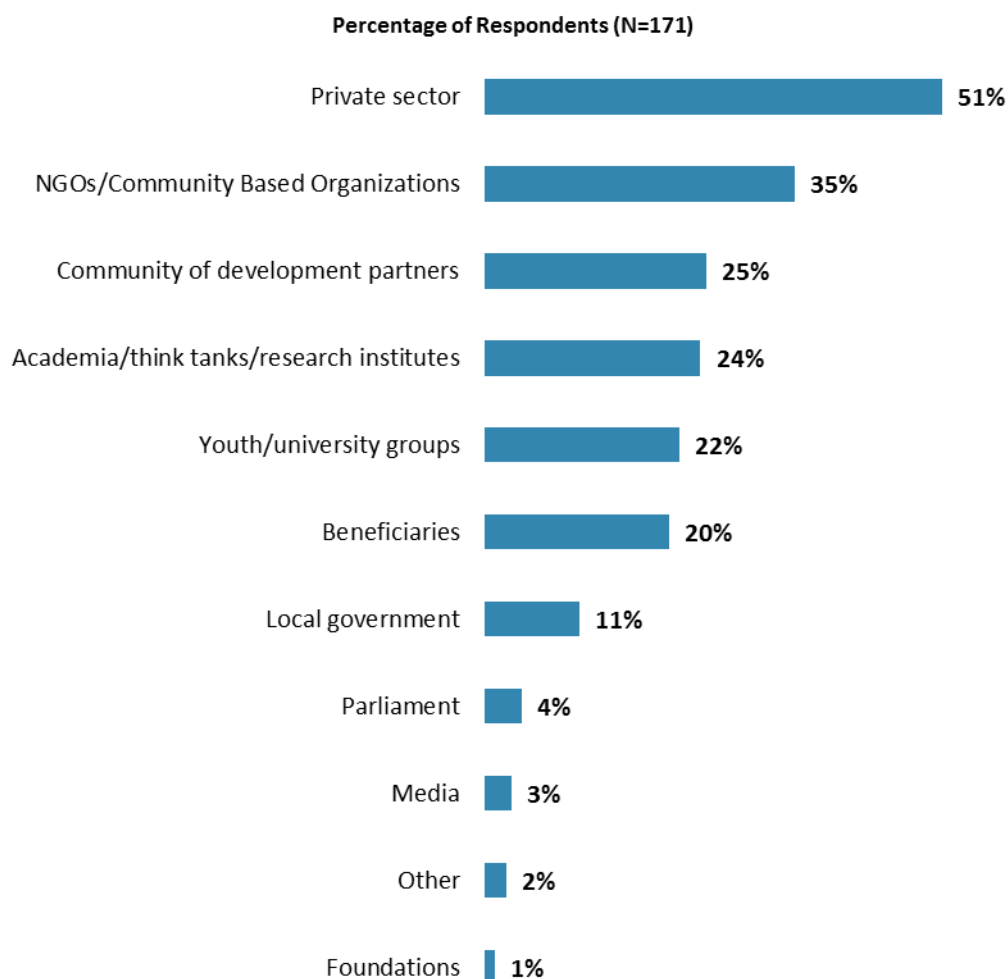

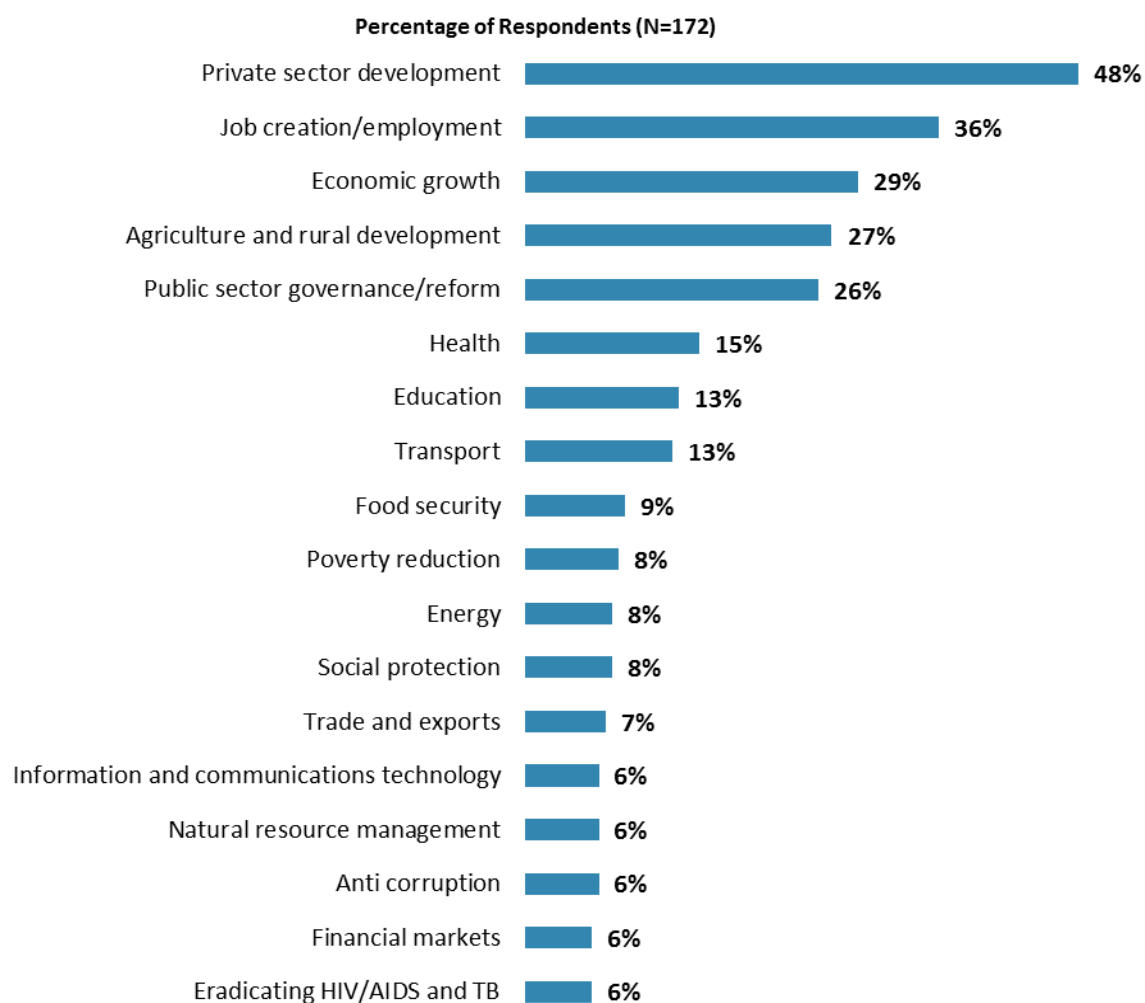
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country?"

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the WBG should focus most of its resources on “*job creation/employment*” (31%) and “*public sector governance/reform*” (30%).
- **Specialization:** Respondents who identified their primary specialization of work as “*trade and competitiveness*” (11% of the sample) were significantly more likely to indicate that the WBG should focus most of its resources on “*private sector development*” in Lesotho, compared to the rest of respondents in other areas of work (trade and competitiveness specialists = 88%; others = 44%).

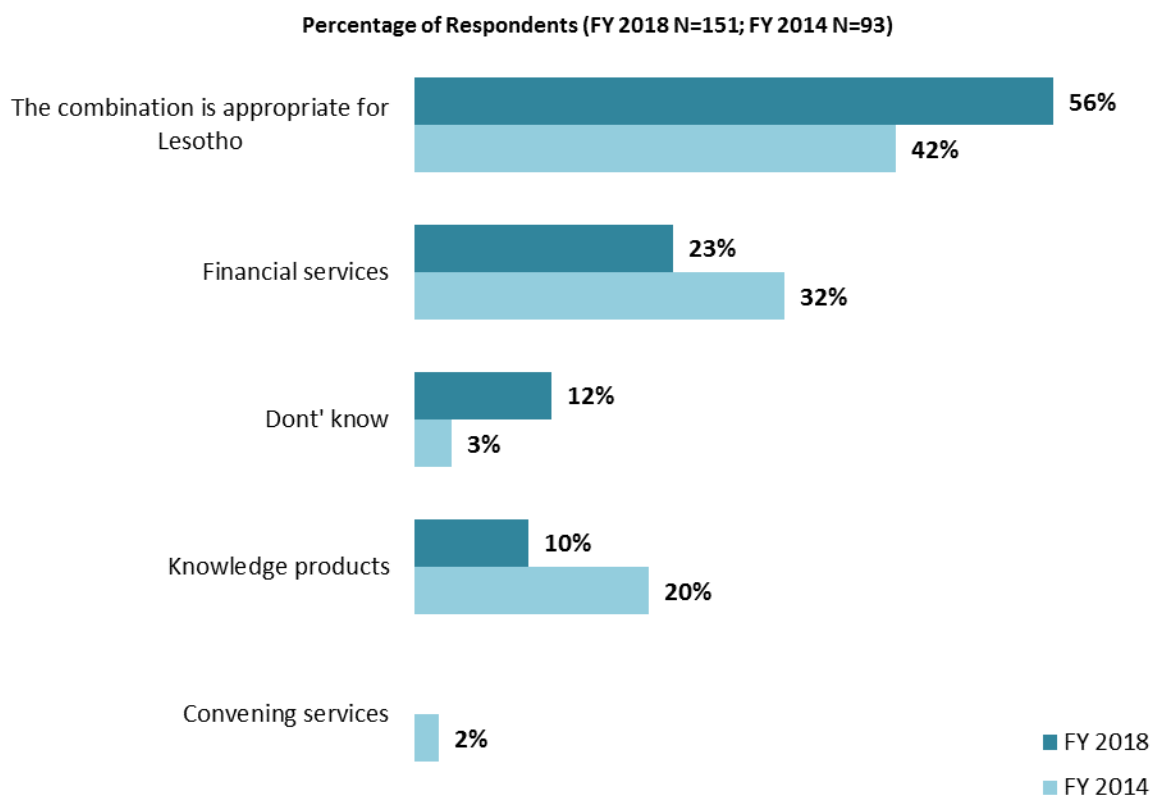

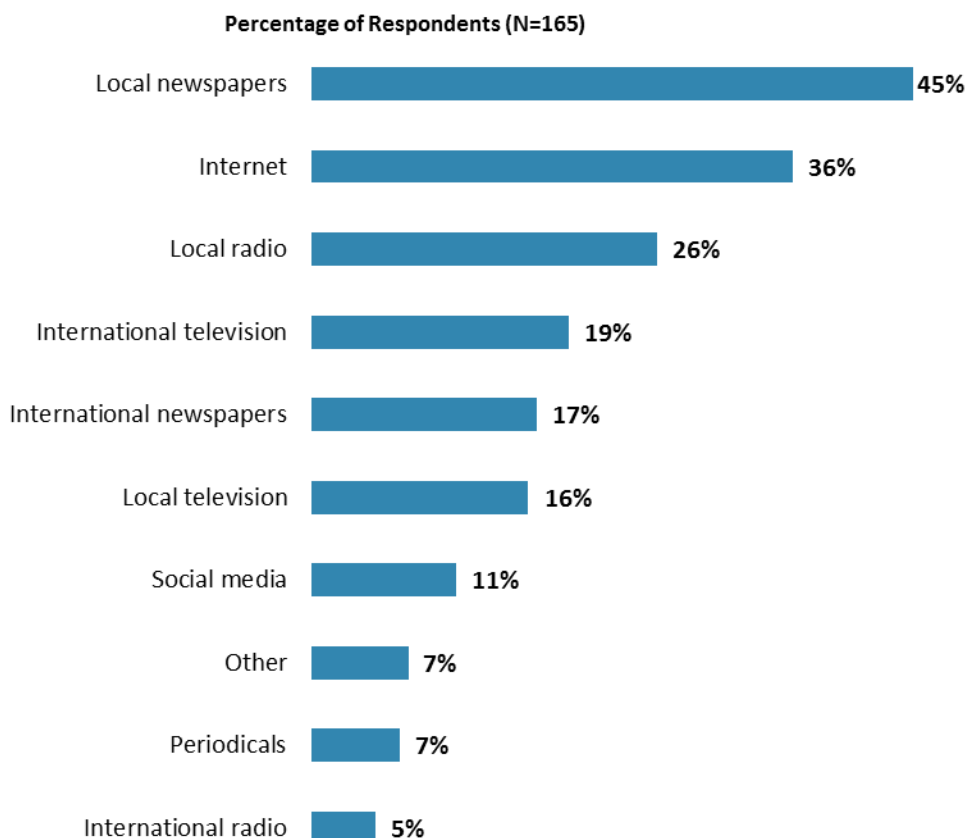

General Information Sources

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that they got most of their information about economic and social development issues in Lesotho from “*local newspapers*” (64%) and “*Internet*” (36%).
- **Stakeholder groups:** Respondents from CSOs and the private sector were significantly more likely than respondents from other stakeholder groups to indicate that they get most of their information about economic and social development issues in Lesotho from “*international newspapers*.”



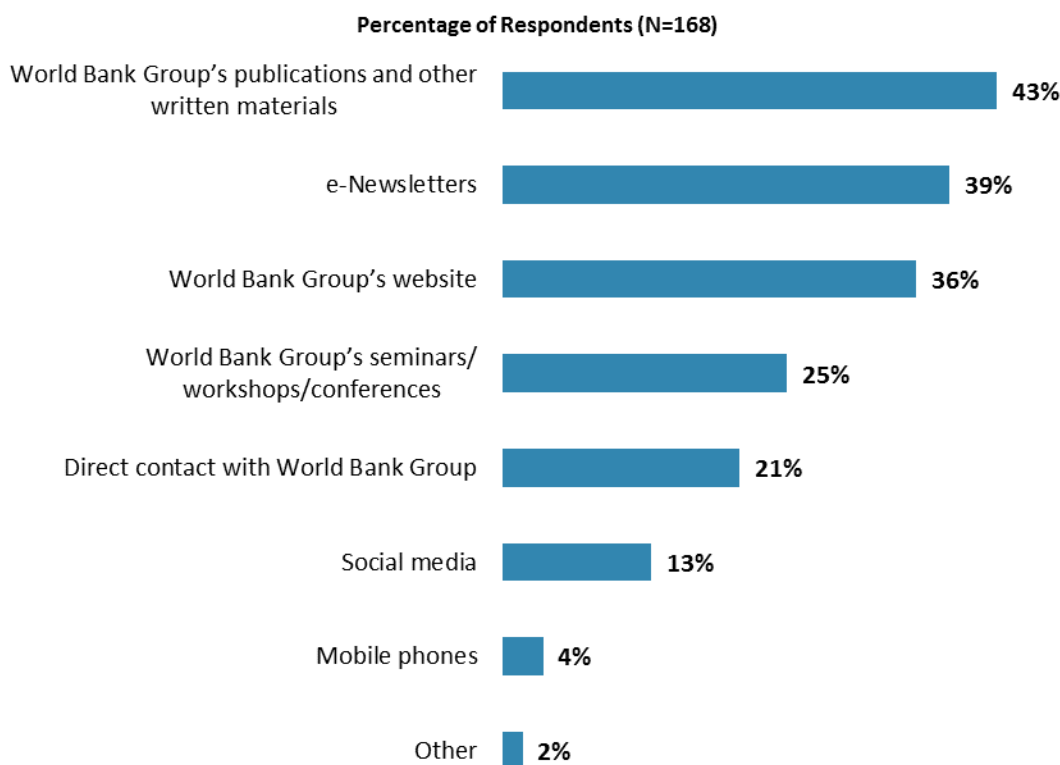
"How do you get most of your information about economic and social development issues in Lesotho? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

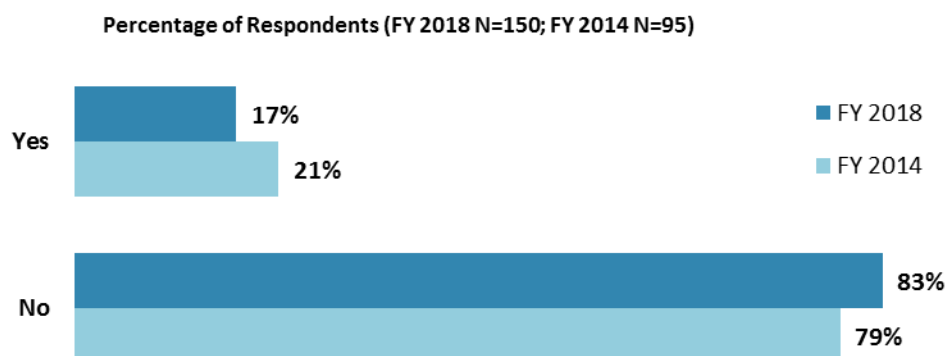


**"How would you prefer to receive information from the World Bank Group?

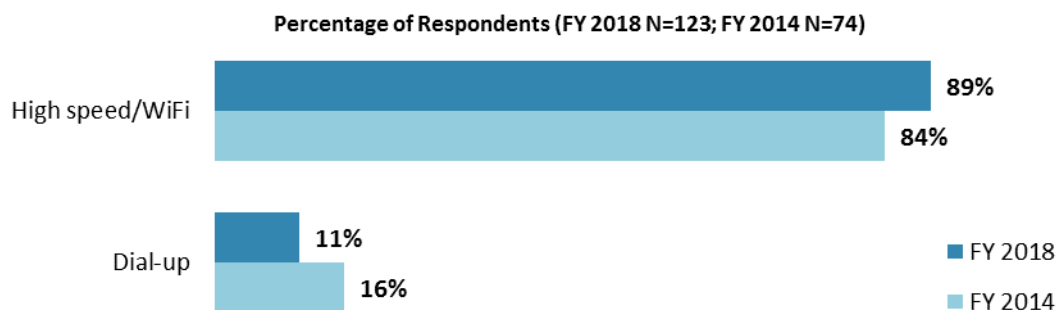

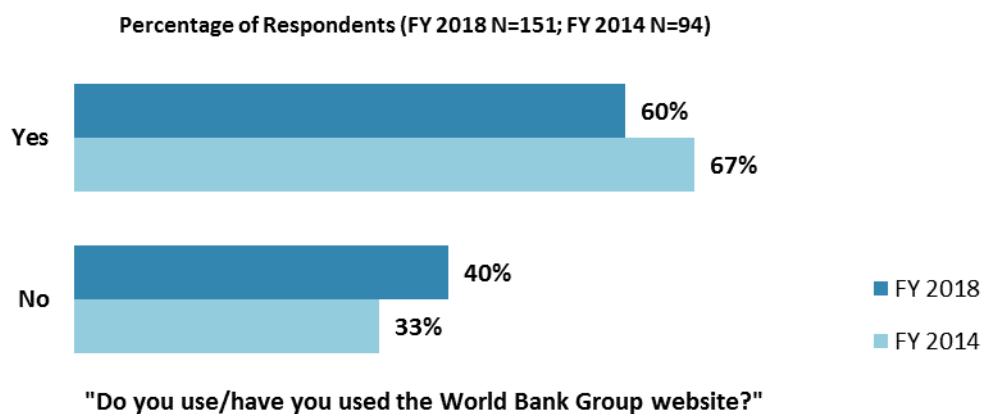
"Which Internet connection do you use primarily when visiting a World Bank Group website?"

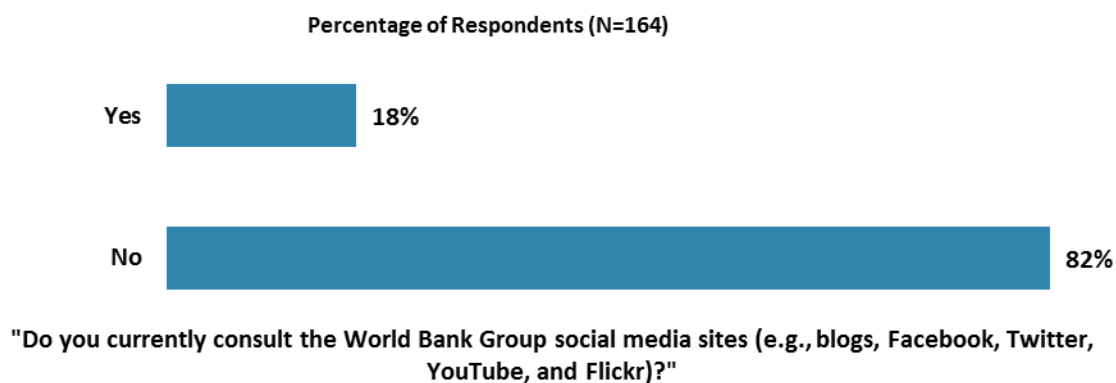

Use of the WBG's Social Media Channels



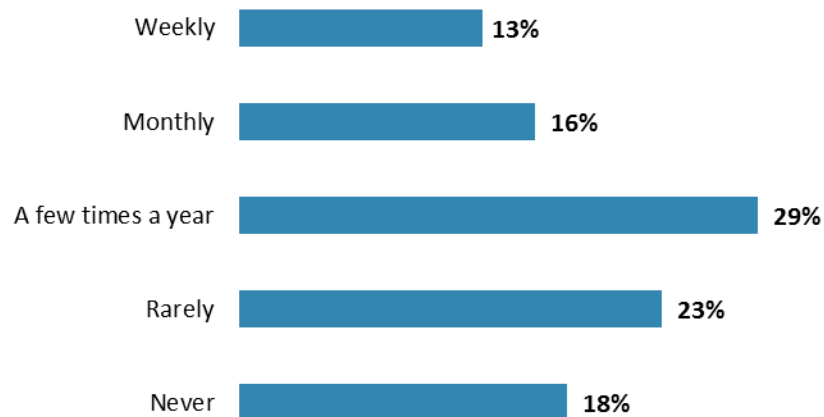
