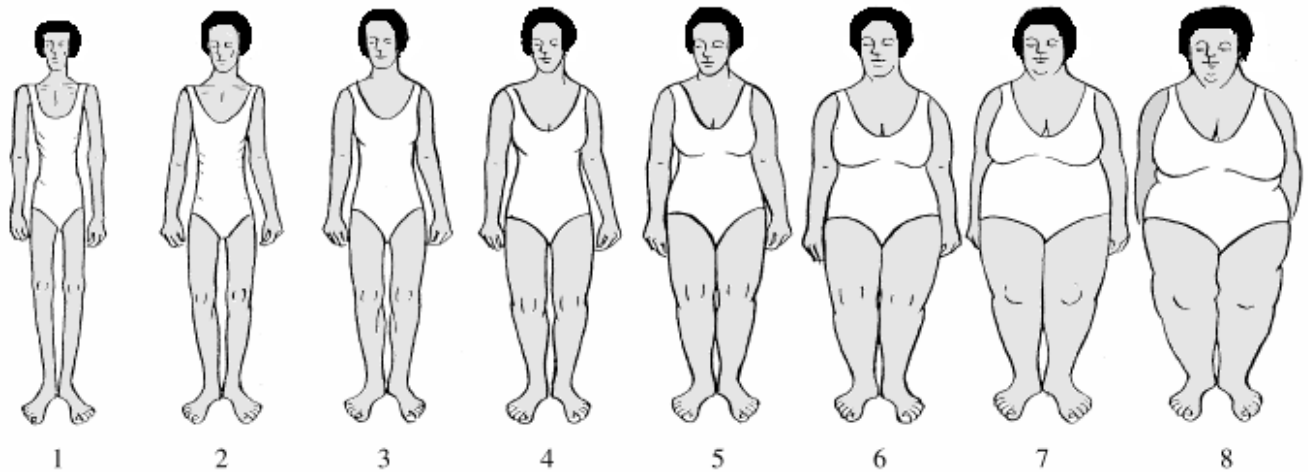


Figure 1 The illustrations of body shapes used for women.

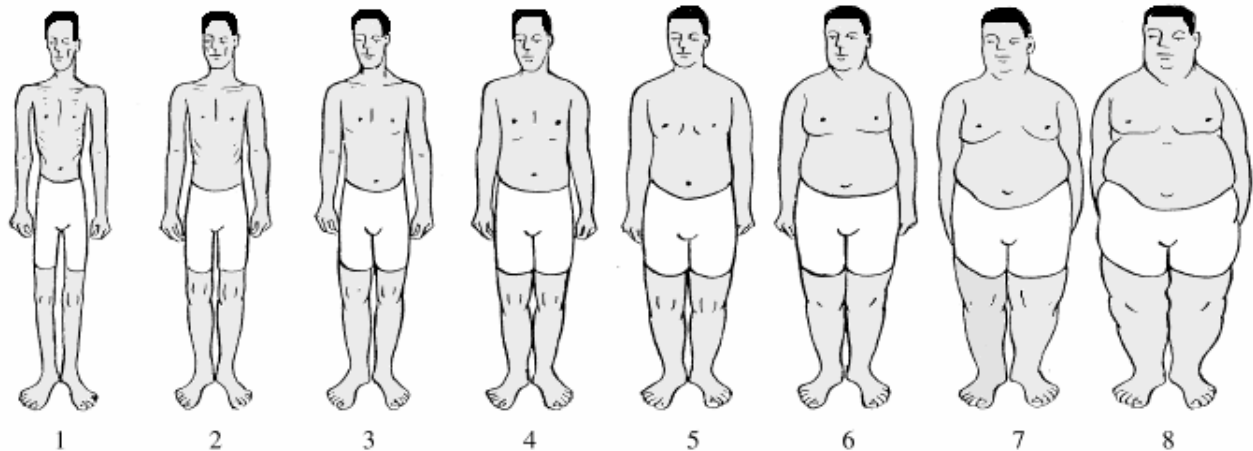


Figure 2 The illustrations of body shapes used for men.
