### ABSTRACT

The UNHCR Results Monitoring Survey (RMS) is a household-level survey on persons of concern (PoC) to UNHCR directly or indirectly assisted by UNHCR, including refugees and asylum seekers, internally displaced persons, returnees, stateless and others of concern. The objective of the survey is to monitor impact and outcome level indicators on education, healthcare, livelihoods, protection concerns, shelter, and water and sanitation. The results contribute to an evidence base for reporting against UNHCR's multi-year strategies to key stakeholders.

The RMS can be implemented in any operational context. A standard structured questionnaire has been developed for the RMS, which can be conducted as a stand-alone survey or flexibly integrated with other data collection exercises. The data includes indicators collected at both the household and individual (household-member) level, and results are statistically representative.

This RMS took place in Ethiopia from June 2022 to August 2022. The surveyed population was refugees and asylum seekers in Ethiopia. The survey uses a cross-sectional, stratified two stage cluster random sampling design. The sample frame was ProGres which covers the majority of refugees and asylum seekers in the country. Data subjects were interviewed over the phone.

This dataset is the anonymized version of the original data.

## SAMPLING PROCEDURE

The UNHCR Ethiopia Country Office (ETH-CO) provided a list of RAS Communities drawing from the proGres database which was last updated in March 2022. The Communities are the smallest geographic units in the Ethiopia proGres database. The list of Communities, which are mapped to their corresponding Region, Zone, Camp and Block, served as the sampling frame for the RAS population in Ethiopia. The RAS sampling frame included a total of about 745,000 individuals, which according to UNHCR covers 99 percent of the total RAS population in the country. 30 households were randomly selected from each cluster.
