I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank in gaining a better understanding of how stakeholders in Croatia perceive the Bank;
- Obtain systematic feedback from stakeholders in Croatia regarding:
 - Their views regarding the general environment in Croatia;
 - Their overall attitudes toward the World Bank in Croatia;
 - Overall impressions of the World Bank's effectiveness and results, knowledge and research, and communication and information sharing in Croatia; and
 - Perceptions of the World Bank's future role in Croatia.
- Use data to help inform the Croatia country team's strategy.

II. Methodology

In May-July 2012, 694 stakeholders of the World Bank in Croatia were invited to provide their opinions on the Bank's assistance to the country by participating in a country survey. Participants in the survey were drawn from among the office of the President; the office of the Prime Minister; the office of a Minister; the office of a Parliamentarian; employees of a ministry, ministerial department, or implementation agency; consultants/contractors working on World Bank-supported projects/programs; project management units (PMUs) overseeing implementation of a project; local government officials or staff; international partners; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs; community-based organizations (CBOs); the media; independent government institutions; trade unions; academia/research institutes/think tanks; and the judiciary branch. A total of 198 stakeholders participated in the country survey (29%).

Respondents received questionnaires via post or email and returned them accordingly.

Respondents were asked about: general issues facing Croatia; their overall attitudes toward the Bank; the World Bank's effectiveness and results; the Bank's knowledge; working with the World Bank; the Bank's future role in Croatia; and the Bank's communication and information sharing in Croatia.

- A. General Issues facing Croatia: Respondents were asked to indicate whether Croatia is headed in the right direction, what they thought were the top three most important development priorities, which areas would contribute most to achieving EU integration and EU income convergence for Croatia, and which areas would contribute most to generating economic growth in Croatia.
- B. Overall Attitudes toward the World Bank: Respondents were asked to rate their familiarity with the World Bank, the Bank's effectiveness in Croatia, Bank staff preparedness, the extent to which the Bank should seek to influence the global development agenda, their agreement

with various statements regarding the Bank's work, and the extent to which the Bank is an effective development partner. Respondents were also asked to indicate the sectoral areas on which it would be most productive for the Bank to focus its resources, the Bank's greatest values and greatest weaknesses in its work, the most and least effective instruments in helping Croatia achieve EU integration and EU income convergence, with which groups the Bank should collaborate more, and to what reasons respondents attributed failed or slow reform efforts.


- C. World Bank Effectiveness and Results: Respondents were asked to rate the extent to which the Bank's work helps achieve development results in Croatia, the extent to which the Bank meets Croatia's need for knowledge services and financial instruments, and the Bank's level of effectiveness across thirty-six development areas, such as EU integration and EU income convergence, economic growth, job creation, and others.
- D. The World Bank's Knowledge: Respondents were asked to indicate how frequently they consult Bank knowledge/research, the areas on which the Bank should focus its research efforts, and to rate the effectiveness and quality of the Bank's knowledge/research, including how significant of a contribution it makes to development results, its technical quality, the Bank's effectiveness at providing linkage to non-Bank expertise, and the extent to which Croatia received value for money from the Bank's fee-for-service products.
- E. Working with the World Bank: Respondents were asked to rate their level of agreement with a series of statements regarding working with the Bank, such as the World Bank's "Safeguard Policy" requirements being reasonable, the Bank imposing reasonable conditions on its lending, disbursing funds promptly, increasing Croatia's institutional capacity, and providing effective implementation support.
- F. The Future Role of the World Bank in Croatia: Respondents were asked to rate how significant a role the Bank should play in Croatia's EU integration and EU income convergence in the near future and to indicate what the Bank should do to make itself of greater value in Croatia.
- G. Communication and Information Sharing: Respondents were asked to indicate where they get information about economic and social development issues, how they prefer to receive information from the Bank, and their usage and evaluation of the Bank's websites. Respondents were asked about their awareness of the Bank's Access to Information policy, past information requests from the Bank, and their level of agreement that they use more data from the World Bank as a result of the Bank's Open Data policy. Respondents were also asked about their level of agreement that they know how to find information from the Bank and that the Bank is responsive to information requests.
- H. Background Information: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the World Bank, their exposure to the Bank in Croatia, and their geographic location.

When possible, responses from respondents completing this year's country survey were compared to responses from the 207 respondents (35% response rate) who completed the country survey in FY 2008 and the 122 respondents (27% response rate) who completed the survey in FY 2003. Notations and/or charts are included when these comparisons were possible.


Current Position

- For further analyses, the small number of consultants/contractors working on Bank-supported projects were combined with respondents from PMUs; respondents from multilateral agencies were combined with international partners; respondents from NGOs were combined with those from community based organizations and trade unions; respondents from the financial sector/private banks were combined with those from private sector organizations; and the few respondents from the office of Parliamentarian, the judiciary branch, and local officials were included in the “Other” category. Note that there were no respondents from the office of the President, Prime Minister, bilateral agencies, or private foundations.


Area of Primary Specialization

Geographic Location



- The vast majority of respondents indicated that they were located in the Zagreb area. Because of the small number of respondents from other areas, these locations were included in the “Other” category for all further analyses.




Familiarity with the World Bank

- Across all respondents, familiarity with the Bank received a mean rating of 6.4; this was significantly lower than the mean rating received in the FY '08 country survey (6.9) and statistically similar to the mean rating received in the FY '03 country survey (6.5).
 - Respondents from the office of Minister and PMUs/consultants on Bank supported projects indicated the highest levels of familiarity whereas respondents from NGOs/CBOs/ trade unions indicated significantly lower levels of familiarity.
 - It should be noted that respondents' ratings of familiarity with the Bank were significantly, strongly correlated with their perceptions of the Bank's overall effectiveness in Croatia, the Bank's ability to help achieve development results, and the Bank's relevance to Croatia's development.



Development Priority


- In the FY '08 country survey*, economic growth (46%) and government effectiveness/governance (36%) were considered the most important development priorities for Croatia.







The World Bank's Overall Effectiveness (*Indicator Question*)


- Across all respondents, ratings of the World Bank's overall effectiveness in Croatia received a mean rating of 6.5; this was statistically similar to the mean ratings received in the FY '08 country survey (6.8) and in the FY '03 country survey (6.9).
- Respondents across all stakeholder groups and both geographic locations had statistically similar ratings for the World Bank's overall effectiveness in Croatia.
 - Although it was not a significant difference, international partners and respondents from multilateral agencies had the highest ratings of the World Bank's overall effectiveness whereas respondents from private sector organizations/financial sector/private banks had the lowest ratings.

Achieving Development Results (*Indicator Question*)


- International partners and respondents from multilateral agencies had significantly higher ratings for the World Bank helping achieve development results in Croatia than respondents from NGOs/CBOs/trade unions.
- Respondents from both geographic locations had statistically similar ratings for the World Bank helping achieve development results in Croatia.

Staff Preparedness (*Indicator Question*)


- Respondents across all stakeholder groups and both geographic locations had statistically similar ratings for the World Bank's staff being well prepared to help Croatia solve its most complicated development challenges.
 - Although it was not a significant difference, international partners and respondents from multilateral agencies had the highest ratings for the World Bank's staff preparedness whereas respondents from the media and private sector organizations/financial sector/private banks had the lowest ratings.

Greatest Value

- Respondents in the FY '08 country survey* indicated that the Bank's greatest values to Croatia were Bank's knowledge (41%) and financial resources (34%).



Greatest Weakness


- Respondents in the FY '08 survey* indicated that the Bank's greatest weakness in its work was being too bureaucratic in its operational policies and procedures (79%) in Croatia.



Specific Areas of Effectiveness (continued)

- There were significant stakeholder differences in their ratings of the Bank's effectiveness across eight of these thirty-six areas. For the most part, international partners, respondents from multilateral agencies, and PMUs/consultants on Bank supported projects had the highest ratings across these areas whereas respondents from NGOs/CBOs/trade unions, private sector organizations/financial sector/private banks, and the media tended to have significantly lower ratings for the Bank's effectiveness across these areas. Those areas with significant stakeholder group differences were:
 - "Environmental sustainability";
 - "Global integration";
 - "Water and sanitation";
 - "Law and justice";
 - "Health";
 - "Rural development";
 - "Domestic private sector development"; and
 - "Poverty reduction".


- There were significant differences between geographic locations across three of these thirty-six areas. In all three instances, respondents from Zagreb had significantly higher ratings for the Bank's effectiveness across these areas than respondents from other locations. Those areas with significant differences were:
 - "Information and communications technology";
 - "Economic growth"; and
 - "Public financial management".

Specific Areas of Effectiveness (continued)

- Respondents in this year's country survey gave significantly higher ratings for the Bank's effectiveness at urban development compared to respondents in the FY'08 country survey. At the same time, respondents in this year's country survey gave significantly lower ratings for the Bank's effectiveness at economic growth, domestic private sector development, and natural resource management compared to respondents in both the FY'08 and FY'03 country surveys.

Drivers of Effectiveness


To determine the key drivers of respondents' ratings of the Bank's overall effectiveness and ratings of its ability to help achieve development results in Croatia, bivariate correlational analyses were conducted using respondents' ratings of the thirty-five specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the Bank's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the Bank's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank's overall effectiveness or perceptions of the Bank's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's overall effectiveness in Croatia. The areas determined to be key drivers from these analyses were:
 - Poverty reduction;
 - Equality of opportunity; and
 - Monitoring and evaluation.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's ability to help achieve development results in Croatia, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - Equality of opportunity;
 - Foreign direct investment; and
 - Governance.


Knowledge: Frequency of Use


Knowledge: Meeting Croatia's Knowledge Needs (*Indicator Question*)

- International partners and respondents from multilateral agencies gave the highest ratings for the Bank meeting Croatia's needs for knowledge services whereas respondents from NGOs/CBOs/trade unions and the media gave significantly lower ratings.
- Respondents from both geographic locations had statistically similar ratings.


Knowledge: Focusing Bank Research

Knowledge: Effectiveness


- There were significant stakeholder group differences in their ratings of the World Bank's knowledge and research effectiveness in terms of enhancing knowledge and/or skills; providing support for program implementation; and contributing to good policy making. International partners, respondents from multilateral agencies, and 'other' organizations gave the highest ratings for the Bank's effectiveness whereas respondents from NGOs/CBOs/trade unions gave significantly lower ratings.

Knowledge: Qualities


- There were significant differences between stakeholder groups across three of these qualities of the World Bank's knowledge and research: accessibility (well written and easy to understand), relevance to Croatia's development priorities, and including appropriate level of stakeholder involvement during preparation. For the most part, international partners, respondents from multilateral agencies, PMUs/consultants on Bank supported projects, and independent government institutions gave the highest ratings regarding these three aspects of the Bank's knowledge and research whereas respondents from NGOs/CBOs/trade unions and the media tended to give significantly lower ratings.
- There were significant differences between two geographic locations. Respondents from Zagreb gave significantly higher ratings for the Bank's knowledge and research being adaptable to Croatia's specific development challenges and country circumstances than respondents from other geographic areas in Croatia.




Knowledge: Technical Quality (*Indicator Question*)

- Respondents across all stakeholder groups and both geographic locations had statistically similar ratings for the technical quality of the World Bank's knowledge and research.





Knowledge: Linkage to Non-Bank Expertise





Knowledge: World Bank' Fee-For-Service Products/Services



Instruments: Most Effective




Instruments: Least Effective


- International partners, respondents from multilateral agencies, and 'other' organizations had the highest levels of agreement that the Bank's financial instruments meet Croatia's needs whereas respondents from private sector organizations/financial sector/private banks had significantly lower levels of agreement.

The World Bank's Work in Croatia


- Respondents in this year's country survey had significantly lower levels of agreement that the Bank currently plays a relevant role in development in Croatia and that its work is aligned with respondents' development priorities compared to respondents from the FY'03 country survey.
- There were significant stakeholder group differences in their levels of agreement that the Bank currently plays a relevant role in development in Croatia, that its work is aligned with respondents' development priorities, and that its programs and strategies are realistic. International partners, respondents from multilateral agencies, and independent government institutions tended to have the highest levels of agreement with these statements, whereas respondents from NGOs/CBOs/trade unions and private sector organizations/financial sector/private banks tended to have significantly lower levels of agreement.

- Respondents across all stakeholder groups, both geographic locations, and FY'03, FY'08, and FY'12 country surveys had statistically similar levels of agreement for all these aspects of World Bank's work in Croatia.





The World Bank as an Effective Development Partner

- Respondents in this year's country survey gave significantly lower ratings for staff accessibility, straightforwardness and honesty, and flexibility in terms of the changing country circumstances, compared to respondents in the FY'08 and FY'03 country surveys.
- There were significant stakeholder group differences in their ratings across eight of these aspects of the Bank being an effective development partner: collaboration with international and European partners, staff accessibility, openness, straightforwardness and honesty, being inclusive, responsiveness, collaboration with groups outside of the Government, and flexibility in terms of the Bank's products and services. International partners and respondents from multilateral agencies tended to have the highest ratings for these eight aspects whereas respondents from private sector organizations/financial sector/private banks tended to have significantly lower ratings.
- There were significant differences between two geographic locations. Respondents from Zagreb gave significantly higher ratings for staff accessibility than respondent from other geographic areas.








- Respondents indicated that the World Bank should work more closely with the private sector and local governments to ensure better development results in Croatia.


Influencing the Global Development Agenda








Internet Access



Website Usage


