I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank in gaining a better understanding of how stakeholders in Belarus perceive the Bank;
- Obtain systematic feedback from stakeholders in Belarus regarding:
 - Their views regarding the general environment in Belarus;
 - Their overall attitudes toward the World Bank in Belarus;
 - Overall impressions of the World Bank's effectiveness and results, knowledge and research, and communication and information sharing in Belarus; and
 - Perceptions of the World Bank's future role in Belarus.
- Use data to help inform the Belarus country team's strategy.

II. Methodology

In January 2013, 190 stakeholders of the World Bank in Belarus were invited to provide their opinions on the Bank's assistance to the country by participating in a country survey. Participants in the survey were drawn from among the office of the Presidential Administration; the office of the Prime Minister; the office of a Minister; the office of a Parliamentarian; employees of a ministry or a state committee; project management units (PMUs) overseeing implementation of a project; local government officials or staff; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; CSOs; the media; academia/research institutes/think tanks; and beneficiaries of a program. A total of 115 stakeholders participated in the country survey (61% response rate).

Respondents received questionnaires via post or email and returned them accordingly. Respondents were asked about: general issues facing Belarus; their overall attitudes toward the Bank; the World Bank's effectiveness and results; the Bank's knowledge; working with the World Bank; the Bank's future role in Belarus; and the Bank's communication and information sharing in Belarus.

Every country that engages in the Country Survey must include specific indicator questions that will be aggregated for the World Bank's annual Corporate Scorecard. These questions are identified throughout the survey report.

- A. General Issues Facing Belarus: Respondents were asked to indicate whether Belarus is headed in the right direction, what they thought were the top three most important development priorities, and which areas of development would contribute most to improving people's lives and generating economic growth in Belarus.

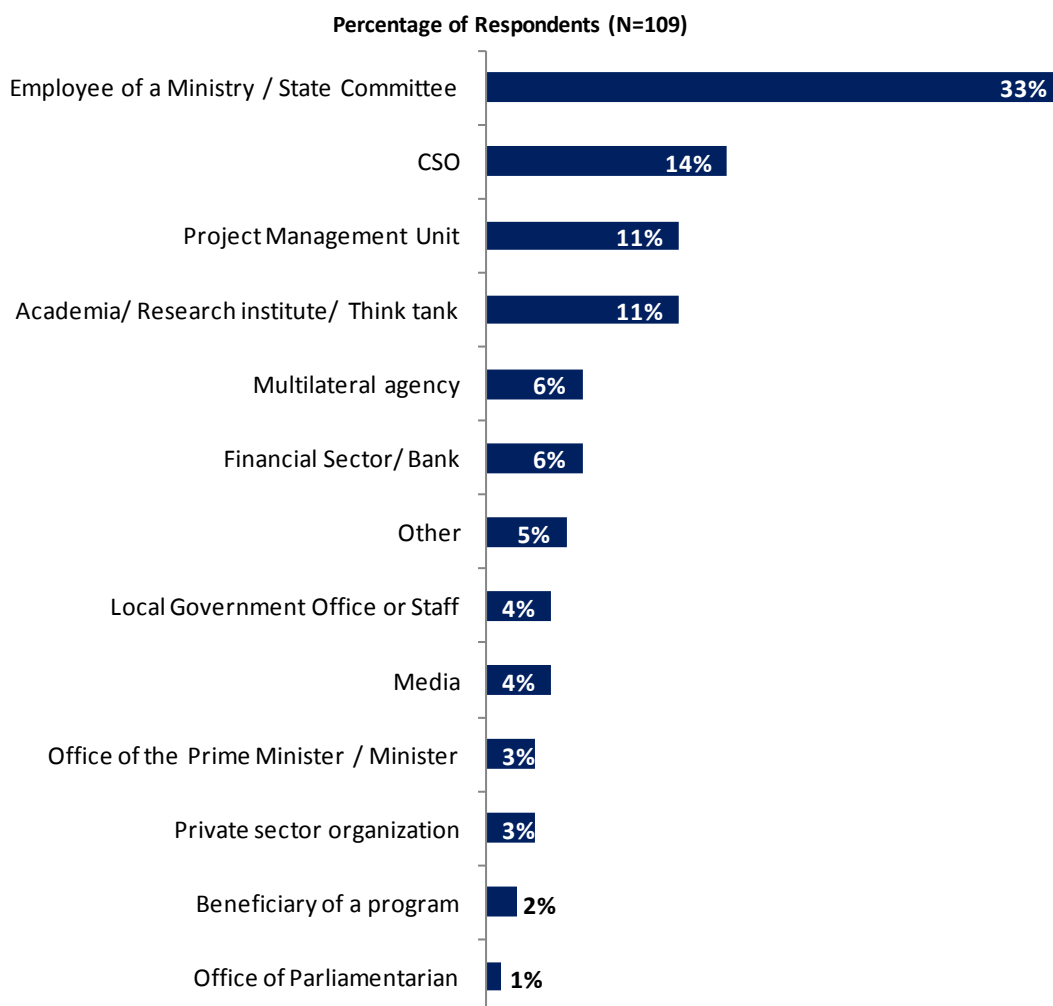
II. Methodology (continued)

- B. Overall Attitudes toward the World Bank: Respondents were asked to rate their familiarity with the World Bank, the Bank's effectiveness in Belarus, Bank staff preparedness to help Belarus solve its development challenges, their agreement with various statements regarding the Bank's work, and the extent to which the Bank is an effective development partner. Respondents were also asked to indicate the sectoral areas on which it would be most productive for the Bank to focus its resources, the Bank's greatest values and greatest weaknesses in its work, the most effective instruments in helping to promote development and reduce poverty in Belarus, with which stakeholder groups the Bank should collaborate more, and to what reasons respondents attributed failed or slow reform efforts.
- C. World Bank Effectiveness and Results: Respondents were asked to rate the extent to which the Bank's work helps achieve development results in Belarus, the extent to which the Bank meets Belarus's needs for knowledge services and financial instruments, and the Bank's level of effectiveness across thirty development areas, such as economic growth, governance and anti corruption, job creation, and others.
- D. The World Bank's Knowledge: Respondents were asked to indicate how frequently they consult Bank knowledge/research, the areas on which the Bank should focus its research efforts, and to rate the effectiveness and quality of the Bank's knowledge/research, including how significant of a contribution it makes to development results in Belarus and its technical quality.
- E. Working with the World Bank: Respondents were asked to rate their level of agreement with a series of statements regarding working with the Bank, such as the World Bank's "Safeguard Policy" requirements being reasonable, the Bank imposing reasonable conditions on its lending, disbursing funds promptly, increasing Belarus' institutional capacity, and providing effective implementation support.
- F. The Future Role of the World Bank in Belarus: Respondents were asked to rate how significant a role the Bank should play in Belarus' development in the near future and to indicate what the Bank should do to make itself of greater value in Belarus.
- G. Communication and Information Sharing: Respondents were asked to indicate how they get information about economic and social development issues, how they prefer to receive information from the Bank, and their usage and evaluation of the Bank's websites. Respondents were asked about their awareness of the Bank's Access to Information policy, past information requests from the Bank, and their level of agreement that they use more data from the World Bank as a result of the Bank's Open Data policy. Respondents were also asked about their level of agreement that they know how to find information from the Bank and that the Bank is responsive to their information requests.
- H. Background Information: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the World Bank, their exposure to the Bank in Belarus, and their geographic location.

Current Position

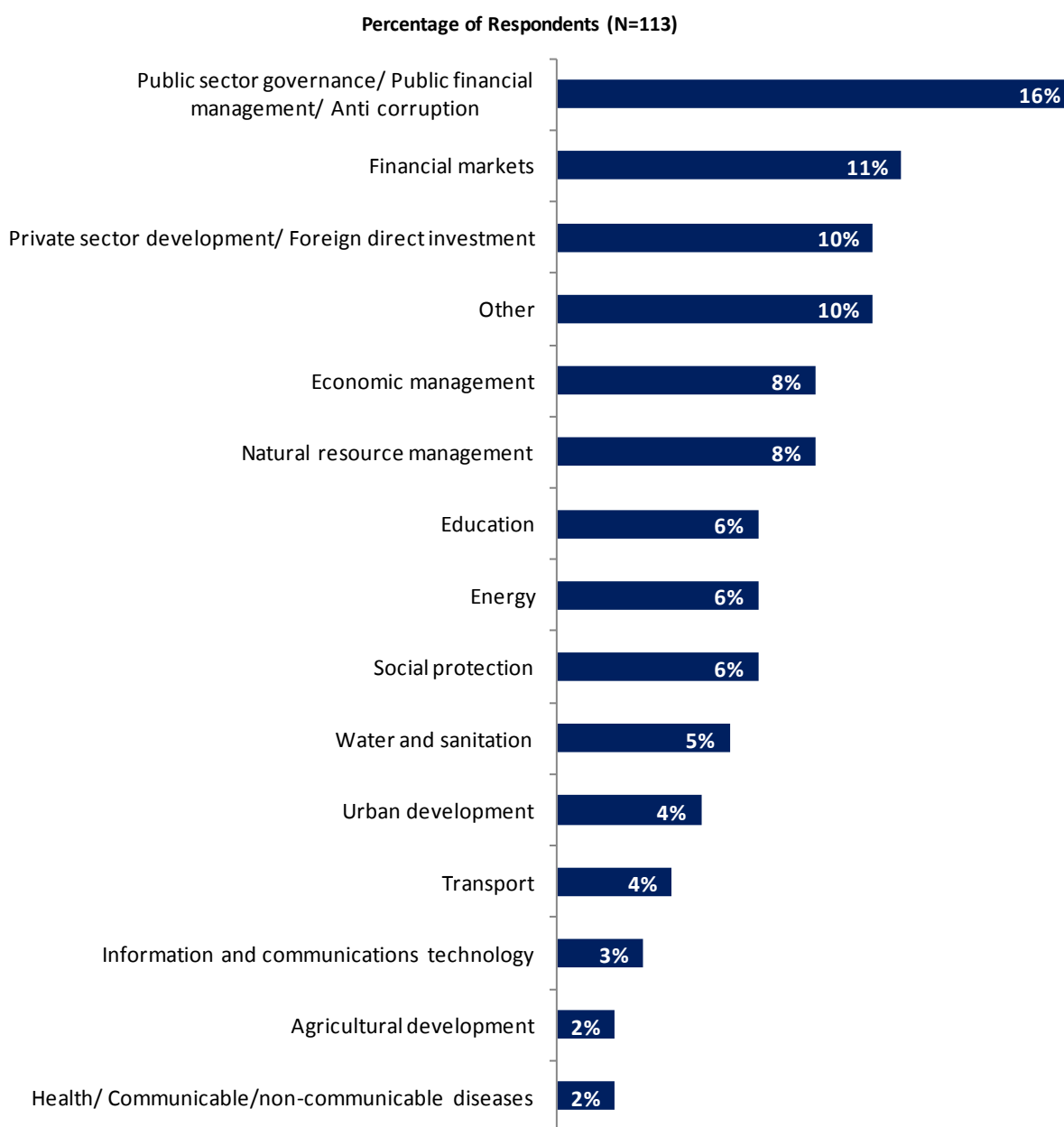
- For further analyses, the small number of respondents from private sector organizations were combined with respondents from the financial sector and banks, the few respondents from the office of the Prime Minister, the office of Minister, the office of Parliamentarian, and beneficiaries of a program were included in the “Other” category. Note that there were no respondents from the Presidential Administration and bilateral agencies.

Area of Primary Specialization

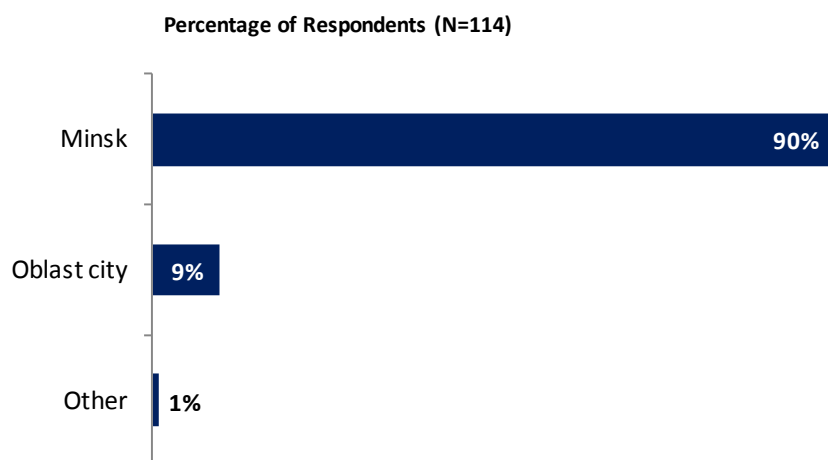


“Please identify the primary specialization of your work.” (Respondents chose from a list.)

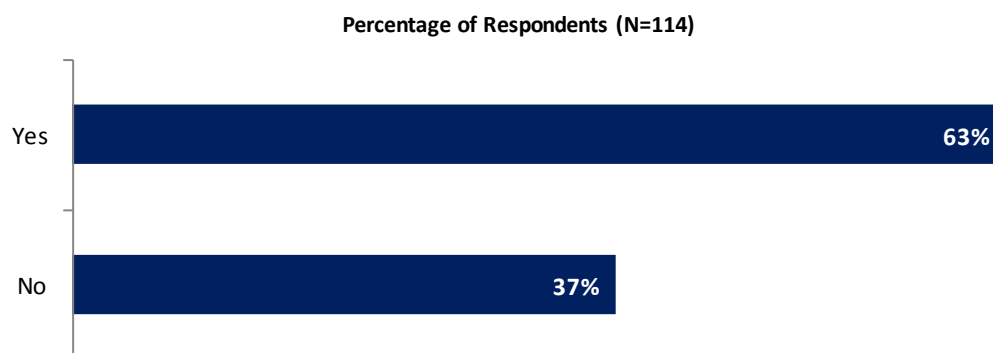


“Which best represents your geographic location?” (Respondents chose from a list.)

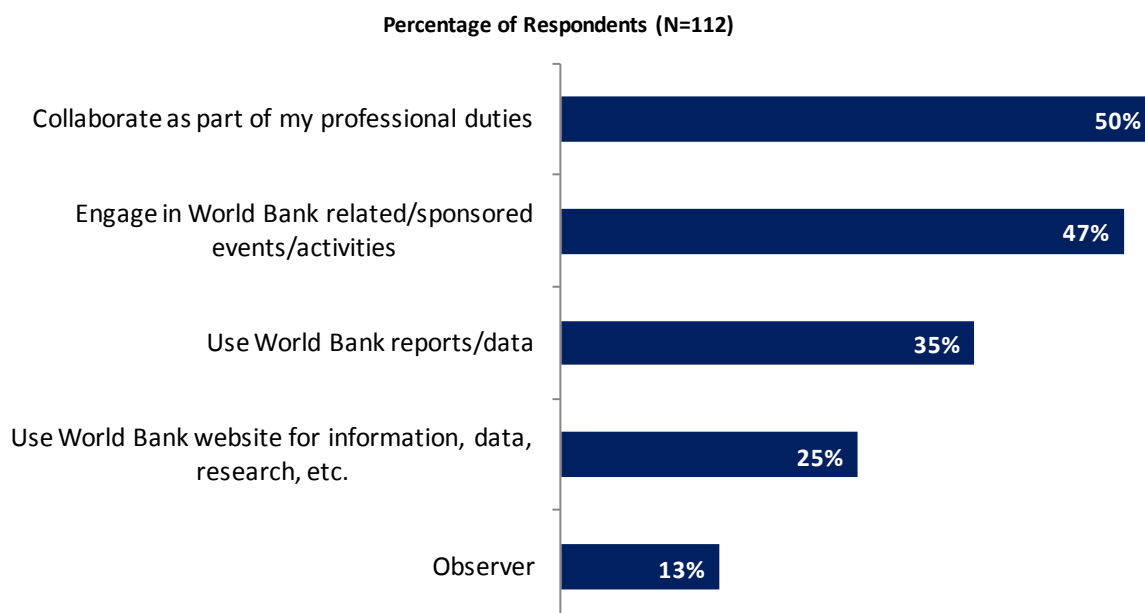

"Currently, do you professionally collaborate/work with the World Bank in your country?"

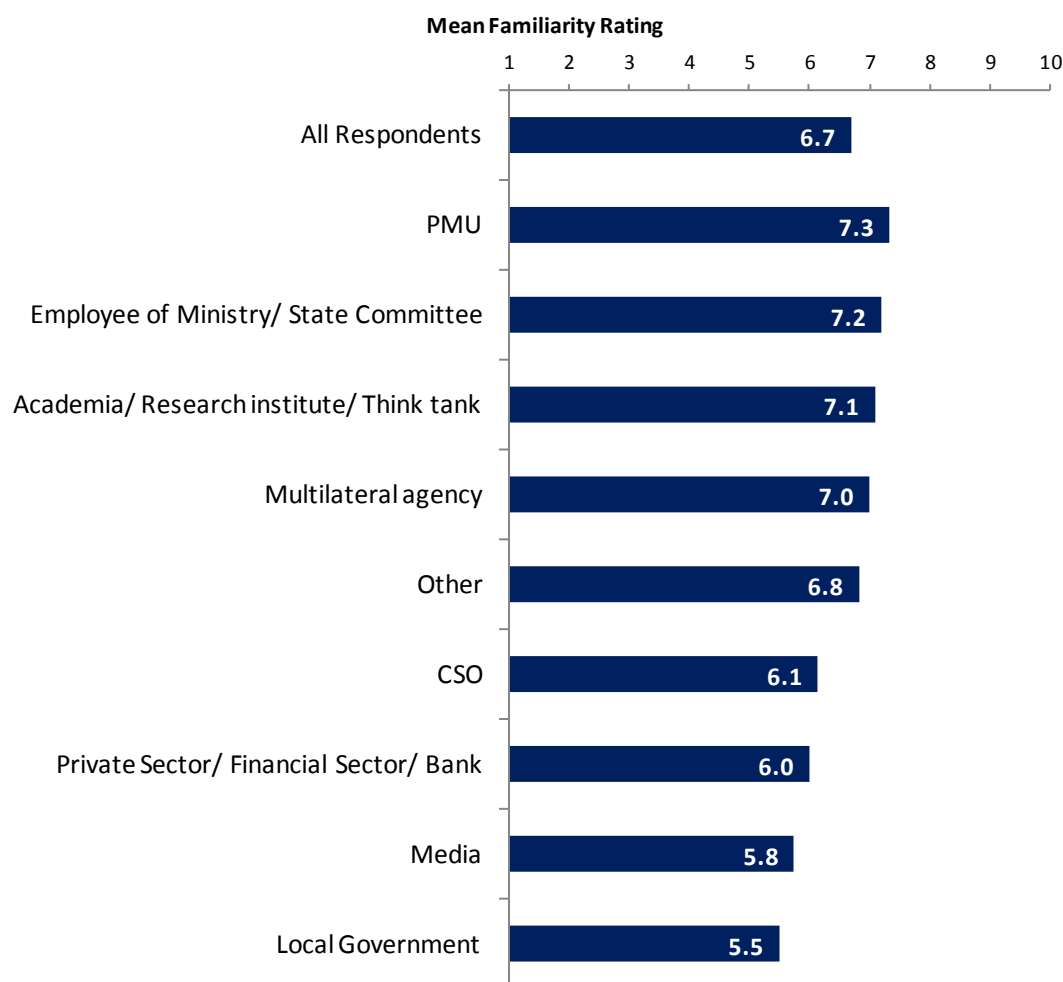


"Which of the following describes most of your exposure to the World Bank in Belarus? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

Familiarity with the World Bank

- Respondents across all stakeholder groups and geographic locations gave statistically similar ratings for their familiarity with the World Bank.
- It should be noted that respondents' ratings of familiarity with the Bank were significantly, strongly correlated with their perceptions of the Bank's overall effectiveness in Belarus, the Bank's ability to help achieve development results, and the Bank's relevance to Belarus's development.

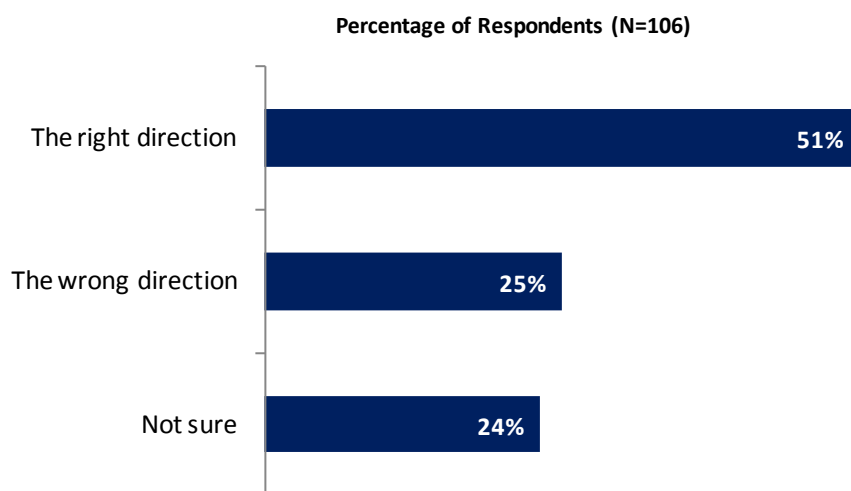


"How familiar are you with the work of the World Bank in Belarus, on a ten-point scale?"

Headed in the Right Direction

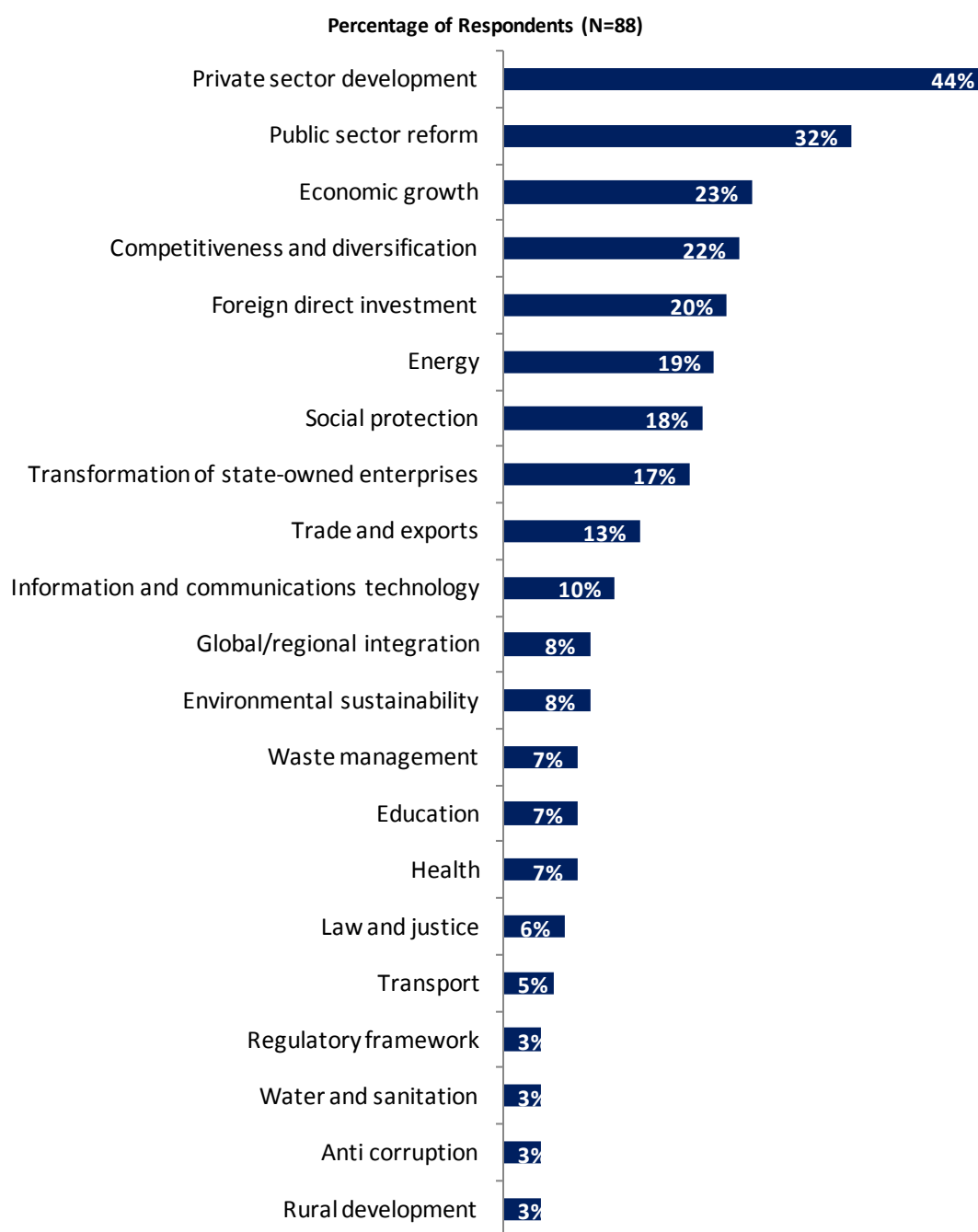
- A majority of employees of ministries/state committees and respondents from local government indicated that the Belarusian economy was headed in the right direction, while respondents from multilateral agencies and private sector organizations/financial sector/banks were more likely to indicate that the Belarusian economy was headed in the wrong direction. Respondents from PMUs tended to indicate that they were not sure whether the Belarusian economy was headed in the right or wrong direction.

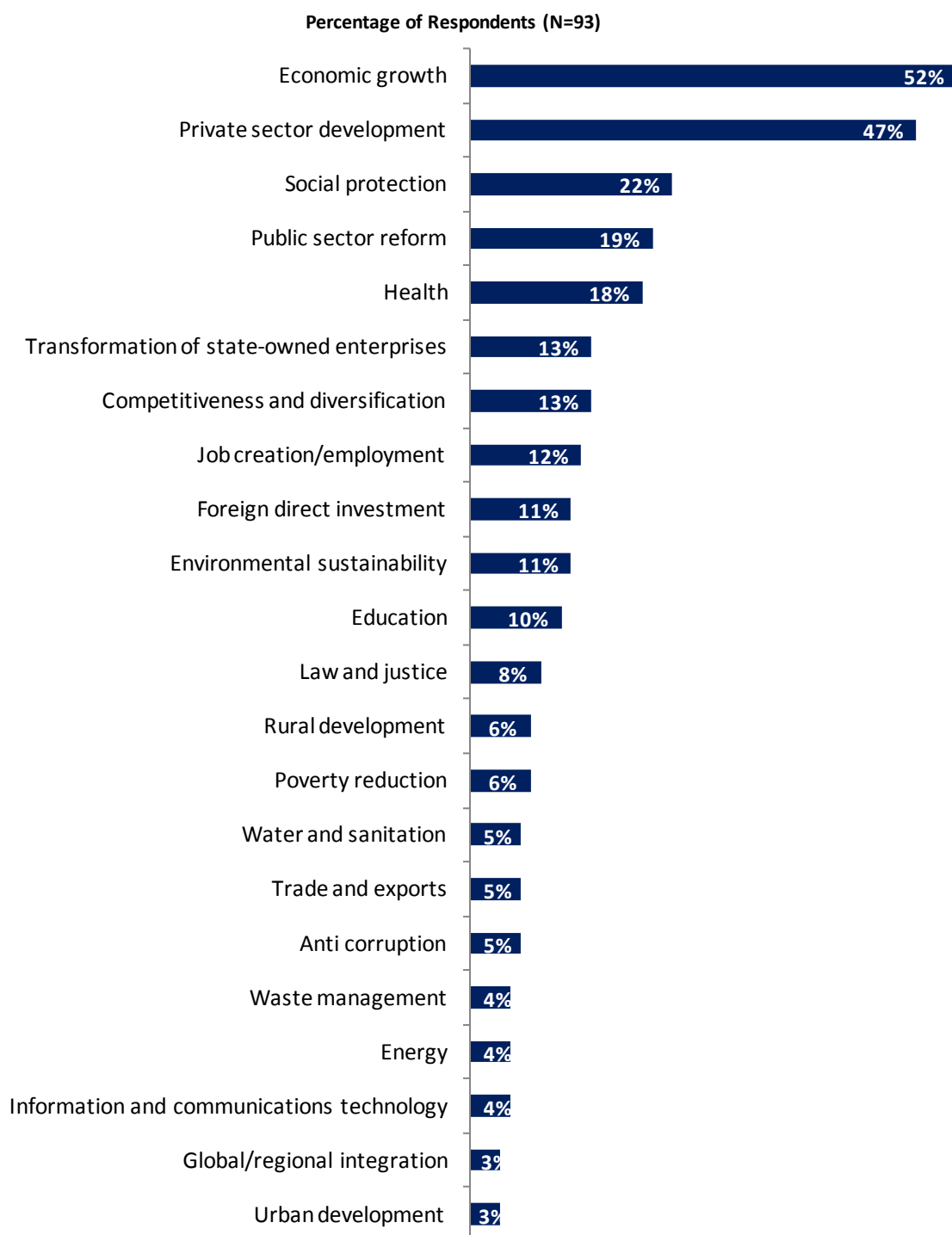
Development Priority

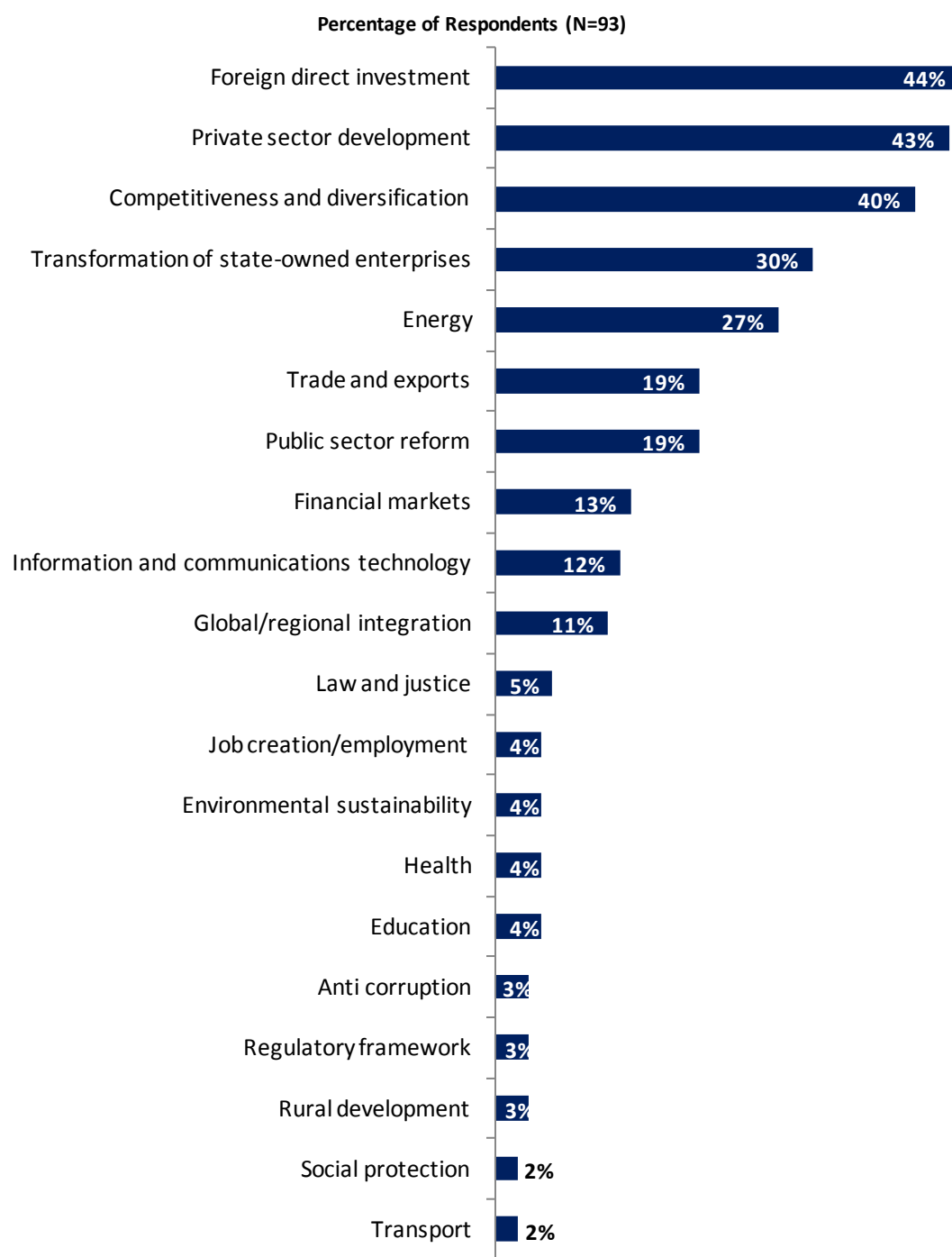
What Would Contribute Most to Improving Quality of People's Lives

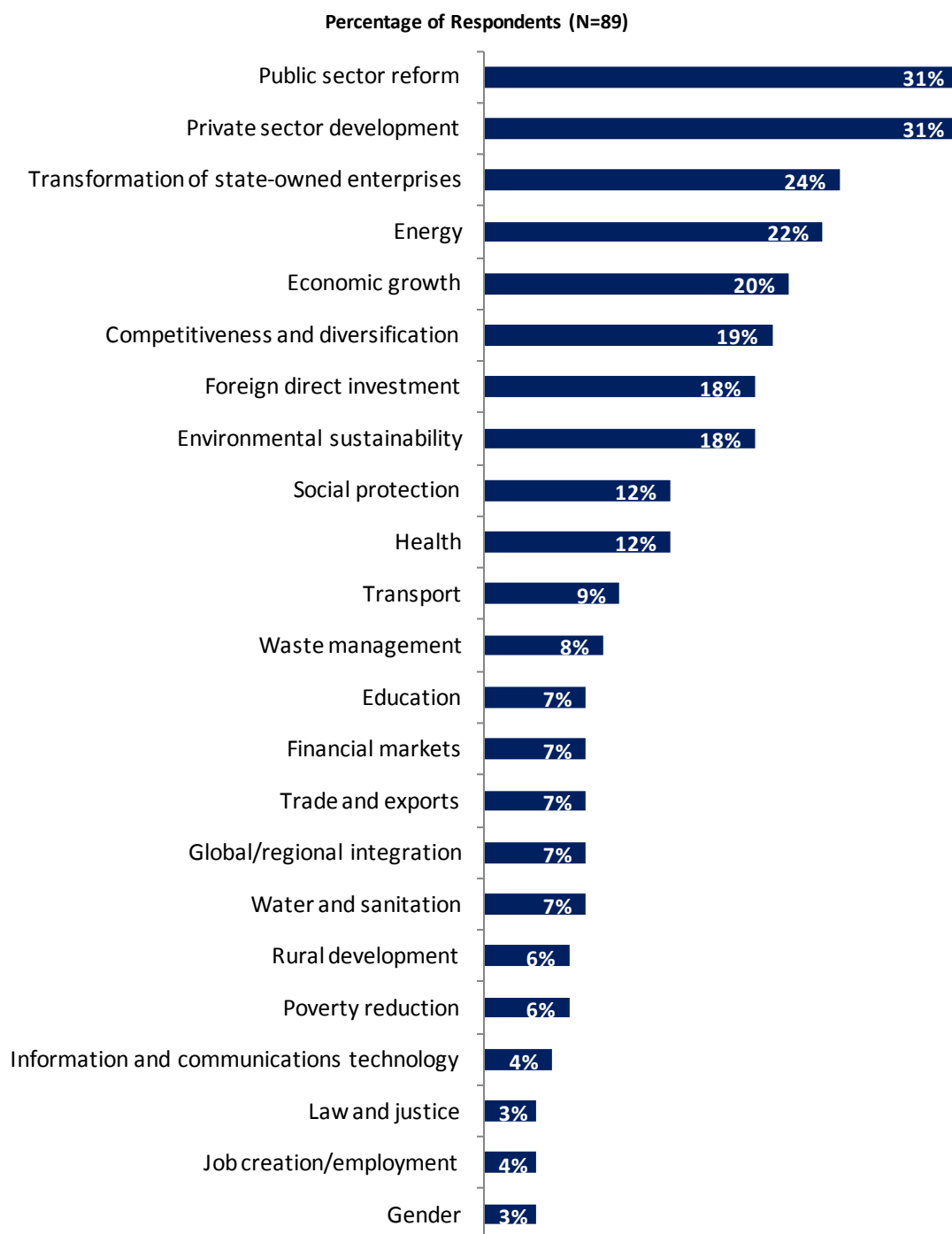
What Would Contribute Most to Generating Economic Growth

Where the World Bank Should Focus its Resources



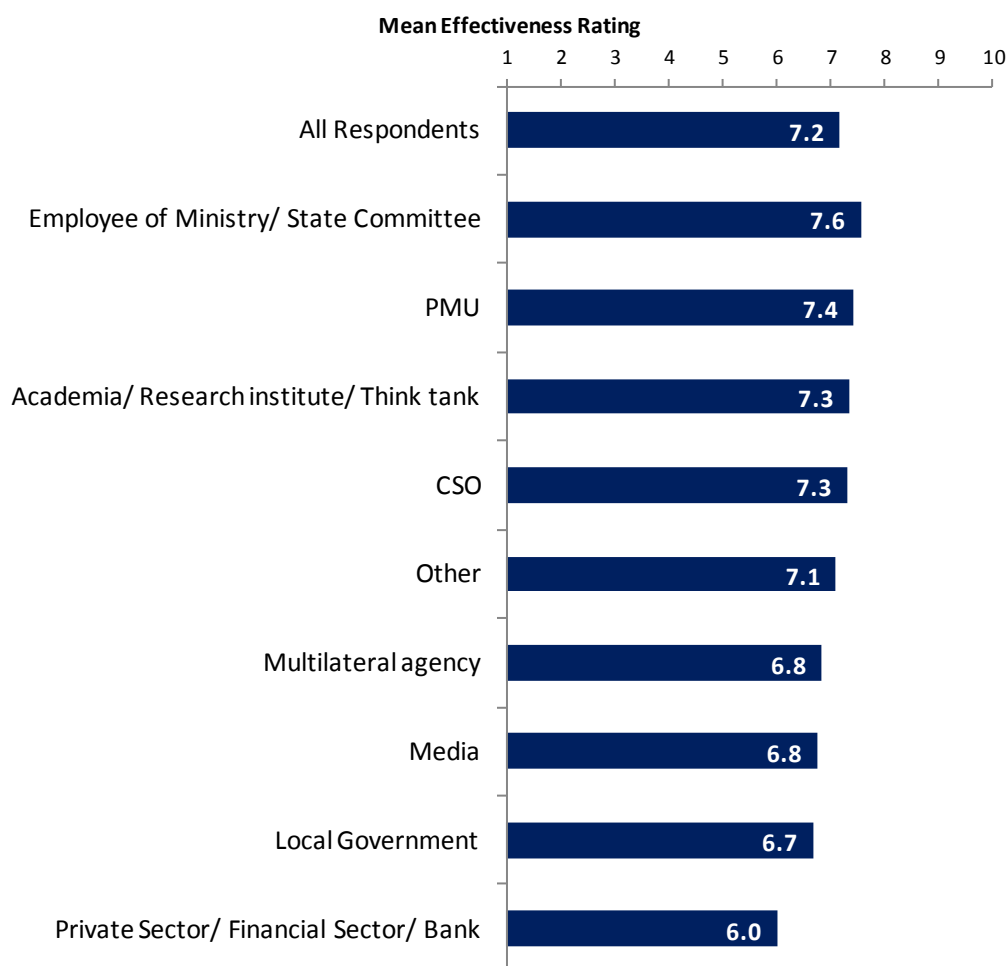

- Respondents across all stakeholder groups and geographic locations gave statistically similar ratings for the World Bank’s overall effectiveness in Belarus.

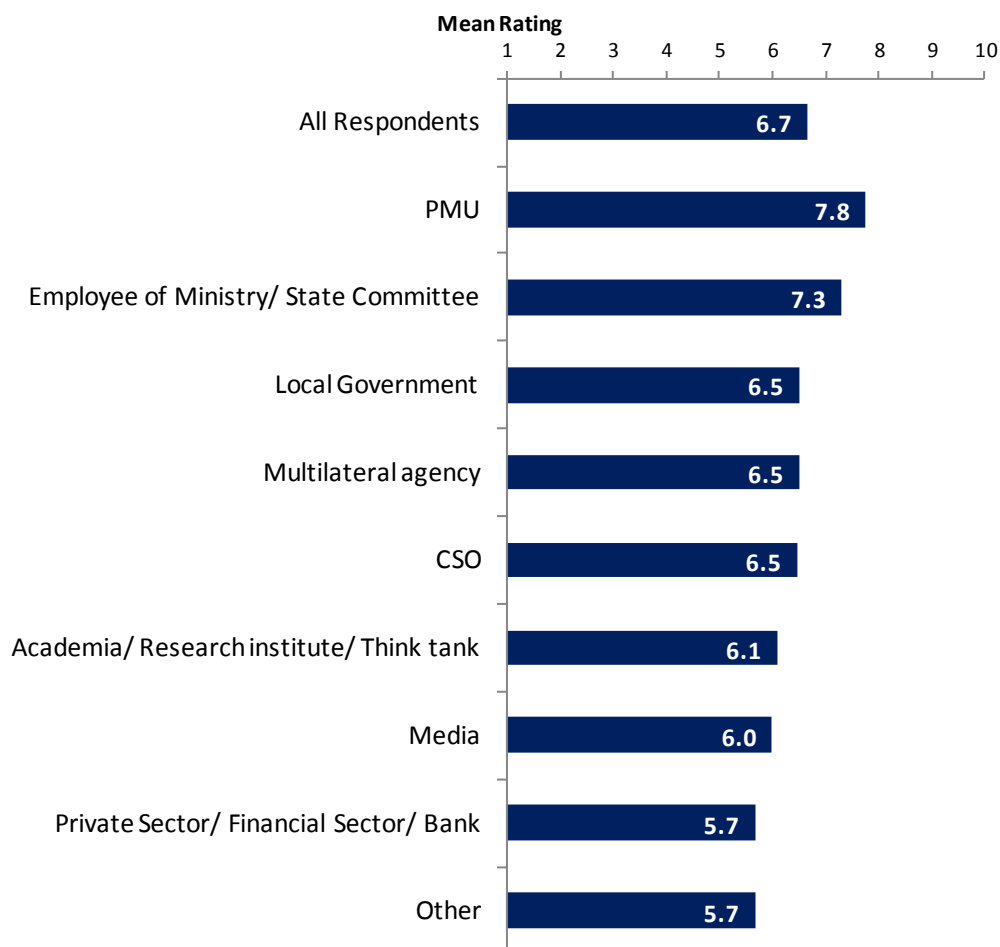

Achieving Development Results *(Indicator Question)*

- Respondents from PMUs and employees of ministries/state committees gave the highest ratings for the World Bank helping achieve development results in Belarus whereas respondents from the media, private sector organizations/financial sector/banks, and other organizations gave significantly lower ratings.
- Respondents from Minsk and other geographic areas gave statistically similar ratings.

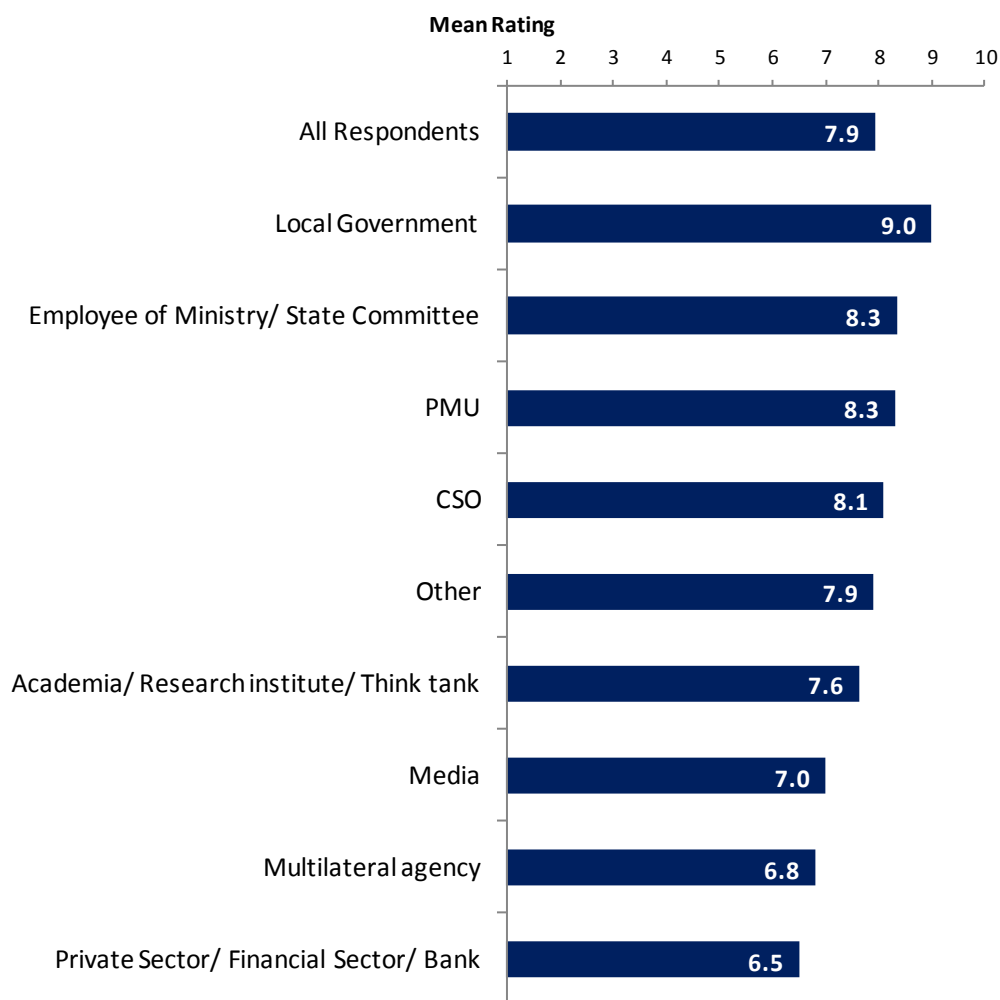


"To what extent does the World Bank's work help to achieve development results in Belarus, on a ten point scale?" (1-"To no degree at all", 10-"To a very significant degree")

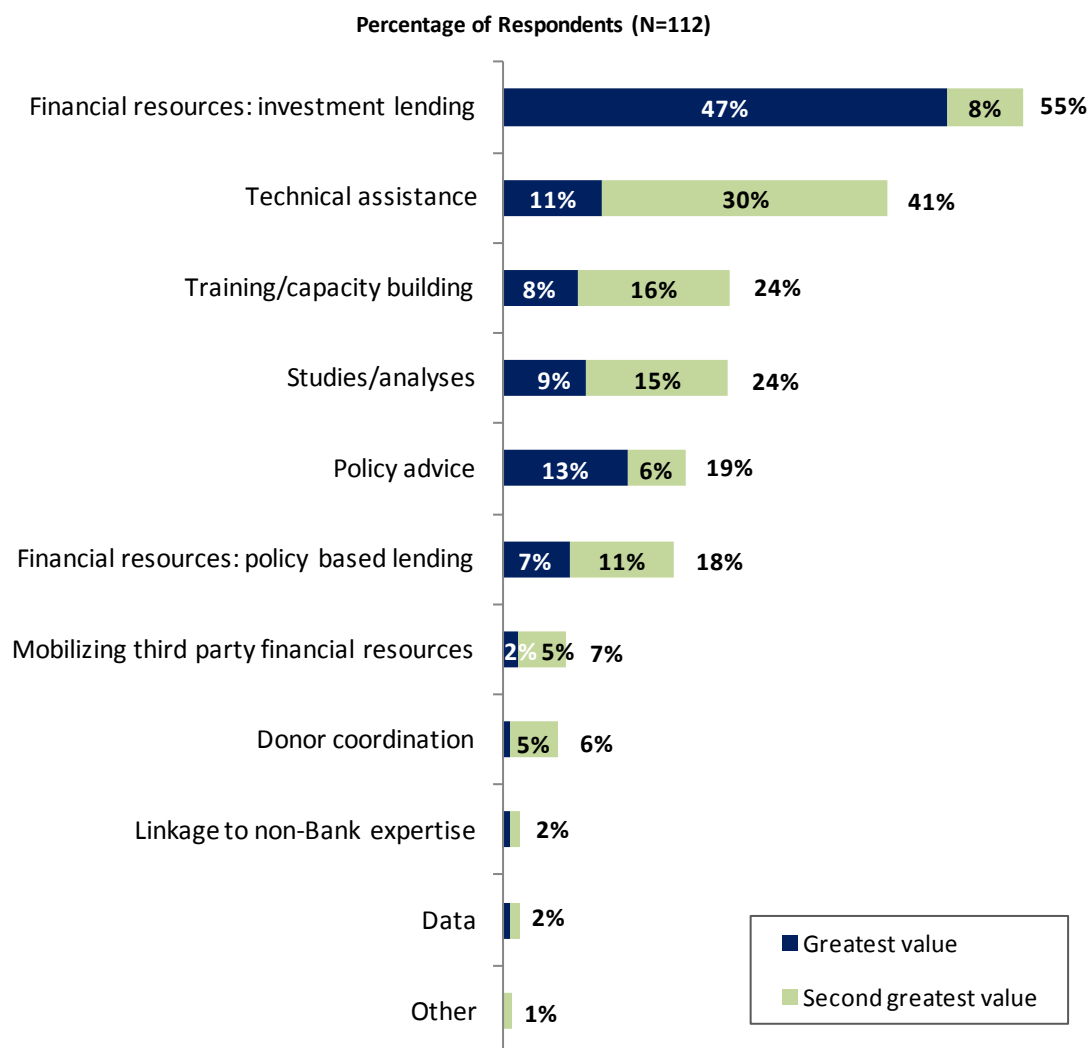

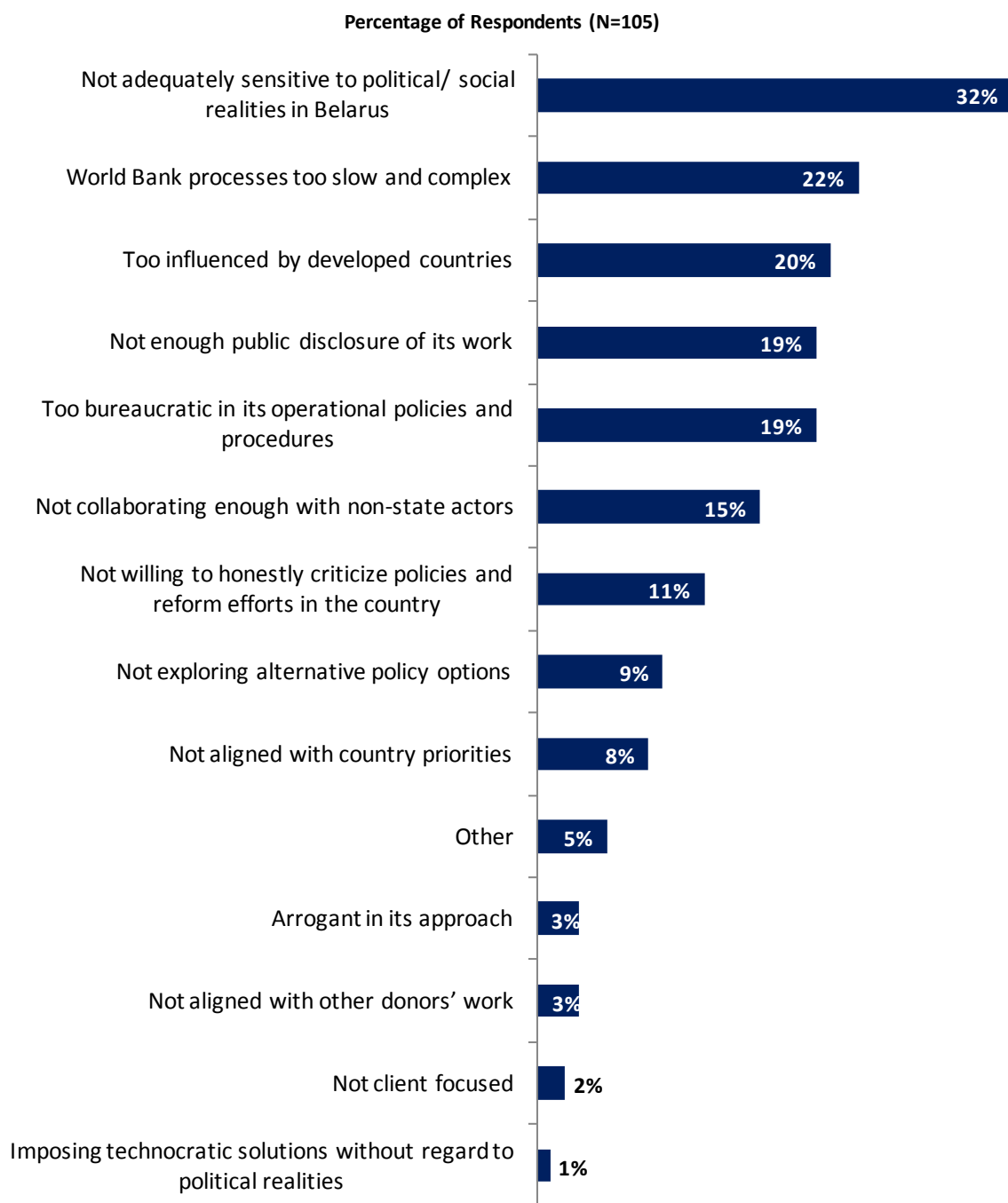
Greatest Value

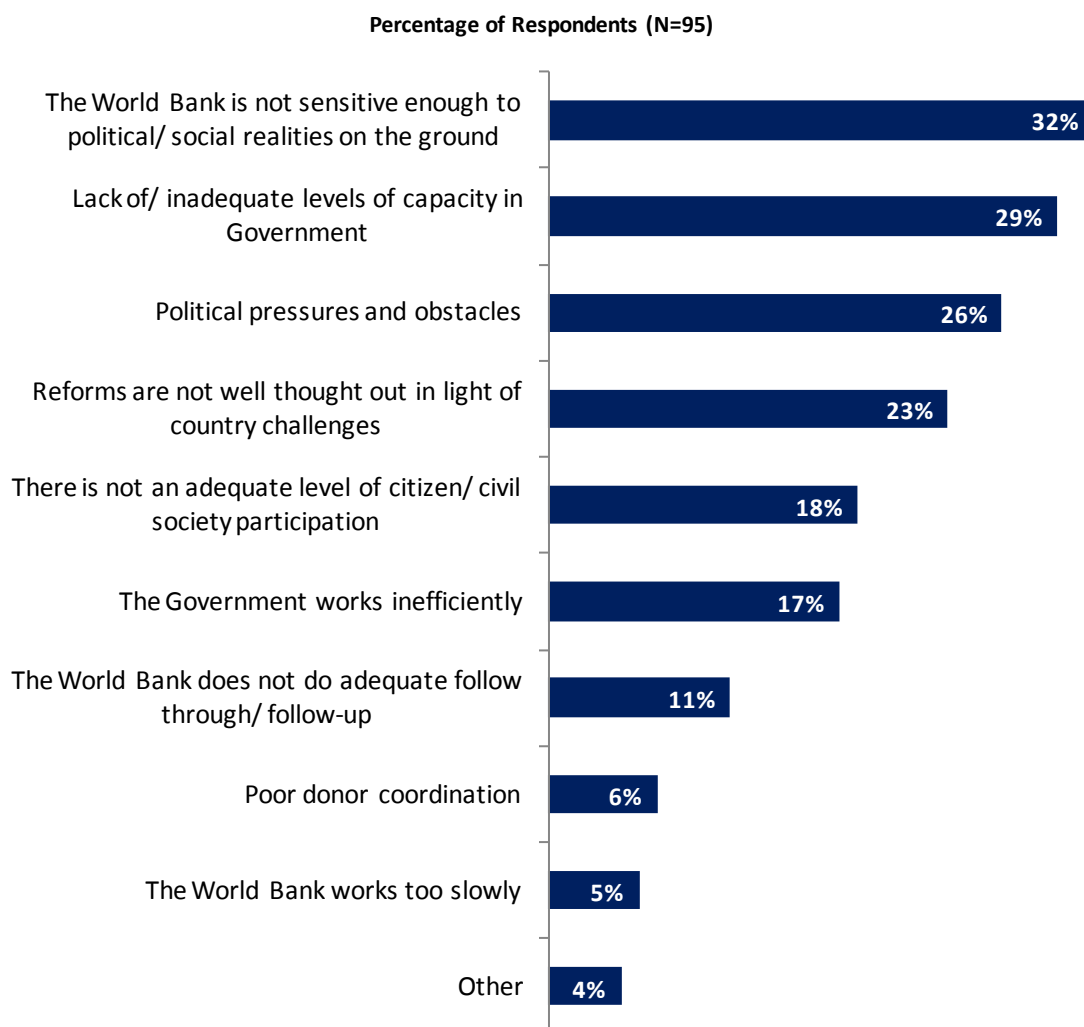
Greatest Weakness

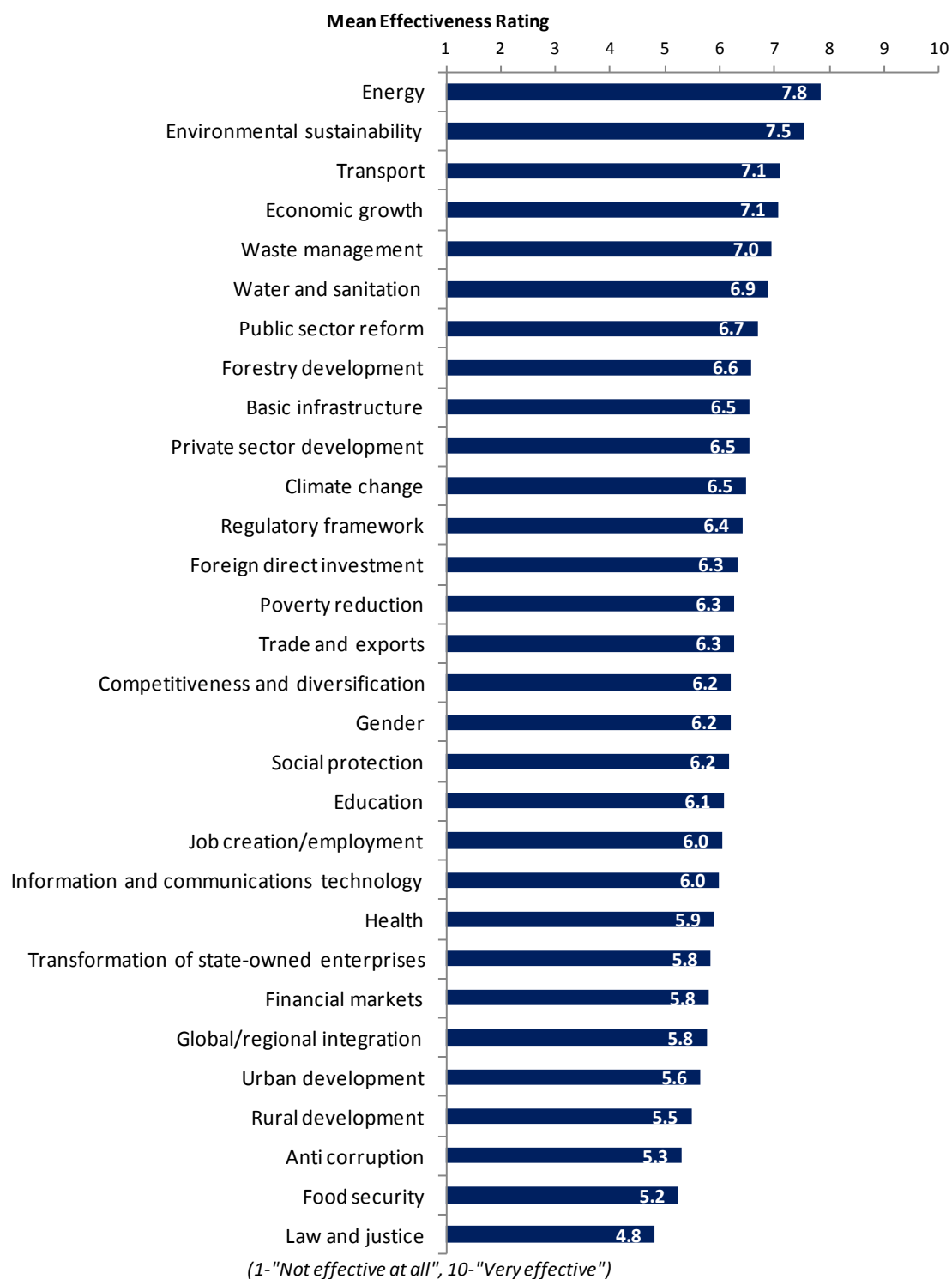
Attributing Slow or Failed Reform Efforts

Drivers of Effectiveness

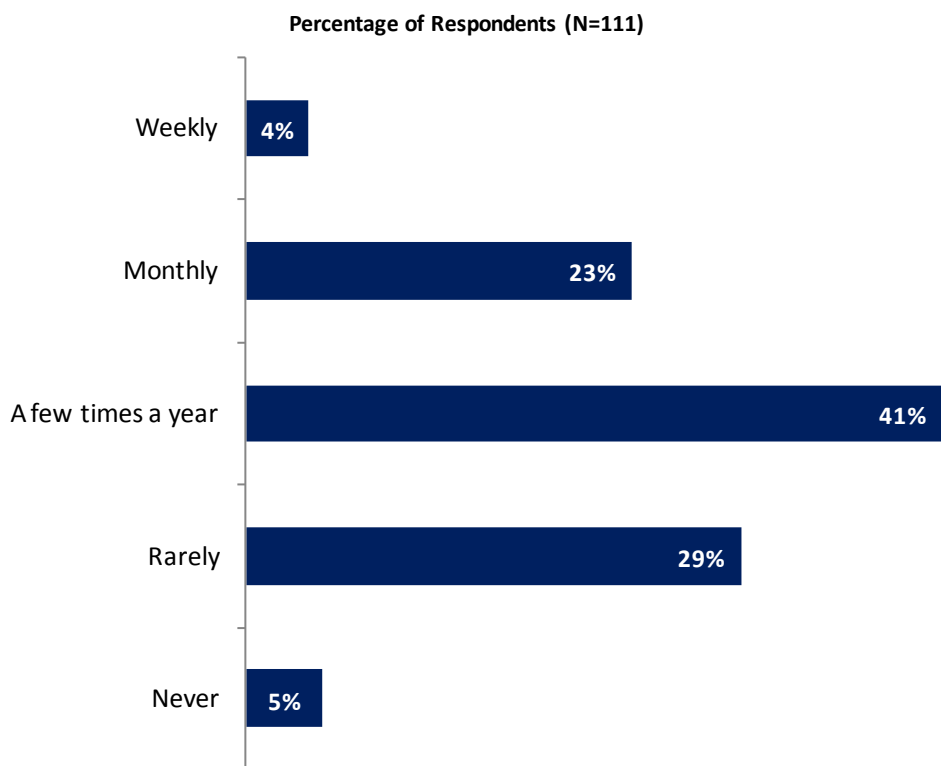
To determine the key drivers of respondents' ratings of the Bank's overall effectiveness and ratings of its ability to help achieve development results in Belarus, bivariate correlational analyses were conducted using respondents' ratings of the thirty specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the Bank's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the Bank's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank's overall effectiveness or perceptions of the Bank's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's overall effectiveness in Belarus. The areas determined to be key drivers from these analyses were:
 - Education;
 - Social protection;
 - Financial markets;
 - Global/regional integration; and
 - Job creation/employment.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's ability to help achieve development results in Belarus, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - Education;
 - Waste management;
 - Energy;
 - Water and sanitation;
 - Environmental sustainability; and
 - Forestry development.

Knowledge: Frequency of Use

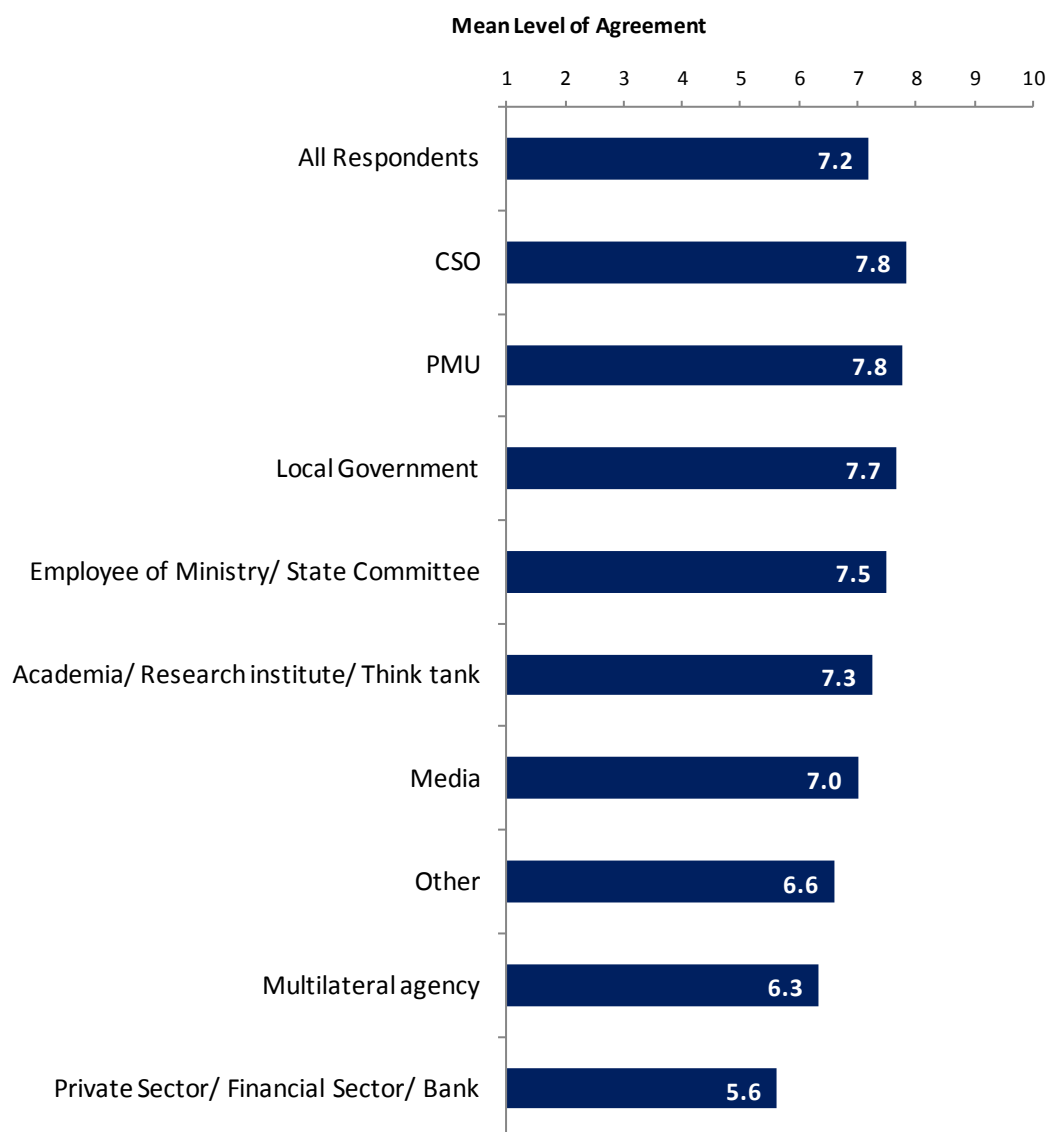


"How frequently do you consult World Bank knowledge work and activities in the work you do?"

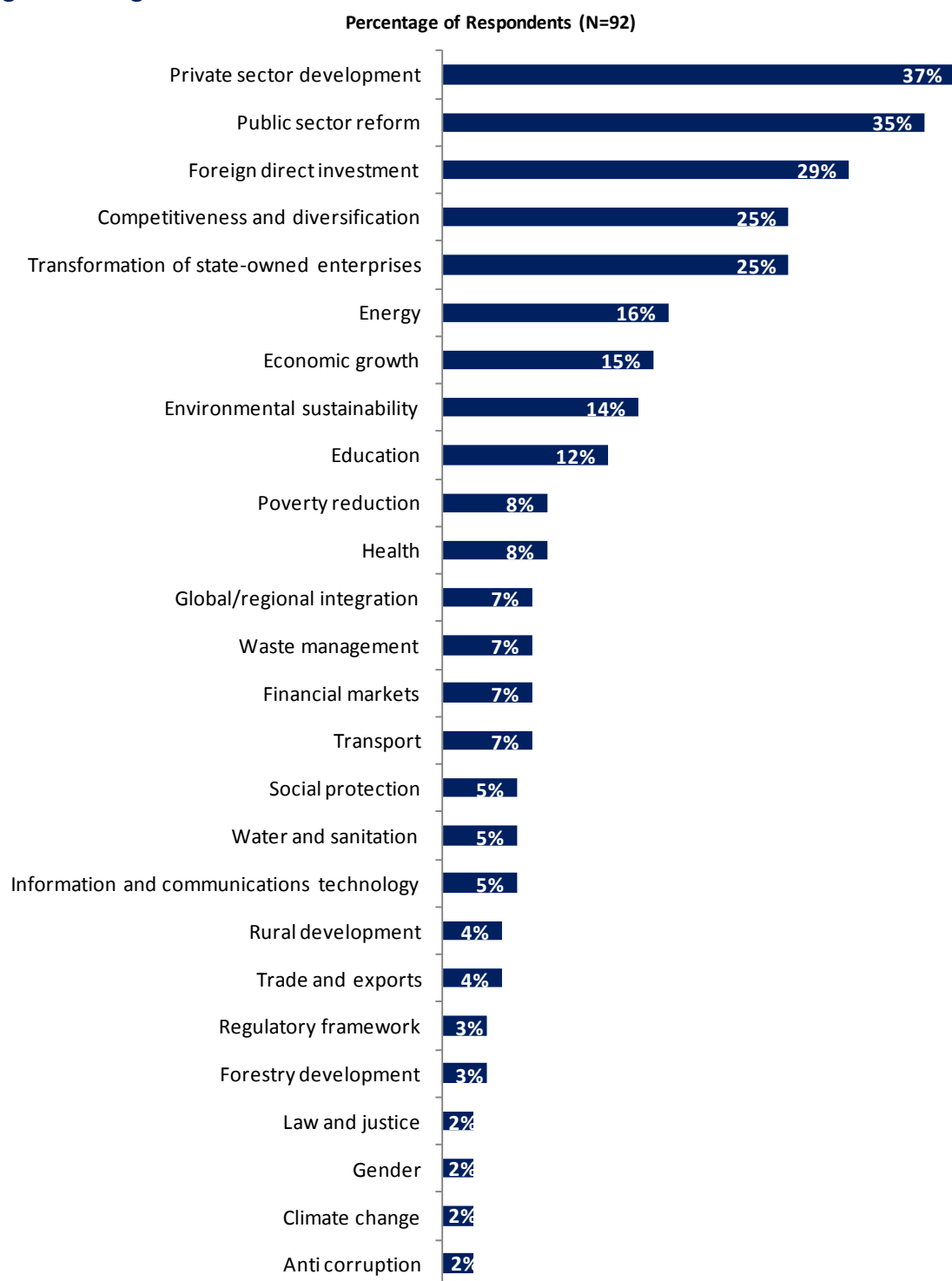
- Respondents across all stakeholder groups and geographic locations had statistically similar levels of agreement that the World Bank meets Belarus' needs for knowledge services.

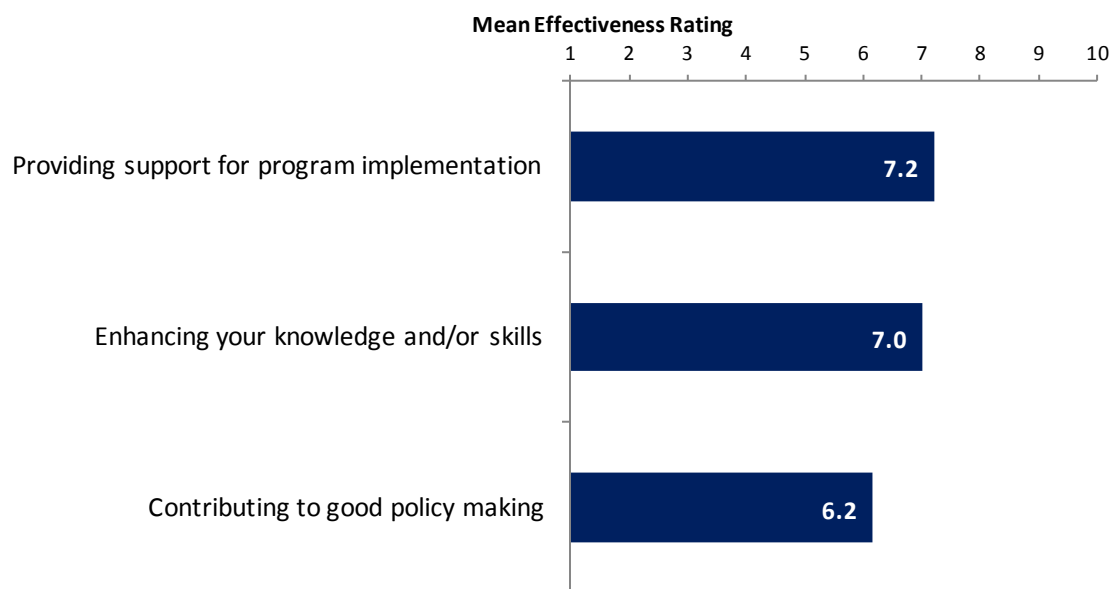

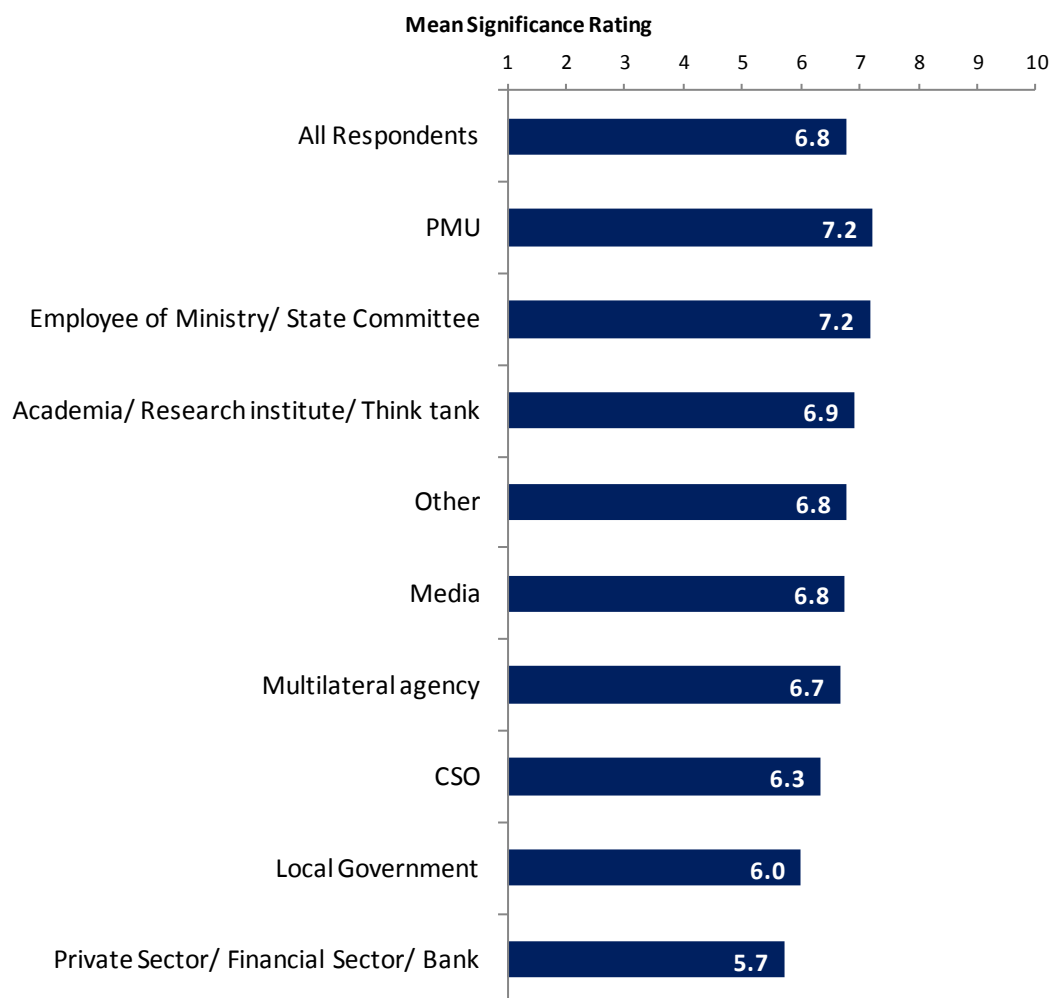


"In Belarus, to what extent do you believe that the World Bank's knowledge work and activities ... ?"

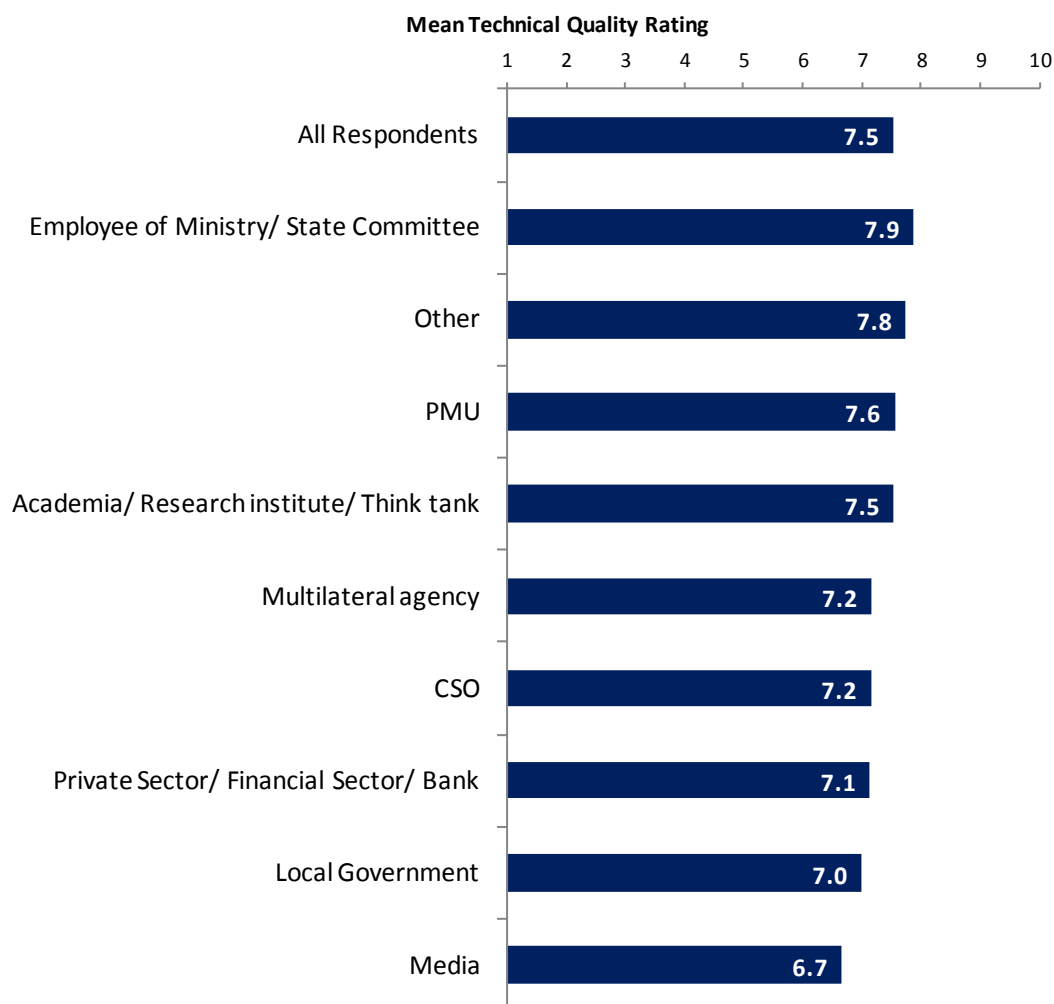


"Overall, how significant a contribution do you believe the World Bank's knowledge work and activities make to development results in your country, on a ten point scale?

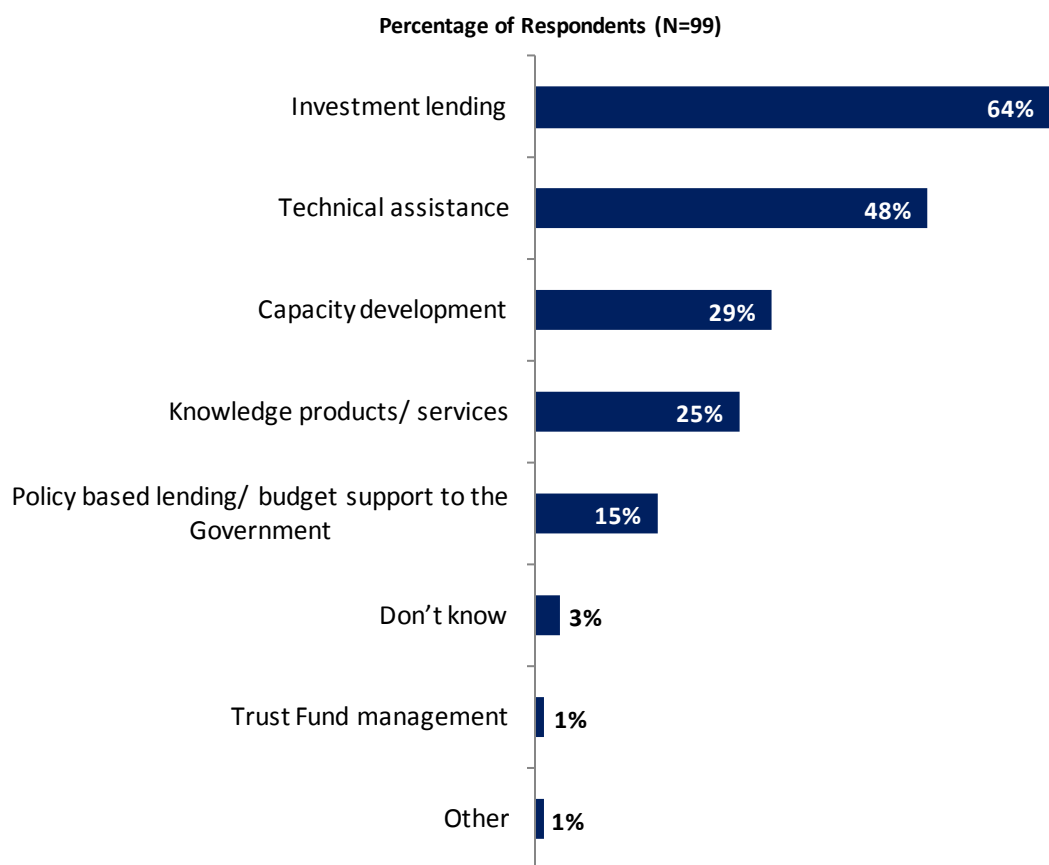

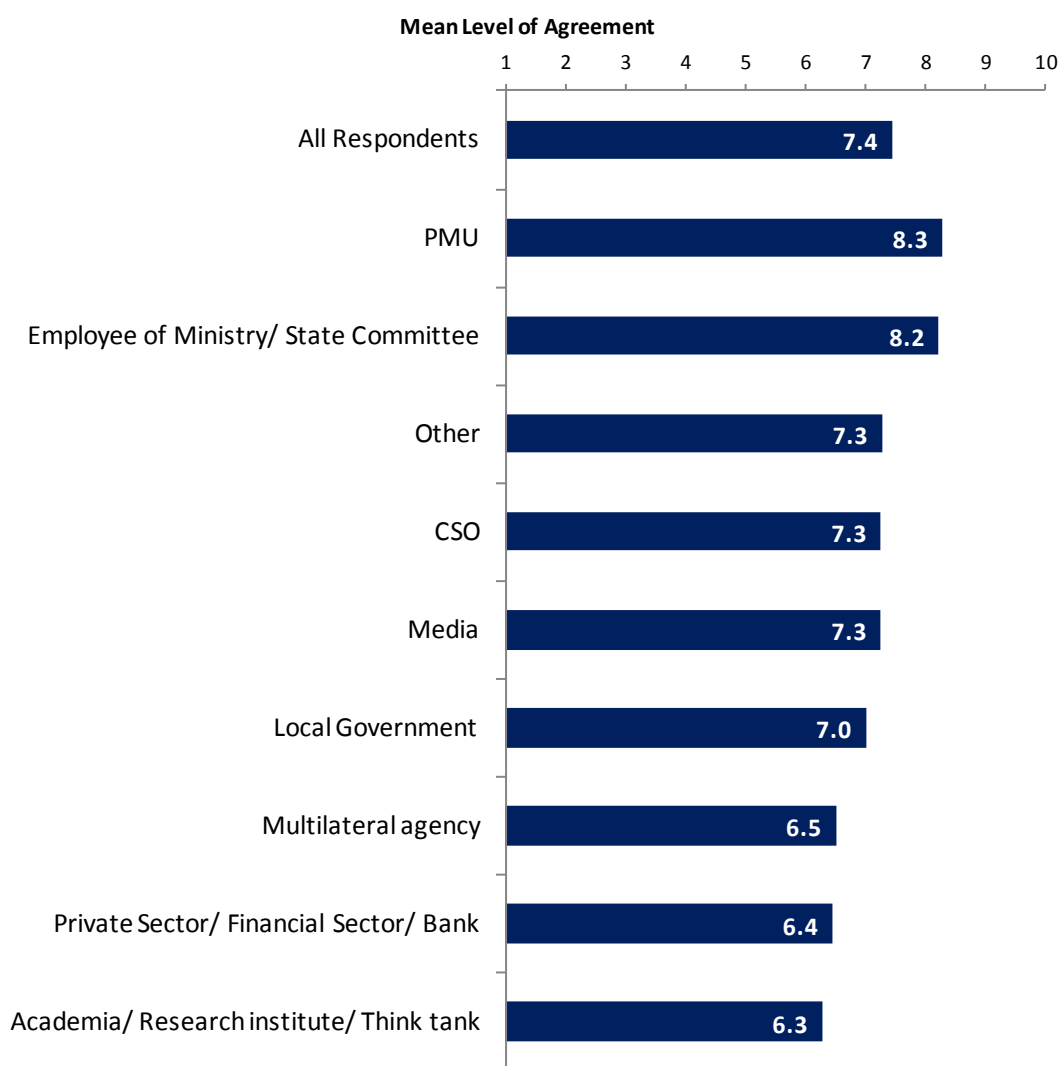


“Which World Bank instruments do you believe are the MOST effective in helping to promote development and reduce poverty in Belarus? (Choose no more than TWO)”

- Respondents from PMUs and employees of ministries/state committees had the highest levels of agreement that the World Bank's financial instruments meet Belarus' needs whereas respondents from multilateral agencies, private sector organizations/financial sector/banks, and academia/research institutes/think tanks had significantly lower levels of agreement.
- Respondents across both geographic locations had statistically similar levels of agreement.

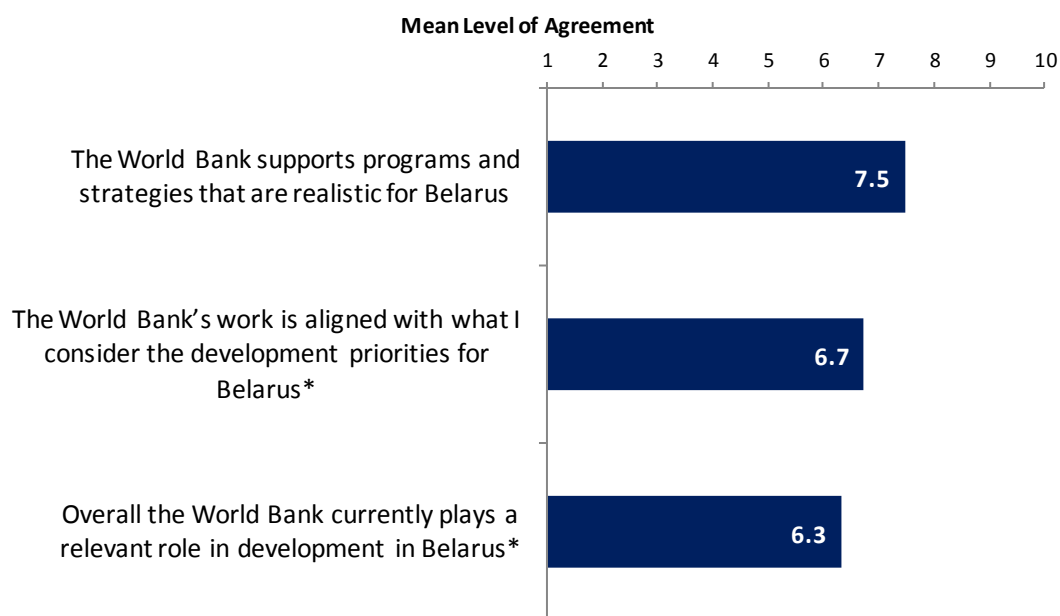

- There were significant stakeholder group differences in their levels of agreement regarding two of these aspects of the Bank's work in Belarus: The World Bank supporting realistic programs/strategies and playing a relevant role in development in the country. Respondents from PMUs and employees of ministries/state committees tended to have the highest levels of agreement with these statements whereas respondents from the media, private sector organizations/financial sector/banks, and other organizations tended to have significantly lower levels of agreement.
- Respondents across both geographic locations had statistically similar levels of agreement.

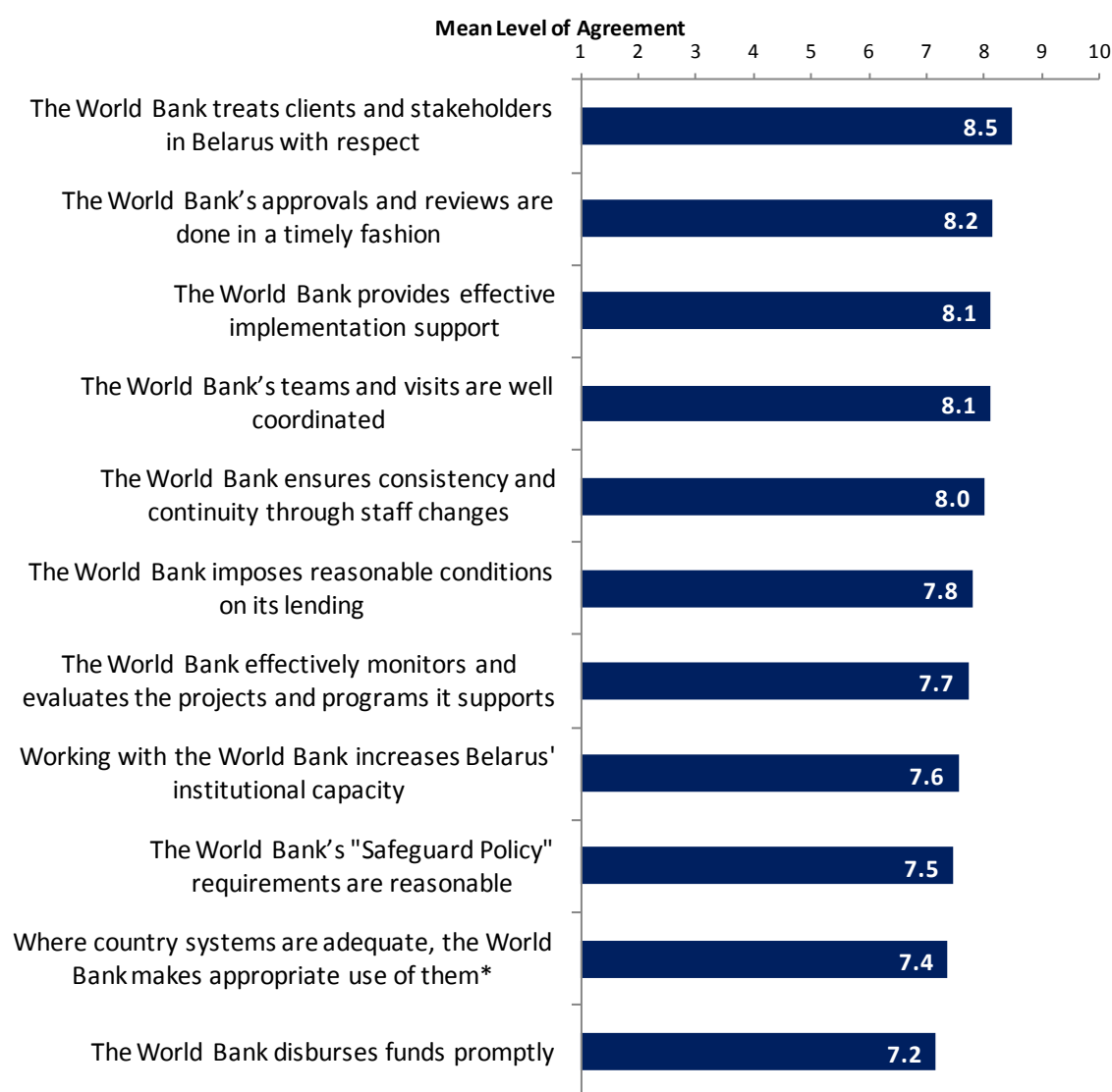

Overall Perceptions

- There were significant stakeholder group differences in their levels of agreement across two of these aspects of how the Bank operates: “The World Bank treats clients and stakeholders in Belarus with respect” and “The World Bank’s approvals and reviews are done in a timely fashion”. For the most part, employees of ministries/state committees and respondents from PMUs tended to have the highest levels of agreement with these statements whereas respondents from multilateral agencies tended to have significantly lower levels of agreement.
- Respondents across both geographic locations had statistically similar levels of agreement.

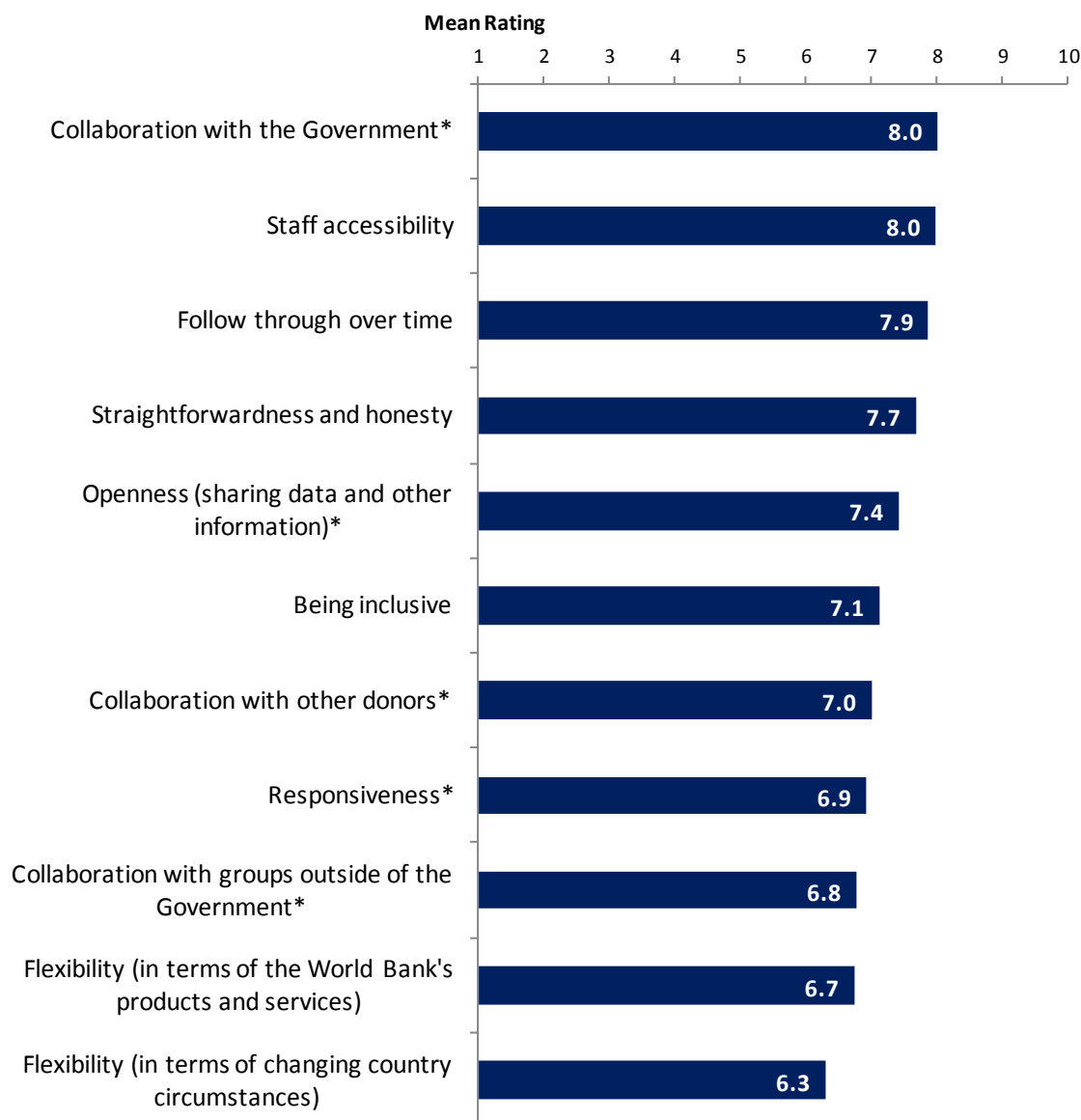


“To what extent do you agree/disagree with the following statements, on a ten point scale?”

The World Bank as an Effective Development Partner

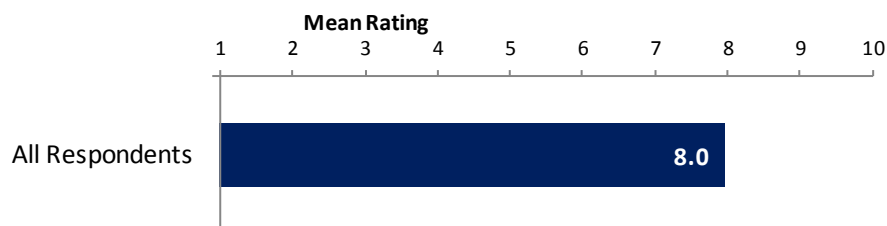
- There were significant stakeholder group differences in their ratings across two of these aspects of the World Bank's effectiveness as a development partner in the country: inclusiveness and flexibility in terms of Bank's products and services. For the most part, employees of ministries/state committees tended to give the highest ratings for these aspects whereas respondents from CSOs tended to give significantly lower ratings.

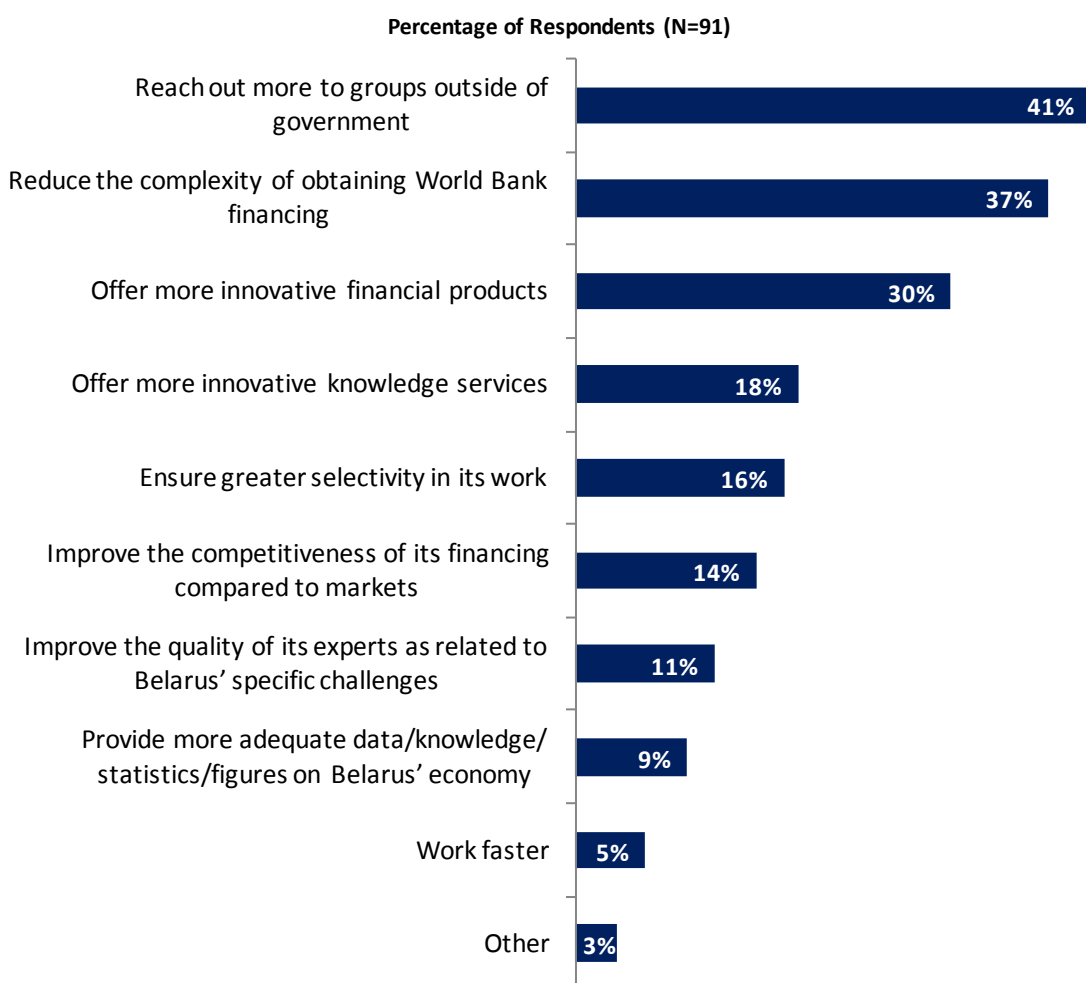

Making the World Bank of Greater Value

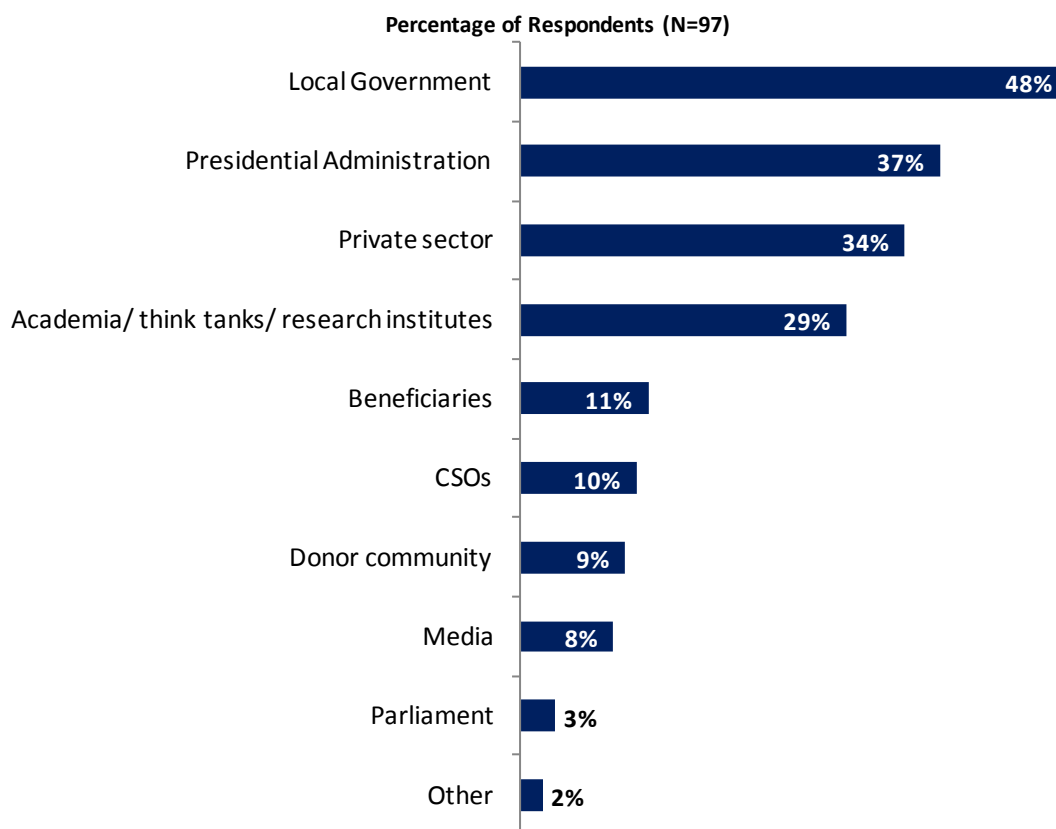

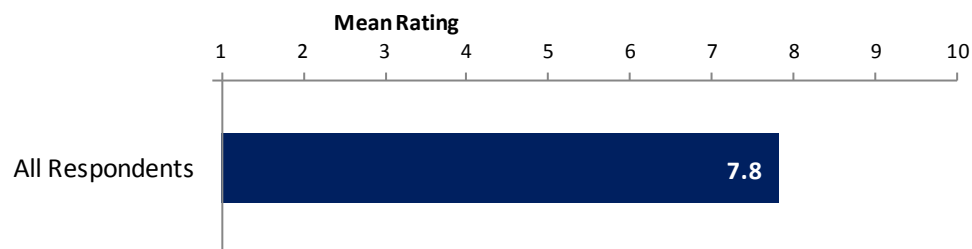
Collaborating with Stakeholders in Belarus

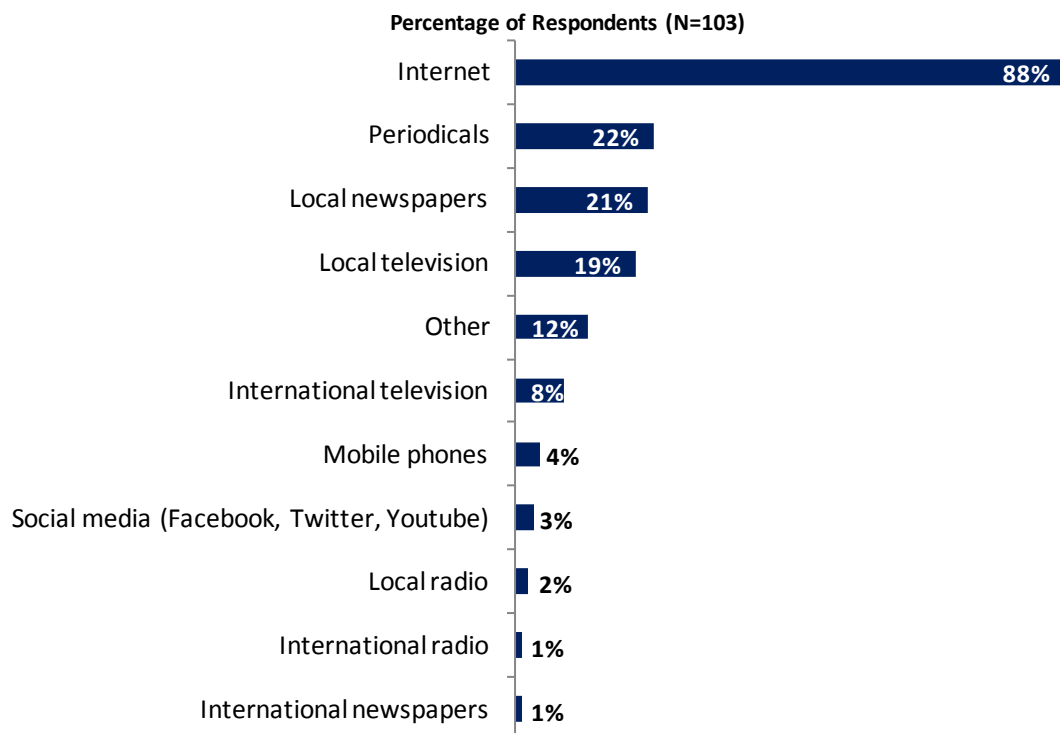

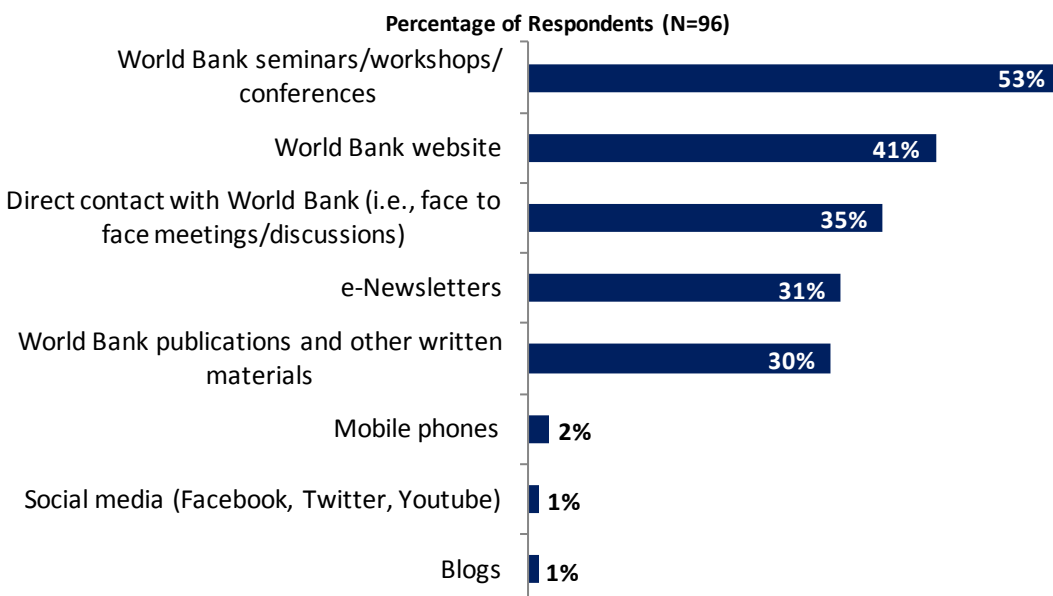

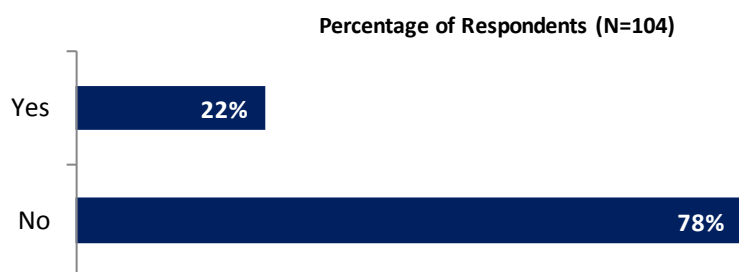
"How do you get most of your information about economic and social development issues in Belarus? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)



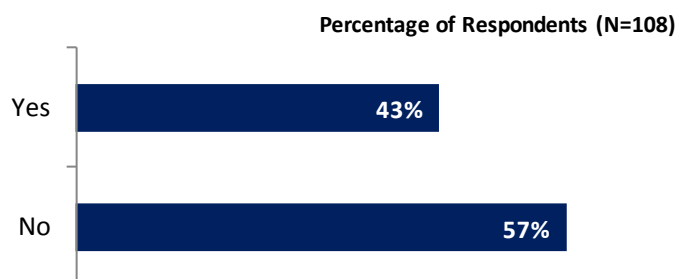
"How would you prefer to receive information from the World Bank? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

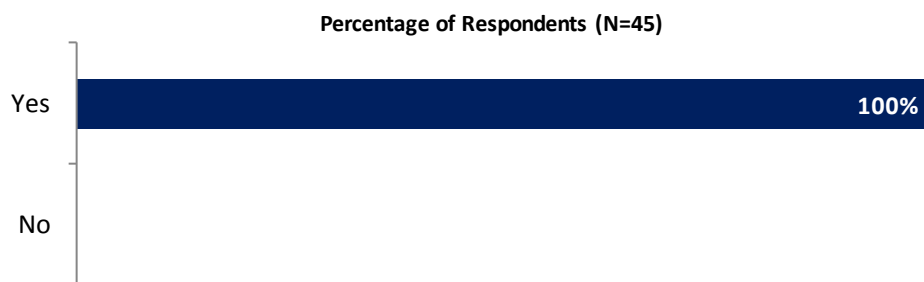
Access to Information



"Are you aware of the World Bank's Access to Information Policy under which the Bank will now disclose any information in its possession that is not on a list of exceptions?"



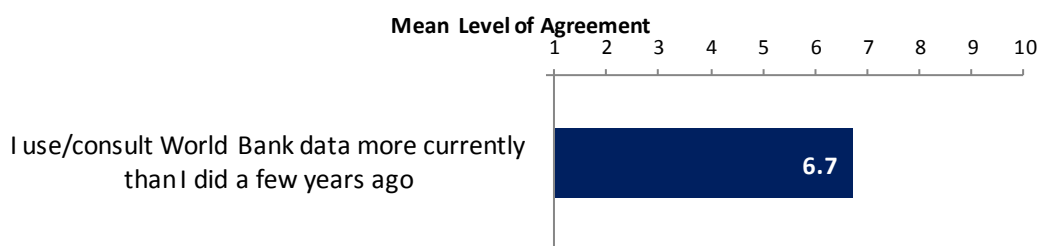
"Have you requested information from the World Bank on its activities in the past year?"



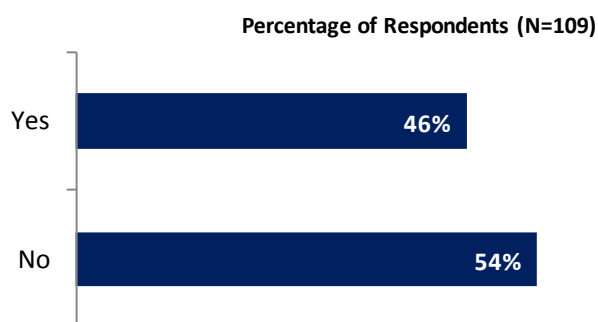
"Were you able to obtain this information?"

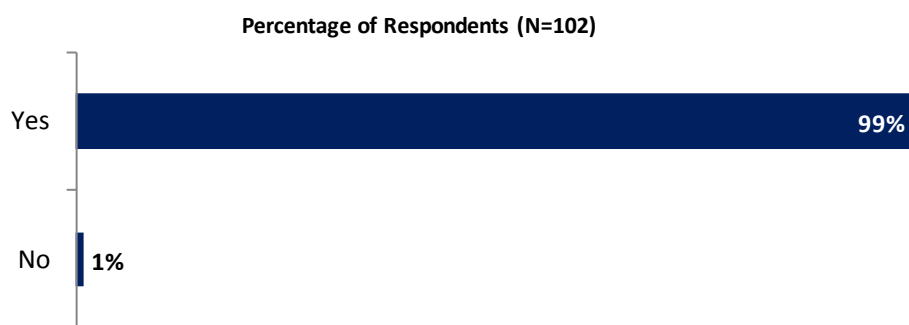


"Please rate how much you agree with the following statements, on a ten point scale."

"Is your knowledge of English sufficient to use World Bank resources in English?"

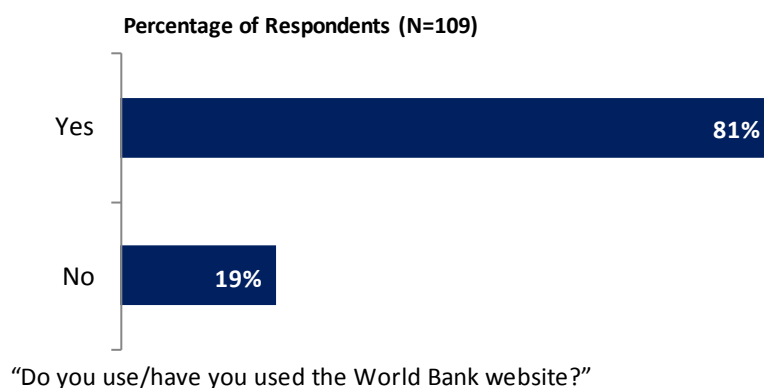

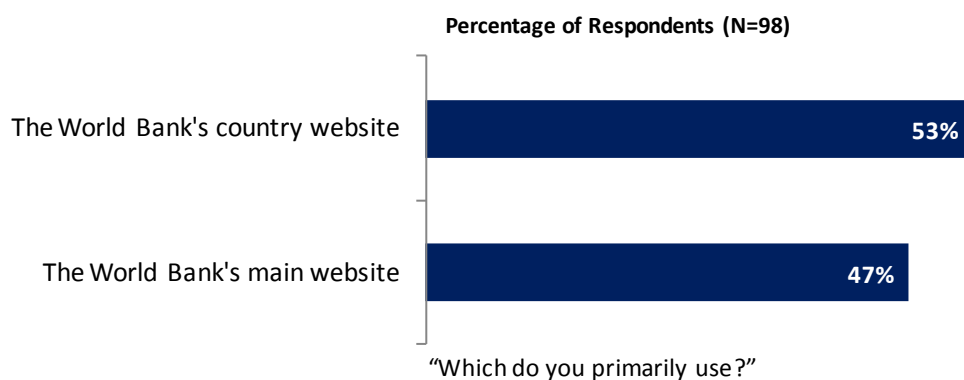
"Do you have access to the Internet?"

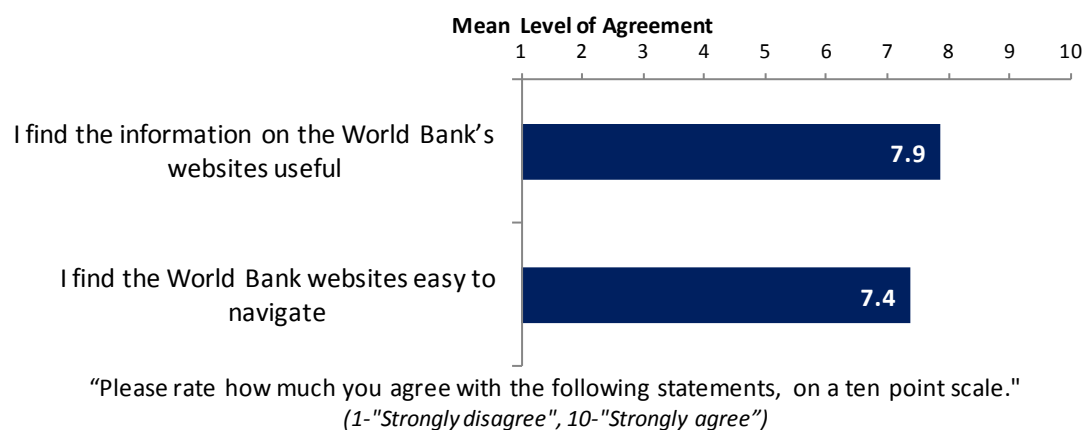

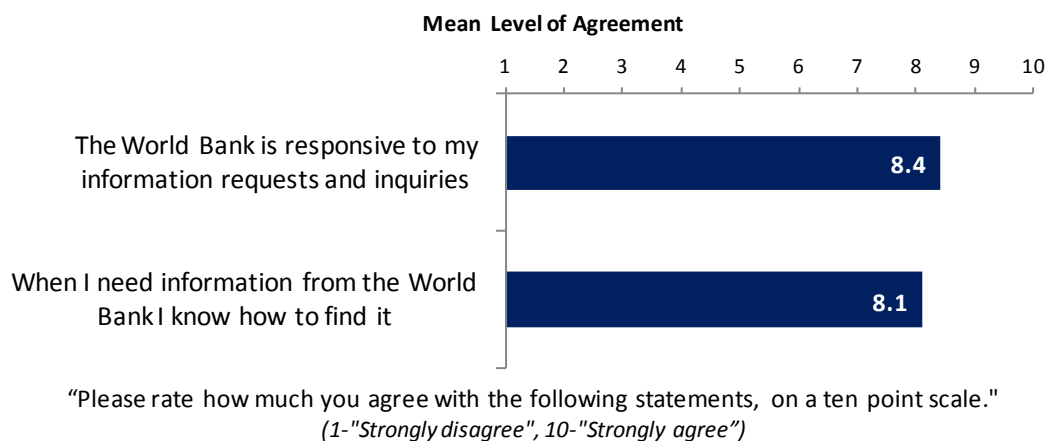
