I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank in gaining a better understanding of how stakeholders in Uzbekistan perceive the Bank;
- Obtain systematic feedback from stakeholders in Uzbekistan regarding:
 - Their views regarding the general environment in Uzbekistan;
 - Their overall attitudes toward the World Bank in Uzbekistan;
 - Overall impressions of the World Bank's effectiveness and results, knowledge work and activities, and communication and information sharing in Uzbekistan;
 - Perceptions of the World Bank's future role in Uzbekistan.
- Use data to help inform Uzbekistan country team's strategy.

II. Methodology

In April-May 2013, 253 stakeholders of the World Bank in Uzbekistan were invited to provide their opinions on the Bank's assistance to the country by participating in a country survey. Participants in the survey were drawn from the office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries, ministerial departments, or implementation agencies; consultants/contractors working on World Bank-supported projects/programs; project management units (PMUs) overseeing implementation of a project; local government officials or staff; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs; community based organizations; the media; independent government institutions; trade unions; faith-based groups; academia/research institutes/think tanks; the judiciary branch; beneficiaries of Bank programs; and other organizations. A total of 147 stakeholders participated in the survey (58% response rate).

Respondents received questionnaires via courier and returned them accordingly. Respondents were asked about: general issues facing Uzbekistan; their overall attitudes toward the Bank; the World Bank's effectiveness and results; the Bank's knowledge work and activities; working with the World Bank; the Bank's future role in Uzbekistan; and the Bank's communication and information sharing in Uzbekistan.

Every country that engages in the Country Survey must include specific indicator questions that will be aggregated for the World Bank's annual Corporate Scorecard. These questions are identified throughout the survey report.

- A. General Issues Facing Uzbekistan: Respondents were asked to indicate whether Uzbekistan is headed in the right direction, what they thought were the top three most important development priorities in the country, and which areas would contribute most to reducing poverty and generating economic growth in Uzbekistan.

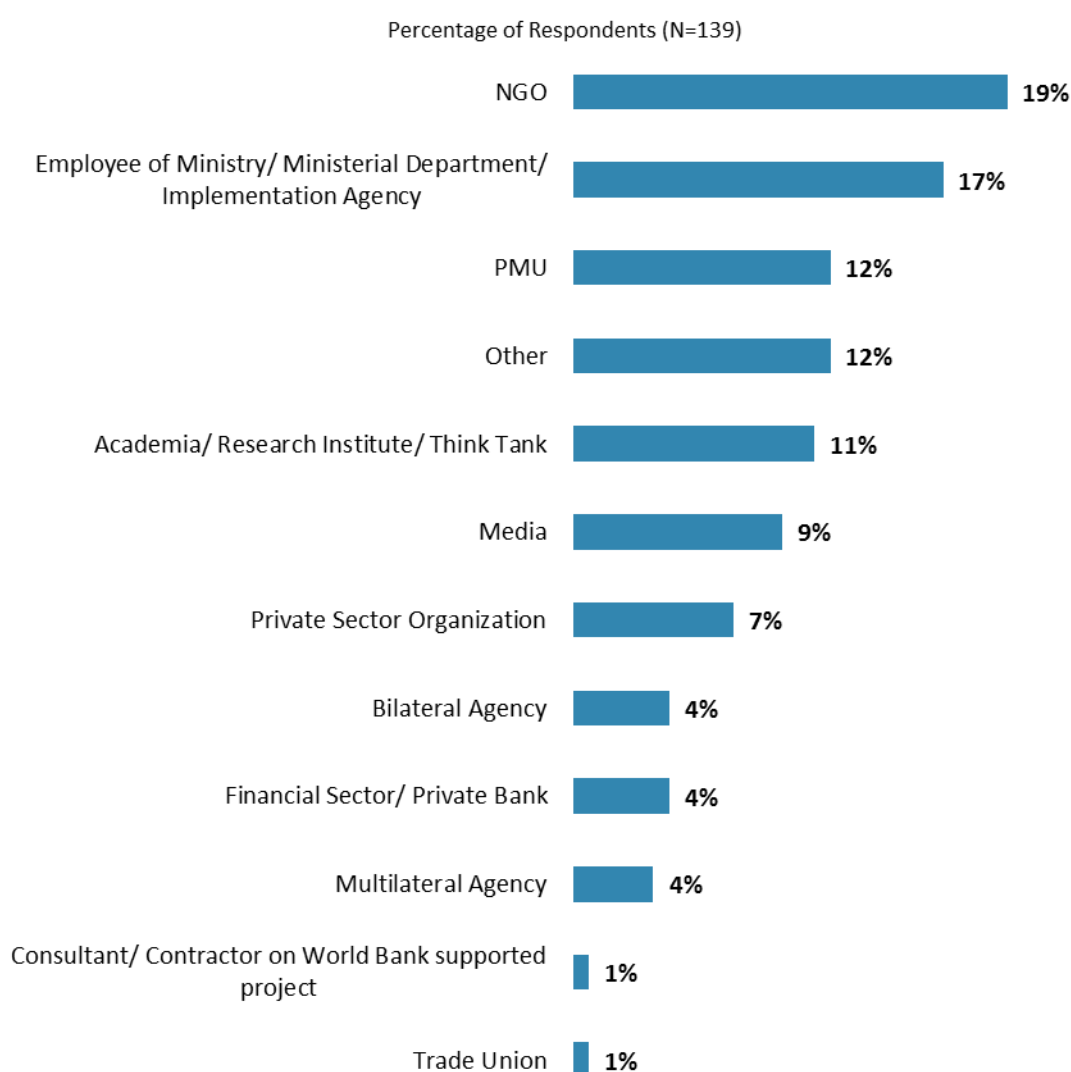
- B. Overall Attitudes toward the World Bank: Respondents were asked to rate their familiarity with the World Bank, the Bank's effectiveness in Uzbekistan, Bank staff preparedness to help Uzbekistan solve its development challenges, their agreement with various statements regarding the Bank's work, and the extent to which the Bank is an effective development partner. Respondents were asked to indicate the Bank's greatest values and weaknesses, the most effective instruments in helping reduce poverty in Uzbekistan, with which stakeholder groups the Bank should collaborate more, in which sectoral areas the Bank should focus most of its resources, and to what reasons respondents attributed failed or slow reform efforts.
- C. World Bank Effectiveness and Results: Respondents were asked to rate the extent to which the Bank's work helps achieve development results in Uzbekistan, the extent to which the Bank meets Uzbekistan's needs for knowledge services and financial instruments, and the Bank's level of effectiveness across thirty six development areas, such as economic growth, governance, education, and job creation.
- D. The World Bank's Knowledge: Respondents were asked to indicate the areas on which the Bank should focus its research efforts and to rate the effectiveness and quality of the Bank's knowledge work and activities, including how significant of a contribution it makes to development results and its technical quality.
- E. Working with the World Bank: Respondents were asked to rate their level of agreement with a series of statements regarding working with the World Bank, such as the Bank's "Safeguard Policy" requirements being reasonable, the Bank imposing reasonable conditions on its lending, disbursing funds promptly, increasing Uzbekistan's institutional capacity, and providing effective implementation support.
- F. The Future Role of the World Bank in Uzbekistan: Respondents were asked to rate how significant a role the Bank should play in Uzbekistan in the near future and to indicate what the Bank should do to make itself of greater value in Uzbekistan.
- G. Communication and Information Sharing: Respondents were asked to indicate how they get information about economic and social development issues, how they prefer to receive information from the Bank, and their usage and evaluation of the Bank's websites. Respondents were also asked about their awareness of the Bank's Access to Information policy, past information requests from the Bank, and their level of agreement that they use more data from the World Bank as a result of the Bank's Open Data policy.
- H. Background Information: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the World Bank, their exposure to the Bank in Uzbekistan, and their geographic location.

When possible, responses from respondents completing this year's country survey were compared to responses from 114 respondents (82% response rate) who completed the survey in FY 2003. Notations and/or charts are included when these comparisons were possible.

III. Demographics of the Sample

Current Position

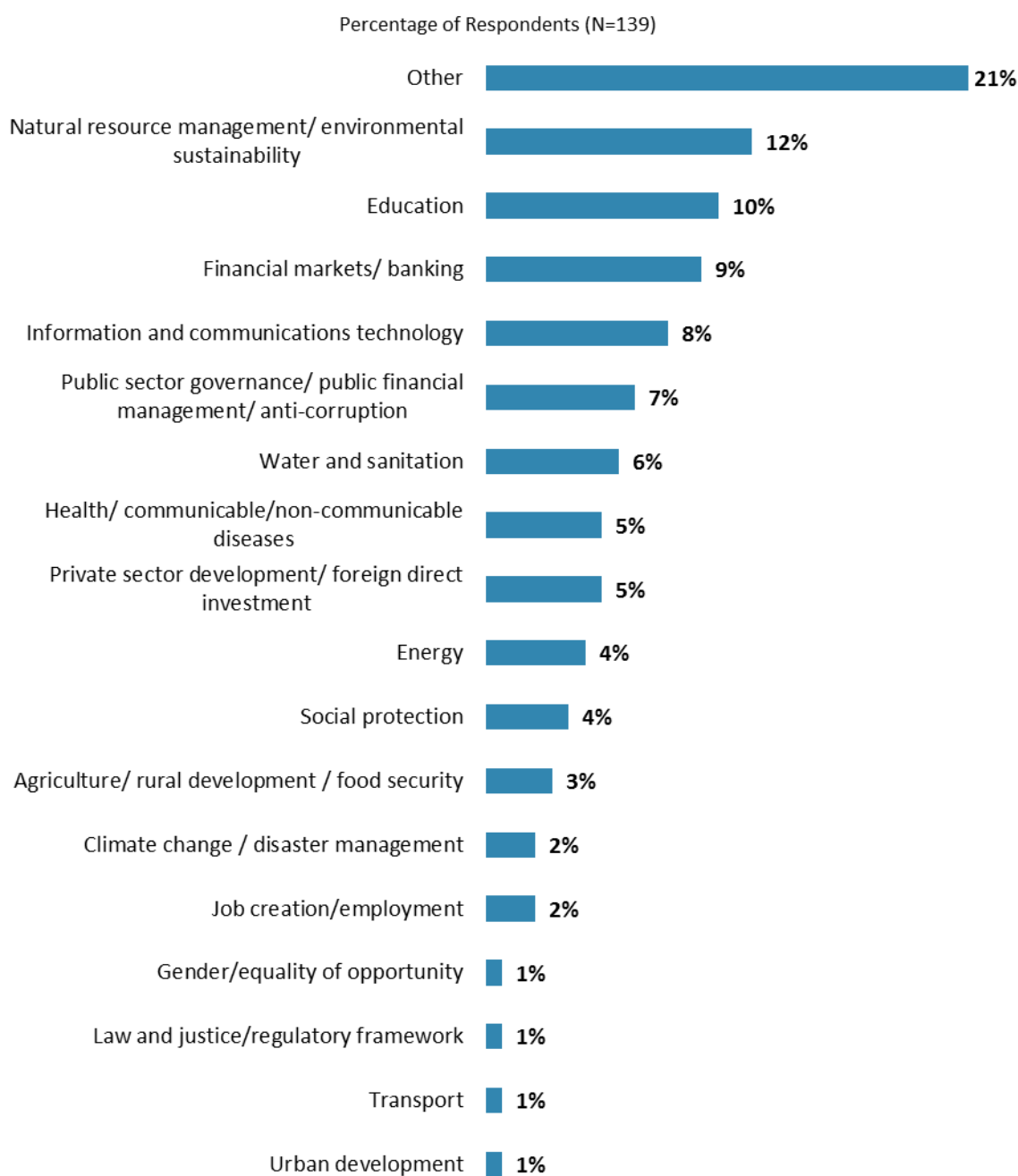
- For further analyses, a small number of consultants/contractors working on Bank projects were combined with respondents from PMUs; respondents from multilateral agencies were combined with those from bilateral agencies; respondents from the financial sector/private banks were combined with those from private sector organizations; and the few respondents from trade unions were combined with respondents from NGOs. There were no respondents from the Office of the President, Prime Minister, office of a minister, office of a parliamentarian, local governments, private foundations, community based organizations, independent government institutions, faith-based groups, the judiciary branch, or beneficiaries of a program.

Area of Primary Specialization

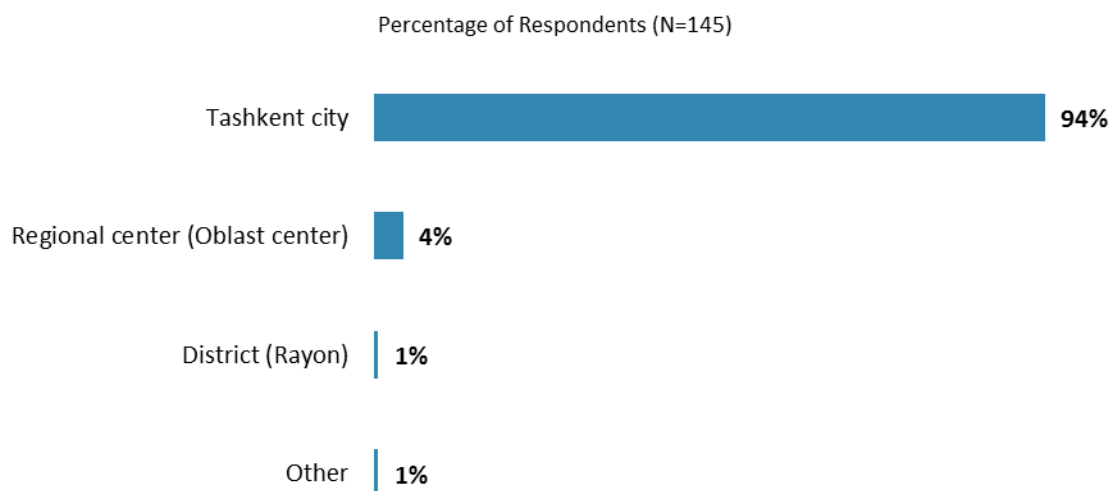


“Please identify the primary specialization of your work.” (Respondents chose from a list.)

Collaboration with and Exposure to the World Bank

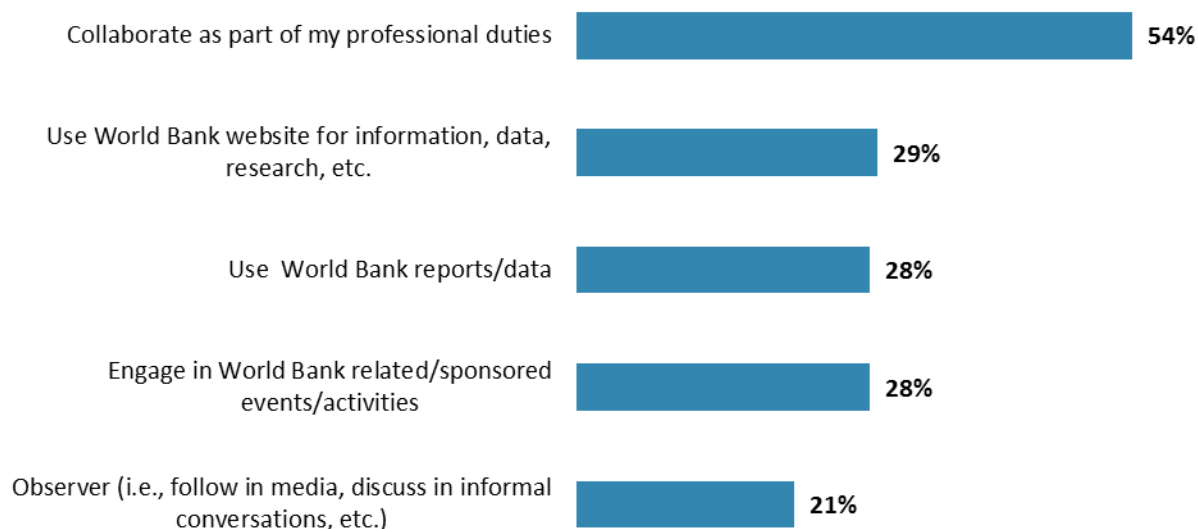

Percentage of Respondents (N=138)

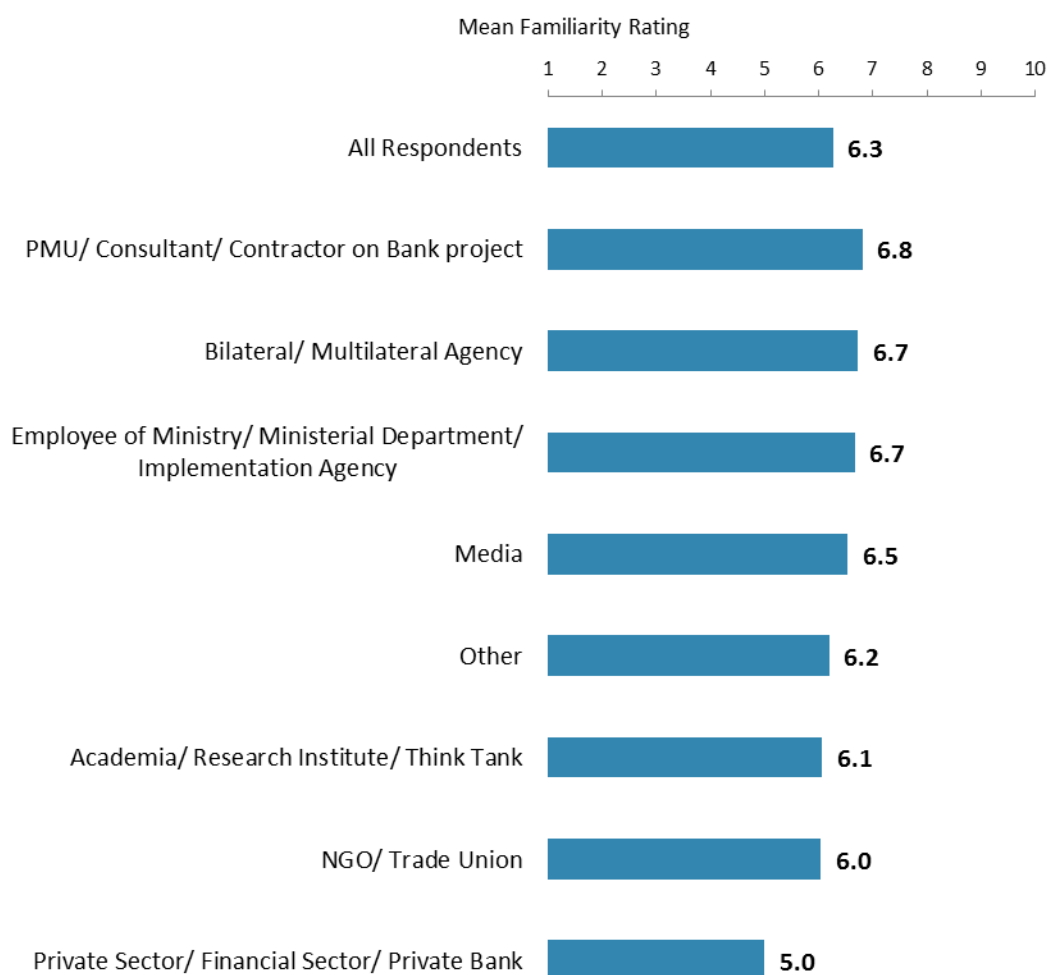


"Which of the following describes most of your exposure to the World Bank in Uzbekistan? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

Familiarity with the World Bank

- Across all respondents, familiarity with the World Bank received a mean rating of 6.3; this was significantly *lower* than the mean rating received in the FY '03 country survey (6.9).
- Respondents' ratings of familiarity with the Bank were significantly, strongly correlated with their perceptions of the Bank's overall effectiveness in Uzbekistan, and significantly, moderately correlated with their perceptions of the Bank's relevance to Uzbekistan's development, and the Bank's ability to help achieve development results in Uzbekistan.

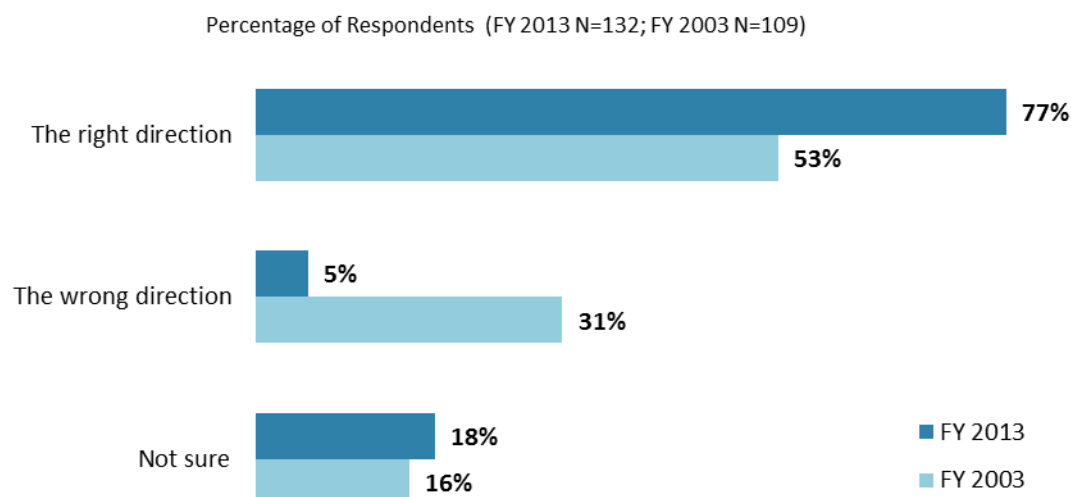


"How familiar are you with the work of the World Bank in Uzbekistan?"

Headed in the Right Direction

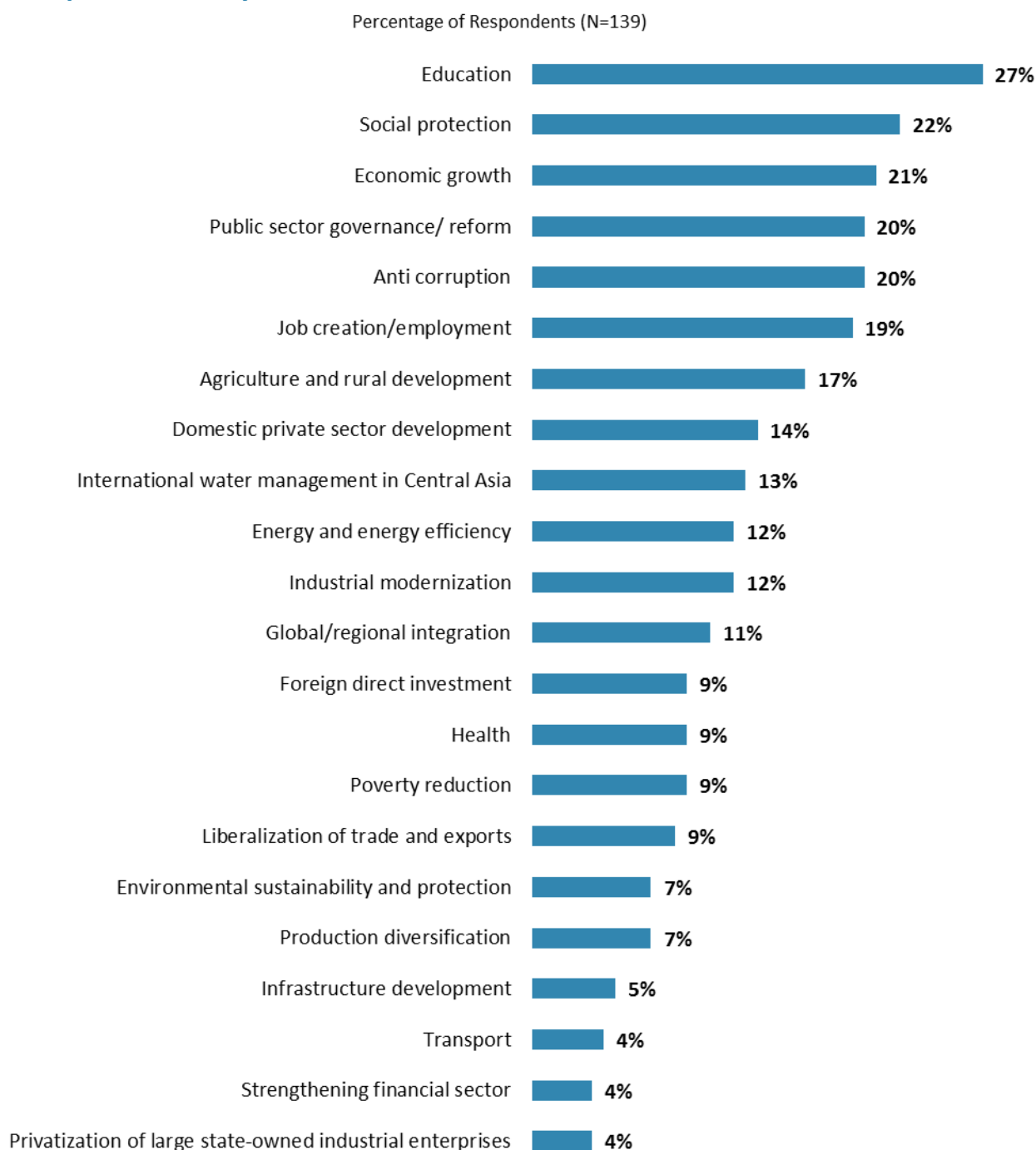
- Respondents in this year's country survey were significantly *more* likely to indicate that Uzbekistan is headed in the right direction compared to respondents from the FY '03 country survey.
- A majority of respondents across all stakeholder groups indicated that Uzbekistan is headed in the right direction, except respondents from bilateral/multilateral agencies who tended to indicate that they were not sure whether Uzbekistan is headed in the right or wrong direction.

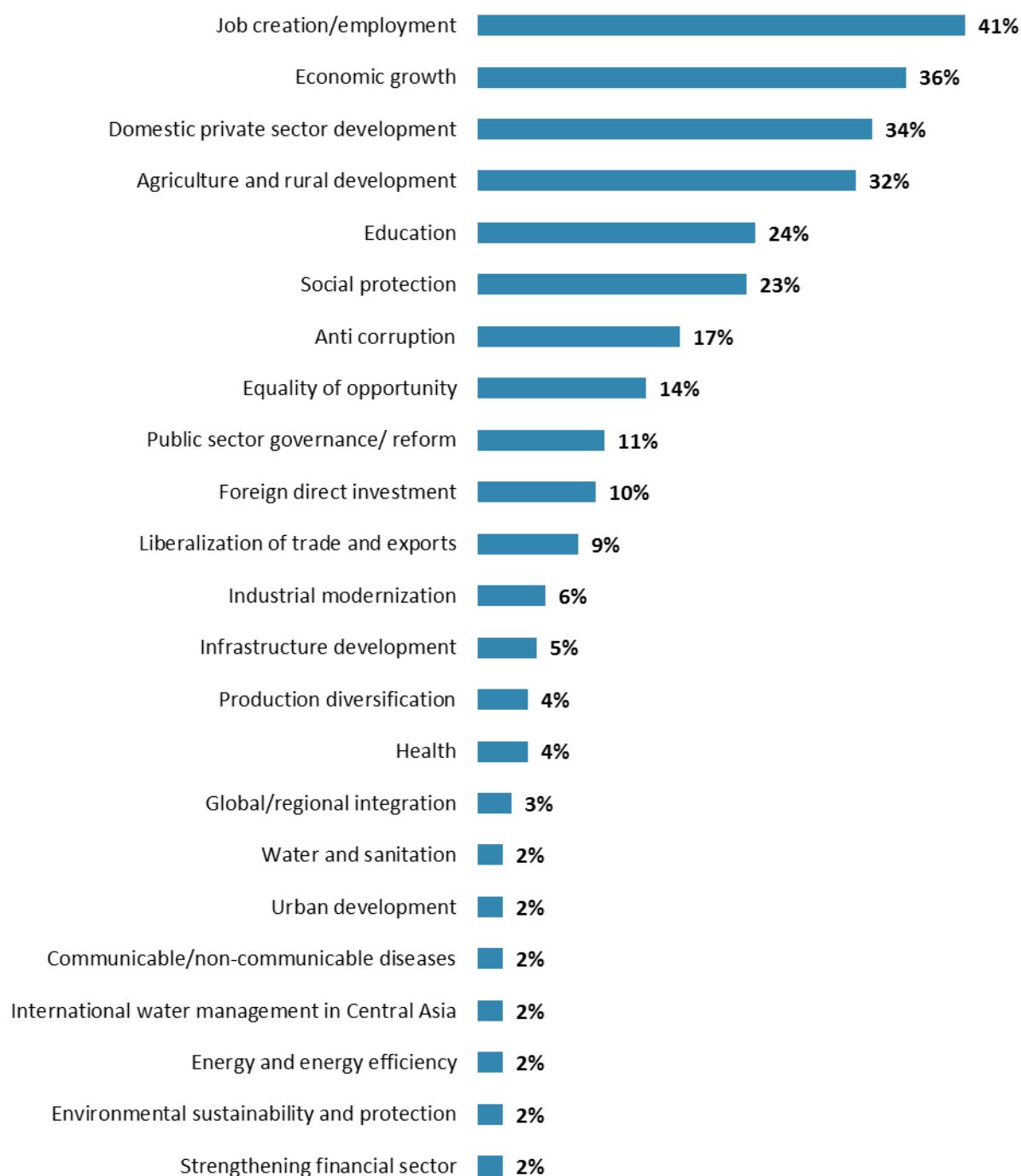


"Listed below are a number of development priorities in Uzbekistan. Please identify which of the following you consider the most important development priorities in Uzbekistan.

Percentage of Respondents (N=140)

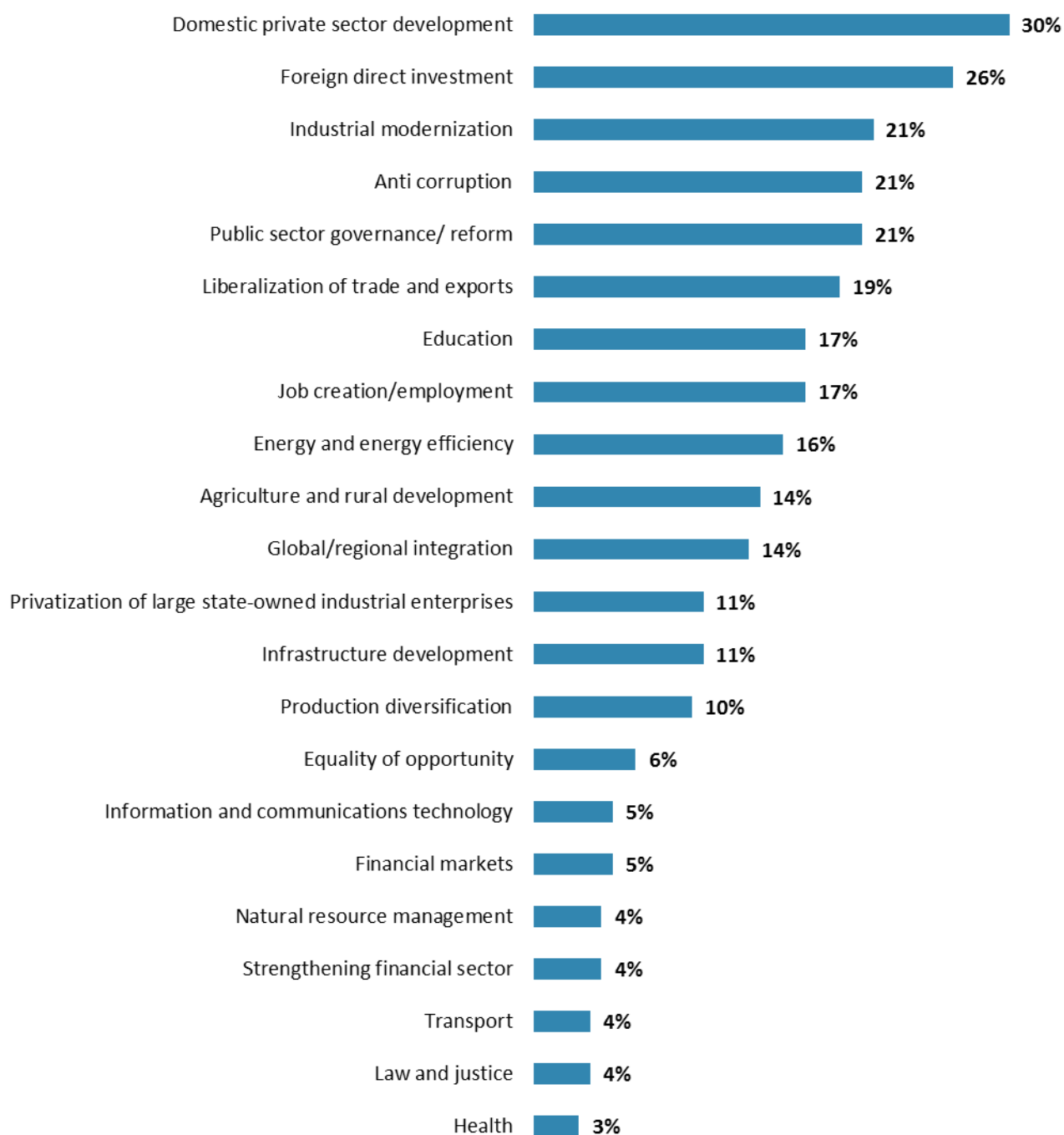

Percentage of Respondents (N=140)



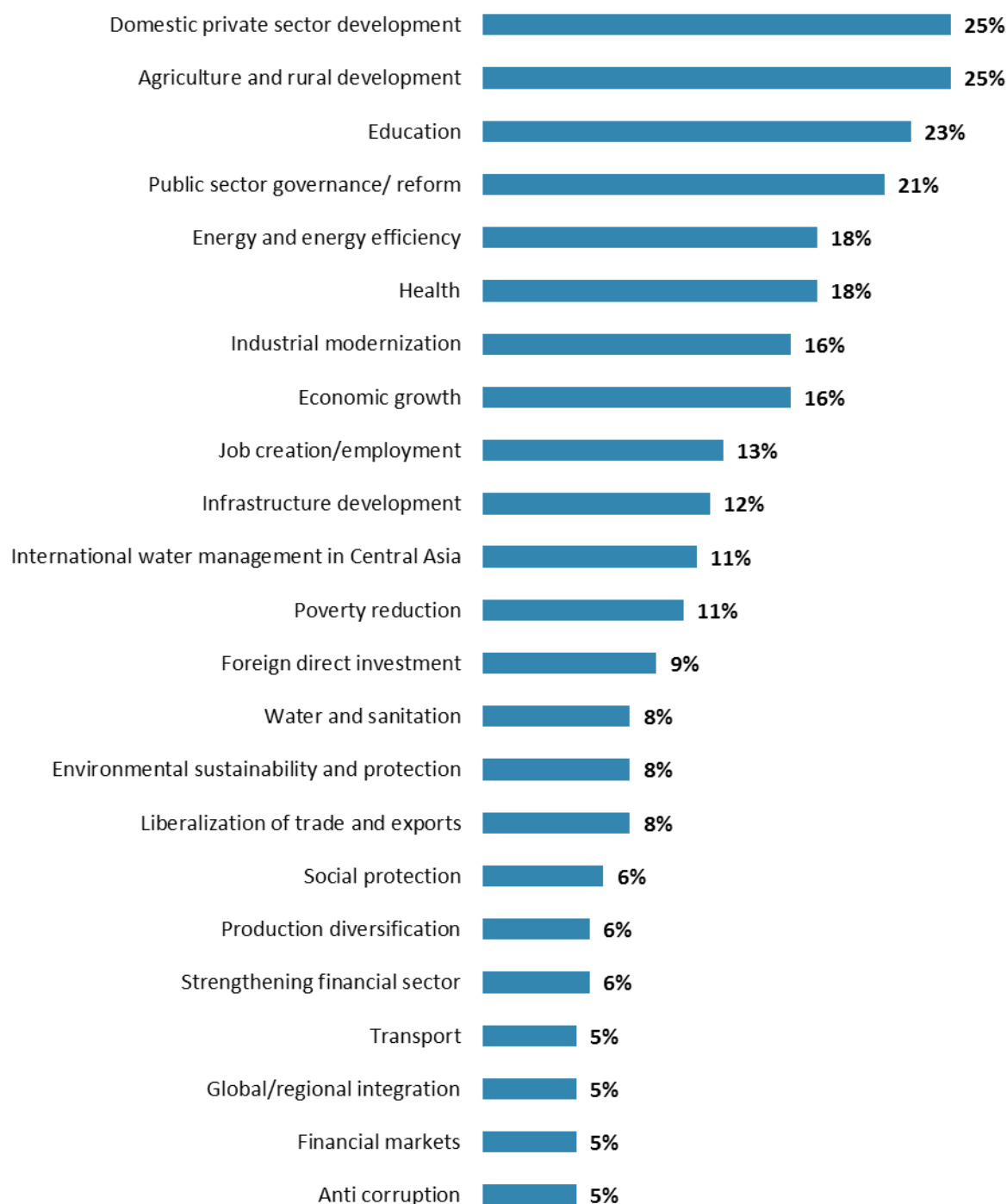
"Economic growth can be driven by a number of factors. Which THREE areas below do you believe would contribute most to generating economic growth in Uzbekistan?"

Percentage of Respondents (N=142)



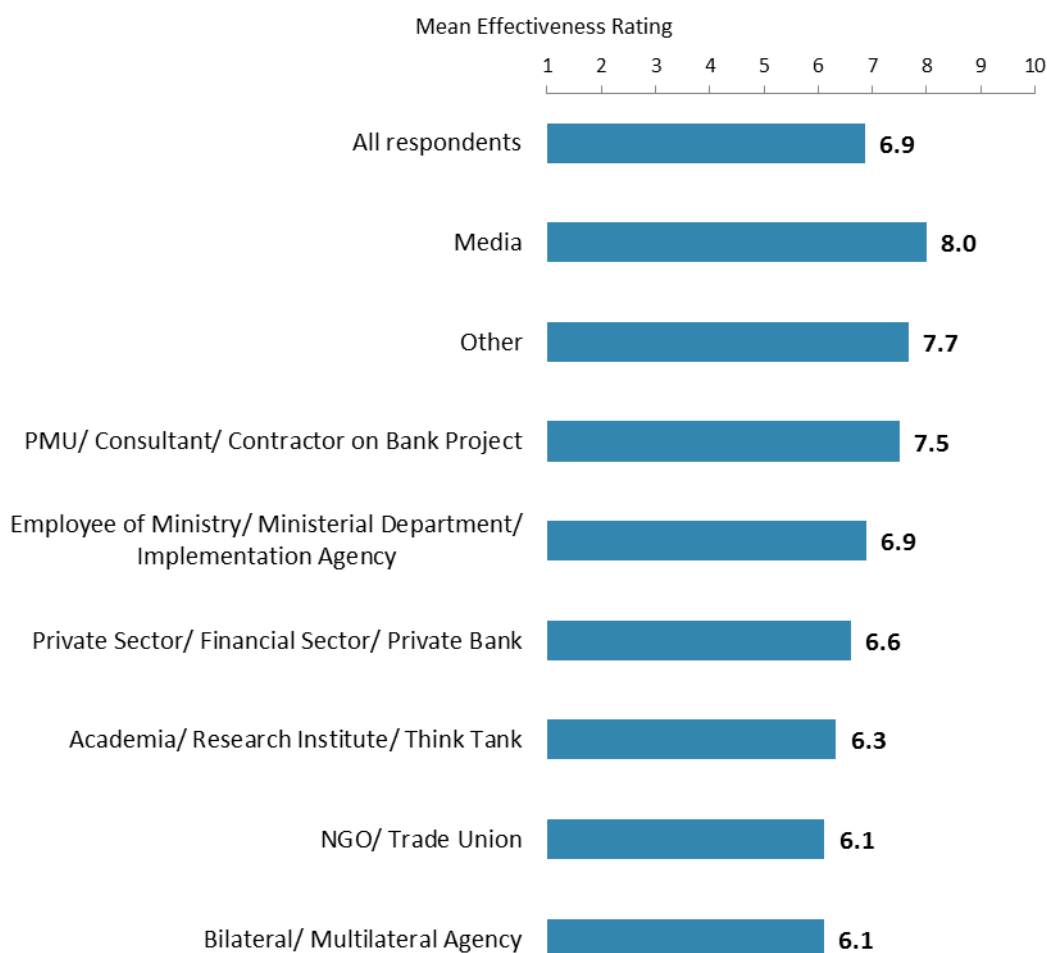

As noted in the “Methodology” section, the indicator questions referred to throughout the survey report are questions that are asked in every country that engages in the Country Survey. These will be aggregated for the Bank’s annual Corporate Scorecard.

The World Bank’s Overall Effectiveness (*Indicator Question*)

- Across all respondents, ratings of the World Bank’s overall effectiveness in Uzbekistan received a mean rating of 6.9. This is statistically similar to the mean rating received in the FY ’03 country survey (6.7).
- Respondents across all stakeholder groups gave statistically similar ratings for the World Bank’s overall effectiveness in Uzbekistan.

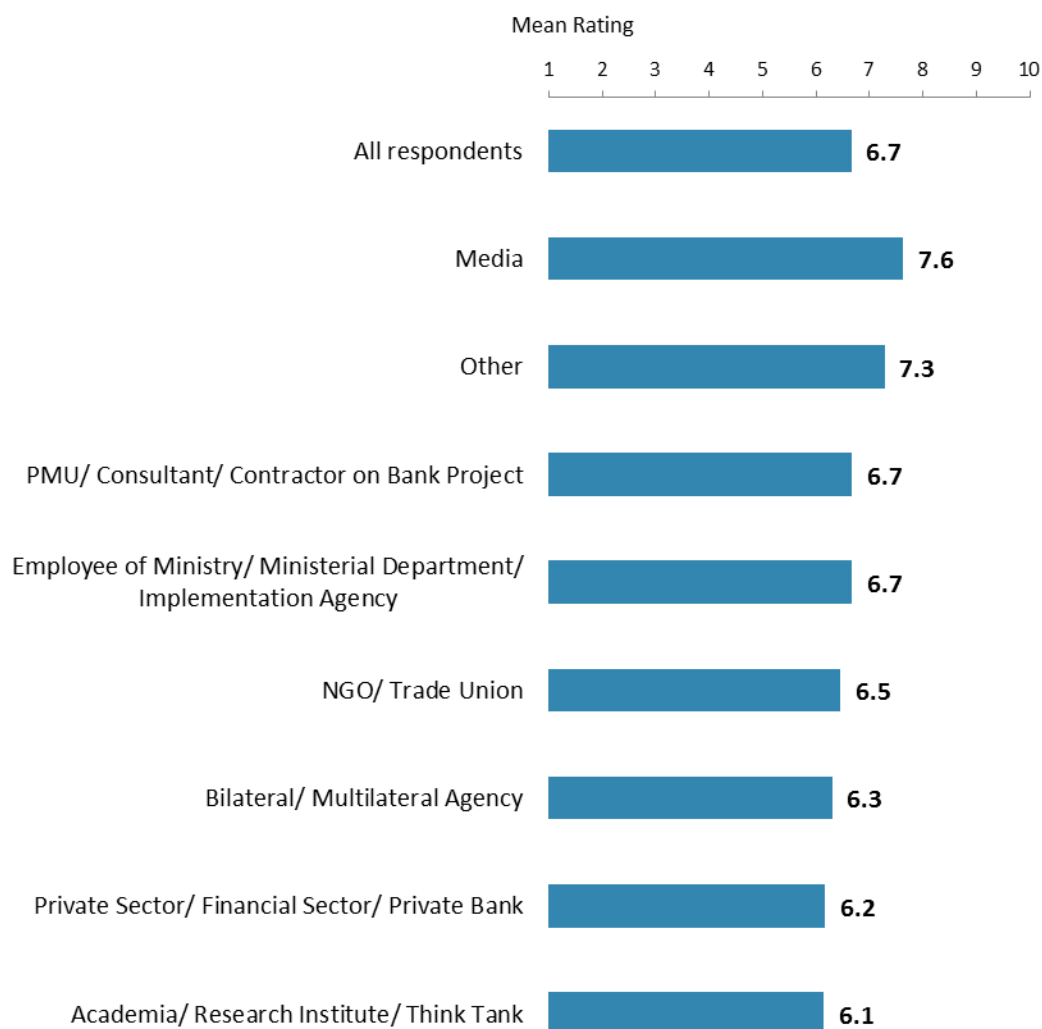


"Overall, please rate your impression of the World Bank's effectiveness in Uzbekistan?"

- Respondents across all stakeholder groups gave statistically similar ratings for the World Bank helping achieve development results in Uzbekistan.

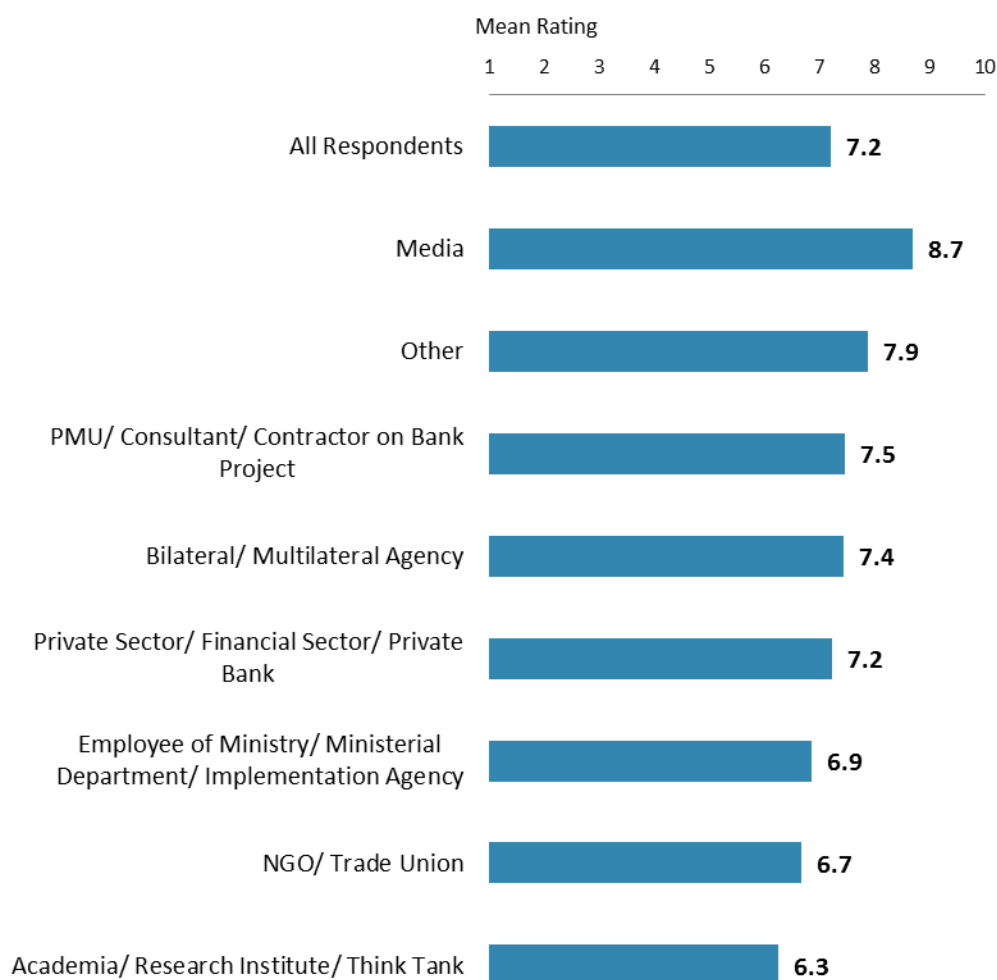


"To what extent does the World Bank's work help to achieve development results in Uzbekistan?"

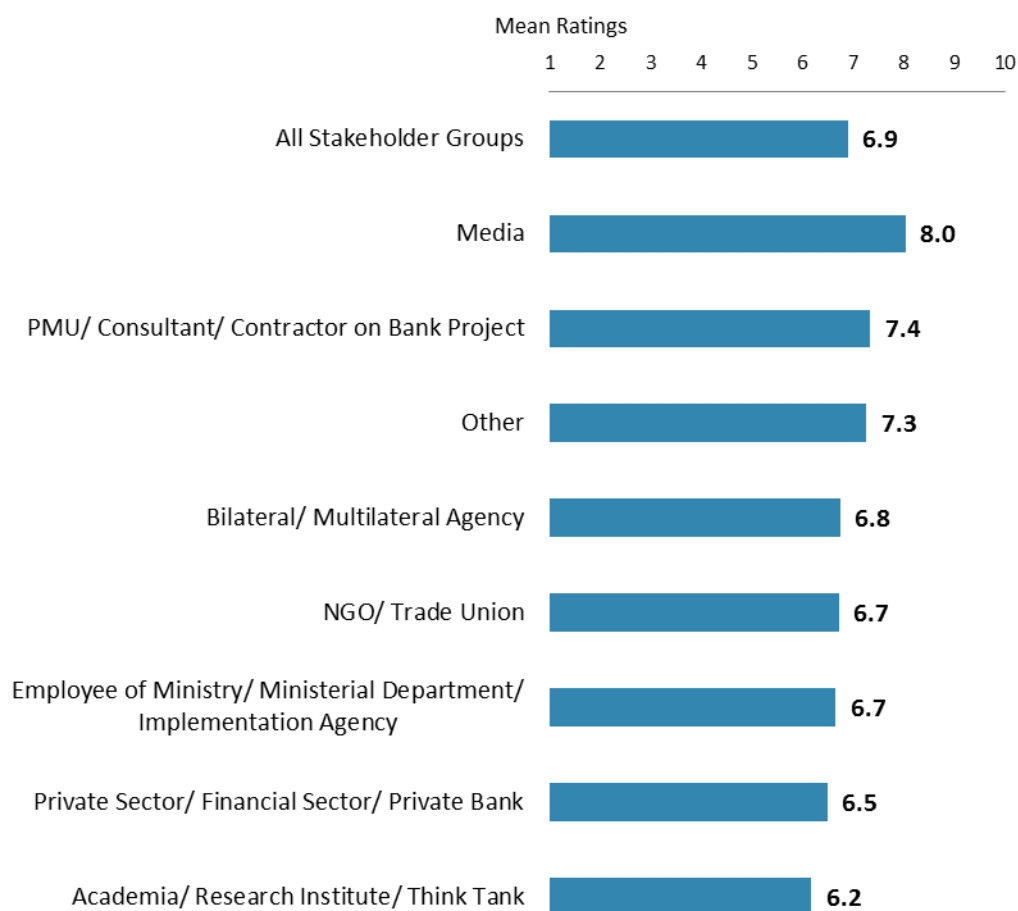


"To what extent do you believe the World Bank's staff is well prepared (e.g., skills and knowledge) to help Uzbekistan solve its most complicated development challenges?"

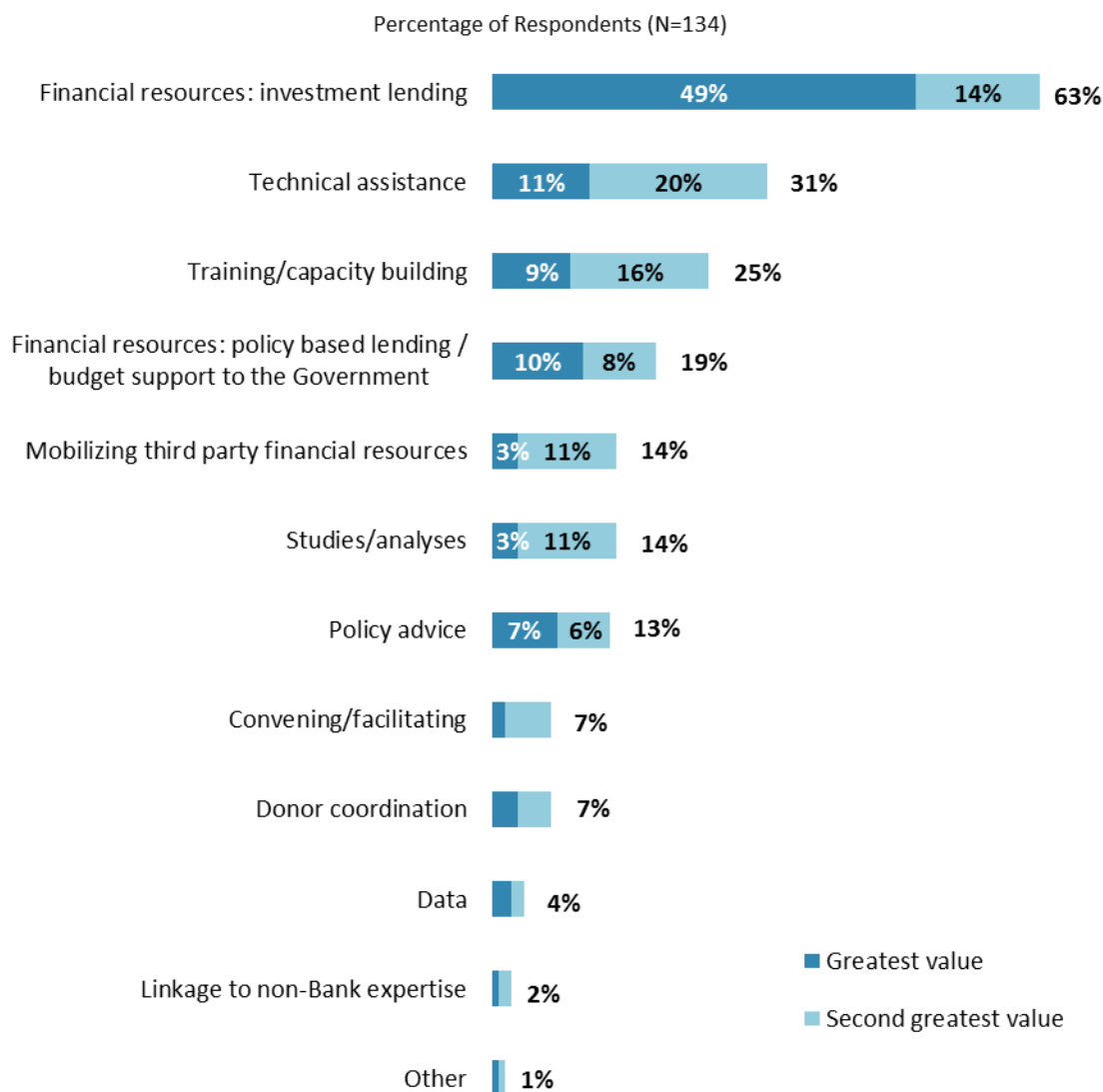


Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

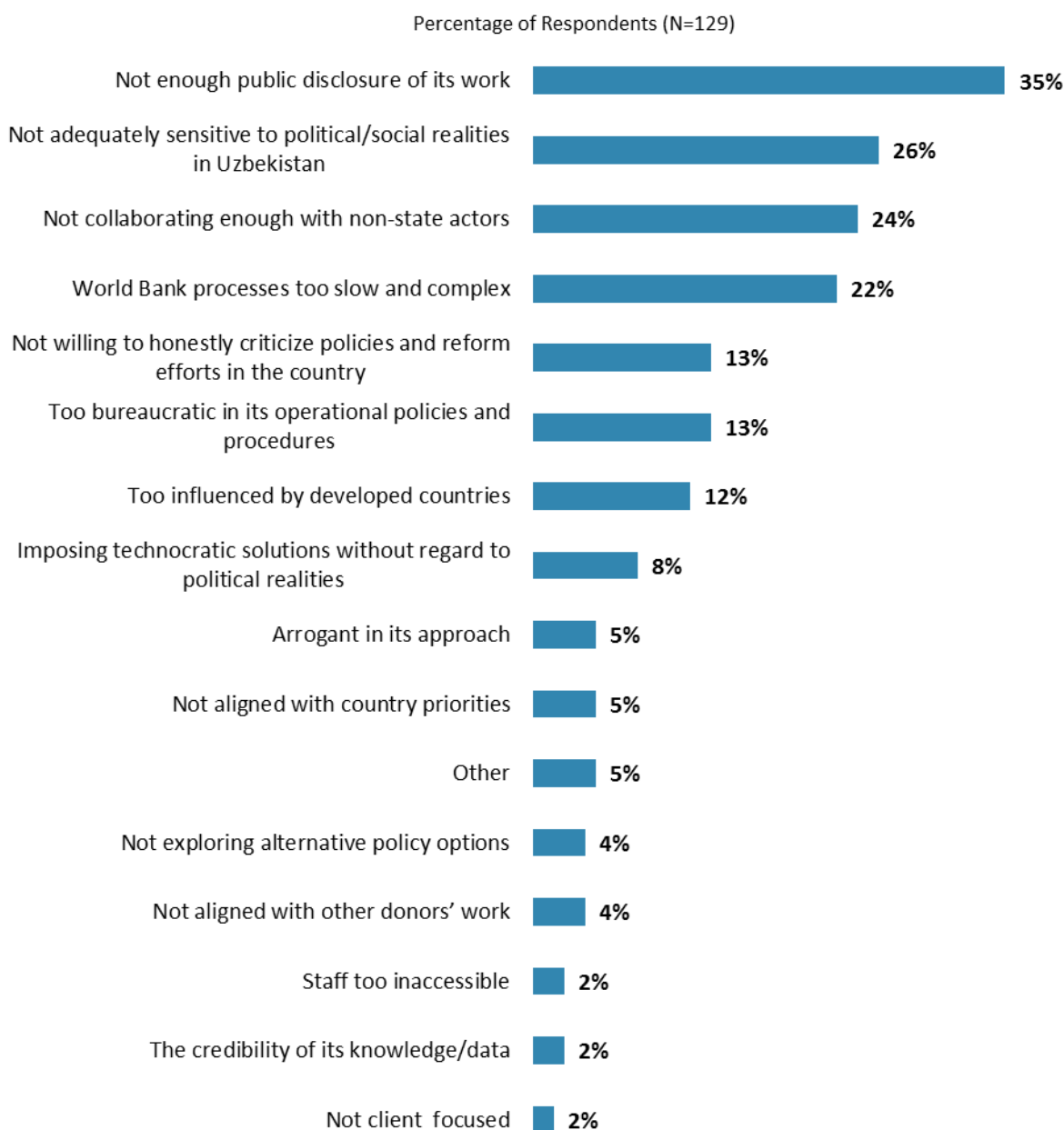
Greatest Value

Greatest Weakness

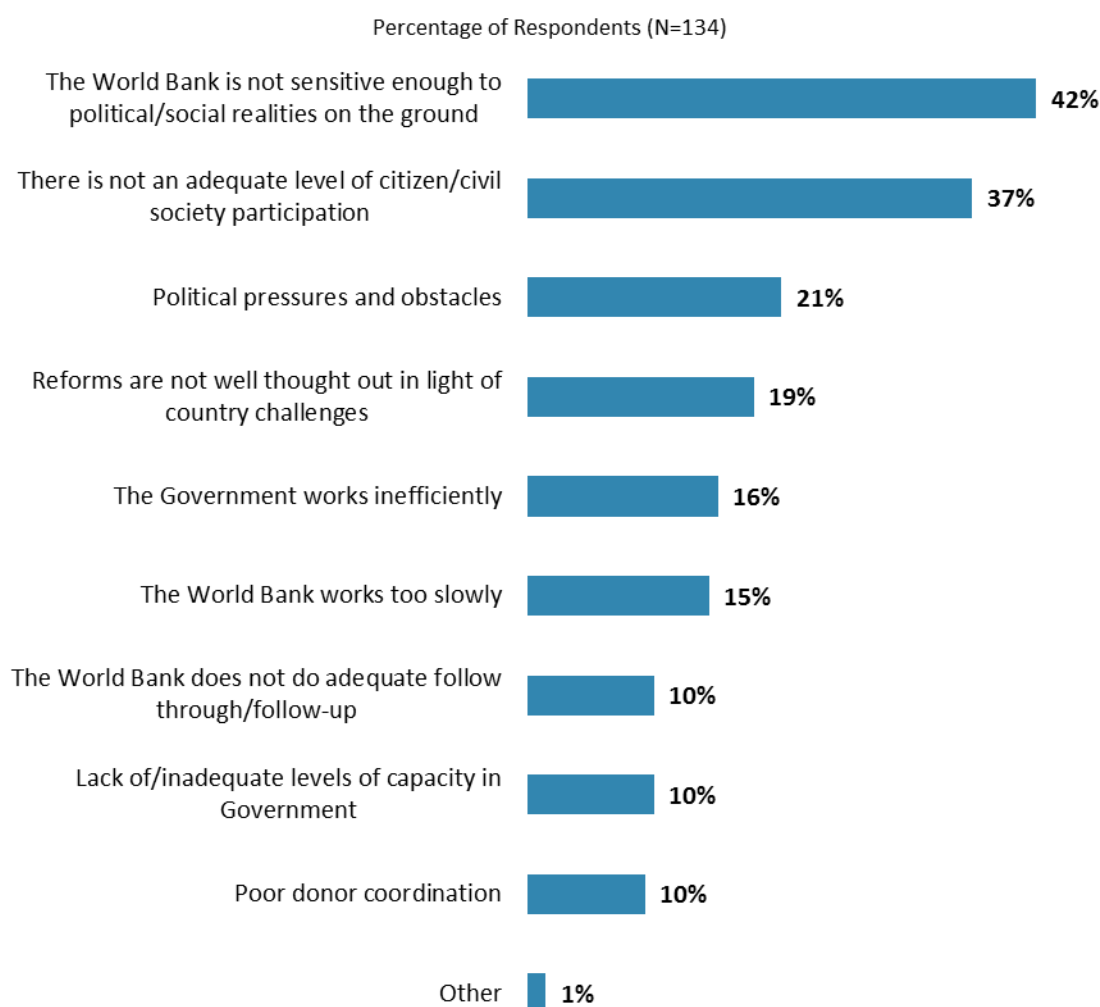


"Which of the following do you identify as the World Bank's greatest WEAKNESSES in its work in Uzbekistan? (Choose no more than TWO)"

Attributing Slow or Failed Reform Efforts

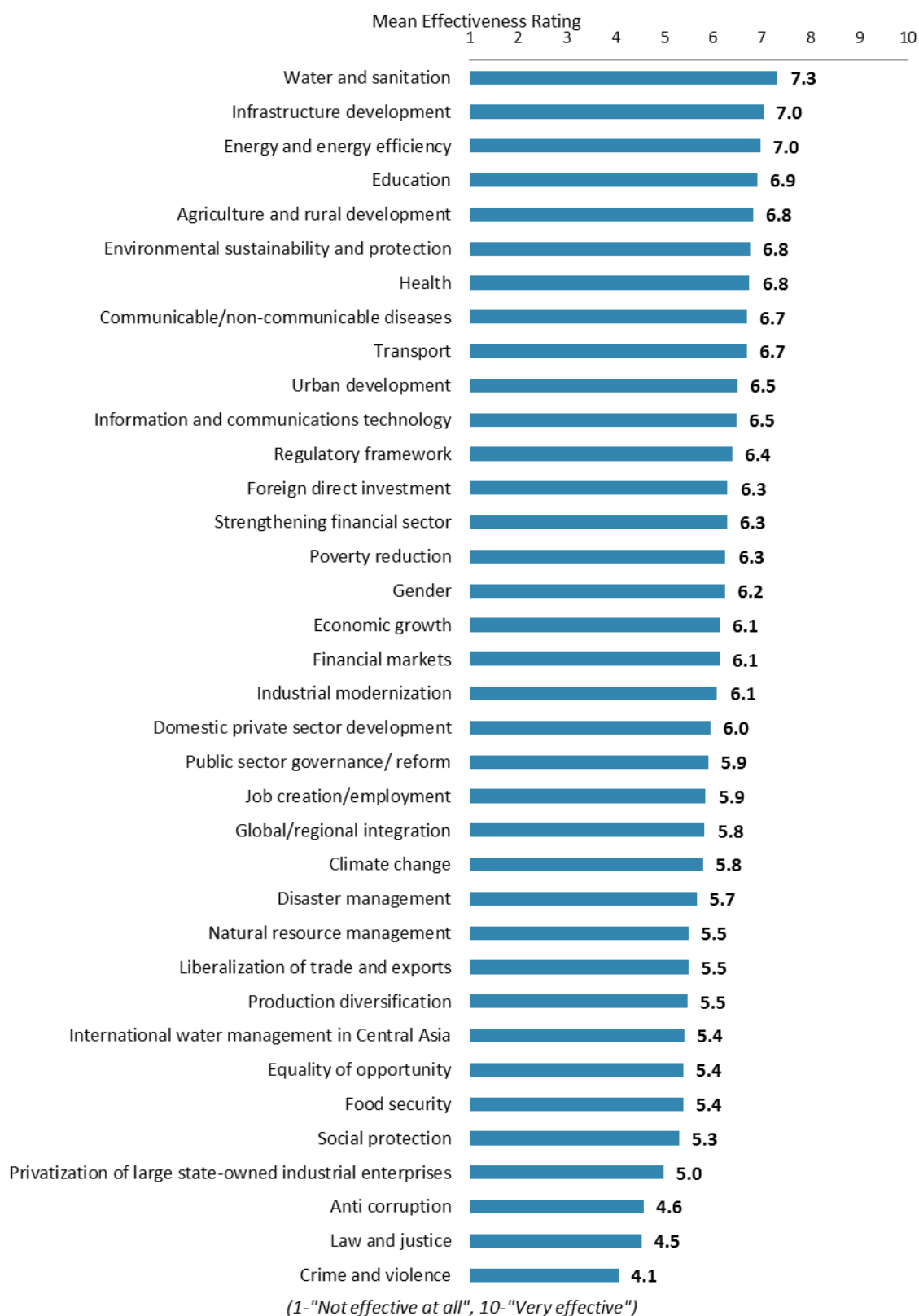
- While employees of ministries/ministerial departments/implementation agencies and respondents from PMUs/consultants/contractors on Bank-supported projects tended to attribute slow or failed reform efforts to the Bank's not being sensitive enough to political/social realities on the ground, respondents from the media and CSOs/trade unions tended to indicate that there is not an adequate level of citizen/civil society participation.

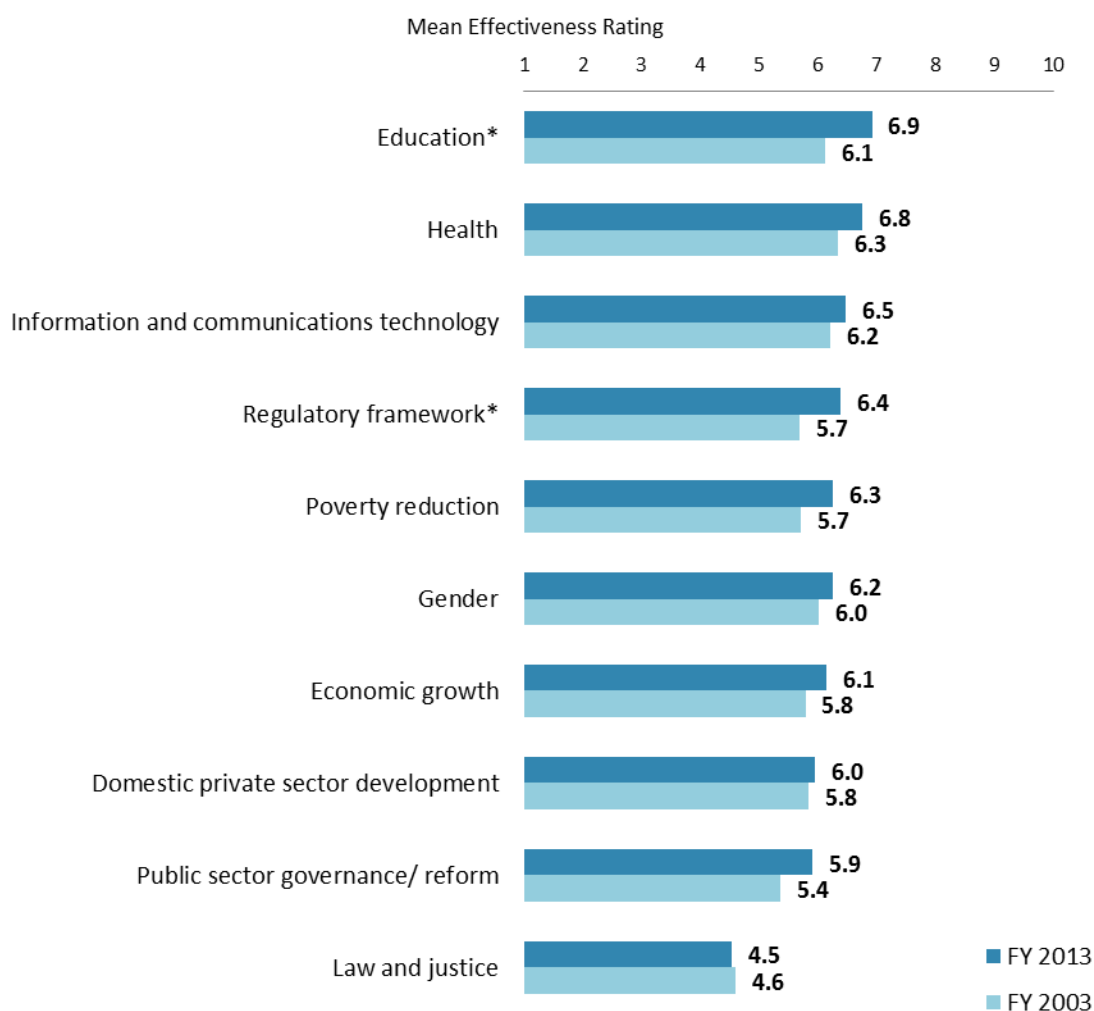
Specific Areas of Effectiveness (continued)

- There were significant stakeholder group differences in their ratings of the Bank's effectiveness in the education sector only. Respondents from the media and PMUs/consultants/contractors working on World Bank projects gave the highest ratings, whereas respondents from the private sector/financial sector/private banks and academia/research institutes/think tanks tended to give significantly lower ratings.

- Respondents in this year's country survey gave significantly *higher* ratings for the Bank's effectiveness in "education" and "regulatory framework" compared to respondents in the FY '03 country survey.

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the Bank's overall effectiveness and ratings of its ability to help achieve development results in Uzbekistan, bivariate correlational analyses were conducted using respondents' ratings of the thirty-six specific areas of effectiveness.

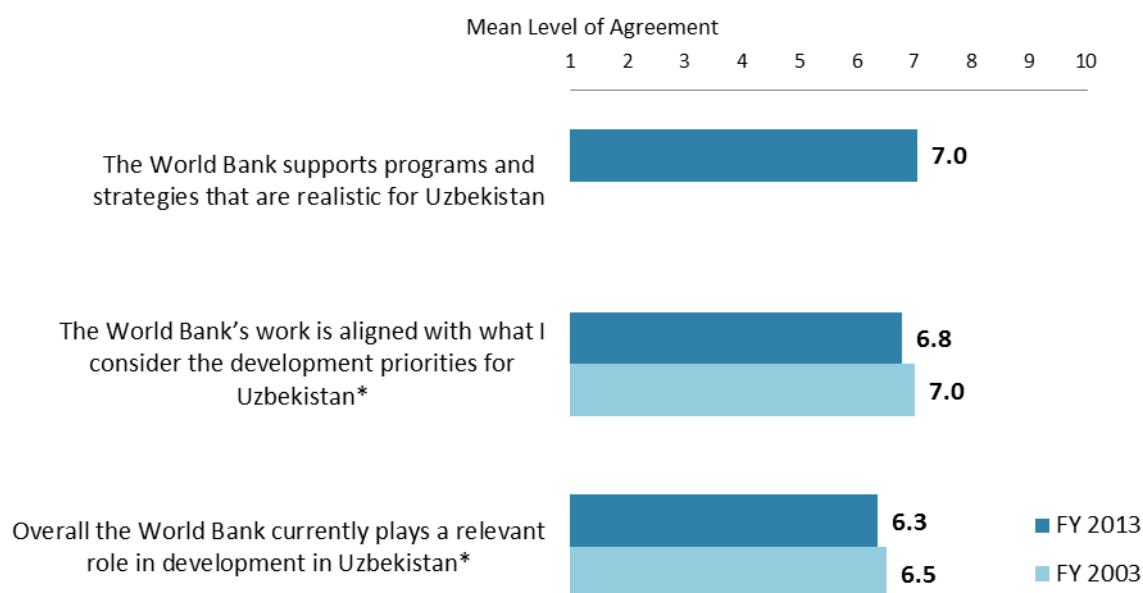
Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the Bank's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the Bank's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank's overall effectiveness or perceptions of the Bank's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's overall effectiveness in Uzbekistan. The areas determined to be key drivers from these analyses were:
 - The Bank's effectiveness at strengthening financial sector;
 - The Bank's effectiveness at equality of opportunity; and
 - The Bank's effectiveness at financial markets.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's ability to help achieve development results in Uzbekistan, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the Bank's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - The Bank's effectiveness at regulatory framework;
 - The Bank's effectiveness at public sector governance/reform;
 - The Bank's effectiveness at financial markets;
 - The Bank's effectiveness at natural resource management; and
 - The Bank's effectiveness at equality of opportunity.

VII. How the World Bank Operates

The World Bank's Work in Uzbekistan

- Respondents in this year's country survey had statistically similar levels of agreement with these statements compared to respondents in the FY '03 country survey.
- There were significant stakeholder group differences in their levels of agreement with the statement that "overall the World Bank currently plays a relevant role in development in Uzbekistan". Respondents from the media had the highest levels of agreement that the Bank plays a relevant role in development whereas respondents from academia/research institutes/think tanks had significantly lower levels of agreement.

VII. How the World Bank Operates (continued)

Overall Perceptions

- Respondents in this year's country survey had significantly *lower* levels of agreement that the World Bank disburses funds promptly compared to respondents from the FY '03 country survey (7.8).
- There were significant stakeholder group differences in their ratings across a number of these areas (see Appendix B for details). For the most part, respondents from the media tended to have the highest levels of agreement whereas respondents from academia/research institutes/think tanks tended to have significantly lower levels of agreement.
- Respondents across all stakeholder groups had statistically similar levels of agreement with the indicator statement ("Where country systems are adequate, the World Bank makes appropriate use of them").



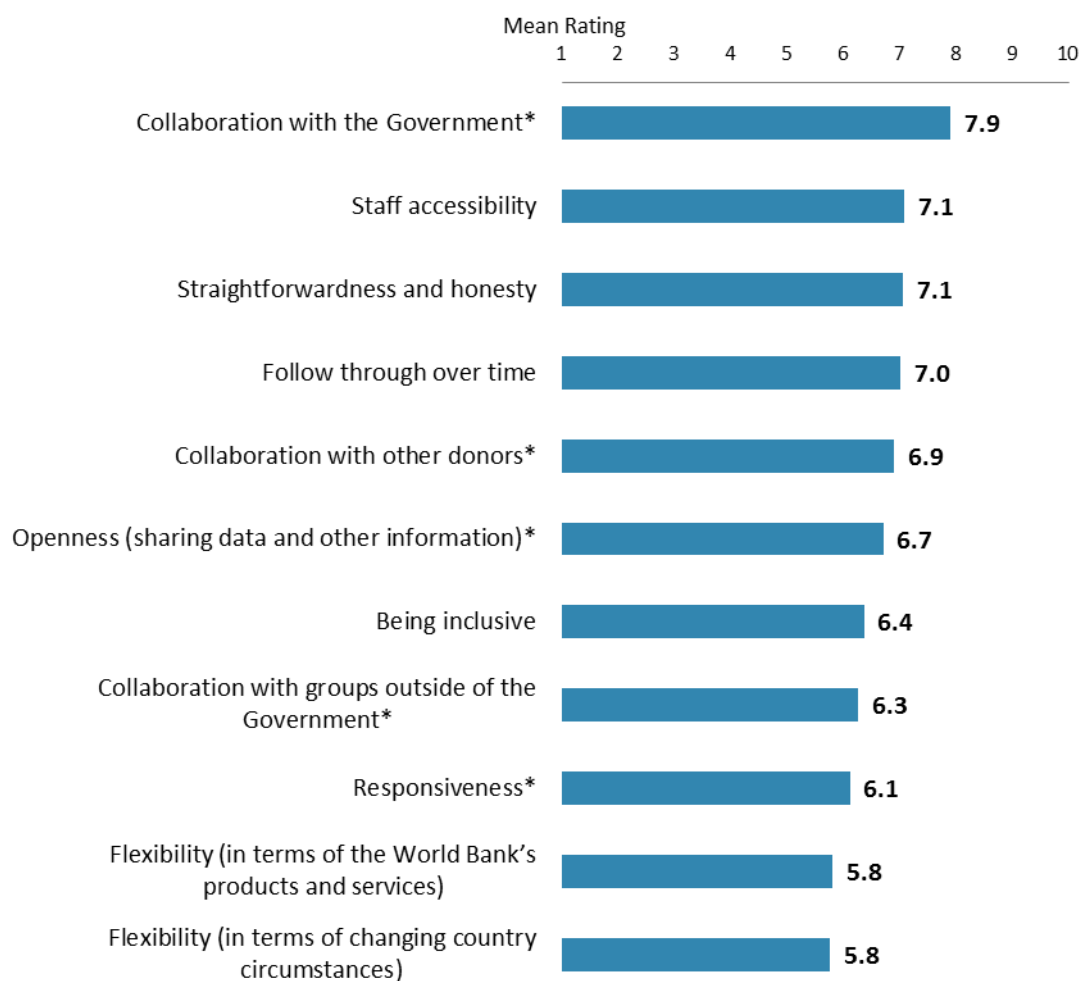
"To what extent do you agree/disagree with the following statements?"

The World Bank as an Effective Development Partner

- Respondents in this year's country survey gave significantly *lower* ratings for the Bank's flexibility in terms of its products and services and in terms of changing country circumstances compared to respondents from the FY '03 country survey (6.8 and 6.9, respectively).
- Respondents across stakeholder groups gave statistically similar ratings for all of the following qualities of the Bank as an effective development partner, except the Bank's openness (indicator question) and inclusiveness. For the most part, respondents from PMUs/consultants/contractors on Bank projects tended to give the highest ratings whereas respondents from academia/research institutes/think tanks and the private sector/financial sector/private banks tended to give significantly lower ratings.



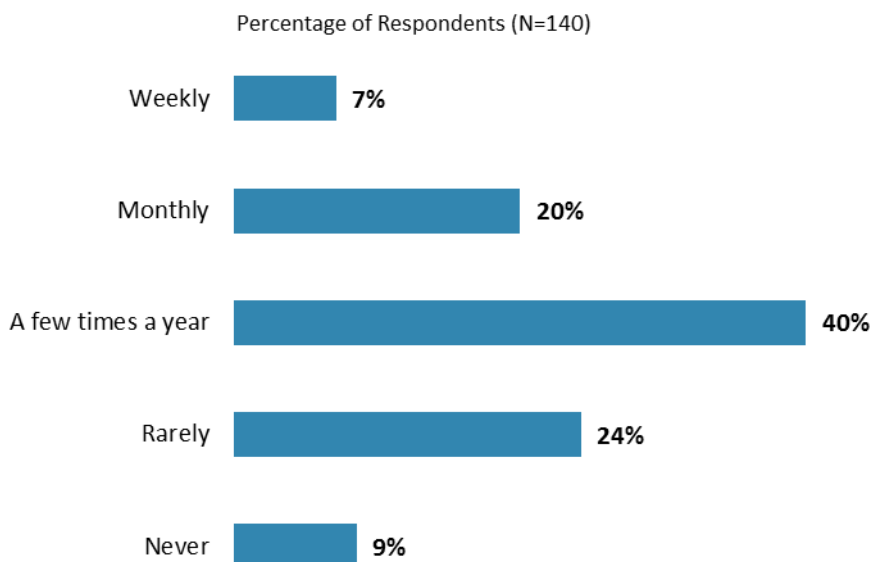
"To what extent is the World Bank an effective development partner in Uzbekistan, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")

VIII. World Bank Knowledge and Instruments

Frequency of Consulting World Bank Knowledge Work and Activities

- Respondents from bilateral/multilateral agencies, PMUs/consultants/contractors on Bank projects, the media, and employees of ministries/ministerial departments/implementation agencies tended to indicate that they consulted Bank knowledge more often than respondents from other stakeholder groups.

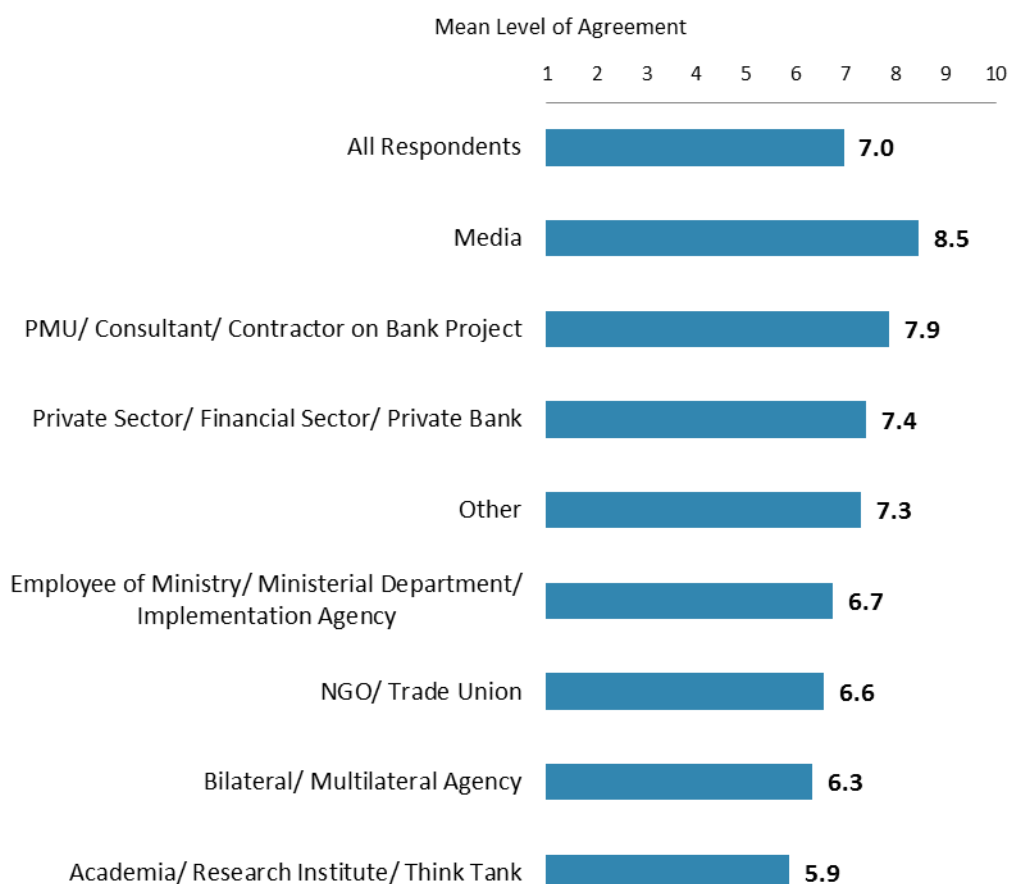


"How frequently do you consult World Bank knowledge work and activities in the work you do?"

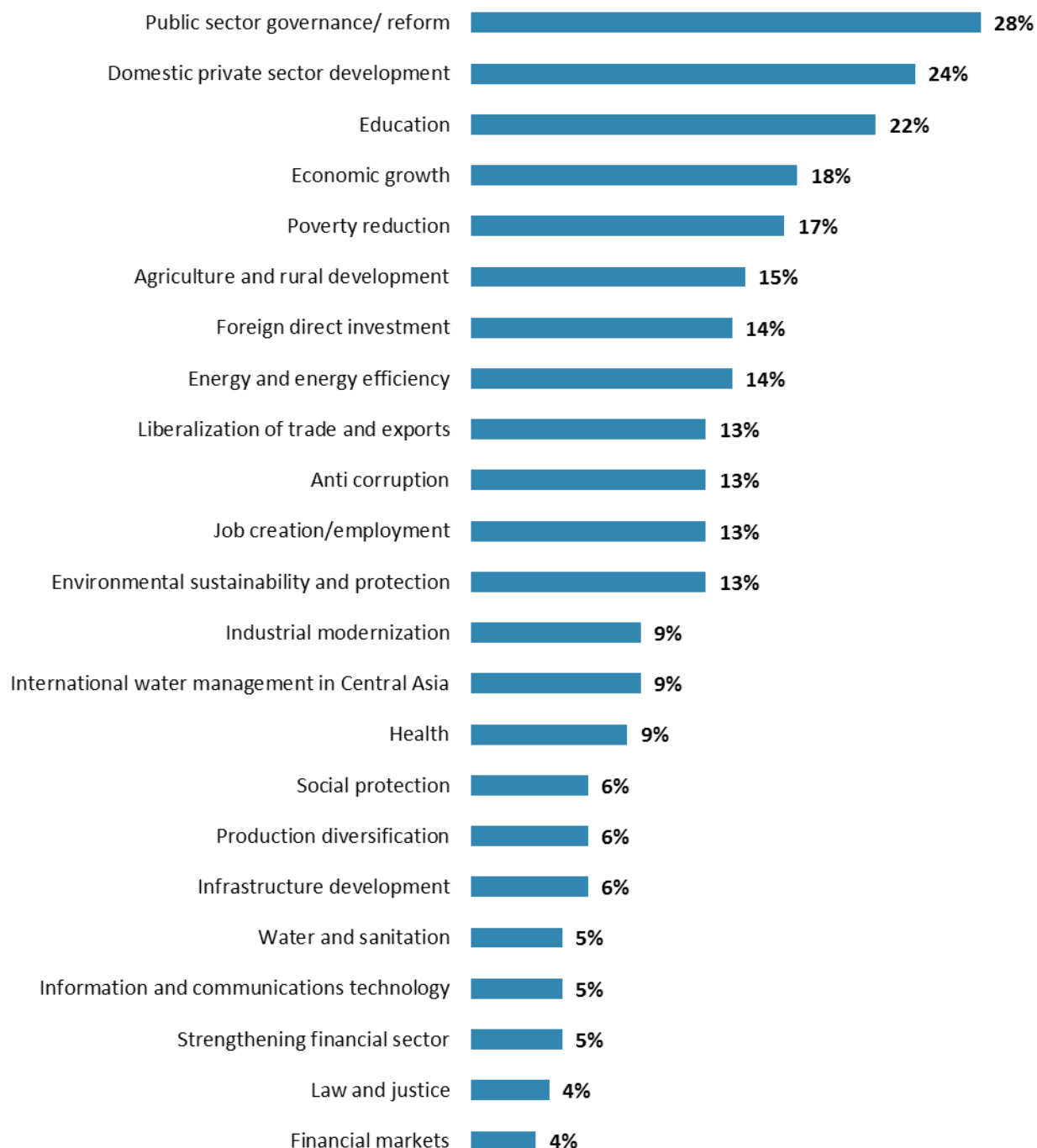


"The World Bank meets Uzbekistan's needs for knowledge services"

Percentage of Respondents (N=141)

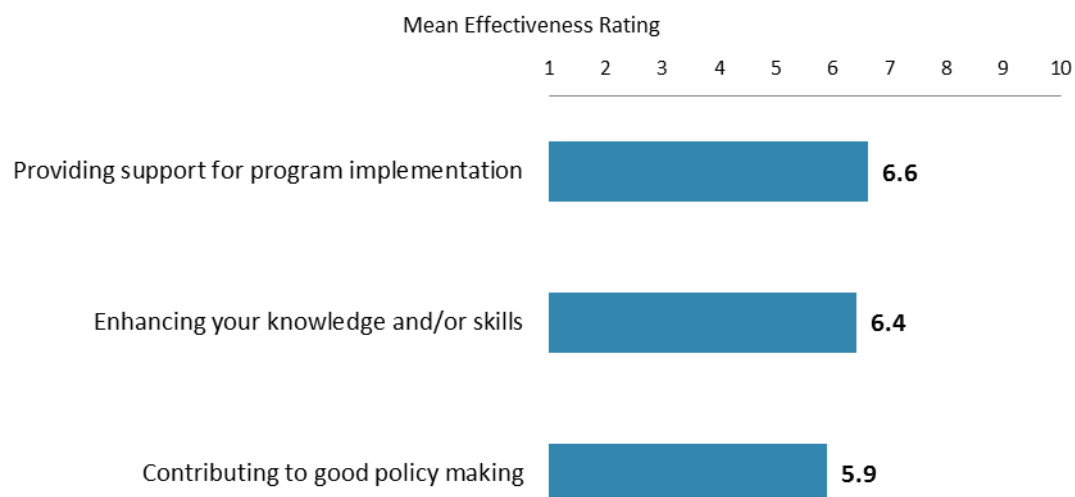

- Respondents across all stakeholder groups gave statistically similar ratings for effectiveness of the World Bank's knowledge work and activities in all these areas.

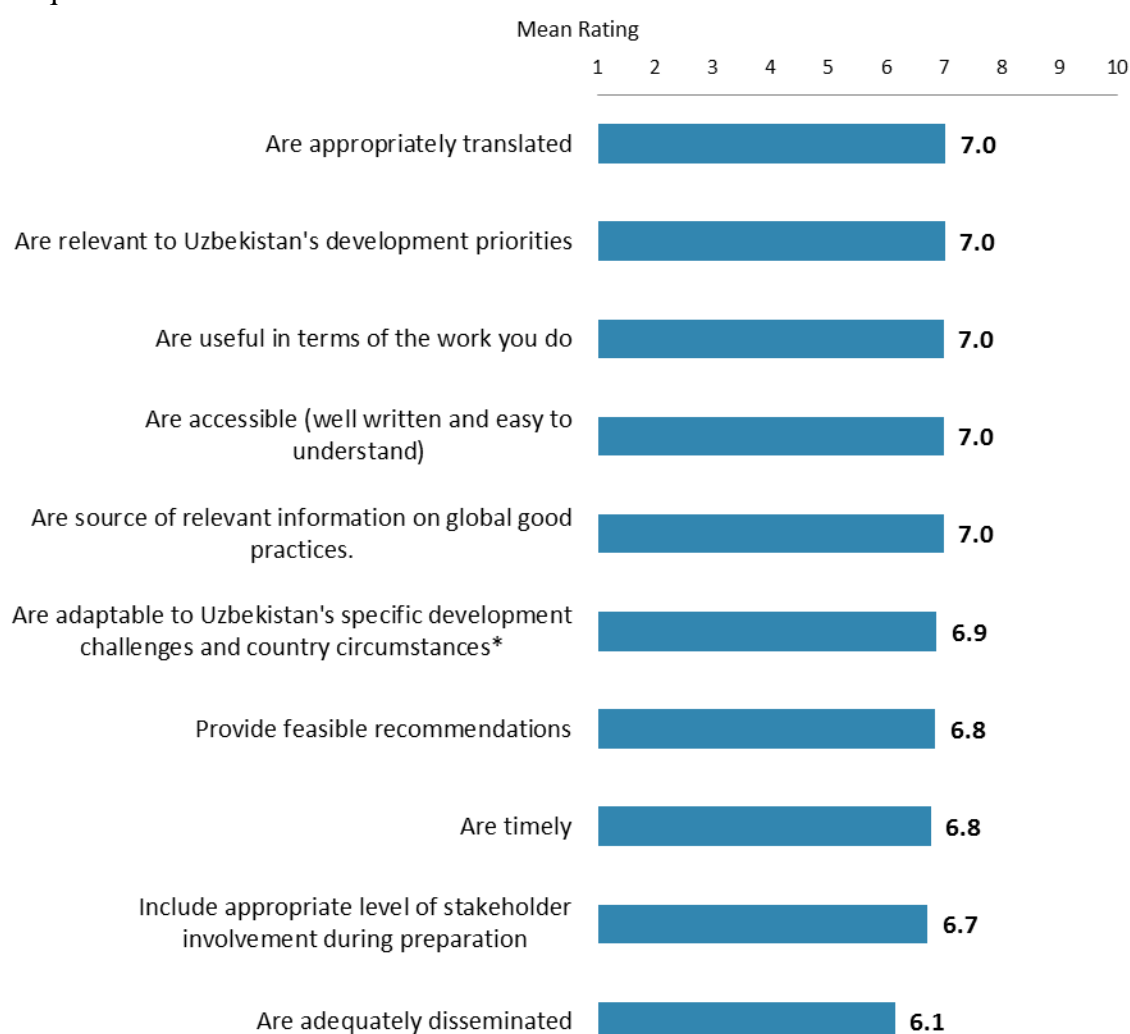


"In Uzbekistan, how effective do you believe the World Bank's knowledge work and activities are at:"

- Respondents in this year's country survey gave significantly *higher* ratings for the Bank's knowledge work and activities being adaptable to Uzbekistan's specific development challenges and country circumstances (indicator question) compared to respondents from the FY '03 country survey (5.9), but significantly *lower* ratings for the usefulness of the Bank's knowledge work and activities compared to respondents from the FY '03 country survey (7.5).
- Respondents across all stakeholder groups gave statistically similar ratings for all the following qualities of the Bank's knowledge work and activities, including the indicator question.



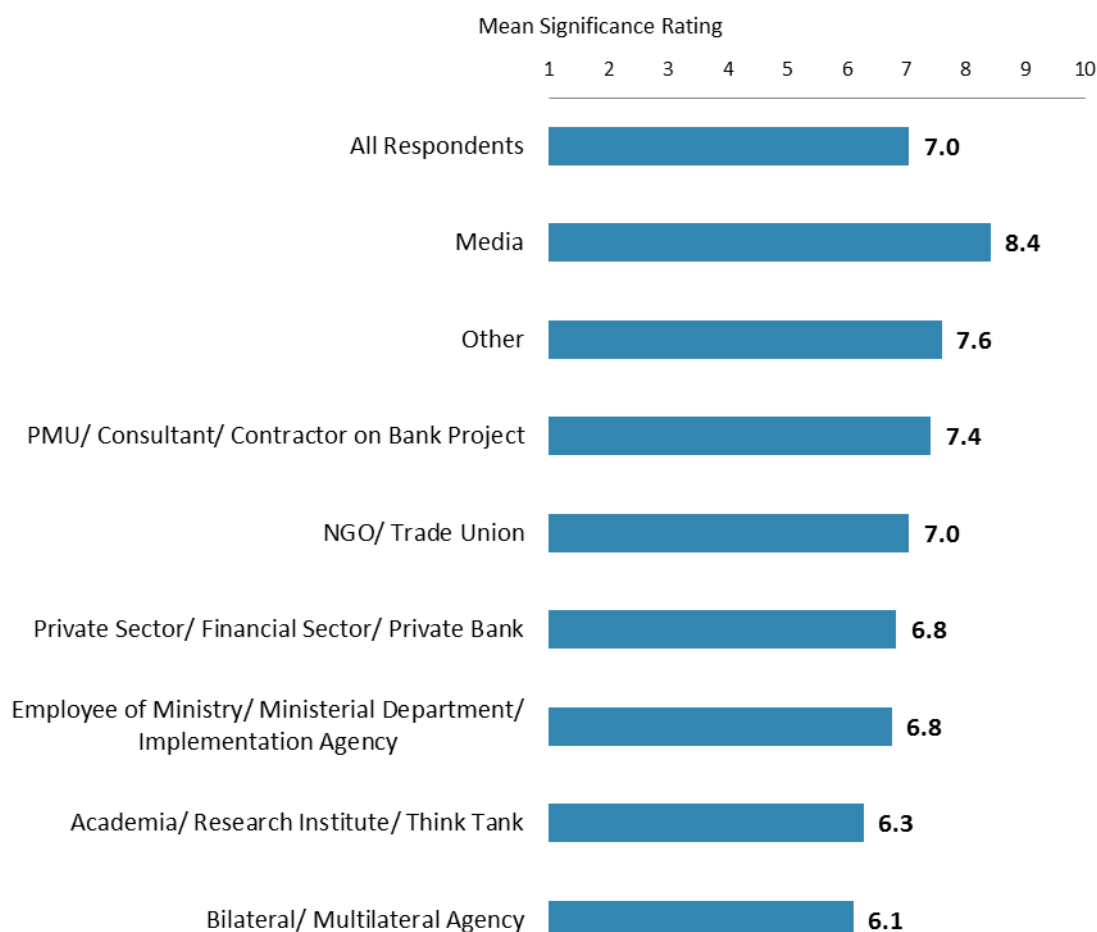
"In Uzbekistan, to what extent do you believe that the World Bank's knowledge work and activities:"

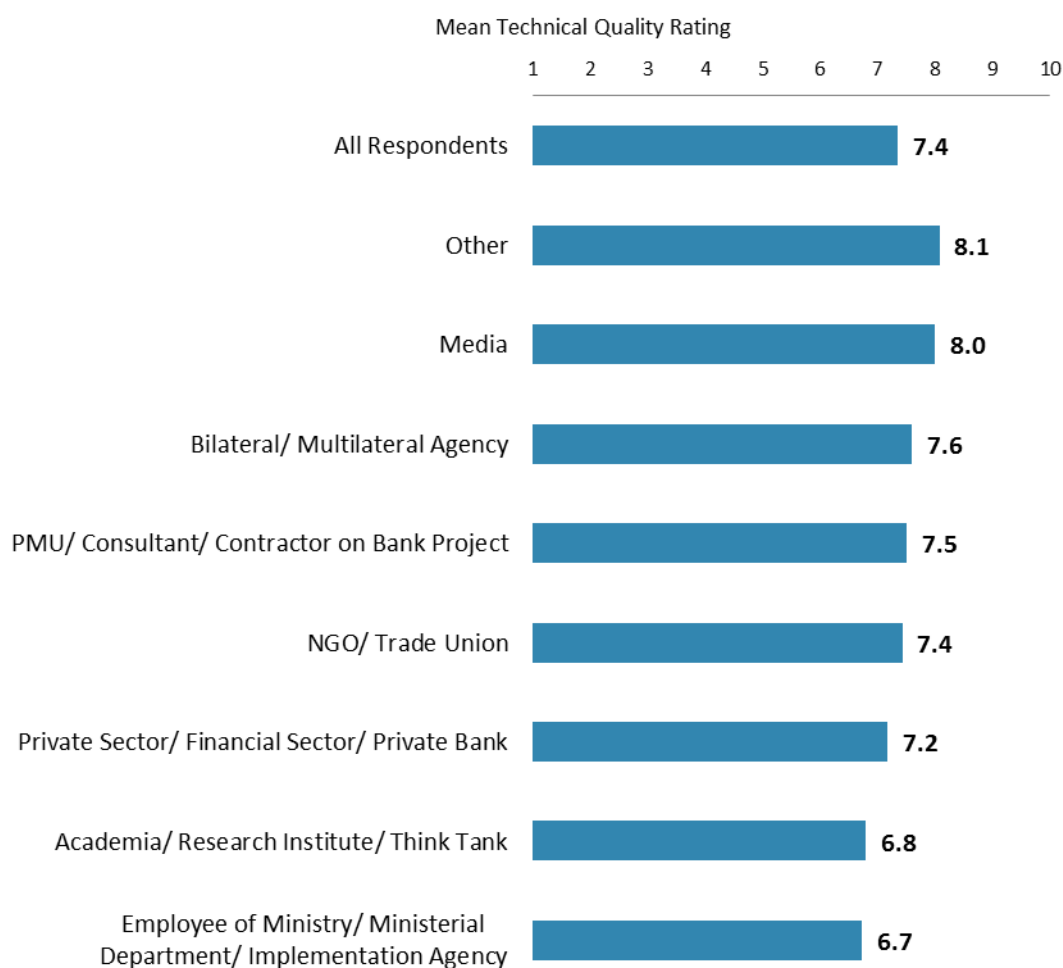


"Overall, how significant a contribution do you believe the World Bank's knowledge work and activities make to development results in your country?"

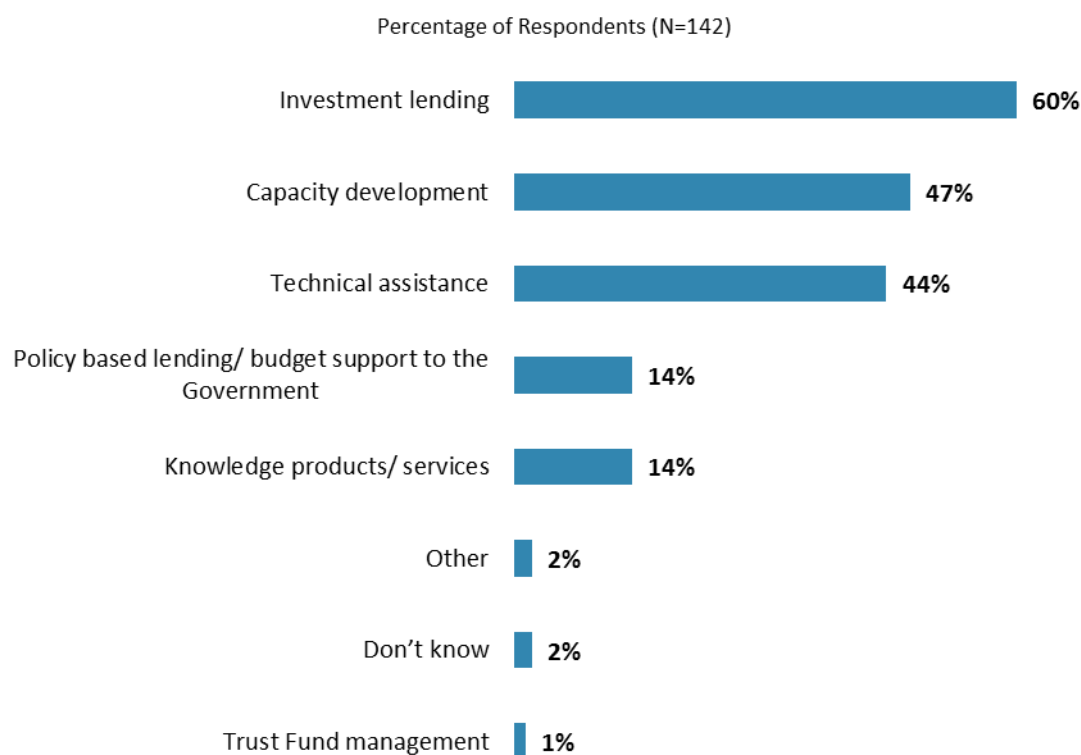


"To what extent do you believe that Uzbekistan received value for money from the World Bank's products/services that were paid for on a fee for service basis?"

- Respondents from PMUs/consultants/contractors on Bank-supported projects and employees of ministries/ministerial departments/implementation agencies tended to indicate “investment lending” as the World Bank’s most effective instrument more often than respondents from other stakeholder groups.
- Respondents from the media tended to indicate “capacity development” as the Bank’s most effective instrument in reducing poverty.
- Respondents from the private sector/financial sector/private banks tended to indicate “technical assistance” as the Bank’s most effective instrument.

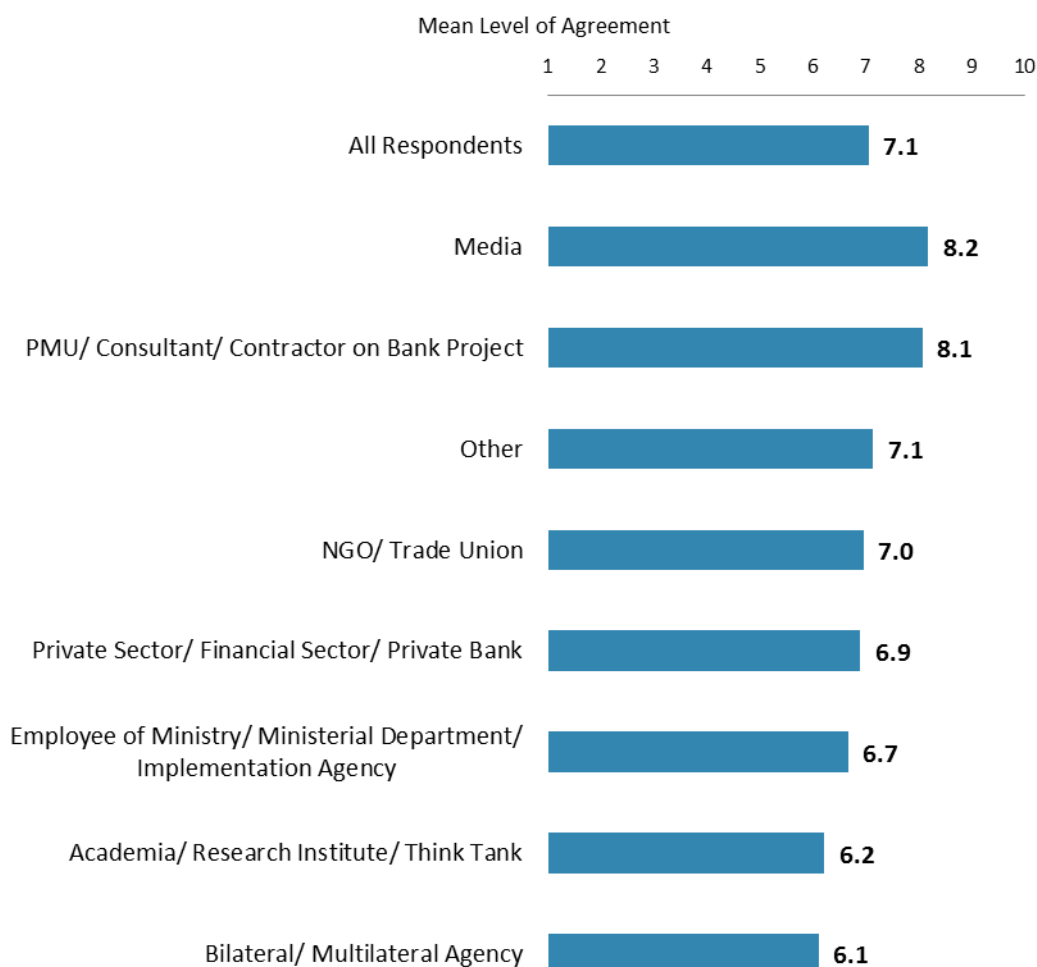


“Which World Bank instruments do you believe are the MOST effective in reducing poverty in Uzbekistan? (Choose no more than TWO)”

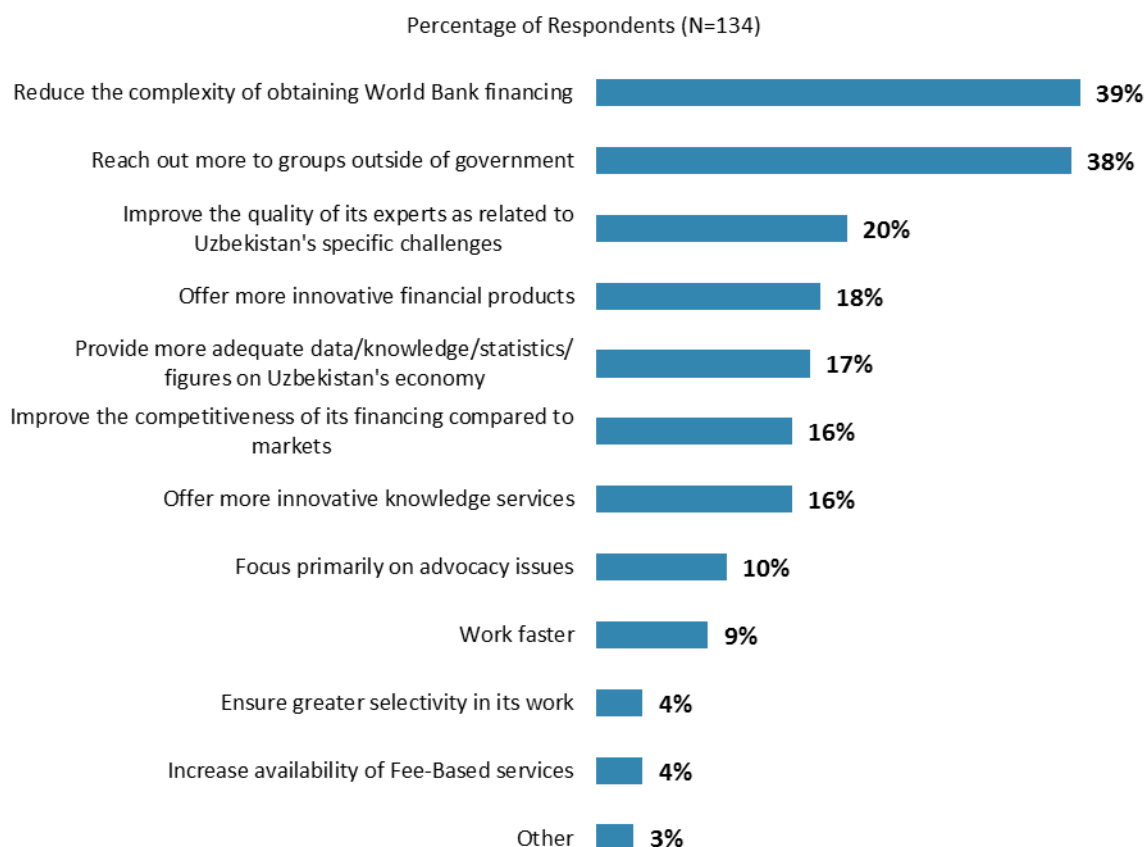

Making the World Bank of Greater Value

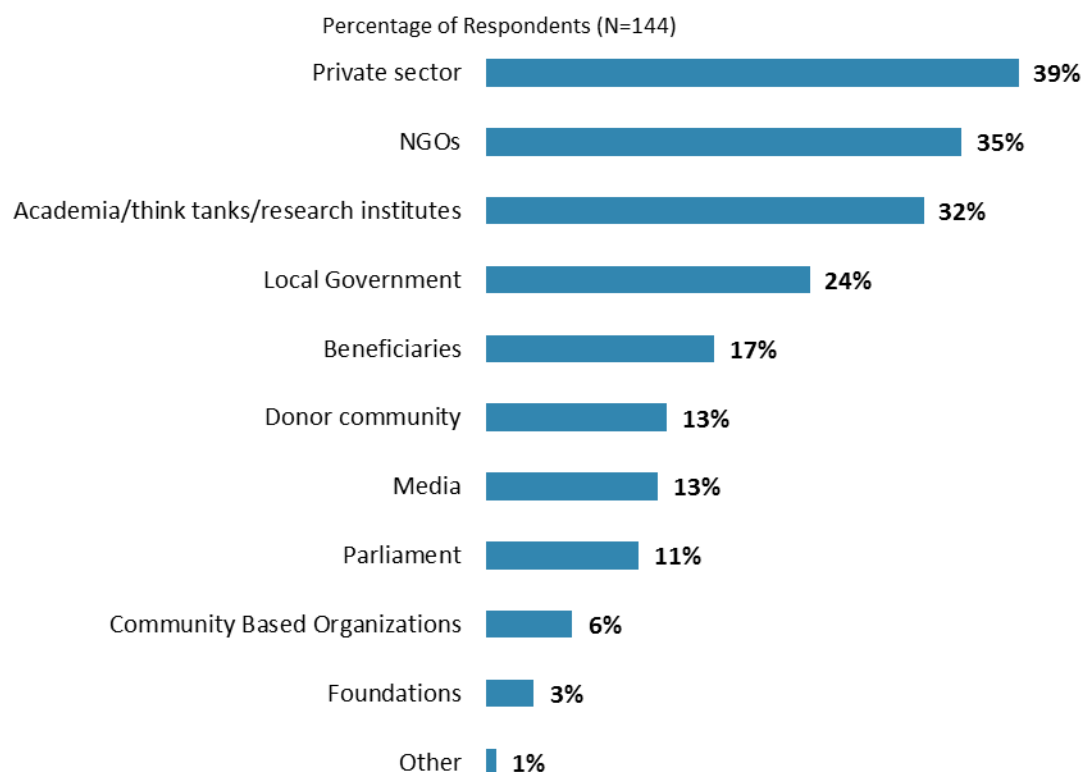

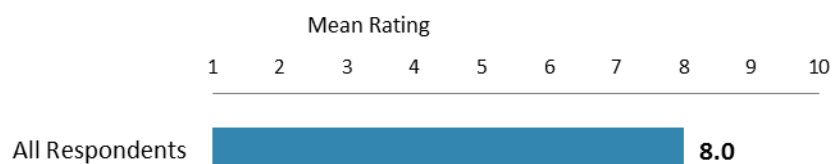

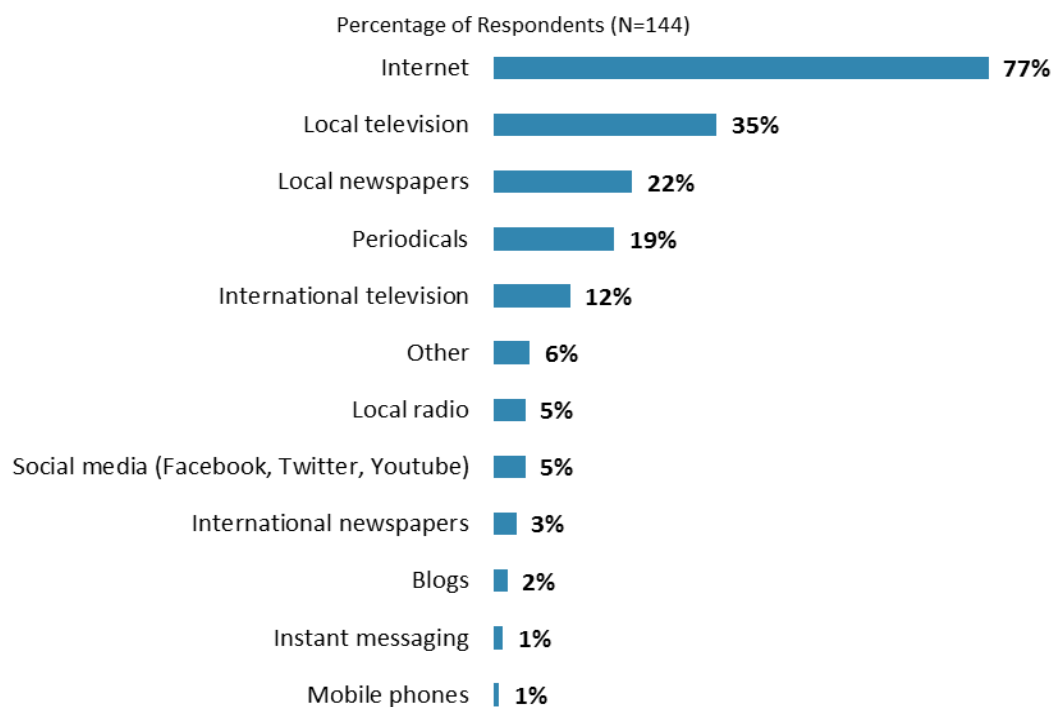

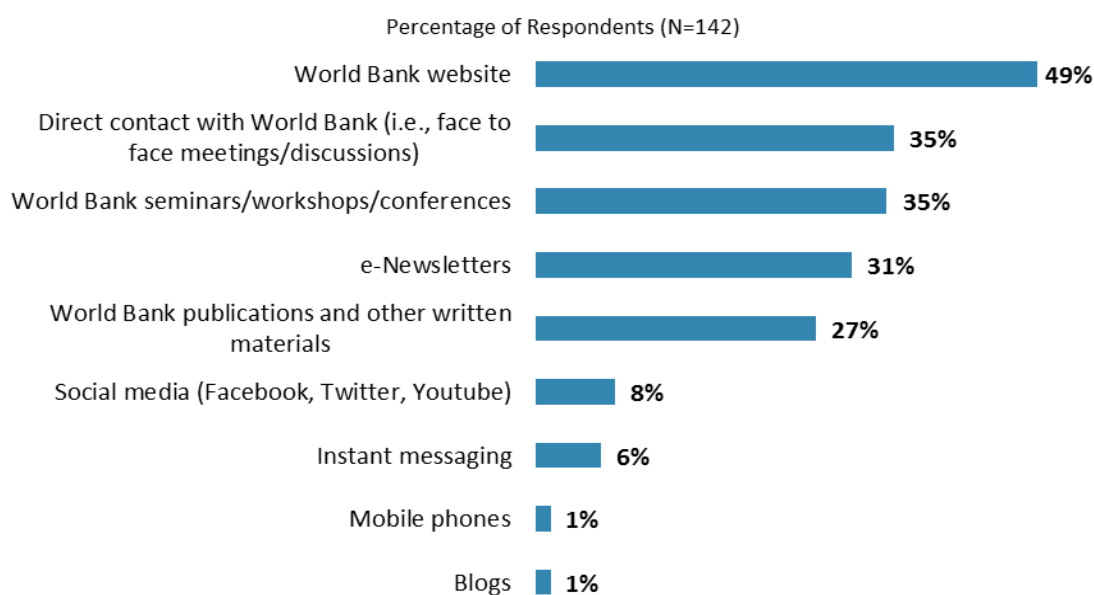

Preferred Information Sources

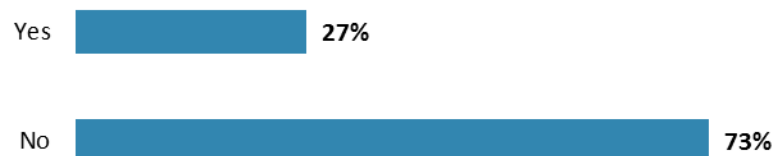


"How would you prefer to receive information from the World Bank? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

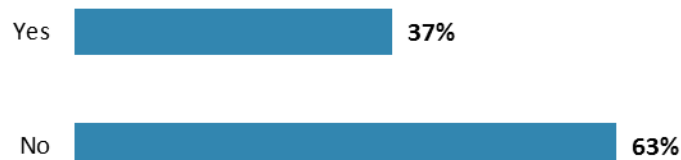
Percentage of Respondents (N=131)



"Are you aware of the World Bank's Access to Information Policy under which the Bank will now disclose any information in its possession that is not on a list of exceptions?"

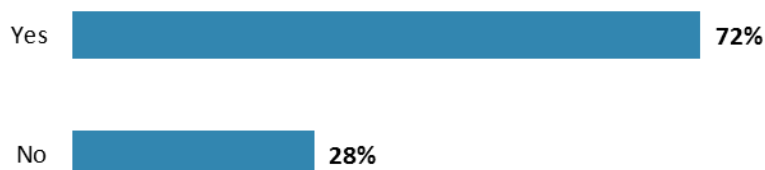

"Have you requested information from the World Bank on its activities in the past year?"

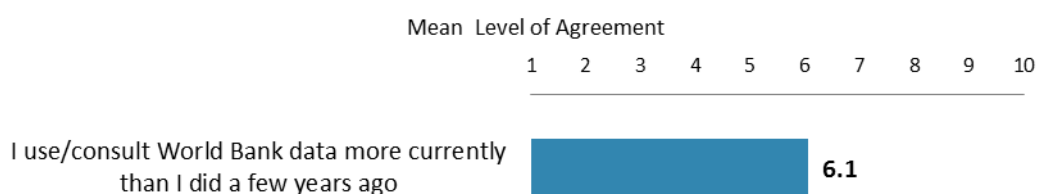

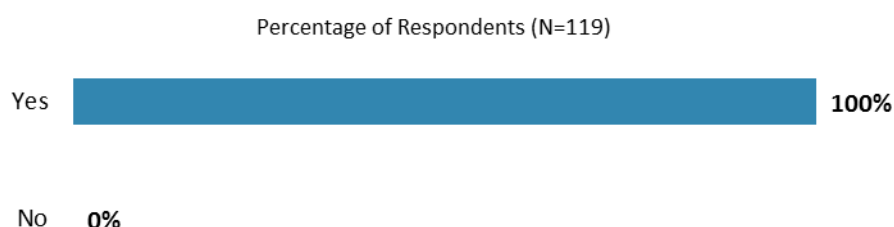

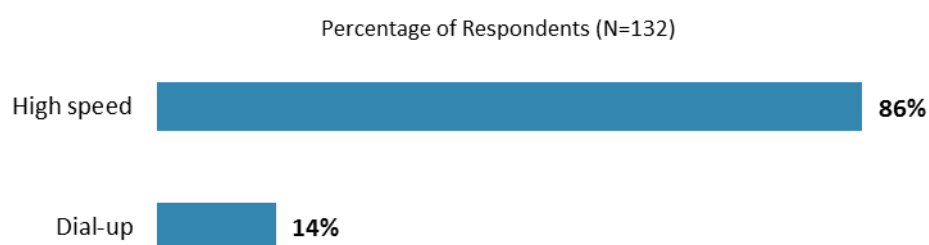


"Please rate how much you agree with the following statements"

Internet Access



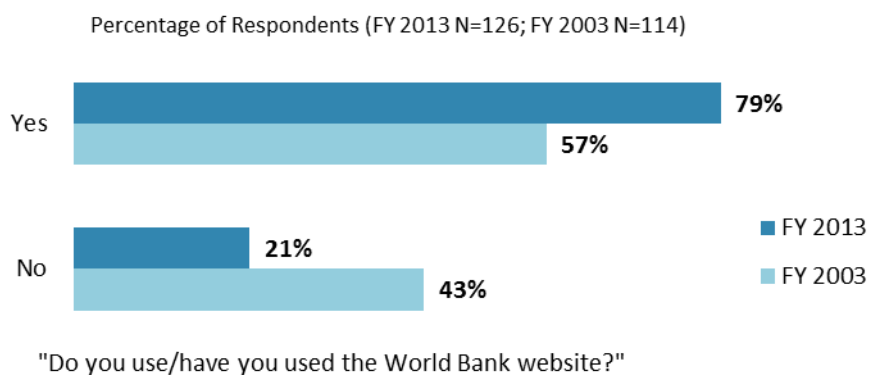
"Do you have access to the Internet?"



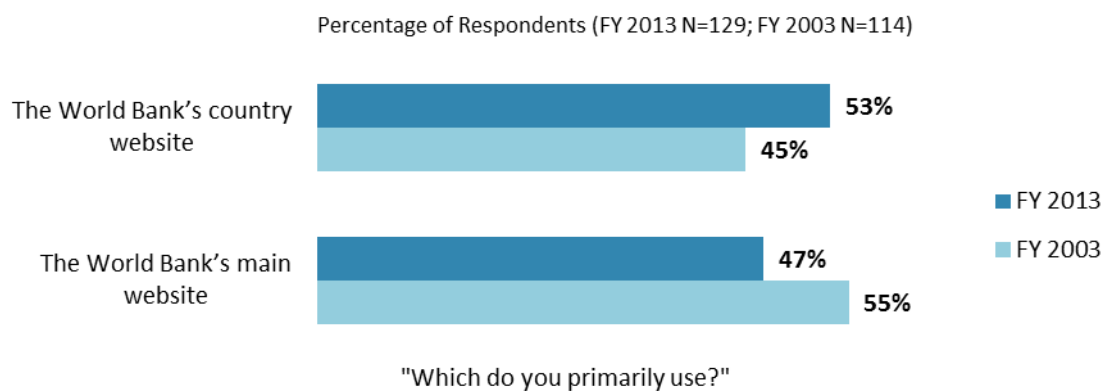
"Which Internet connection do you use primarily when visiting a World Bank website?"

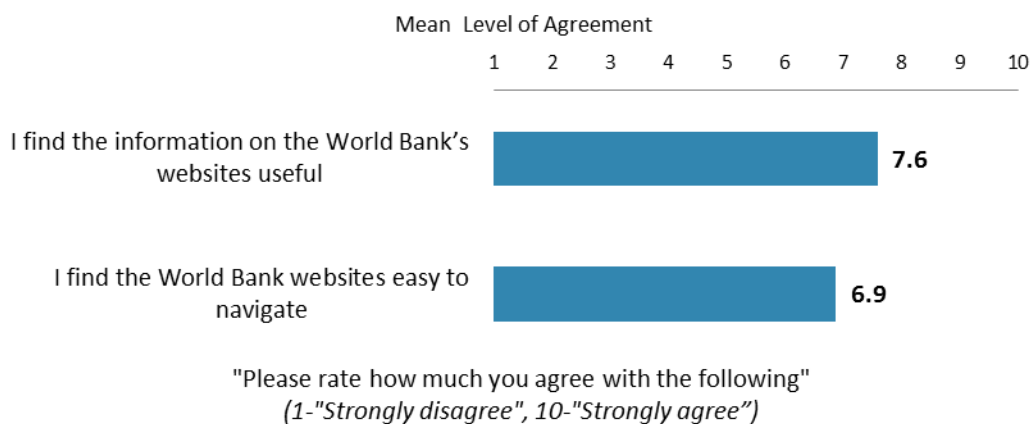

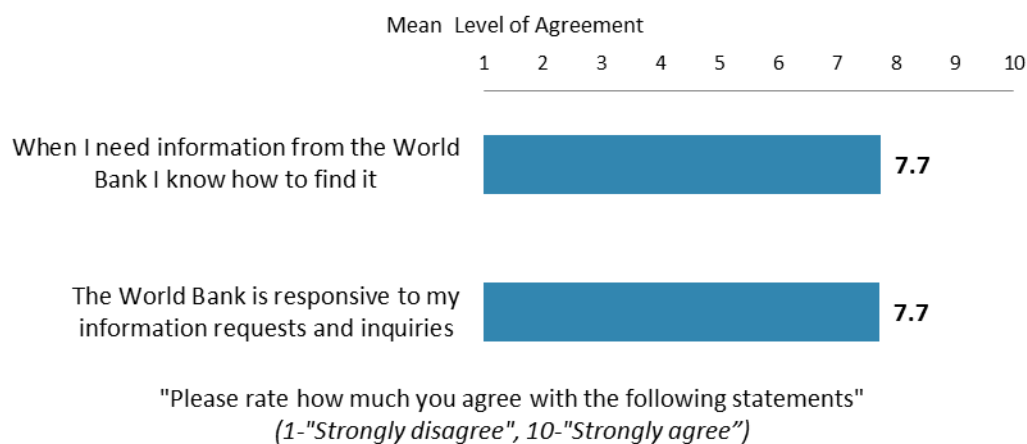
