I. Objectives

This survey was designed to achieve the following objectives:

- Assist the World Bank Group in gaining a better understanding of how stakeholders in Mexico perceive the Bank Group;
- Obtain systematic feedback from stakeholders in Mexico regarding:
 - Their views regarding the general environment in Mexico;
 - Their overall attitudes toward the World Bank Group in Mexico;
 - Overall impressions of the World Bank Group's effectiveness and results, knowledge and convening services, and communication and information sharing in Mexico;
 - Perceptions of the World Bank Group's future role in Mexico.
- Use data to help inform Mexico country team's strategy.

II. Methodology

In May-June 2014, 400 stakeholders of the World Bank Group in Mexico were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from the office of the President; the office of a Minister; office of a parliamentarian; ministries, ministerial departments, or implementation agencies; consultants/contractors working on WBG-supported projects/programs; project management units (PMUs) overseeing implementation of a project; local government officials; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs; community based organizations; the media; independent government institutions; trade unions; faith-based groups; academia/research institutes/think tanks; judiciary branch; and other organizations. A total of 191 stakeholders participated in the survey (48% response rate).

Respondents received a link to an online version of the questionnaire and completed the survey on the Qualtrics platform. Respondents were asked about: general issues facing Mexico; their overall attitudes toward the WBG; the WBG's effectiveness and results; the WBG's knowledge and convening services; working with the WBG; the WBG's future role in Mexico; the WBG's communication and information sharing in Mexico; and development organizations in the region.

Every country that engages in the Country Opinion Survey must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

When possible, responses from respondents completing this year's country survey were compared to responses from the 273 respondents (45% response rate) who completed the country survey in FY '08. Comparing responses across country surveys reflect changes in attitudes over time, but also changes in respondent samples and changes to the survey instrument itself. The differences in stakeholder identification in the FY'08 and FY'14 Country Surveys make weighting difficult. The unweighted mean/percentage comparisons are presented in Appendix D to show overall attitudinal changes from FY'08 to FY'14. Yet interpretation of these trends should be based on the understanding of the differences in the samples in the two years.

- A. General Issues Facing Mexico: Respondents were asked to indicate whether Mexico is headed in the right direction, what they thought were the top three most important development priorities in the country, which areas would contribute most to reducing poverty, and how "shared prosperity" would be best achieved.

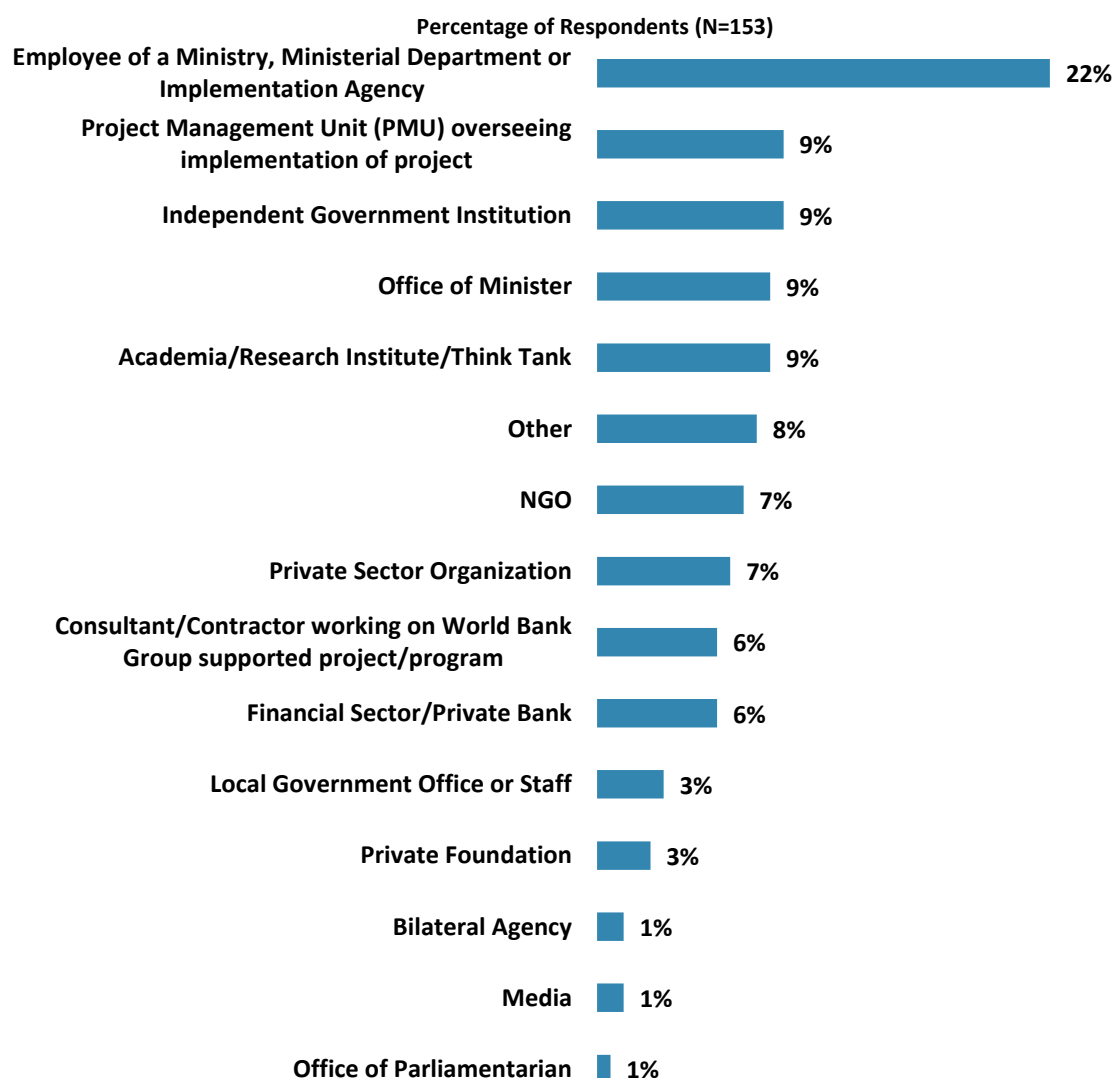
II. Methodology (continued)

- B. Overall Attitudes toward the World Bank Group (WBG): Respondents were asked to rate their familiarity with the WBG and the International Finance Corporation (IFC), the effectiveness the WBG in Mexico, how effectively different parts of the WBG collaborate, WBG staff preparedness, their agreement with various statements regarding the WBG's work, and the extent to which the WBG is an effective development partner. Respondents were asked to indicate the WBG's greatest weaknesses, in which sectoral areas the WBG should focus most of its resources, which groups the Bank Group should collaborate with more, and to what reasons respondents attributed failed or slow reform efforts.
- C. World Bank Group's Effectiveness and Results: Respondents were asked to rate the extent to which the WBG's work helps achieve development results in Mexico, the extent to which the World Bank and IFC meet Mexico's needs for financial instruments respectively, the extent to which the WBG meets Mexico's needs for knowledge and convening services, and the WBG's effectiveness in eleven development areas serving four thematic objectives in Mexico's 2014-2019 Development Strategy. Respondents were also asked to rate the extent to which Mexico received value for money from the WBG's reimbursable advisory services.
- D. The World Bank Group's knowledge and convening services: Respondents were asked to indicate how frequently they consult WBG's knowledge and convening services and to rate the effectiveness and quality of the WBG's knowledge and convening services, including how significant of a contribution it makes to development results and its technical quality. Respondents were also asked about the LAC Flagship Report (*Latin American Entrepreneurs: Many Firms but Little Innovation*), including if it raised substantive new information, and whether it provided them with useful information in terms of work they do.
- E. Working with the World Bank Group: Respondents were asked to rate their level of agreement with a series of statements regarding working with the WBG, such as the WBG's "Safeguard Policy" requirements being reasonable, and disbursing funds promptly.
- F. The Future Role of the World Bank Group in Mexico: Respondents were asked to indicate what the WBG should do to make itself of greater value in Mexico, and which services the Bank should offer more of in the country. They were asked whether WBG has moved to the right direction, how significant the roles of the WBG, IFC, and international development cooperation are in Mexico's development respectively in the near future.
- G. Communication and Information Sharing: Respondents were asked to indicate how they get information about economic and social development issues, how they prefer to receive information from the WBG, and their usage and evaluation of the WBG's websites. Respondents were also asked about their awareness of the WBG's Access to Information policy, were asked to rate WBG's responsiveness to information requests, value of its social media channels, and levels of easiness to find information they needed.
- H. Development Organization in the Region: Respondents were asked to rate their level of familiarity with the Inter-American Development Bank (IDB) and its effectiveness.
- I. Background Information: Respondents were asked to indicate their current position, specialization, whether they professionally collaborate with the WBG, their exposure to the WBG in Mexico, which WBG agencies they work with, whether IFC and the Bank work well together, and their geographic location.

Current Position

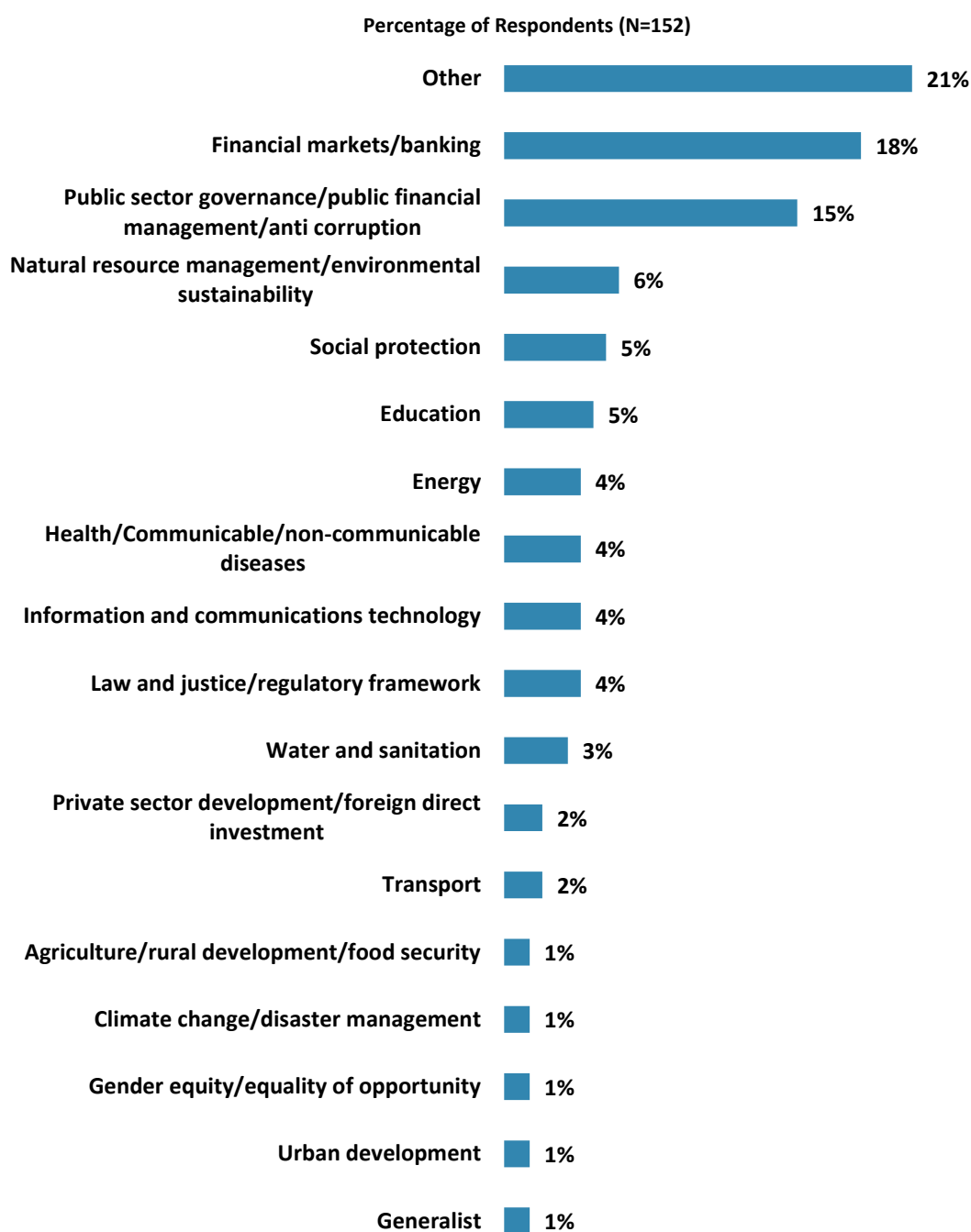
- For further analyses, respondents from consultants/contractors working on WBG projects were combined with those from PMUs; respondents from the financial sector/private banks were combined with those from private sector organizations; Respondents from private foundations and NGOs were combined into “CSO.” Few respondents from office of parliamentarian, bilateral agencies, the media, and other organizations were included in the “Other” category. There were no respondents from the Office of the President, multilateral agencies, CBOs, trade unions, faith-based groups, or the judiciary branch.

Area of Primary Specialization

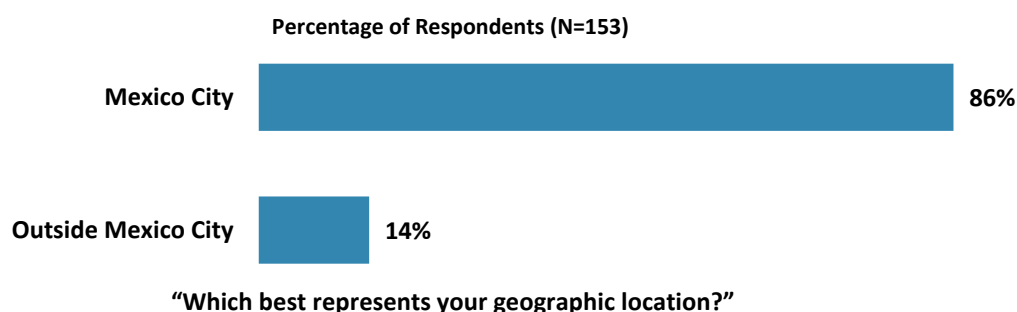

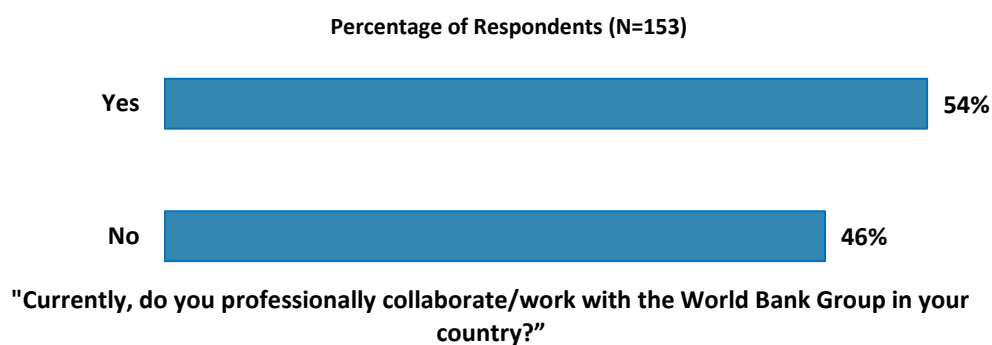

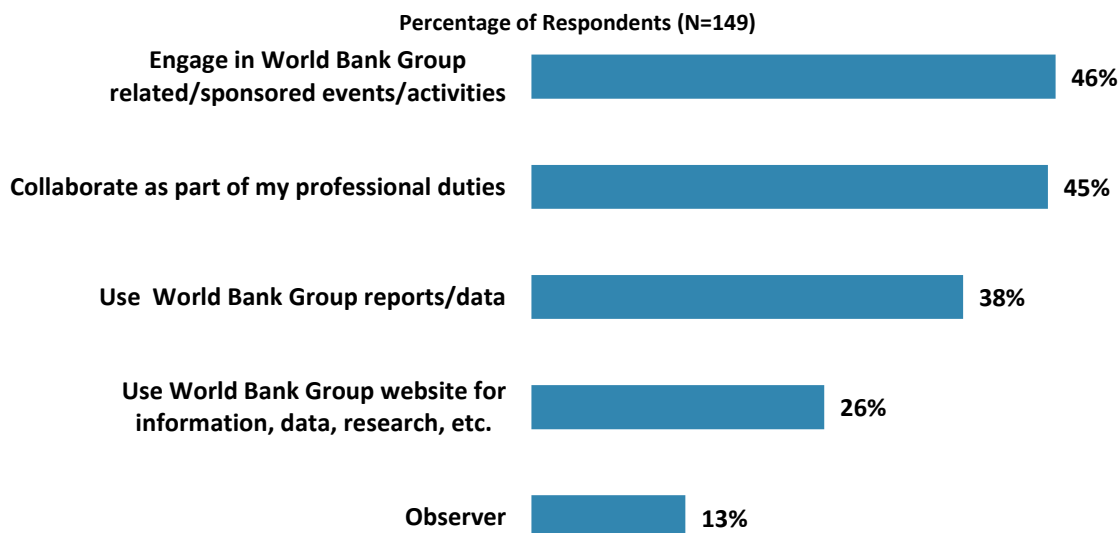
Collaboration with and Exposure to the World Bank Group

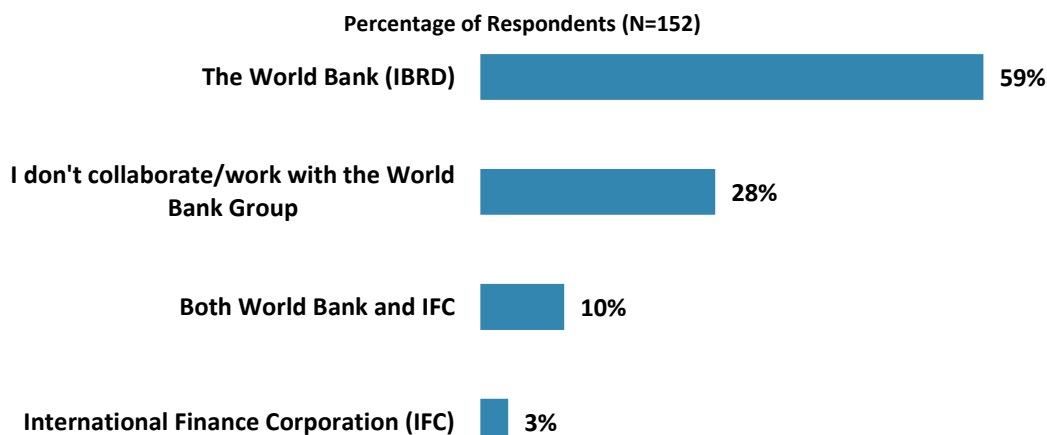

(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

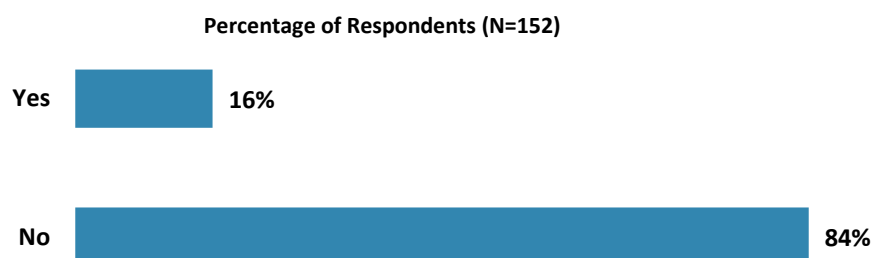

Exposure to the IFC

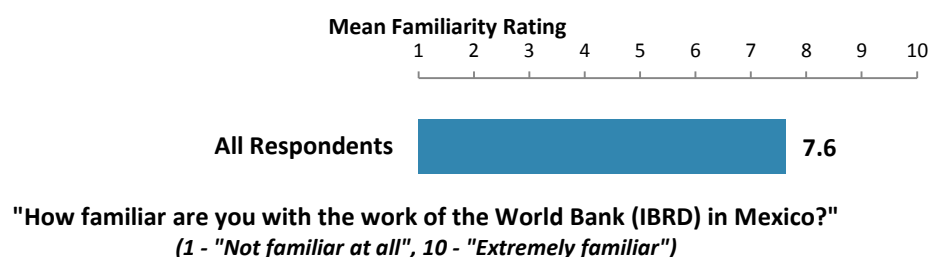


"Are you/have you been an IFC client?"

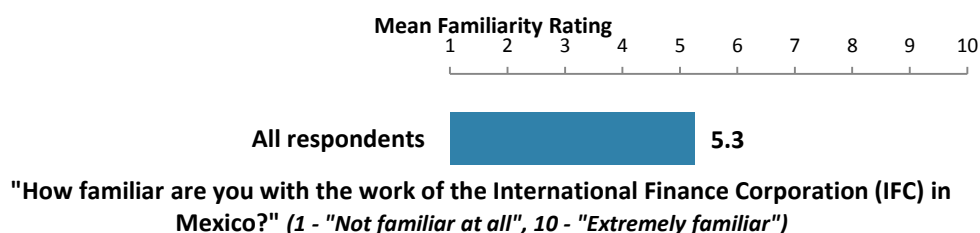
Familiarity with the World Bank

- Respondents from Office of Minister, PMUs and consultants/contractors working on WBG projects had the highest levels of familiarity with the World Bank, whereas respondents from academia/research institutes/think tanks had significantly lower levels of familiarity.
- Respondents from Mexico City had significantly higher levels of familiarity with the World Bank than those who are from outside Mexico City.
- Respondents' ratings of familiarity with the World Bank were significantly, strongly correlated with their perceptions of the WBG's overall effectiveness in Mexico, and the WBG's ability to help achieve development results in Mexico, significantly, moderately correlated with the perceptions of the WBG's relevance to Mexico's development.



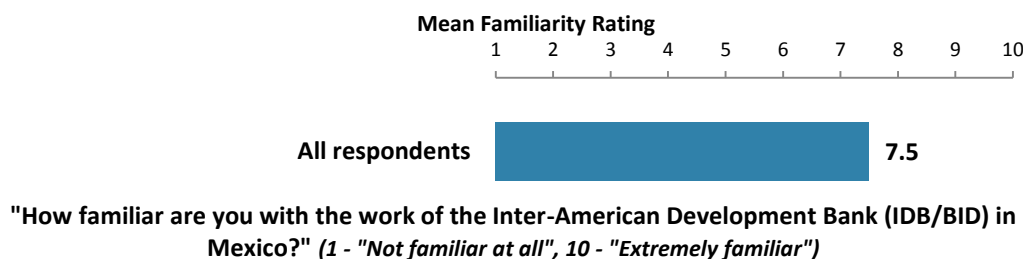
Familiarity with the IFC

Familiarity with the IDB

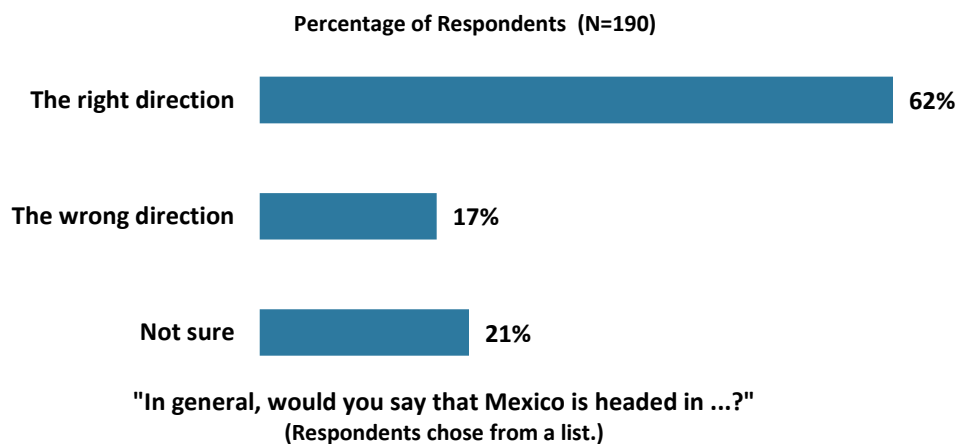
- Respondents had statistically similar levels of familiarity with the World Bank and IDB.

Headed in the Right Direction

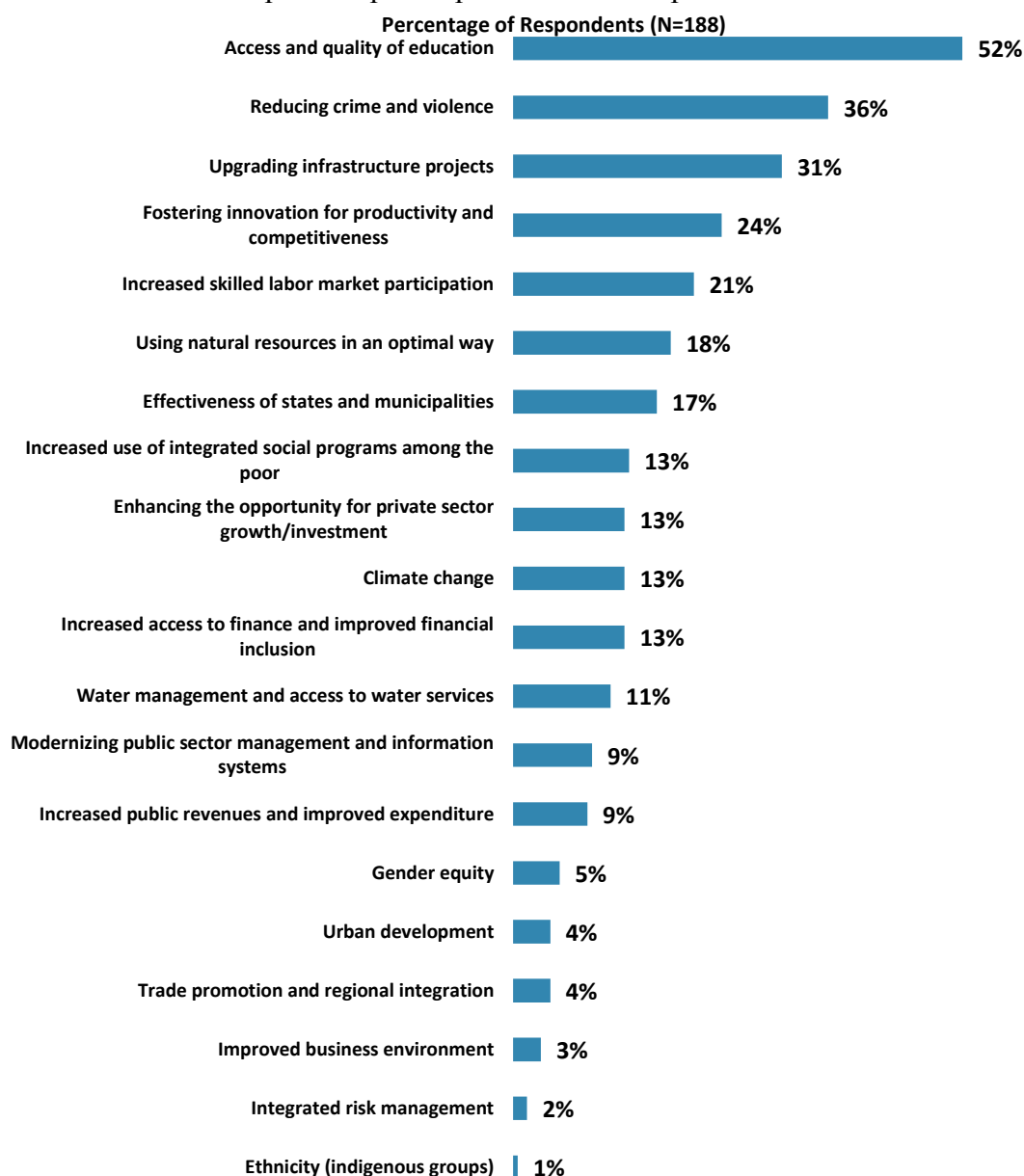
- Respondents who professionally collaborate/work with the WBG in Mexico were significantly more likely to indicate that Mexico is headed in the right direction.
- Among all stakeholders, respondents from academia/research institutes/think tanks were significantly more likely to indicate that Mexico is headed in the wrong direction than respondents from other stakeholder groups.



IV. General Issues Facing Mexico (continued)

Development Priority

- Respondents who identified their specialized areas as *financial markets/banking* (18% of the sample) were significantly more likely to indicate that “*increased access to finance and improved financial inclusion*” was one of the most important development priorities in Mexico, compared to respondents who work in other areas.
- Respondents who do not professionally collaborate with the WBG were significantly more likely to view “*access and quality of education*” and “*reducing crime and violence*” as top development priorities than respondents who work with the WBG.



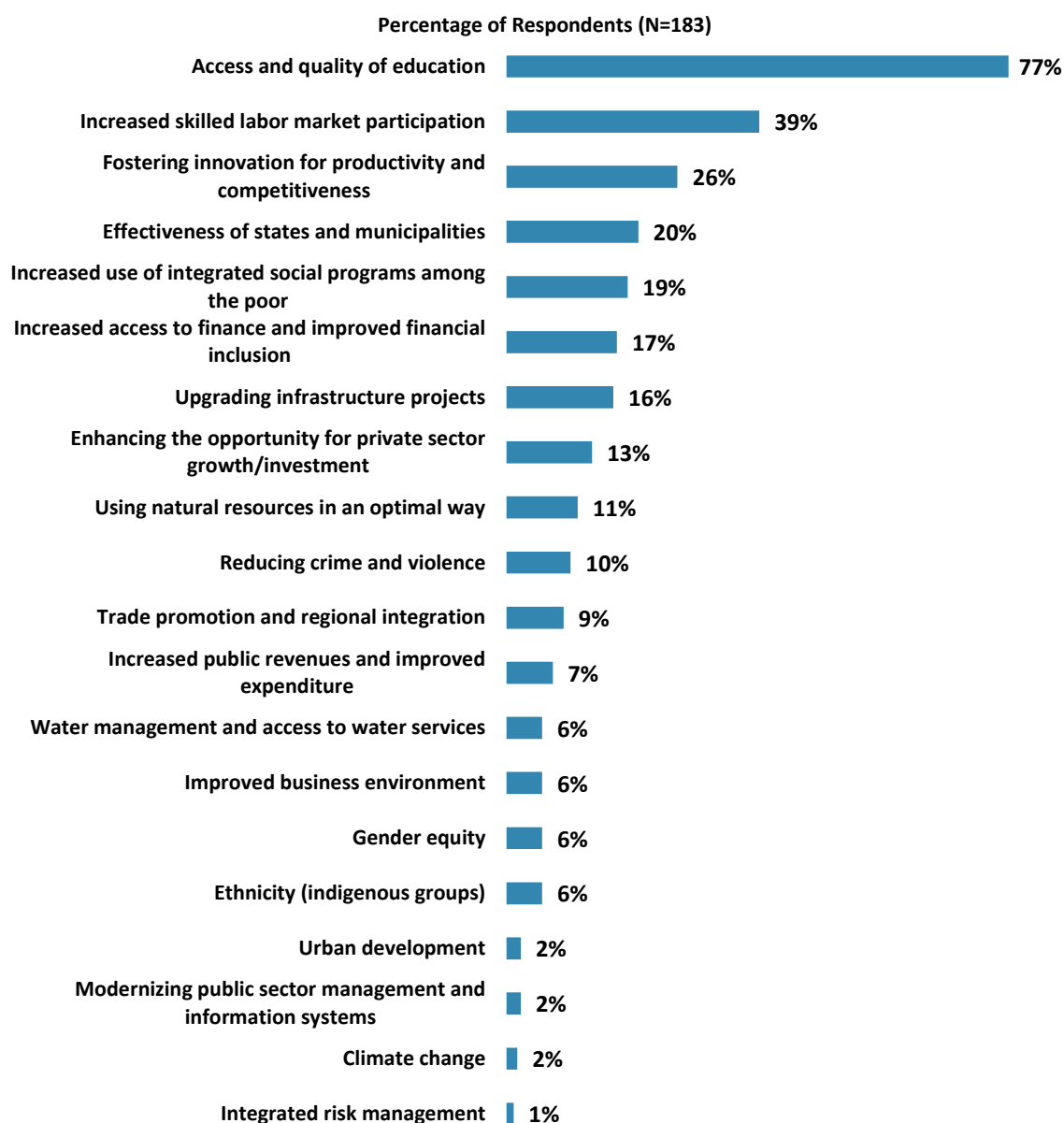

What Would Contribute Most to Reducing Poverty

- Respondents whose primary specialization of work is *financial markets/banking* (18% of the sample) were significantly more likely to indicate that “*increased access to finance and improved financial inclusion*” would contribute most to reducing poverty in Mexico, compared to respondents in other areas of work.



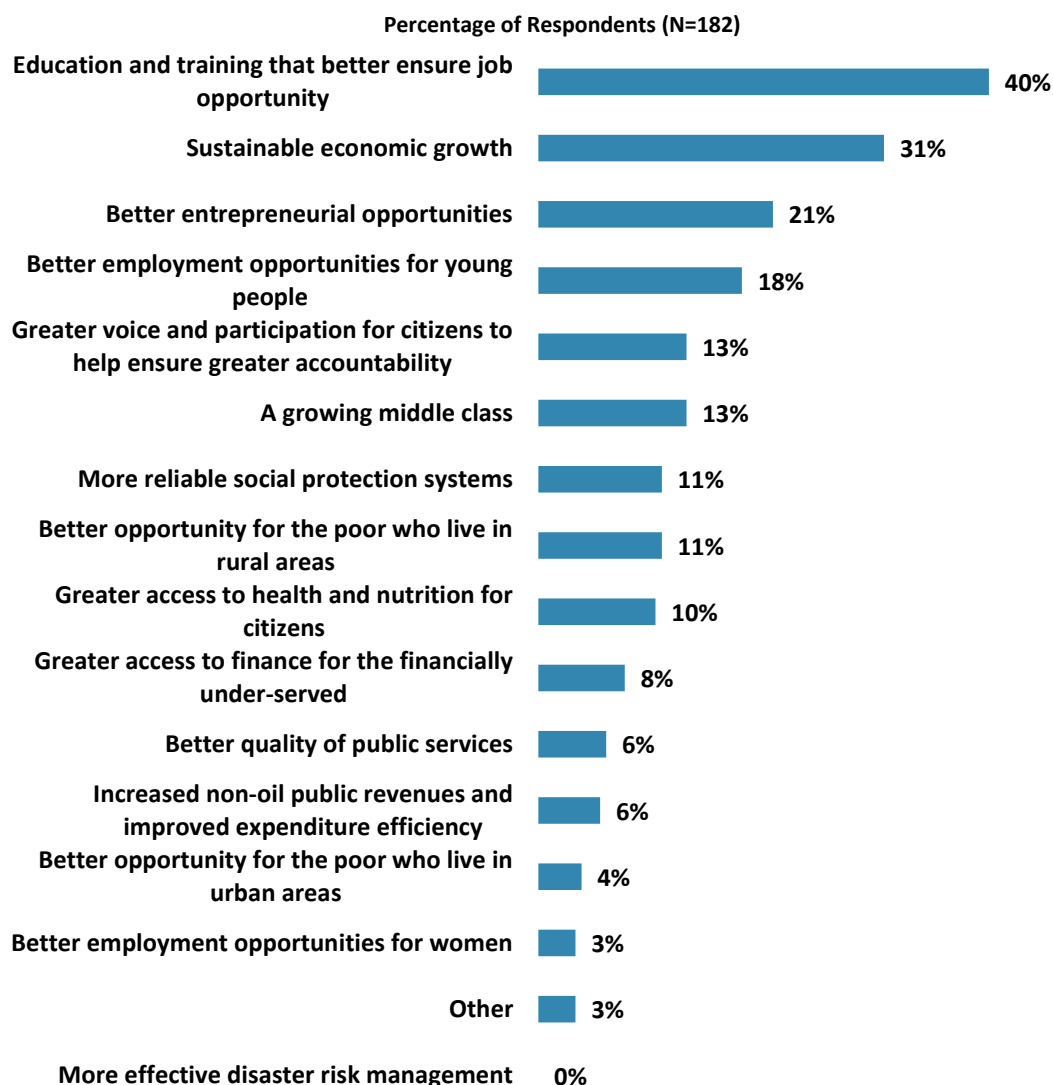

Factors Contributing to “Shared Prosperity”

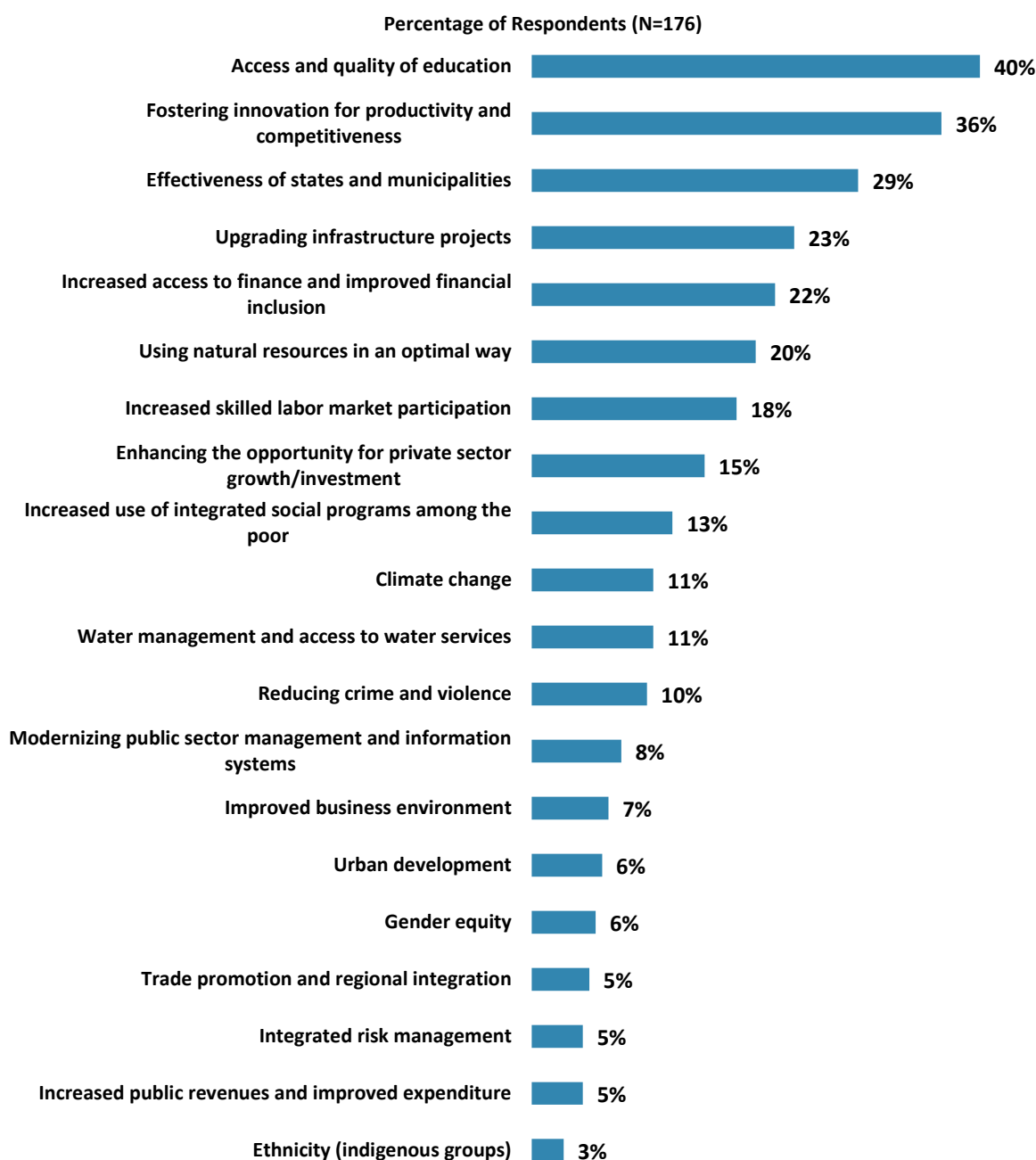
- While “*education and training that better ensure job opportunity*” and “*sustainable economic growth*” are perceived as topic contributors to achieving Shared Prosperity by all stakeholder groups, respondents from CSOs were significantly more likely than other stakeholder groups to indicate that “*greater voice and participation for citizens to help ensure greater accountability*” best illustrates how Shared Prosperity would be achieved in Mexico.

Where the World Bank Group Should Focus its Resources (continued)

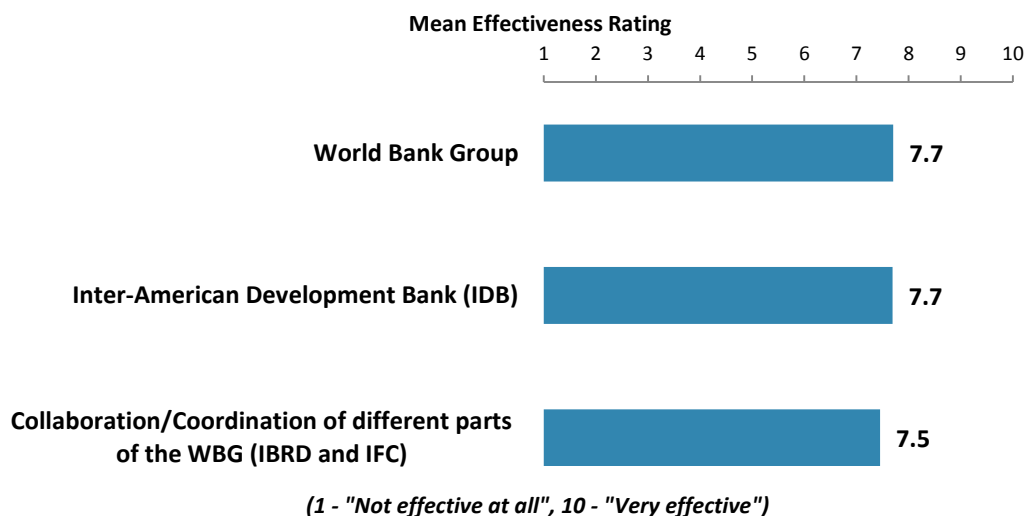
- “*Access and quality of education*” emerges as not only the top development priority in Mexico, but also the area where the WBG should focus most of its resources.
- Respondents whose primary specialization of work is *financial markets/banking* (18% of the sample) were significantly more likely to indicate that the WBG should focus its attention and resources on “*enhancing the opportunity for private sector growth/investment*,” compared to respondents in other areas of work.

V. Overall Attitudes toward the World Bank Group (continued)

As noted in the “Methodology” section, the indicator questions referred to throughout the survey report are questions that are asked in every country that engages in the Country Opinion Survey. These will be aggregated for the World Bank Group’s annual Corporate Scorecard.

Overall Effectiveness of the World Bank Group (*Indicator Question*), Collaboration between Different parts of the WBG (IBRD and IFC), and IDB

- Respondents across stakeholder groups gave statistically similar ratings for the WBG’s overall effectiveness in Mexico.
- Respondents from Mexico City gave significantly higher ratings for the WBG’s overall effectiveness in Mexico than respondents from outside Mexico City.
- Respondents who professionally collaborate/work with the World Bank had significantly higher ratings for the Bank’s effectiveness compared to respondents who do not professionally collaborate/work with the Bank.
- Respondents across stakeholder groups and geographic locations gave statistically similar ratings for the effectiveness of the different parts of the WBG working together.



V. Overall Attitudes toward the World Bank Group (continued)

Effectiveness of the WBG Activities

- Respondents across stakeholder groups had statistically similar ratings for the effectiveness of the following WBG activities in supporting Mexico's efforts to achieve development results.
- There were significant differences in the responses across geographic locations. Respondents from Mexico City gave significantly higher ratings for the WBG's effectiveness in "*data*," "*policy advice, studies, analyses*," "*financial resources*," "*technical assistance*," and "*working in partnerships with others to improve impact*," compared to respondents from outside Mexico City.

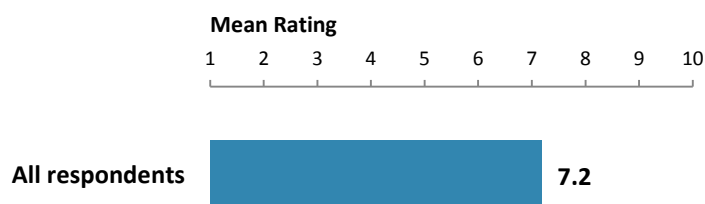


"How effective do the World Bank Group's activities below support Mexico's efforts to achieve development results?"

Achieving Development Results (*Indicator Question*)

- Respondents from PMUs and consultants/contractors working on WBG projects had the highest ratings for the WBG helping achieve development results in Mexico, whereas respondents from CSOs and academia/research institutes/think tanks had significantly *lower* ratings.
- Respondents across geographic locations had statistically similar ratings for the World Bank Group helping achieve development results in Mexico.
- Respondents who professionally collaborate/work with the World Bank Group had significantly *higher* ratings for the WBG helping achieve development results in Mexico, compared to respondents who do not professionally collaborate/work with the WBG.



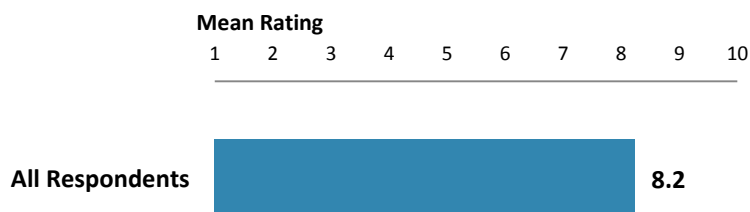
"To what extent does the World Bank Group's work help to achieve development results in Mexico?"

Staff Preparedness (*Indicator Question*)

- Respondents across geographic locations gave statistically similar ratings for the extent to which the WBG's staff is well prepared to help Mexico solve its most complicated development challenges.
- Respondents from Office of Minister and the private sector/financial sector/private banks had the highest ratings for the extent to which the WBG's staff is well prepared to help Mexico solve its most complicated development challenges, whereas respondents from independent government institutions had significantly lower ratings.
- Respondents who do and do not professionally collaborate/work with WBG had statistically similar ratings for the extent to which the WBG's staff is well prepared to help Mexico solve its most complicated development challenges.

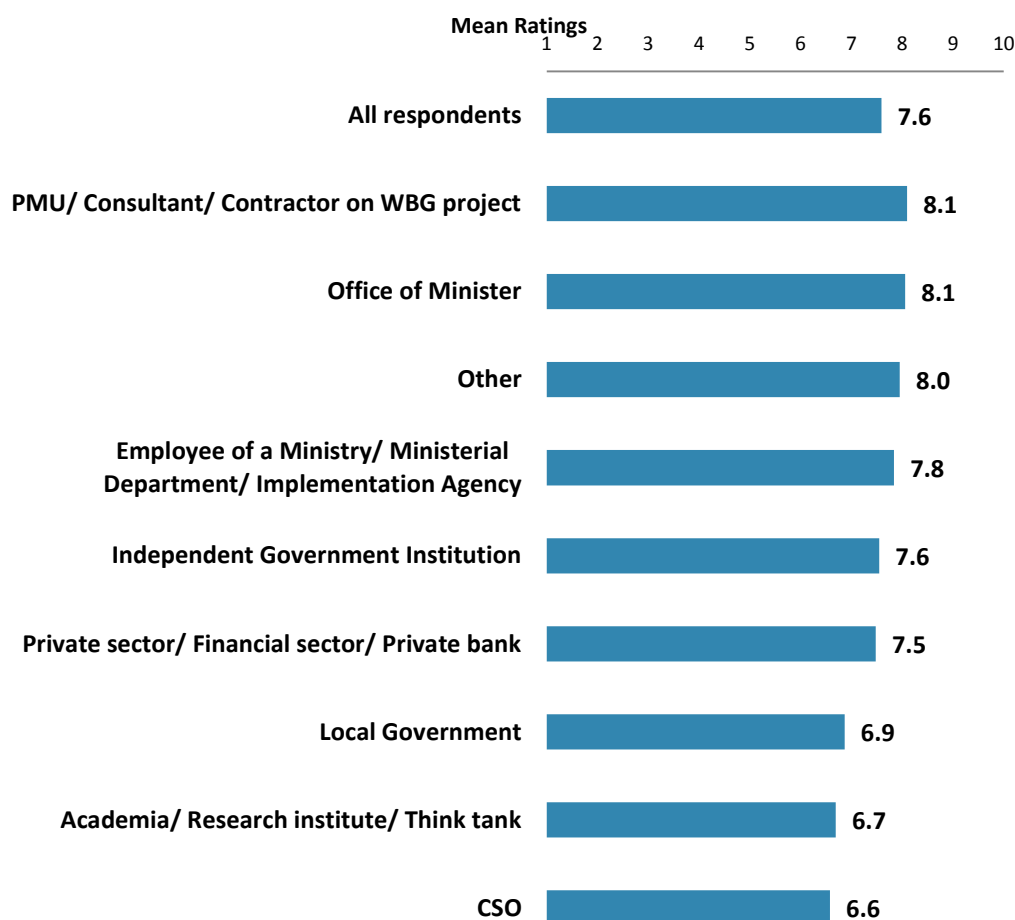


"To what extent do you believe the World Bank Group's staff is well prepared (e.g., skills and knowledge) to help Mexico solve its most complicated development challenges?"

Overall Ratings for Indicator Questions by Stakeholder Groups*

- There were significant stakeholder group differences in their overall responses to twenty four indicator questions. Respondents from Office of Minister, PMUs, and consultants/contractors working on WBG projects gave the highest ratings for those questions, whereas respondents from CSOs and academia/research institutes/think tanks gave significantly lower ratings. Respondents' overall ratings for the indicator questions are significantly correlated with the level of familiarity they are with the World Bank's work in Mexico ($p < .01$).
- Respondents who professionally collaborate/work with the WBG tended to give significantly higher ratings (7.9) for twenty four indicator questions than respondents who do not professionally collaborate/work with the WBG (7.2)

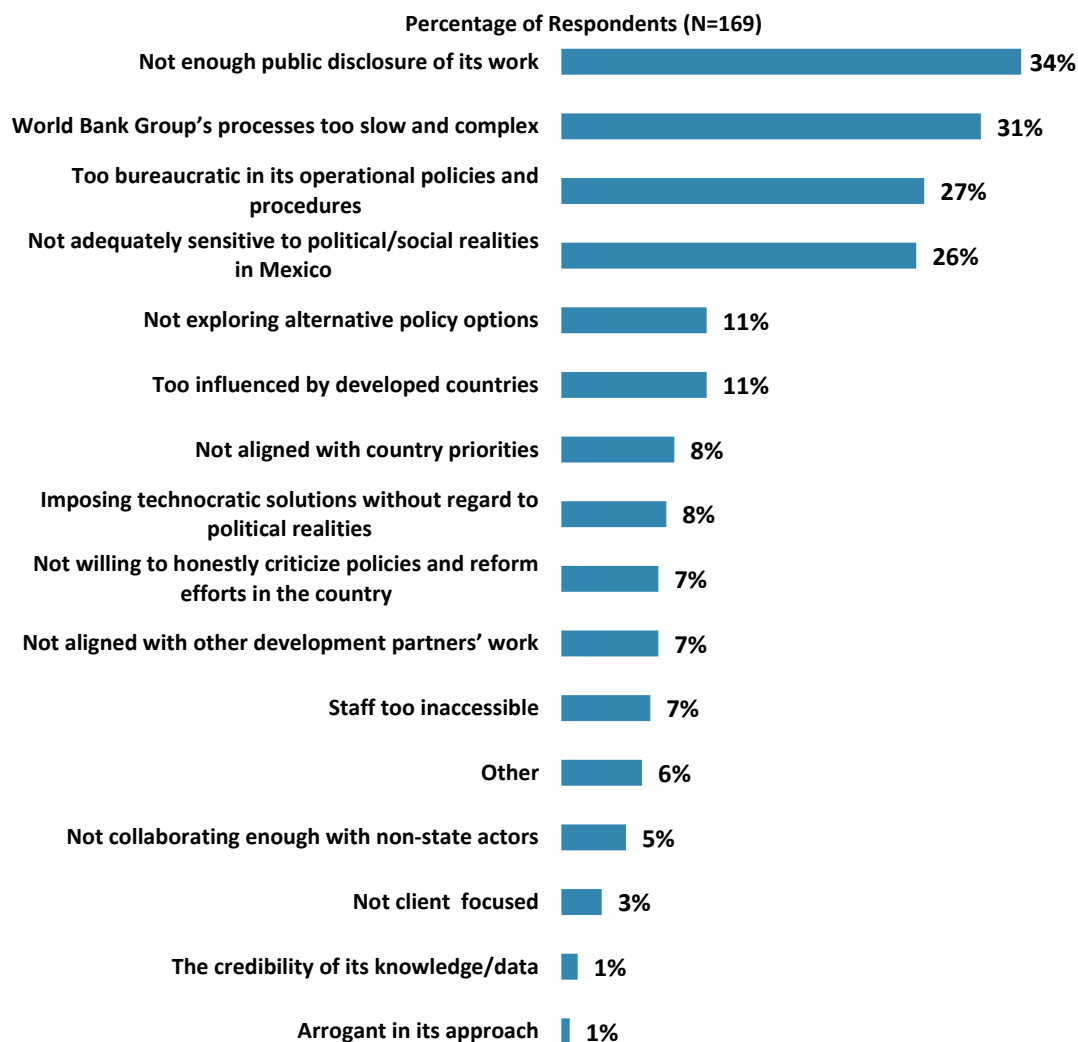
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

Greatest Weakness

- In this year's Country Survey, "*not enough public disclosure of its work*" and "*the WBG's processes being too slow and complex*" are perceived as the greatest weaknesses of the institution by respondents across stakeholder groups and geographic locations.
- Respondents who professionally collaborate/work with the WBG were significantly more likely to consider "*the WBG's processes being too slow and complex*" as the WBG's greatest weakness than respondents who do not professionally collaborate/work with the WBG.

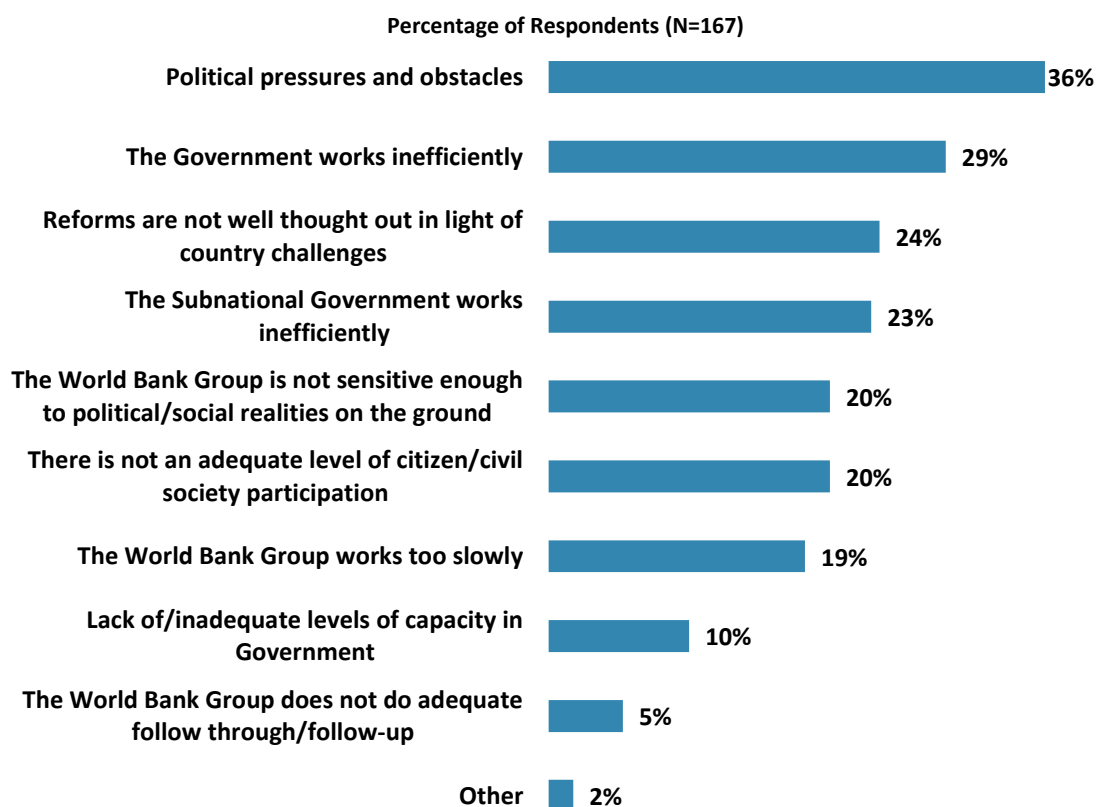


"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Mexico? (Choose no more than TWO)"

Attributing Slow or Failed Reform Efforts

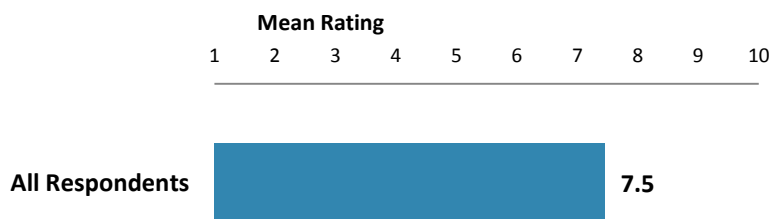
- Overall, “*political pressures and obstacles*” and “*government working inefficiently*” are perceived as the greatest causes, when the WBG assisted reform efforts fail or are slow to take place.
- While overall more than a quarter of respondents consider “*government working inefficiently*” as the second greatest cause of failed/slow reforms, respondents from the private sector/financial sector/private banks and academia/research institutes/think tanks were significantly more likely to think so than respondents from other stakeholder groups. In the meantime, respondents who do not professionally collaborate/work with the WBG are significantly more likely to indicate so compared to respondents who do professionally collaborate/work with the WBG.

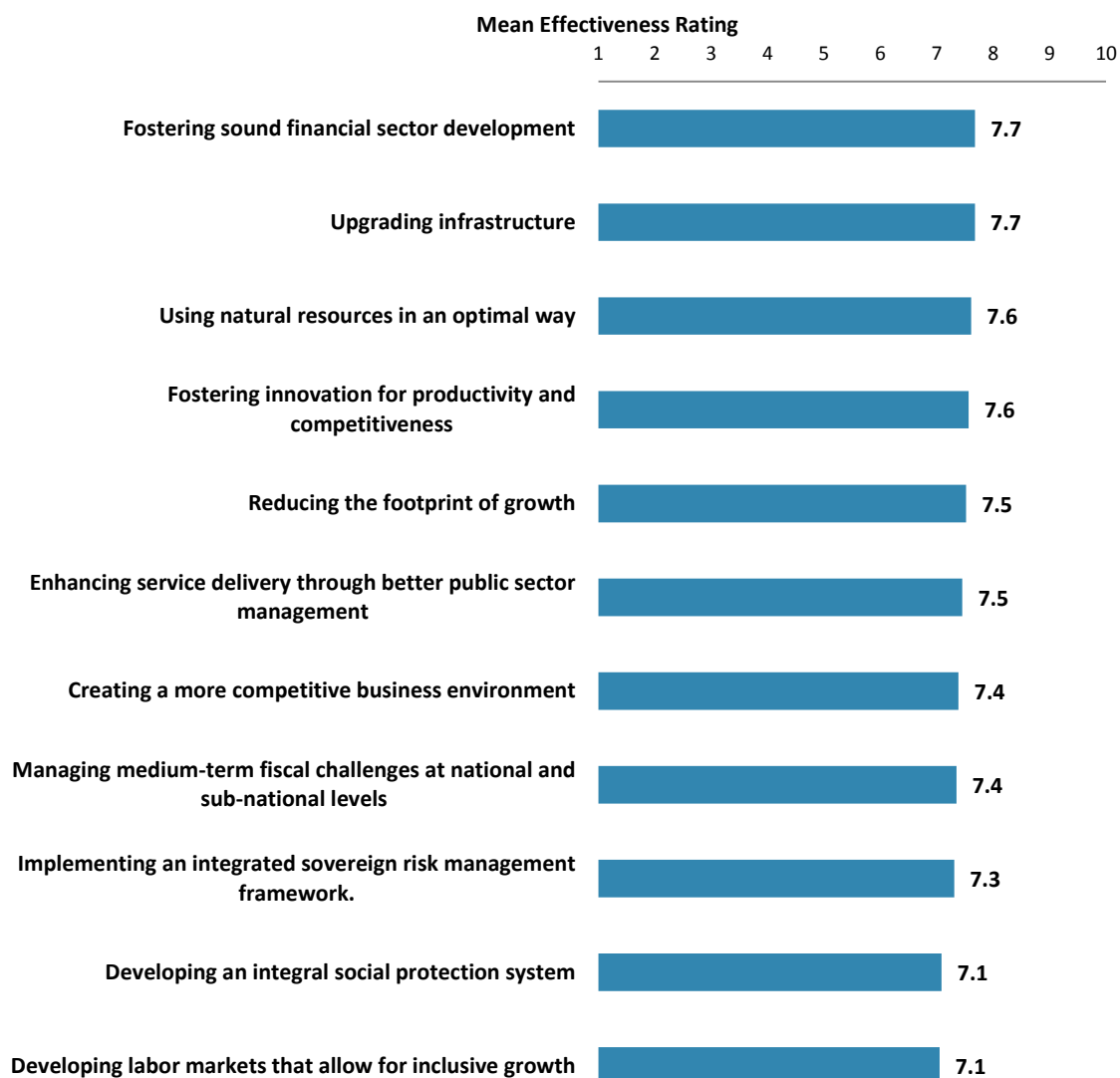
World Bank Group Moving in the Right Direction

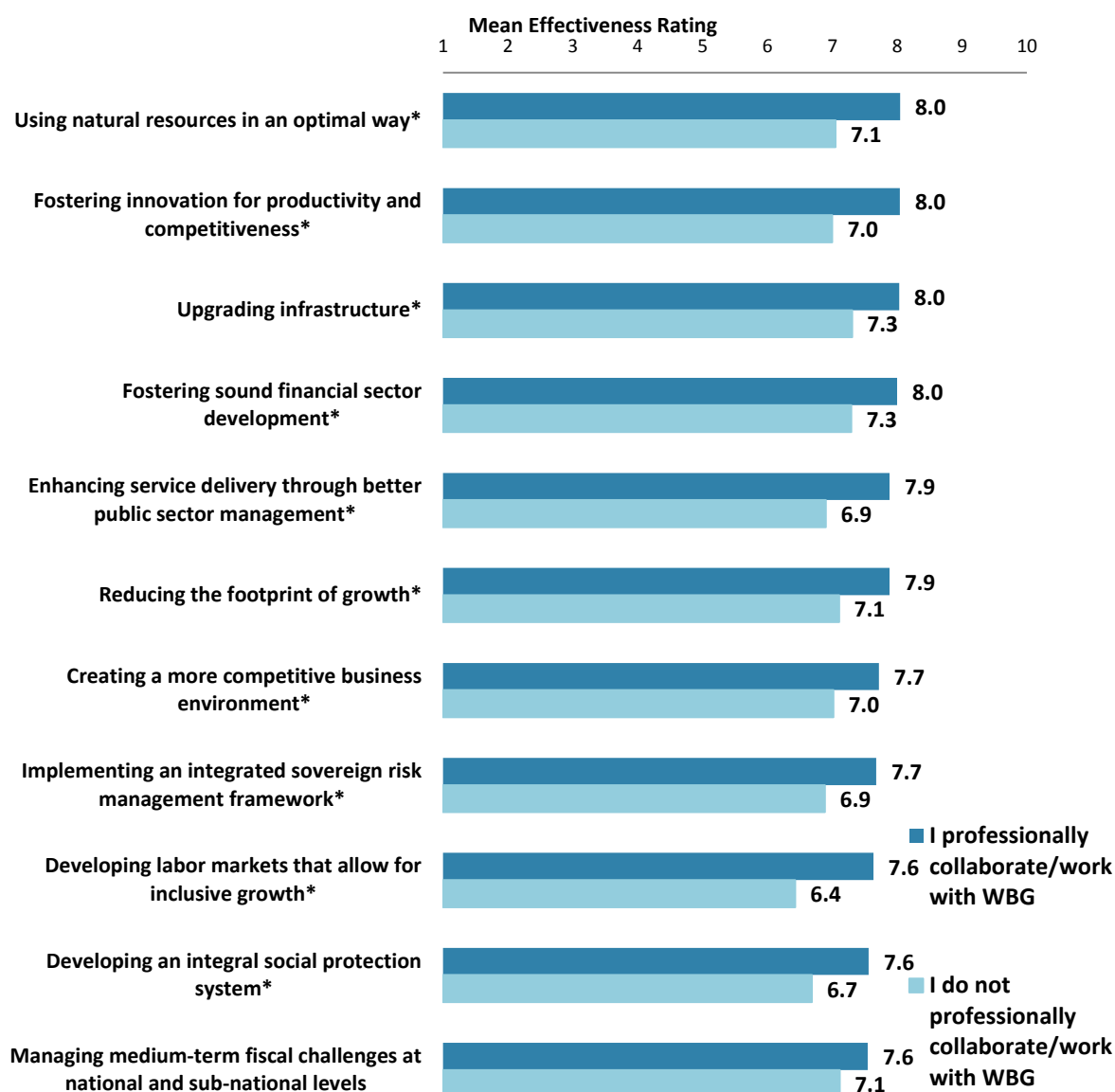
Effectiveness of Sectoral Areas (continued)

- There were significant stakeholder differences in their ratings for the WBG's effectiveness in nine of the eleven areas of engagement in Mexico (except "*creating a more competitive business environment*" and "*implementing an integrated sovereign risk management framework*." For the most part, respondents from Office of Minister, PMUs and consultants/contractors working on WBG projects had the highest ratings for the WBG's effectiveness, whereas respondents from CSOs and academia/research institutes/think tanks had significantly lower ratings. (For detailed information, please see Appendix A)
- Respondents whose primary specialization of work is in "*financial markets/banking*" (18%) and those who specialize in "*public sector governance/public financial management/anti-corruption*" (15% of the sample) gave significantly higher ratings for the WBG's effectiveness in the following areas compared to other respondents.
 - *Fostering sound financial sector development;*
 - *Fostering innovation for productivity and competitiveness;*
 - *Managing medium-term fiscal challenges at national and sub-national levels;*
 - *Enhancing service delivery through better public sector management;*
 - *Implementing an integrated sovereign risk management framework; and*
 - *Reducing the footprint of growth.*
- Note in the Appendix on the sectoral effectiveness (Appendix A, page 54) that primarily informed stakeholders responded to this question. Those who had no exposure to the WBG's work were given the option "Don't Know."
- Respondents across geographic locations had statistically similar ratings for the WBG's effectiveness in all of the areas of engagement except "*reducing the footprint of growth*." Respondents from Mexico City had significantly higher ratings for the WBG's effectiveness in "*reducing the footprint of growth*" than respondents from outside Mexico City.

Effectiveness of Sectoral Areas (continued)

- Respondents who professionally collaborate/work with the WBG gave significantly higher ratings for the WBG's effectiveness in almost all following areas compared to respondents who do not professionally collaborate/work with the WBG.

Drivers of Effectiveness

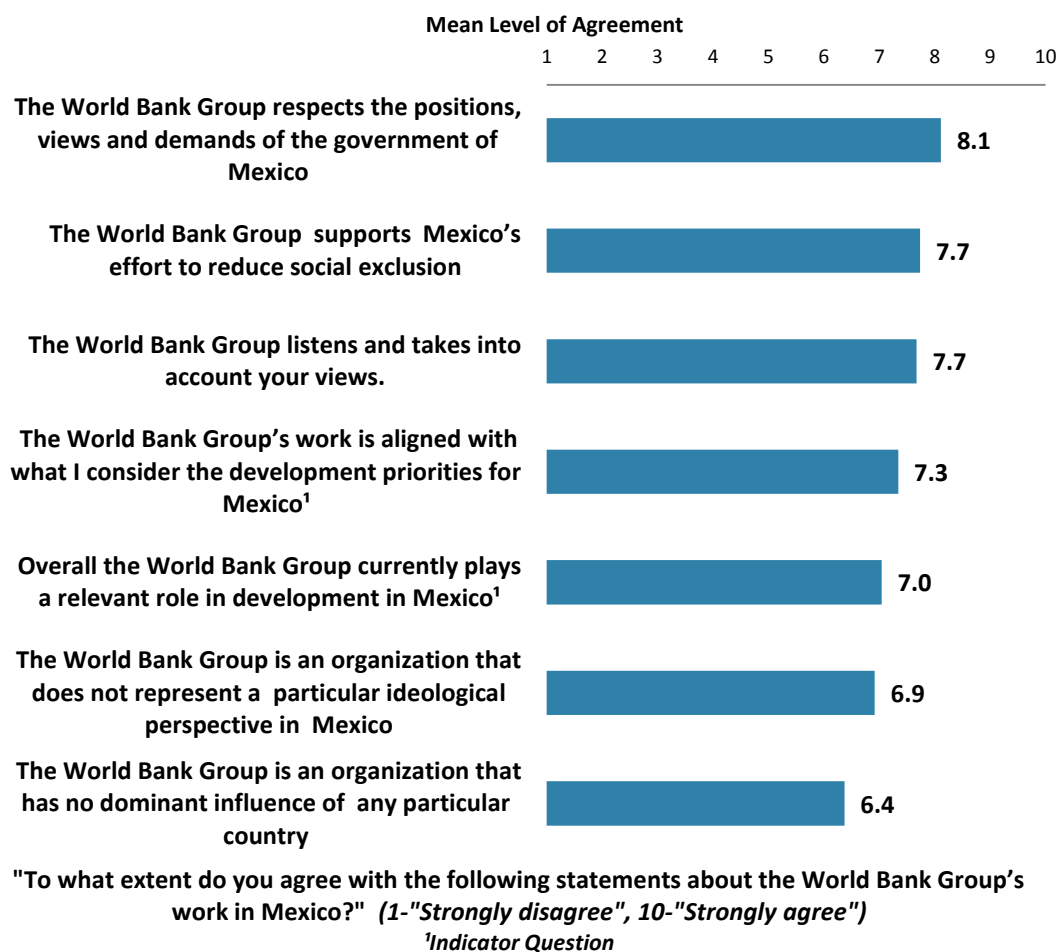
To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Mexico, bivariate correlational analyses were conducted using respondents' ratings of the eleven specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the Bank's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the Bank Group's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the Bank's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Mexico. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at enhancing service delivery through better public sector management;
 - The WBG's effectiveness at urban development;
 - The WBG's effectiveness at developing labor markets that allow for inclusive growth;
 - The WBG's effectiveness at fostering innovation for productivity and competitiveness;
 - The WBG's effectiveness at creating a more competitive business environment
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Mexico, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at developing labor markets that allow for inclusive growth;
 - The WBG's effectiveness at fostering innovation for productivity and competitiveness;
 - The WBG's effectiveness at enhancing service delivery through better public sector management;
 - The WBG's effectiveness at using natural resources in an optimal way

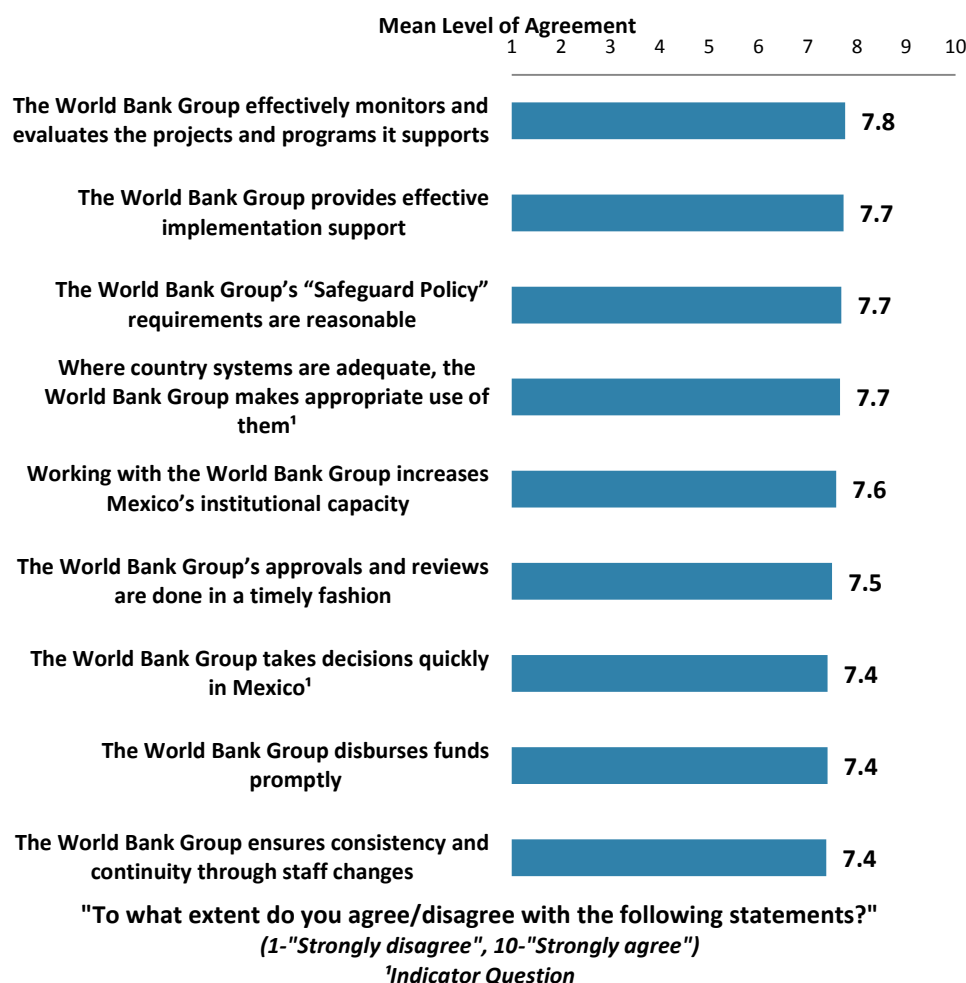
The World Bank Group's Work in Mexico (continued)

- There were significant stakeholder group differences in their levels of agreement with all of the statements above about the WBG. For the most part, respondents from PMUs and consultants/contractors working on WBG projects had the highest levels of agreement, whereas respondents from CSOs and academia/research institutes/think tanks had significantly lower ratings.
- There were significant differences between respondents in and outside Mexico City in their levels of agreement with that “*the WBG’s work is aligned with what I consider the development priorities for Mexico*,” “*the World Bank Group is an organization that does not represent a particular ideological perspective in Mexico*” and “*the World Bank Group supports Mexico’s effort to reduce social exclusion*.” Respondents from Mexico City had significantly higher levels of agreement with these statements than respondents from outside Mexico City.
- Respondents who professionally collaborate/work with WBG tended to have significantly higher levels of agreement with the all of statements above except that “*the World Bank Group is an organization that does not represent a particular ideological perspective in Mexico*” compared to respondents who do not professionally collaborate/work with the WBG.

"To what extent do you agree/disagree with the following statements?"

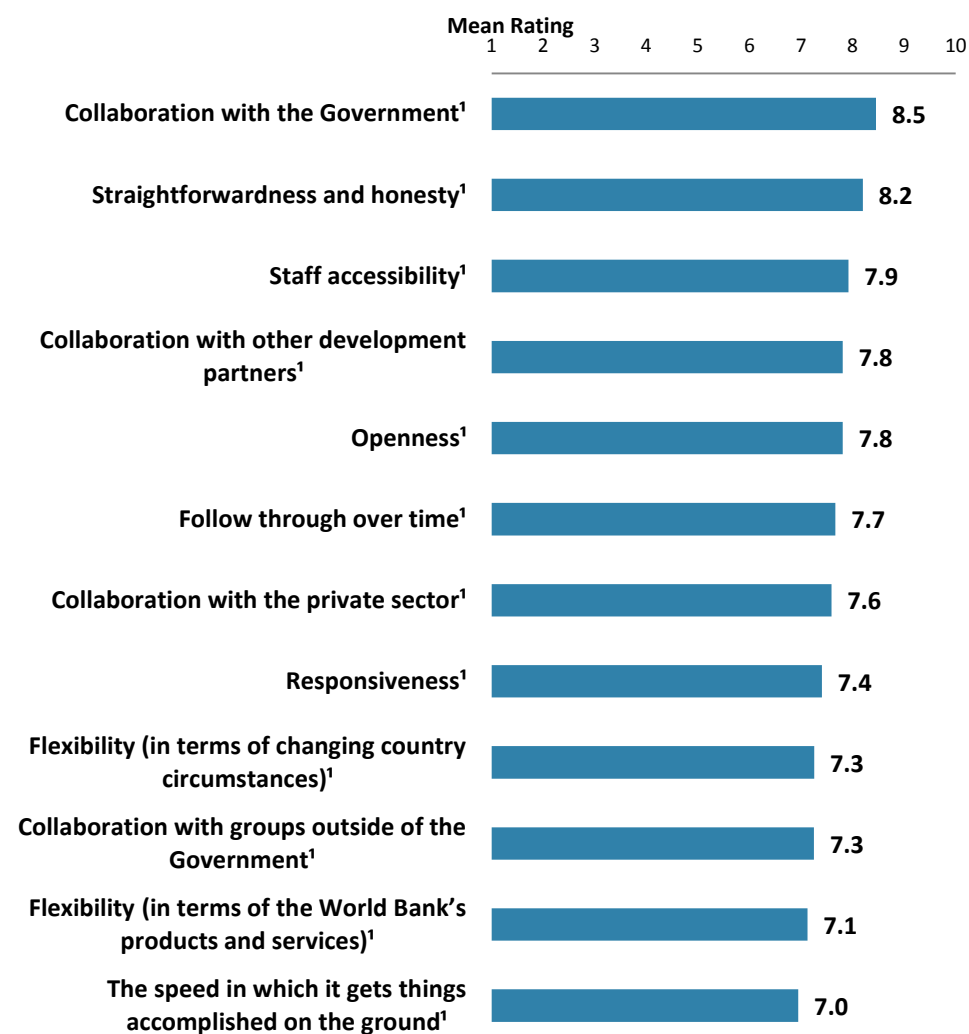

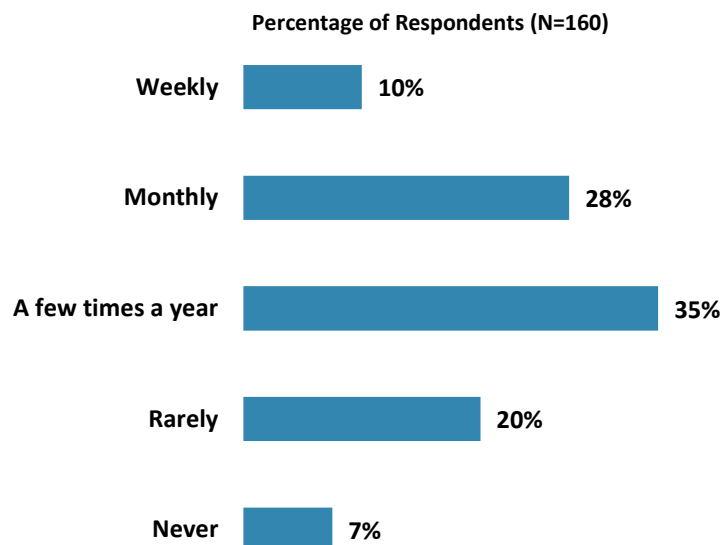

Frequency of Consulting World Bank Group's Knowledge and Convening Services

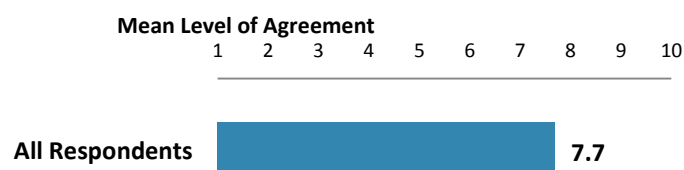


"How frequently do you interact with the World Bank Group on knowledge and convening services in the work you do?" (Respondents chose from a list.)

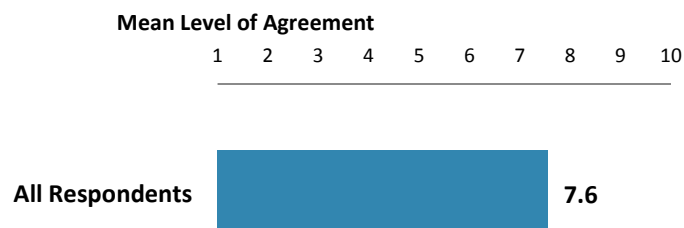

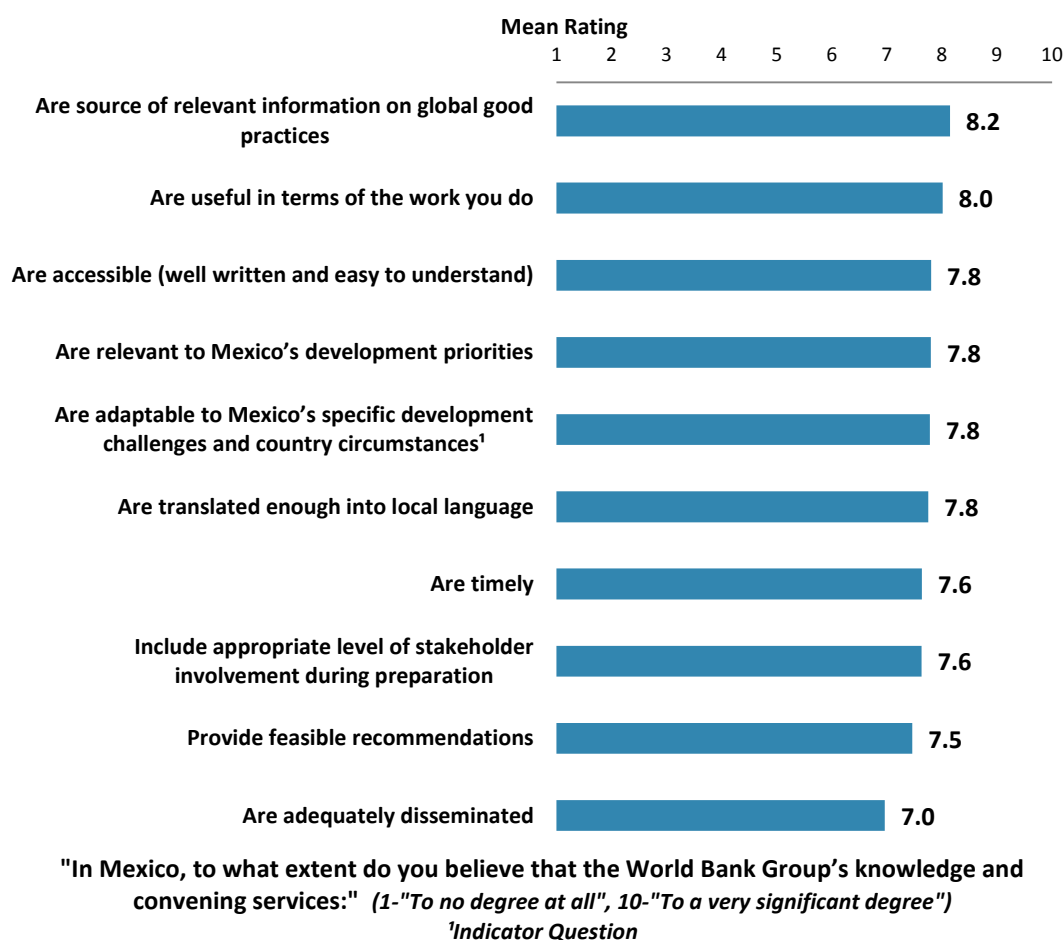


"The World Bank Group's convening services meet the needs of Mexico."

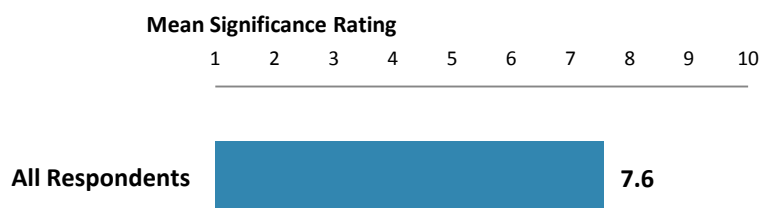

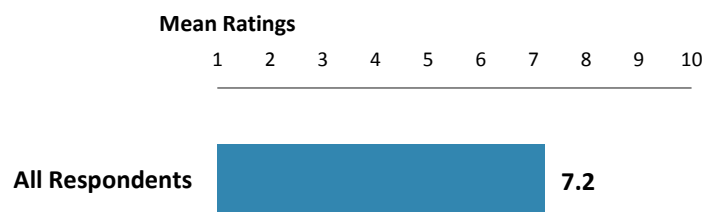

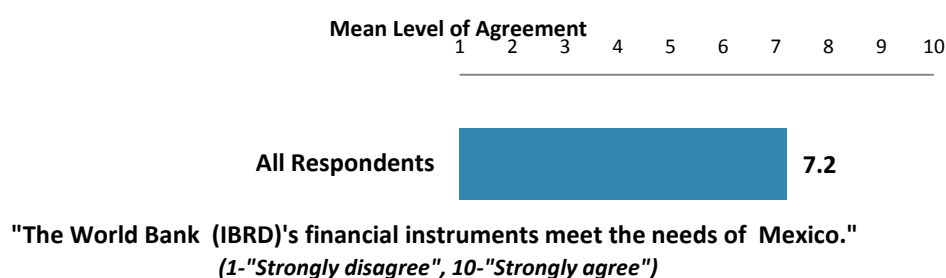

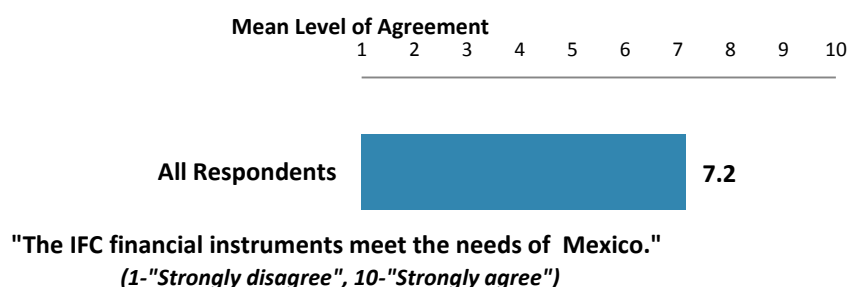

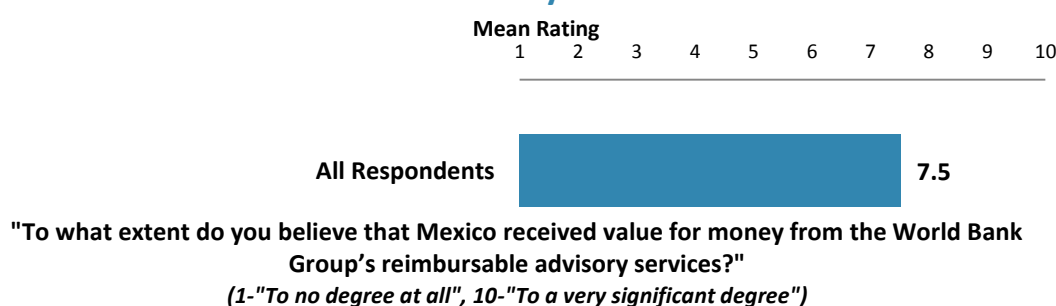


The IFC Meeting Mexico's Needs

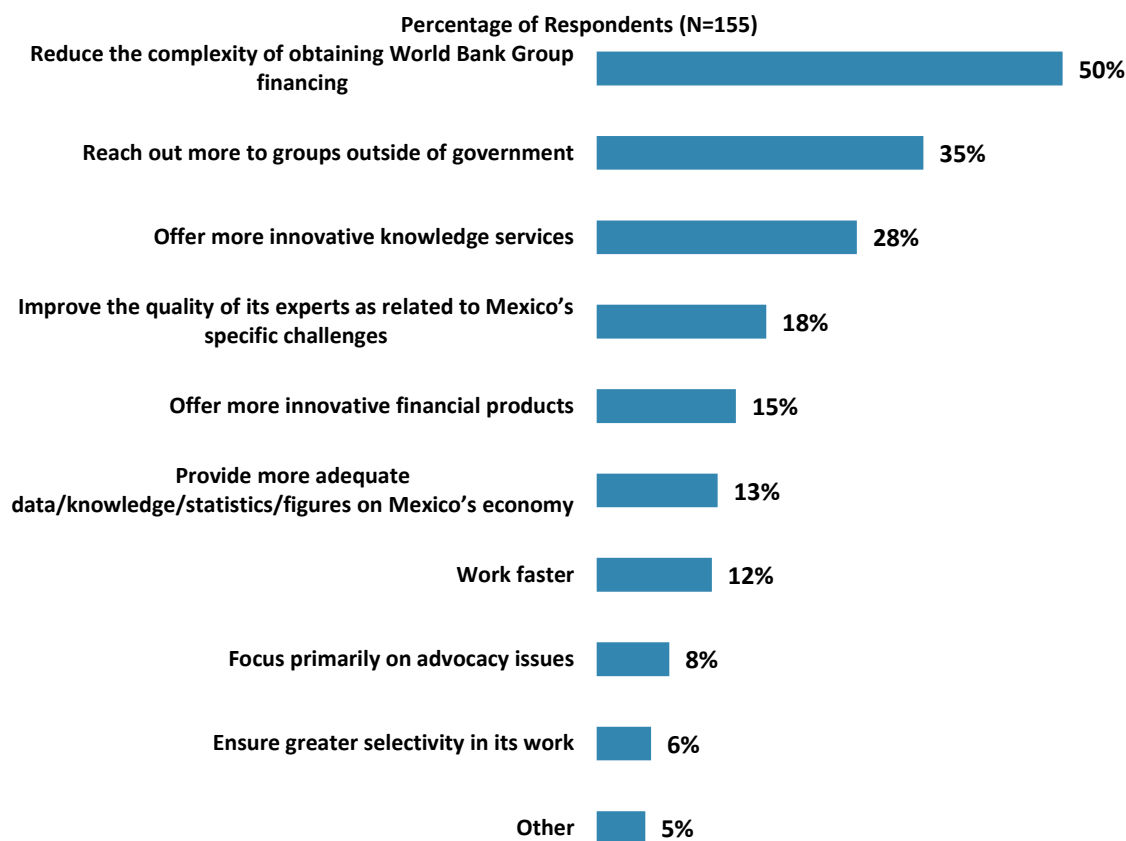
Value of the WBG's Reimbursable Advisory Services

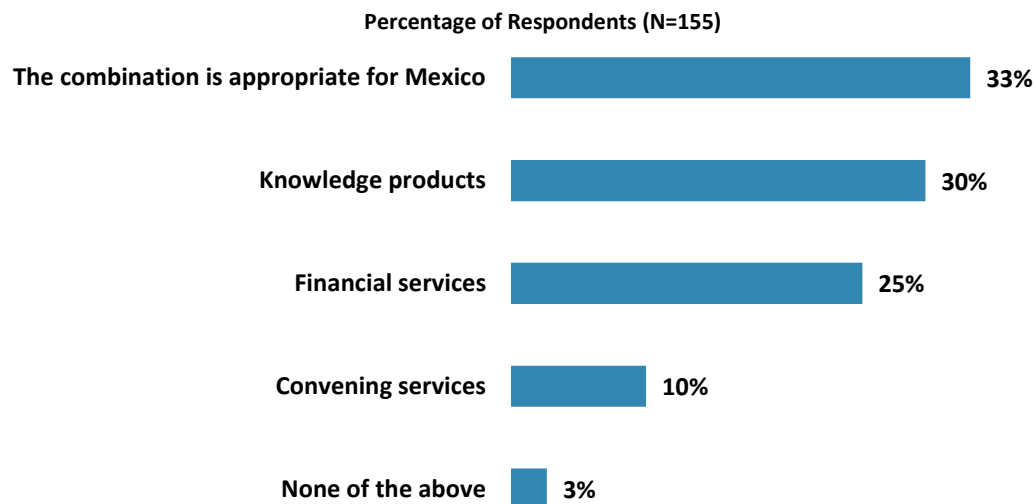

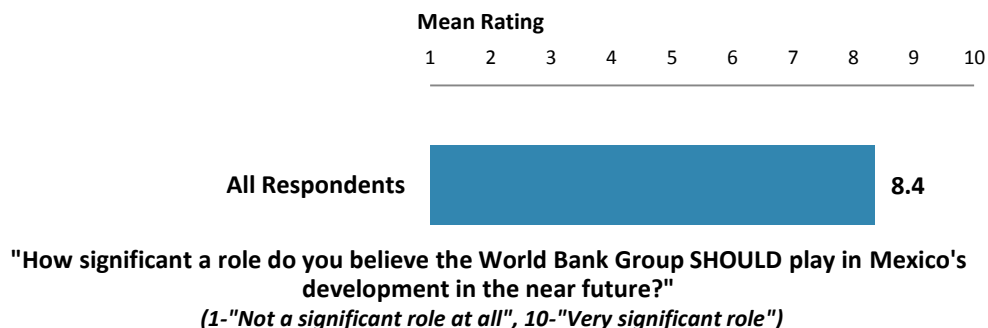
World Bank Group's Services in Mexico



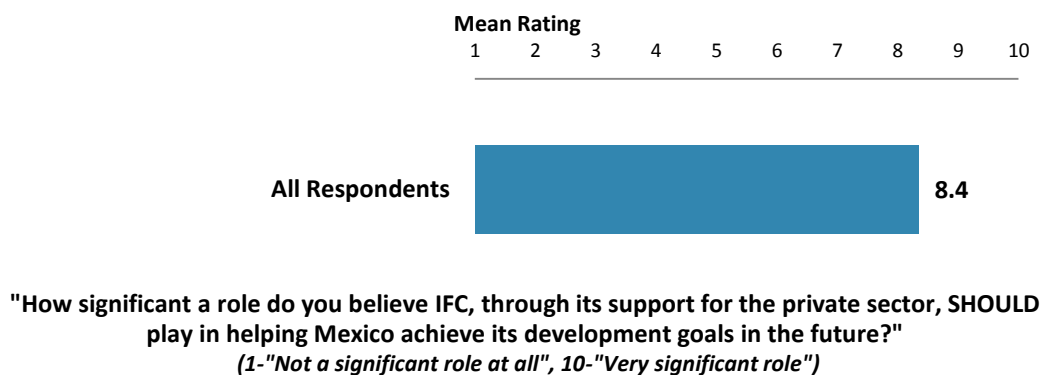

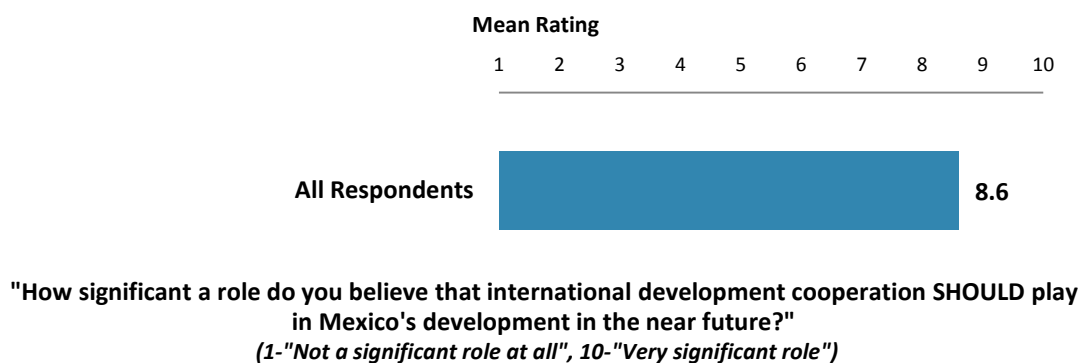
Future Role of the World Bank Group in Mexico



Future Role of the International Finance Corporation in Mexico



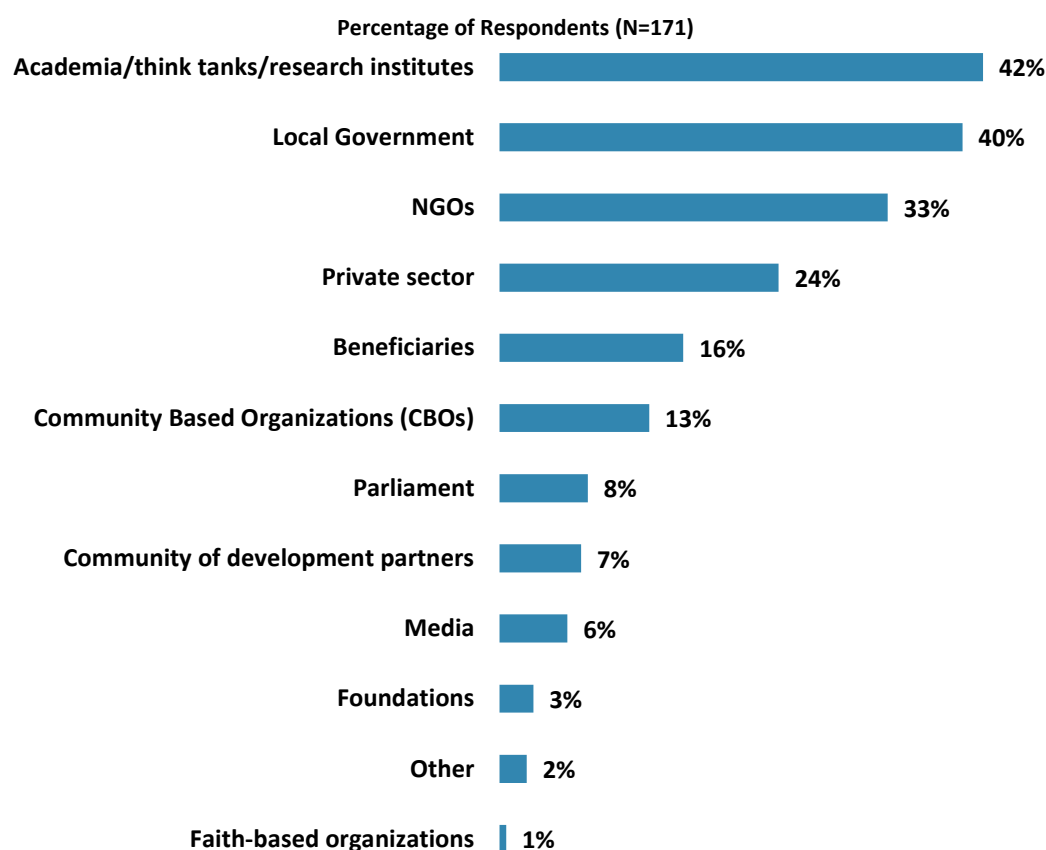
Future Role of International Development Cooperation in Mexico

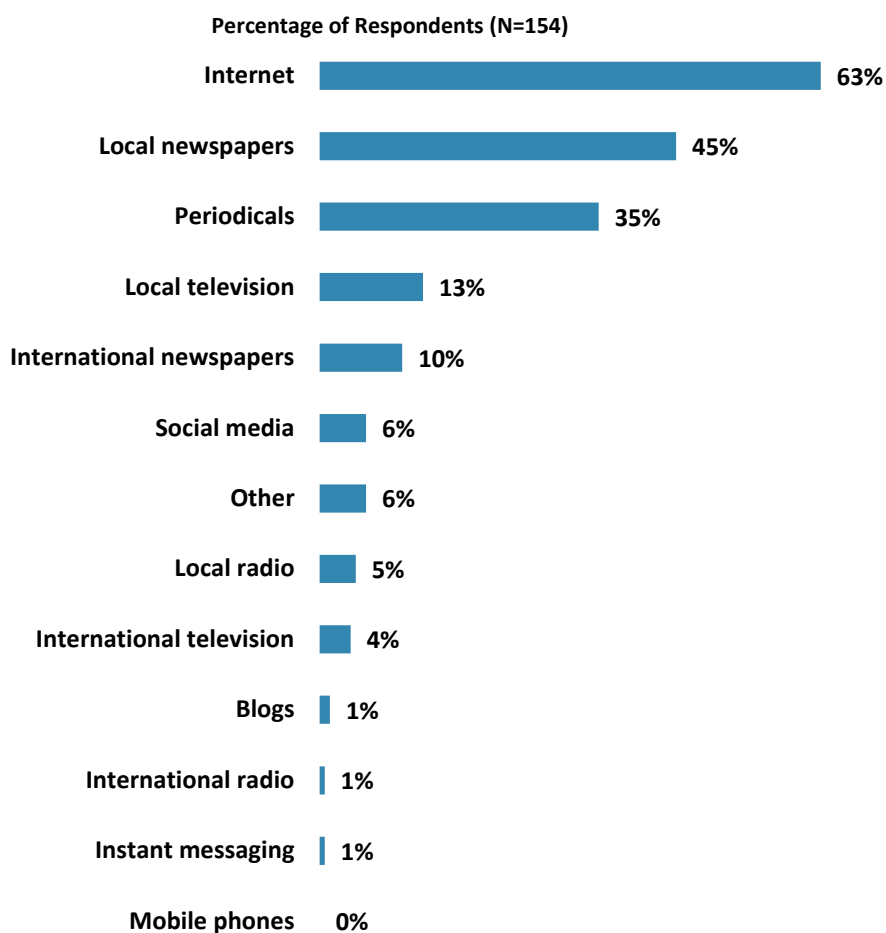

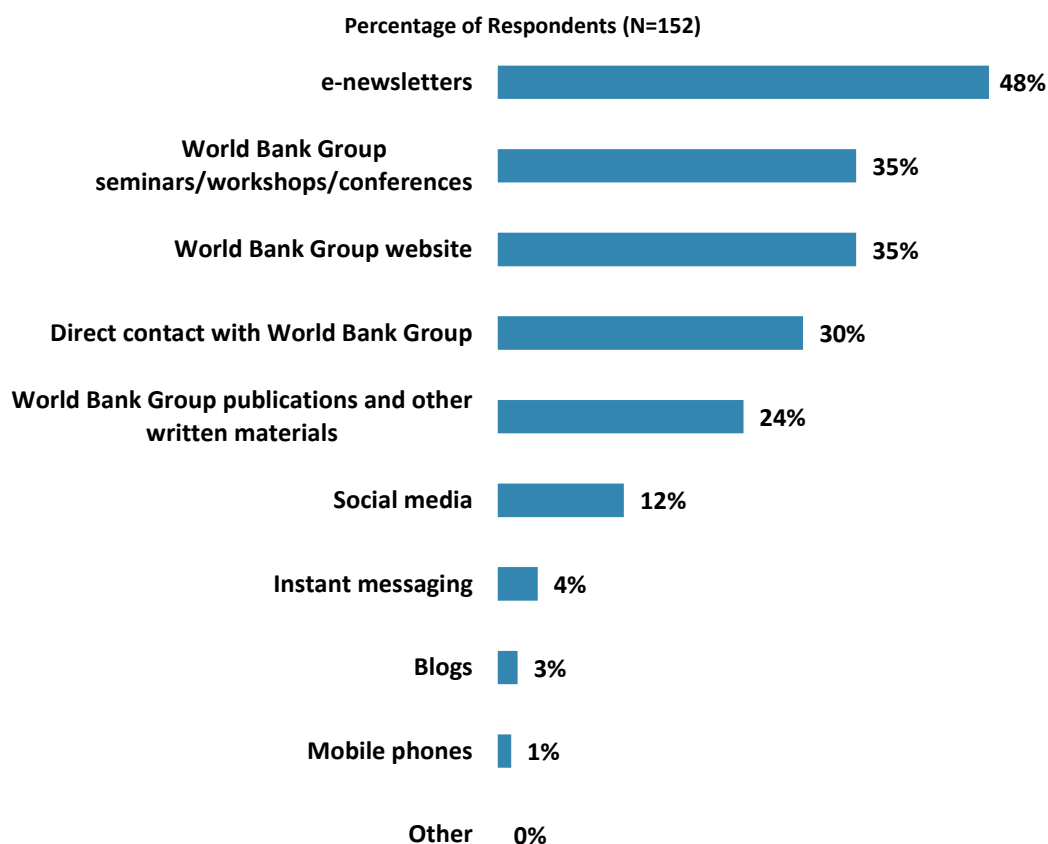
General Information Sources

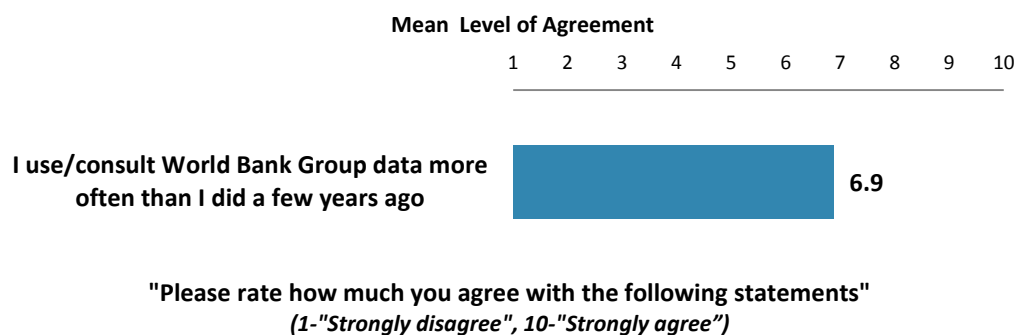
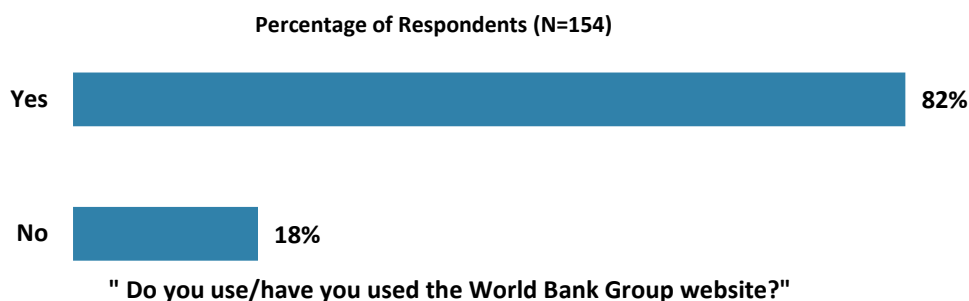

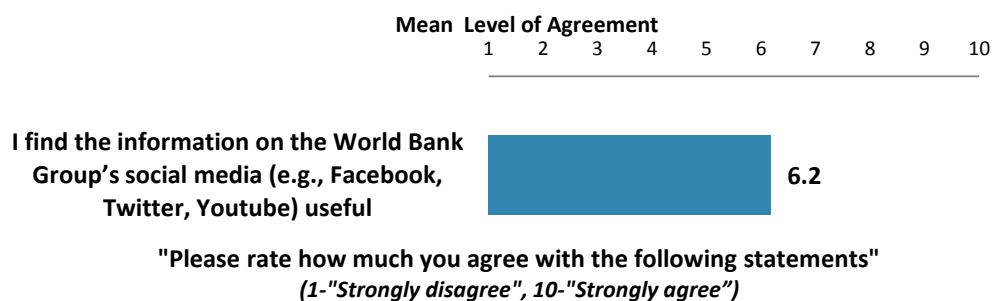
Website Usage

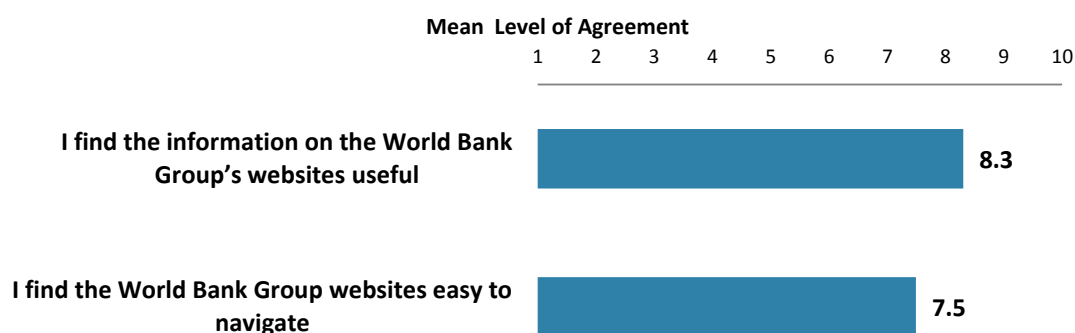
Evaluation of WBG's Social Media Channels

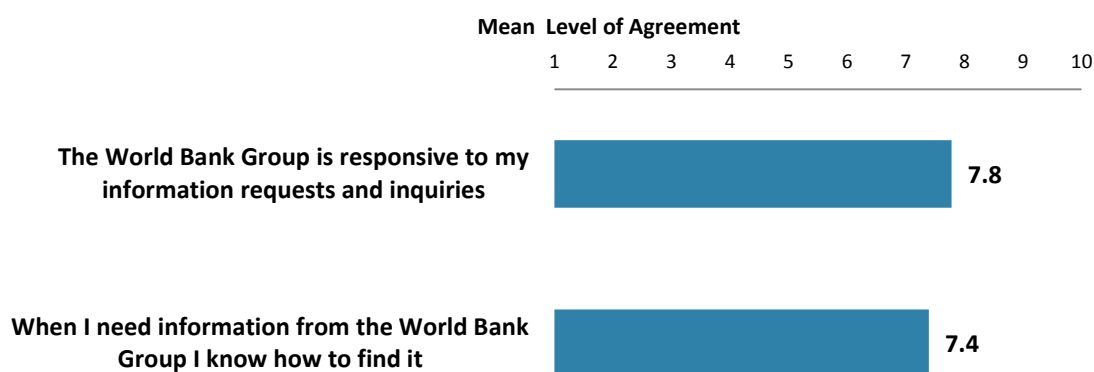
