Sampling

Sampling Procedure

From April to May 2015, 361 stakeholders of the WBG in São Tomé and Príncipe were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from the Office of the President/Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/ programs; local governments; bilateral/multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; non-profit organizations/community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

A total of 290 stakeholders participated in the survey (80% response rate).

Weighting

The results in 2015 Country Survey were compared to those in the Country Survey conducted in FY2012 (response rate is 63%, N=125). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, means of the 2015 data and the total number of respondents in both years are slightly different from those of the original data reported in appendices A, B, C, D, and F.
