## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Cameroon perceive the WBG. The survey explored:

- General Issues Facing Cameroon
- Overall Attitudes toward the World Bank Group
- World Bank Group's Effectiveness and Results
- The World Bank Group's Knowledge Work and Activities
- Working with the World Bank Group
- The Future Role of the World Bank Group in Cameroon
- Communication and Information Sharing
- Background Information

## II. Methodology

From May to June 2016, 607 stakeholders of the WBG in Cameroon were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/ contractors working on WBG-supported projects/programs; local governments; bilateral/ multilateral agencies; private sector organizations; private foundations; the financial sector/ private banks; NGOs/community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations. A total of 394 stakeholders participated in the survey (65% response rate).


Some respondents received and returned the questionnaires via courier or email; others completed the questionnaire with the presence of an independent research consultant. Respondents were asked about: general issues facing Cameroon; their overall attitudes toward the WBG; the WBG's effectiveness and results; the WBG's knowledge work and activities; working with the WBG; the WBG's future role in Cameroon; and the WBG's communication and information sharing.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'13 (response rate is 71%, N=403). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'13 COS report and the non-weighted data presented in appendices A, B, C, D, and F. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix E (page 89).

#### **Current Position**

For further analyses, employees of ministries/ministerial departments/implementation agencies were combined with respondents from PMUs/consultants/contractors working on WBG-supported projects; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/ community based organizations, private foundations, faith-based groups, youth groups, and trade unions were combined in the "CSO" category; and the small number of respondents from the Office of the President/Prime Minister, the office of a minister, the office of a parliamentarian, local governments, independent government institutions were included in the "Other" category. There were no respondents from the judiciary branch.




Percentage of Respondents (N=383)

#### **Area of Primary Specialization**







"Which of the following agencies of the World Bank Group do you primarily engage with in Cameroon?" (Respondents chose from a list.)



### III. Demographics of the Sample (continued)

#### Familiarity with the World Bank Group

- Year comparison: Respondents in this year's Country Survey and the FY'13 Country Survey had statistically similar levels of familiarity with the WBG (weighted mean in FY'16 = 5.4; weighted mean in FY'13 = 5.7)<sup>1</sup>.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Cameroon, and significantly, moderately correlated with the extent to which the WBG plays a relevant role in development in Cameroon, and the extent to which the WBG contributes to the country's development results.



### Headed in the Right Direction<sup>2</sup>

- Year comparison: This year's respondents were significantly more likely to believe that Cameroon is headed in the wrong direction compared to respondents in the FY'13 Country Survey.
- **Stakeholder groups:** In this year's Country Survey, respondents from the private sector/financial sector/private banks were more likely to indicate that Cameroon is headed in the right direction, while respondents from the media and academia were significantly less positive about the prospect of Cameroon.



Percentage of Respondents (N=374)




















Percentage of Respondents (N=58)


"If your projects involved both the World Bank and the IFC, what was your view on the two institutions working together in Cameroon?" (Respondents chose from a list.)

#### **Overall Ratings for Indicator Questions by Stakeholder Groups**


- Stakeholder groups: Respondents from academia/research institutes/think tanks had significantly lower mean ratings for the aggregated responses to the twenty six COS indicator questions compared to respondents from other stakeholder groups. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (see page 59).
- Collaboration: Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty six COS indicator questions (mean rating = 6.6) compared to respondents who do not collaborate with the WBG (mean rating = 5.7). 



### **Drivers of Effectiveness**

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Cameroon, bivariate correlational analyses were conducted using respondents' ratings of the twenty six specific areas of effectiveness.


Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

- <u>Overall Effectiveness</u>: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Cameroon. The areas determined to be key drivers from these analyses were:
  - > The WBG's effectiveness at rural development; and
  - > The WBG's effectiveness at poverty reduction.
- <u>Achieving Development Results:</u> Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Cameroon, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The area determined to be key driver from these analyses was:
  - > The WBG's effectiveness at poverty reduction;
  - > The WBG's effectiveness at economic growth;
  - ➤ The WBG's effectiveness at health;
  - > The WBG's effectiveness at urban development; and
  - > The WBG's effectiveness at rural development.



"To what extent do you believe that the World Bank Group's work and support help the poorest in Cameroon?" (Respondents chose from a list.)












"To what extent do you believe the World Bank Group measures and corrects its work in real time in Cameroon?" (1-"To no degree at all", 10-"To a very significant degree")




#### Percentage of Respondents (FY 2016 N=372; FY 2013 N=358)






#### Technical Quality of the WBG's Knowledge Work and Activities (Indicator Question)
















"How would you prefer to receive information from the World Bank Group? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)





"Which Internet connection do you use primarily when visiting a World Bank Group website?" (Respondents chose from a list.)




