I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Bulgaria perceive the WBG. The survey explored:

- *General Issues Facing Bulgaria*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Bulgaria*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From January to February 2018, 458 stakeholders of the WBG in Bulgaria were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs and community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

A total of 145 stakeholders participated in the survey (32% response rate). Respondents received and completed the questionnaires via the online survey platform Qualtrics, or received and returned the questionnaires via courier.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

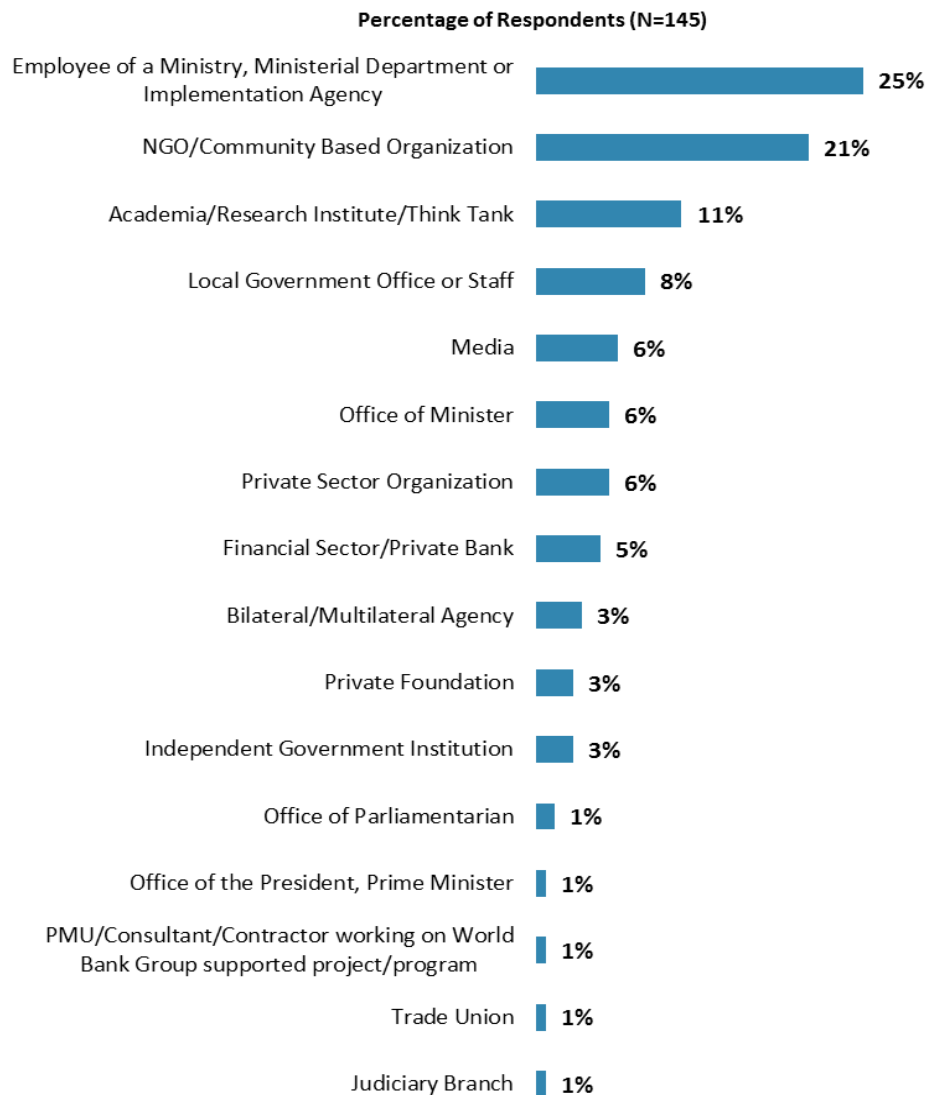
The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'15 (response rate was 37%, N=183). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'15 COS report and the non-weighted data presented in appendices A, B, C, D, and F. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix E (page 88).



III. Demographics of the Sample

Current Position

- For further analyses, respondents from the Office of the President/Prime Minister were combined with respondents from the office of a minister; employees of ministries/ministerial departments/implementation agencies were combined with respondents from PMUs/consultants/contractors working on WBG-supported projects; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/community based organizations, private foundations, and trade unions were combined in the “CSO” category; and the small number of respondents from office of a parliamentarian, bilateral and multilateral agencies, independent government institutions, and the judiciary branch were included in the “Other” category. There were no respondents from faith-based groups, youth groups, or other organizations.

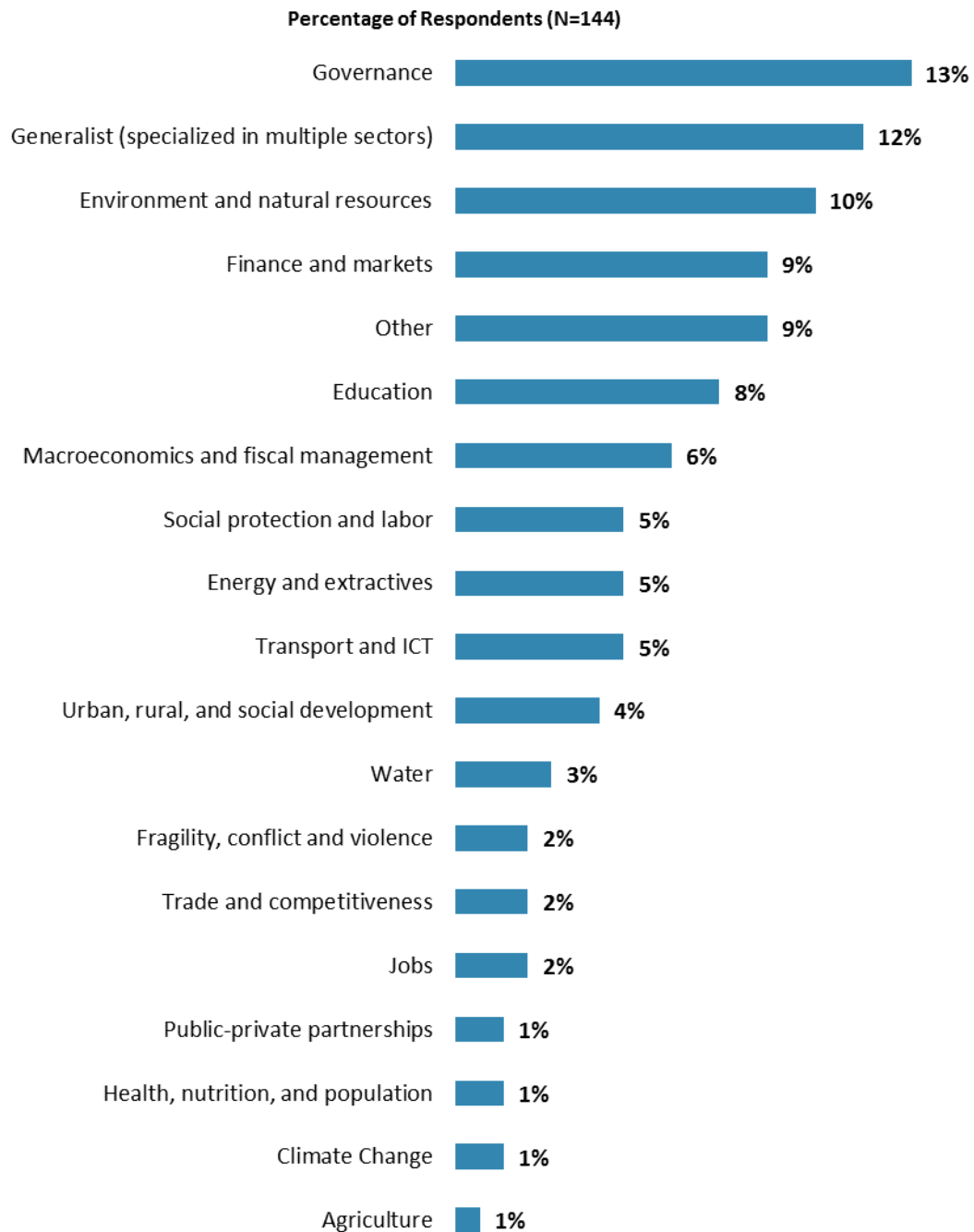


“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization



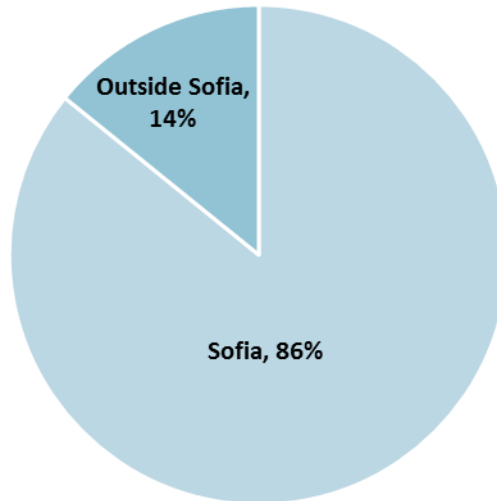
"Please identify the primary specialization of your work." (Respondents chose from a list.)

Geographic Locations

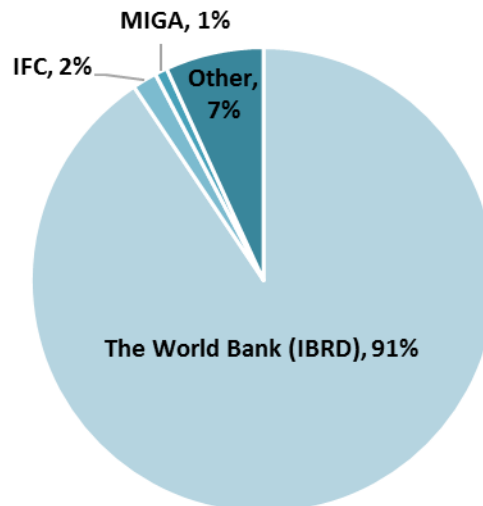
Percentage of Respondents (N=141)

Percentage of Respondents (N=117)



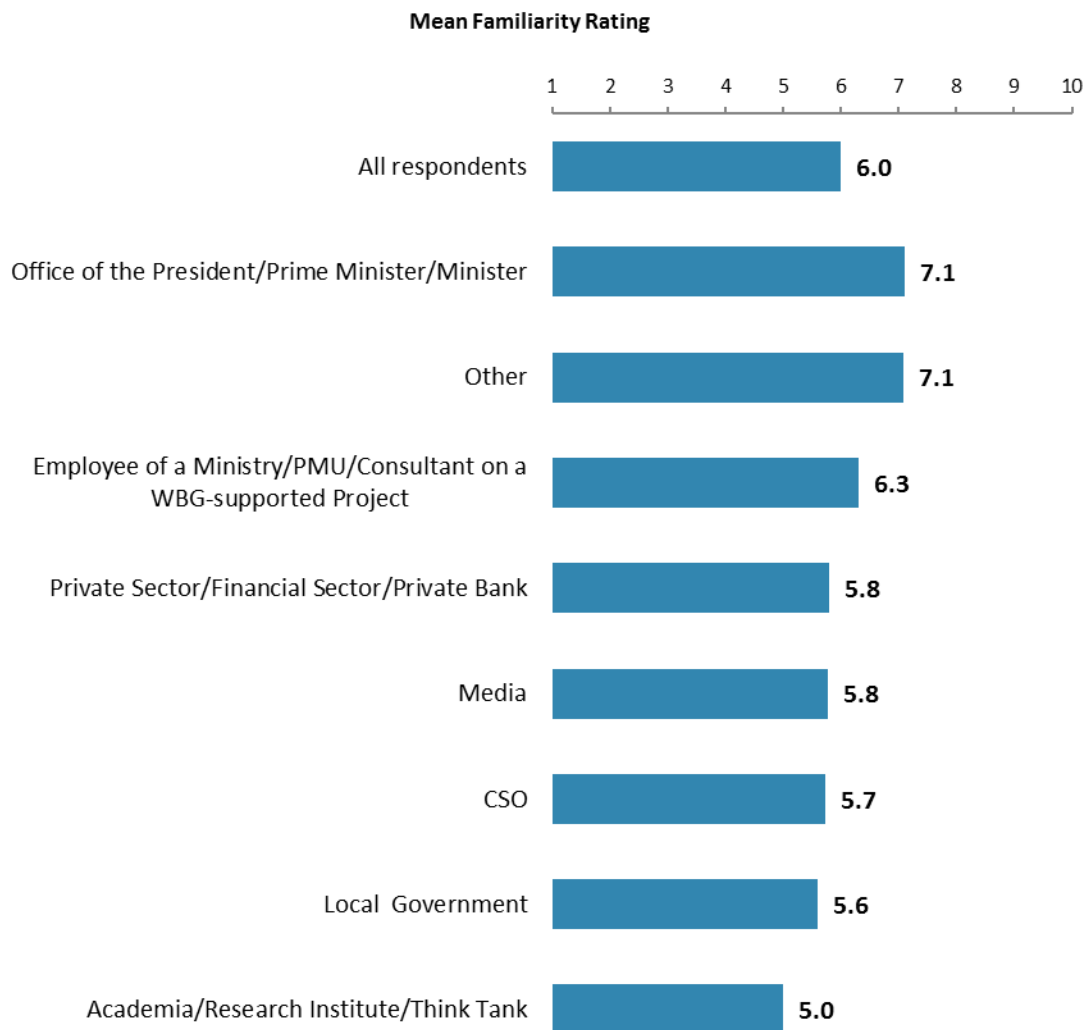
"Which of the following agencies of the World Bank Group do you primarily engage with in Bulgaria?" (Respondents chose from a list.)

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had statistically similar levels of familiarity with the WBG as respondents in the FY'15 Country Survey (weighted mean in FY'18 = 6.1; weighted mean in FY'15 = 5.8)¹.
- Respondents' levels of familiarity with the WBG were significantly, strongly correlated with their ratings of the WBG's overall effectiveness in Bulgaria, and significantly, moderately correlated with the extent to which the WBG plays a relevant role in development in Bulgaria, and the extent to which the WBG contributes to the country's development results.

(1-"Not familiar at all", 10-"Extremely familiar")

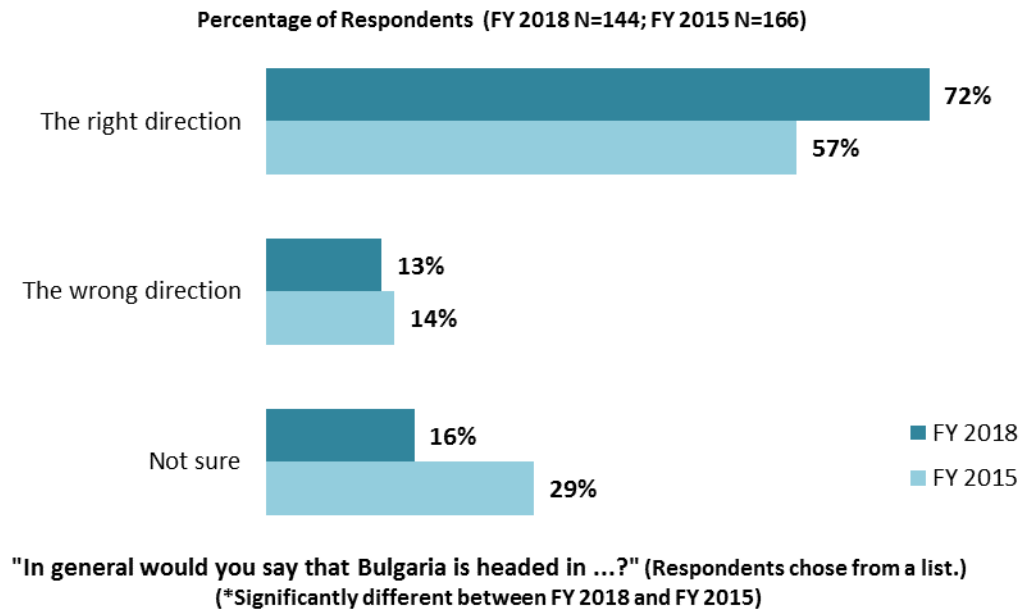

Headed in the Right Direction²

- **Stakeholder groups:** In this year's Country Survey, respondents across most stakeholder groups were likely to indicate that Bulgaria is headed in the right direction, while respondents from the "CSO" category and the media were less positive about the prospects of Bulgaria.



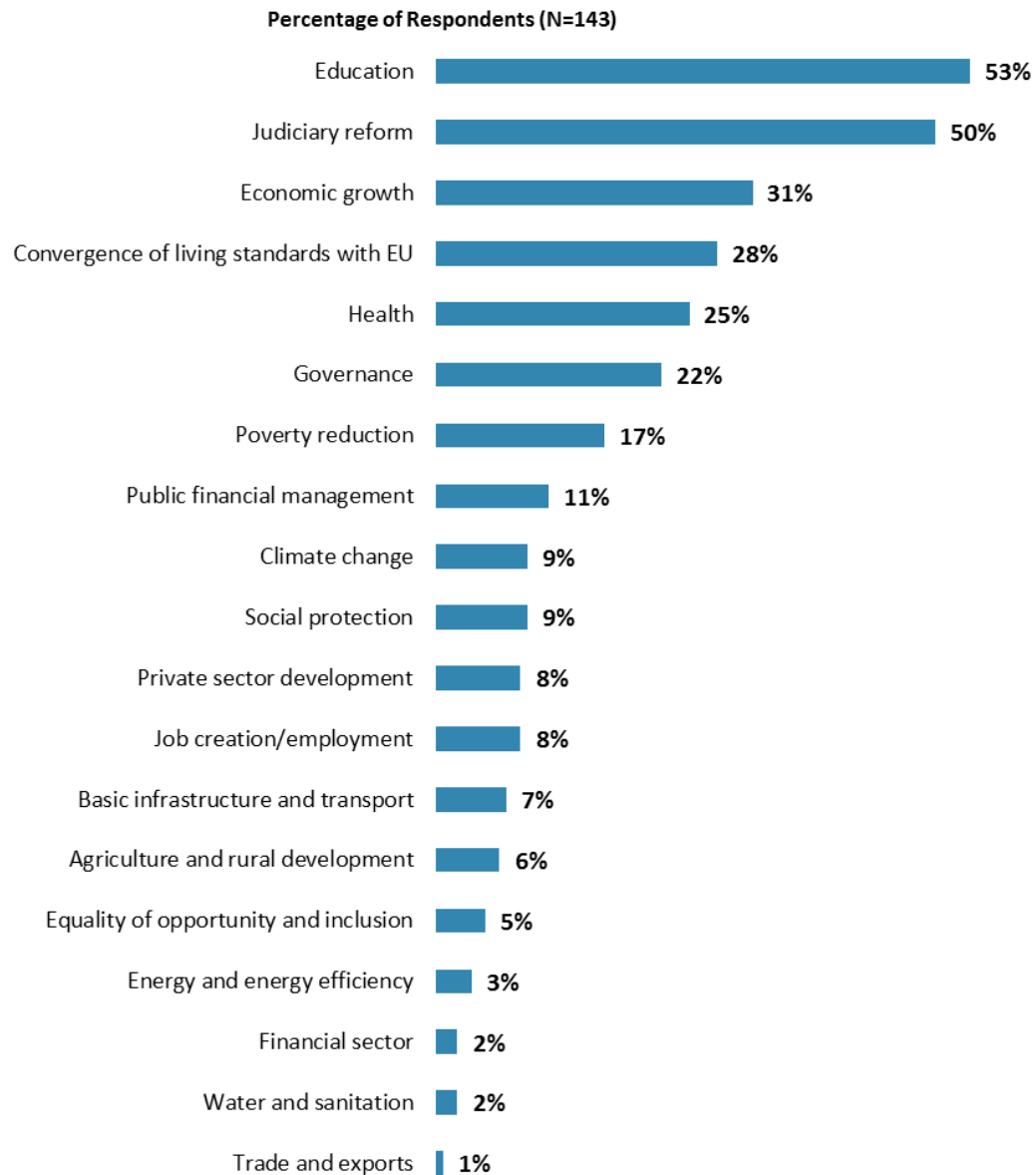

- **Year comparison:** Respondents in the previous FY'15 Country Survey indicated that the most important development priorities in Bulgaria were “*education*” (53%), “*economic growth*” (53%), and “*law and justice*” (48%).



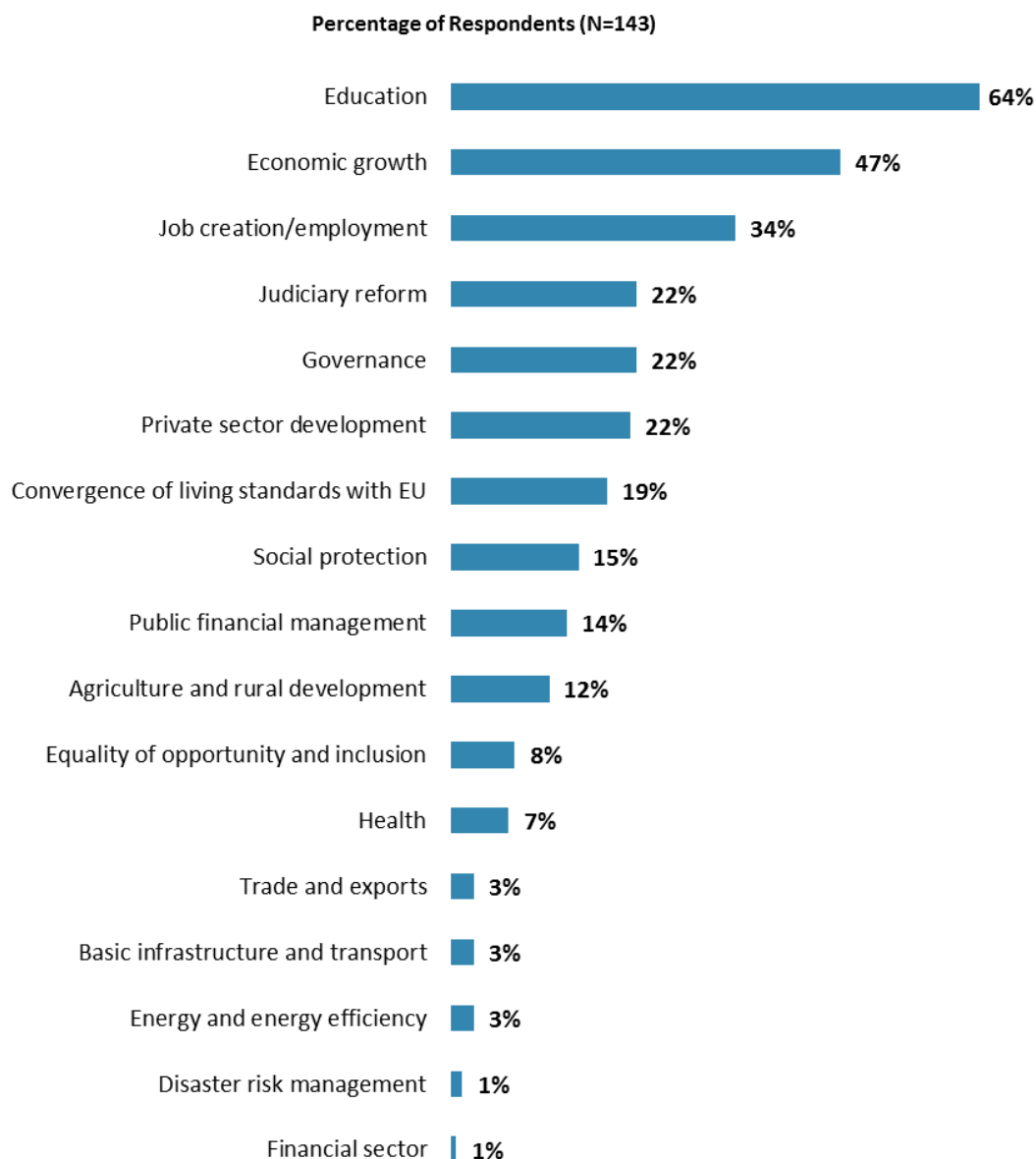

- **Year comparison:** In the previous FY'15 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Bulgaria were “*education*” (53%), “*economic growth*” (41%), and “*job creation/employment*” (39%).



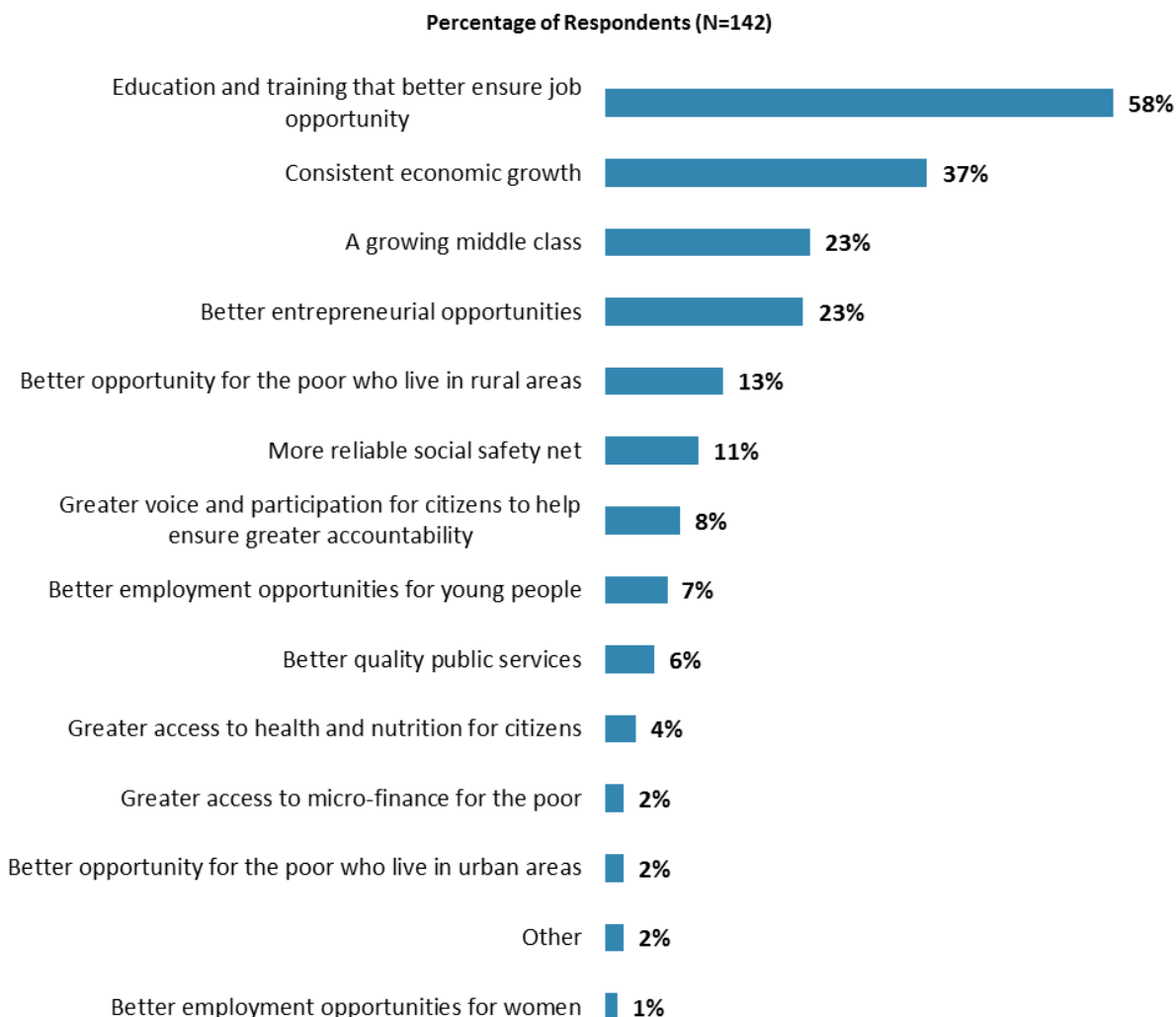

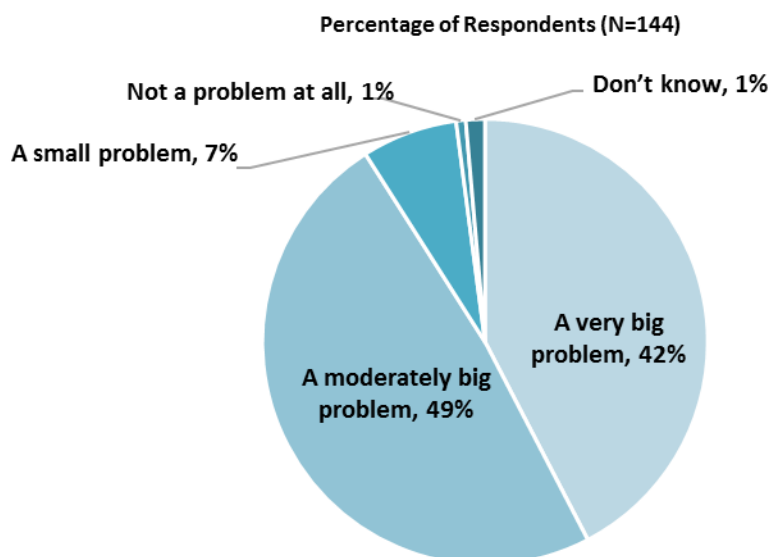

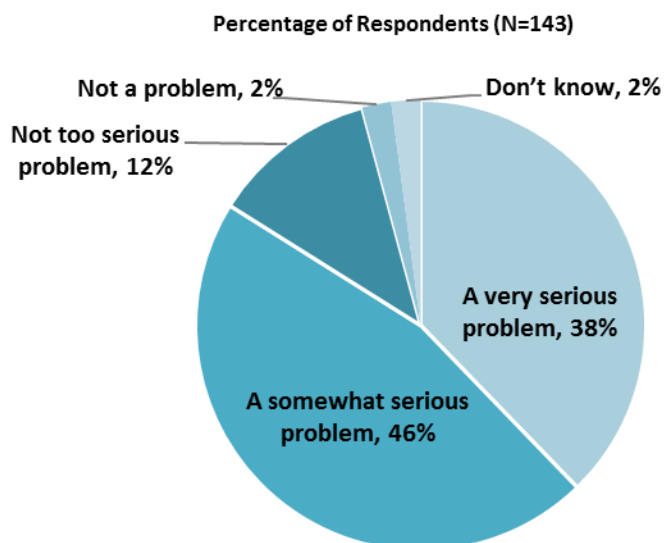

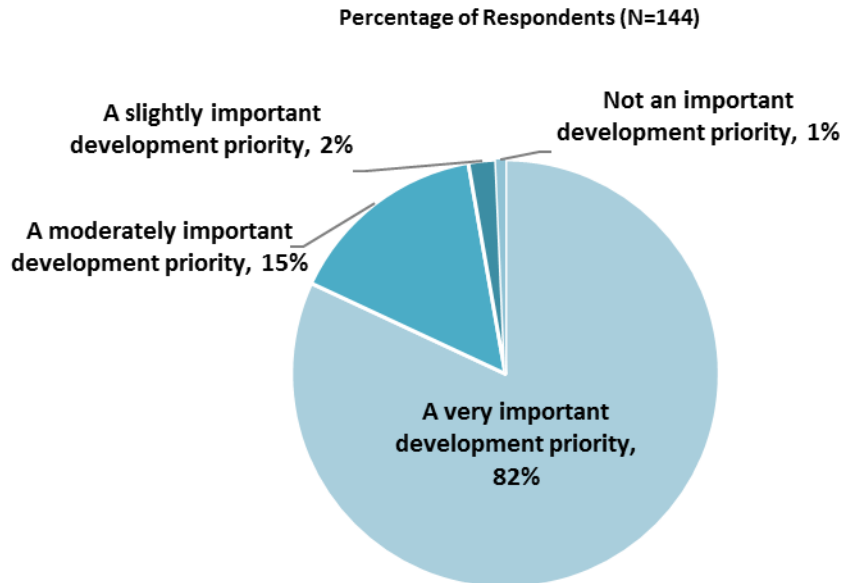


"In your view, is climate change a very serious problem, somewhat serious, not too serious, or not a problem in your country?" (Respondents chose from a list.)

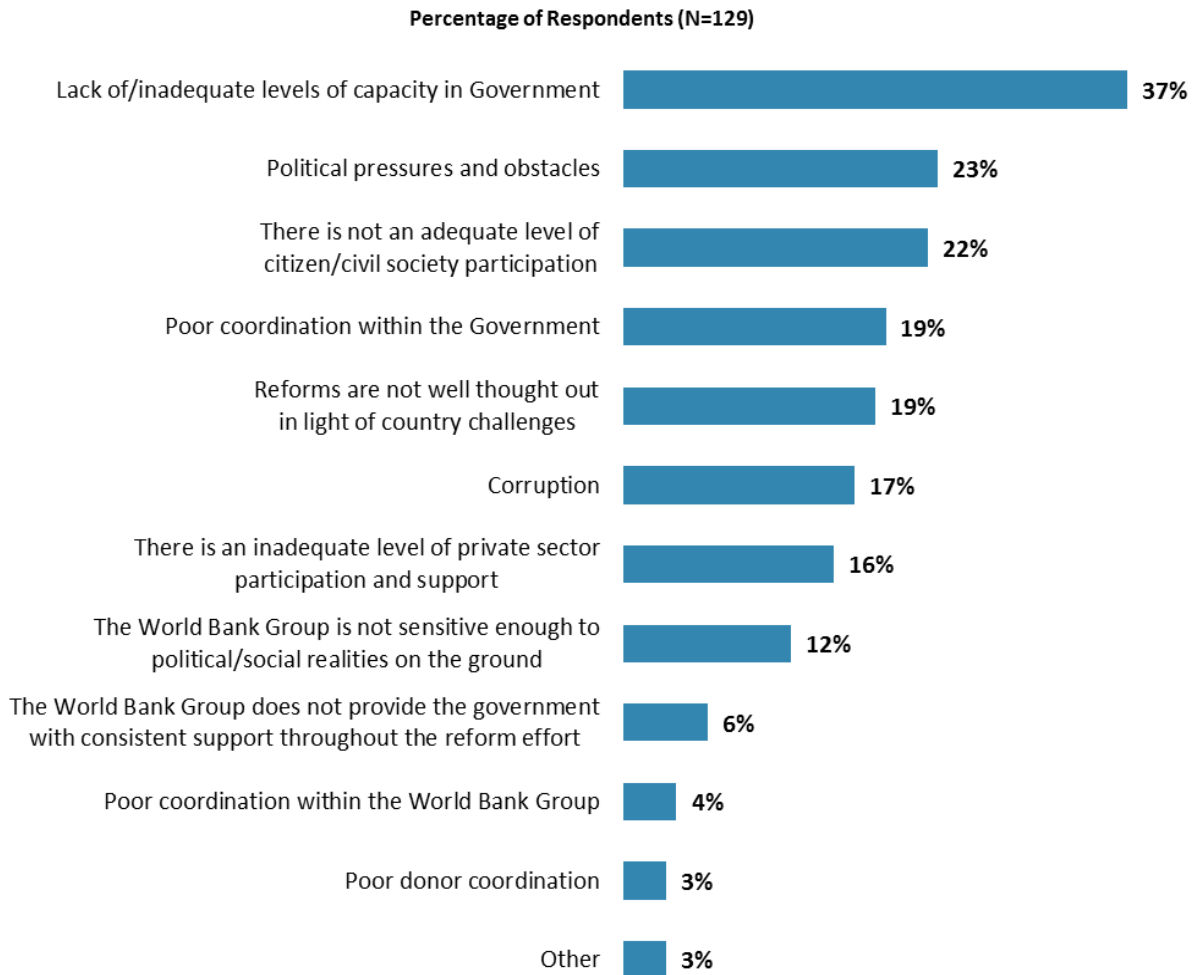

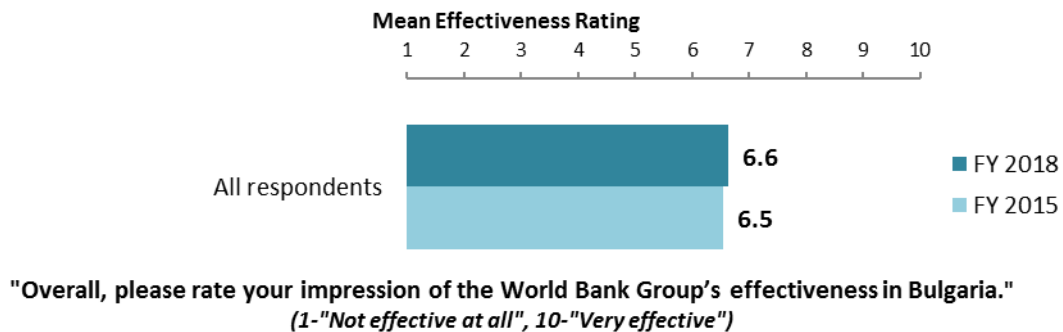
"When World Bank Group assisted reform efforts fail or are slow to take place, which of the following would you attribute this to? (Choose no more than TWO)"

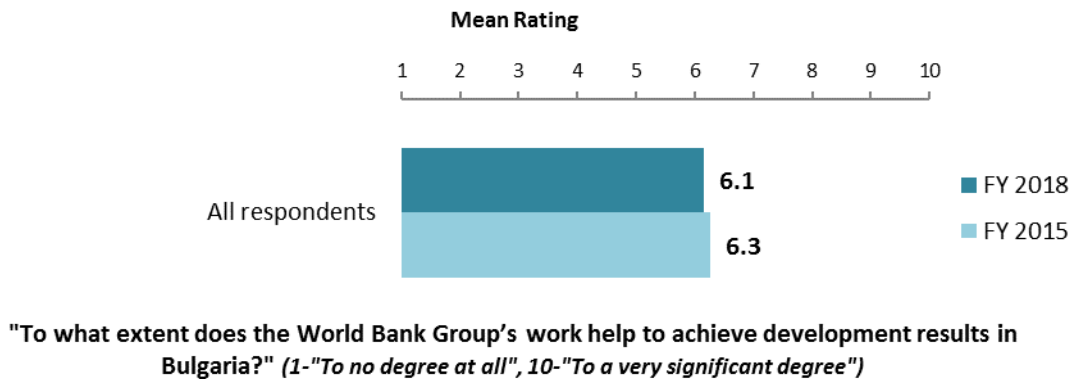

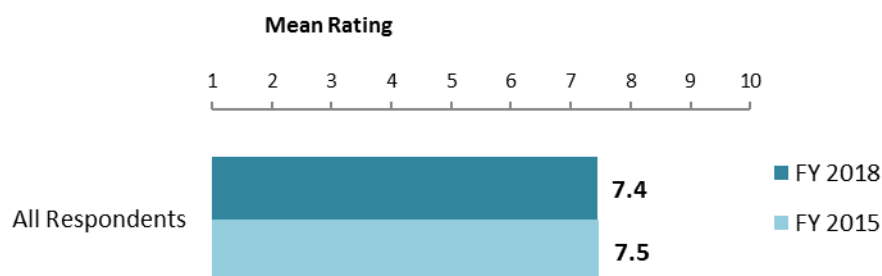

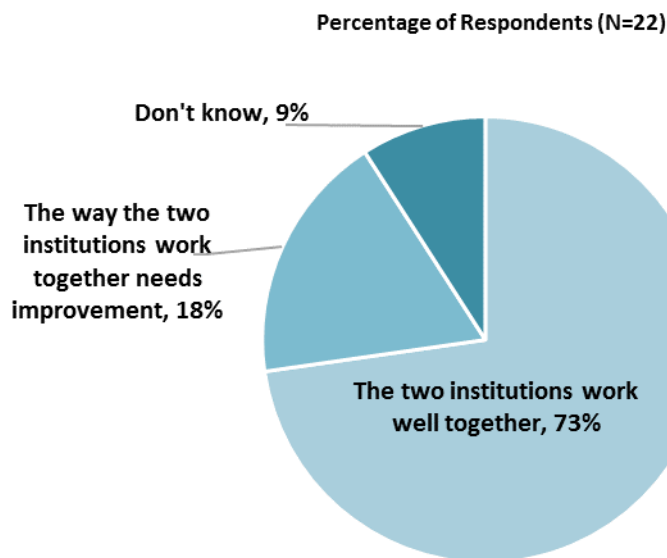
WBG Staff Preparedness⁴

"If your projects involved both the World Bank and the IFC, what was your view on the two institutions working together in Bulgaria?" (Respondents chose from a list.)

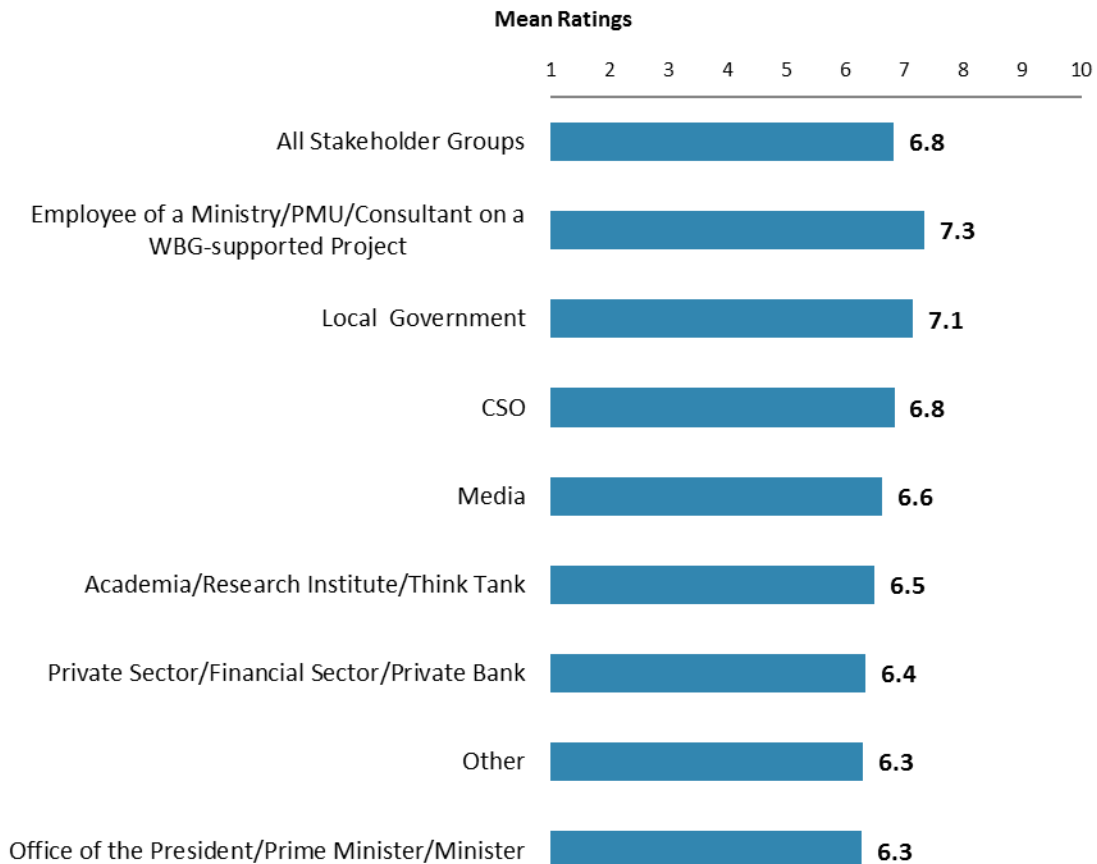

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-six COS indicator questions (mean rating = 7.4) compared to respondents who do not collaborate with the WBG (mean rating = 6.2). 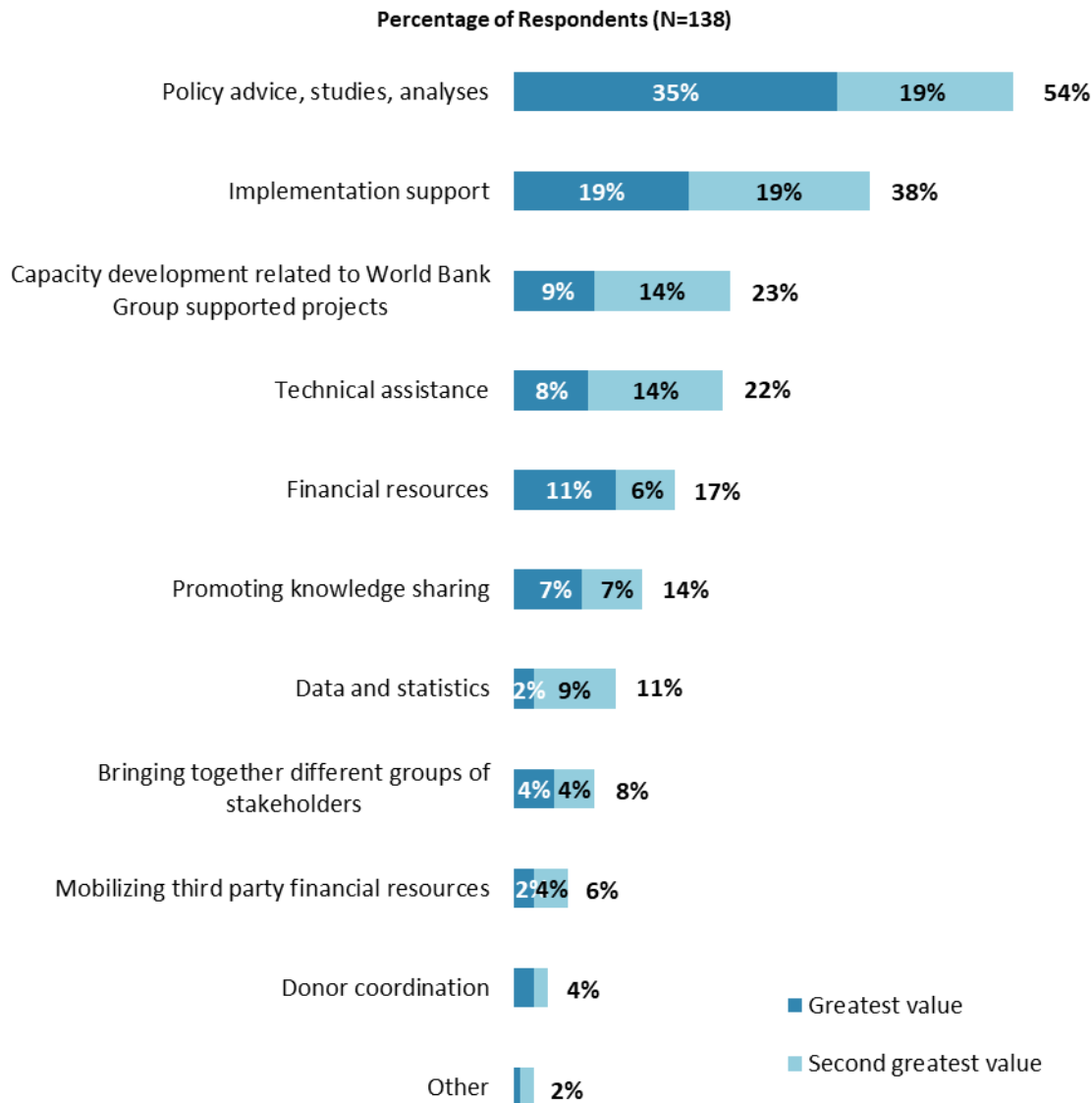
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

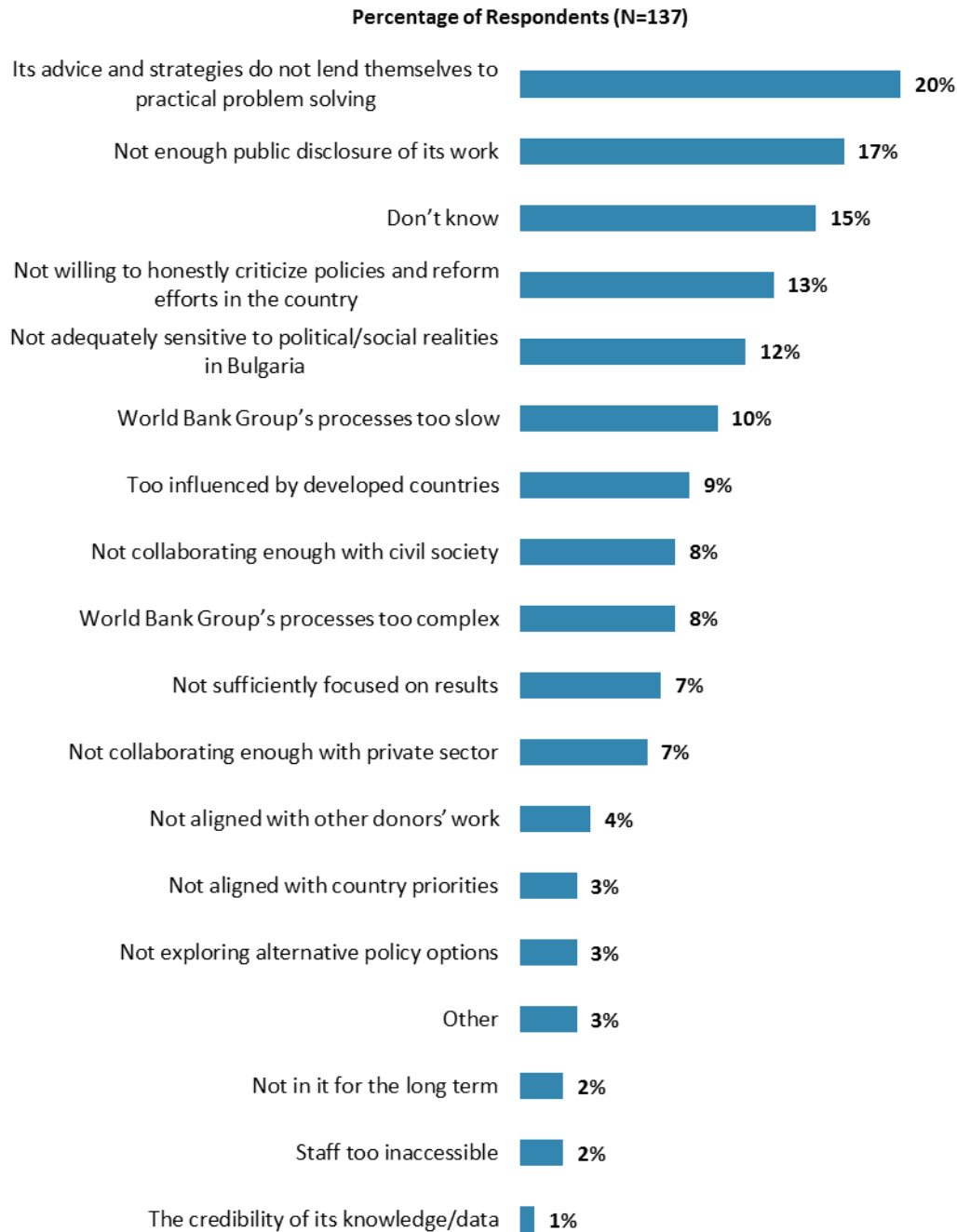
"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Bulgaria?"

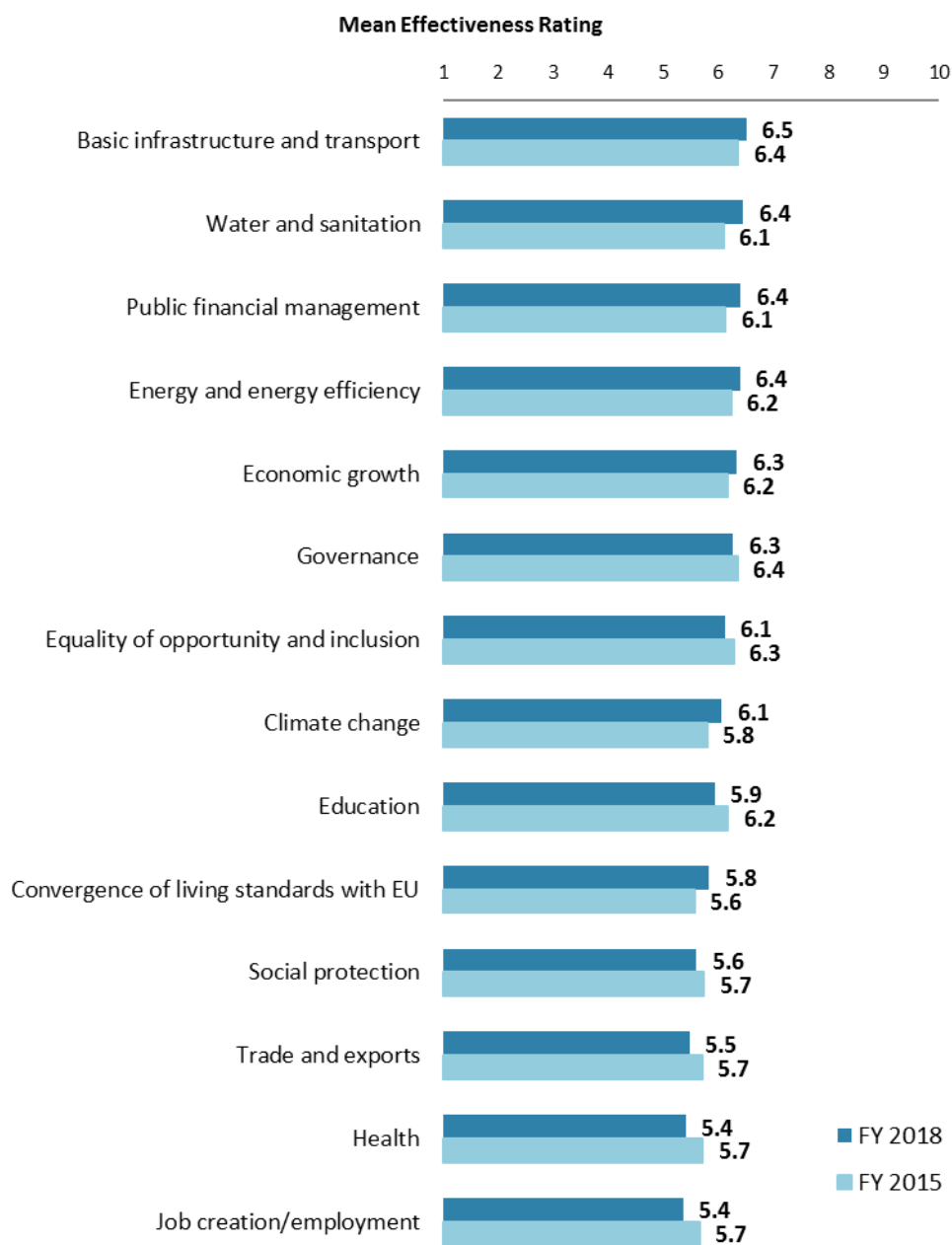

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁵



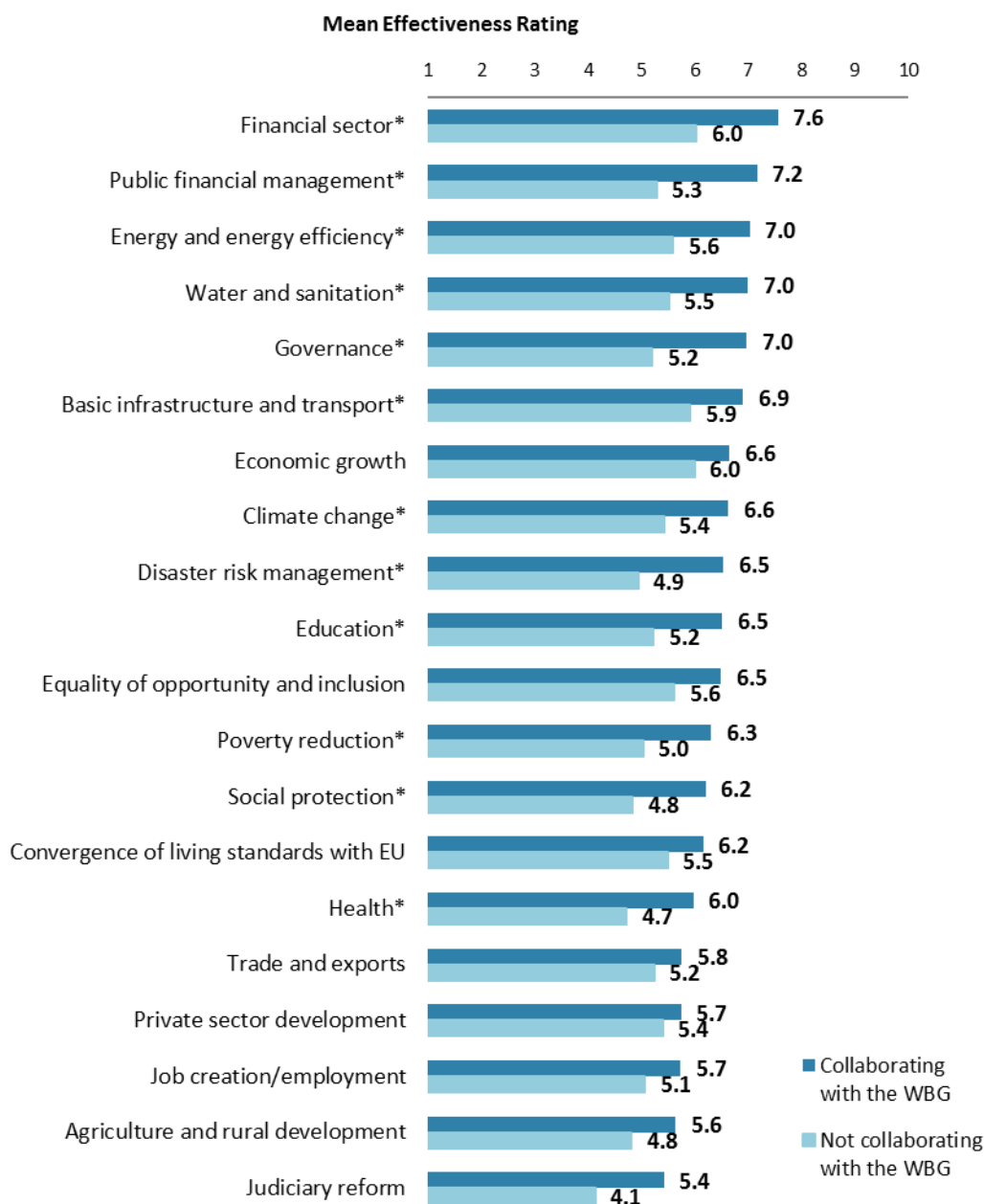

VI. Sectoral Effectiveness (continued)

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Bulgaria, bivariate correlational analyses were conducted using respondents' ratings of the twenty specific areas of effectiveness.

Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

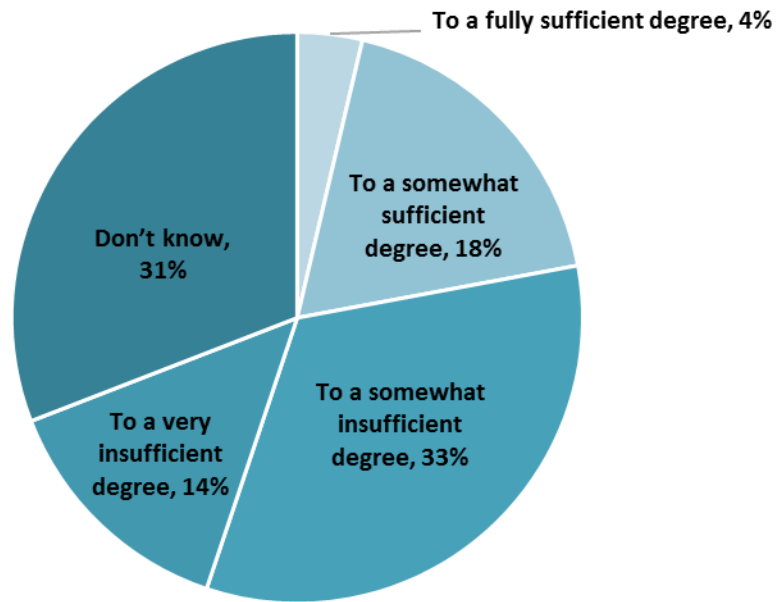
- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Bulgaria. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at public financial management;
 - The WBG's effectiveness at education; and
 - The WBG's effectiveness at poverty reduction.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Bulgaria, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The areas determined to be key driver from these analyses were:
 - The WBG's effectiveness at health;
 - The WBG's effectiveness at economic growth;
 - The WBG's effectiveness at public financial management;
 - The WBG's effectiveness at disaster risk management; and
 - The WBG's effectiveness at education.

Percentage of Respondents (N=136)

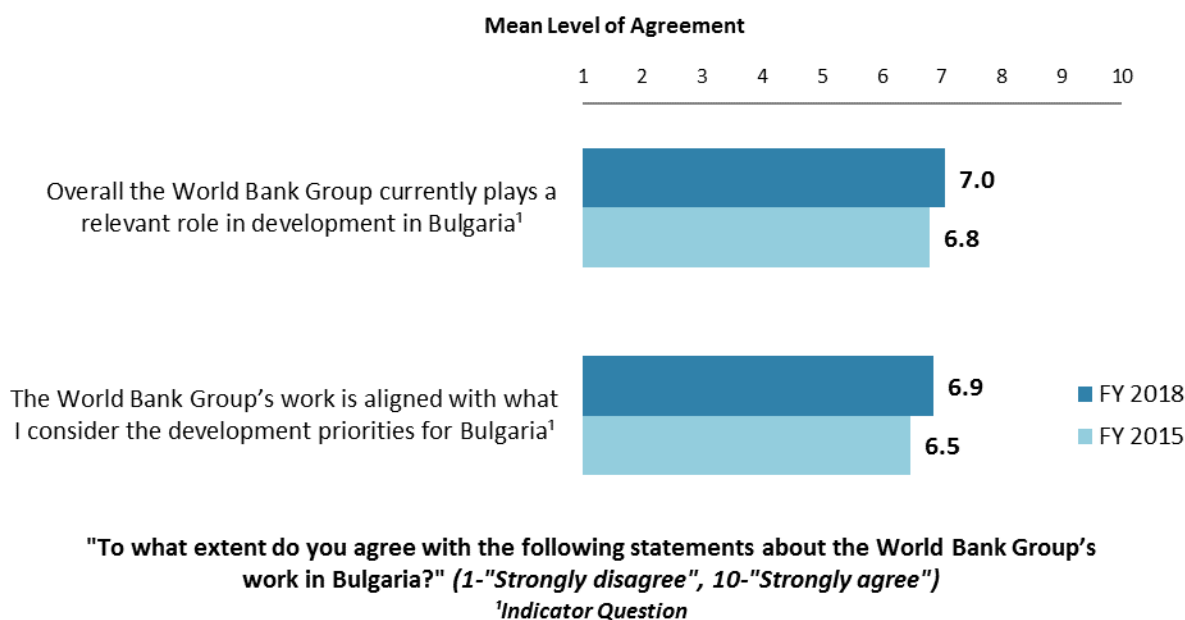


"To what extent do you believe that the World Bank Group's work and support help the poorest in Bulgaria?" (Respondents chose from a list.)

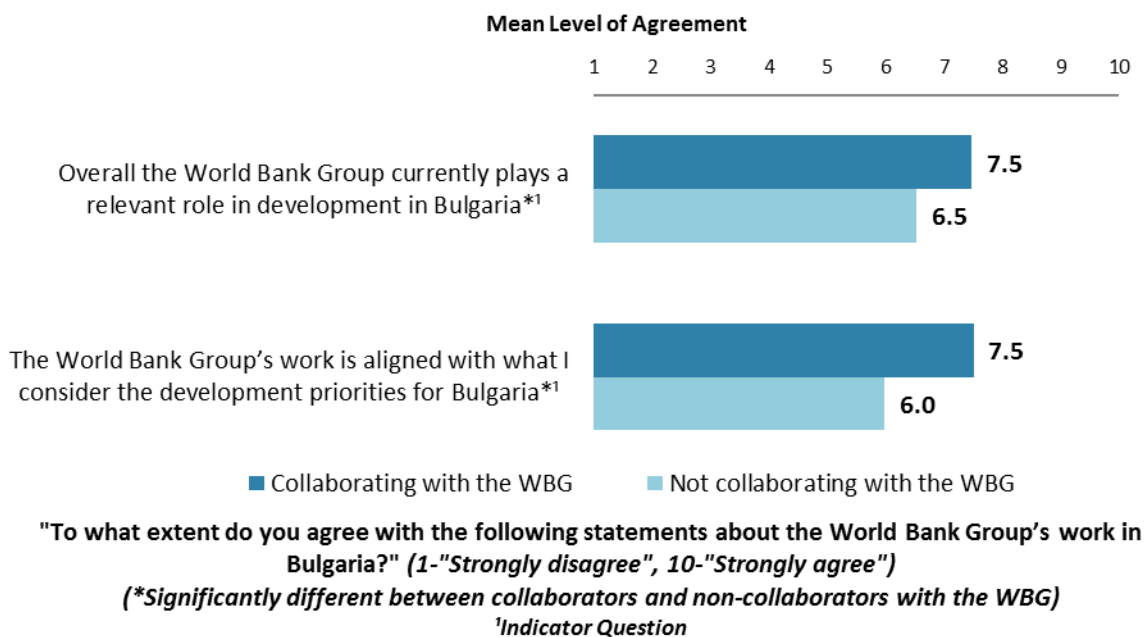

The World Bank Group's Work in Bulgaria: Collaboration

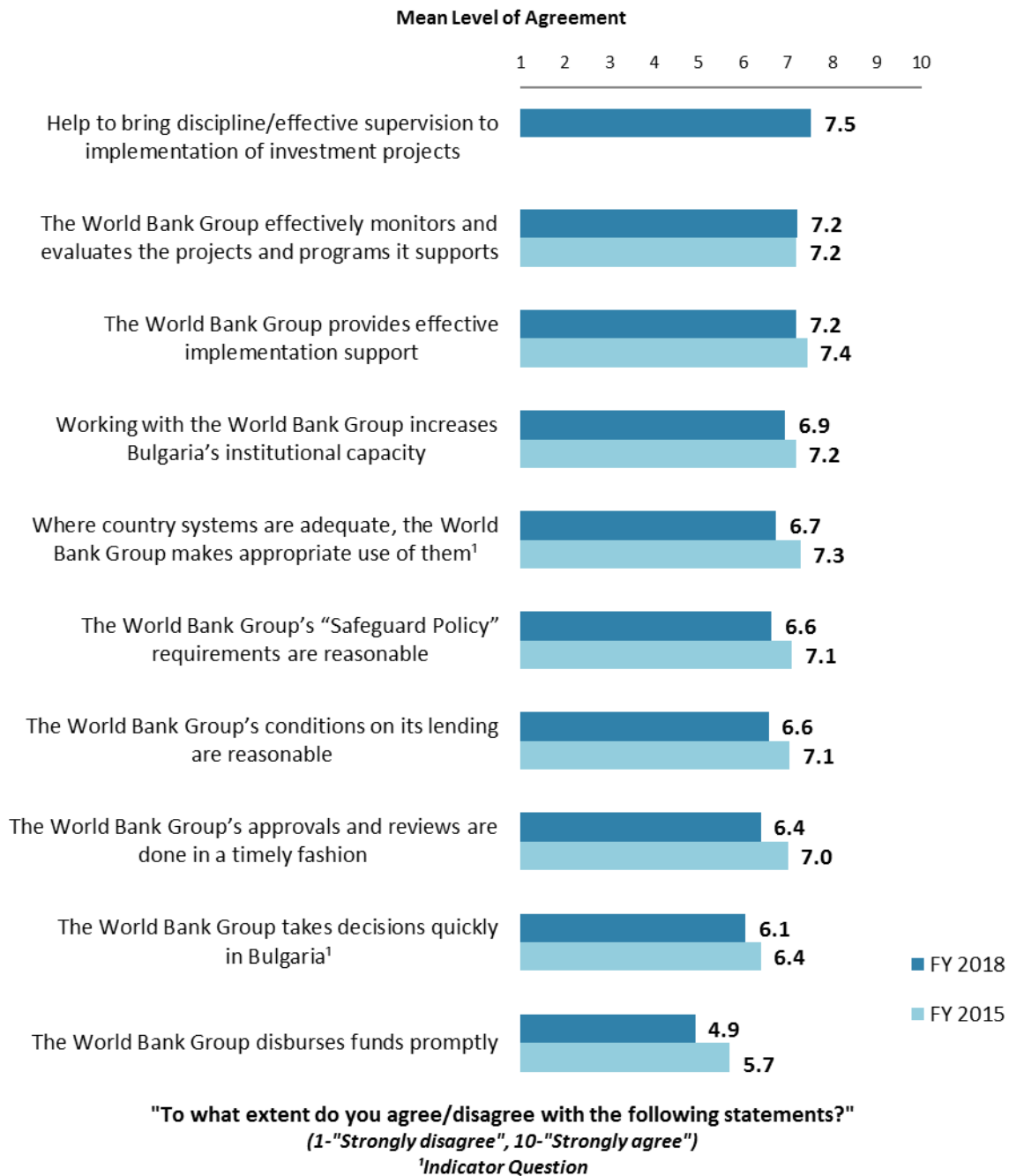

Overall Perceptions: Year Comparison⁸

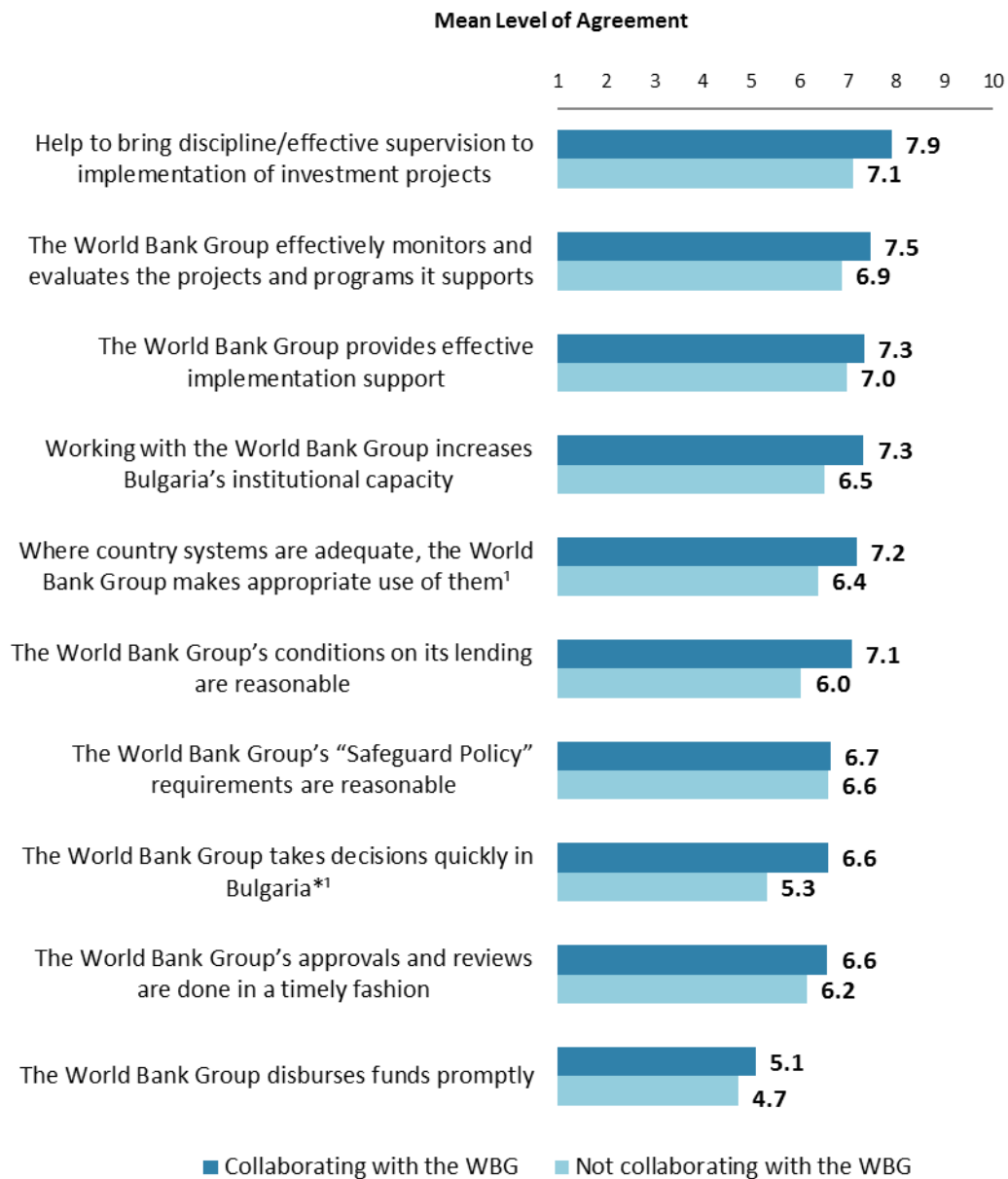

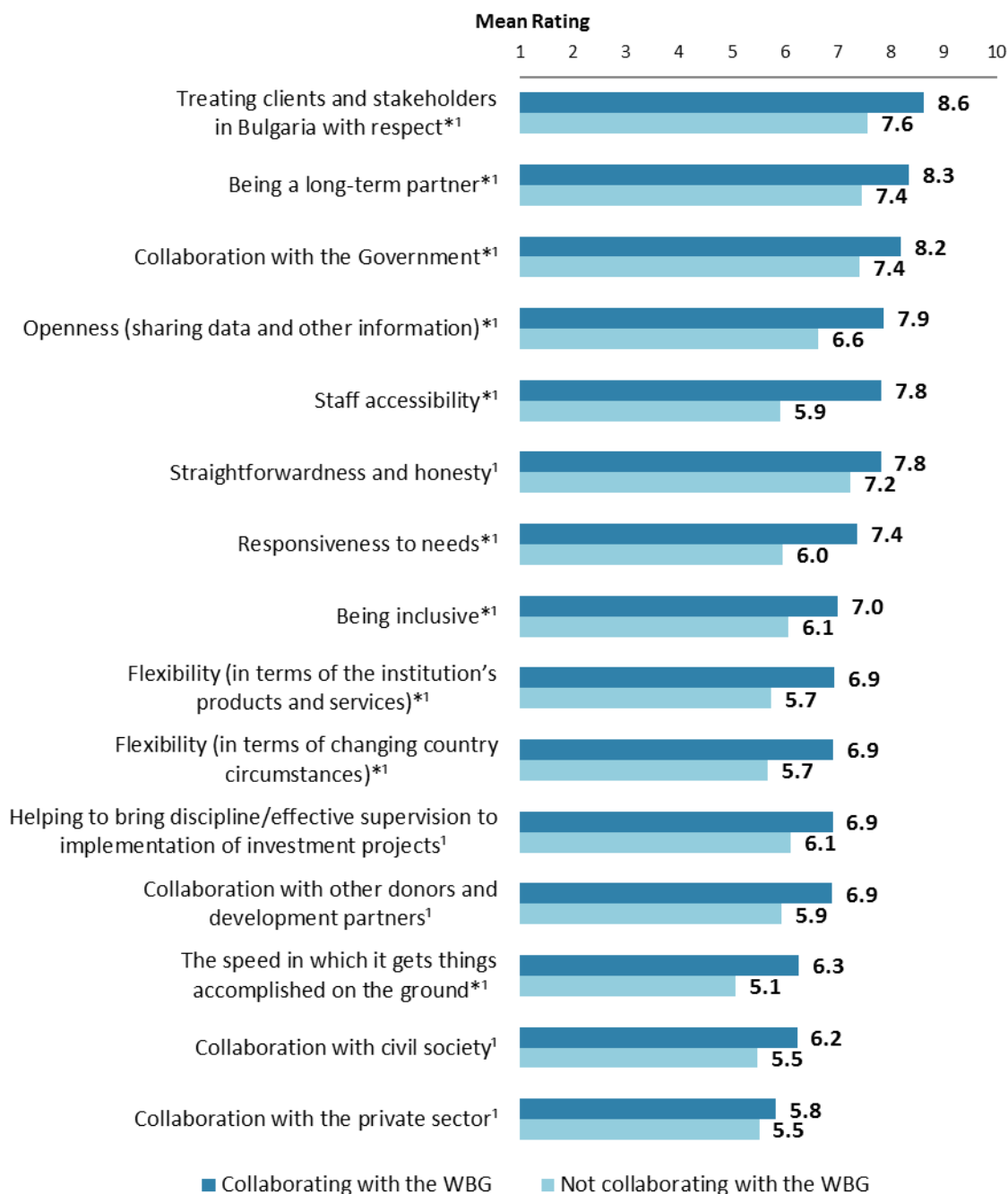

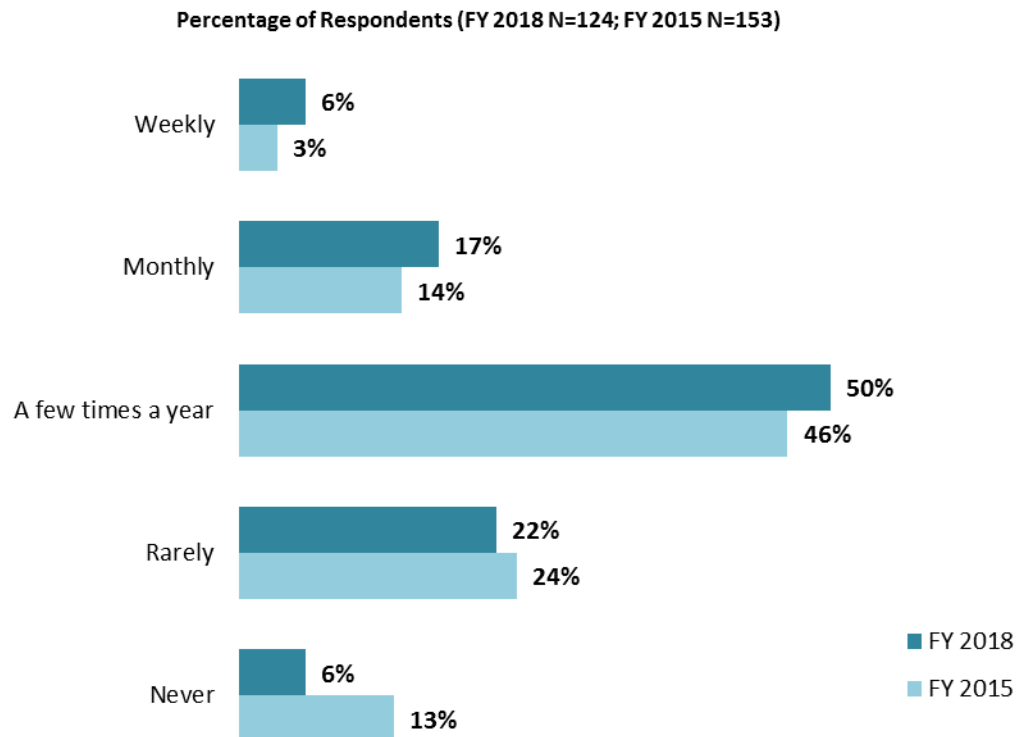

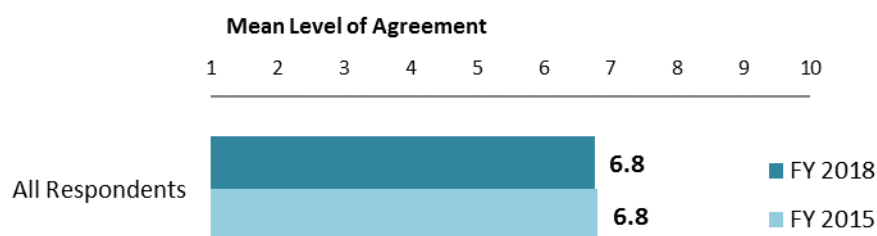
"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"

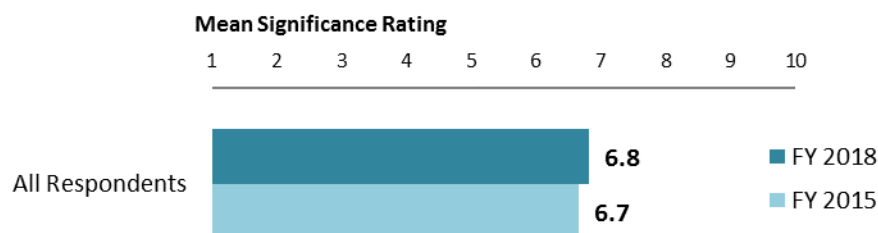

Meeting Bulgaria's Knowledge Needs¹¹ (Indicator Question)



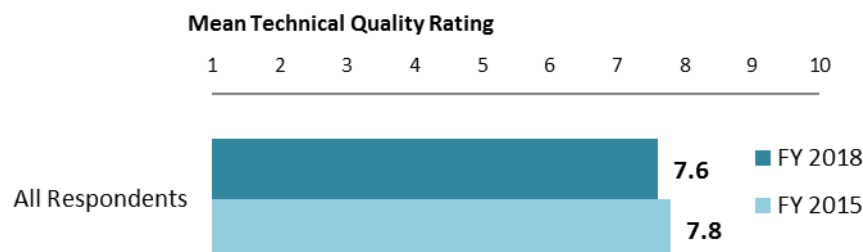

Technical Quality of the WBG's Knowledge Work and Activities (Indicator Question)



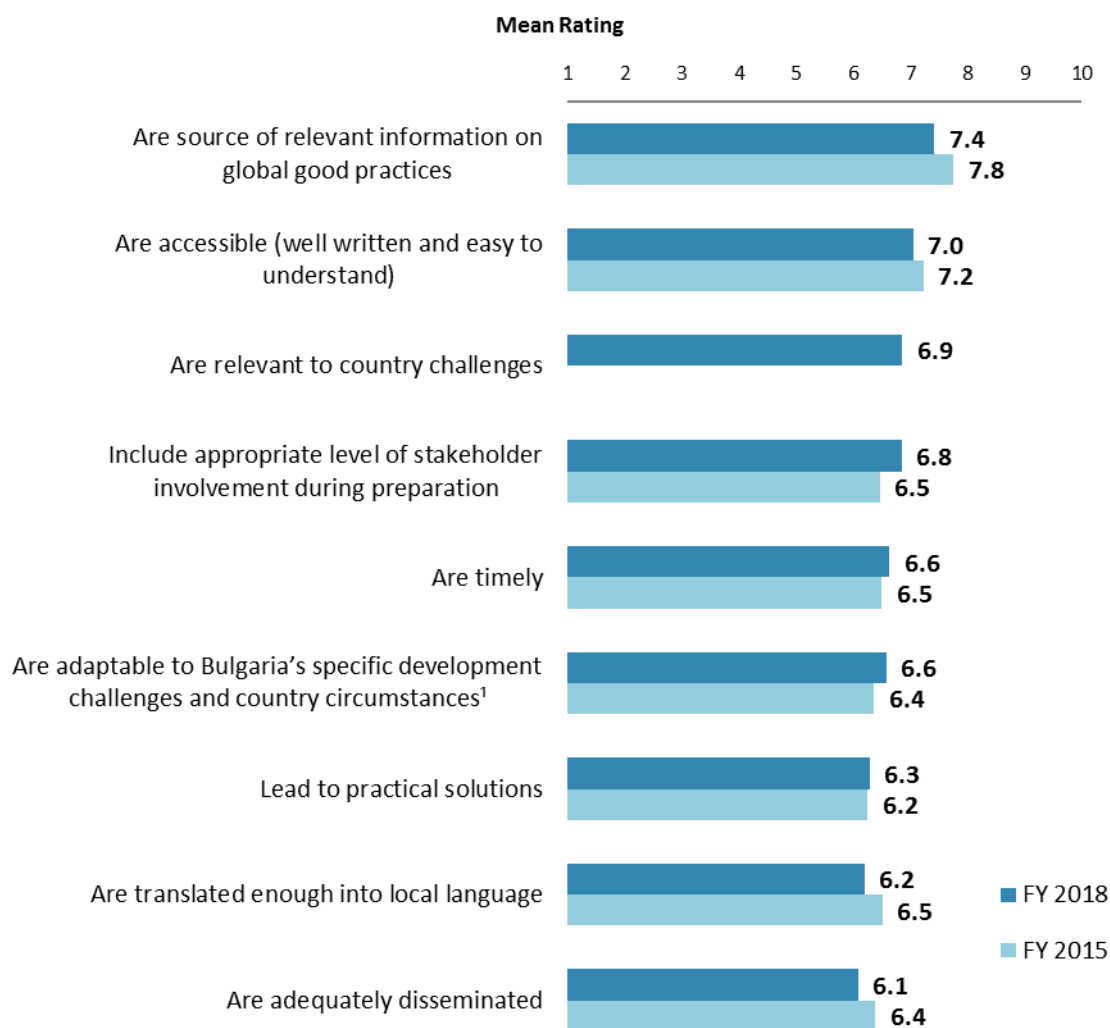

"In Bulgaria, to what extent do you believe that the World Bank Group's knowledge work and activities:" (1-"To no degree at all", 10-"To a very significant degree")

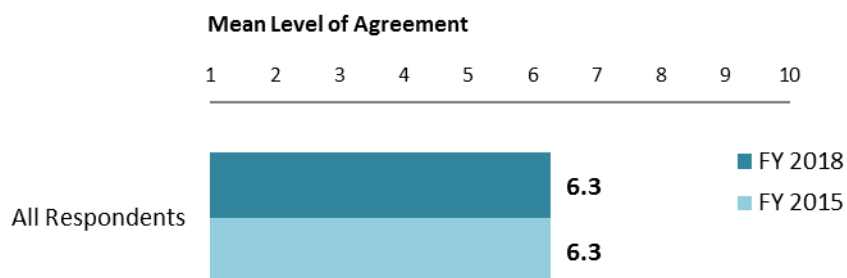

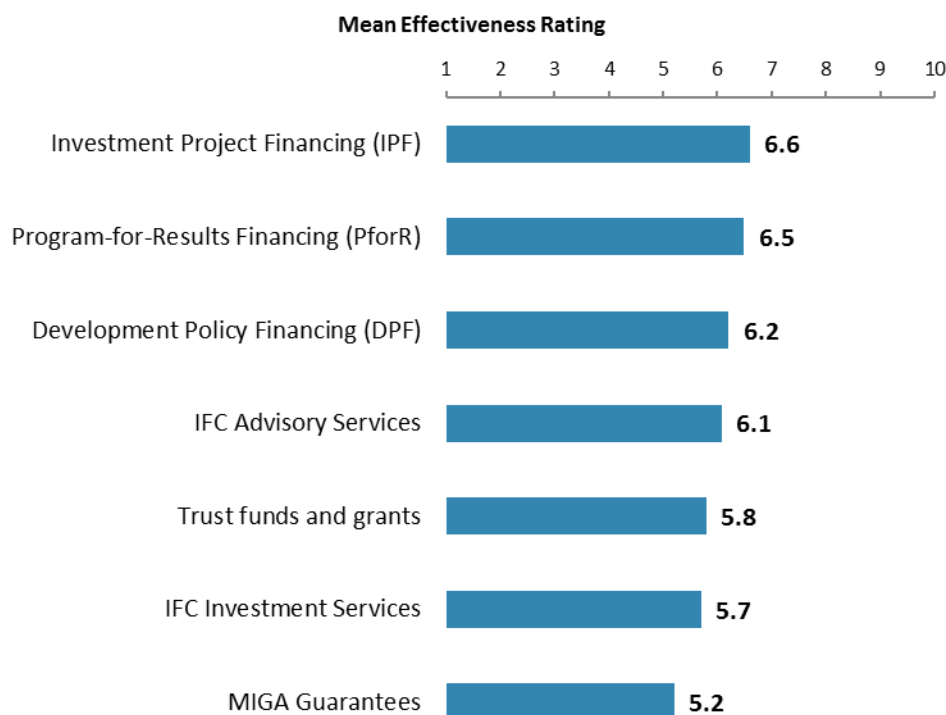

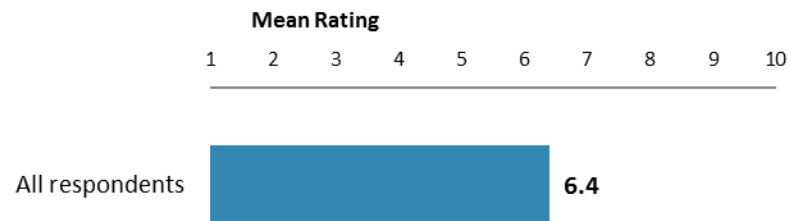
"How effective do you believe the following World Bank Group's instruments are in supporting the Bulgaria Government's efforts to reduce poverty?"

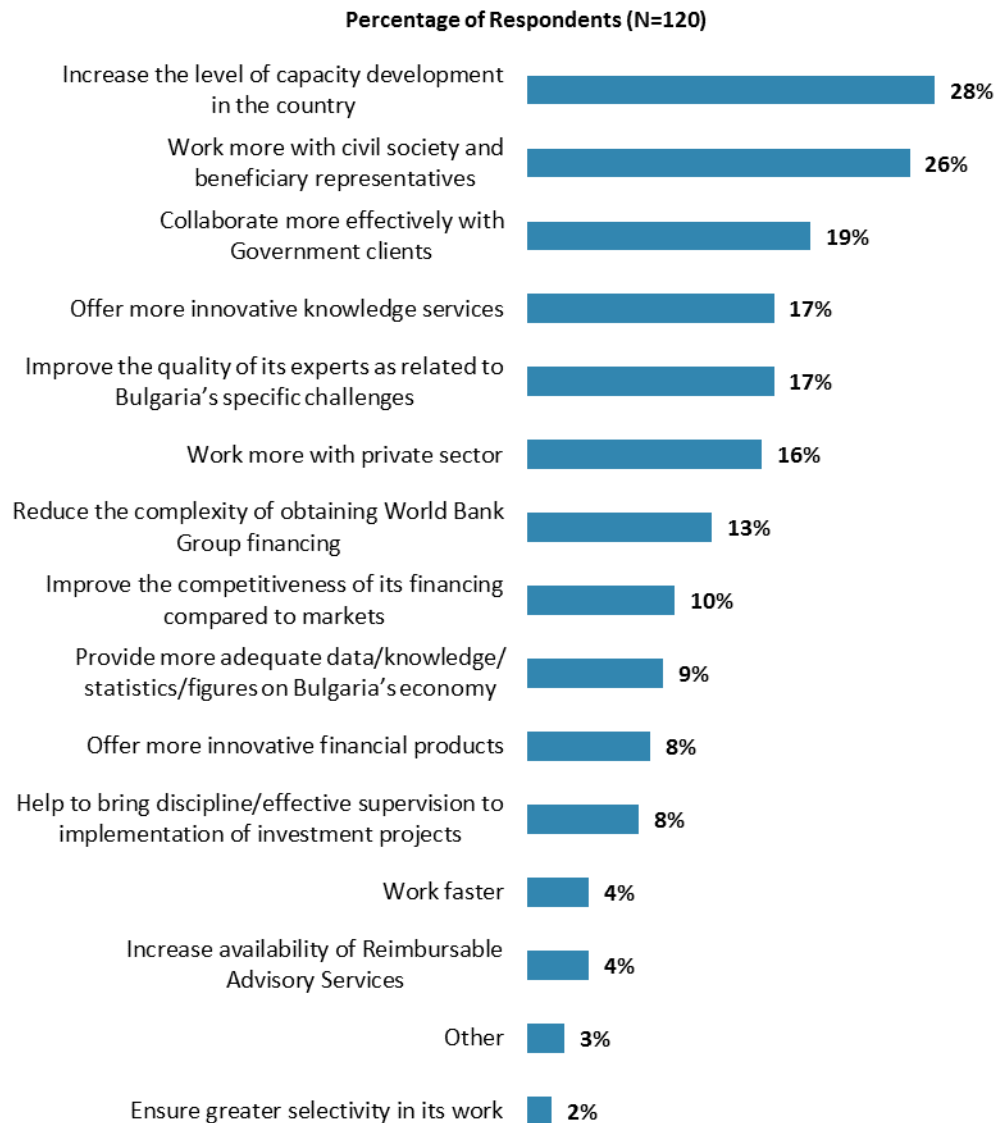

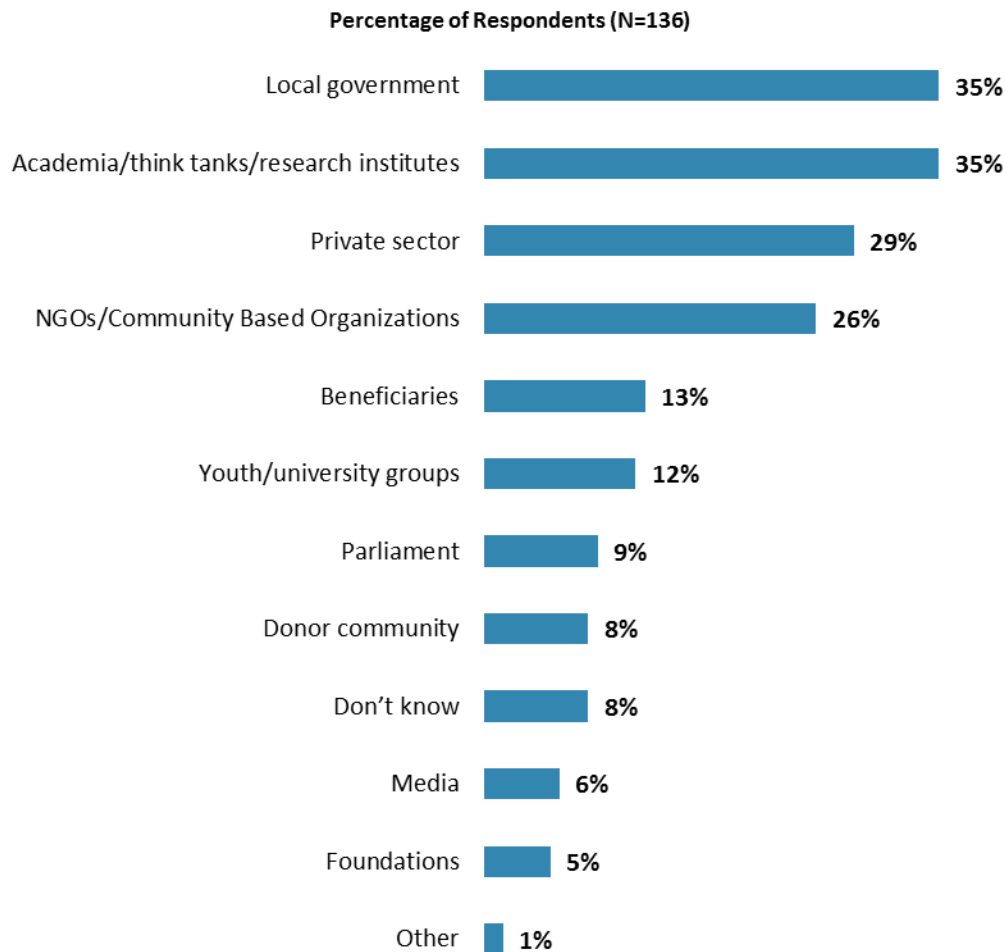

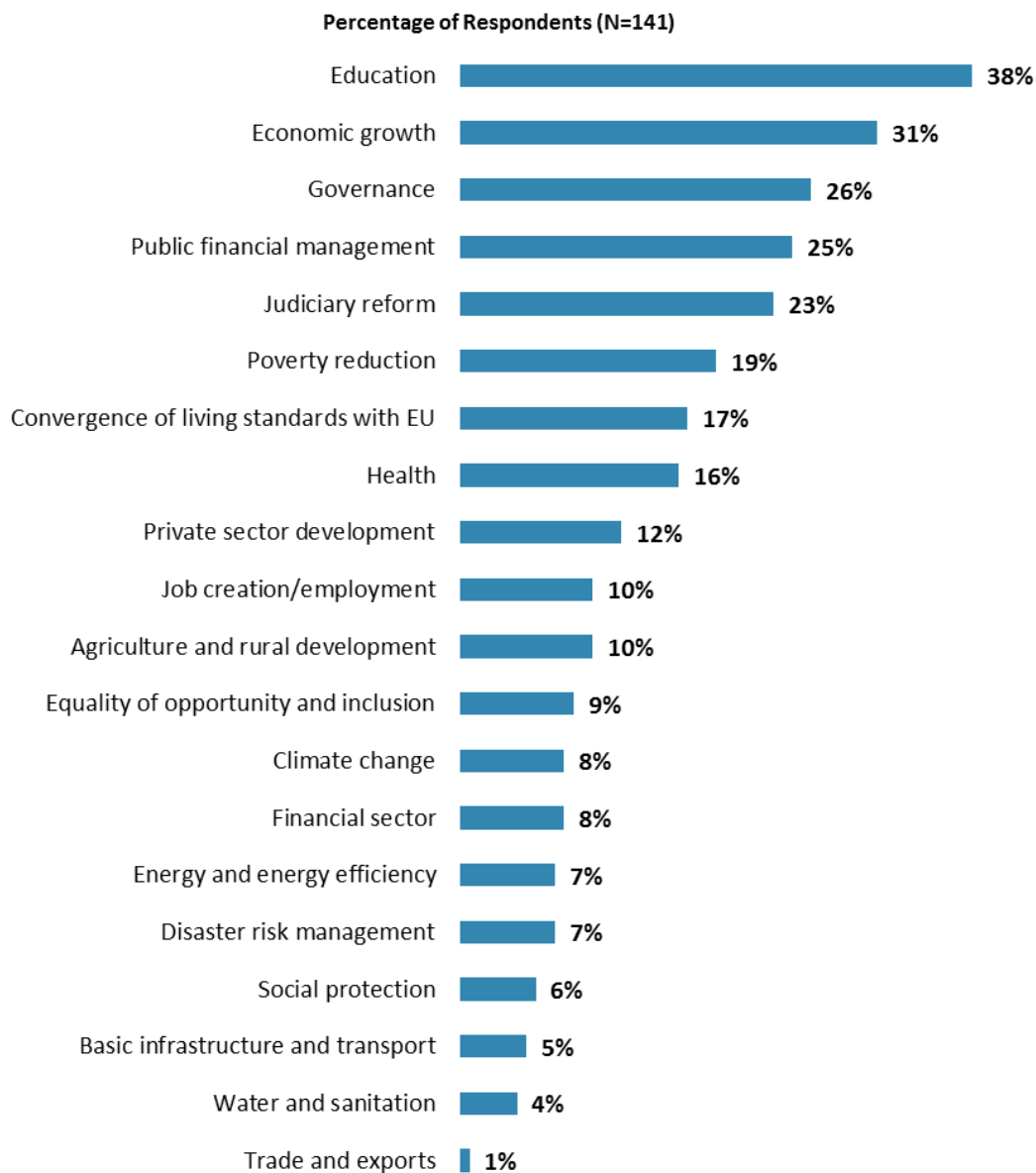
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country?"

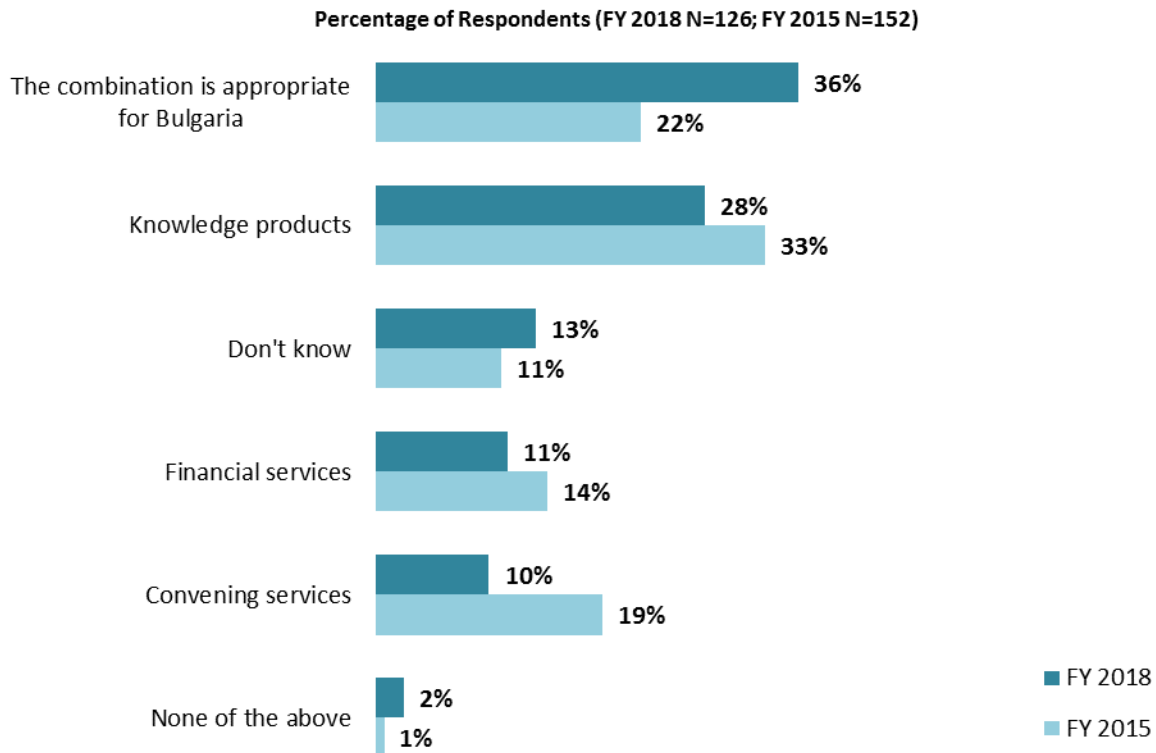

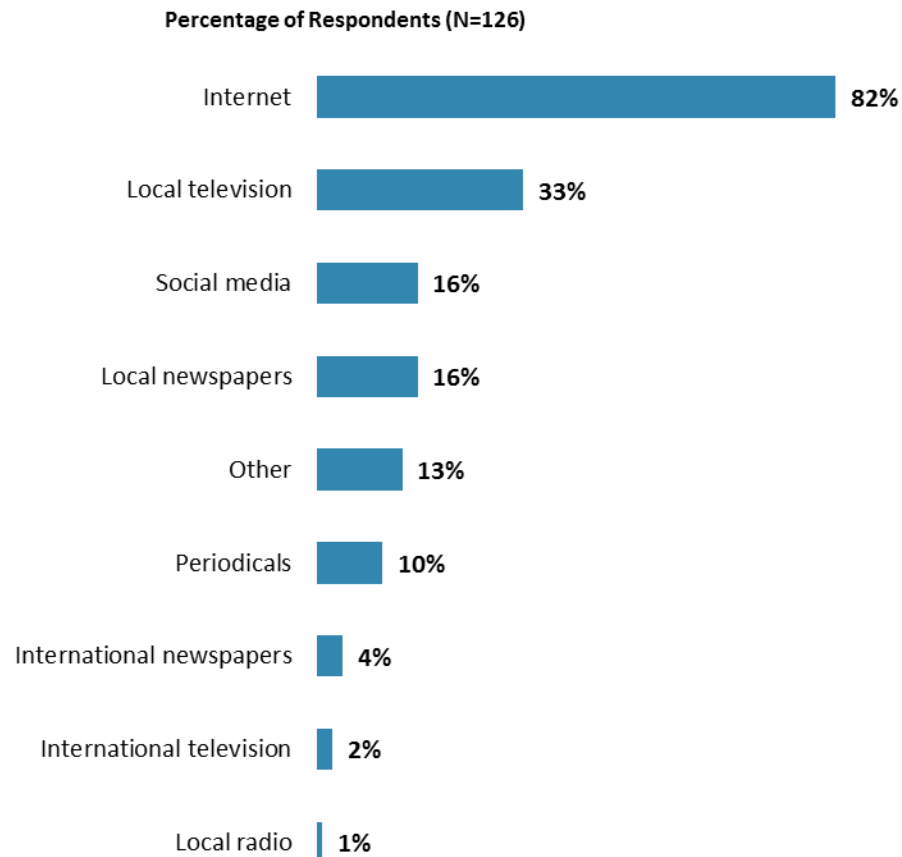

"How do you get most of your information about economic and social development issues in Bulgaria? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

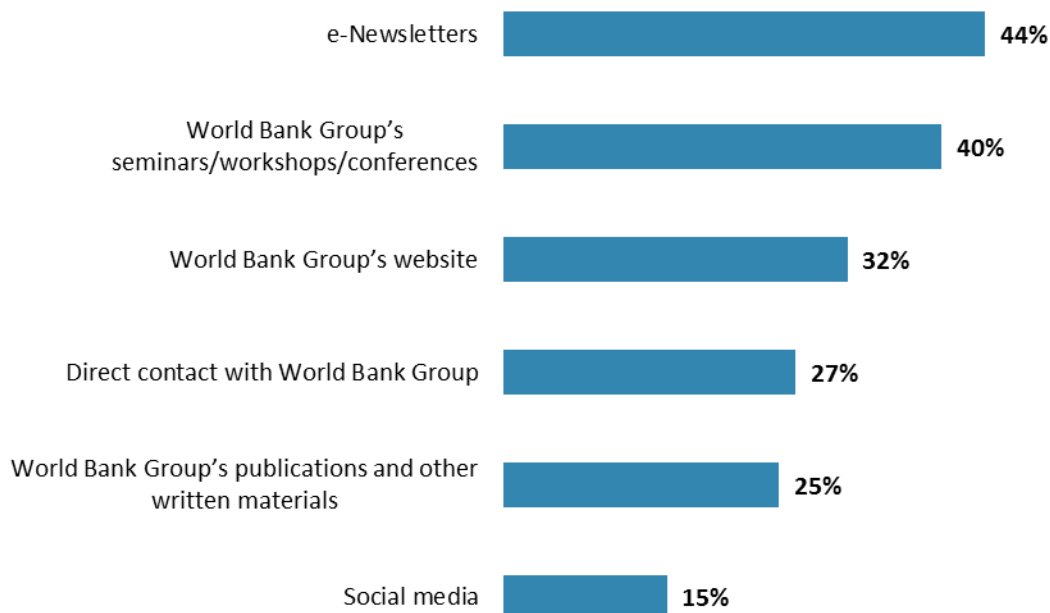

Percentage of Respondents (N=126)

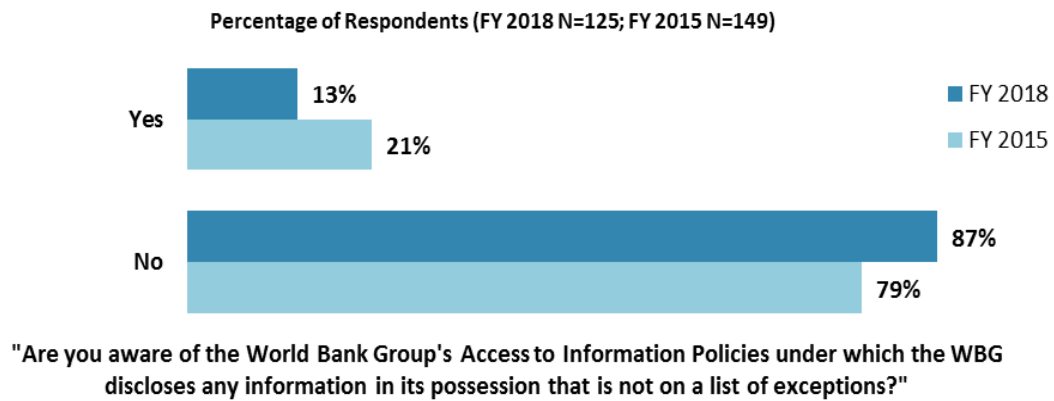


**"How would you prefer to receive information from the World Bank Group?
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)**

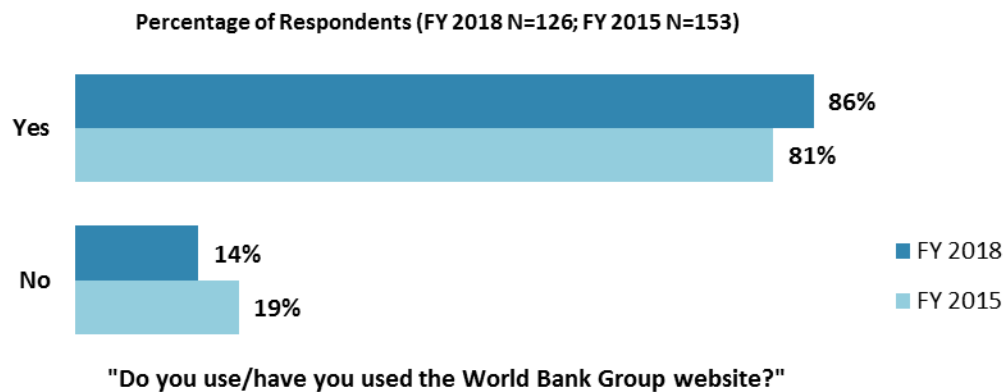

The WBG Website Usage

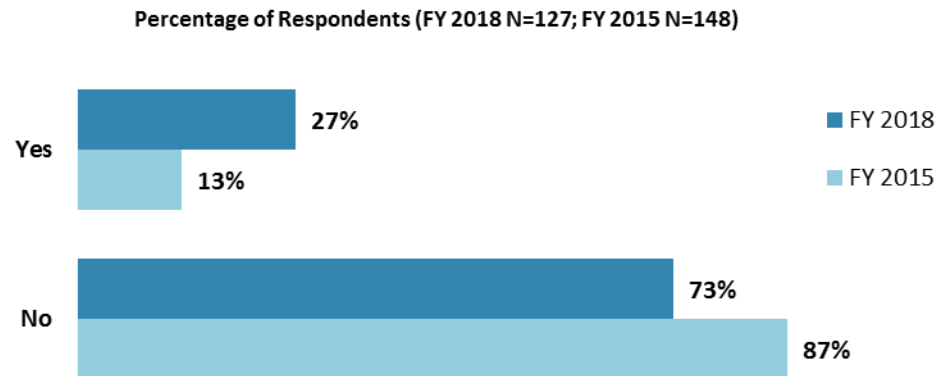

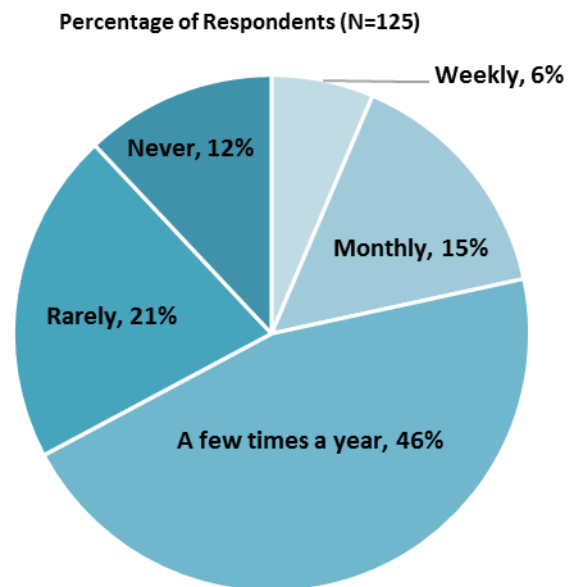
