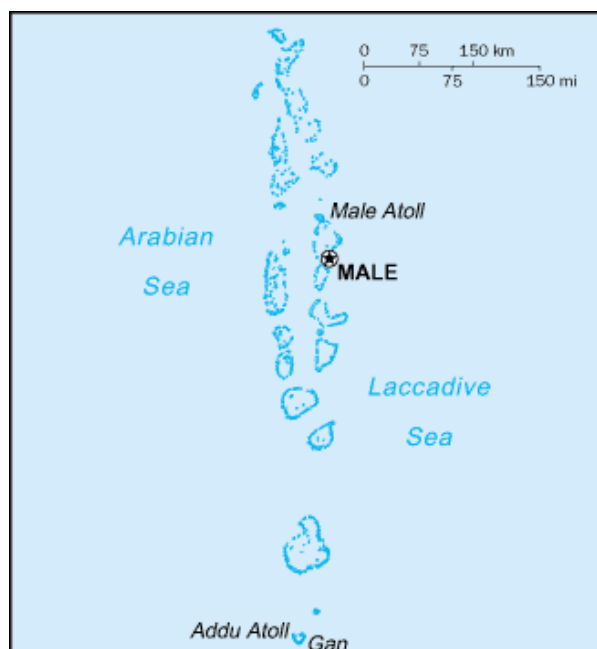

## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Maldives perceive the WBG. The survey explored:

- *General Issues Facing Maldives*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Maldives*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From June to July 2018, 307 stakeholders of the WBG in Maldives were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a Minister; office of a Parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral and multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs and community-based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

A total of 106 stakeholders participated in the survey (35% response rate). Respondents received the questionnaires via courier or received the questionnaires via the online survey platform Qualtrics.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'14 (response rate was 35%, N=104). Data were weighted to reach the same stakeholder composition in both years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'14 COS report and the non-weighted data presented in appendices A, B, C, and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 71).

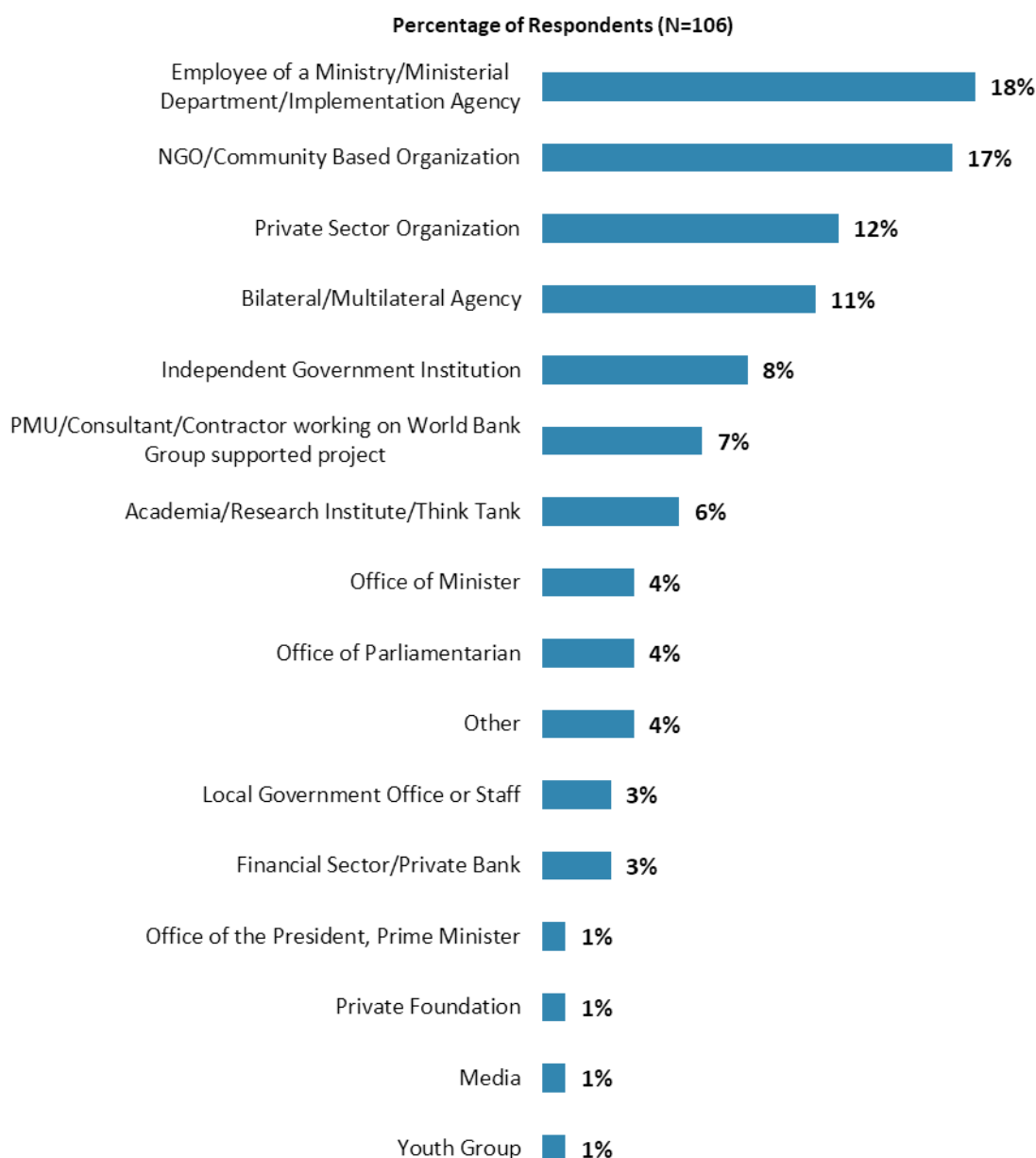

### III. Demographics of the Sample

#### Current Position

- For further analyses, respondents from the Office of the President, Prime Minister and the office of a minister were combined; respondents from the financial sector/private banks were combined with those from private sector organizations; respondents from NGOs/community based organizations, private foundations, and youth groups were combined in the “CSO” category; and the small number of respondents from the office of a parliamentarian, local government, and the media were included in the “Other” category. There were no respondents from trade unions, faith-based groups, and judiciary branch.



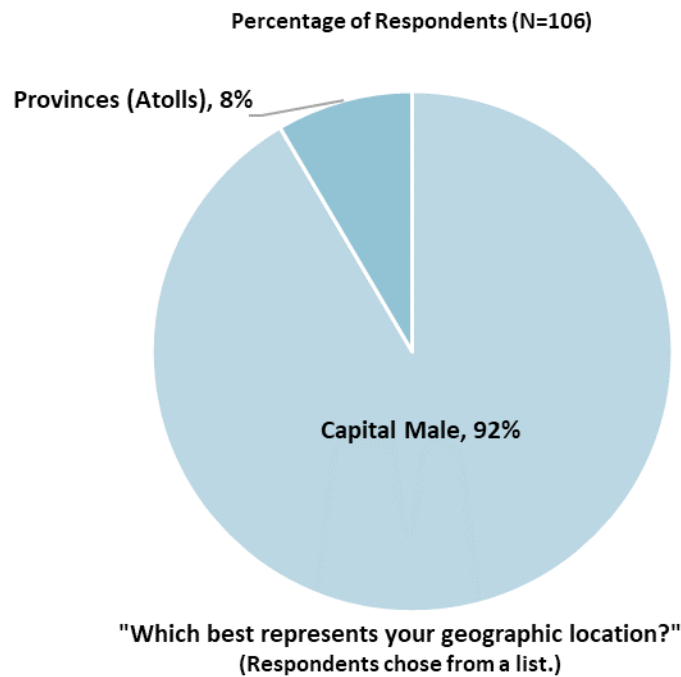
“Which of the following best describes your current position?” (Respondents chose from a list.)

- Because of the small number of respondents from provinces (atolls), comparisons of geographic locations were not conducted.

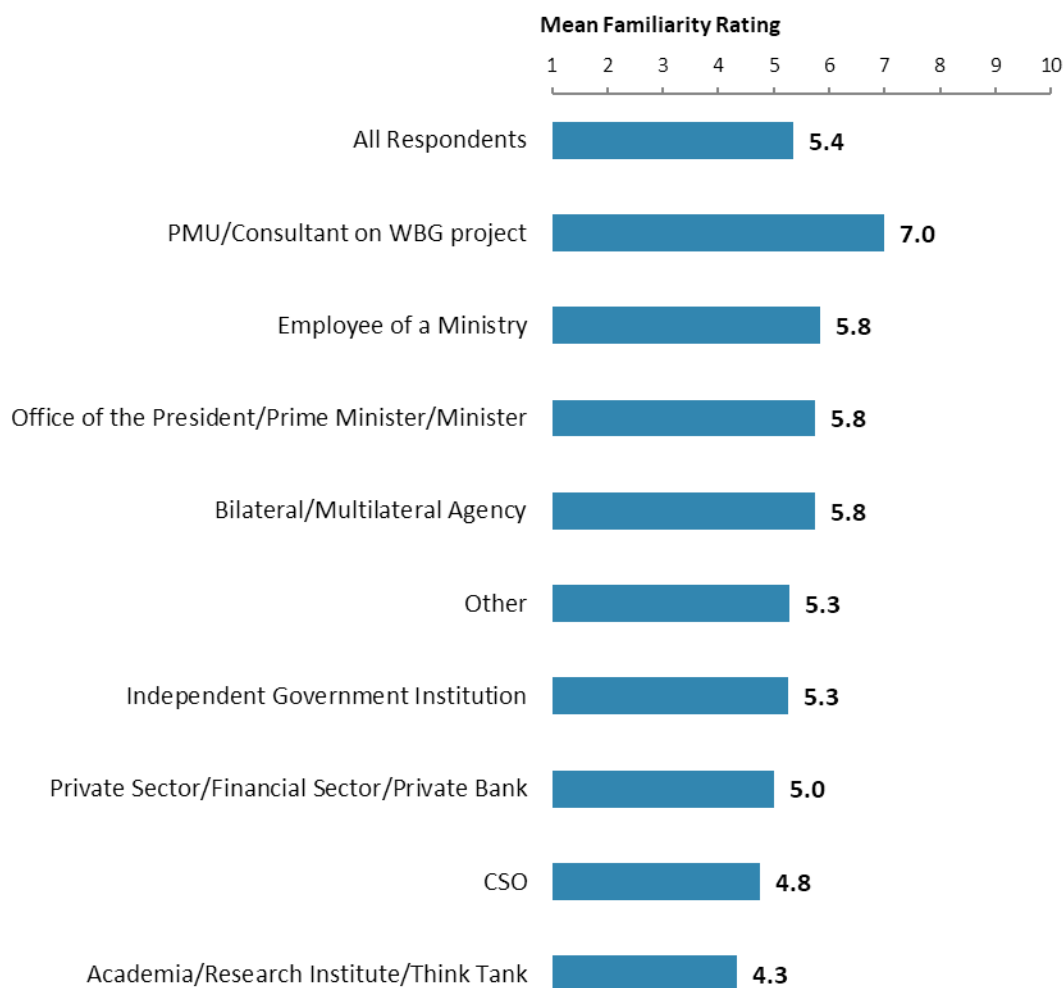




### III. Demographics of the Sample (continued)

- Respondents' levels of familiarity with the WBG were significantly correlated with their ratings of the WBG's overall effectiveness in Maldives.



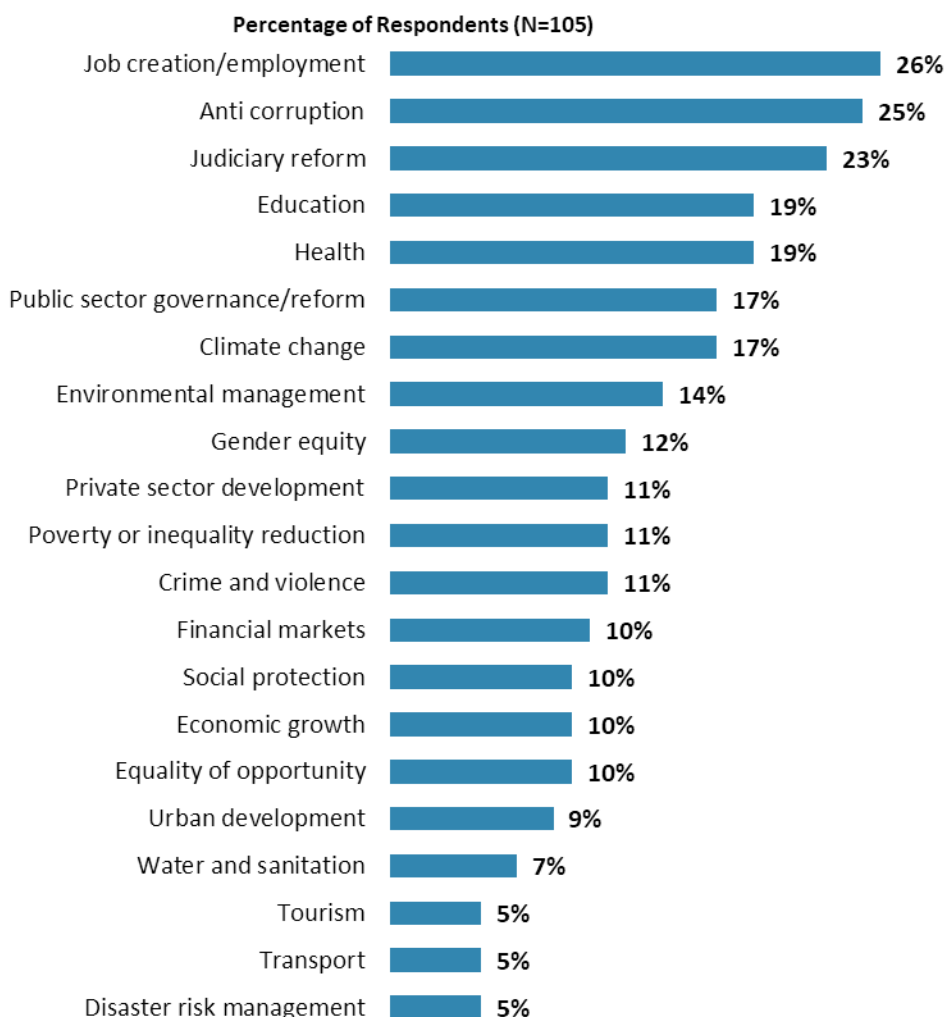
**"How familiar are you with the work of the World Bank Group in Maldives?"**

## IV. General Issues Facing Maldives

### Development Priority

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the most important development priorities in Maldives were “*law and justice*” (30%), “*macroeconomic management/fiscal sustainability*” (27%), and “*anti-corruption*” (25%).
- **Specialization:** Respondents who identified their primary specialization of work as “*education*” (17% of the sample) were significantly more likely to indicate that “*job creation/employment*” and “*education*” were the most important development priorities in Maldives, compared to the rest of respondents in other areas of work (education specialists = 44% and 39%; others = 22% and 15%, respectively).

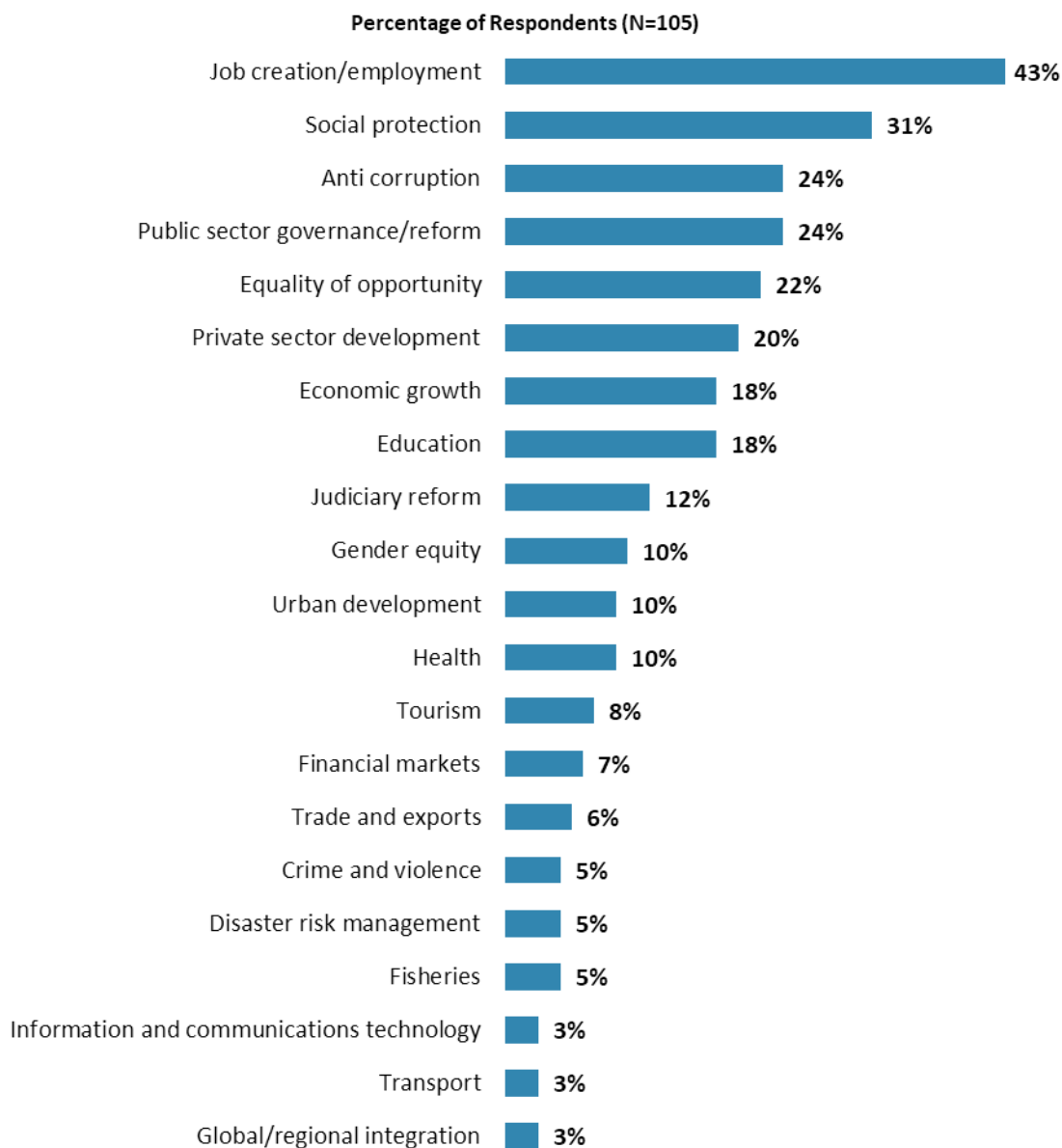




## IV. General Issues Facing Maldives (continued)

### What Would Contribute Most to Reducing Poverty

- **Year comparison:** In the previous FY'14 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Maldives were “*job creation/employment*” (33%), “*economic growth*” (29%), and “*equality of opportunity*” (22%).

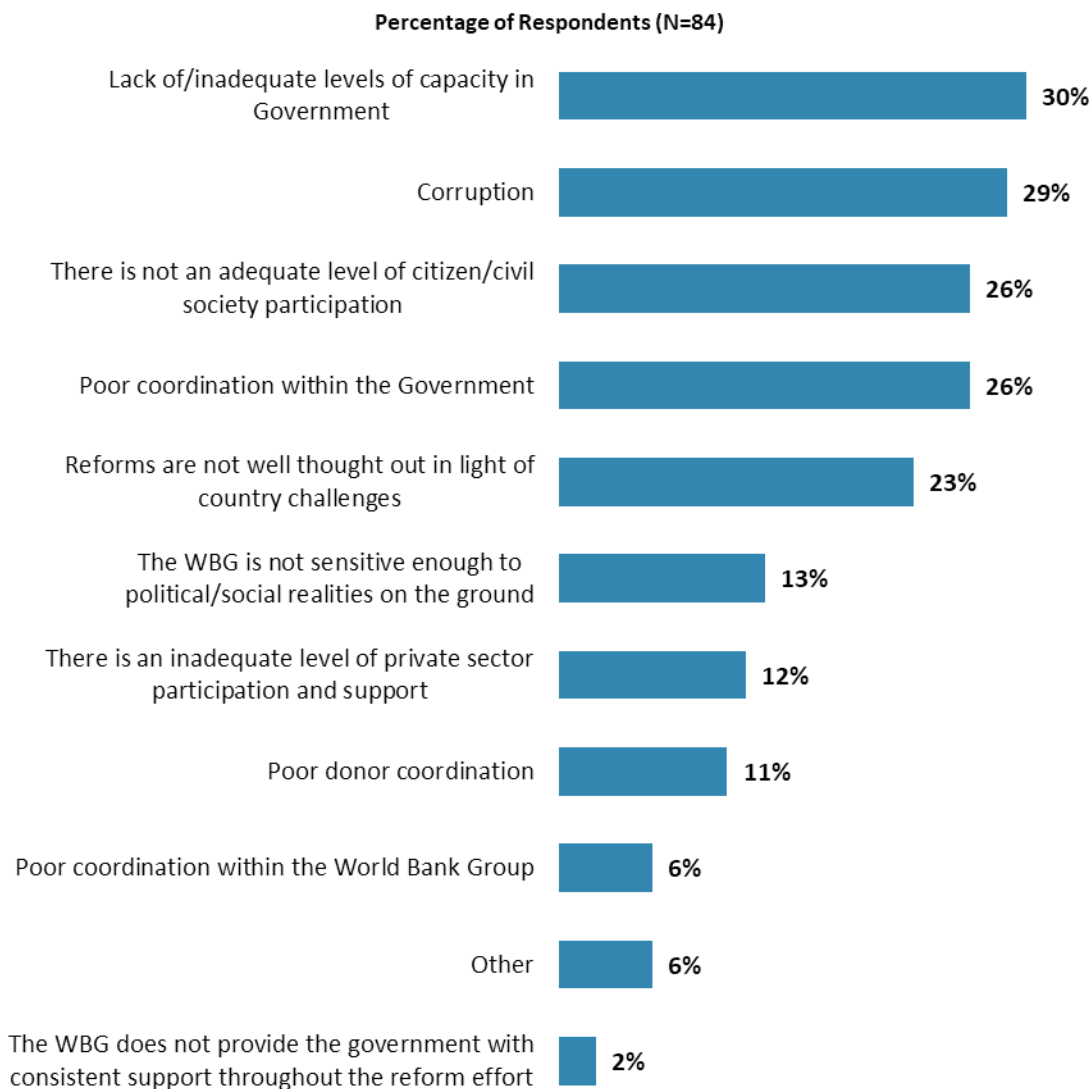

## V. Overall Attitudes toward the World Bank Group

### Attributing Failed/Slow Reform Efforts

- **Year comparison:** Respondents in the previous FY'14 Country Survey most often attributed failed or slow WBG assisted reform efforts to “*lack of/inadequate levels of capacity in Government*” (34%), that “*there is not an adequate level of citizen/civil society participation*” (29%), that “*the Government works inefficiently*” (29%), and that “*reforms are not well thought out in light of country challenges*” (28%).

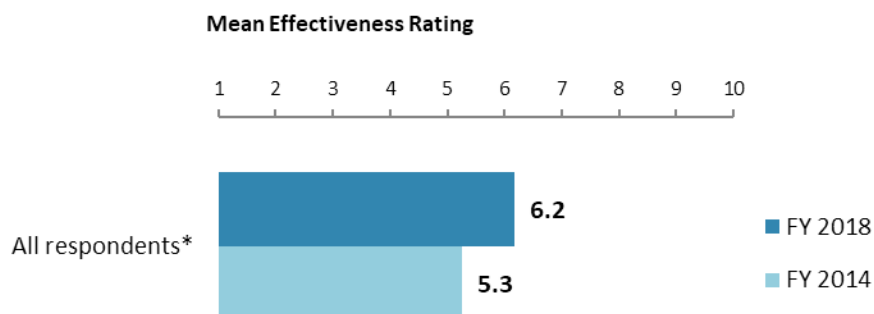


**"When World Bank Group assisted reform efforts fail or are slow to take place, which of the following would you attribute this to? (Choose no more than TWO)"**

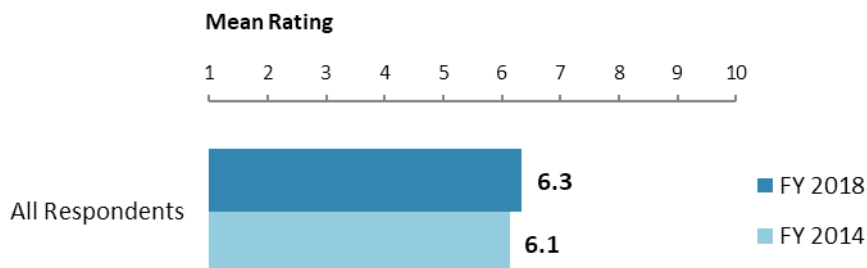

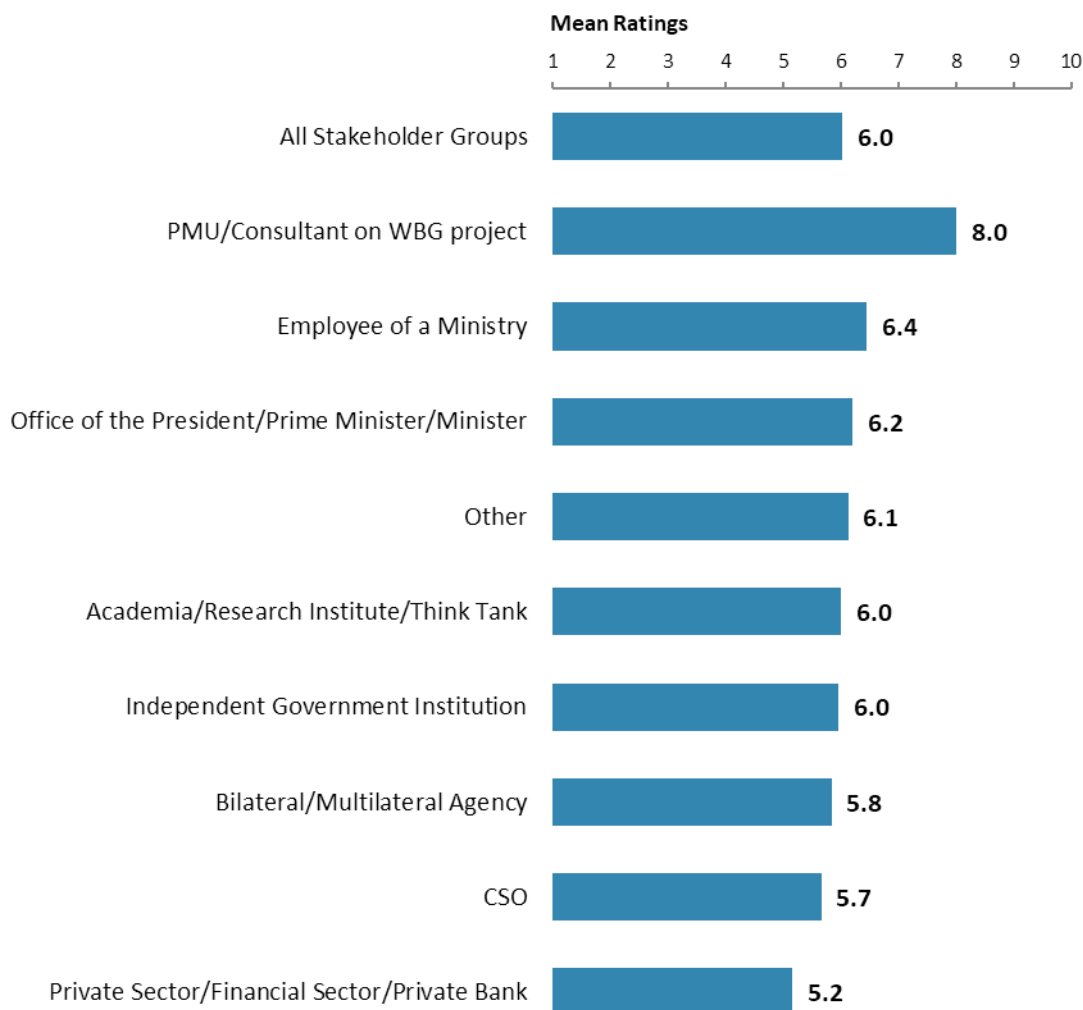

### Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholder groups:** Respondents from PMUs/consultants on WBG projects had the highest mean ratings for the aggregated responses to the twenty-six COS indicator questions, whereas respondents from private sector/financial sector/private bank had significantly lower mean ratings. 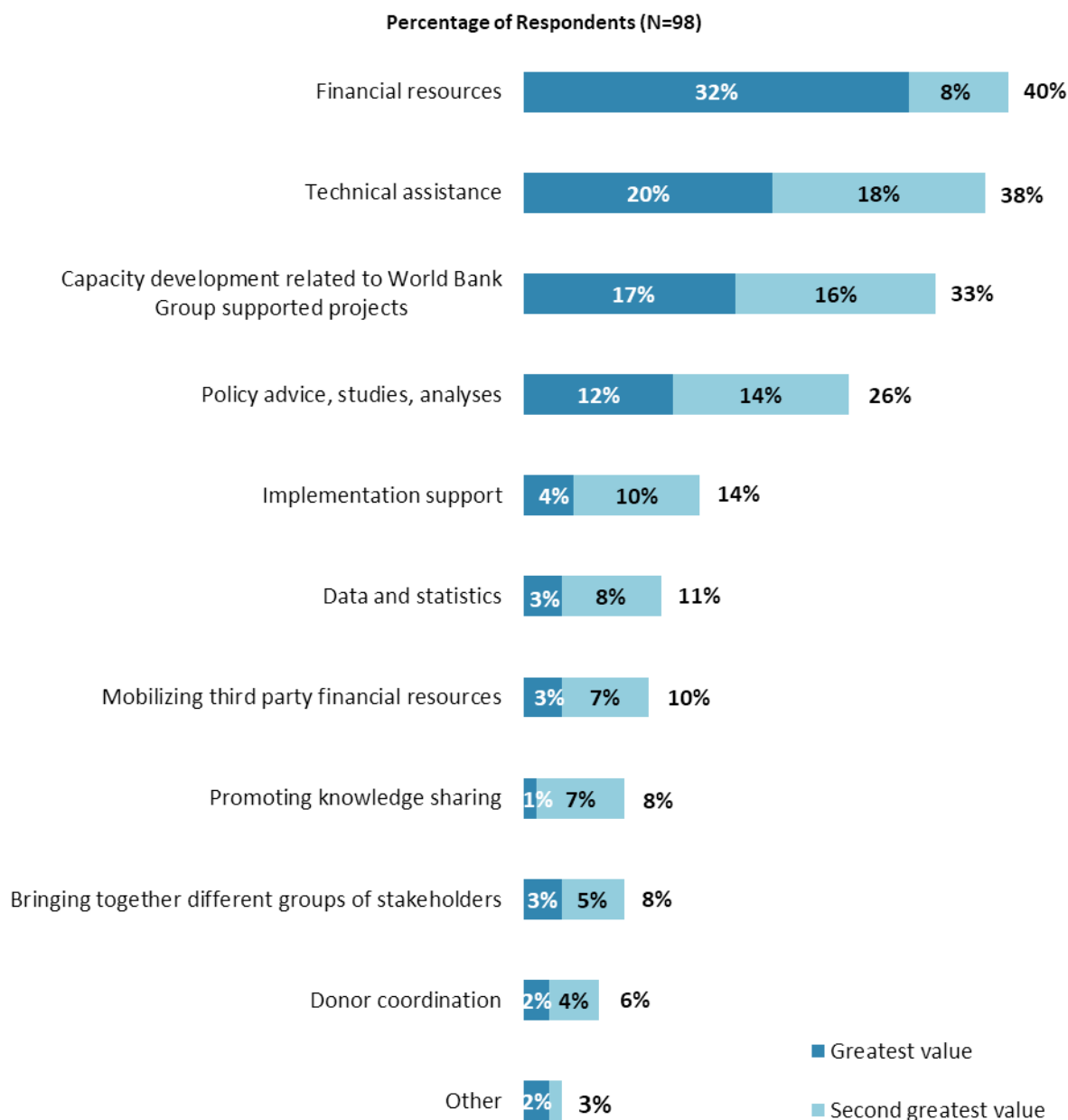
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

### Greatest Value

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the WBG's greatest values to Maldives were "*capacity development*" (43%), "*financial resources*" (43%), and "*technical assistance*" (40%).



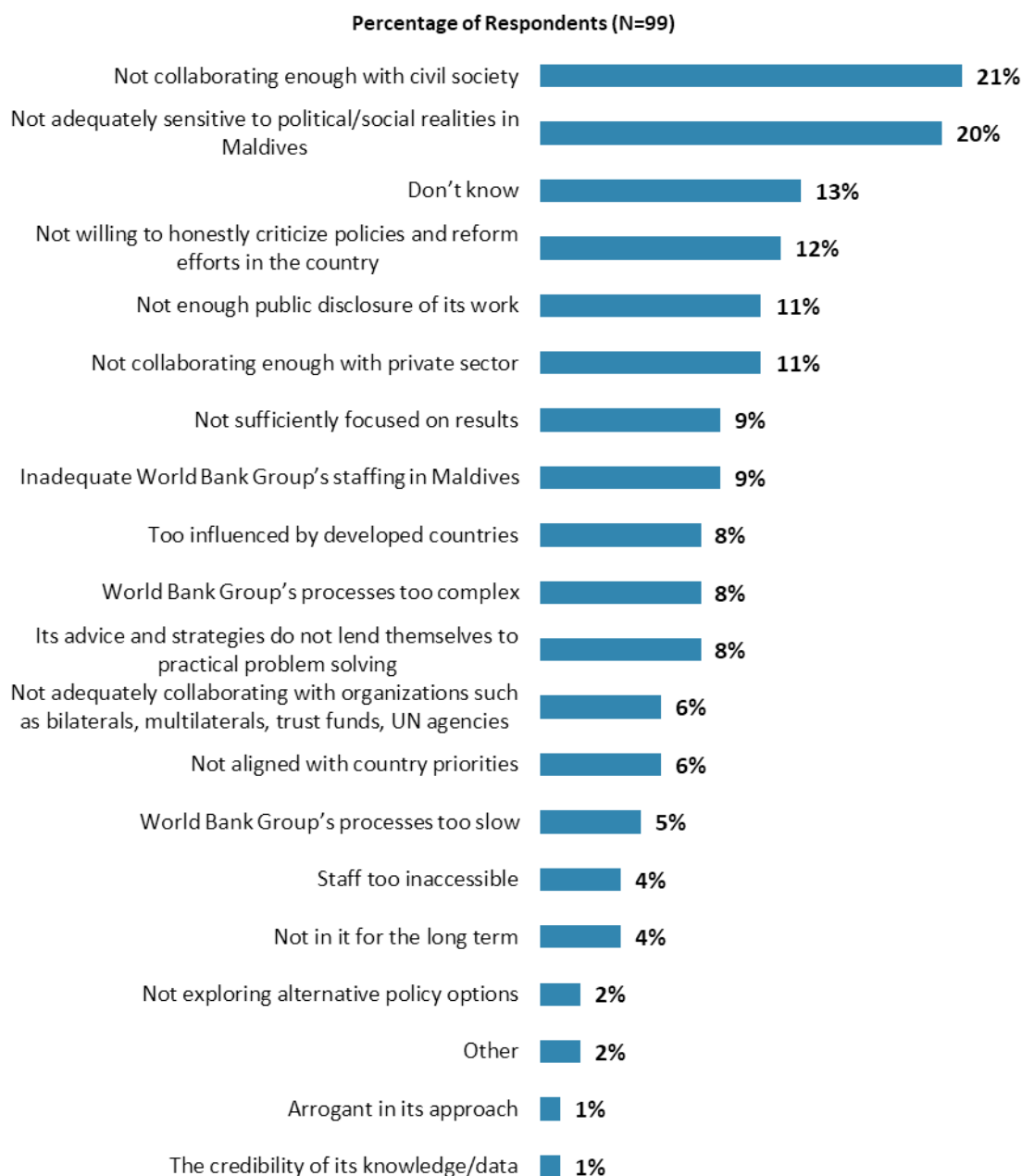
"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Maldives?"

## V. Overall Attitudes toward the World Bank Group (continued)

### Greatest Weakness

- **Year comparison:** Respondents in the previous FY'14 Country Survey indicated that the WBG's greatest weaknesses in its work in Maldives were "*not enough public disclosure of its work*" (32%), "*not adequately sensitive to political/social realities in Maldives*" (19%), and "*not collaborating enough with non-state actors*" (16%).

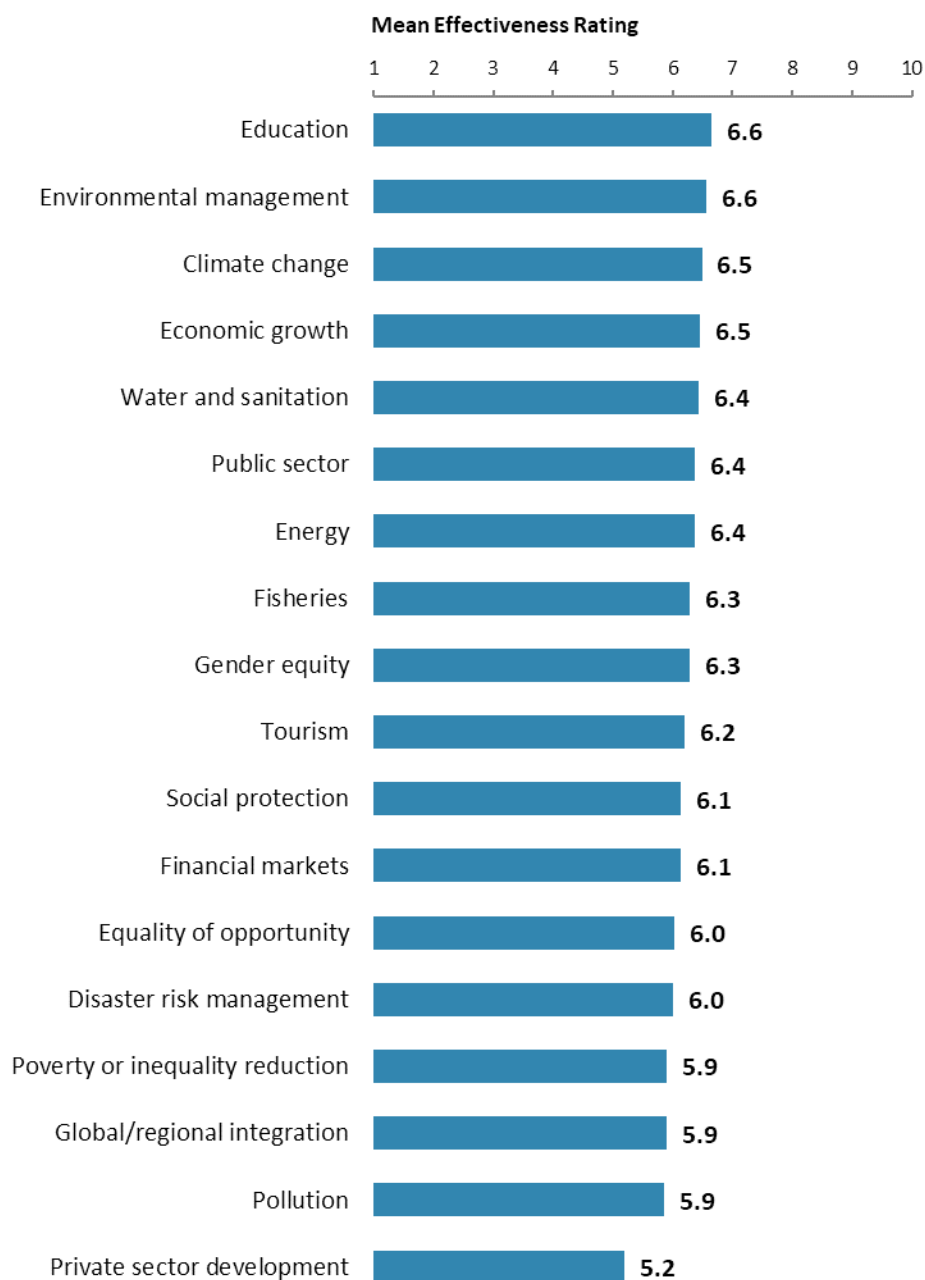

### Effectiveness of WBG's Support in Sectoral Areas<sup>2</sup>



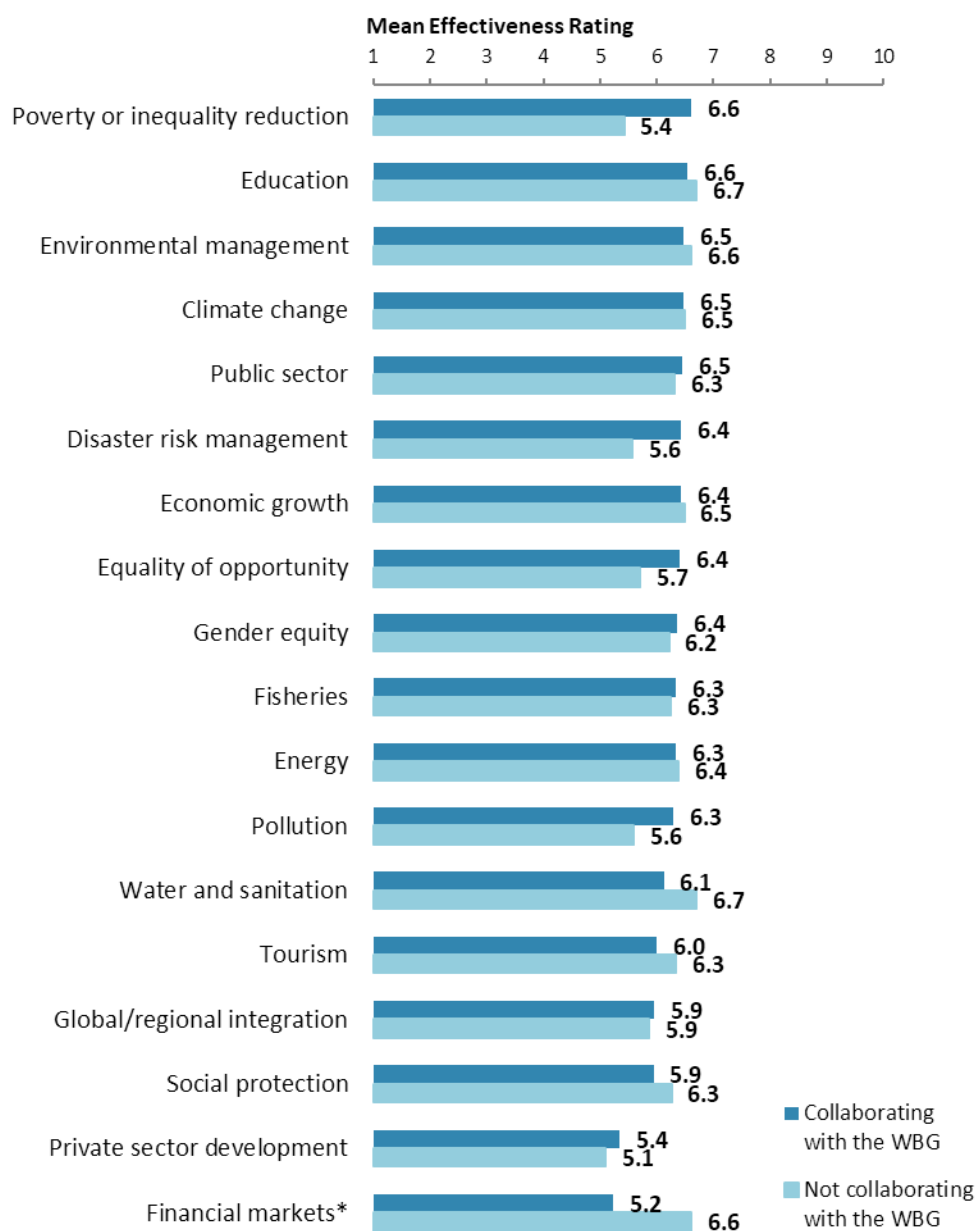

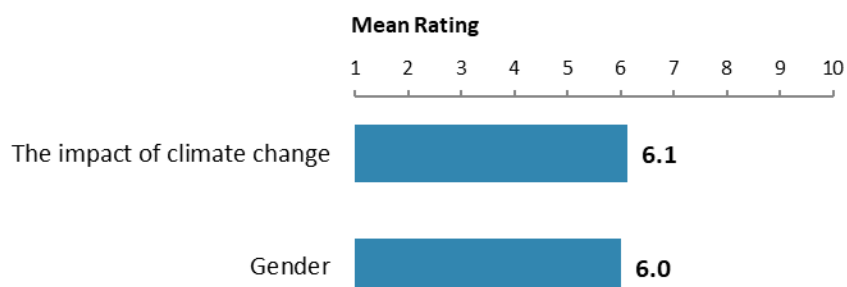

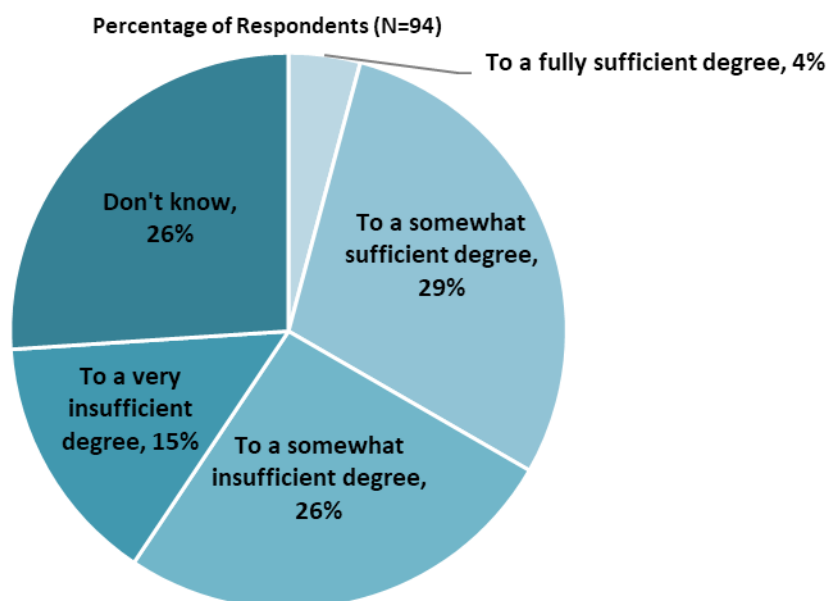

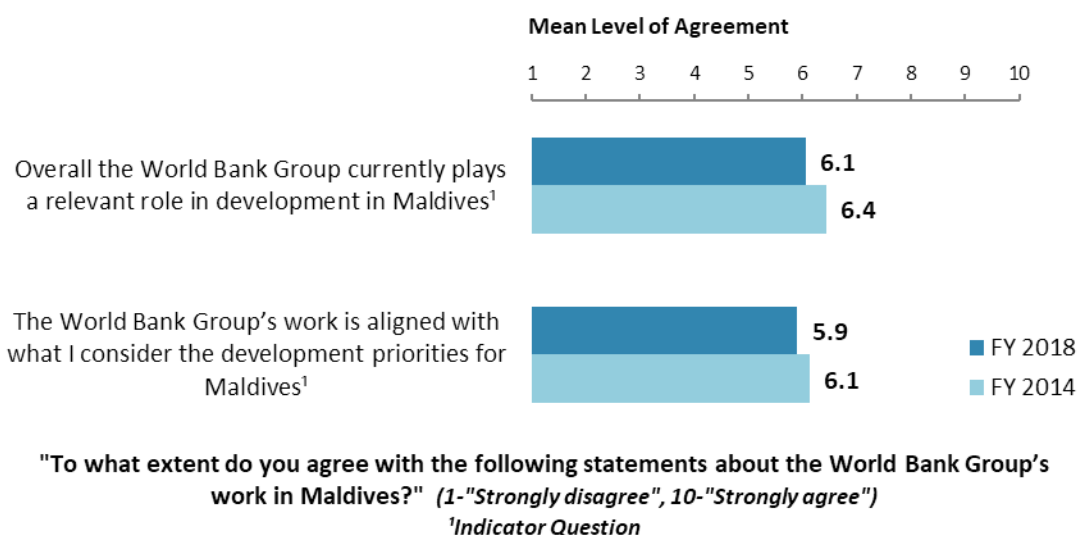


"To what extent do you believe that the World Bank Group's work and support help the poorest in Maldives?" (Respondents chose from a list.)

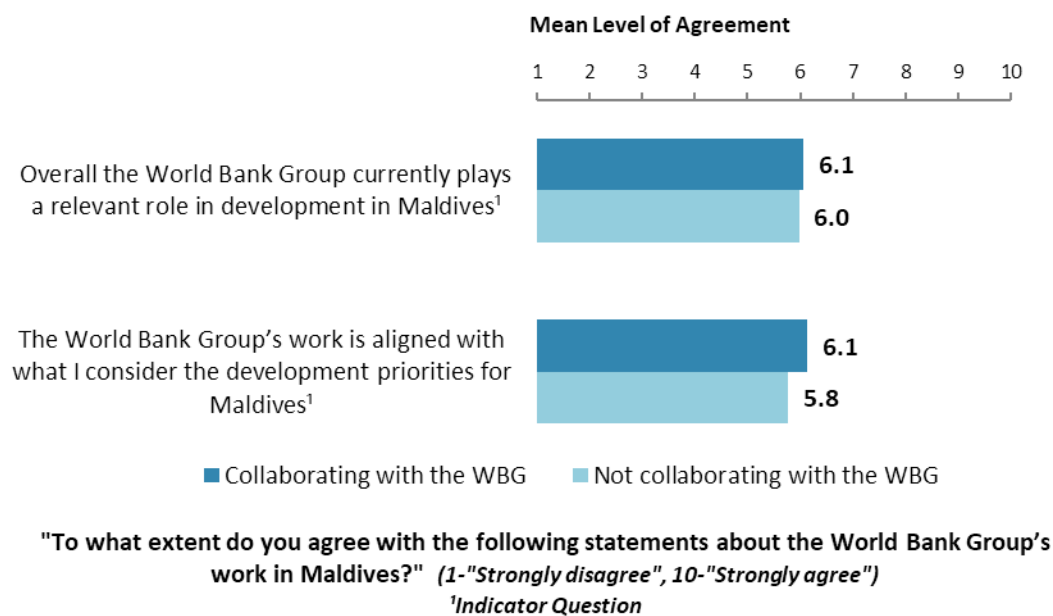

### The World Bank Group's Work in Maldives: Collaboration

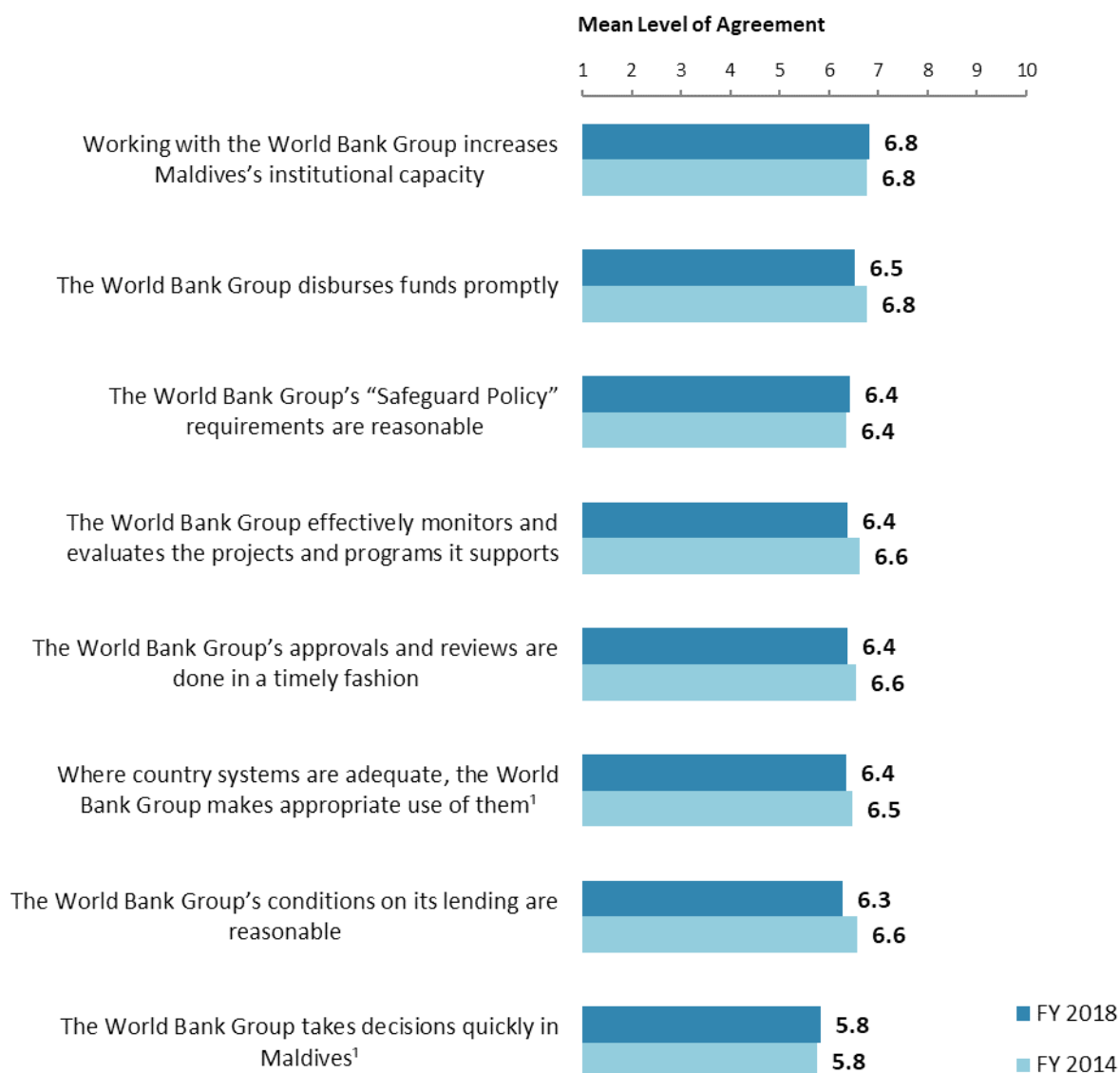

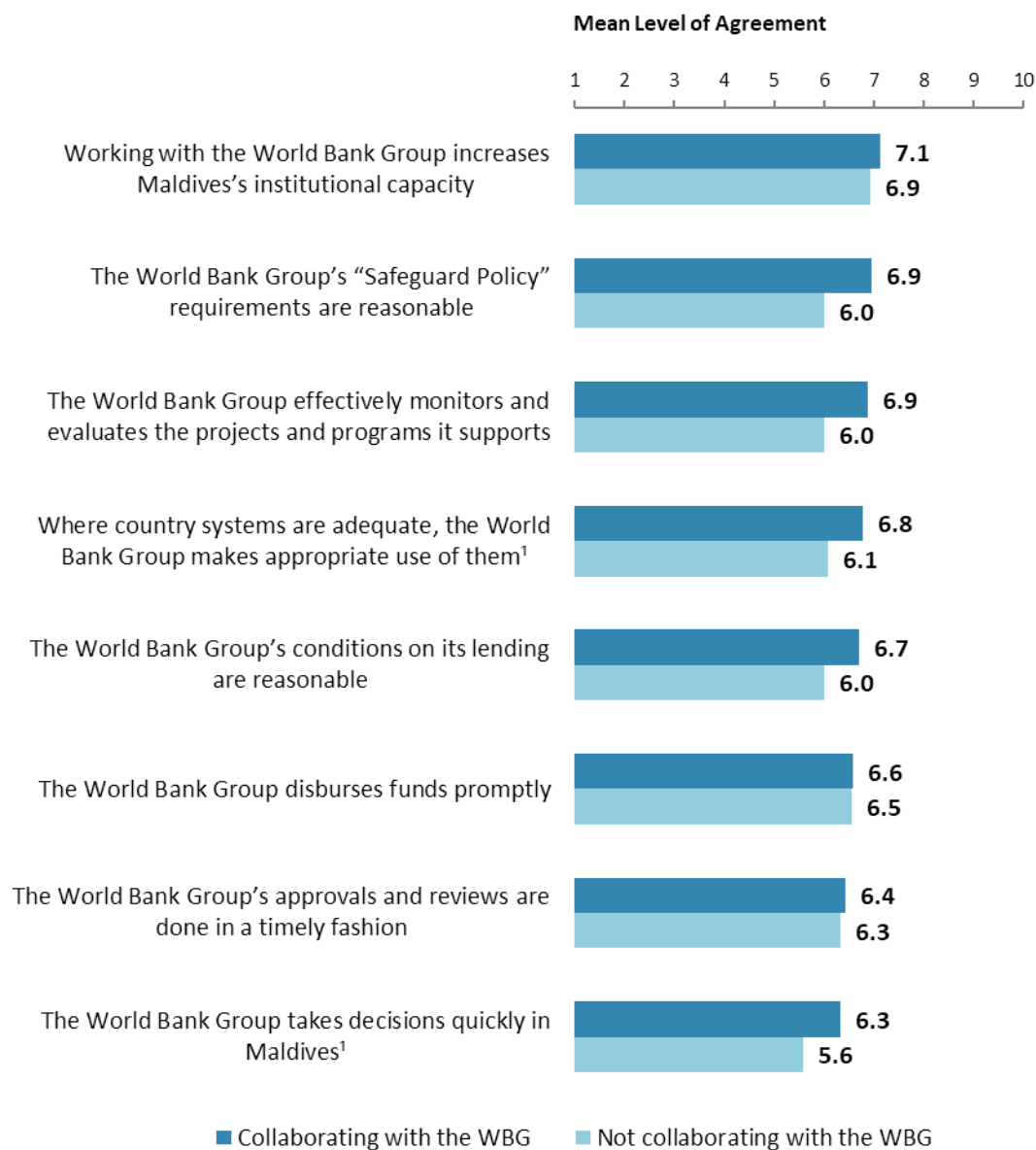

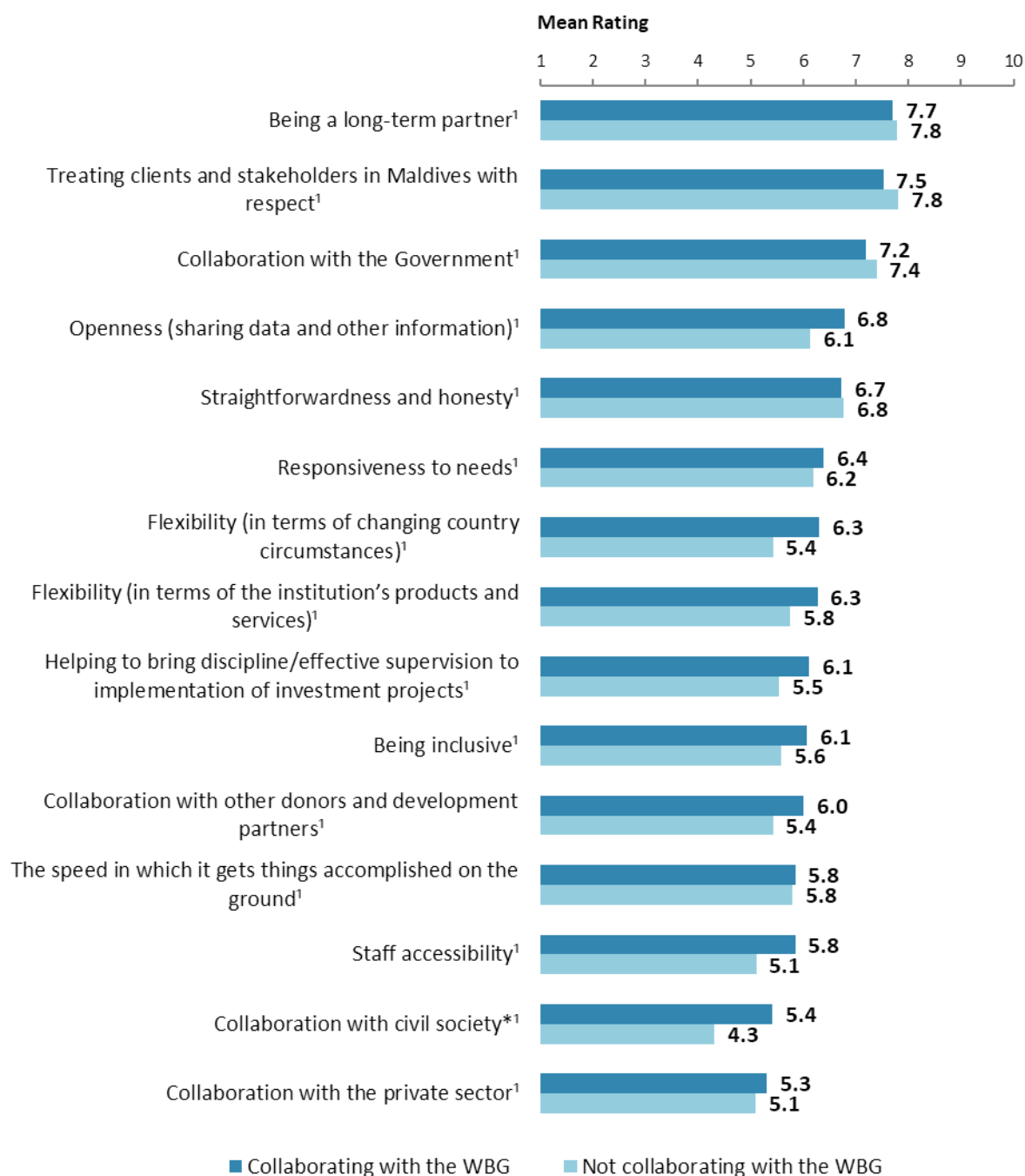

**"To what extent is the World Bank Group an effective development partner in Maldives, in terms of the following?" (1-"To no degree at all", 10-"To a very significant degree")**

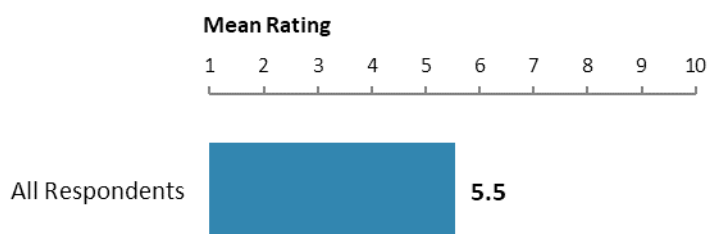

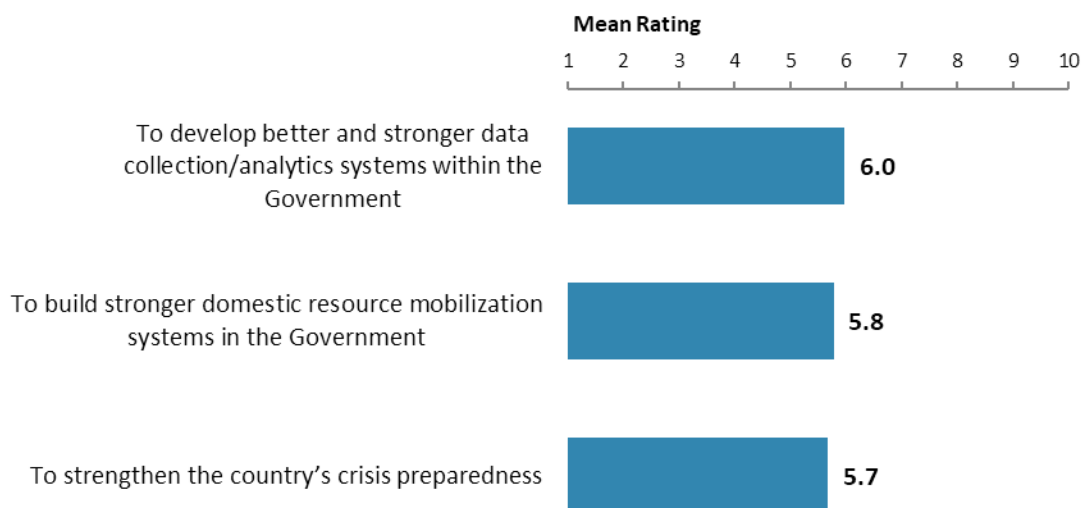

### The World Bank Group's Support to Maldives

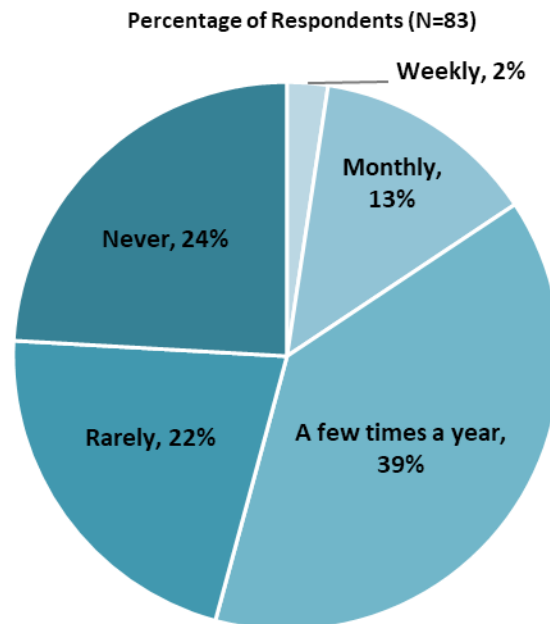


"How effectively does the World Bank Group support Maldives's efforts ... ?" (1-"Not effectively at all", 10-"Very effectively")

### Frequency of Consulting WBG Knowledge Work and Activities



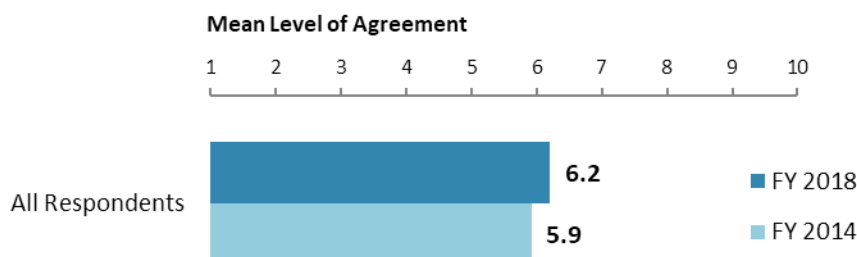
"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"

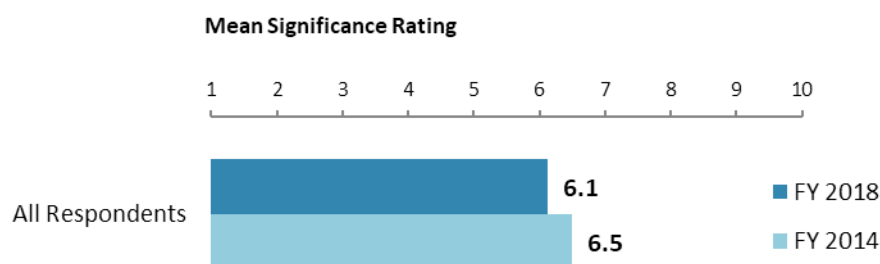

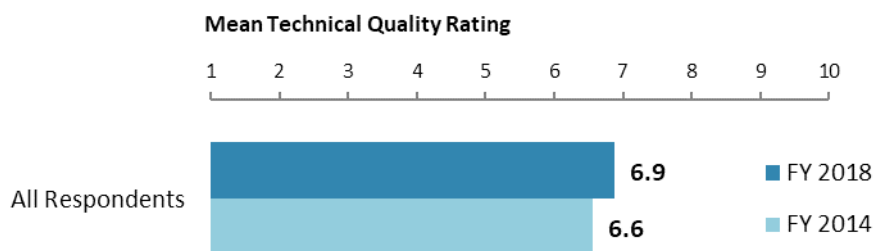

### Technical Quality of the WBG's Knowledge Work and Activities (*Indicator Question*)



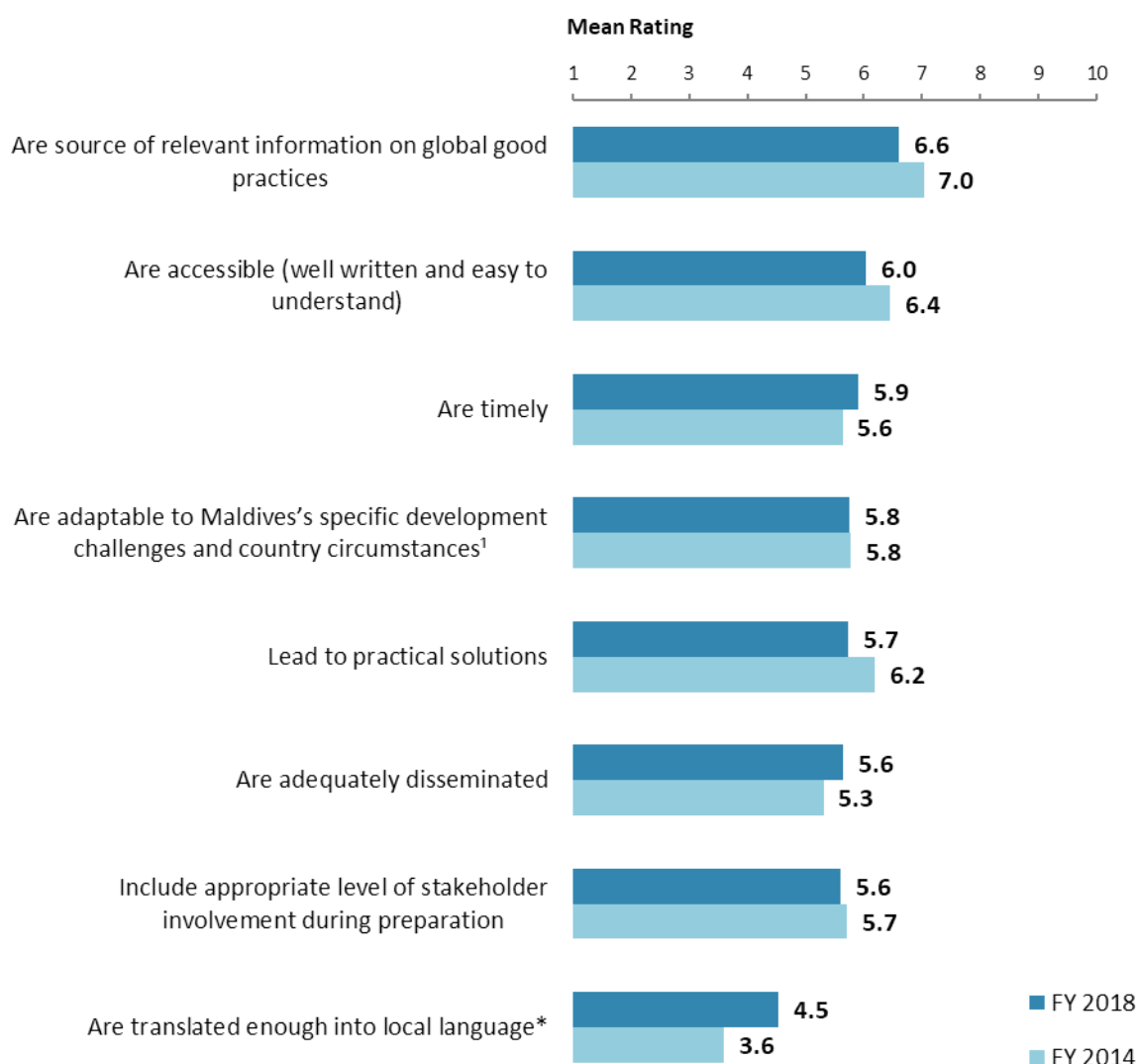

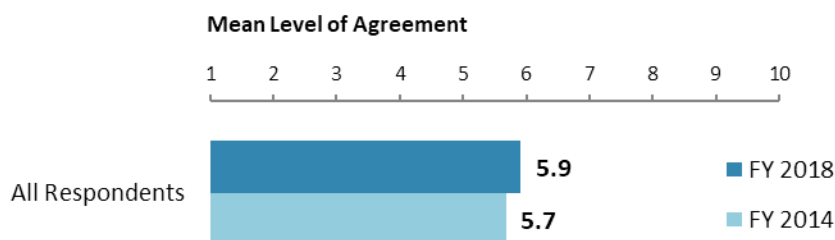

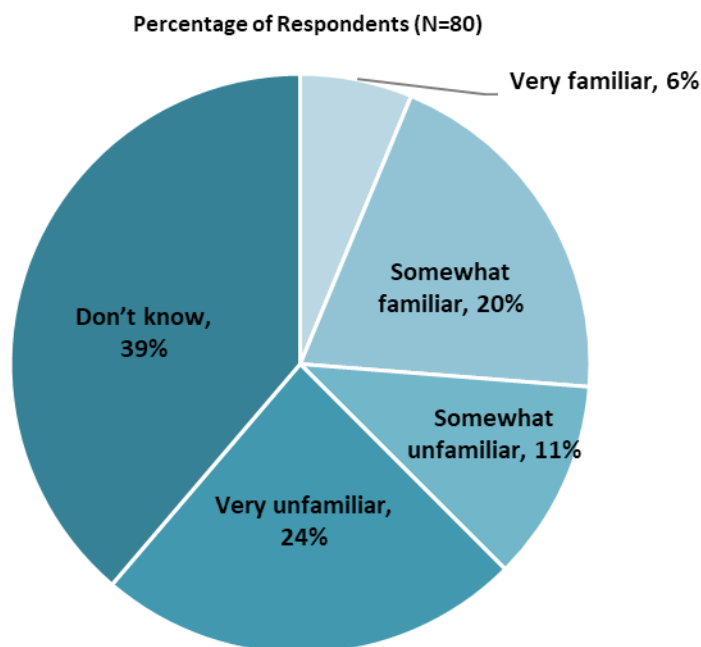

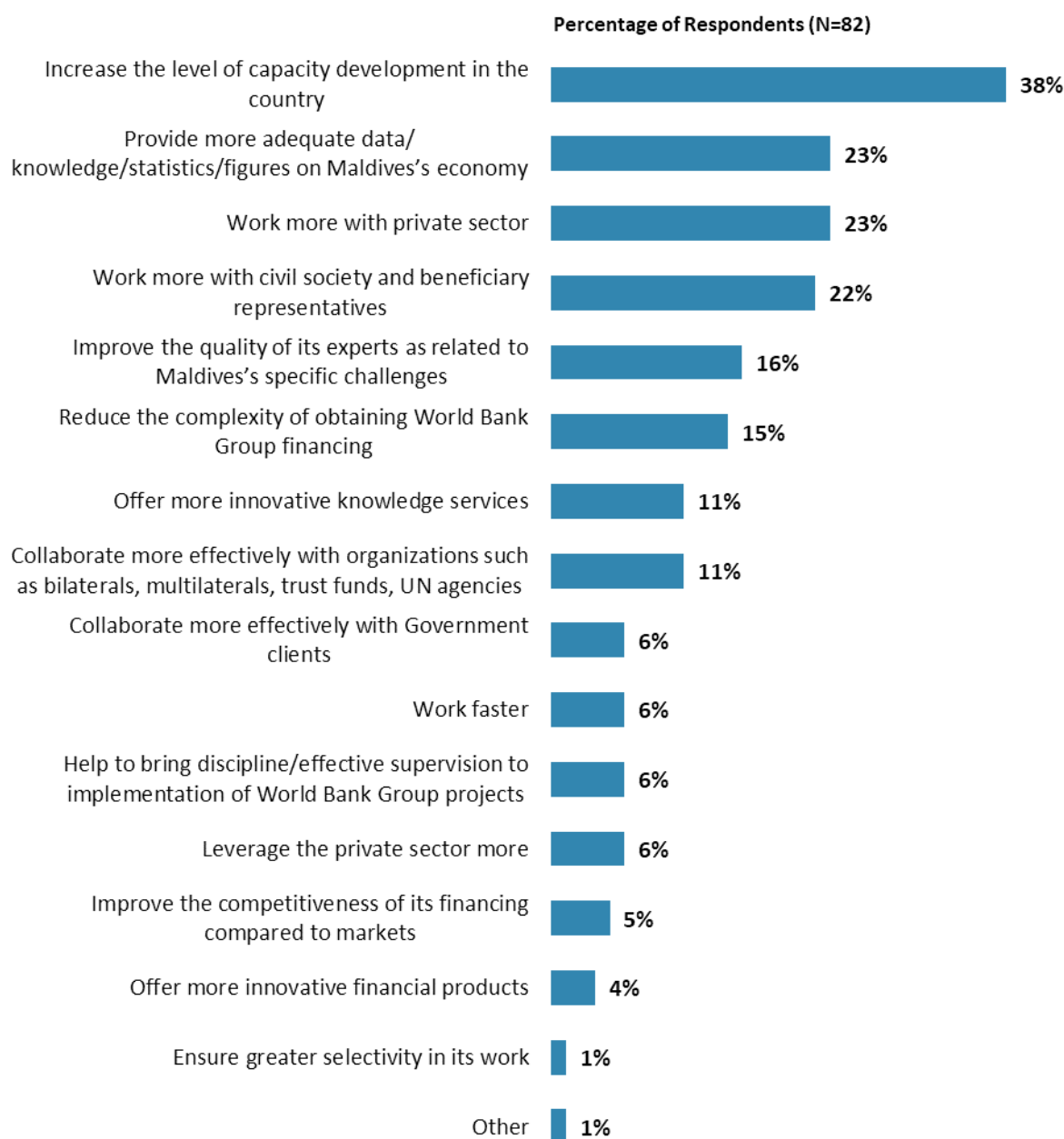

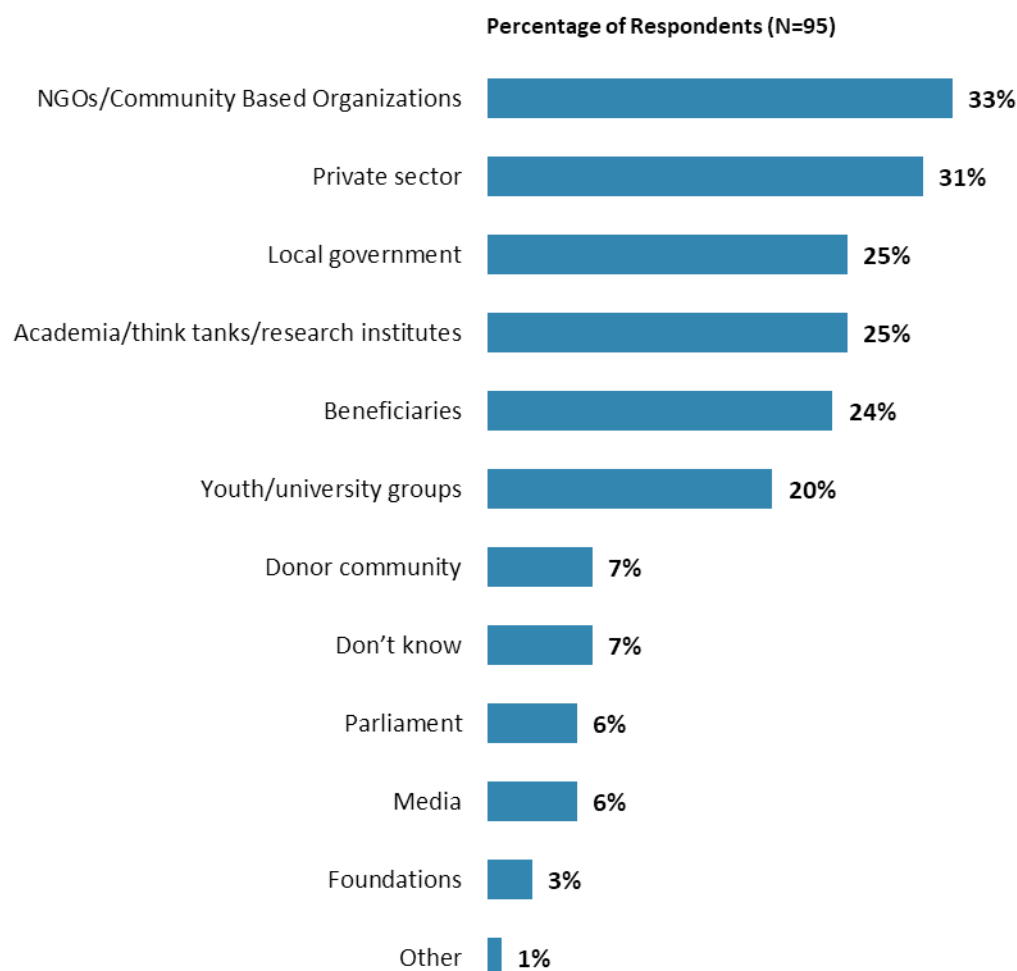

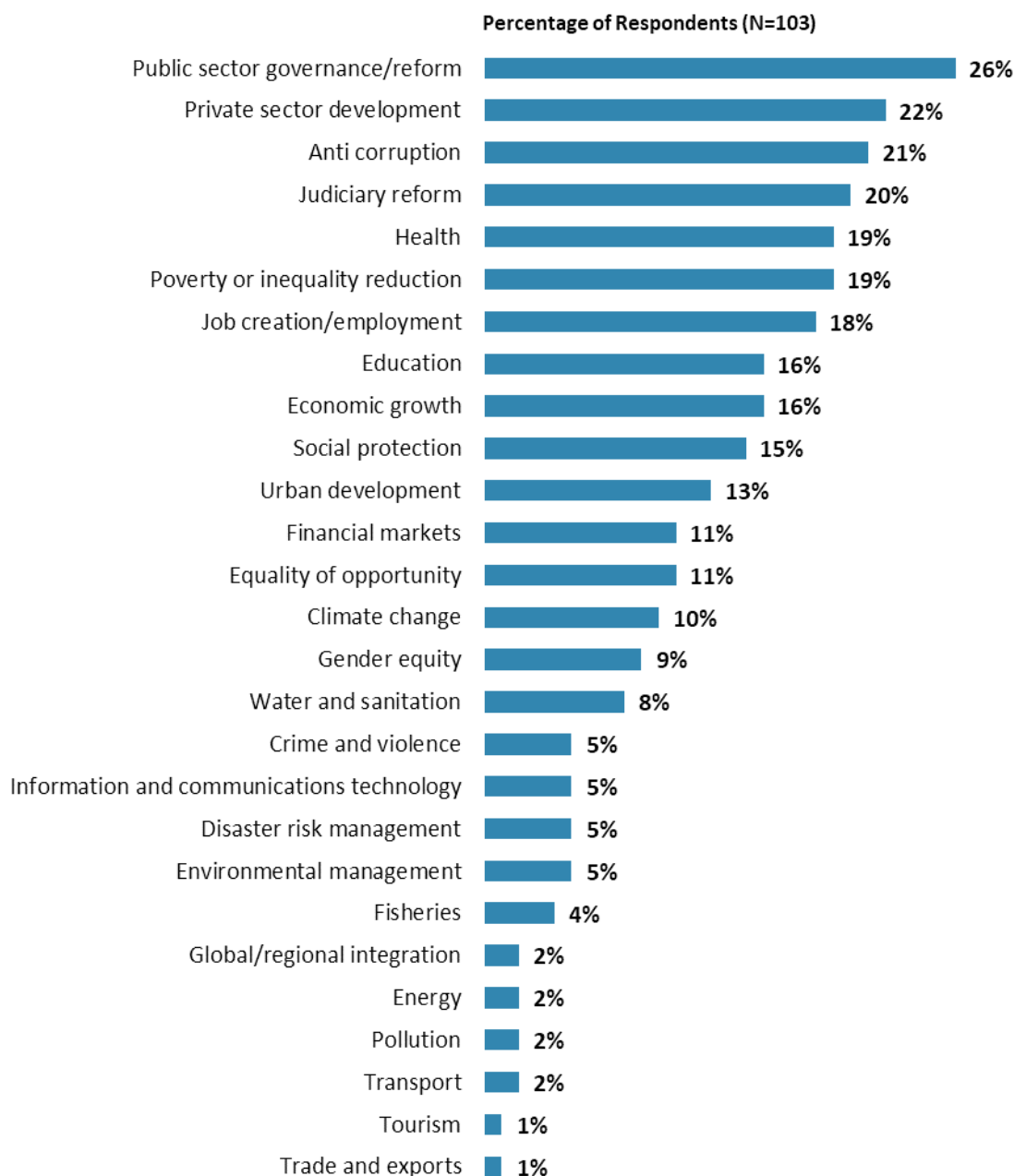
**"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country?"**

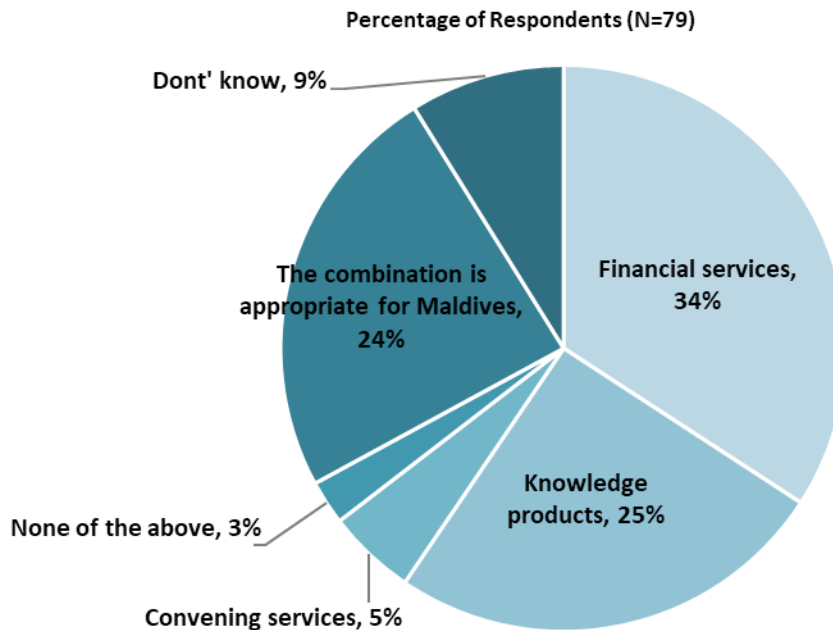

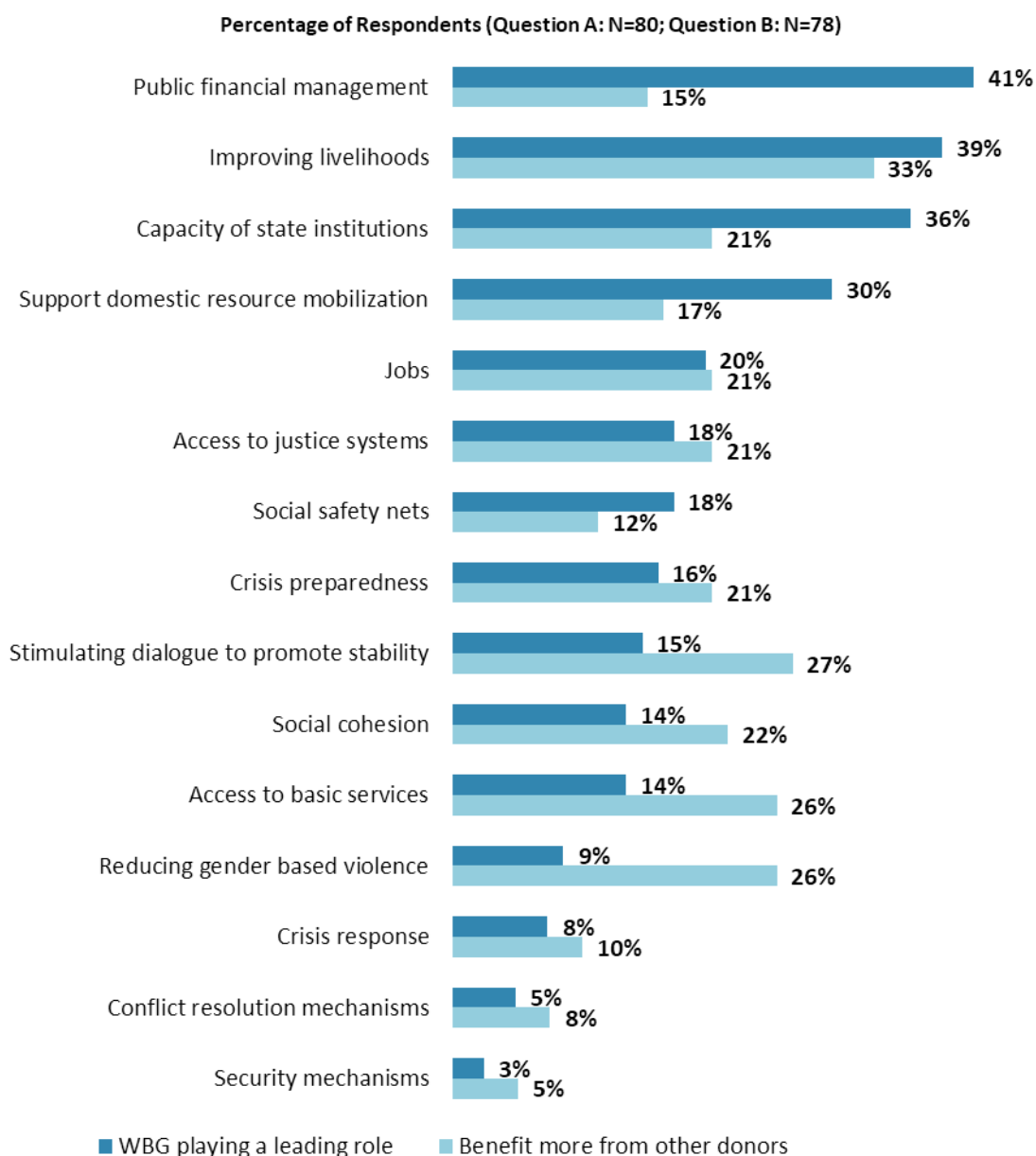

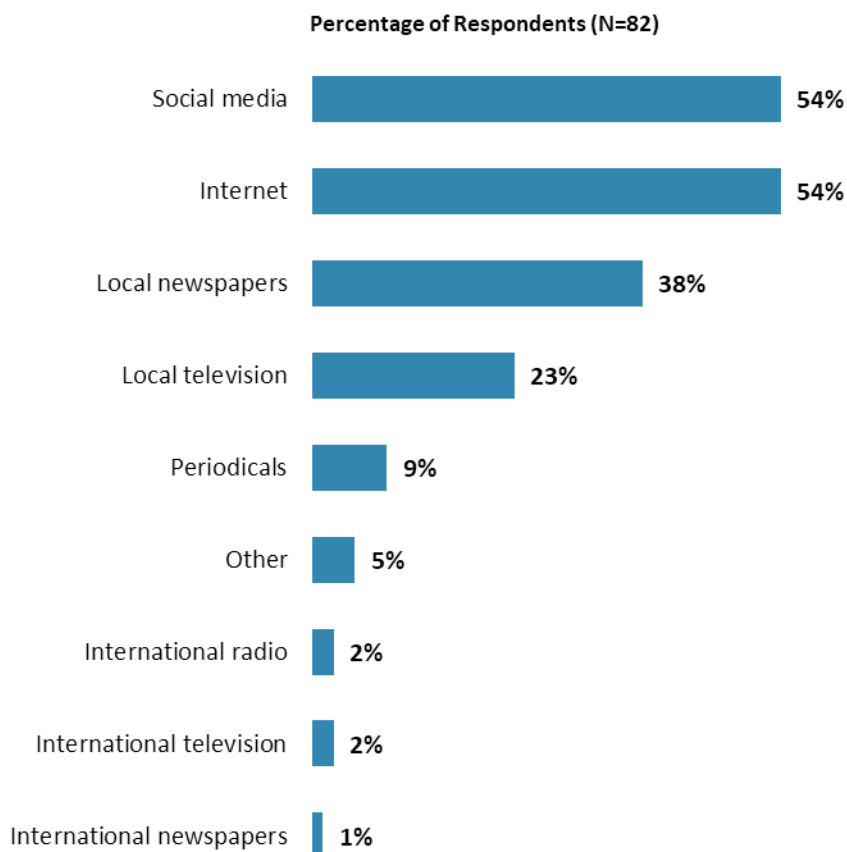

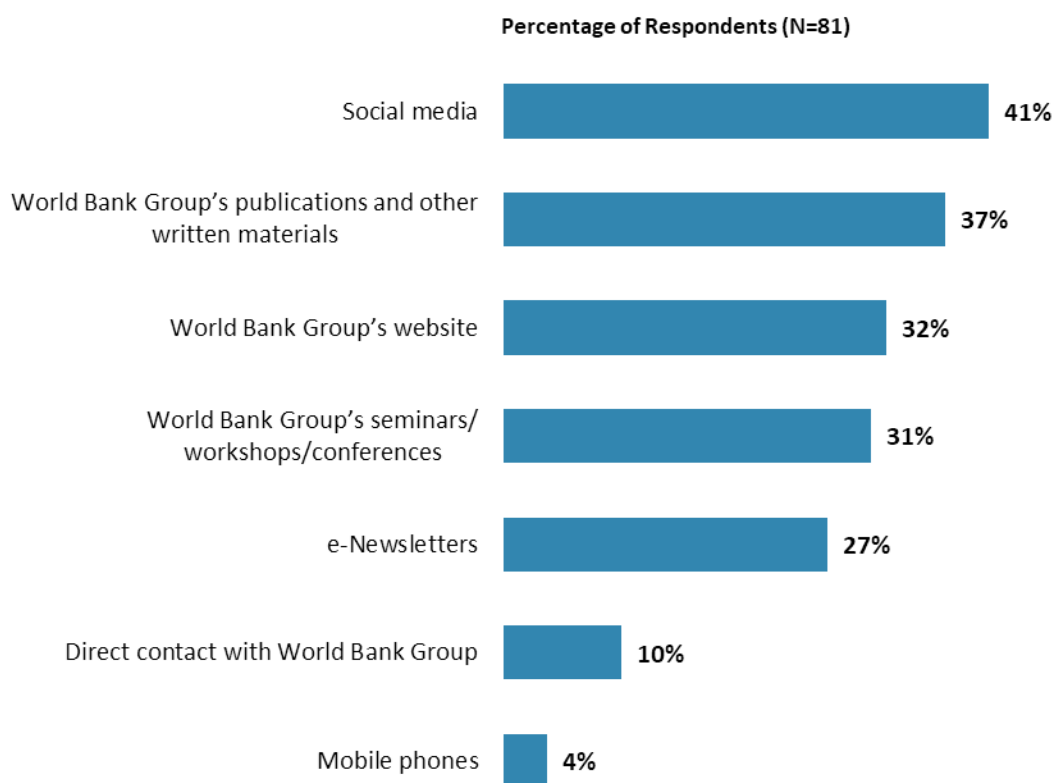
"How do you get most of your information about economic and social development issues in Maldives? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

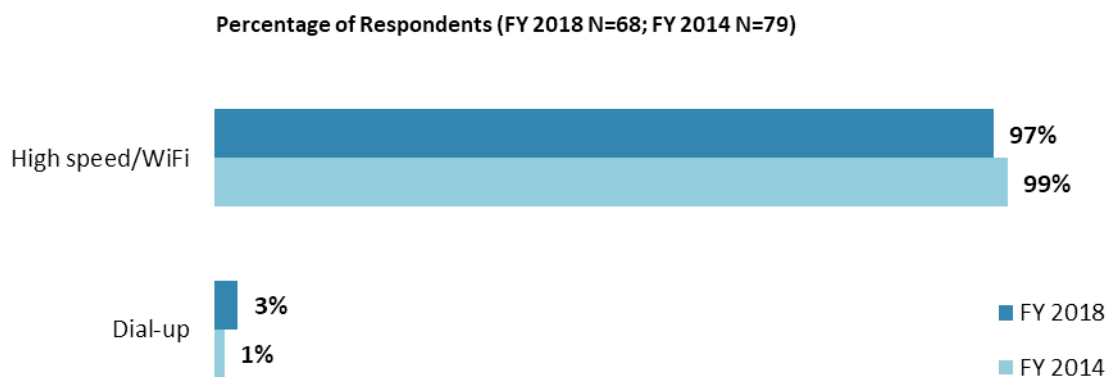
**"How would you prefer to receive information from the World Bank Group?

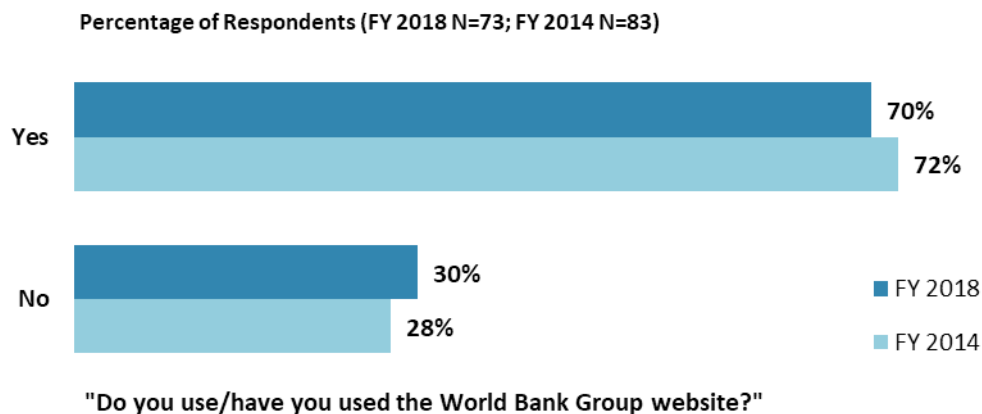

### The WBG Website Usage



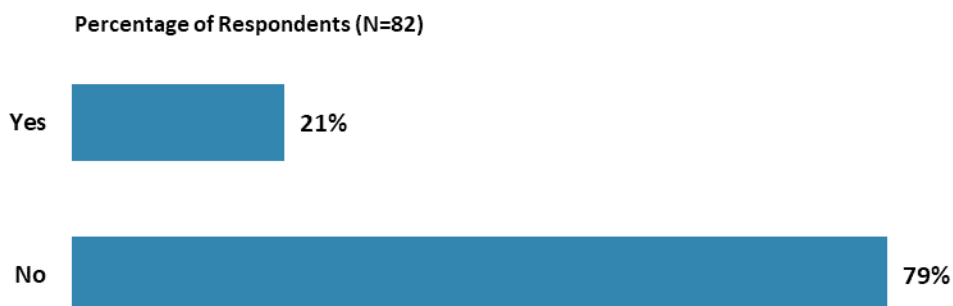

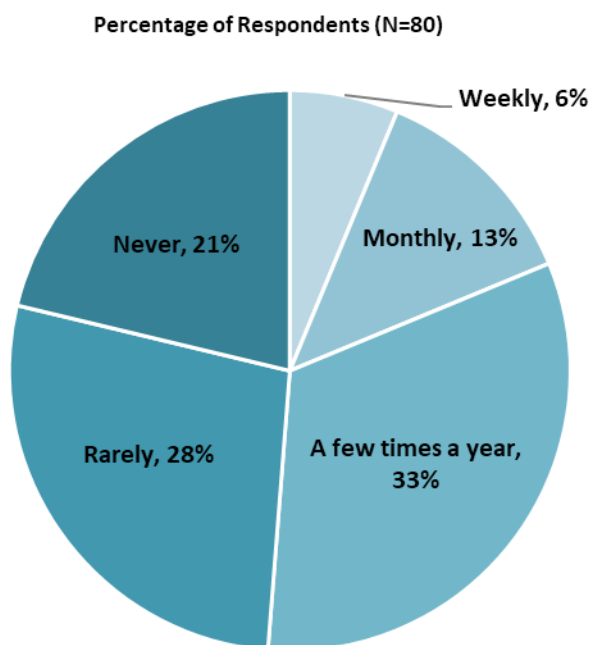

### Frequency Visiting WBG Websites and Social Media



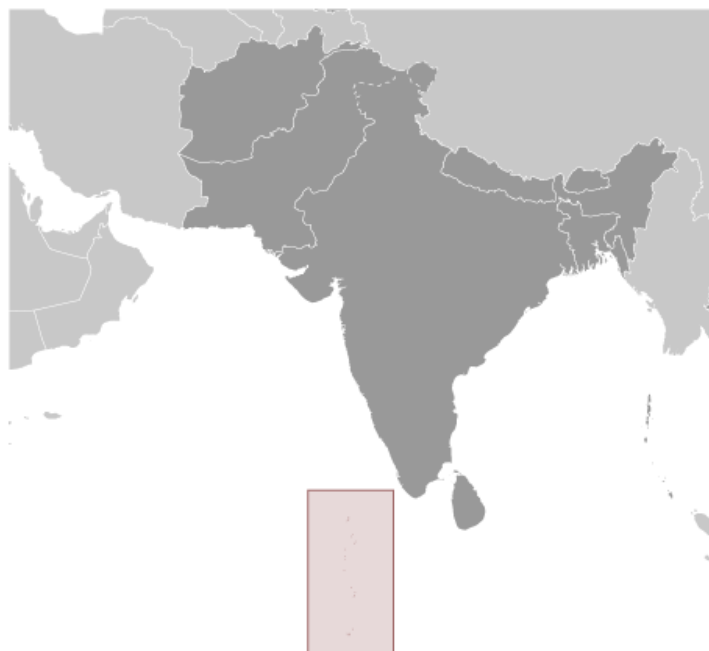
