- Yes/No questions: "Yes" is coded as "1," "No" is coded as "2."

ABSTRACT  
The Country Opinion Survey in Kyrgyz Republic assists the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Kyrgyz Republic perceive the WBG. It provides the WBG with systematic feedback from national and local governments, multilateral/bilateral agencies, media, academia, the private sector, and civil society in Kyrgyz Republic on:

- 1) Their views regarding the general environment in Kyrgyz Republic;
- 2) Their overall attitudes toward the WBG in Kyrgyz Republic;
- 3) Overall impressions of the WBG's effectiveness and results, knowledge work and activities, and communication and information sharing in Kyrgyz Republic; and
- 4) Their perceptions of the WBG's future role in Kyrgyz Republic.

# Sampling

## Sampling Procedure

---

From April to May 2019, 583 stakeholders of the WBG in the Kyrgyz Republic were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/ contractors working on WBG-supported projects/programs; local governments; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; NGOs/ community based organizations; the media; independent government institutions; trade unions/ professional associations; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations.

## Weighting

---

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'16 (response rate was 67%, N=322). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'16 COS report and the non-weighted data presented in appendices A, B, C, D and F. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix E (Report, see page 80) in the Related Documentation.
