I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Mongolia perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Mongolia*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From September to October 2019, 413 stakeholders of the WBG in Mongolia were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local government; independent government institutions; the judiciary system; state-owned enterprises; bilateral and multilateral agencies; public-private partnerships; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 269 stakeholders participated in the survey (65% response rate). Respondents completed the questionnaire with a representative from the local fielding agency or they received the questionnaire via mail or email and returned it accordingly.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'17 (response rate was 52%, N=266). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'17 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 79).




“Which of the following best describes your current position?”




"Please identify the primary specialization of your work."



Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of familiarity with the WBG compared to respondents in the FY'17 Country Survey (weighted mean in FY'20 = 7.1; weighted mean in FY'17 = 6.5)².
- **Impact of familiarity:** Respondents' ratings of familiarity with the WBG were significantly, strongly correlated with their agreement that the WBG plays a relevant role in Mongolia's development and with their ratings for the WBG's overall effectiveness in Mongolia, and significantly, moderately correlated with their ratings of the extent to which the WBG's work helps to achieve development results in Mongolia.




"How familiar are you with the work of the World Bank Group in Mongolia?"



Perceptions of Economic Opportunity




"Compared to 2017, do you think that economic opportunity for citizens in Mongolia is ... ?"

Perceptions of Improvement and Decline in Specific Areas




"Compared to 2017, please describe the direction Mongolia is moving in, when considering ... ?"

Development Priority

- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the most important development priorities in Mongolia were “*public sector governance/reform*” (44%), “*education*” (35%), “*anti-corruption*” (27%), “*private sector development*” (24%), and “*natural resource management*” (23%). In FY'20, “*health*” emerged among the top development priorities, with 23% of respondents selecting it, up from 14% in FY'17.





- **Year comparison:** Respondents in the previous FY'17 Country Survey indicated that the biggest contributors to poverty reduction in Mongolia were “*job creation/employment*” (54%), “*economic growth*” (36%), “*agriculture and rural development*” (35%), “*private sector development*” (30%), “*public sector governance/reform*” (27%), and “*education*” (27%).
















"When economic and/or social reform efforts fail or are slow to take place in Mongolia, which of the following would you attribute this to? (Choose no more than TWO)"









- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-eight COS indicator questions (mean rating = 6.9) compared to respondents who do not collaborate with the WBG (mean rating = 6.4). 
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10


"When thinking about the World Bank Group's role in Mongolia, which activity do you VALUE the most? (Choose no more than TWO)"




"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Mongolia? (Choose no more than TWO)"

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁵









The WBG's Human Capital Investment














"To what extent is the World Bank Group an effective development partner in Mongolia, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")



Effectiveness of WBG's Support for Management of Crisis Related Risks




"How effectively does the World Bank Group's SCD and CPF activities support Mongolia's efforts to manage crisis related risks?"

Frequency of Consulting WBG Knowledge Work and Activities




"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"



Meeting Mongolia's Knowledge Needs¹¹ (*Indicator Question*)





Technical Quality of the WBG's Knowledge Work and Activities (*Indicator Question*)














"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"




"How do you get most of your information about economic and social development issues in Mongolia? (Choose no more than TWO)"


**"How would you prefer to receive information from the World Bank Group?



WBG Interaction Frequency




"How frequently do you interact with the World Bank Group now in Mongolia?"
