

I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Morocco perceive the WBG. The survey explored:

- *General Issues Facing Morocco*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Morocco*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From April to June 2019, 400 stakeholders of the WBG in Morocco were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the Head of the Government; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community-based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; judiciary branch; and other organizations.

A total of 148 stakeholders participated in the survey (37% response rate). Respondents received the questionnaires via mail, courier, online survey platform Qualtrics, or from a representative of the fielding company.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

As a rule, the results in this year's Country Survey are compared to results of the previous cycle of the Country Survey. Due to the small number of respondents in the FY'16 Morocco Country Survey (response rate was 14%, N=52), the data comparisons across years would have been statistically unsound. Therefore, only FY'19 data are presented in this report.



- For further analyses, some respondent groups were combined¹.




“Which of the following best describes your current affiliation?”

Area of Primary Specialization




“Please identify the primary specialization of your work.”



Exposure to Agencies within the World Bank Group




"Which of the following agencies of the World Bank Group do you primarily collaborate/work with in Morocco?" (Respondents chose from a list.)

Familiarity with the World Bank Group

- **Impact of familiarity:** Respondents' ratings of familiarity with the WBG were significantly, moderately correlated with their ratings of the WBG's overall effectiveness in Morocco, with their agreement that the WBG plays a relevant role in development in Morocco, and with their ratings of the extent to which the WBG's work helps to achieve development results in Morocco.




"How familiar are you with the work of the World Bank Group in Morocco?"
(1-"Not familiar at all", 10-"Extremely familiar")





Perceptions of Economic Opportunity




"Do you think that economic opportunity for citizens in Morocco is ... ?"

Perceptions of Improvement and Decline in Specific Areas





Development Priority

- **Specialization:** Respondents who identified their primary specialization of work as “education” (11% of the sample) were significantly *more* likely to indicate that “education” was the most important development priority in Morocco, compared to the rest of respondents in other areas of work (education specialists = 94%; others = 66%).²













Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-eight COS indicator questions (mean rating = 6.3) compared to respondents who do not collaborate with the WBG (mean rating = 5.7). 


Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10




"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Morocco?"




"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Morocco? (Choose no more than TWO)"

Effectiveness of WBG's Support in Sectoral Areas³




"How EFFECTIVE do you believe the World Bank Group is in terms of the work it does in the following areas of development in Morocco?"


"How EFFECTIVE do you believe the World Bank Group is in terms of the work it does in the following areas of development in Morocco?"











"To what extent is the World Bank Group an effective development partner in Morocco, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")






"Overall, how would you rate the technical quality of the World Bank Group's knowledge work and activities?"

Qualities of the WBG's Knowledge Work and Activities




"In Morocco, to what extent do you believe that the World Bank Group's knowledge work and activities:" (1-"To no degree at all", 10-"To a very significant degree")




**"Which of the following SHOULD the World Bank Group do to make itself of greater value in Morocco?



Future Combination of the WBG Services








**"How do you get most of your information about economic and social development issues in Morocco?
