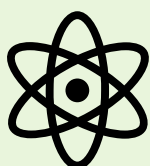

#### OVERVIEW



The quick spread of the COVID-19 pandemic and its potential impacts on multiple aspects of Burkina Faso's economy and livelihood create an urgent need for timely data and evidence to monitor the crisis and inform interventions and policy responses. Toward these goals, the World Bank and the National Institute of Statistics and Demography of Burkina Faso decided to implement the Burkina Faso Covid-19 High Frequency Phone Survey (BFA Covid-19 HFPS). The first phase of the survey was implemented monthly between June 2020 and July 2022. The second phase will be conducted bi-monthly over 12 months since April 2022. The survey questionnaire is designed to cover important and relevant topics, including knowledge of Covid-19 and social behavior, access to food and basic services, impact of the Covid-19 on economic activities and income sources. The final dataset consists of a panel of approximately 2,000 households, representative for households with access to a mobile phone at the national level, Ouagadougou level, and for urban and rural areas.

This note describes the questionnaire design, sampling methodology, and weighting procedures of the survey.

#### INTRODUCTION

The World Bank is providing technical and financial support to countries to help mitigate the spread and impact of the new corona-virus disease (COVID-19). One area of support is for data collection to inform evidence-based policies that may help mitigate the effects of this disease. Towards this end, the World Bank is leveraging the West Africa Economic Monetary Union (WAEMU) Household Survey harmonization Project to produce high frequency longitudinal data in member countries.

For Burkina Faso, the survey, which is implemented by the Institut National de la Statistique et la Demographie (INSD), is conducted using cell phone numbers of household members collected during the 2018/19 EHCVM survey. The extensive information collected in the EHCVM provides a rich set of background information for the COVID-19 High Frequency Phone Survey of households. This background information can be leveraged to assess the differential impacts of the pandemic in the country. Every month, the sampled households will be asked a set of core questions on the key channels through which individuals and households are expected to be affected by the COVID-19-related restrictions. Employment, access to basic services, non-labor sources of income are channels likely to be impacted. The core questionnaire is complemented by questions on selected topics that rotate each month. This provides data to the government and development partners in near real-time, supporting an evidence-based response to the crisis. The main objectives of the survey are to:

1. Identify type of households directly or indirectly affected by the pandemic;
2. Identify the main channels by which the pandemic affects households;
3. Provide relevant data on income and socioeconomic indicators to assess the welfare impact of the pandemic.

The core questionnaire is complemented by questions on selected topics that rotate each month. These rotating modules deal with food insecurity, shocks and coping strategies, fragility, conflict and violence, safety nets. Selected topics may be investigated more in detail in specific rounds.

## **BASELINE SURVEY SAMPLE AND IMPLEMENTATION – ROUND 1 - PHASE 1**

The sample of the BFA Covid-19 HFPS is a subsample of the 2018/19 Harmonized Living Conditions Household Survey (EHCVM)<sup>1</sup>. The EHCVM 2018/19 is built on a nationally and regionally representative sample of households in Burkina Faso. EHCVM 2018/19 interviewed 7,010 households in urban and rural areas. In the EHCVM interview, households were asked to provide phone numbers of the household head, or a household member, or a non-household member (e.g. friends or neighbors) so that they can be contacted for follow-up questions. At least one valid phone number was obtained for 6,877 households. These households established the sampling frame for the HFPS. To obtain representative strata at the national, capital (Ouagadougou), urban, and rural level, the target sample size for the HFPS is 1,800 households (assuming a 50% non-response rate the minimum required sample is 1,479). To account for non-response and attrition, 2,500 households were called in baseline round (round 1) of the HFPS. 1,968 households were fully interviewed during the first round of interviews. Those 1,968 households constitute the final successful sample and will be contacted in subsequent rounds of the survey (see Table 2). For households contacted for the interview, the objective of the survey is explained to the respondent and consent to participate in the survey is obtained. The modules described in Table 1 were administered in the BFA Covid-19 HFPS – Round 1 between June 9 and July 1, 2020. The interviews are conducted in Moore, Dioula, Fulfulde, Gourmatchema, Bobo, Senoufo, Lobiri, Dagari, French, Lele, Bissa and Bwamu. At completion, the respondents' willingness to participate in the follow-up rounds is requested. The table below presents the interview result for the baseline sample.

Please refer to the section “Using data” for further details between the two surveys.

**RESPONDENTS:** Each round of the Burkina Faso COVID-19 HFPS has ONE RESPONDENT per household. The respondent is the household head or a knowledgeable adult household member. The respondent must be a member of the household. Unlike many other household surveys, interviewers were not expected to seek out other household members to provide their own information. The respondent may still consult with other household members as needed to respond to the questions, including to provide all the necessary information on each household member. Interviewers were instructed to make every effort to reach the same respondent in subsequent rounds of the survey, in order to maintain the consistency of the information collected. However, in cases where the previous respondent was not available, interviewers would identify another knowledgeable adult household member to interview.

## REPRESENTATIVENESS

It is important to note that the BFA Covid-19 HFPS is representative of households who have access to phones in Ouagadougou, urban and rural Burkina Faso. The key concern for the BFA Covid-19 HFPS is the bias sample of households as phone penetration in the most remoted areas is limited. Taken that into consideration, the number of households without a valid phone number is limited (less than 2 percent of the EHCVM sample). Thus, we do not observe great differences in the main socio-economic outcomes between the EHCVM sample and the BFA Covid-19 HFPS final sample.

While the HFPS has a very light questionnaire, we can link households in the HFPS with the EHCVM 2018/19 to have a comprehensive socio-economic profile of households based on information already collected in the EHCVM. In Table 3 the main characteristics of the EHCVM sample and the phone survey sample are reported.

It is also important to highlight that each round of the BFA COVID-19 HFPS has one respondent per household. The respondent must be a member of the household and is the household head or a knowledgeable adult household member. Unlike many other household surveys, interviewers were not expected to seek out other household members to provide their own information. The respondent may still consult with other household members as needed to respond to the questions, including to provide all the necessary information on each household member.

Enumerators were instructed to make every effort to reach the same respondent in subsequent rounds of the survey, in order to maintain the consistency of the information collected. However, in cases where the previous respondent was not available, interviewers would identify another knowledgeable adult household member to interview.

## SAMPLING WEIGHTS

To obtain unbiased estimates from the sample, the information reported by households needs to be adjusted by a sampling weight (or raising factor). To construct the sampling weights for the HFPS, we follow the steps outlined in Himelein, K. (2014): Weight Calculations for Panel Surveys with Subsampling and Split-off Tracking, *Statistics and Public Policy*, 1:1, 40-45.

1. Begin with base weights from the EHCVM 2018/19 for each household
2. Incorporate probability of sub-selection of baseline unit for each of the phone survey households. We calculate the probability of selection for each of the 3 strata by creating the numerators as the number of completed phone interviews and the denominator as the number of households in the EHCVM for each strata.
3. Pool the weights in Steps 1 and 2.
4. Derive attrition-adjusted weights for all individuals by running a logistic response propensity model based on characteristics of the households, the household head, and their dwelling.
5. Trim weights by replacing the top two percent of observations with the 98th percentile cut-off point; and
6. Post-stratify weights to known population totals to correct for the imbalances across our strata and rural sample to ensure similar distribution to the EHCVM sample.

## USING THE DATA

The data should always be used combining them with the questionnaires. All variables specified in the questionnaires have been included in the data sets. Sensitive information of the participants has been removed to respect the confidentiality of data collected.

Variables are likely to maintain the same structure and names in every round. If questions were dropped in previous round, the numbering was preserved. If questions were added in the middle of a section, a letter was added to the question number at that space in sequence. This effort was done in order to make easier the utilization of data across the different rounds.

All datasets contain a variable (*hhid*) which is a unique identifier for the household. Being the BFA Covid-19 HFPS sample based on the sample frame of the EHCVM survey, *grappe* and *menage* variables from EHCVM have been used to build the *hhid* identifier as indicated below:

$$hhid = (grappe * 1000) + menage$$

By applying the same data manipulation to the EHCVM sample it is possible to merge the data between the two surveys.

Moreover, through this variable is possible to merge all household type datasets. Being the BFA Covid-19 HFPS a panel survey, data from different rounds could be merged too. In addition, for datasets that contain information at individual level, *members\_id* is the variable that uniquely identifies the members of the household and it can be used as the reference variable, jointly with *hhid*, for merging the datasets.

## ROUND 2 – PHASE 1

The BFA Covid-19 HFPS – Round 2 was administered between July 20 and August 14, 2020.

The following modules were administered in Round 2: Household Roster; Access to Basic Services; Employment (with a focus on non-farm enterprises); Food Security; Shocks; Fragility, conflict and violence.

Tables 5 and 6 present a brief description of the BFA Covid-19 HFPS and the structure of the datasets for Round 2.

Interviewers attempted to contact and interview all 1,968 households that were successfully interviewed in the Round 1 of the BFA COVID-19 HFPS. As shown in Table 4, 1,891 households (96.1% of the 1,968 attempted) were contacted and 1,860 (94.5%) were successfully interviewed in the second round. Of those contacted, 20 households refused outright to be interviewed and 12 were partially interviewed.

In addition to the 1,968 households successfully interviewed in Round 1, in Round 2 242 additional households were sampled from the rural strata, in order to increase the representativeness in this domain. Out of the 242 sample households, 177 households (73.14% of the 242 attempted) were contacted and successfully interviewed. The entire Round 2 sample comprises 2037 households.

In Round 2, two different weights are provided: cross section and panel weights. The cross section weights (*hhwcovid\_r2\_s1s2*) are applicable to the entire Round 2 sample while the panel weights (*hhwcovid\_r2\_s1*) are only applicable to round 2 sample households that have been successfully interviewed in all two rounds of the survey so far (Sample 1).

## **ROUND 3 – PHASE 1**

The BFA Covid-19 HFPS – Round 3 was administered between September 12 and October 21, 2020.

The following modules were administered in Round 3: Household Roster; Knowledge regarding the spread of COVID-19; Behavior and social distancing; Access to Basic Services; Employment (with a focus on non-farm enterprises); Food Security; Other revenues; Social protection.

The tables below present a brief description of the Round 3 BFA Covid-19 HFPS questionnaire and the structure of the datasets.

In addition to the 2,037 households successfully interviewed in the second round, in an effort to maintain sample size, additional 173 households that had not been successfully interviewed in previous rounds but did not refuse to participate in the survey were called in this third round. As shown in Table 10, 2,037 households (96.08% of the 2,120 attempted) were contacted and 2,013 (94.95%) were successfully interviewed in the third round. Of those contacted, 21 households refused outright to be interviewed and 2 were partially interviewed.

In Round 3, two different weights are provided: cross section and panel weights. The cross-section weights (*hhwcovid\_r3\_cs*) are applicable to the entire Round 3 sample while the panel weights (*hhwcovid\_r3\_pnl*) are only applicable to round 3 sample households that have been successfully interviewed in all rounds of the survey so far.

## **ROUND 4 – PHASE 1**

The BFA Covid-19 HFPS – Round 4 was administered between November 6 and December 2, 2020.

The following modules were administered in Round 4: Household Roster; Access to Basic Services; Credit; Employment and revenue (with a focus on livestock activities); Food Security; Other revenues; Shocks; Fragility, Conflict and Violence. The tables below present a brief description of the BFA Covid-19 HFPS questionnaire and the structure of the datasets for Round 4.

In addition to the 2,013 households successfully interviewed in the third round, in an effort to maintain sample size, additional 91 households that had not been successfully interviewed in previous rounds but did not refuse to participate in the survey were called in this third round. 21 households were excluded from the sample of Round 4 as they refused to participate in Round 3. As shown in Table 13, 2,025 households (96.25% of the 2,104 attempted) were contacted and 2,011 (95.58%) were successfully interviewed in Round 4. Of those contacted, 9 households refused outright to be interviewed and 5 were partially interviewed.

In Round 4, two different weights are provided: cross section and panel weights. The cross-section weights (*hhwcovid\_r4\_cs*) are applicable to the entire Round 4 sample while the panel weights (*hhwcovid\_r4\_pnl*) are only applicable to round 4 sample households that have been successfully interviewed in all rounds of the survey so far.

## ROUND 5 – PHASE 1

The BFA Covid-19 HFPS – Round 5 was administered between December 9 and December 30, 2020.

The following modules were administered in Round 5: Household Roster; Knowledge regarding the spread of COVID-19; Behavior and social distancing; Covid-19 Testing and Vaccination; Access to Basic Services; Education; Employment; Food Security; Other revenues; Social Protection.

The tables below present a brief description of the BFA Covid-19 HFPS questionnaire and the structure of the datasets for Round 5.

In addition to the 2,011 households successfully interviewed in the fourth round, in an effort to maintain sample size, additional 84 households that had not been successfully interviewed in previous rounds but did not refuse to participate in the survey were called in this fifth round. 9 households were excluded from the sample of Round 5 as they refused to participate in Round 4. As shown in Table 16, 1,968 households (93.94% of the 2,095 attempted) were contacted and 1,944 (92.79%) were successfully interviewed in Round 5. Of those contacted, 24 households refused outright to be interviewed.

One new feature of the fifth round is more extensive individual-level data collection on education of household members. For the education module, information on household members 5-18 years was targeted. In order to limit the burden for respondents and interviewers a random number of school-aged members per household was selected, up to a maximum of 6 household members. At least one eligible individual was selected per household, and 3401 individuals 5-18 years old out of 5031 eligible individuals (69.6%) were selected for the module on education.

In Round 5, several different weights are provided: two at the household-level and two at the individual-level. The two household weights are the same as have been provided in previous rounds: The cross-section weights (*hhwcovid\_r5\_cs*) are applicable to the entire Round 5 sample while the panel weights (*hhwcovid\_r5\_pnl*) are only applicable to round 5 sample households that have been successfully interviewed in all rounds of the survey so far.

Given the focus on individual education information in round 5 and the selection steps outlined above for the sample of school-aged members (5-18 years), an additional two individual-level weights were calculated and provided in *r5\_sec5e\_education*. The individual weights for the education module were calculated according to:

$$w_{ish} = w_h \times (n_{hs} / N_{hs})^{-1}$$

Where  $w_{ish}$  is the sampling weight for individual  $i$  who is sex  $s$  (male or female) in household  $h$ ,  $w_h$  is the final household level weight (i.e. *hhwcovid\_r5\_cs*),  $N_{hs}$  is the total number of eligible household members (aged 5-18) of sex  $s$  in household  $h$  and  $n_{hs}$  is the equivalent number of selected eligible individuals in the household. The individual weights were then

calibrated to correspond to the sex and age distribution of the total school-aged population according to the EHCVM 2018/19.

The basic individual weight described above is the cross section individual weight that considers all individuals that education information was collected on. This weight is called *wt\_educ\_r5* and can be found in the individual-level education data file (*r5\_sec5e\_education.dta*). However, an additional weight (*wt\_educ\_r5\_pnl*) is provided for the panel of individuals interviewed in the EHCVM 2018/19 and round 5 of the HFPS (i.e. excluding individuals added in the HFPS).

## ROUND 6 – PHASE 1

The BFA Covid-19 HFPS – Round 6 was administered between January 15 and February 1, 2021.

The following modules were administered in Round 6: Household Roster; Access to Basic Services; Education; Employment and revenues (with a focus on harvest activities and revenues from crop selling); Food Security; Other revenues; Shocks; Fragility, conflict and violence.

In addition to the 1944 households successfully interviewed in the fifth round, in an effort to maintain sample size, additional 84 households that had not been successfully interviewed in previous rounds but did not refuse to participate in the survey were called in this sixth round. 24 households were excluded from the sample of Round 6 as they refused to participate in Round 5. As shown in Table 19, 2008 households (96.96% of the 2,071 attempted) were contacted and 1,985 (95.85%) were successfully interviewed in Round 6. Of those contacted, 18 households refused outright to be interviewed.

The BFA Covid-19 HFPS – Round 7 was administered between February 12 and March 02, 2021.

The following modules were administered in Round 7: Household Roster; Mental health; Access to Basic Services; Education; Employment and revenues (with a focus on harvest activities and revenues from crop selling); Food Security; Other revenues; Shocks; Fragility, conflict and violence.

The tables below present a brief description of the BFA Covid-19 HFPS questionnaire and the structure of the datasets for Round 7.

One new feature of the seventh round is more extensive individual-level data collection on employment of household members. For the individual level employment module, information on household members 15-64 years was targeted. In order to limit the burden for respondents and interviewers a random number of 15-64 aged members per household was selected, up to a maximum of 6 household members.

However, an additional weight (*wt\_empl\_r7\_pnl*) is provided for the panel of individuals interviewed in the EHCVM 2018/19 and round 7 of the HFPS (i.e. excluding individuals added in the HFPS).

## **ROUND 8 – PHASE 1**

The BFA Covid-19 HFPS – Round 8 was administered between March 13 and April 01, 2021.



The following modules were administered in Round 8: Household Roster; Early Child Development; Access to Basic Services; Education; Employment and revenues; Food Security; Other revenues; Shocks; Fragility, conflict and violence. Tables 24 and 25 present a brief description of the BFA Covid-19 HFPS questionnaire and the structure of the datasets for Round 8.

One new feature of Round 8 is an extensive module on early child development. For this module, information on one household member, randomly selected among members aged 2-10 years, was collected. Related information for a total of 1494 children was collected.

## **ROUND 14**
