## **Baseline Evaluation – Early-Grade Reading Intervention Information Sheet and Consent Form for Grade 1 Teachers**

### **Who we are**

Hello! I am \_\_\_\_\_. I am working in a project undertaken by Social Data Collectors (SDC) and JET Education Services (JET). SDC/JET is a data collection consortium contracted to collect information for the Early Grade Reading Study (EGRS II).

### **What we are doing**

The Department of Basic Education (DBE) with support from the Mpumalanga Education Department asked SDC/JET to evaluate the success of two reading interventions that the DBE has developed. The interventions are going to be implemented in a random sample of 100 primary schools in Mpumalanga Province. Grade 1 learners should benefit in 2017, as well as in Grade 2 in 2018. There are also 80 control schools. We as evaluators do not know if a school is a project or a control school. This serves to keep the evaluation “blind” (independent). DBE itself will inform schools of their role and participation. From each sampled school, the school principal, the Grade 1 teachers and a random sample of 20 Grade 1 learners are now asked to participate in the baseline evaluation. This will mainly comprise completion of a brief background questionnaire and a short English Exercise. Individual oral language assessment with 20 randomly sampled Grade 1 learners (12-15 minutes each) is also planned. The evaluation has to tell us how successful the interventions are. The focus is on improved early acquisition of English as First Additional Language among Grade 1 and Grade 2 learners to improve English reading and literacy proficiency. The evaluation hopes to find out if the abovementioned interventions are effective and affordable enough to implement in the rest of the primary schools in the country.

### **Your participation**

We are asking you as a Grade 1 teacher to provide some background information that may underpin how you teach reading in your class by completing a questionnaire. The questions mainly cover classroom facilities and teaching practices. Completion of the whole questionnaire should not take longer than 30-40 minutes. The questions are mainly about conditions and activities that may enhance or hinder your teaching of reading and language in the classroom. We would also like to request that you complete a short English exercise. This exercise will only take 2 minutes. Should it become quite clear if or which interventions are very successful, the DBE, given available funding, intends extending them to teachers and learners in more schools. This will first involve the control schools, and then other schools in Mpumalanga Province and even nationally. We also need to administer simple reading assessments to 20 randomly-selected learners from your school. Some of the learners are from your class.

Please understand that **your participation is voluntary** and that you are not being forced to take part in this evaluation. The choice of whether to participate or not, is yours alone. If you choose not to take part, you will not be affected in any way whatsoever. If you agree to participate, you may stop participating in the evaluation at any time and tell me that you don't want to continue. If you do this, there will be no penalties and nothing will happen to you. The same applies should there be specific questions you do not want to respond to.

### **Confidentiality**

Identifying information such as coded ID numbers and lists of names will be kept in a locked cabinet or office. It will not be available to others, and will be kept confidential to the extent possible by law. The records from your participation may be reviewed by people responsible for making sure that research is done properly, including members of the Human Research Ethics Committee at University of Witwatersrand. (All of these people are required to keep your

identity confidential). Otherwise, records that identify you will be available only to people working on the study, unless you give permission for other people to see the records. If needed, we will ask for your permission in future at the appropriate time. For data sets at school, teacher, learner and parent level, only coded identity numbers will appear on password-protected computers.

### **Risks/discomforts**

We do not see large risks in your participation. However, you may feel embarrassed about physical conditions at your school, or fear criticism about management or teaching practices at your school, or the knowledge or skills that you have. We undertake to handle all your information confidentially and anonymously, and for the purposes of this evaluation only. We will not share identifiable evaluation information with anyone else, especially not other Department officials at the circuit, district, provincial or national offices. A key purpose of the interventions is to help everyone improve the quality of reading teaching and learning at schools.

### **Benefits**

The main purpose of the project in 2017 and 2018 is to improve Grade 1 and 2 learners' reading proficiency through teacher interventions in the project schools. The aim is to help teachers enhance their subject knowledge and teaching skills. Such teacher changes are very likely to have a positive impact on learners' reading proficiency and achievement.

The project, with its ongoing evaluation, is designed in such a way that regular information will be available to intervention service providers working in each school. After completion of the mid-term evaluation by November 2017 and the full evaluation by November 2018, the findings will be made available as soon as possible at concluding seminars and in official reports to the DBE and senior education officials of Mpumalanga Province. Schools will form part of such dissemination. The research and evaluation team also intends to publish its findings in peer-reviewed academic journals. The identity or names of schools, principals, teachers, parents or learners will never be attached to any of the information that you provide, or the information released through articles.

### **Who to contact if you have been harmed or have any concerns**

This research was approved by the Human Research Ethics Committee at University of Witwatersrand.
