I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Lesotho perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Lesotho*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From January 2021 to April 2021, 489 stakeholders of the WBG in Lesotho were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President; Prime Minister; office of a minister; office of a parliamentarian/senator; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth and women groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 109 stakeholders participated in the survey (22% response rate). Respondents filled out the questionnaire via the online platform Qualtrics.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'18 (response rate was 51%, N=175). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'18 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 82).

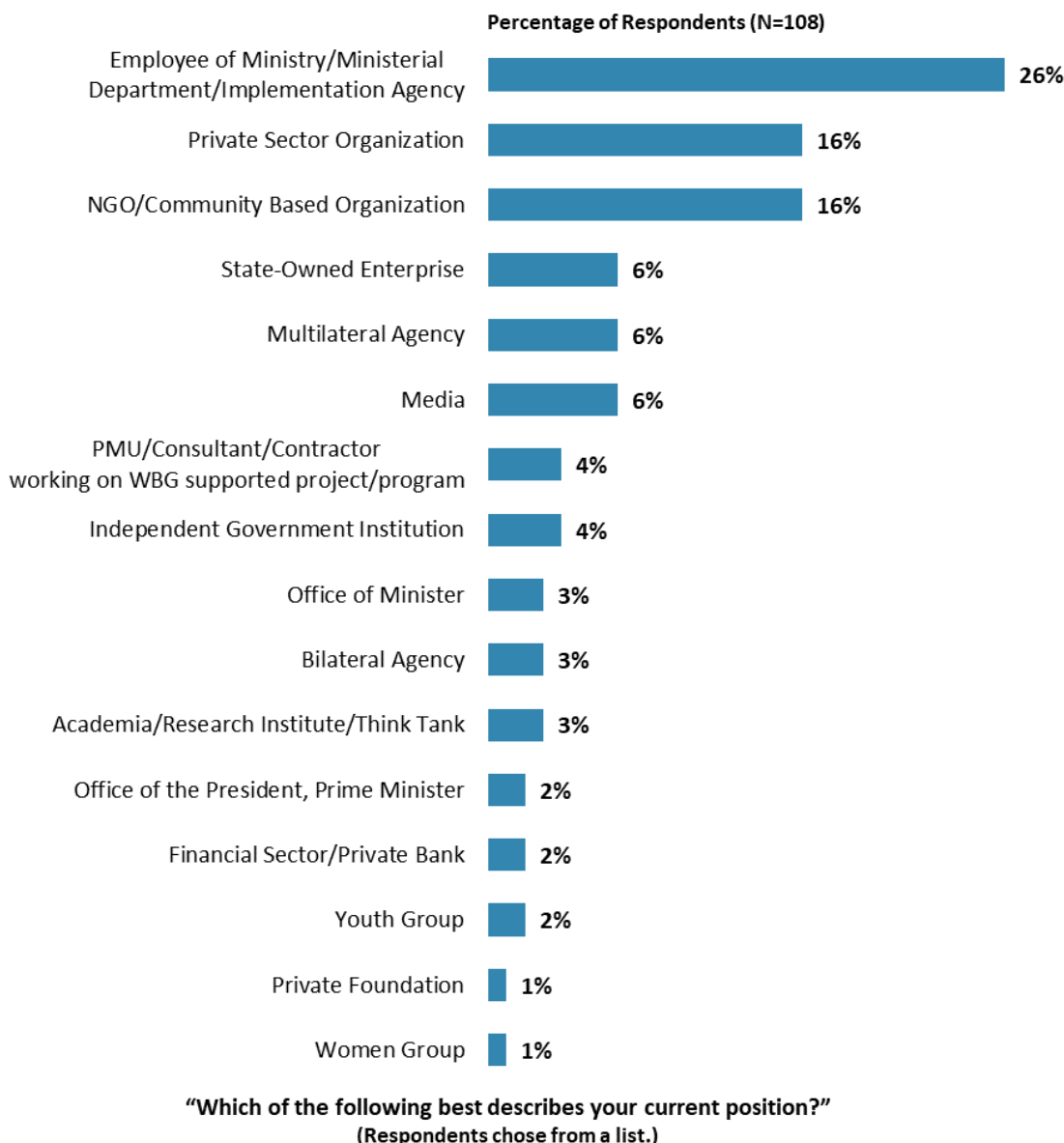

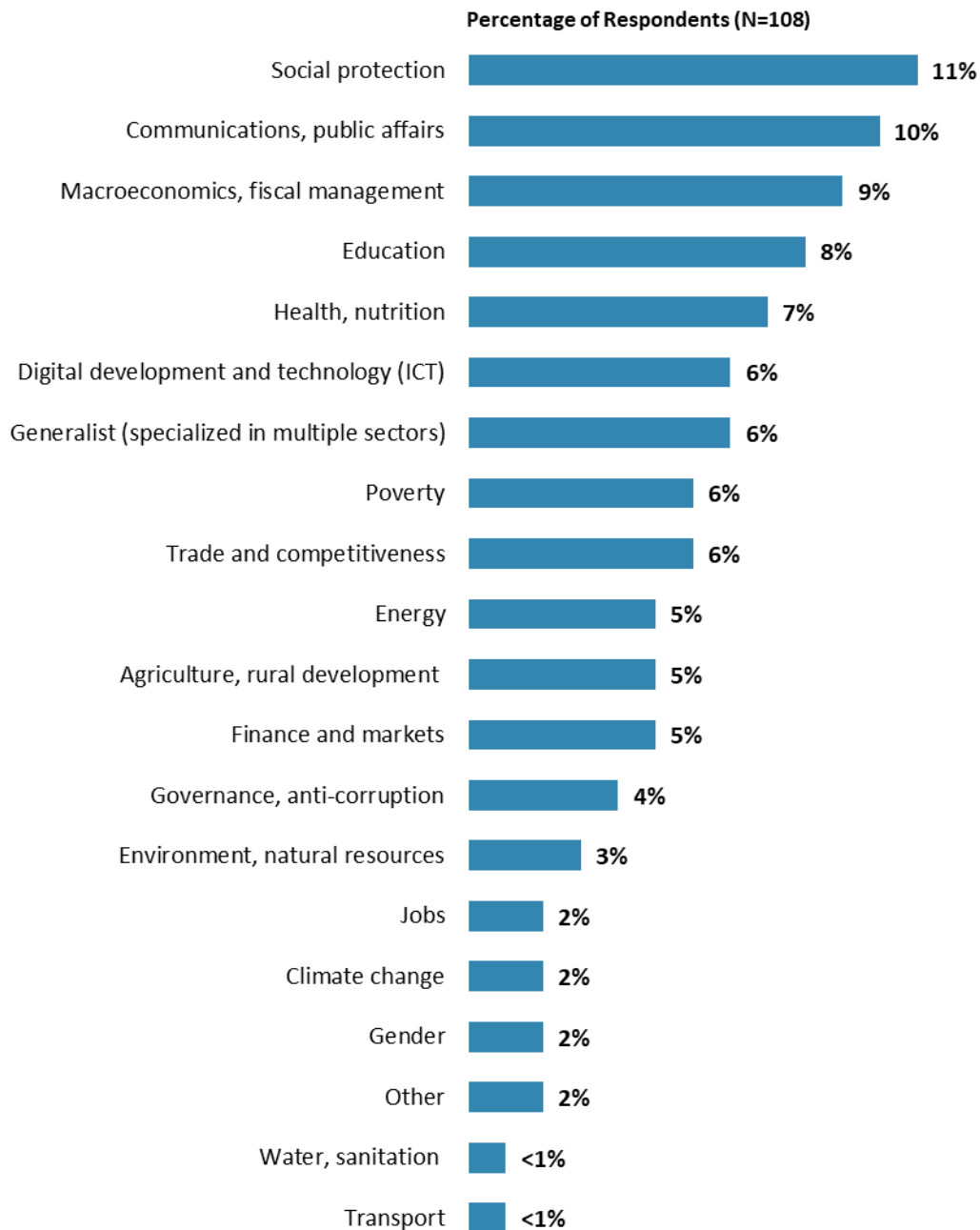

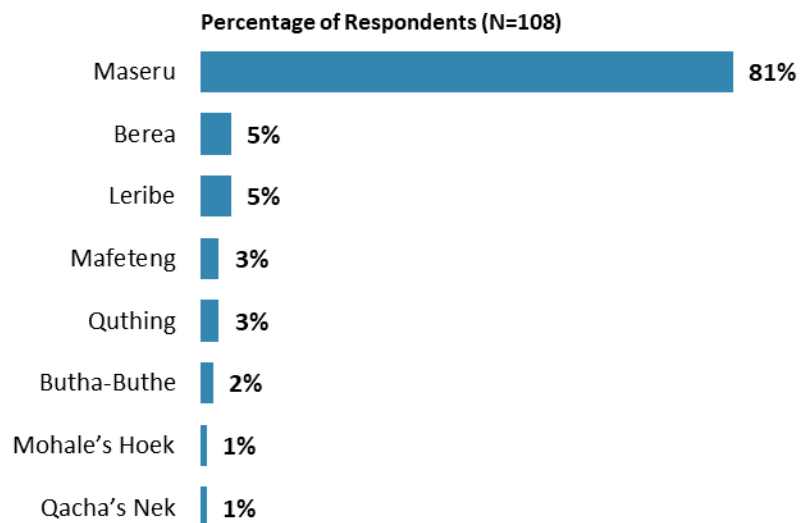


"Please identify the primary specialization of your work."

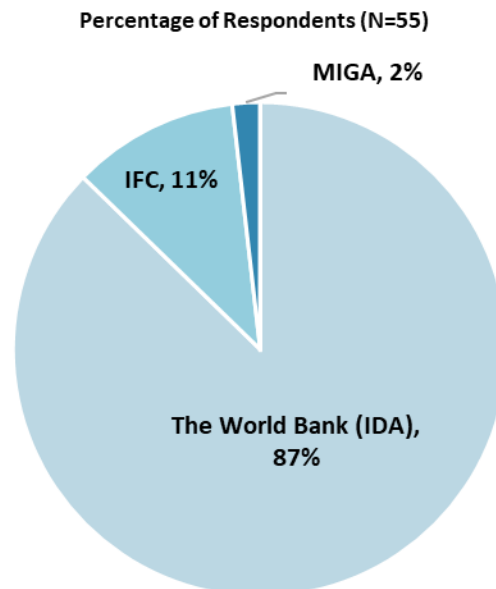

Exposure to Agencies within the World Bank Group



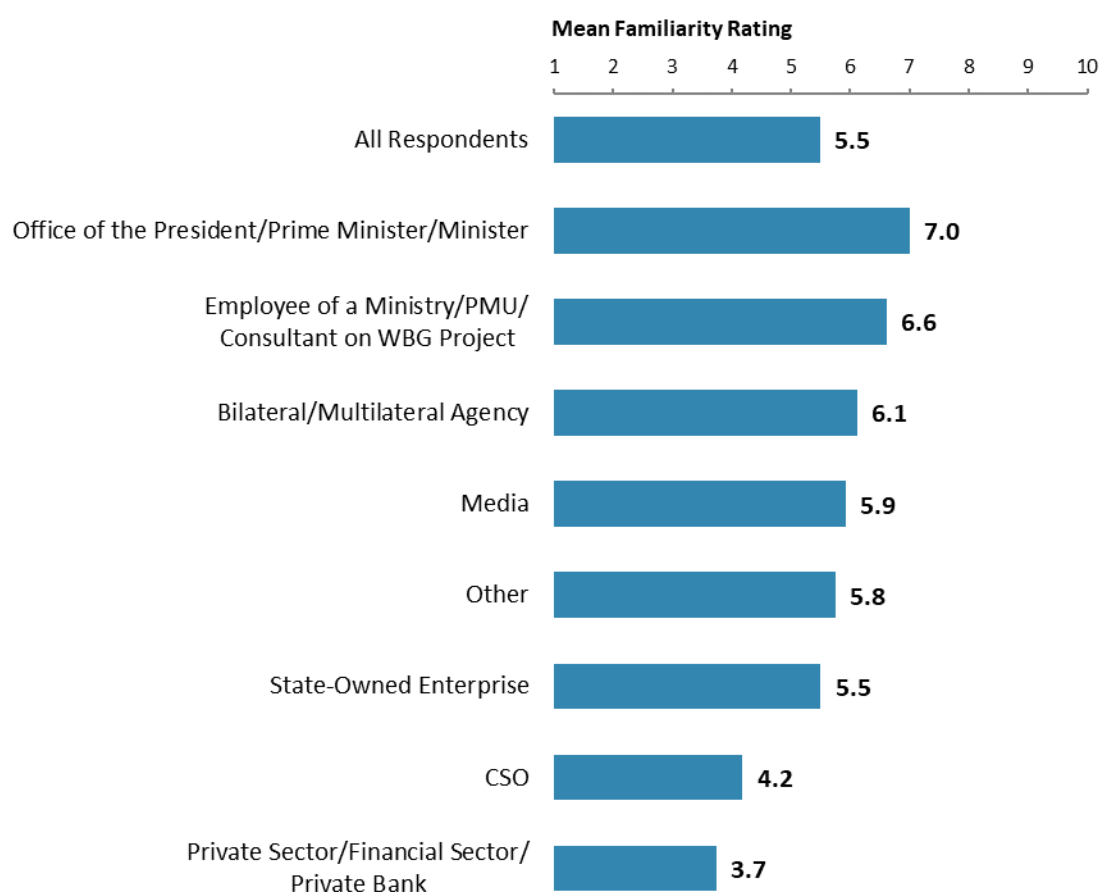
"Which of the following agencies of the World Bank Group do you primarily collaborate/work with in Lesotho?"

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had significantly lower levels of familiarity with the WBG compared to respondents in the FY'18 Country Survey (weighted mean in FY'21 = 5.7²; weighted mean in FY'18 = 6.8).³
- **Impact of familiarity:** Respondents' ratings of familiarity with the WBG were significantly, strongly correlated with their ratings for the WBG's overall effectiveness⁴ in Lesotho and with their agreement that the WBG plays a relevant role in Lesotho's development, and significantly, moderately correlated with their ratings of the extent to which the WBG's work helps achieve development results in Lesotho.

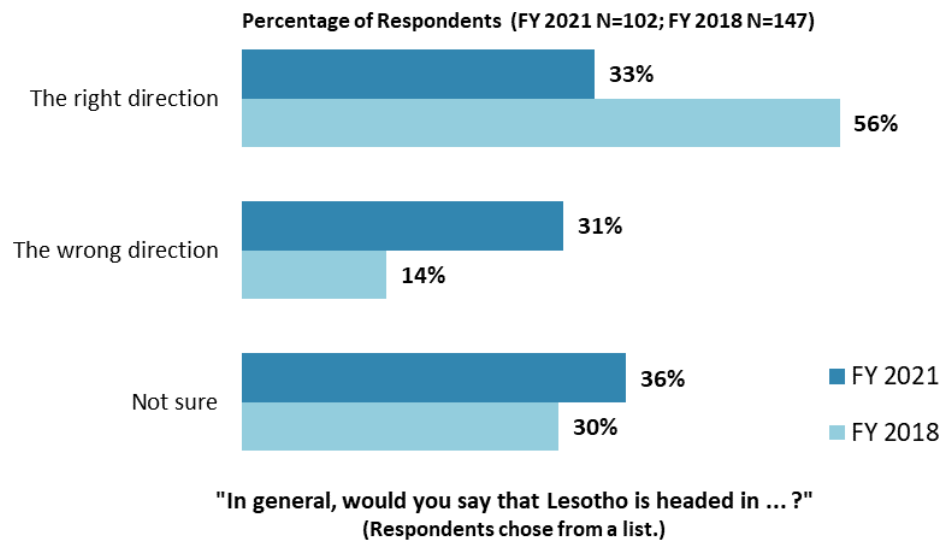

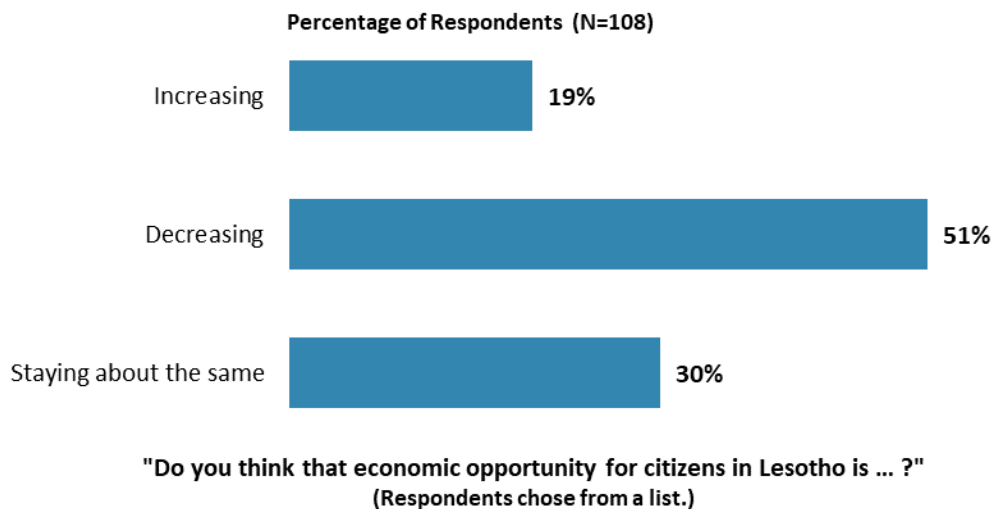

Perceptions of Economic Opportunity



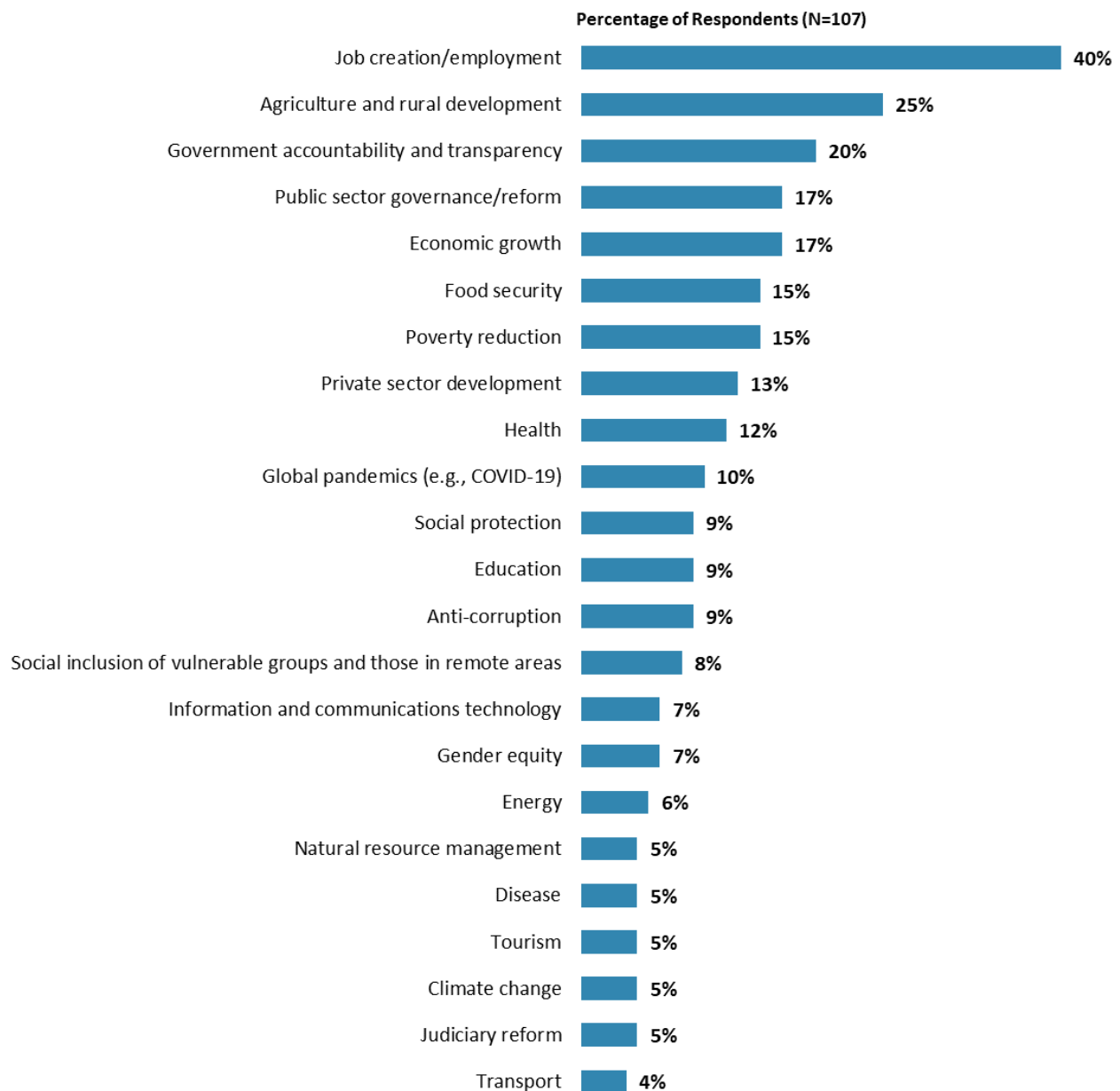

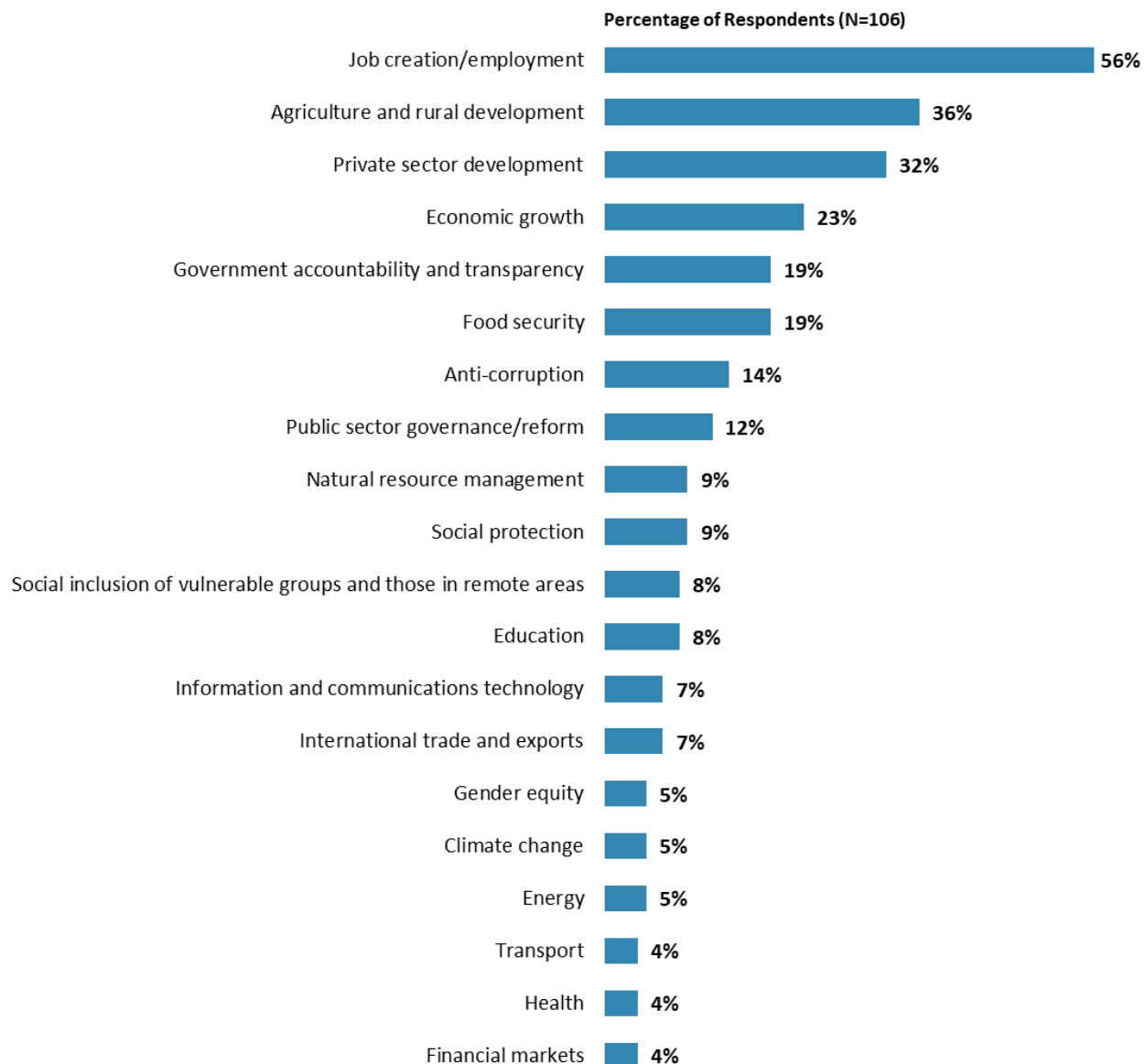

What Would Contribute Most to Reducing Poverty

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the biggest contributors to poverty reduction in Lesotho were “*economic growth*” (54%), “*job creation/employment*” (43%), “*agriculture and rural development*” (40%), “*private sector development*” (40%), and “*public sector governance/reform*” (20%).

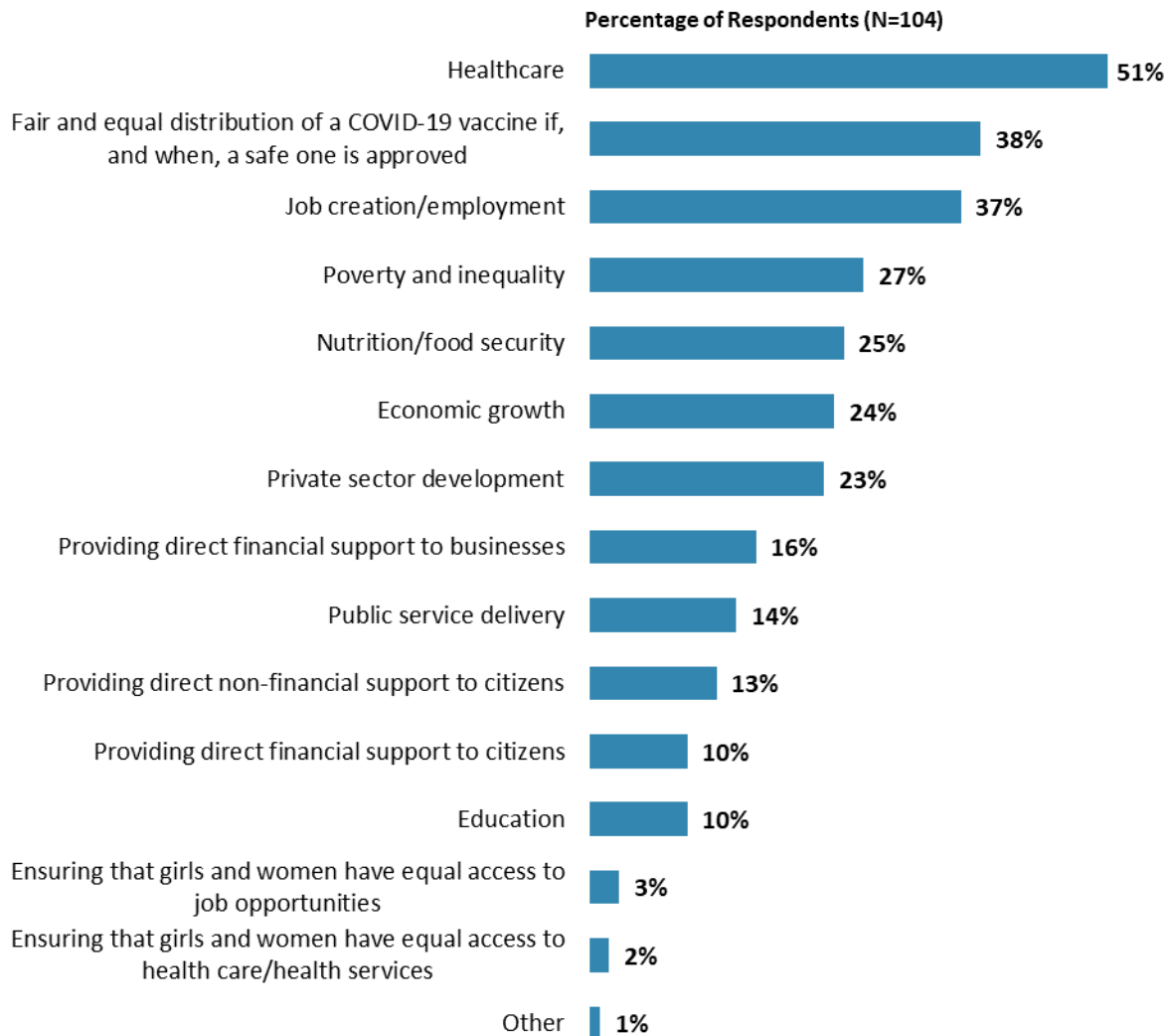

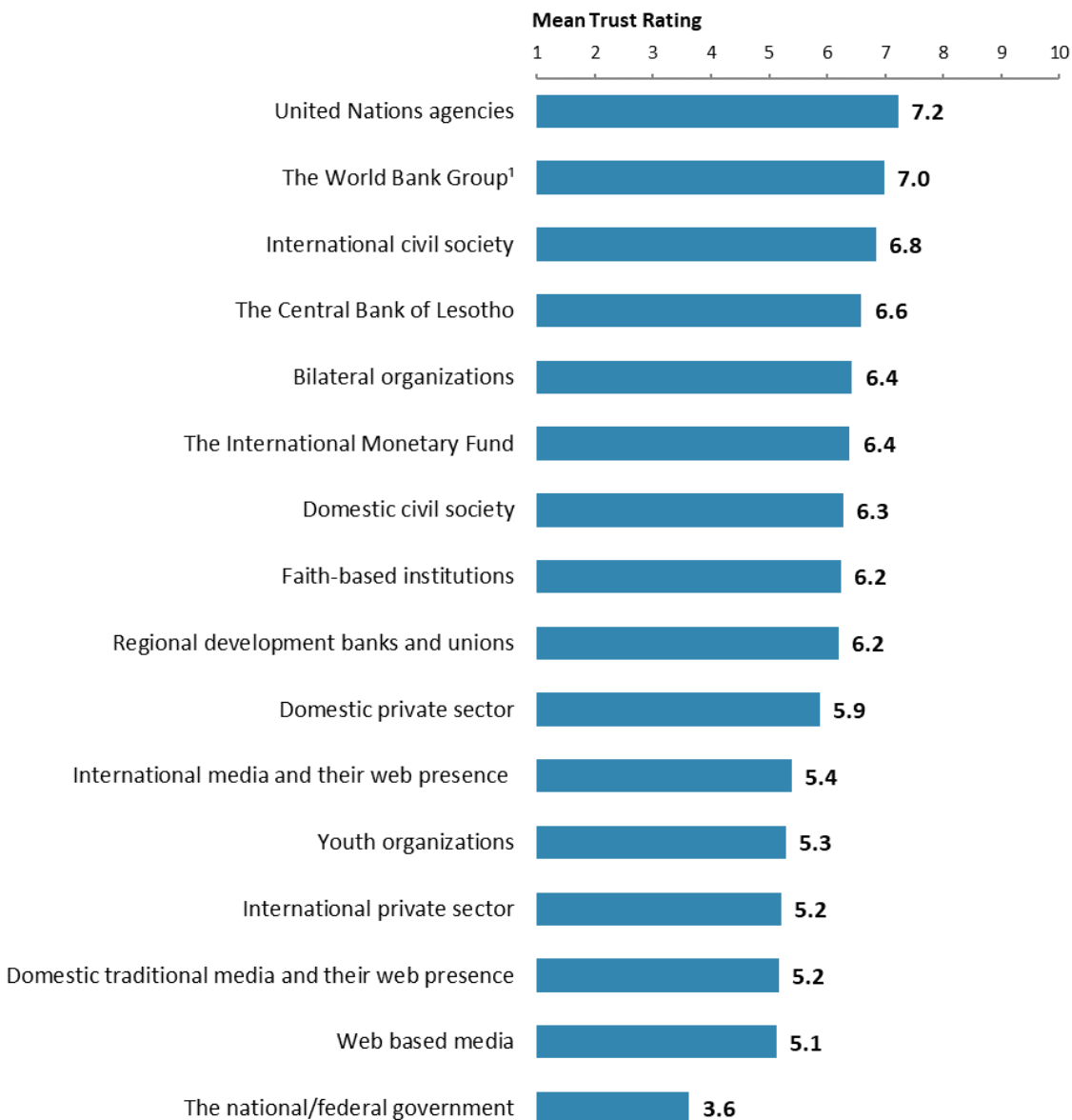

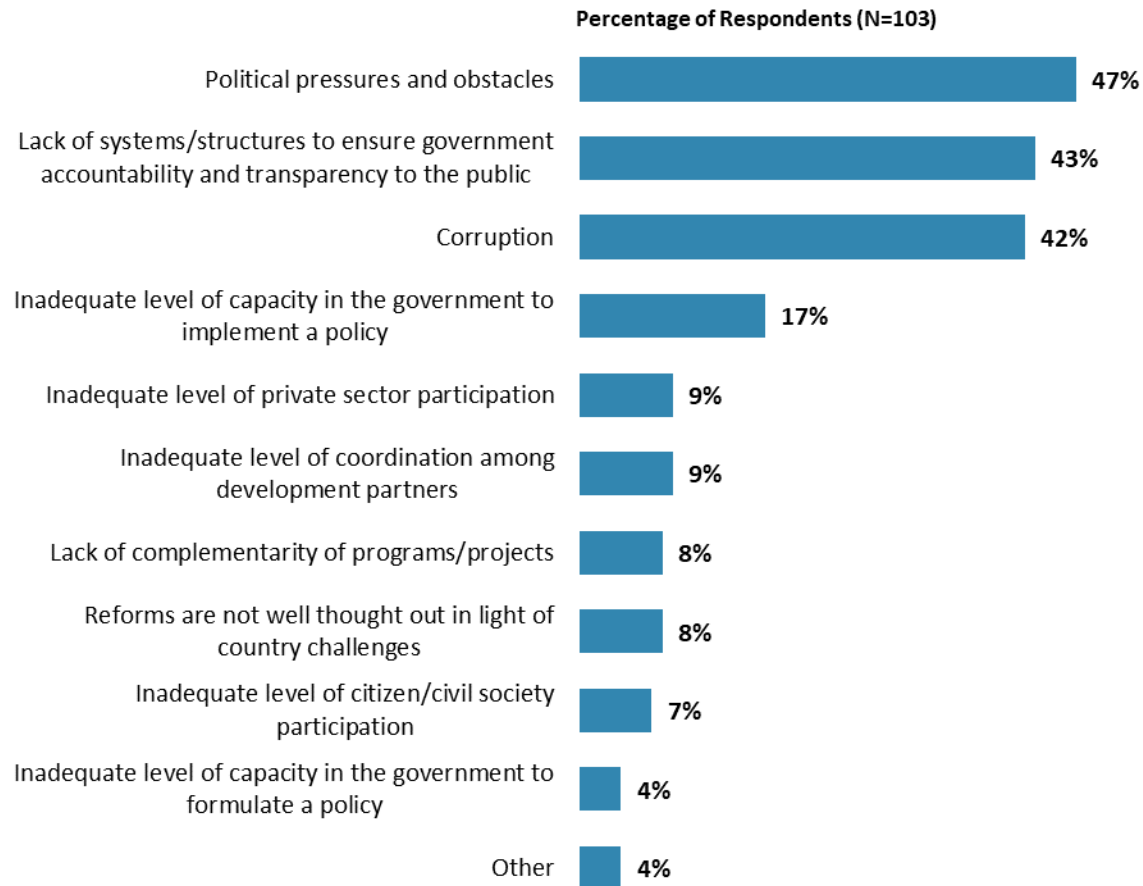

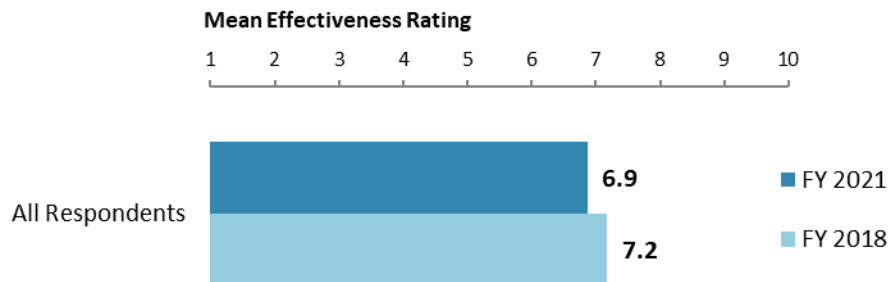


"When economic and/or social reform efforts fail or are slow to take place in Lesotho, which of the following would you attribute this to? (Choose no more than TWO)"

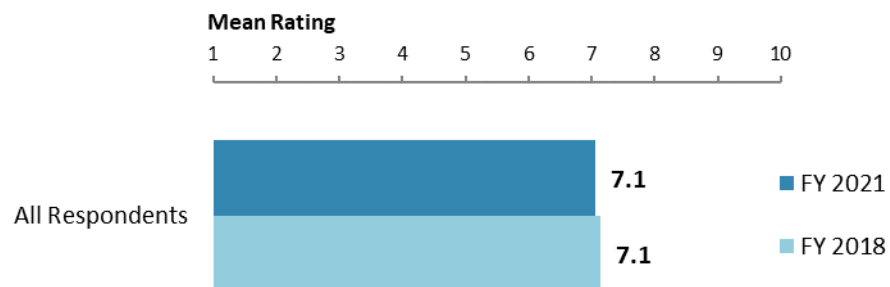

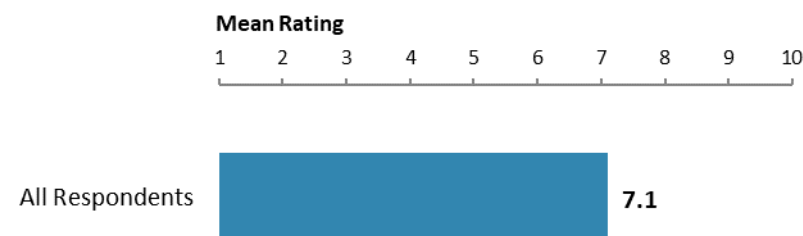

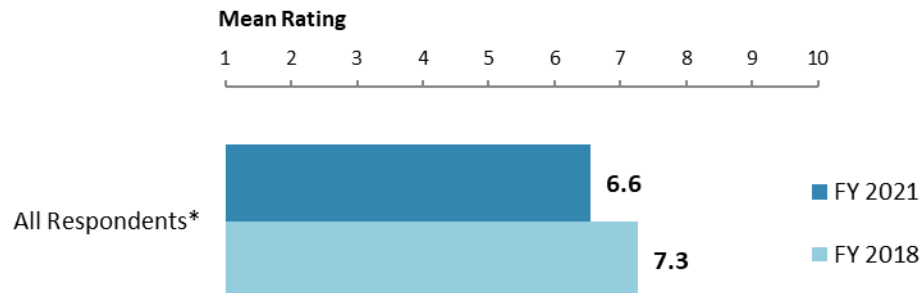

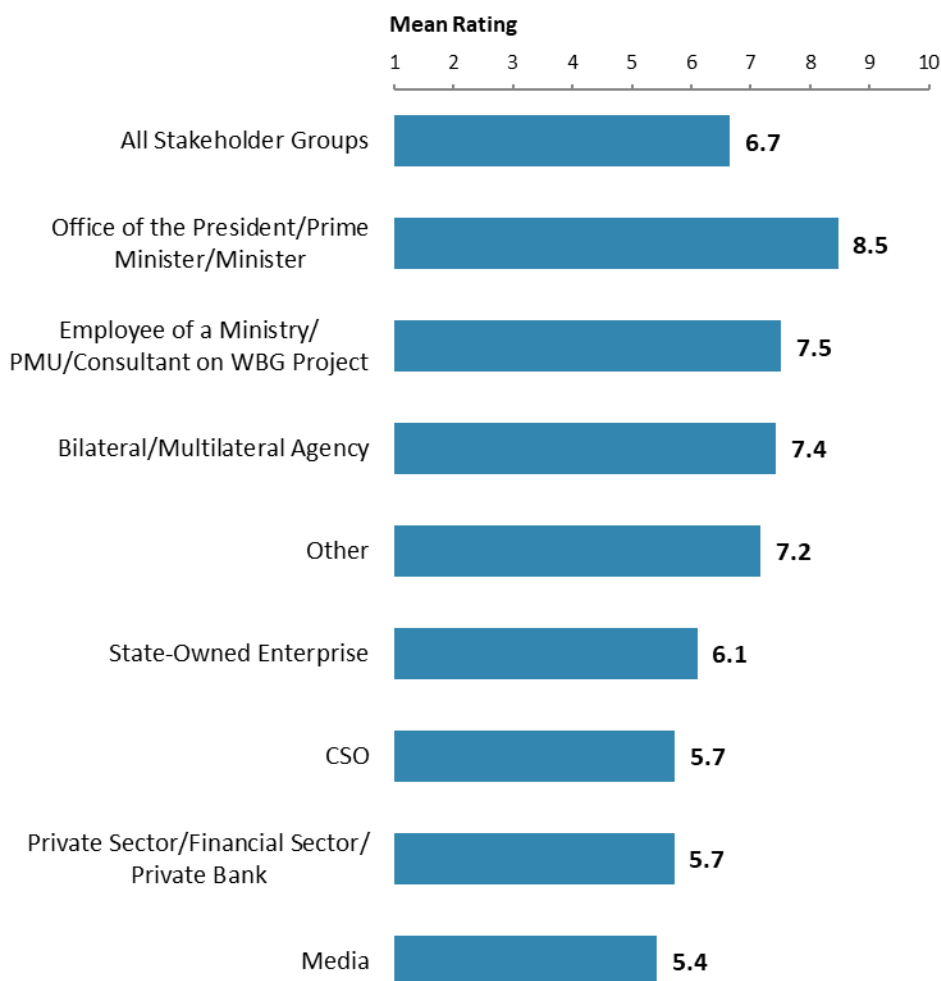

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-eight COS indicator questions (mean rating = 7.3) compared to respondents who do not collaborate with the WBG (mean rating = 5.8). Responses for individual indicator questions by exposure to the WBG can be found in Appendix E (page 88).
- **Stakeholder groups:** Respondents from the office of the President/Prime Minister/Minister had the highest mean ratings for the aggregated responses to the twenty-eight COS indicator questions, whereas respondents from the media had significantly lower mean ratings. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (page 59).



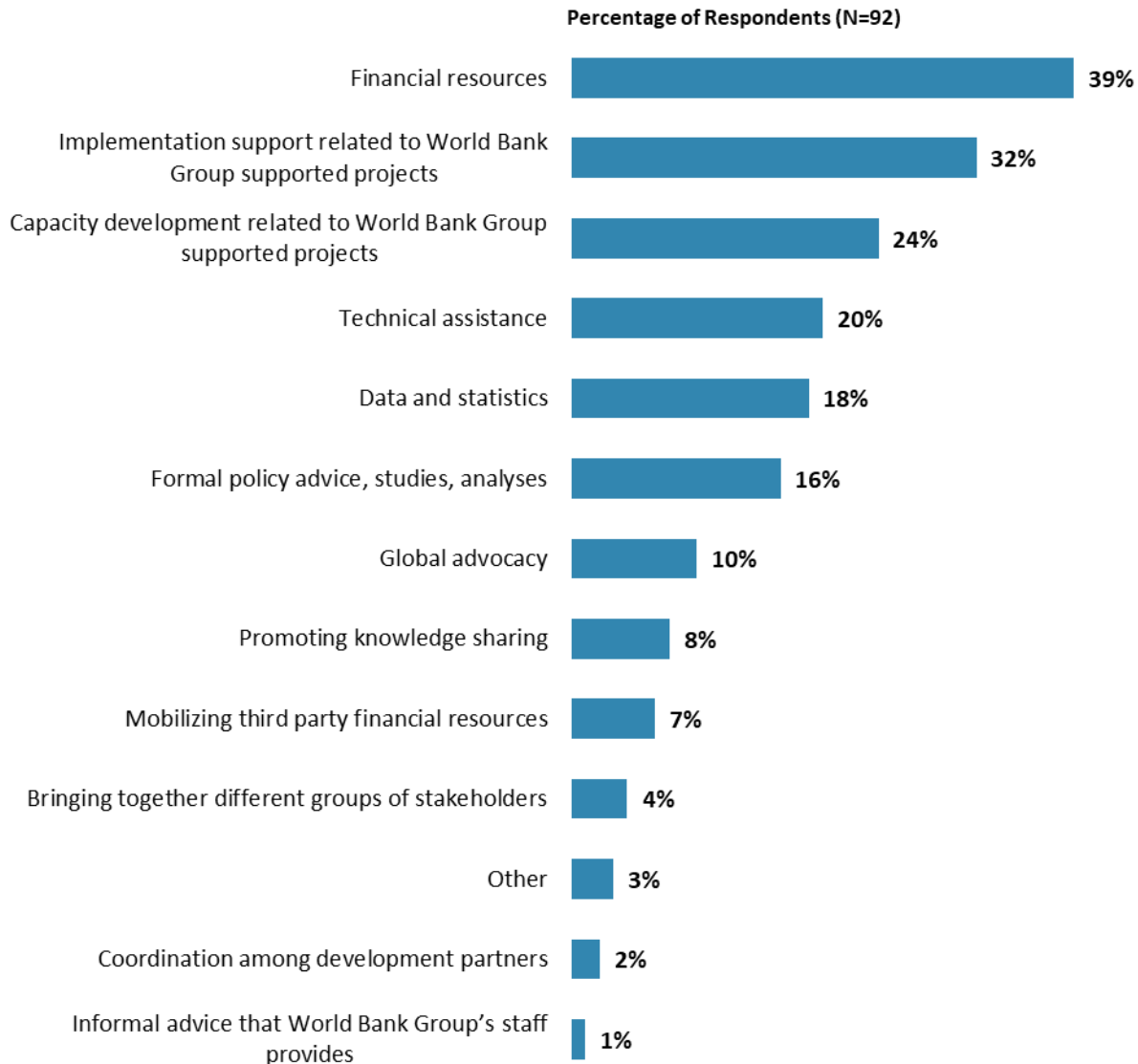
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the WBG's greatest values to Lesotho were "*financial resources*" (39%), "*capacity development related to World Bank Group supported projects*" (35%), and "*policy advice, studies, analyses*" (27%).



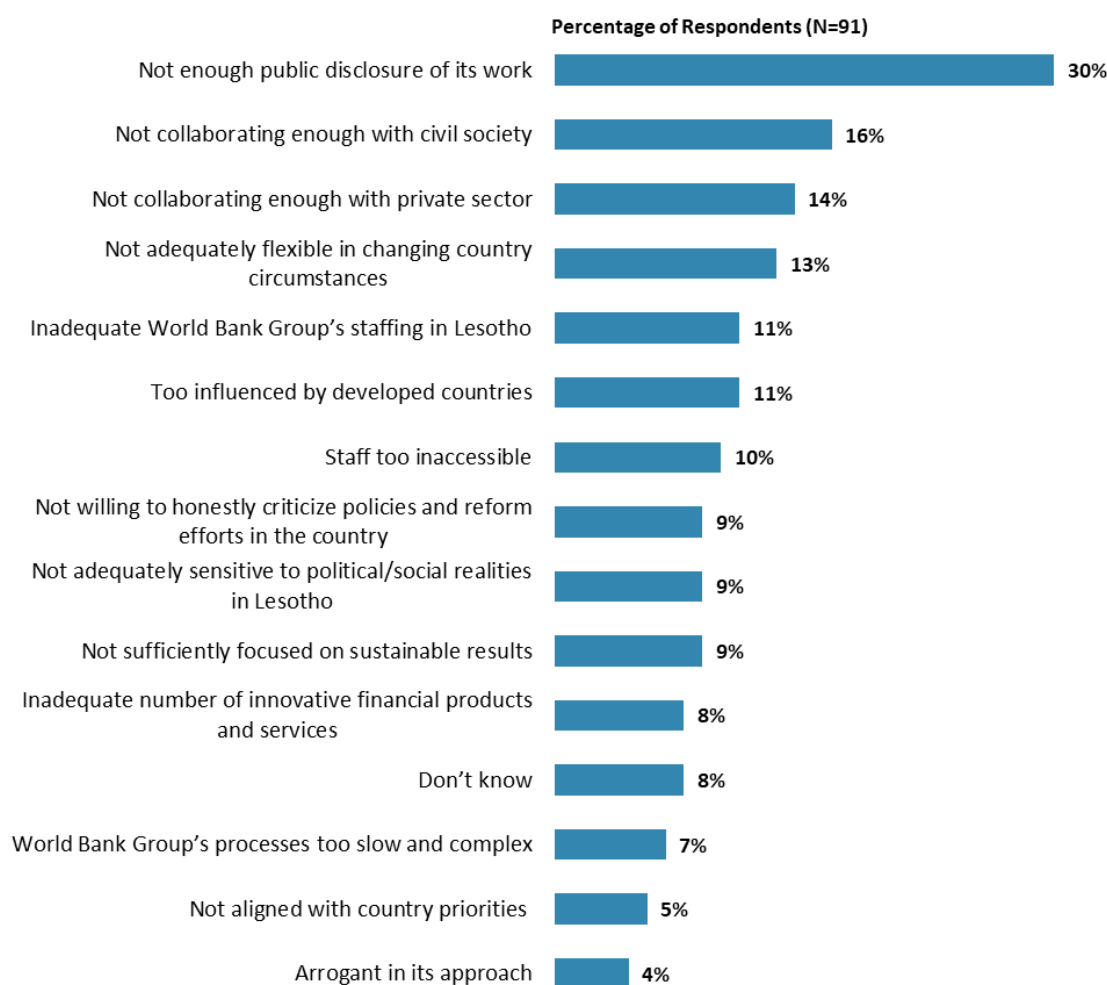
"When thinking about the World Bank Group's role in Lesotho, which activity do you VALUE the most? (Choose no more than TWO)"

Greatest Weakness

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the WBG's greatest weaknesses in its work in Lesotho were "*not collaborating enough with stakeholders outside the Government*" (23%), "*not willing to honestly criticize policies and reform efforts in the country*" (19%), and "*not enough public disclosure of its work*" (18%).
- **Impact of familiarity:** Respondents who had higher levels of familiarity⁸ with the work of the WBG in Lesotho indicated that the WBG's greatest weaknesses were "*not enough public disclosure of its work*" (27%), "*not adequately flexible in changing country circumstances*" (23%), "*not adequately sensitive to political/social realities in Lesotho*" (17%), and "*not collaborating enough with civil society*" (17%).

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁹



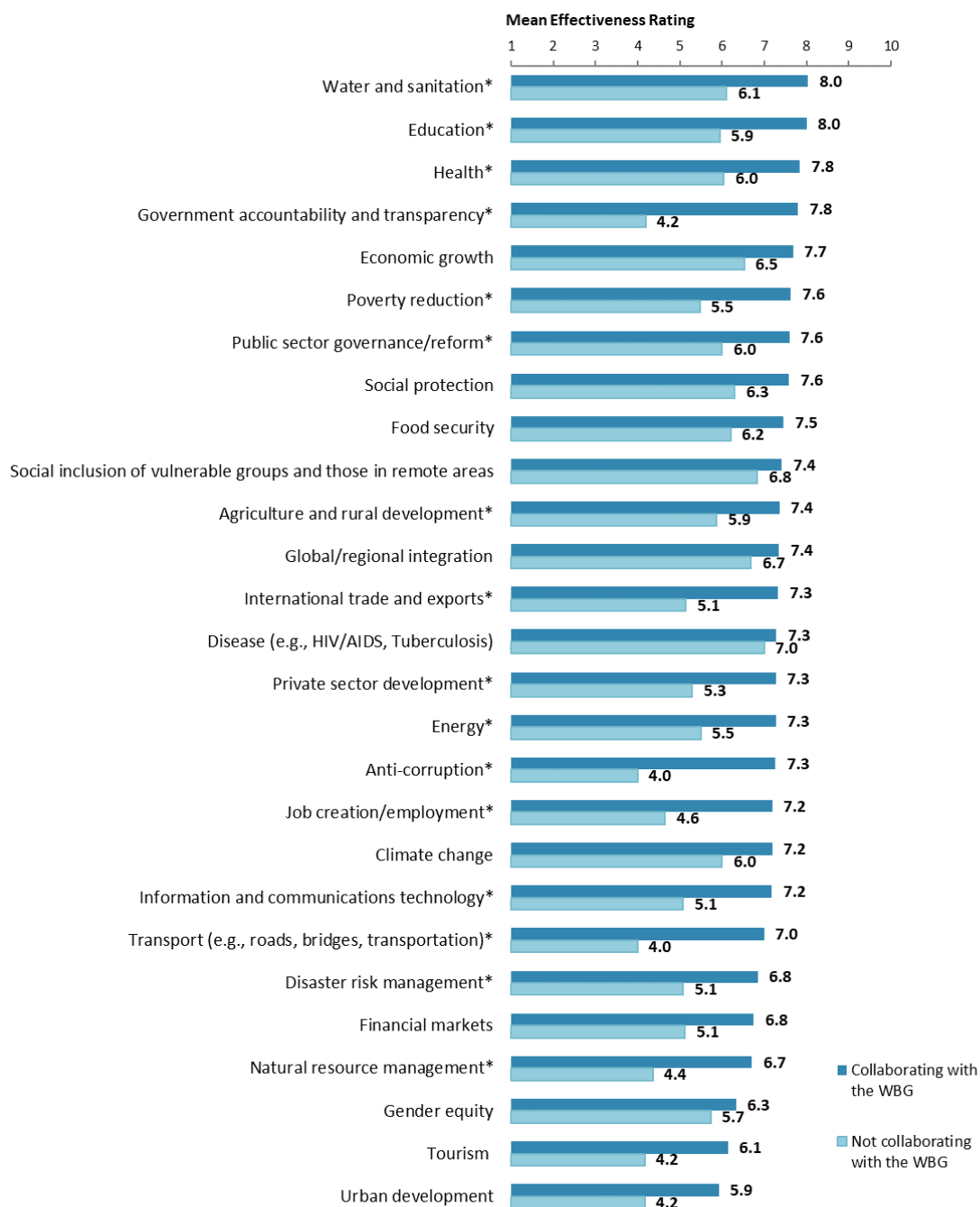
"How EFFECTIVE do you believe the World Bank Group is in terms of the work it does in the following areas of development in Lesotho?"

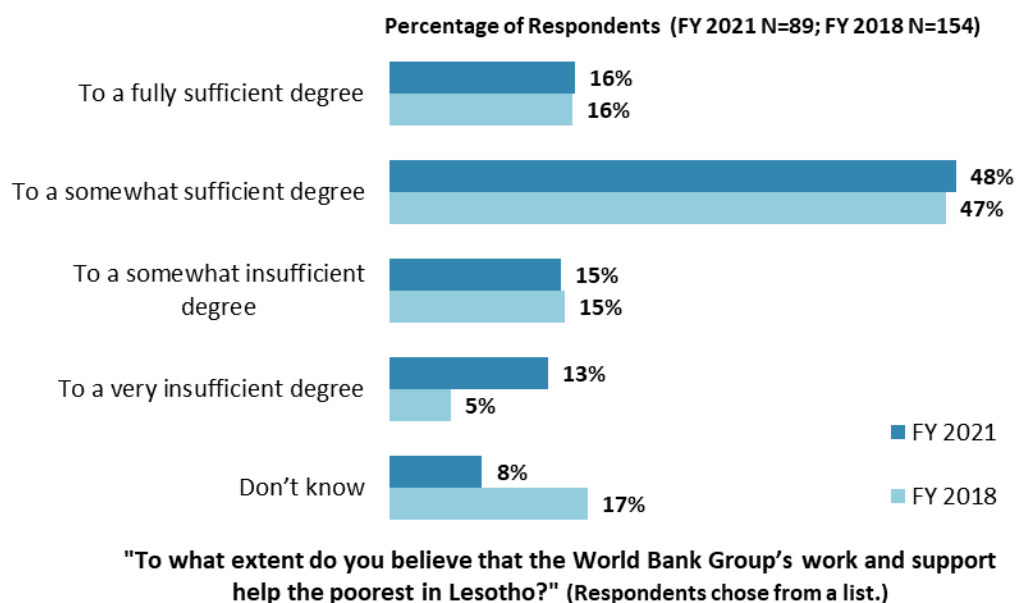

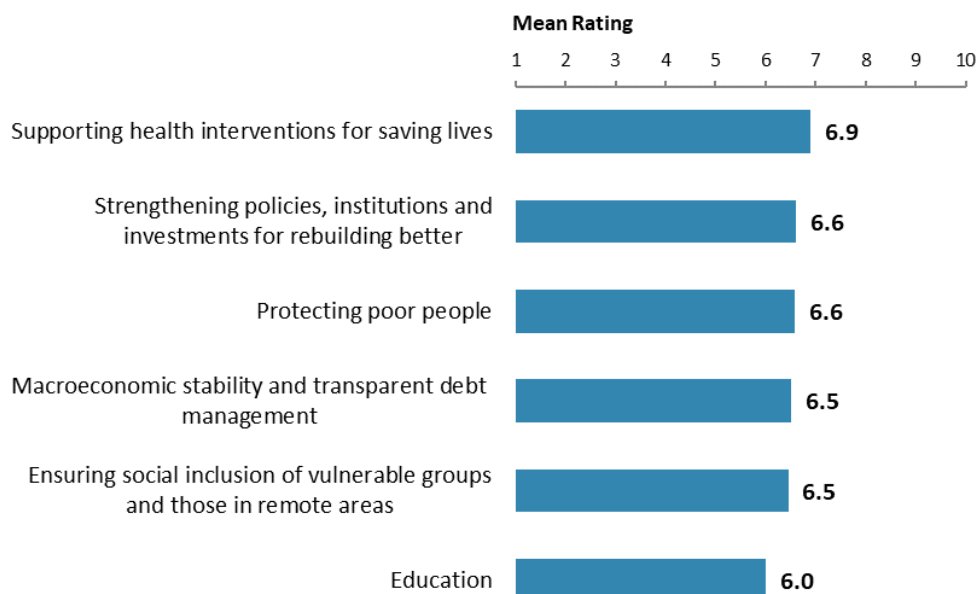

Support related to COVID-19 outbreak



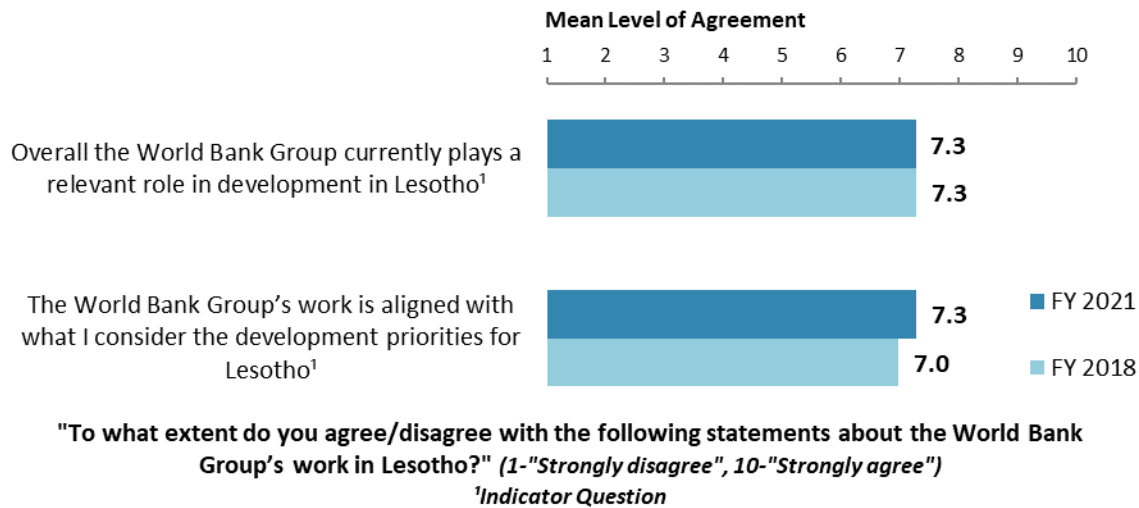

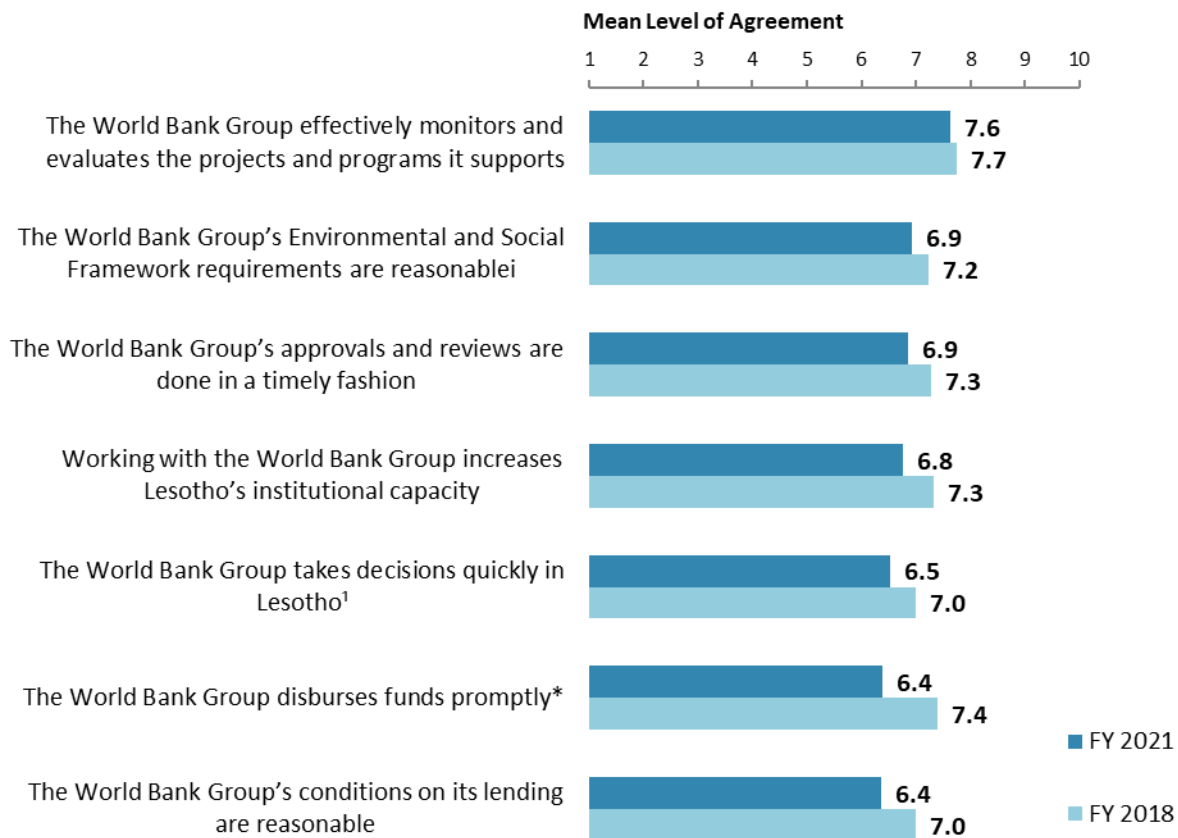

Overall Perceptions: Year Comparison¹³



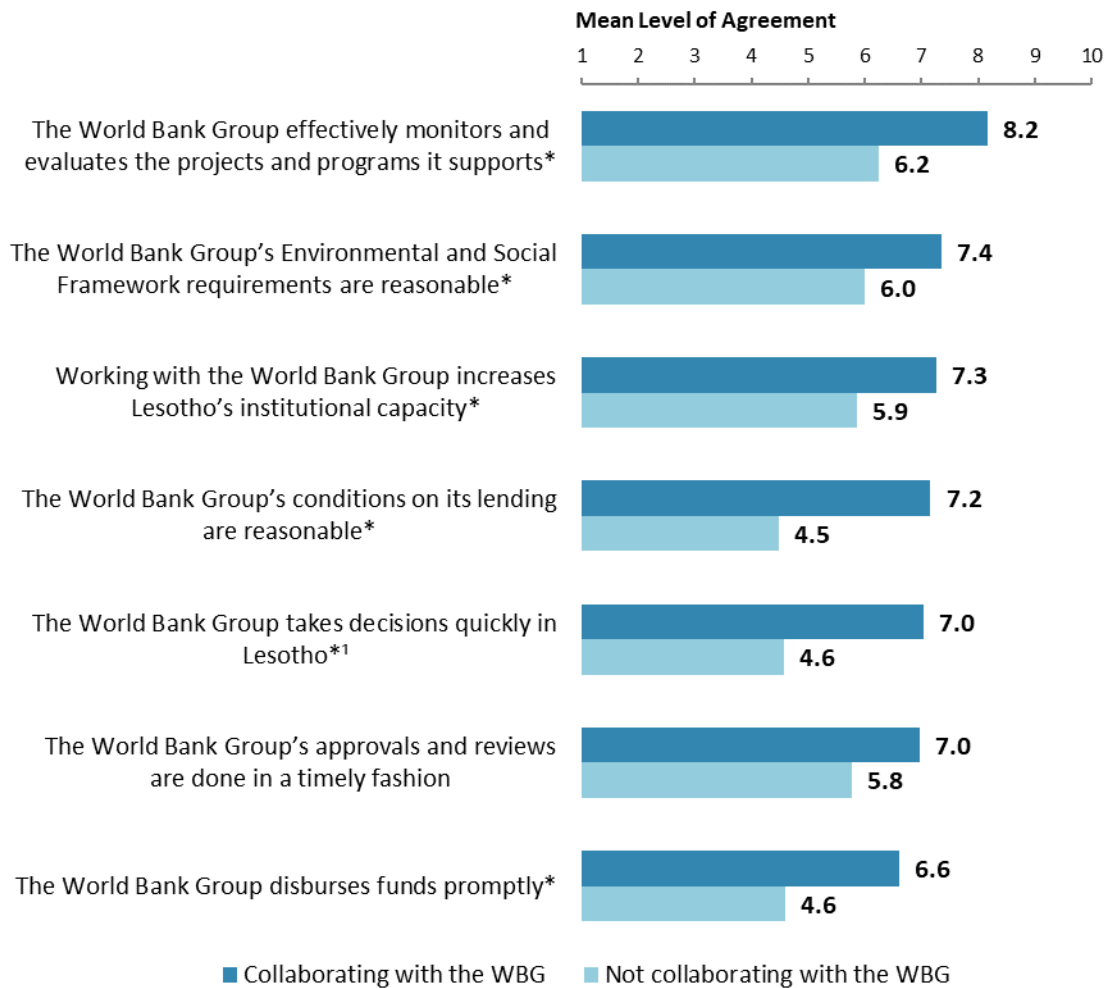

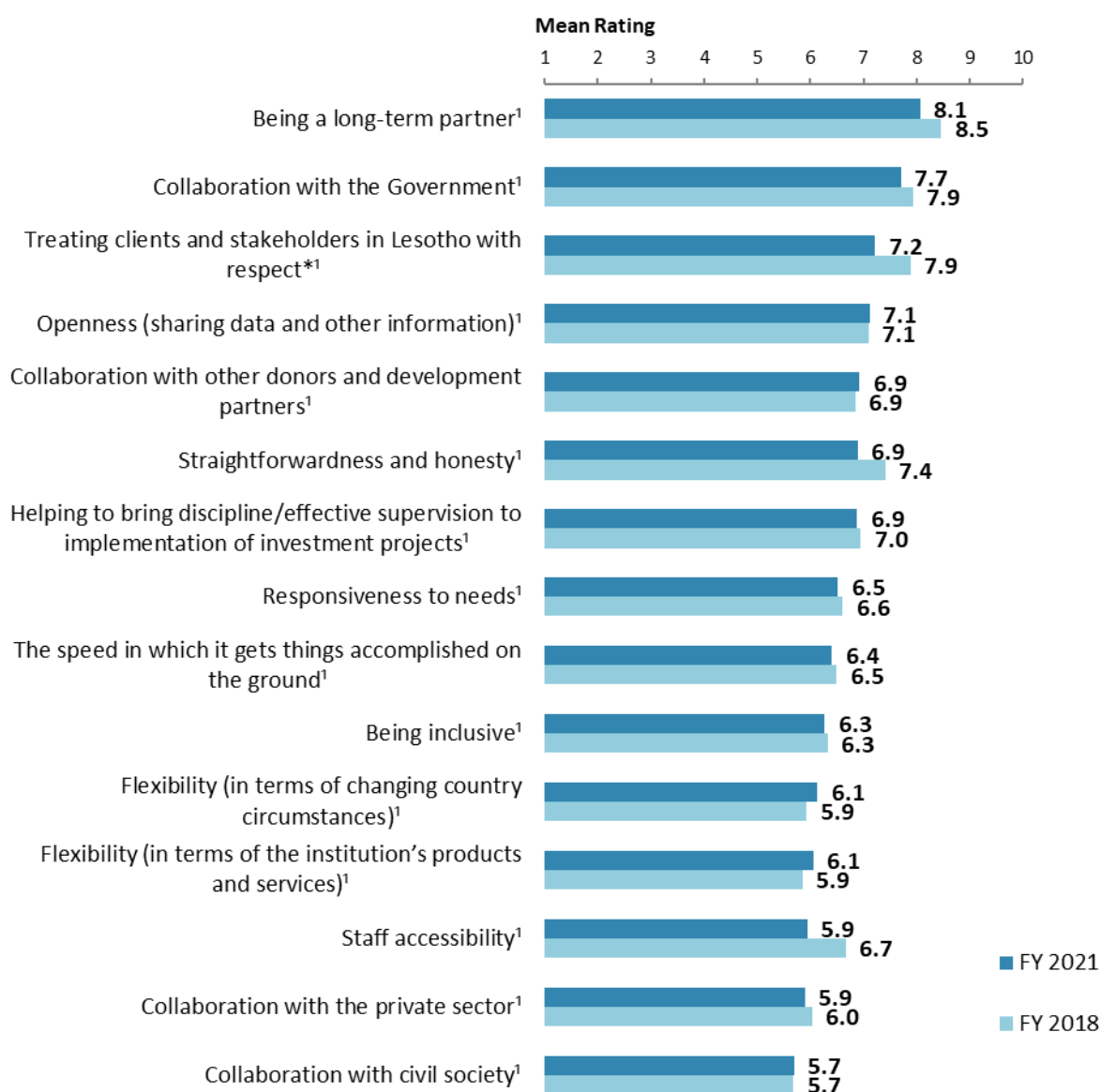

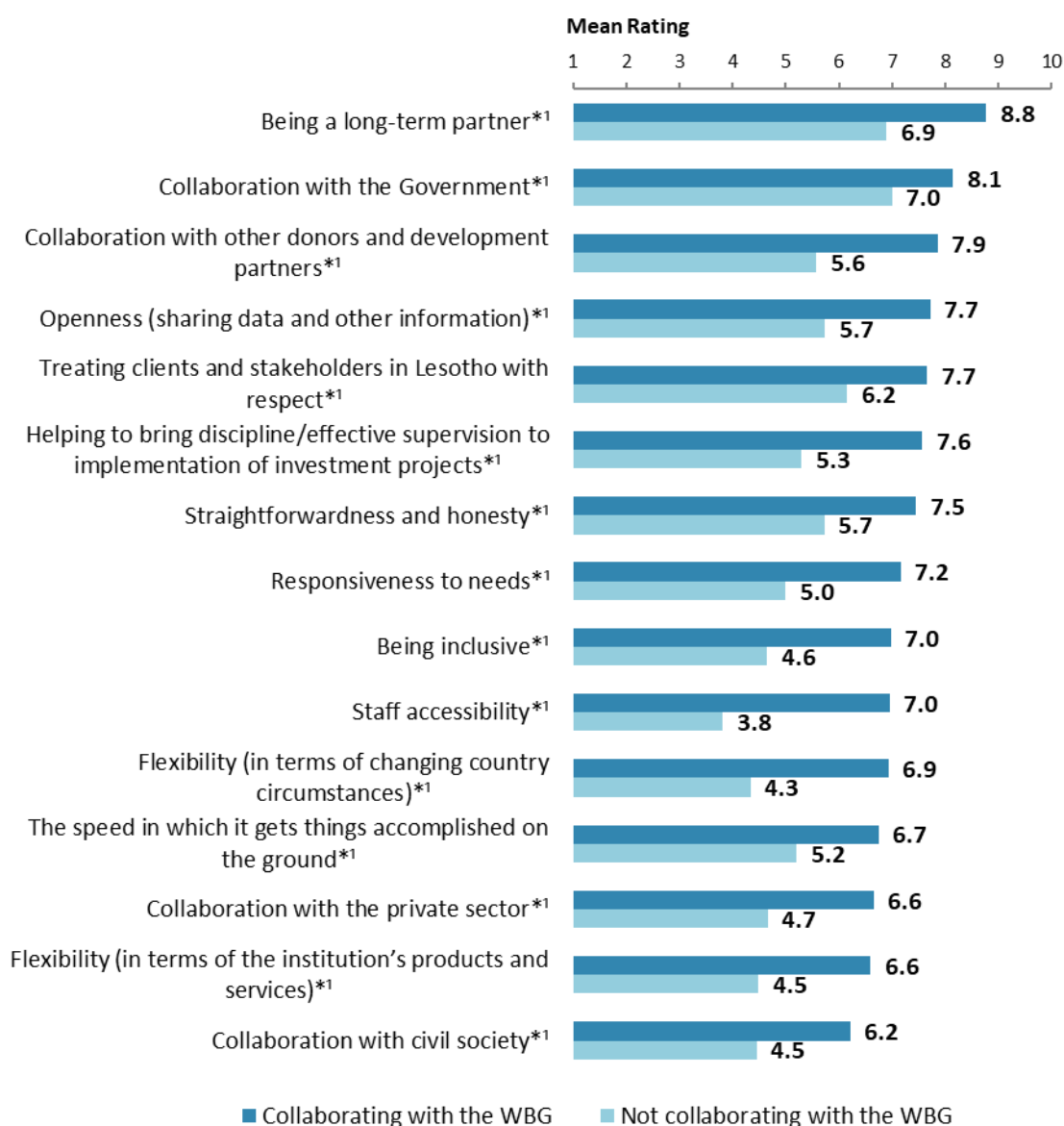

"To what extent is the World Bank Group an effective development partner in Lesotho, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")

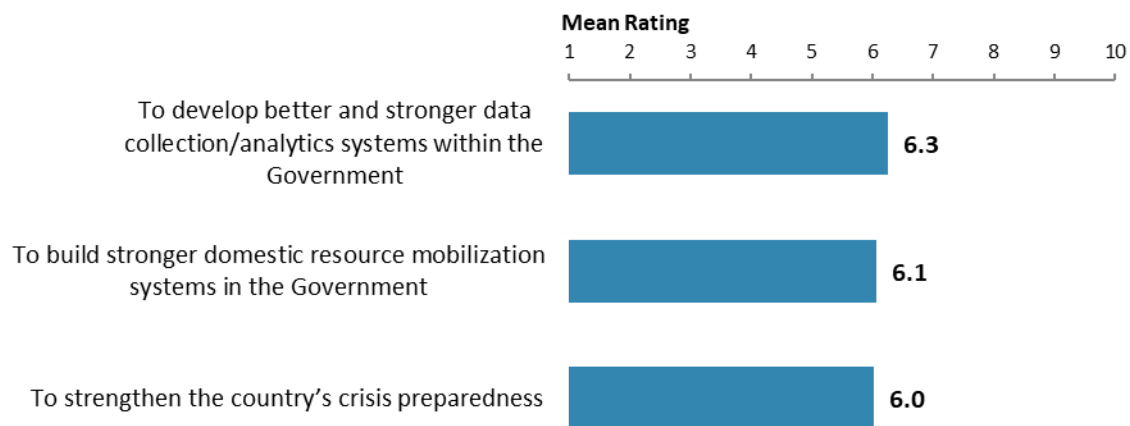

Effectiveness of WBG's Support¹⁵



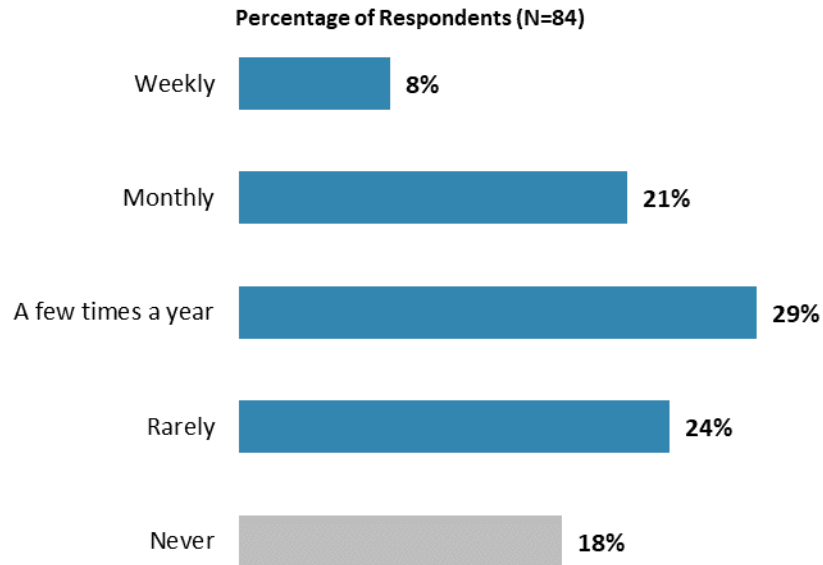
"How effectively does the World Bank Group support Lesotho's efforts ... ?"

Frequency of Consulting WBG Knowledge Work and Activities

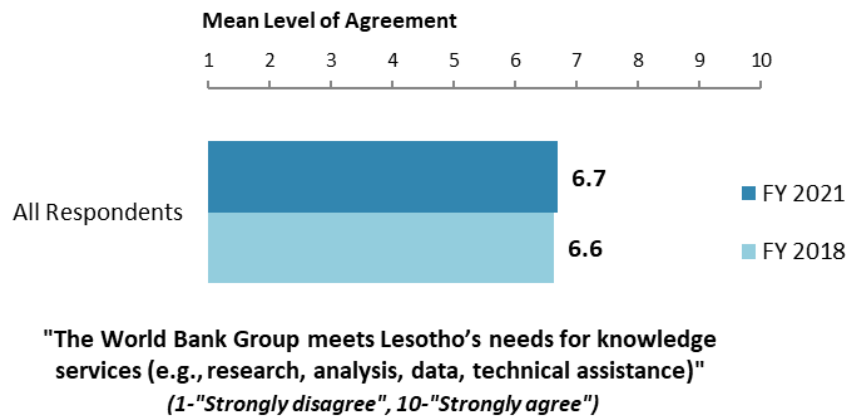


"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"

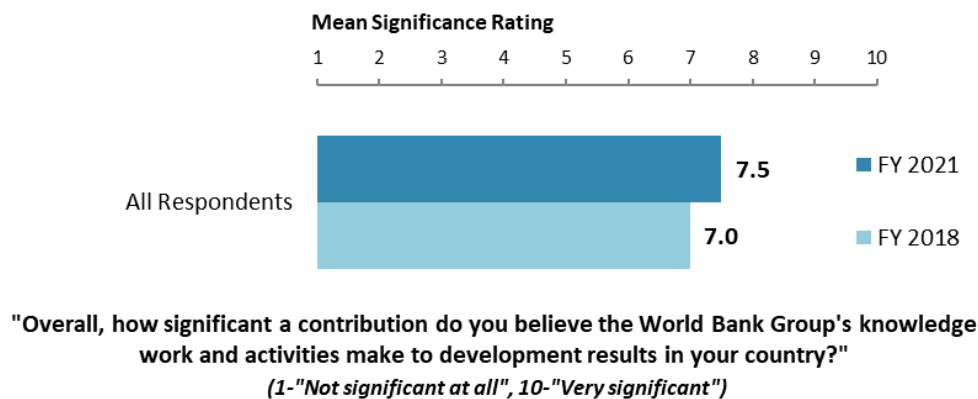

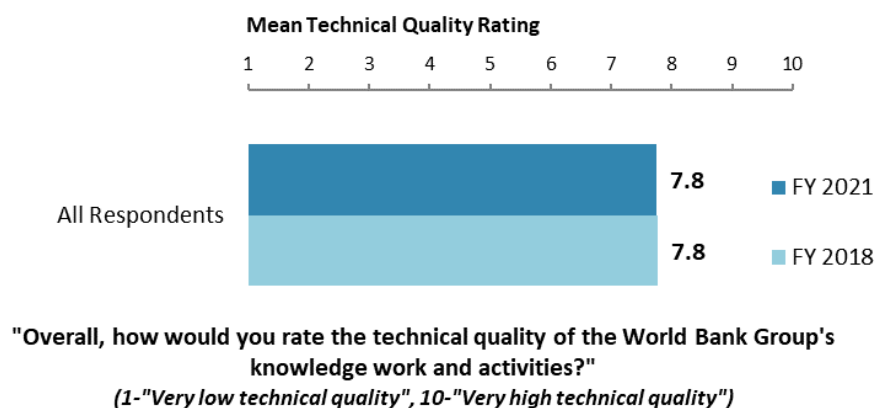
Meeting Lesotho's Knowledge Needs¹⁶ (*Indicator Question*)

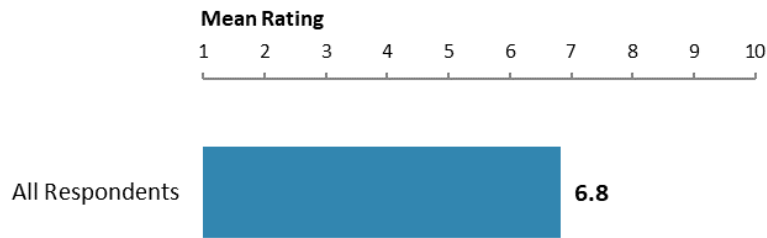

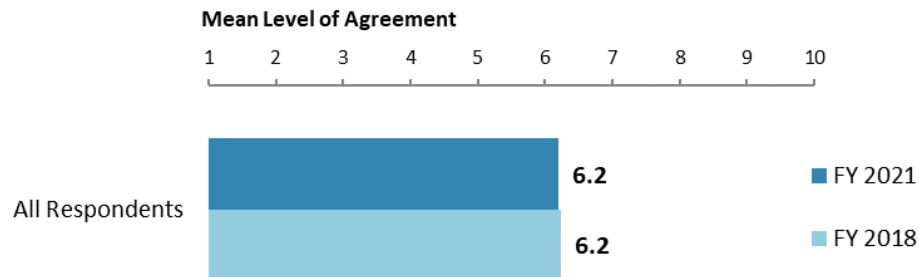

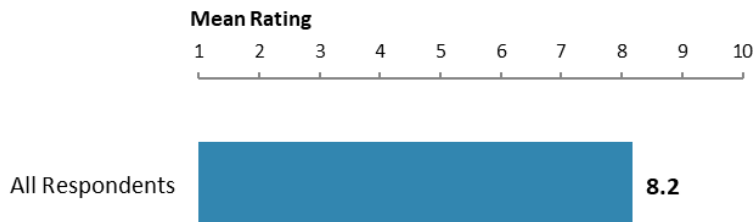

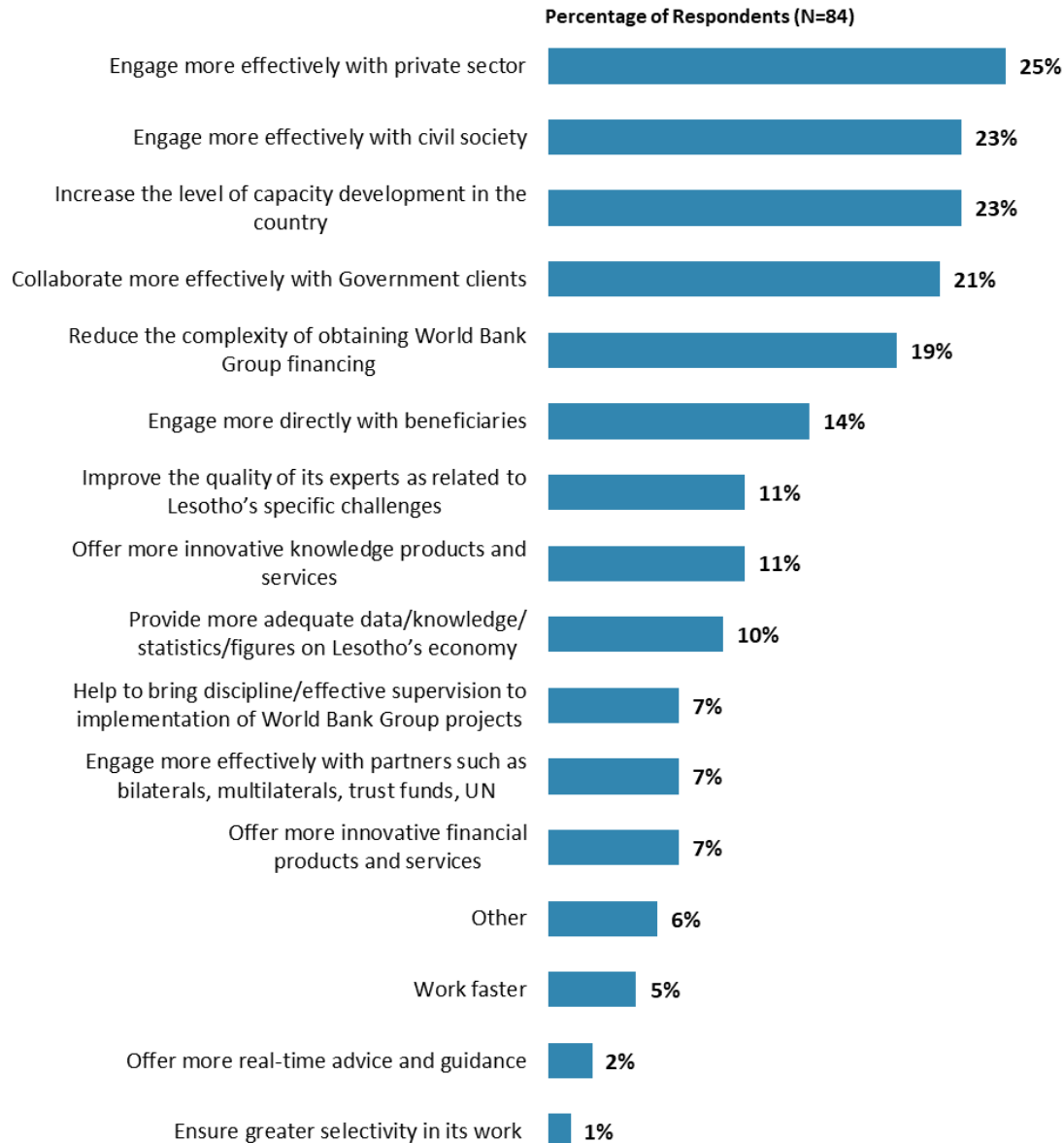

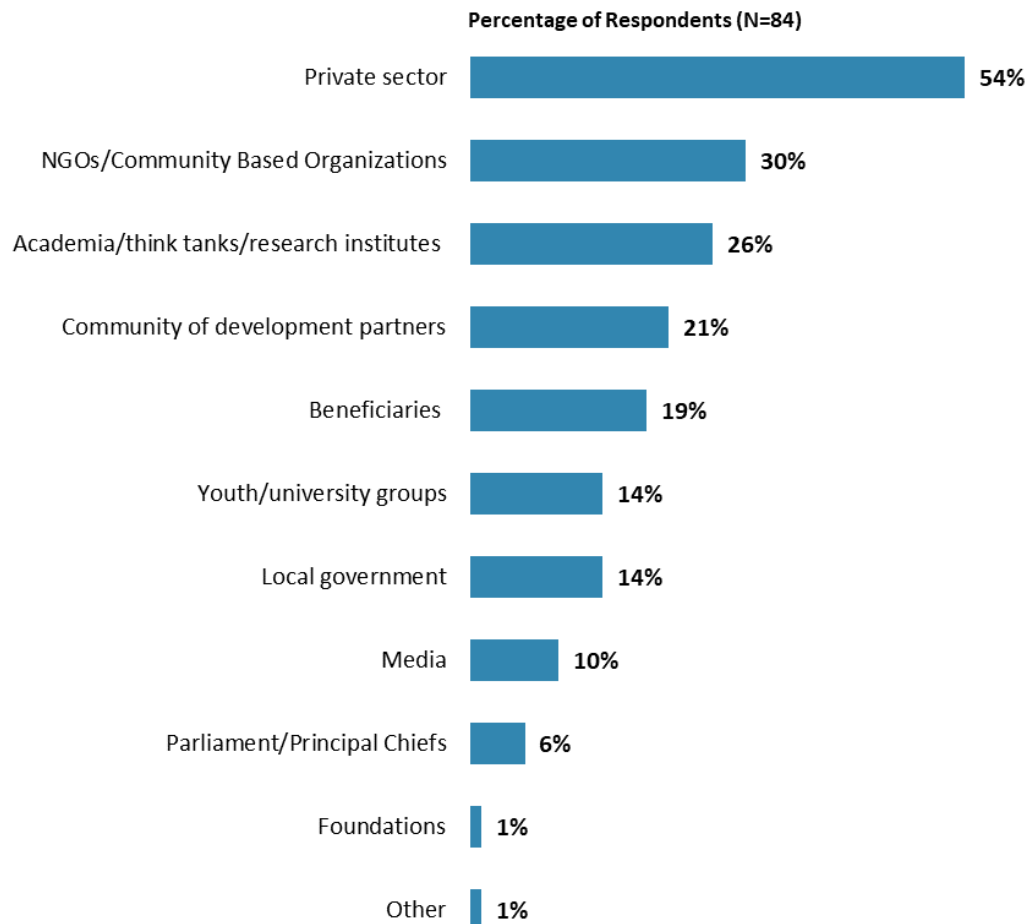
"Which of the following SHOULD the World Bank Group do to make itself of greater value in Lesotho? (Choose no more than TWO)"

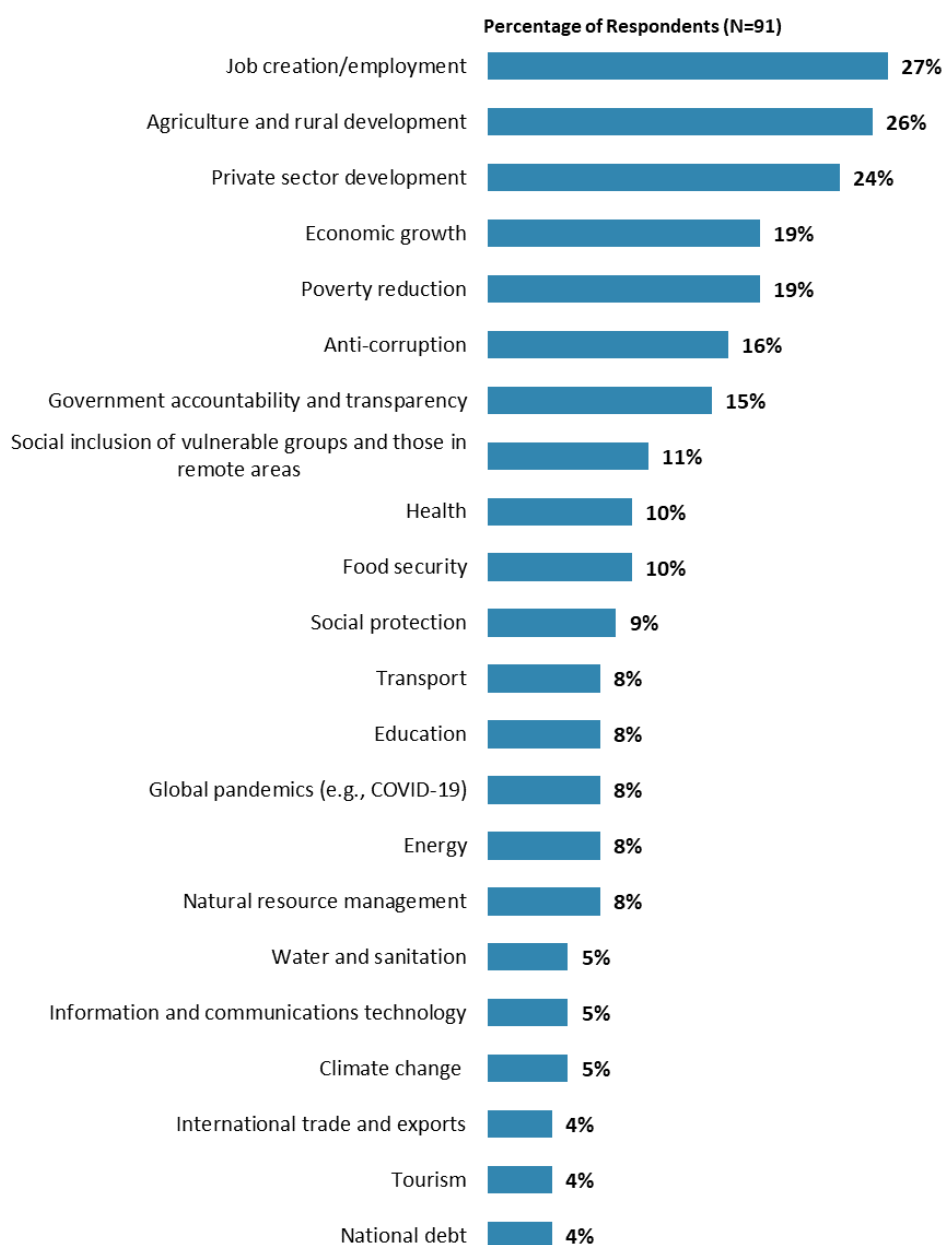
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"

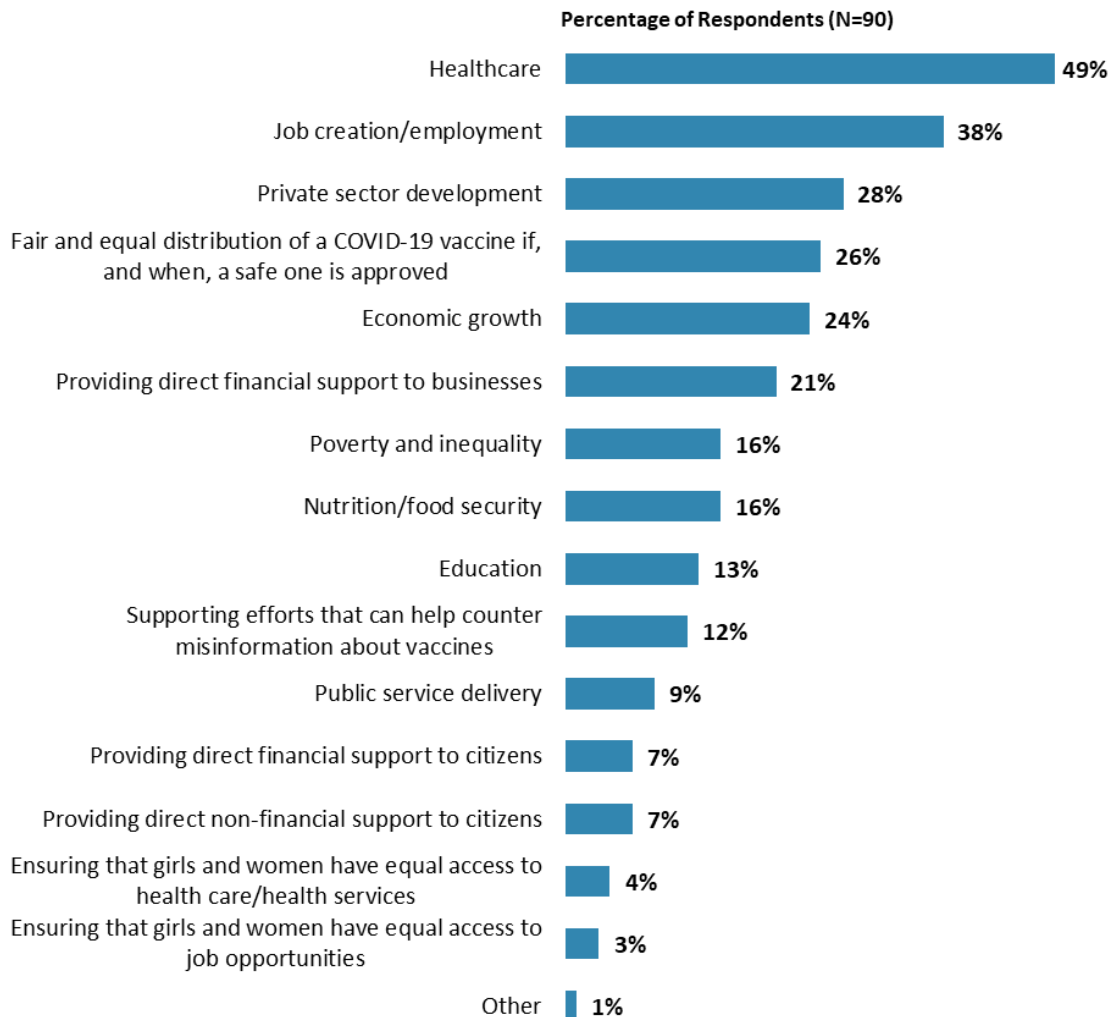

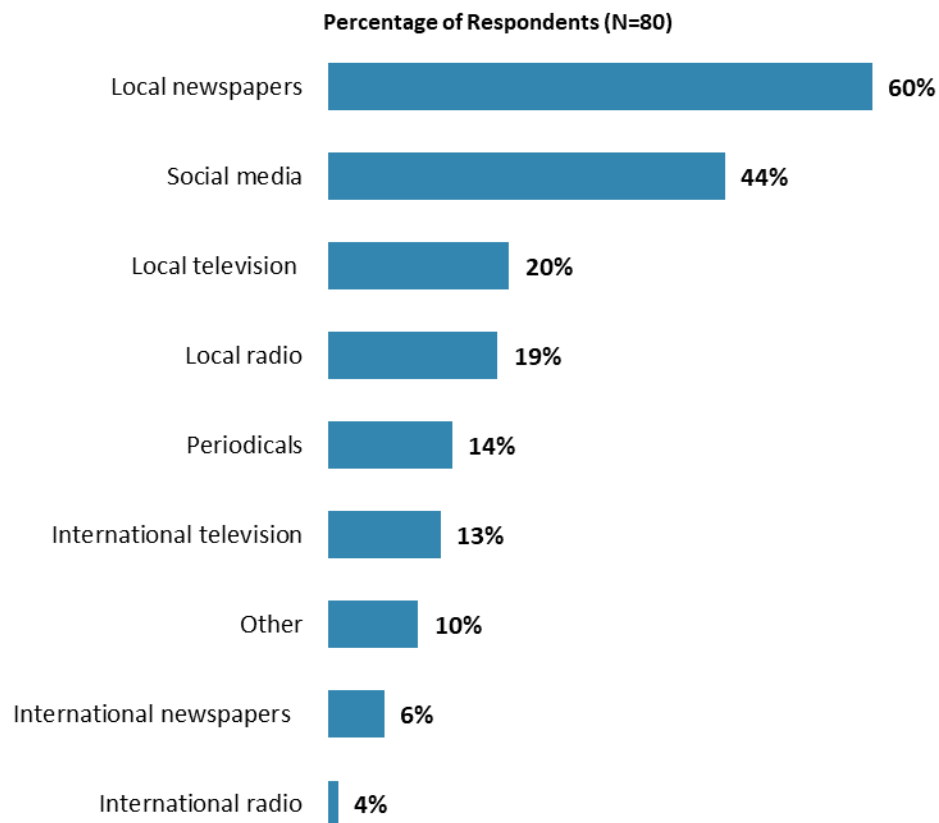

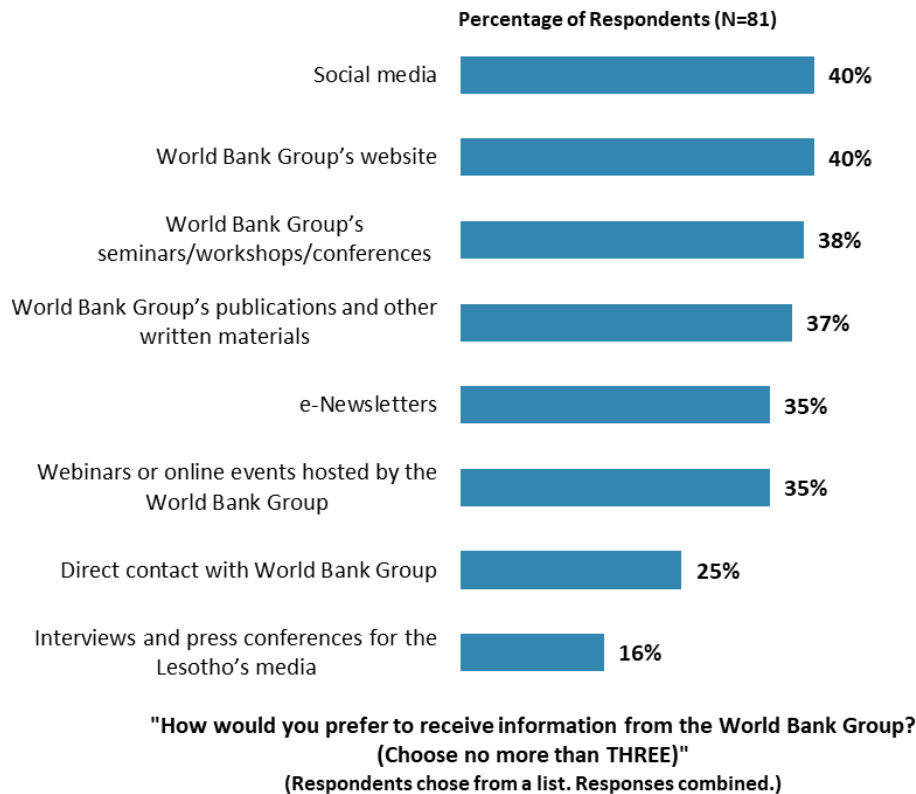
"How do you get most of your information about economic and social development issues in Lesotho? (Choose no more than TWO)"
(Respondents chose from a list. Responses combined.)



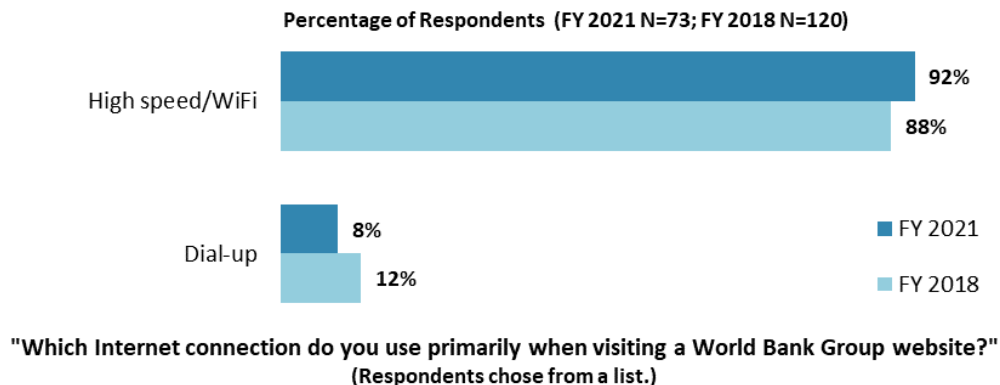

Internet connection¹⁹

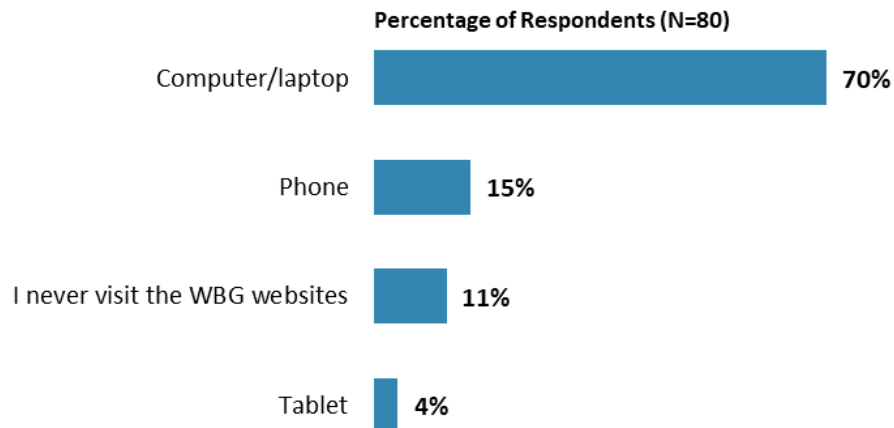

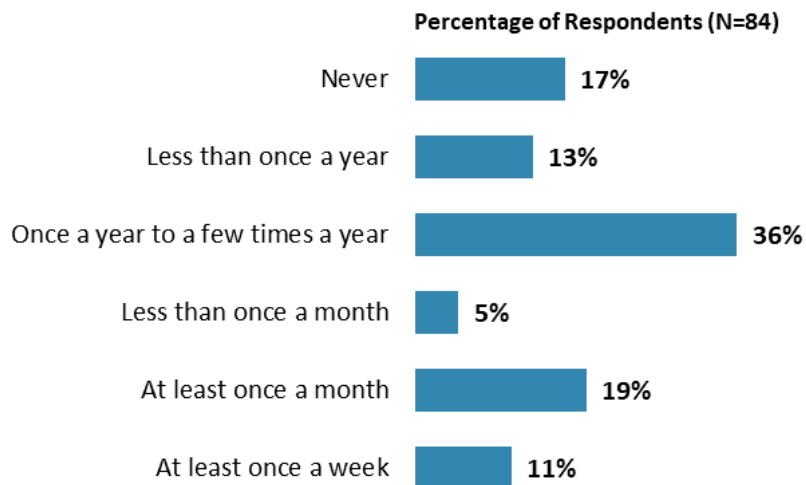

WBG Interaction Frequency

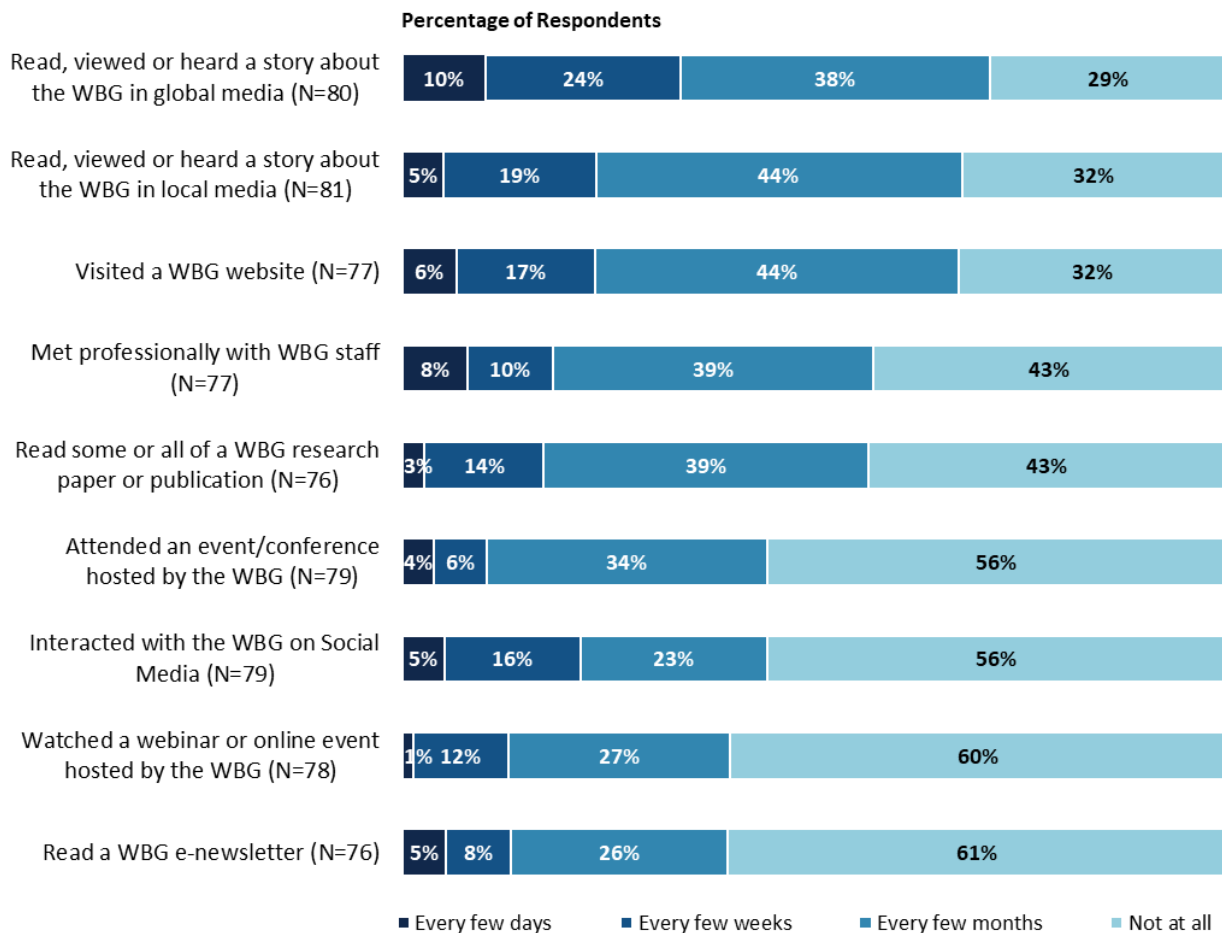


"How frequently do you interact with the World Bank Group now in Lesotho?"
