I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Chad perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Chad*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From December 2020 to February 2021, 415 stakeholders of the WBG in Chad were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 342 stakeholders participated in the survey (82% response rate). Respondents completed the questionnaire with a representative from the local fielding agency, received the questionnaire via a courier and returned it accordingly, or they completed the questionnaire online.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'18 (response rate was 79%, N=315). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'18 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 91).




“Which of the following best describes your current position?”

Area of Primary Specialization




"Please identify the primary specialization of your work."



Exposure to Agencies within the World Bank Group




"Which of the following agencies of the World Bank Group do you primarily collaborate/work with in Chad?"

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of familiarity with the WBG compared to respondents in the FY'18 Country Survey (weighted mean in FY'21 = 5.6; weighted mean in FY'18 = 4.8)².
- **Impact of familiarity:** Respondents' ratings of familiarity³ with the WBG were significantly, moderately correlated with their ratings for the WBG's overall effectiveness⁴ in Chad, and significantly, strongly correlated with their agreement that the WBG plays a relevant role in Chad's development.





Perceptions of Economic Opportunity





Development Priority

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the most important development priorities in Chad were “*education*” (57%), “*health*” (37%), “*agriculture and rural development*” (34%), “*public sector governance/reform*” (30%), and “*job creation/employment*” (19%).
- **Specialization:** Respondents who identified their primary specialization of work as “*education*” (21% of the sample) were significantly *more* likely to indicate that “*education*” was the most important development priority in Chad, compared to the rest of the respondents (education specialists = 64%; others = 42%). Similarly, respondents whose primary specialization was “*agriculture, rural development*” (14% of the sample) were significantly *more* likely to indicate that “*agriculture and rural development*” was the most important development priority in Chad (agriculture specialists = 68%; others = 18%).⁶



IV. Overall Context (continued)

What Would Contribute Most to Reducing Poverty

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the biggest contributors to poverty reduction in Chad were “*agriculture and rural development*” (63%), “*anti-corruption*” (30%), “*job creation/employment*” (25%), “*education*” (24%), and “*public sector governance/reform*” (21%). “*Transport*” emerged among the top factors that contribute to poverty reduction in Chad, with significant increase from 6% in FY'18 to 23% in FY'21.
- **Specialization:** Respondents who identified their primary specialization of work as “*education*” (21% of the sample) were significantly *more* likely to indicate that “*education*” would contribute the most to poverty reduction in Chad compared to the rest of the respondents (education specialists = 38%; others = 24%). Similarly, respondents whose primary specialization was “*agriculture, rural development*” (14% of the sample) were significantly *more* likely to indicate that “*agriculture and rural development*” would contribute the most to poverty reduction in Chad (agriculture specialists = 74%; others = 55%).⁷










"When considering the characteristics of a fragile state, please identify which of the following best illustrate fragility in Chad. (Choose no more than TWO)"




"When economic and/or social reform efforts fail or are slow to take place in Chad, which of the following would you attribute this to? (Choose no more than TWO)"











Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-nine COS indicator questions (mean rating = 7.4) compared to respondents who do not collaborate with the WBG (mean rating = 6.7).

This year's collaborators had significantly higher mean ratings for the aggregated responses to the indicator questions¹⁰ compared to the collaborators in FY'18 Country Survey (mean rating in FY'18 = 6.5; mean rating in FY'21=7.3). Responses for individual indicator questions by exposure to the WBG can be found in Appendix E (page 97).

- **Stakeholder groups:** Respondents from the office of a parliamentarian had the highest mean ratings for the aggregated responses to the twenty-nine COS indicator questions, whereas respondents from the office of the President/Prime Minister/Minister had significantly lower mean ratings. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (page 64).





- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the WBG's greatest values to Chad were “*capacity development related to World Bank Group supported projects*” (48%), “*strategy formulation*” (29%), and “*financial resources*” (27%).




“When thinking about the World Bank Group’s role in Chad, which activity do you VALUE the most? (Choose no more than TWO)”

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the WBG's greatest weaknesses in its work in Chad were "*not adequately sensitive to political/social realities in Chad*" (29%) and "*not willing to honestly criticize policies and reform efforts in the country*" (27%).




"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Chad? (Choose no more than TWO)"





Support related to COVID-19 outbreak







The World Bank Group's Work in Chad: Collaboration








"To what extent do you agree/disagree with the following statements?"



"To what extent is the World Bank Group an effective development partner in Chad, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")



Effectiveness of WBG's Support¹⁷





Meeting Chad's Knowledge Needs¹⁸ (Indicator Question)








"Overall, how significant a contribution do you believe the World Bank Group's knowledge work and activities make to development results in your country?"

Technical Quality of the WBG's Knowledge Work and Activities (*Indicator Question*)




"Overall, how would you rate the technical quality of the World Bank Group's knowledge work and activities?"










"Which of the following SHOULD the World Bank Group do to make itself of greater value in Chad? (Choose no more than TWO)"


"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the WBG should focus its resources on “*education*” (53%), “*agriculture and rural development*” (34%), “*job creation/employment*” (27%), “*food security*” (27%), and “*poverty reduction*” (24%). “*Health*” emerged among the top areas of the WBG focus, with significant increase from 14% in FY'18 to 31% in FY'21.
- **Specialization:** Respondents who identified their primary specialization of work as “*education*” (21% of the sample) were significantly *more* likely to indicate that the WBG should focus most of its resources on “*education*”, compared to the rest of respondents (education specialists = 68%; others = 28%). Similarly, respondents who identified their primary specialization as “*agriculture, rural development*” (14% of the sample) were significantly *more* likely to indicate that the WBG should focus most of its resources on “*agriculture and rural development*” (agriculture specialists = 59%; others = 29%).²¹










"Which TWO organizations are the most valuable for the World Bank Group to collaborate with to tackle fragility in Chad? (Select no more than TWO)"










**"How would you prefer to receive information from the World Bank Group?





Devices used to access WBG website




WBG Interaction Frequency
