I. Objectives

(H)

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Kazakhstan perceive the WBG. The survey explored:

- Overall Context
- Overall Attitudes toward the World Bank Group
- World Bank Group's Work and Engagement on the Ground
- World Bank Group's Support in Development Areas
- World Bank Group's Knowledge Work and Activities
- The Future Role of the World Bank Group in Kazakhstan
- Communication and Information Sharing
- Background Information

II. Methodology

From December 2020 to February 2021, 585 stakeholders of the WBG in Kazakhstan were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 368 stakeholders participated in the survey (63% response rate). Respondents received the questionnaire via a courier and returned it accordingly, or they completed the questionnaire online.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.


The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'17 (response rate was 66%, N=267). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'17 COS report and the non-weighted data presented in appendices A, B, C and E. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 77).

Note that the body of the report presents data on selected questions of the survey questionnaire. Please refer to Appendix A for data on all survey questions. Appendices B, C, D, and E present data on selected questions. Additional data breakdowns are available upon request.










Exposure to Agencies within the World Bank Group





Familiarity with the World Bank Group

- Year comparison: Respondents in this year's Country Survey had statistically similar levels of familiarity with the WBG compared to respondents in the FY'17 Country Survey (weighted mean in FY'21 = 6.0; weighted mean in FY'17 = 6.0^2 .
- Impact of familiarity: Respondents' ratings of familiarity³ with the WBG were significantly, strongly correlated with their ratings for the WBG's overall effectiveness⁴ in Kazakhstan, with their agreement that the WBG plays a relevant role in Kazakhstan's development, and with their ratings of the extent to which the WBG's work helps achieve development results in Kazakhstan.



"How familiar are you with the work of the World Bank (IBRD) in Kazakhstan?" (1-"Not familiar at all", 10-"Extremely familiar")





Perceptions of Economic Opportunity




"Do you think that economic opportunity for citizens in Kazakhstan is ... ?" (Respondents chose from a list.)


Development Priority

- Year comparison: Respondents in the previous FY'17 Country Survey indicated that the most important development priorities in Kazakhstan were "*private sector development*" (35%), "*anti-corruption*" (31%), "*public sector governance/reform*" (29%), "*education*" (26%), and "*economic growth*" (21%).
- Specialization: Respondents who identified their primary specialization of work as "*health*, *nutrition*" (13% of the sample) were significantly *more* likely to indicate that "*healthcare*" was the most important development priority in Kazakhstan, compared to the rest of the respondents (health specialists =57%; others = 22%).⁶





What Would Contribute Most to Reducing Poverty


Year comparison: Respondents in the previous FY'17 Country Survey indicated that the biggest contributors to poverty reduction in Kazakhstan were "*job creation/employment*" (43%), "*private sector development*" (33%), "*economic growth*" (32%), "*agriculture and rural development*" (26%), and "*anti-corruption*" (26%).









WBG Staff Preparedness



Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-nine COS indicator questions (mean rating = 7.1) compared to respondents who do not collaborate with the WBG (mean rating = 5.7).
- Stakeholder groups: Respondents from PMU, consultants on World Bank Group supported projects had the highest mean ratings for the aggregated responses to the twentynine COS indicator questions, whereas employees of ministries had significantly lower mean ratings. 


Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10


• Year comparison: Respondents in the previous FY'17 Country Survey indicated that the WBG's greatest values to Kazakhstan were "capacity development related to World Bank Group supported projects" (35%), "implementation support" (33%), "promoting knowledge sharing" (27%), and "financial resources" (27%).

• Year comparison: Respondents in the previous FY'17 Country Survey indicated that the WBG's greatest weaknesses in its work in Kazakhstan were "too influenced by developed countries" (17%), "WBG's processes too complex" (16%), "not willing to honestly criticize policies and reform efforts in the country" (15%), and "WBG's processes too slow" (14%).





Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁸





Effectiveness of WBG's Support in Sectoral Areas: Collaboration⁹








"To what extent do you believe that the World Bank Group's work and support help the poorest in Kazakhstan?" (Respondents chose from a list.)








Overall Perceptions: Collaboration

The WBG as an Effective Development Partner: Year Comparison¹³






















"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"

Where the World Bank Group Should Focus its Resources

- Year comparison: Respondents in the previous FY'17 Country Survey indicated that the WBG should focus its resources on "*private sector development*" (30%), "*education*" (30%), "*economic growth*" (24%), "*job creation/employment*" (22%), and "*agriculture and rural development*" (22%).
- Specialization: Respondents who identified their primary specialization of work as "education" (12% of the sample) were significantly more likely to indicate that the WBG should focus most of its resources on "education", compared to the rest of respondents (education specialists = 56%; others = 29%). Similarly, respondents who identified their primary specialization as "health, nutrition" (13% of the sample) were significantly more likely to indicate that the WBG should focus most of its resources on "healthcare" (health specialists = 51%; others = 19%).¹⁷




"How do you get most of your information about economic and social development issues in Kazakhstan? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)




"How would you prefer to receive information from the World Bank Group? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)






