## I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Comoros perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Comoros*
- *Communication and Information Sharing*
- *Background Information*

## II. Methodology

From April to May 2021, 251 stakeholders of the WBG in Comoros were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 226 stakeholders participated in the survey (90% response rate). Respondents received the questionnaire via a courier and returned it accordingly, or they completed the questionnaire online.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'18 (response rate was 86%, N=144). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'18 COS report and the non-weighted data presented in appendices A, B, C and E. 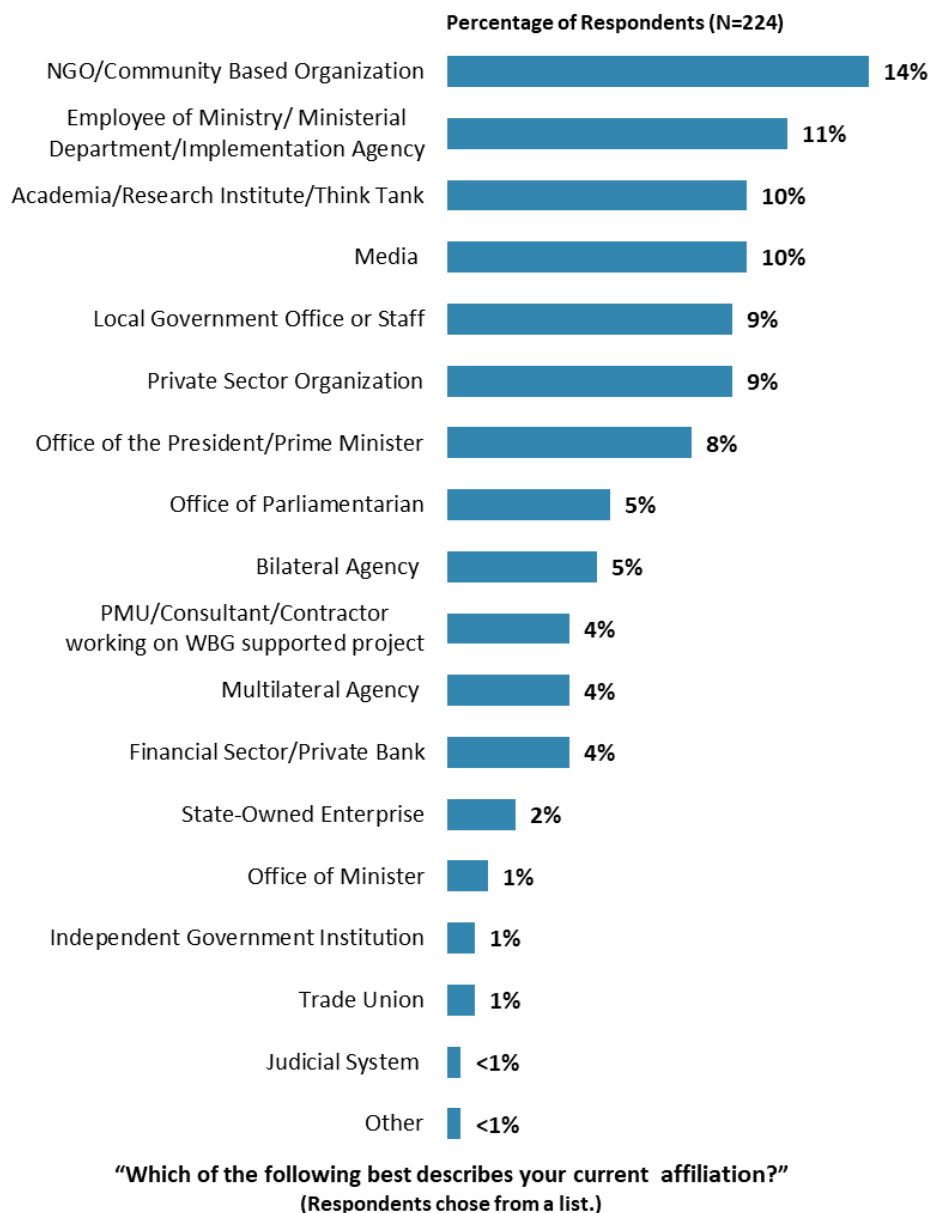

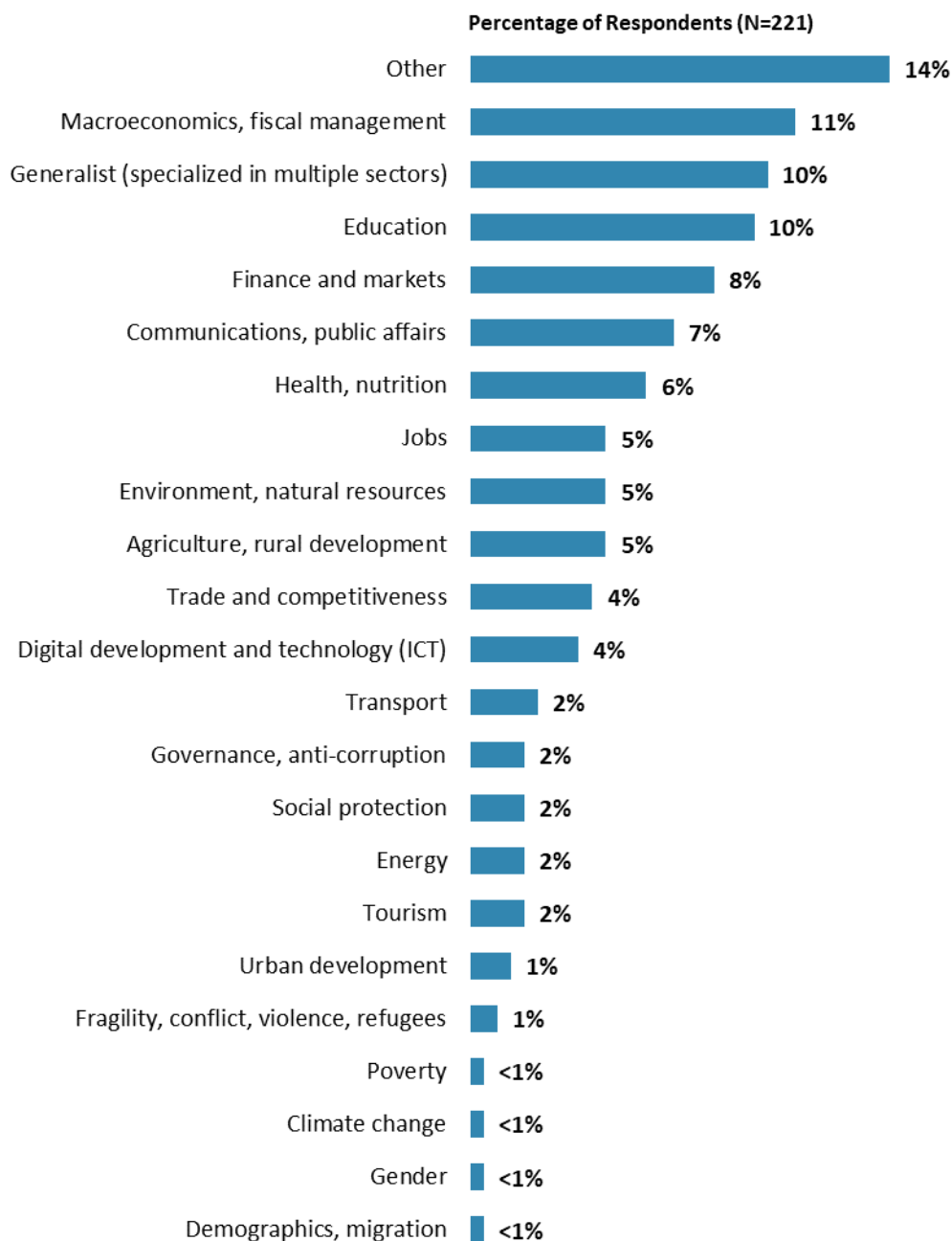

The small number of the respondents from independent government institutions, the judicial system, and state-owned enterprises were included in the “Other” category. #### Area of Primary Specialization

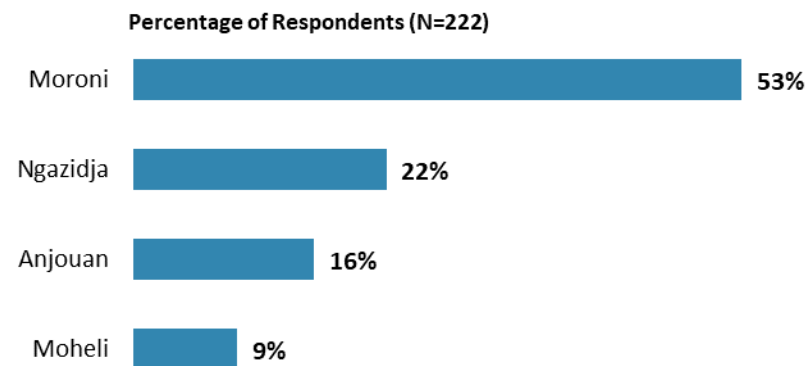


**"Please identify the primary specialization of your work."**

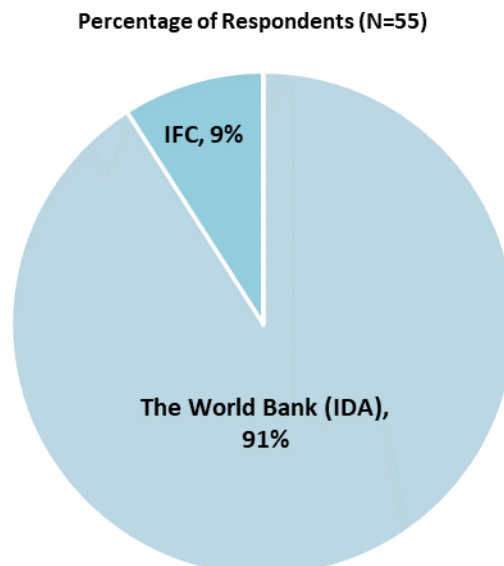
#### Geographic Locations

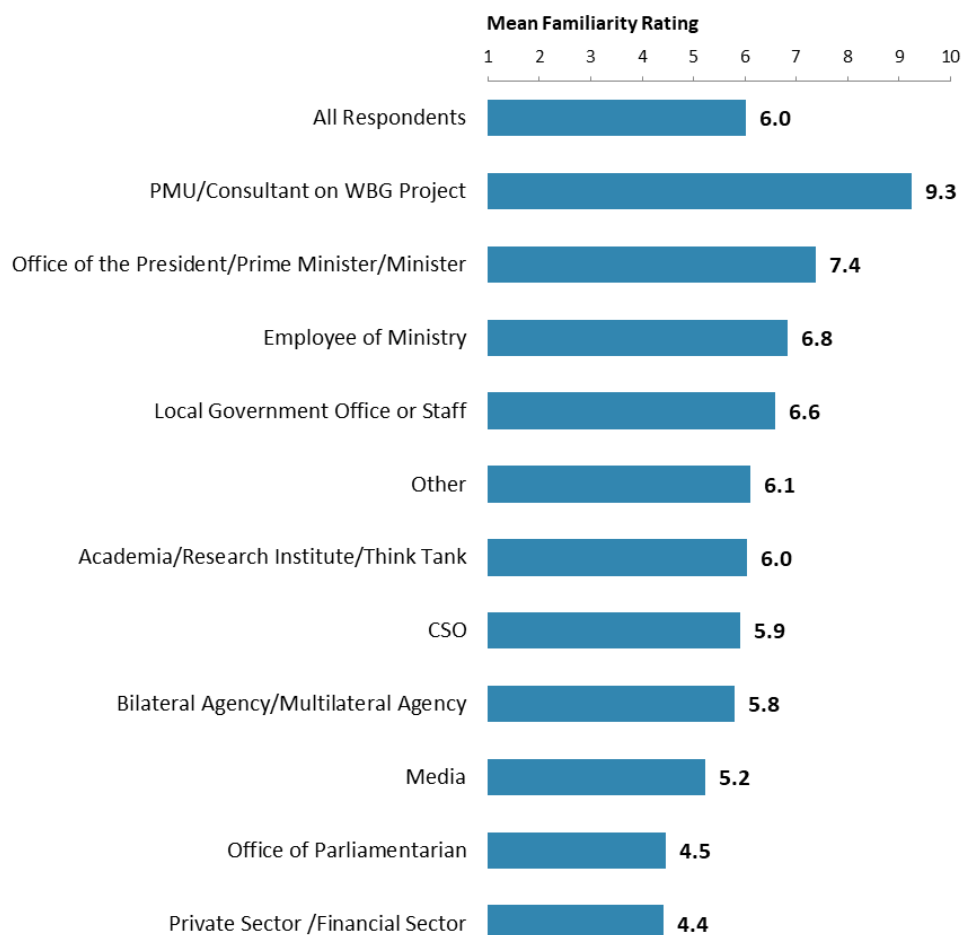

### III. Demographics of the Sample (continued)

#### Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of familiarity with the WBG compared to respondents in the FY'18 Country Survey (weighted mean in FY'21 = 6.0; weighted mean in FY'18 = 5.2)<sup>2</sup>.
- **Impact of familiarity:** Respondents' ratings of familiarity<sup>3</sup> with the WBG were significantly, strongly correlated with their ratings for the WBG's overall effectiveness<sup>4</sup> in Comoros, and significantly, moderately correlated with their agreement that the WBG plays a relevant role in development in Comoros and with their ratings of the extent to which the WBG's work helps achieve development results in Comoros.

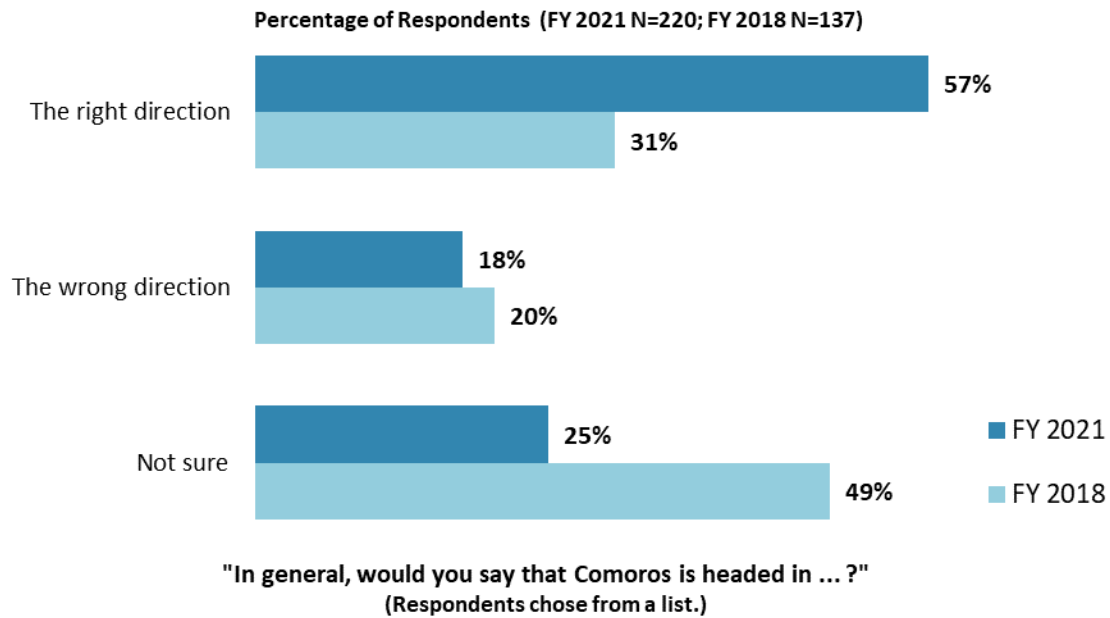

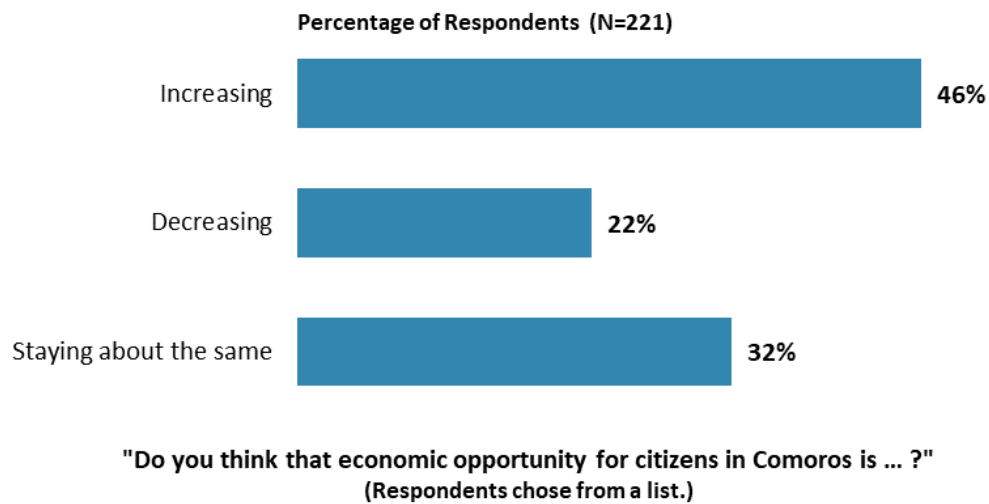

### Perceptions of Economic Opportunity



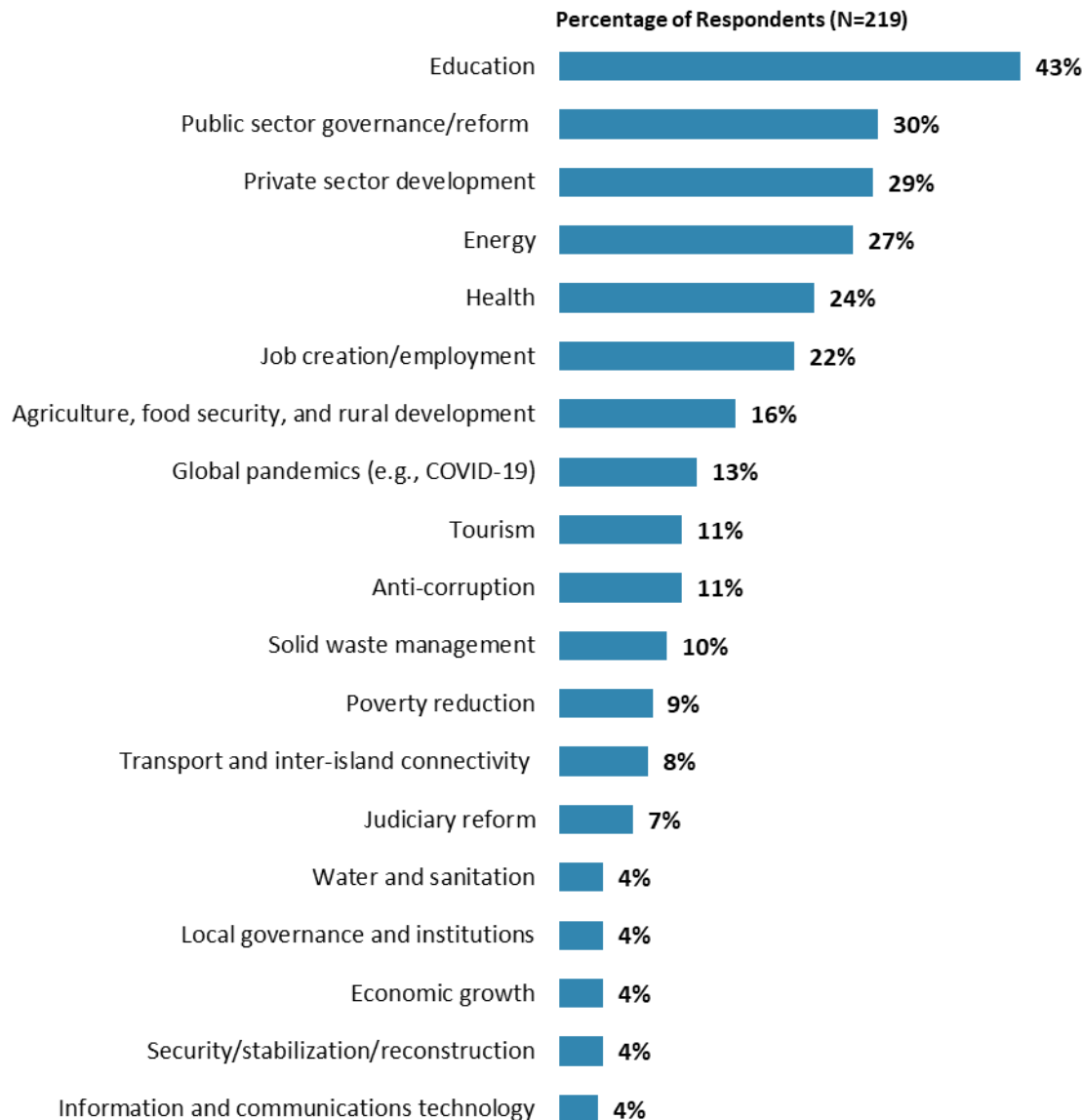

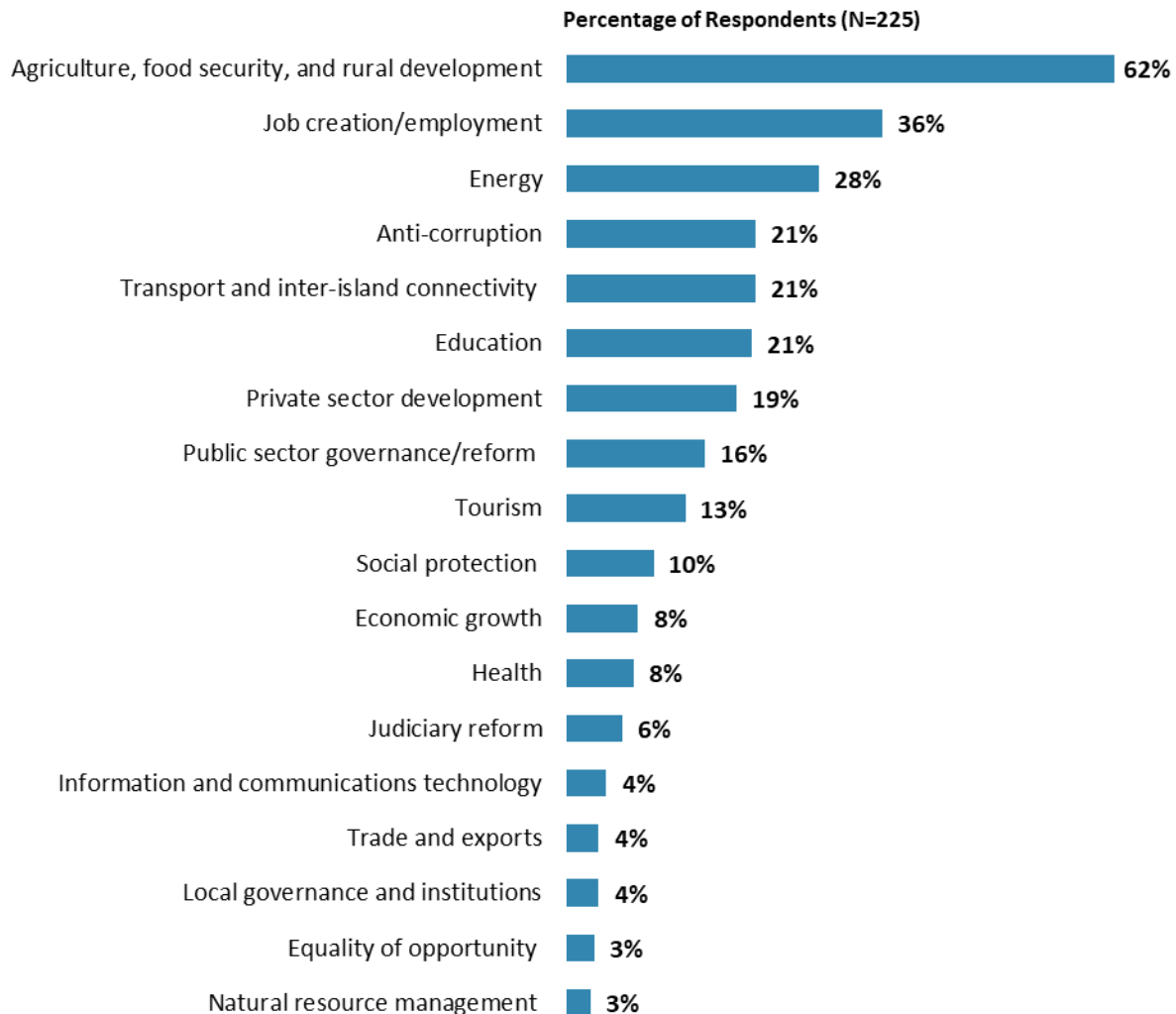

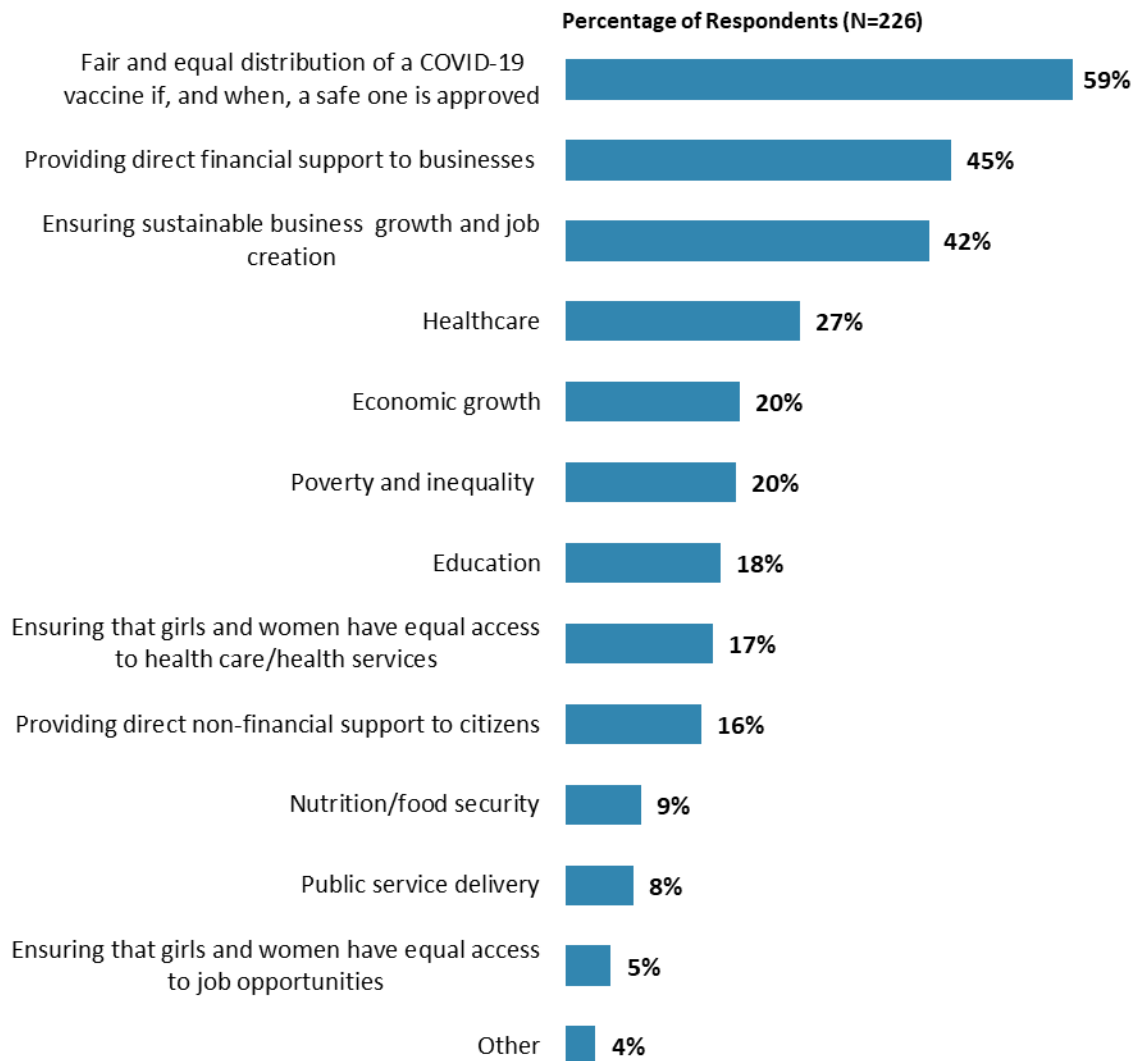

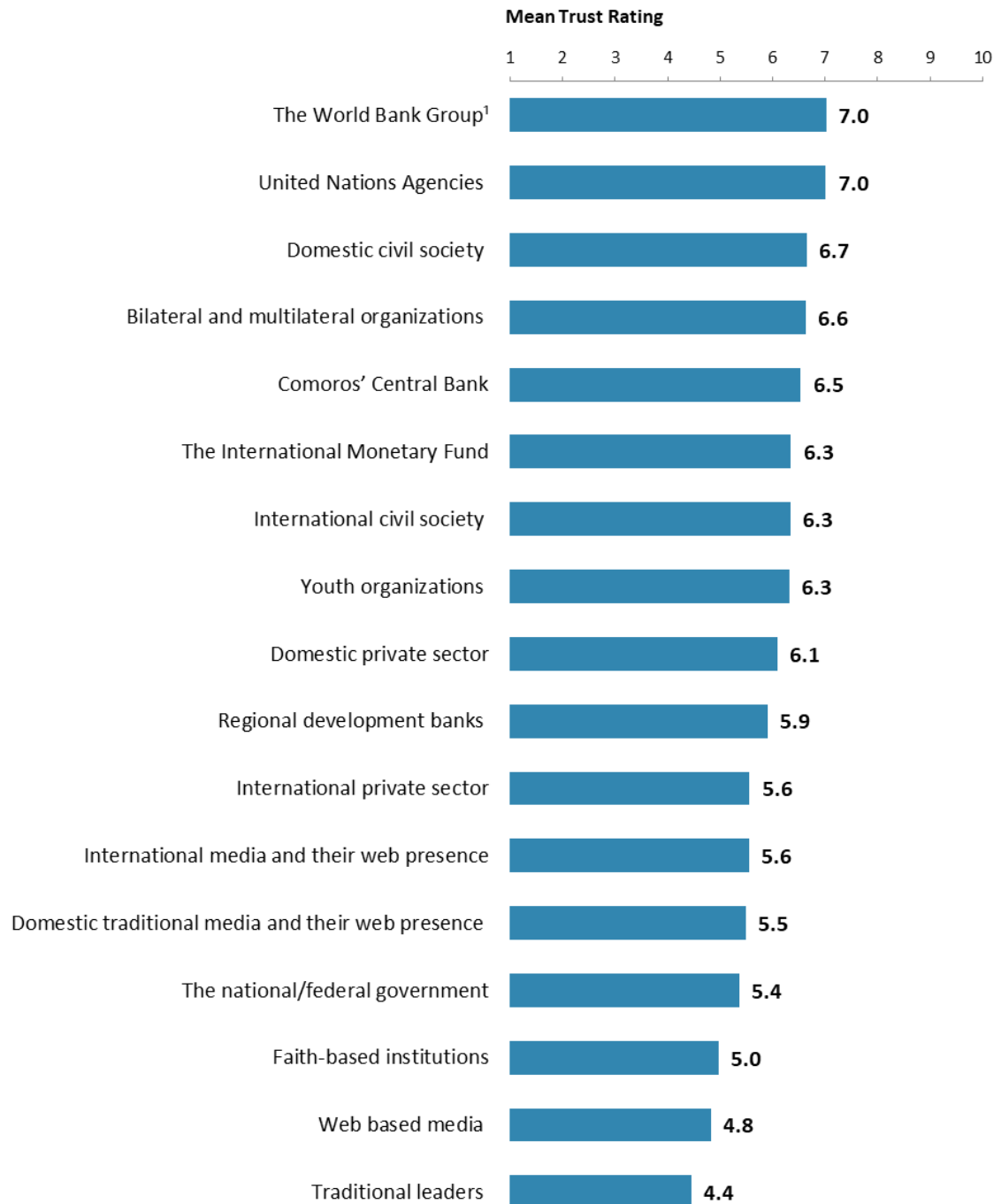

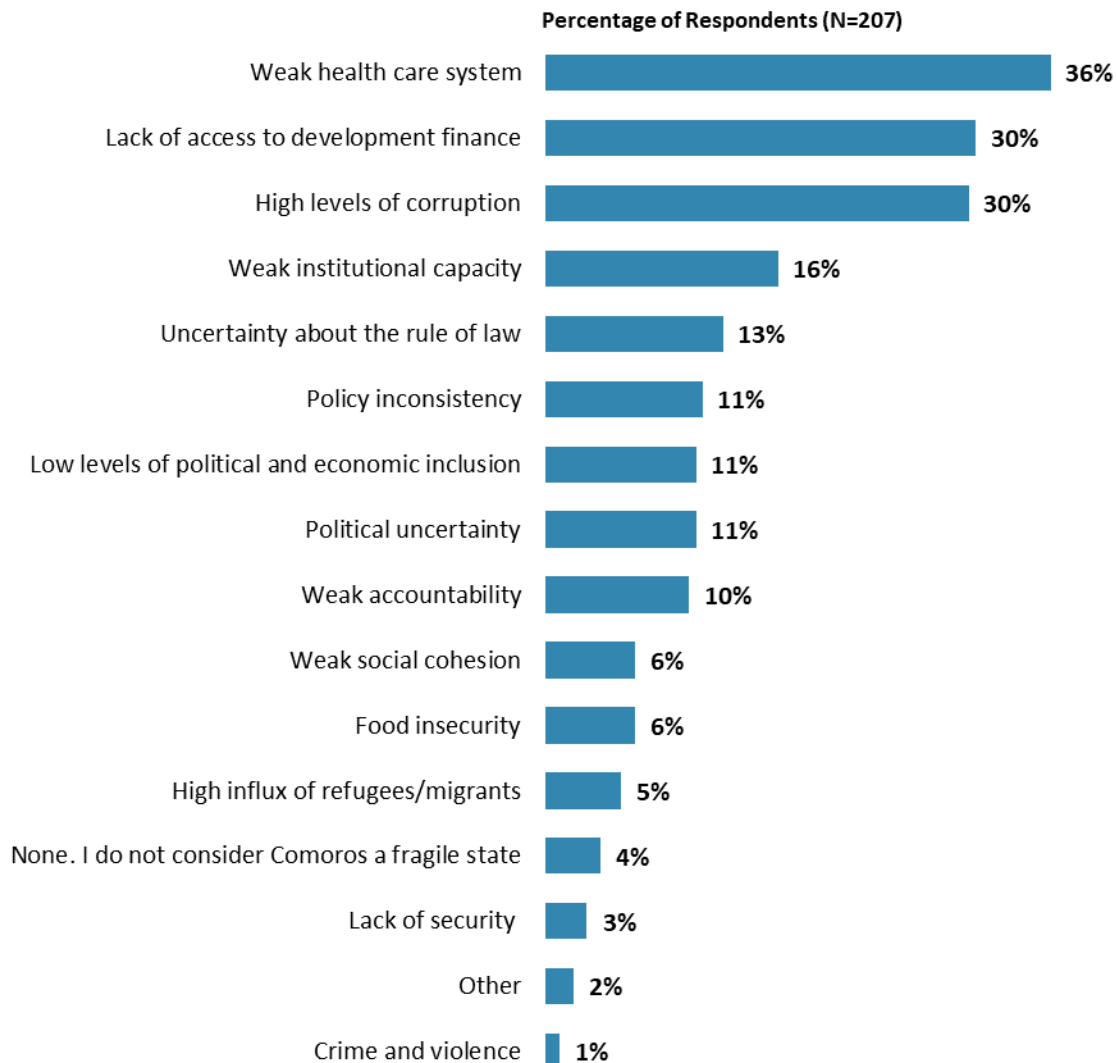

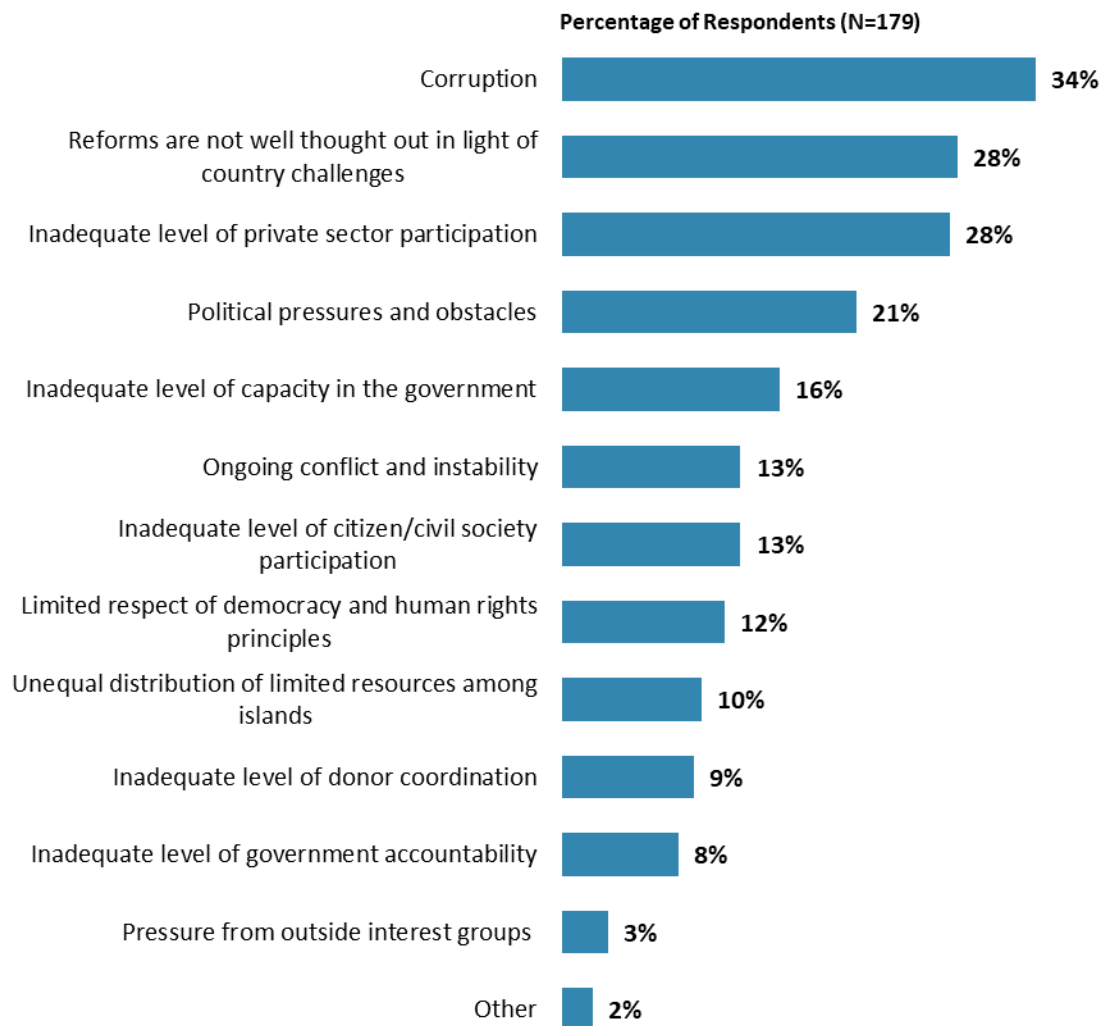


"When considering the characteristics of a fragile state, please identify which of the following best illustrate fragility in Comoros. (Choose no more than TWO)"

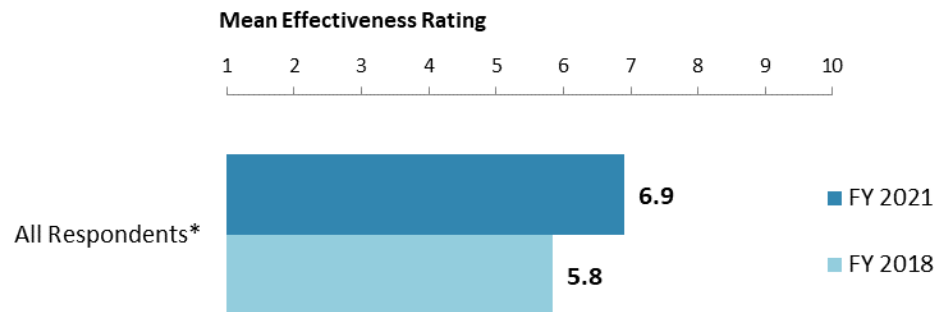


**"When economic and/or social reform efforts fail or are slow to take place in Comoros, which of the following would you attribute this to? (Choose no more than TWO)"**

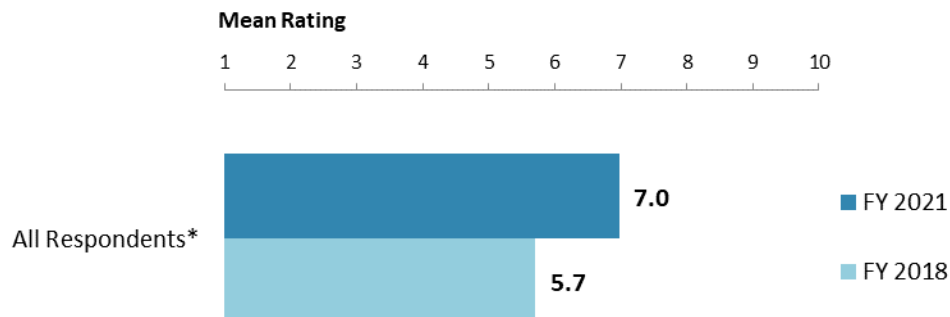

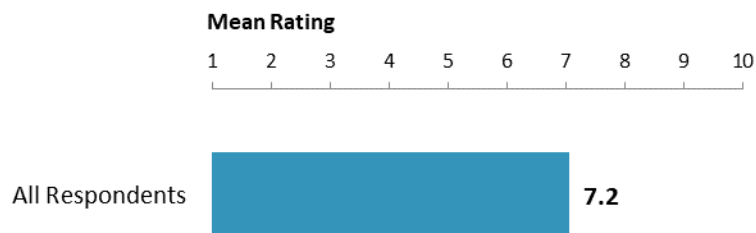

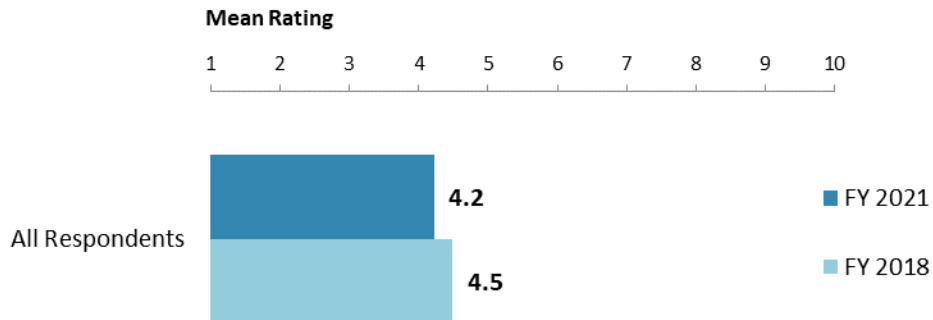

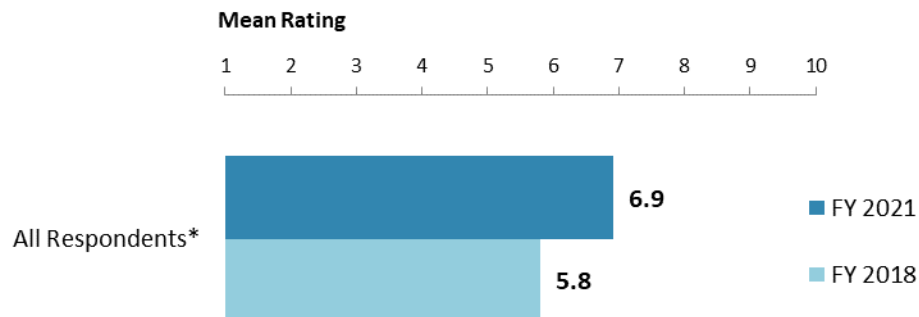

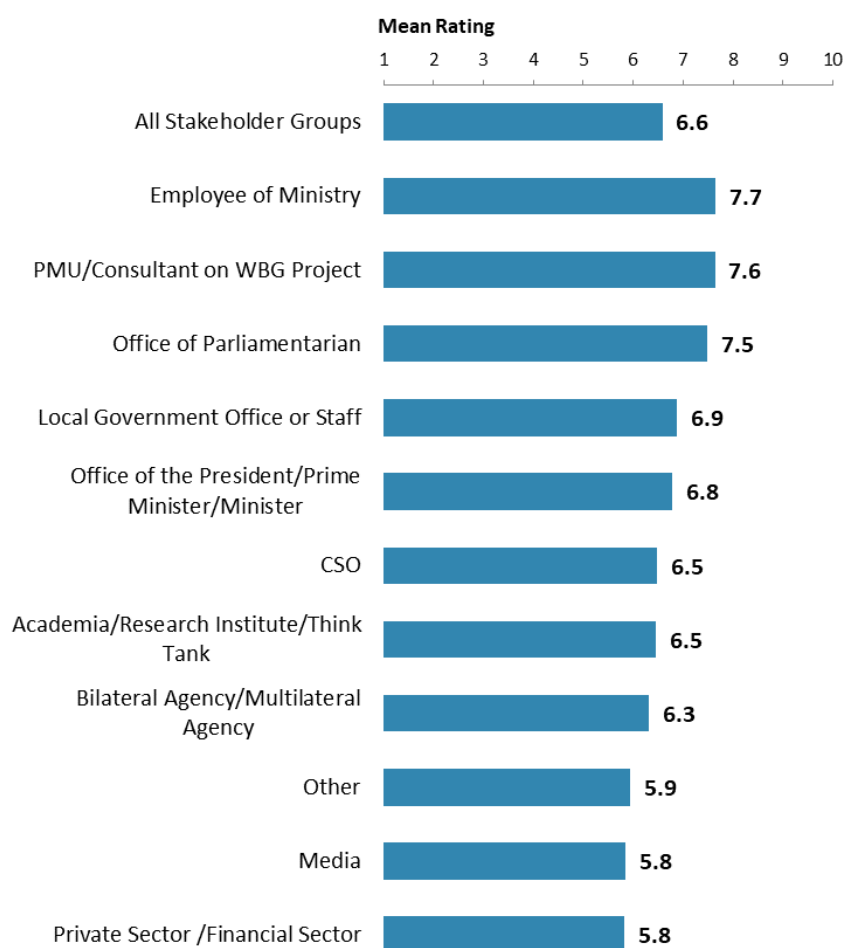

## V. Overall Attitudes toward the World Bank Group (continued)

### Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the thirty COS indicator questions (mean rating = 7.0) compared to respondents who do not collaborate with the WBG (mean rating = 6.5).
- **Stakeholder groups:** Employees of ministries had the highest mean ratings for the aggregated responses to the thirty COS indicator questions, whereas respondents from the office of the Private Sector/Financial Sector had significantly lower mean ratings. 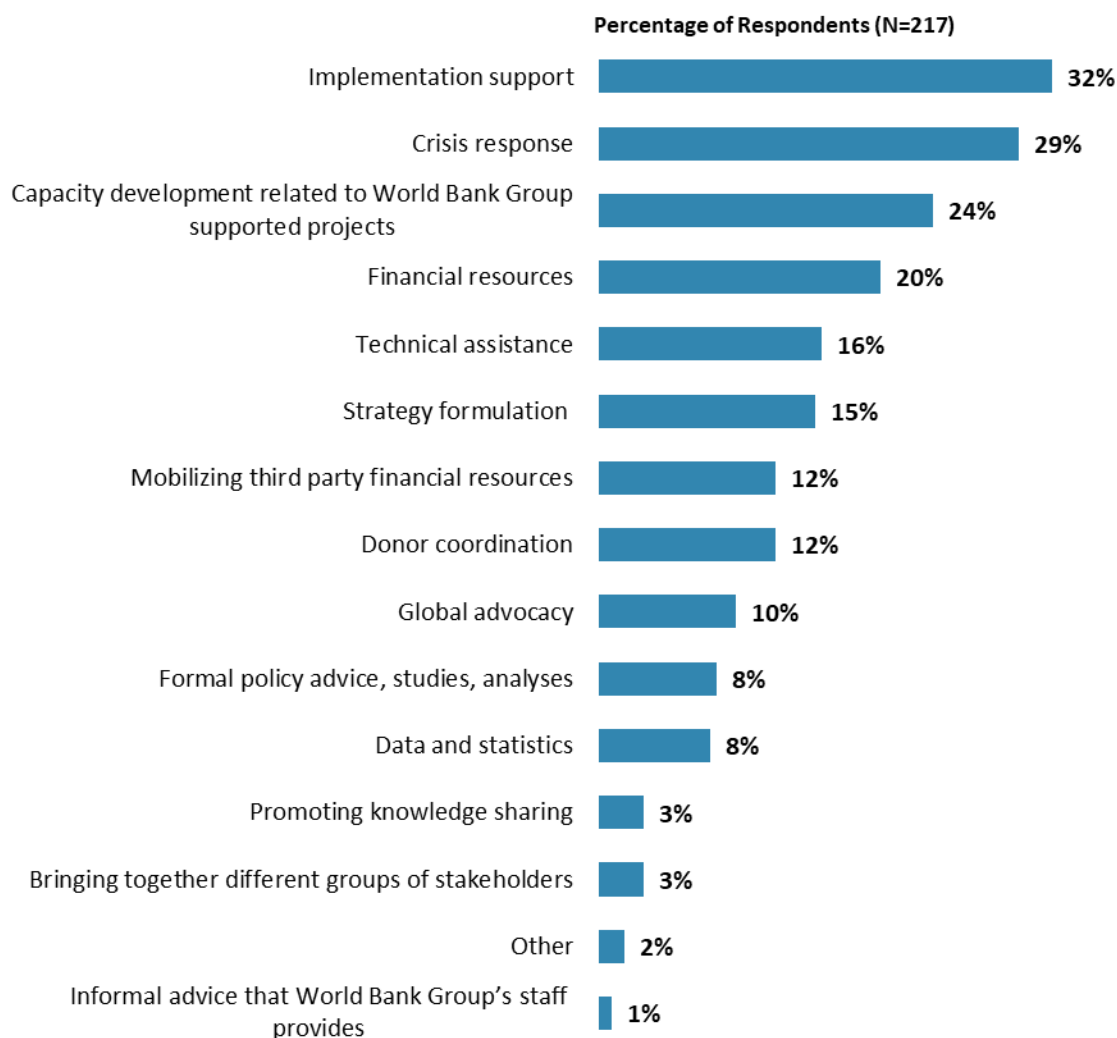
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

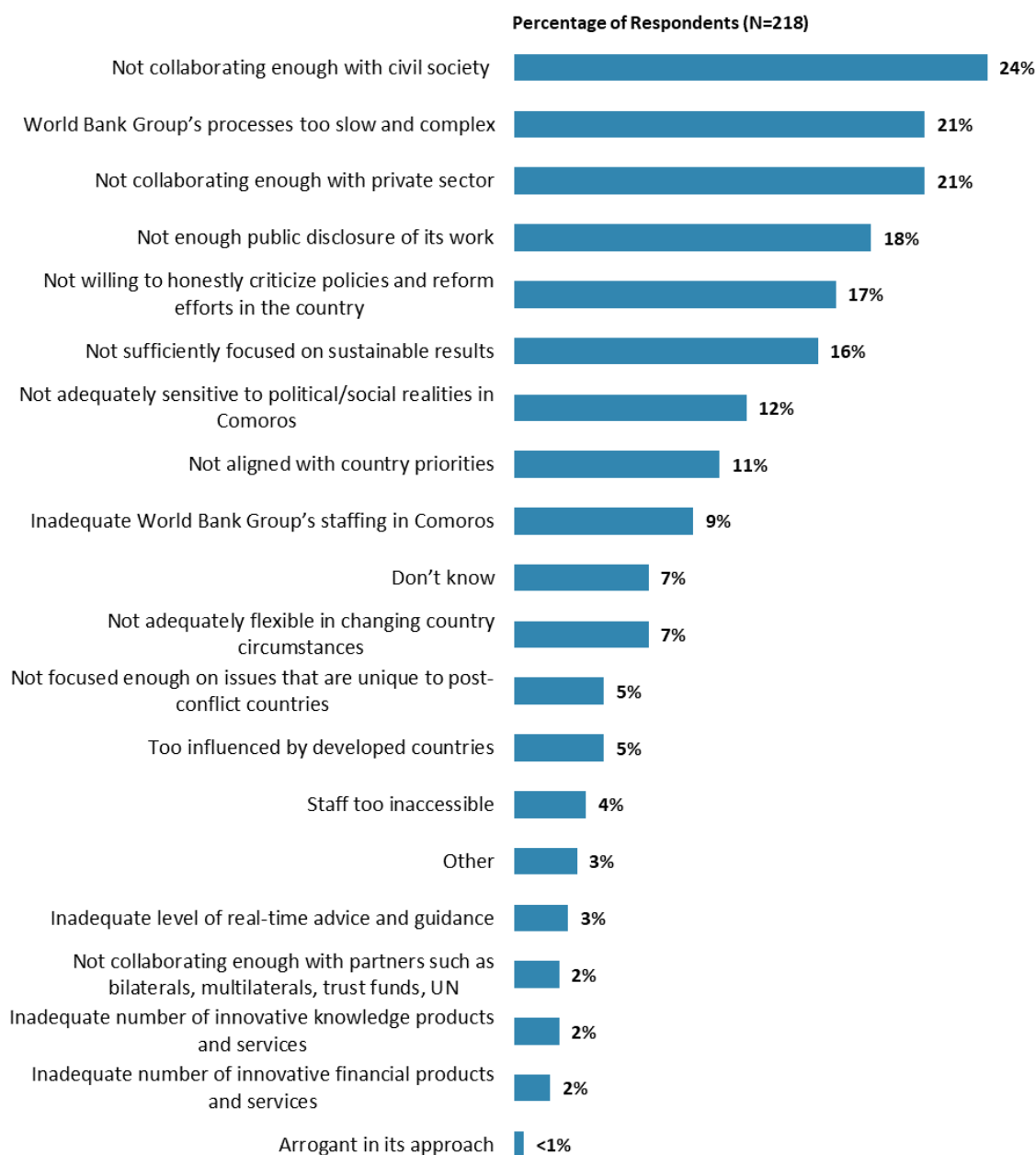
**"When thinking about the World Bank Group's role in Comoros, which activity do you VALUE the most? (Choose no more than TWO)"**

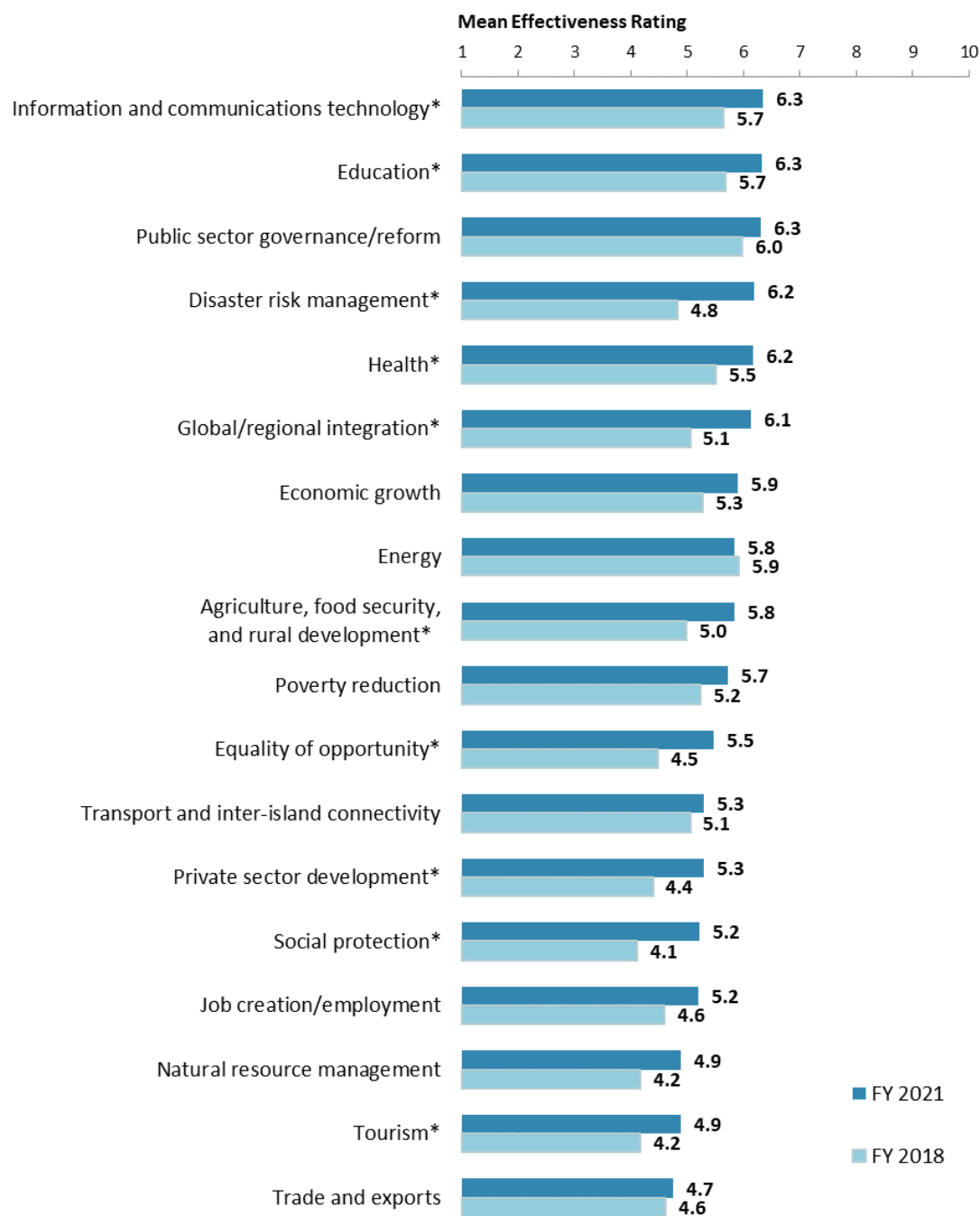


"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Comoros? (Choose no more than TWO)"

### Effectiveness of WBG's Support in Sectoral Areas: Year Comparison<sup>8</sup>



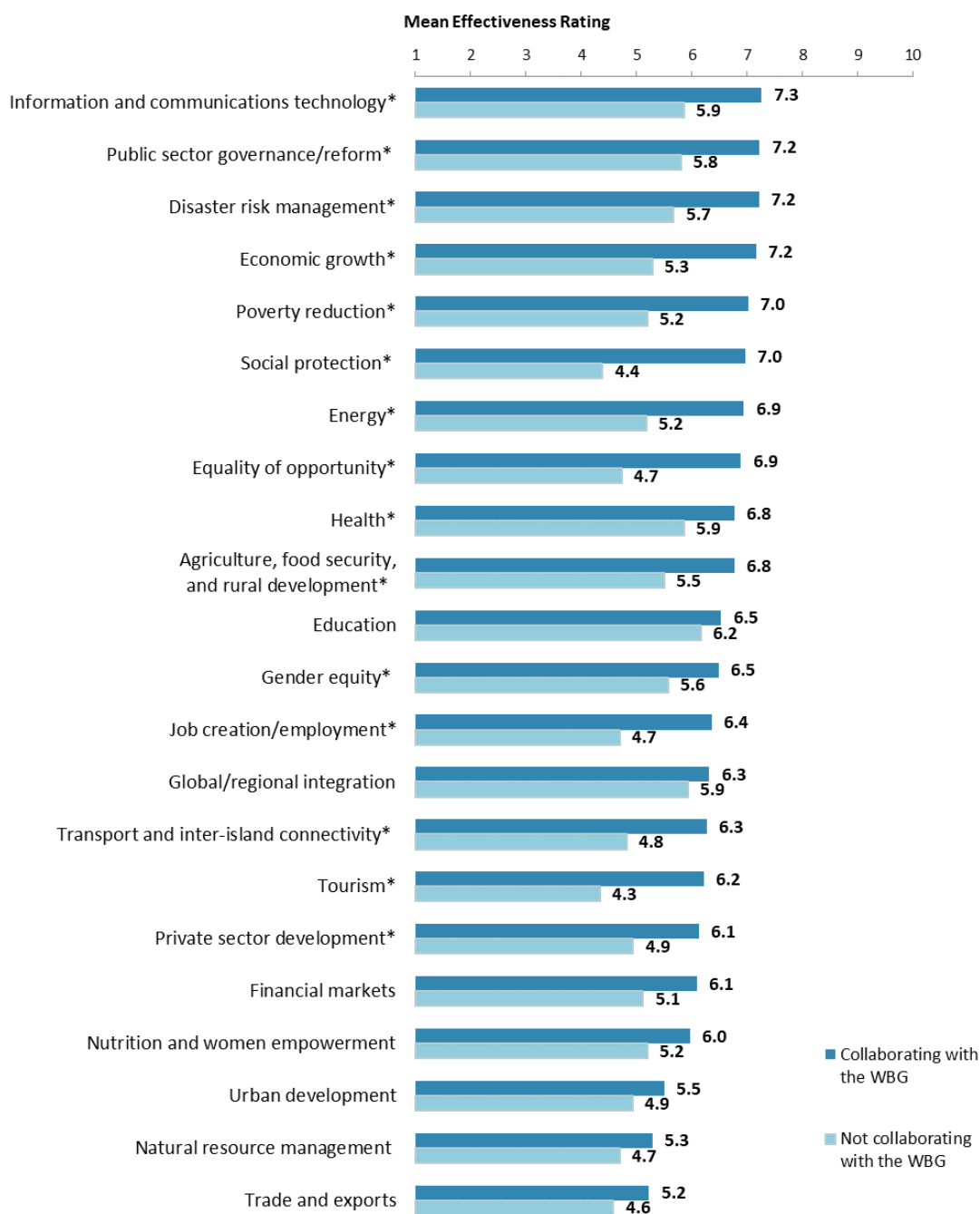

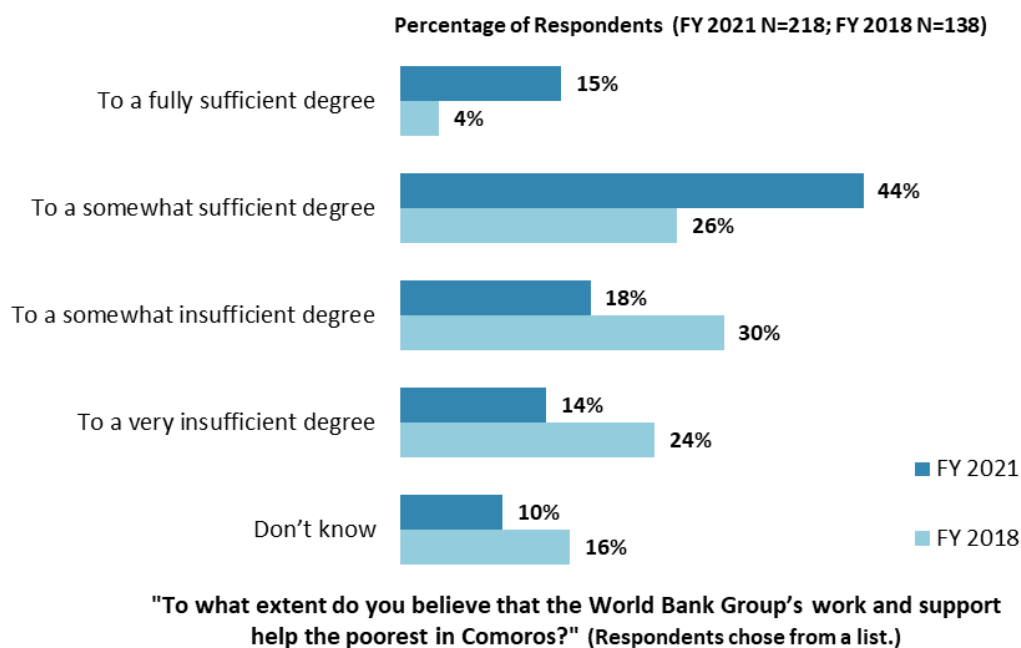

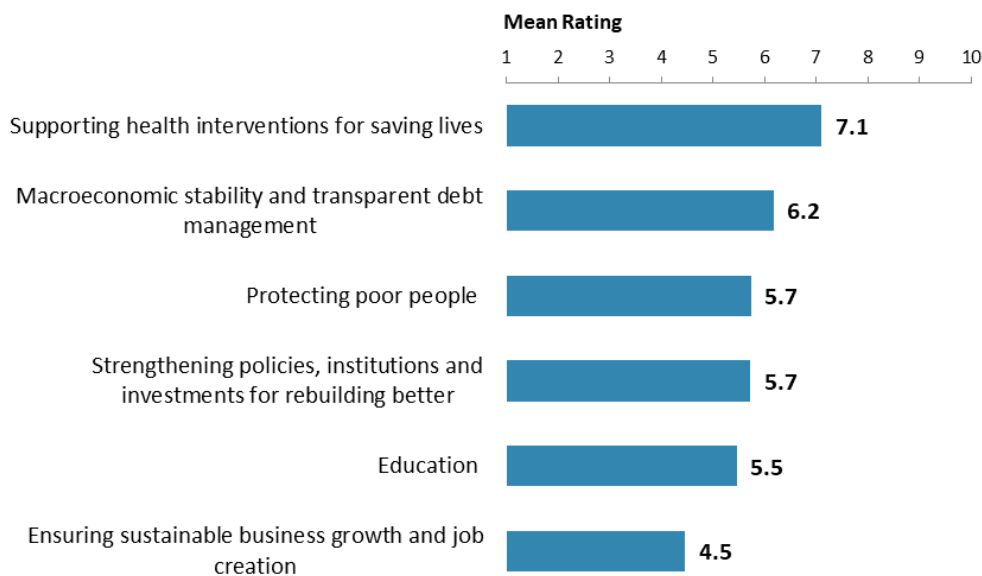

### Support related to COVID-19 outbreak



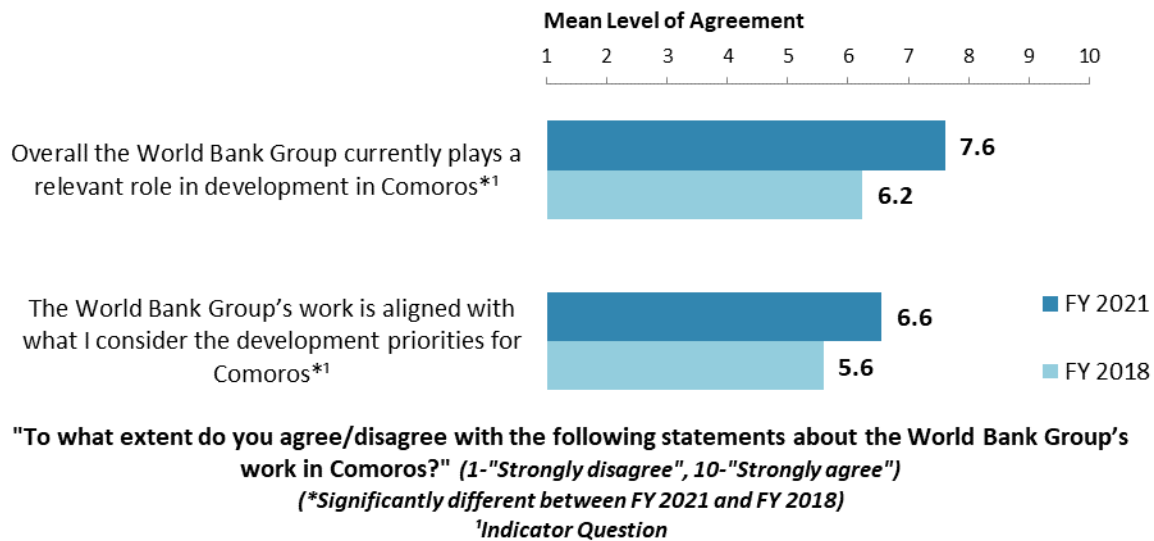

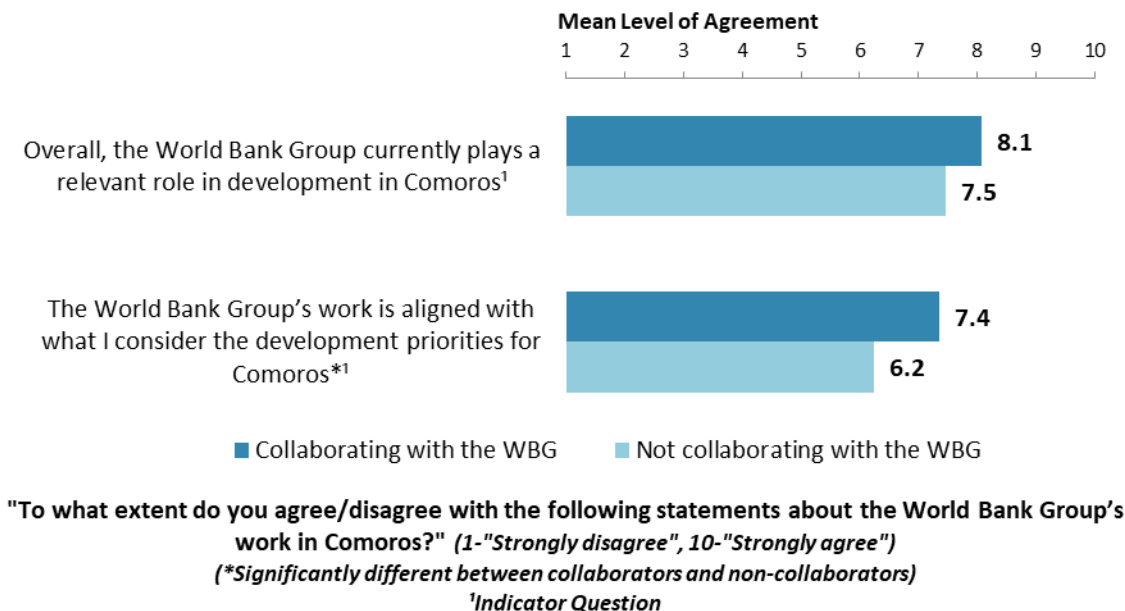

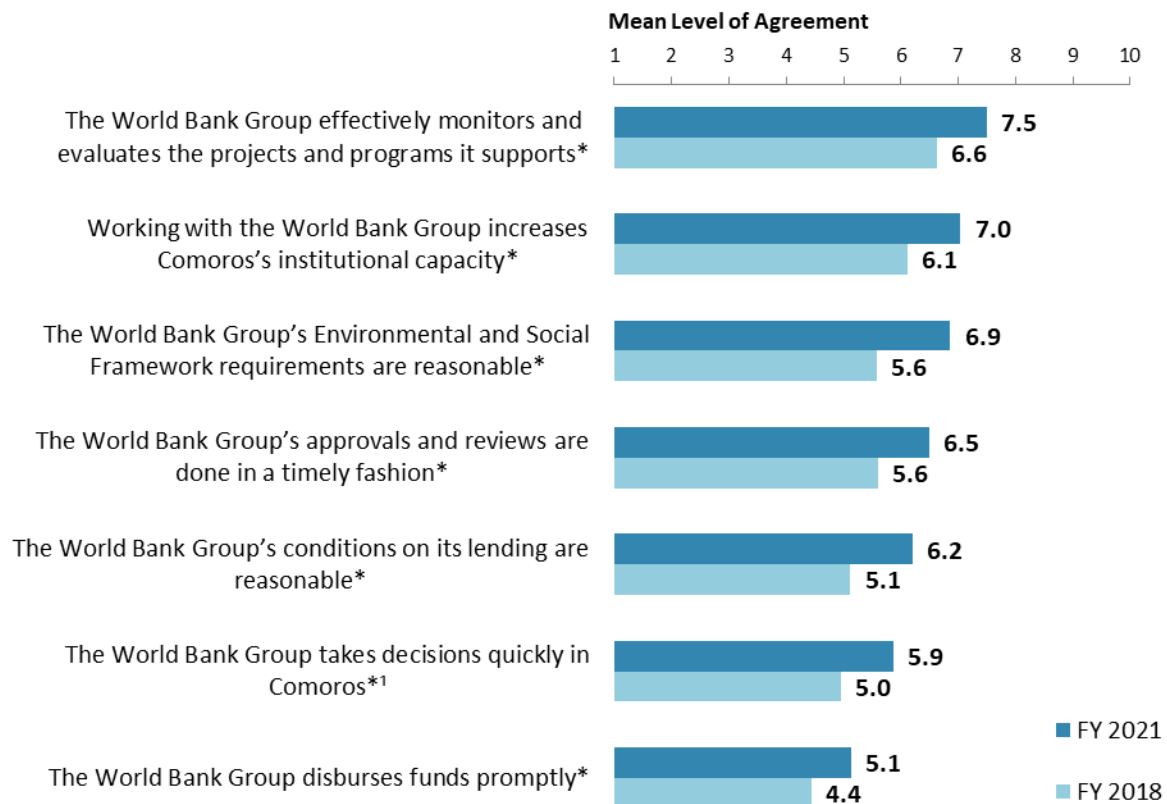

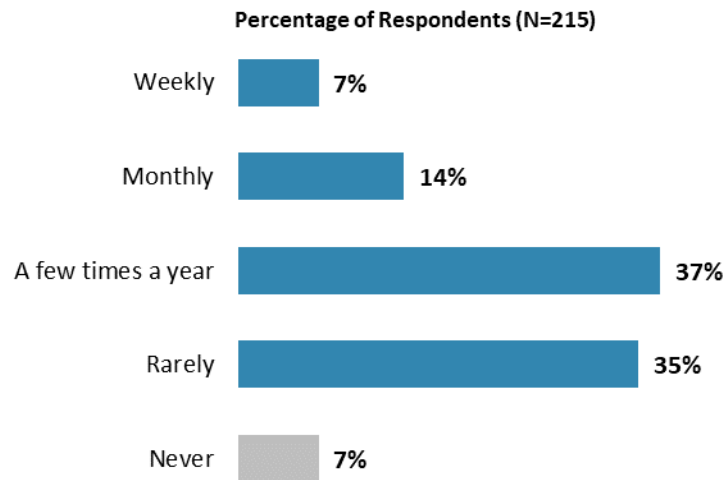

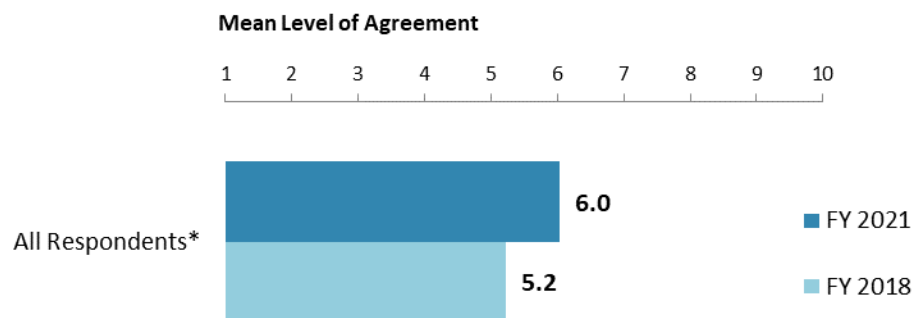

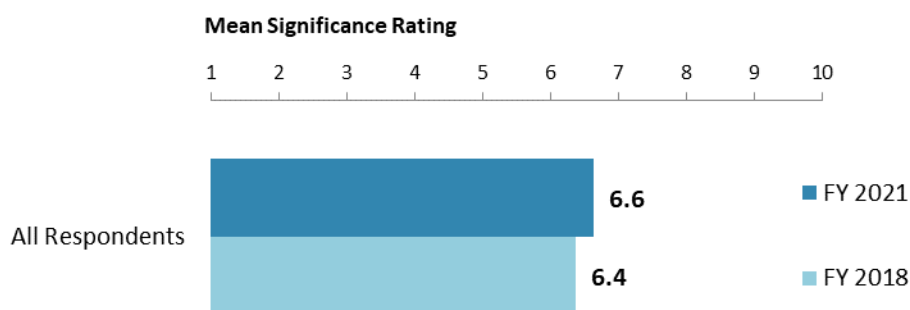

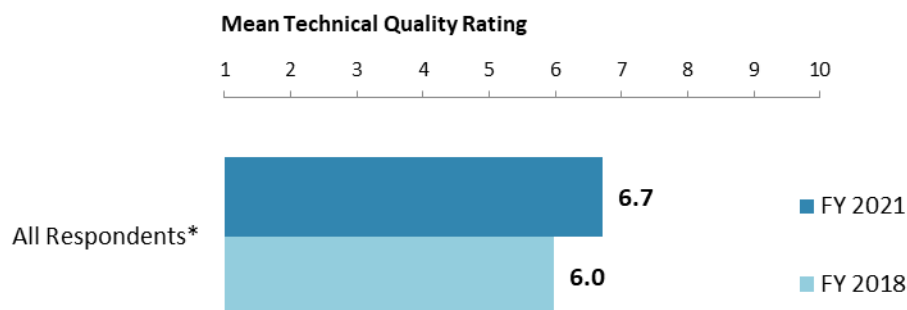

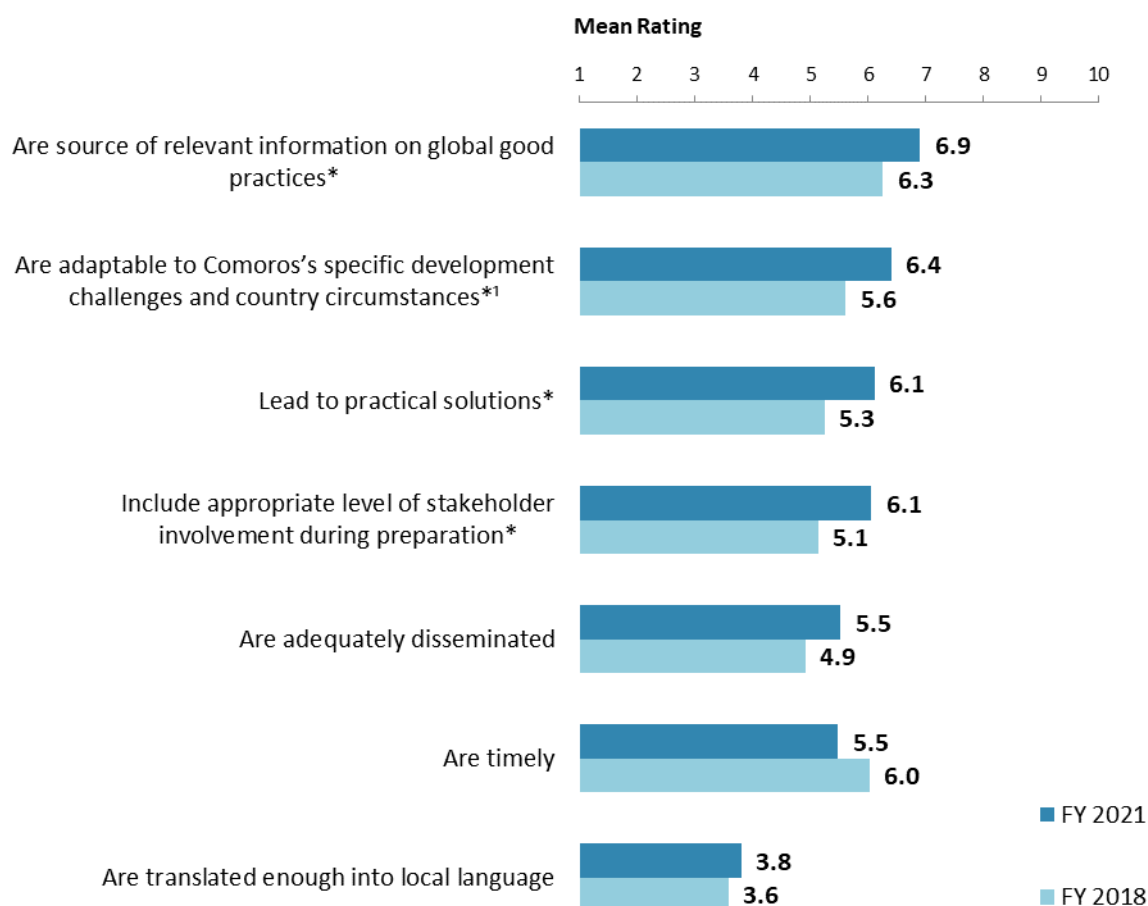


"Overall, how would you rate the technical quality of the World Bank Group's knowledge work and activities?"

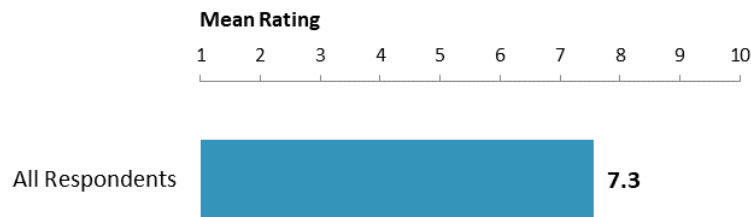

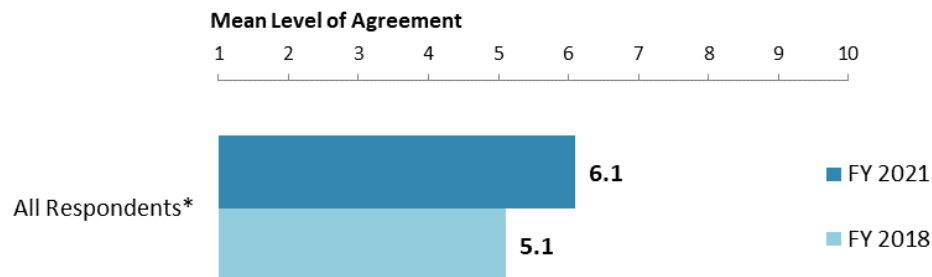

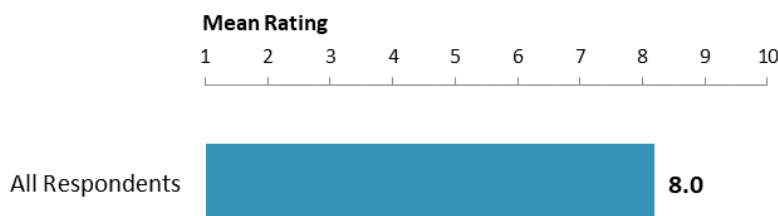

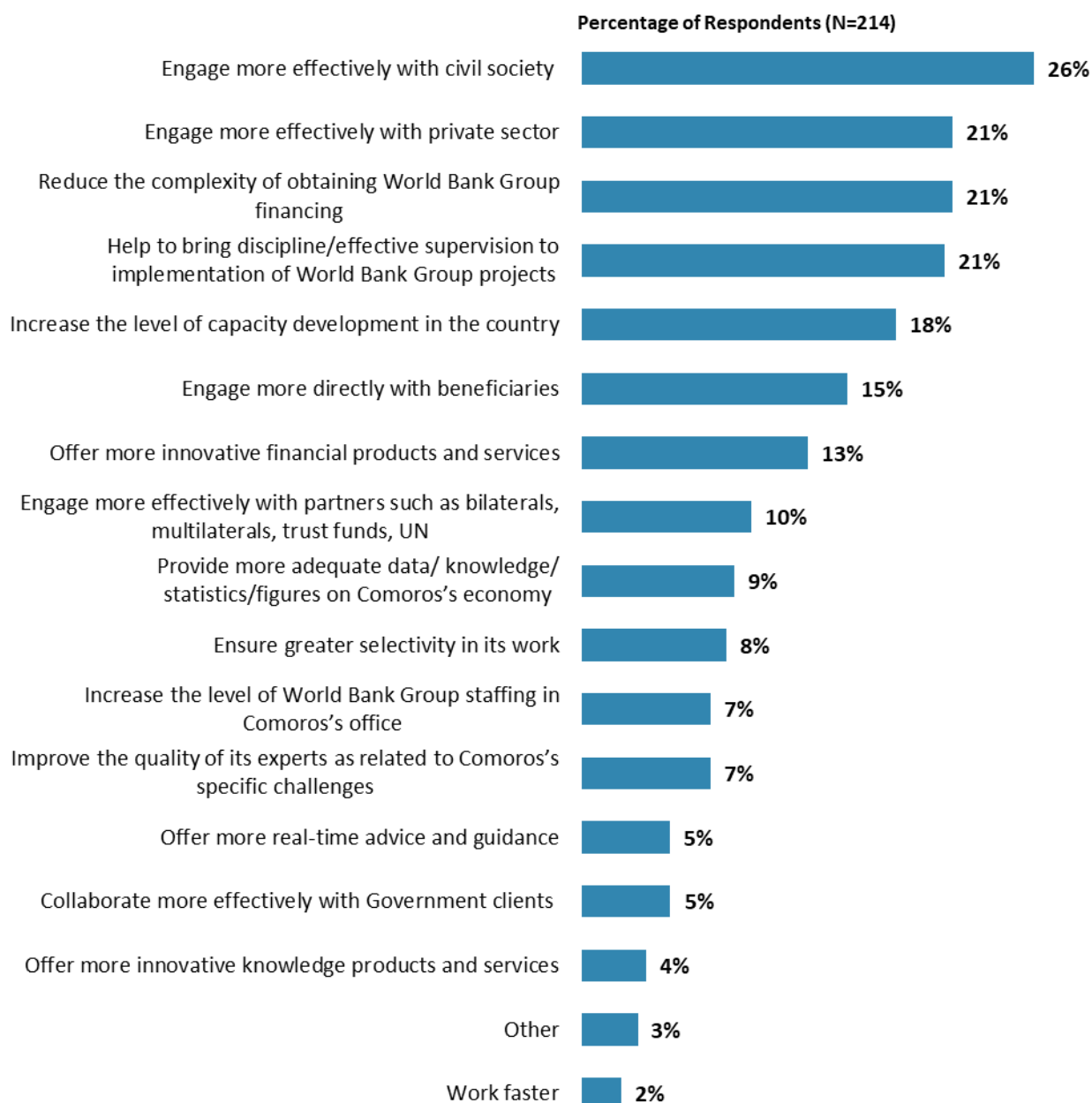

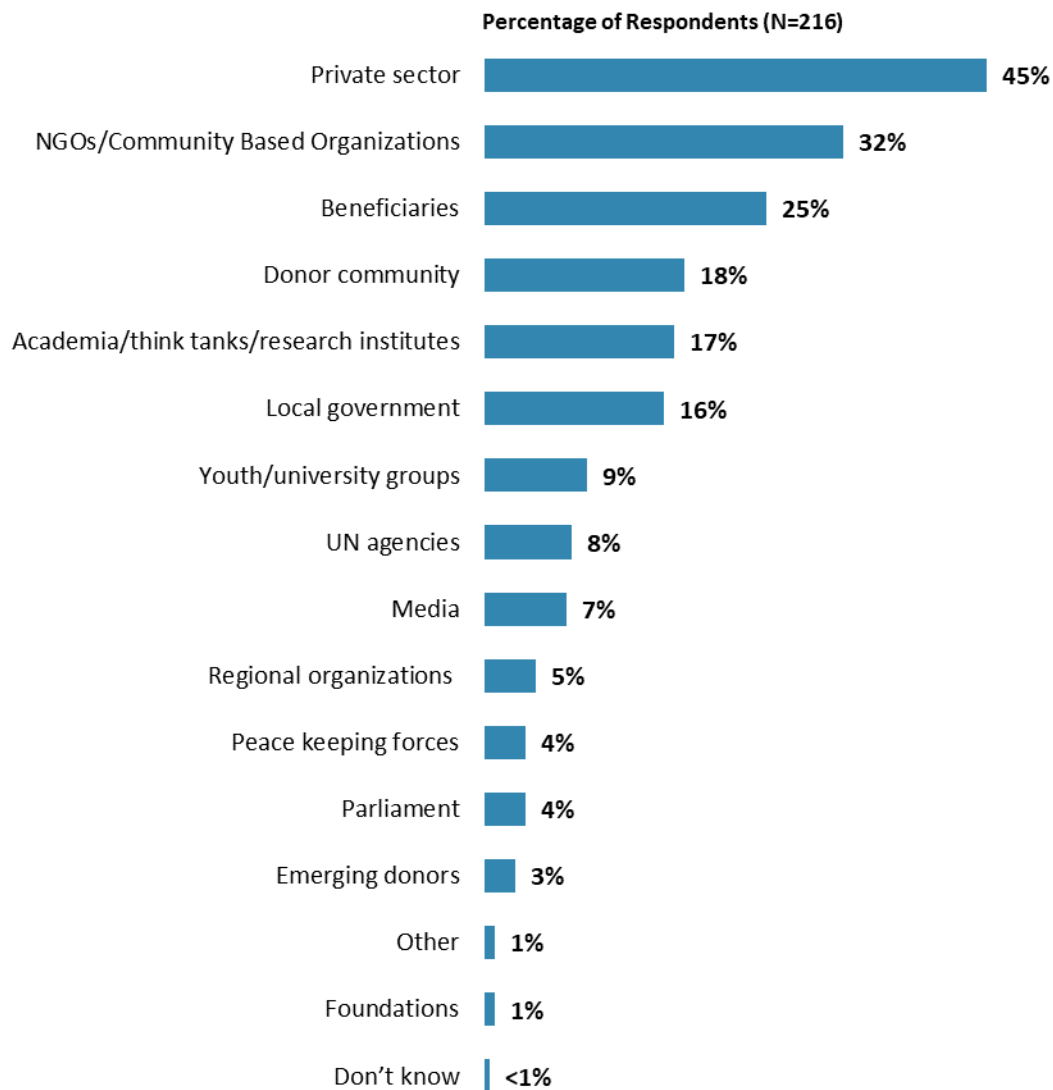

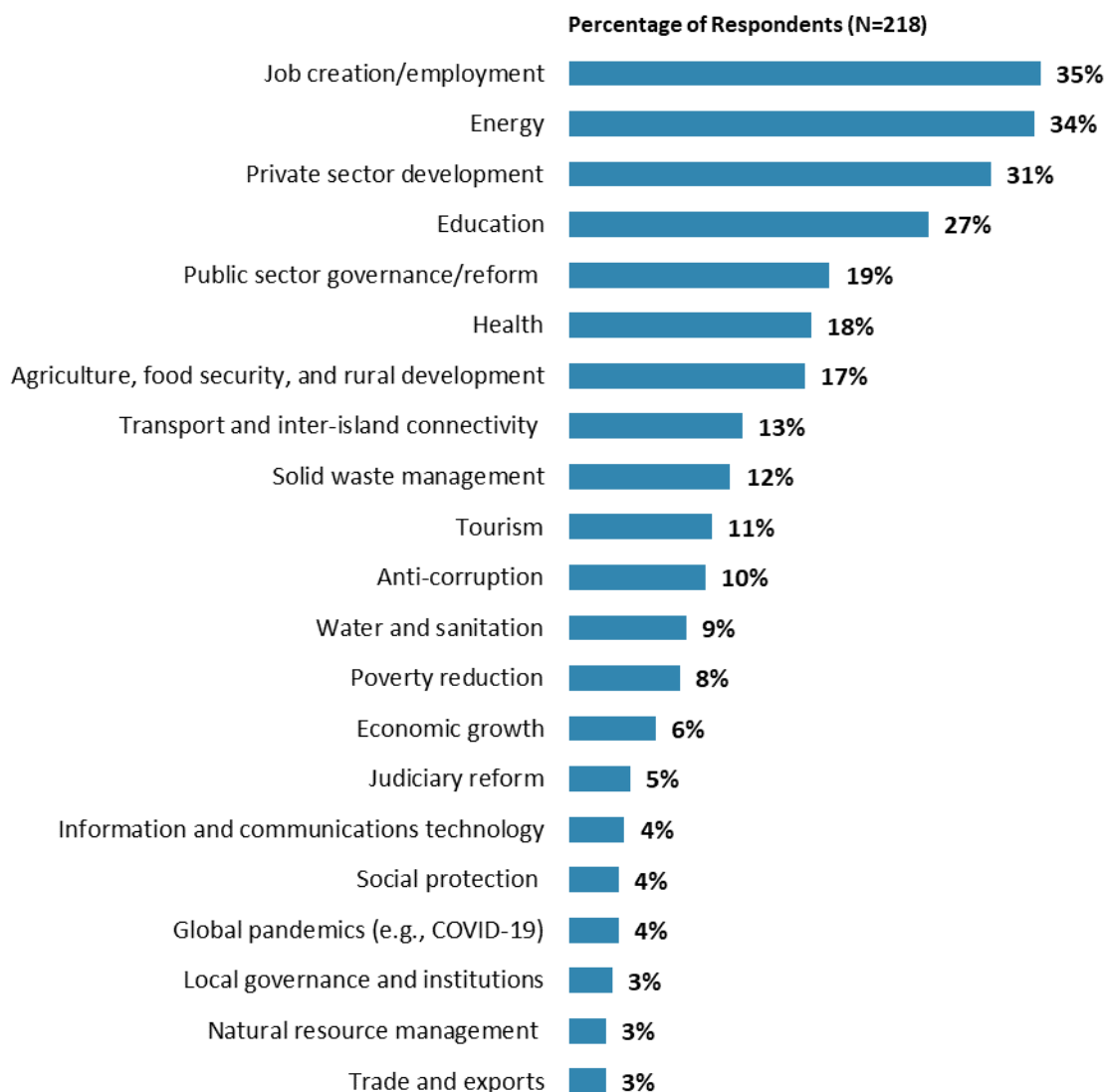
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country? (Choose no more than TWO)"

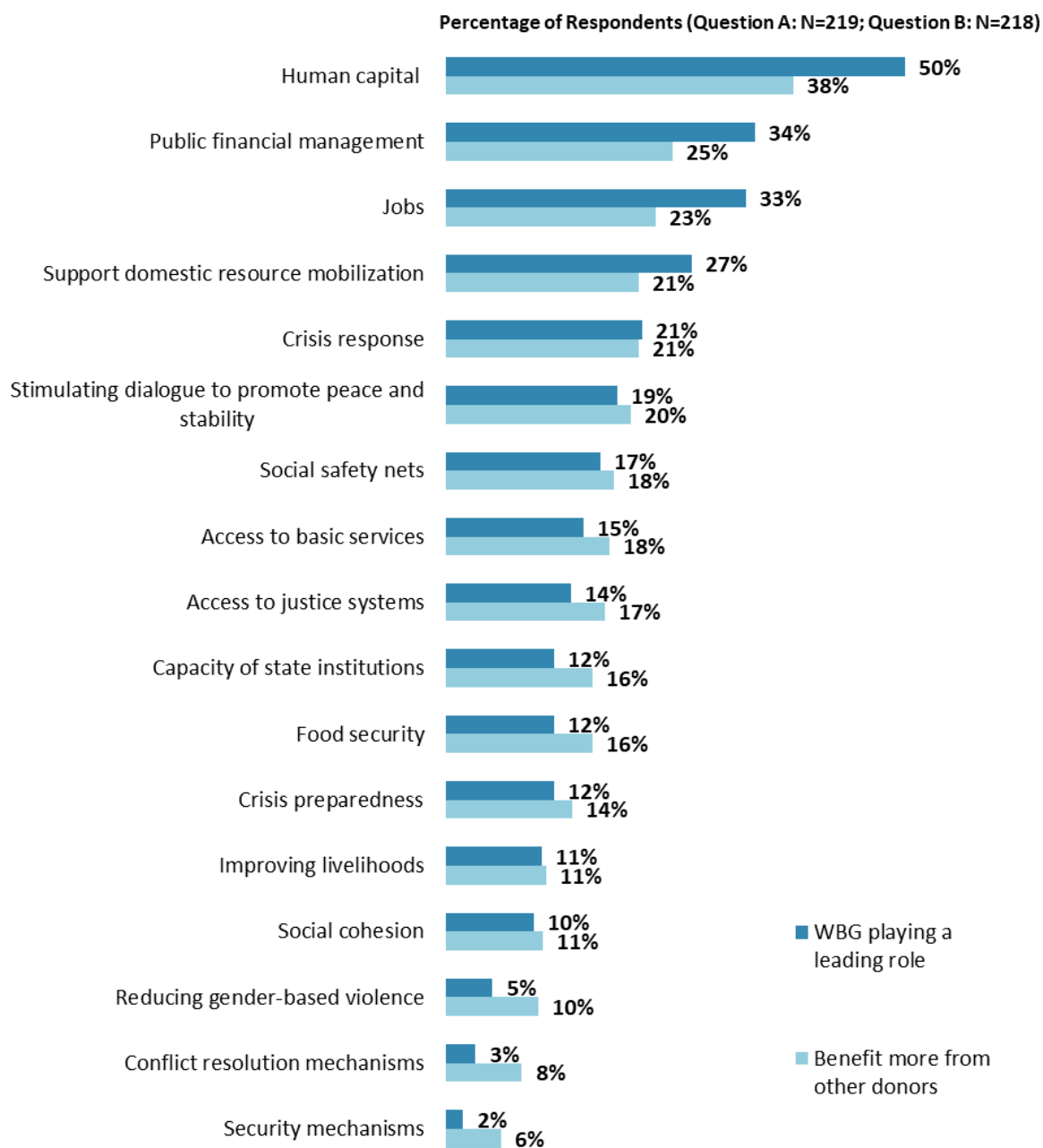

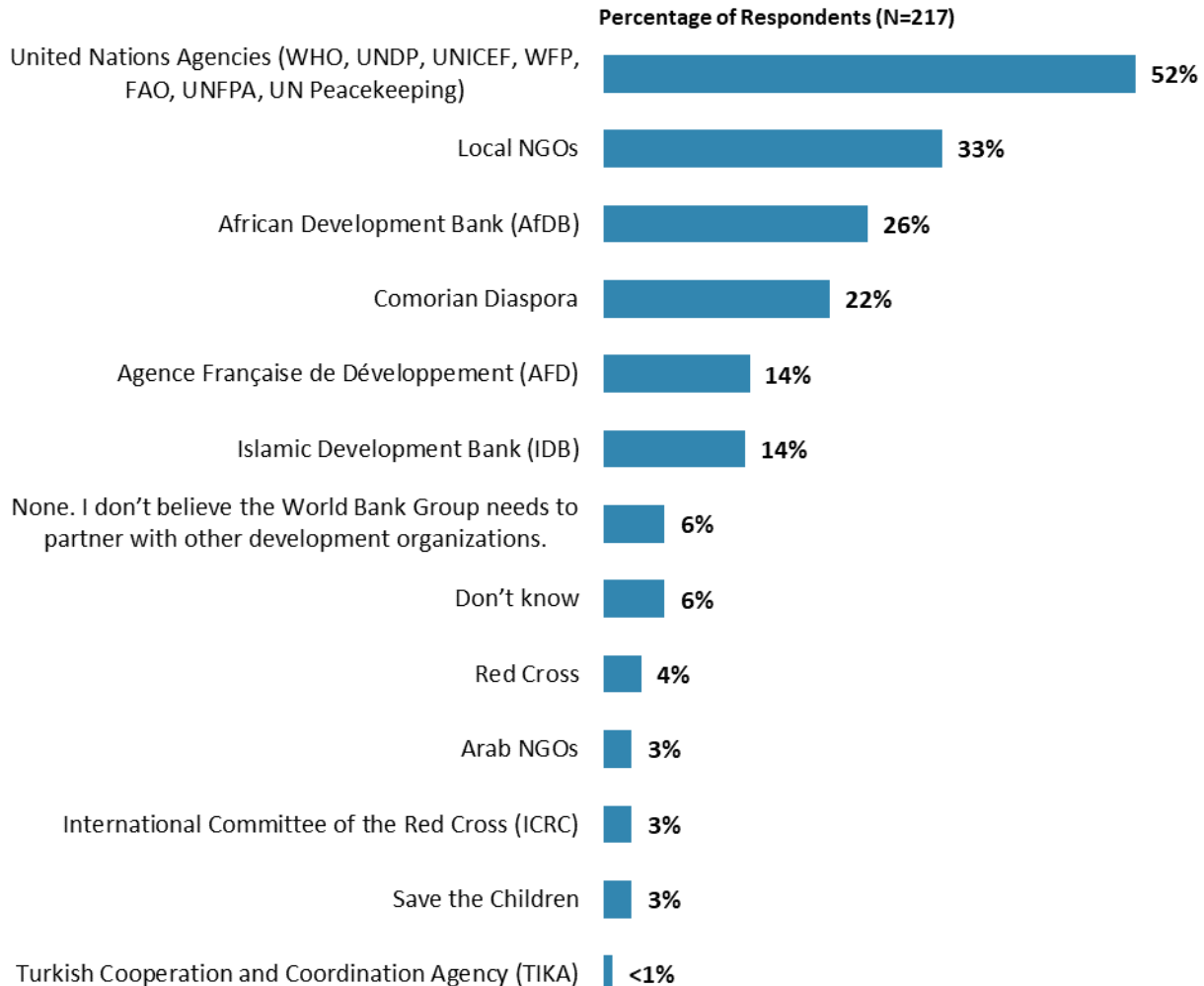

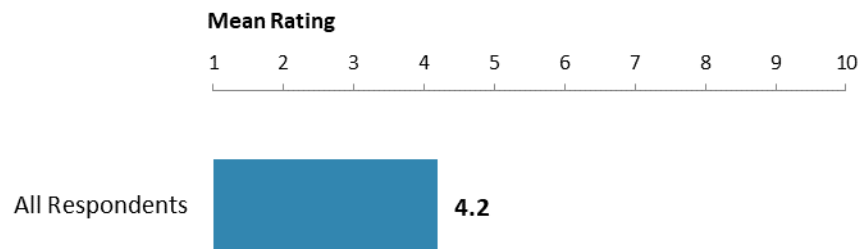

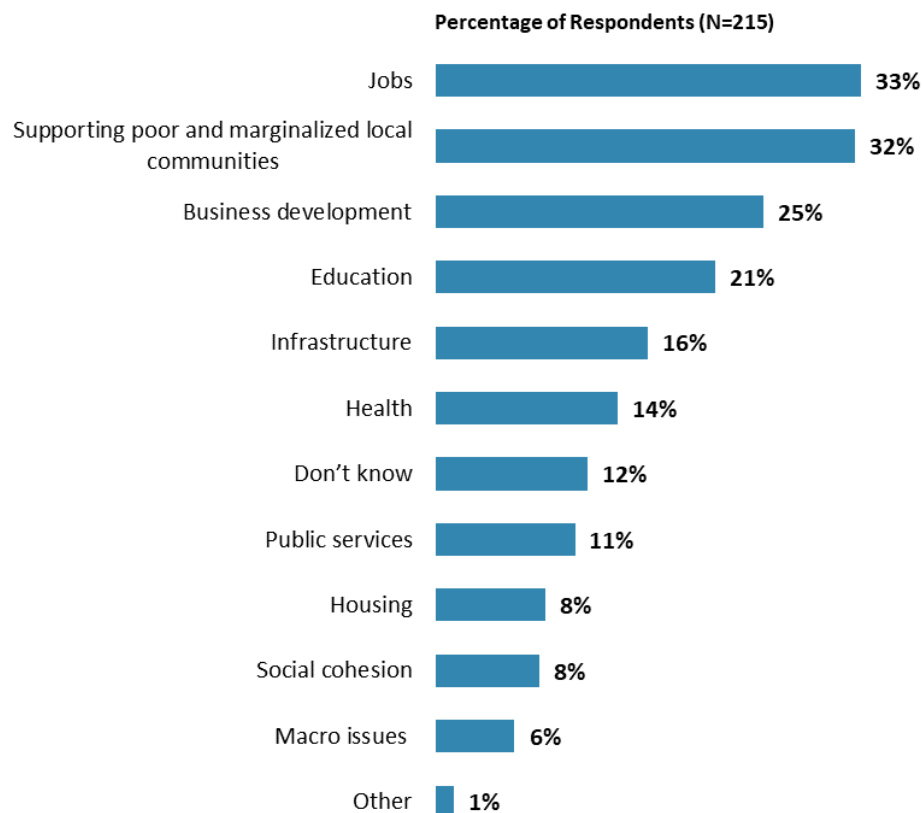

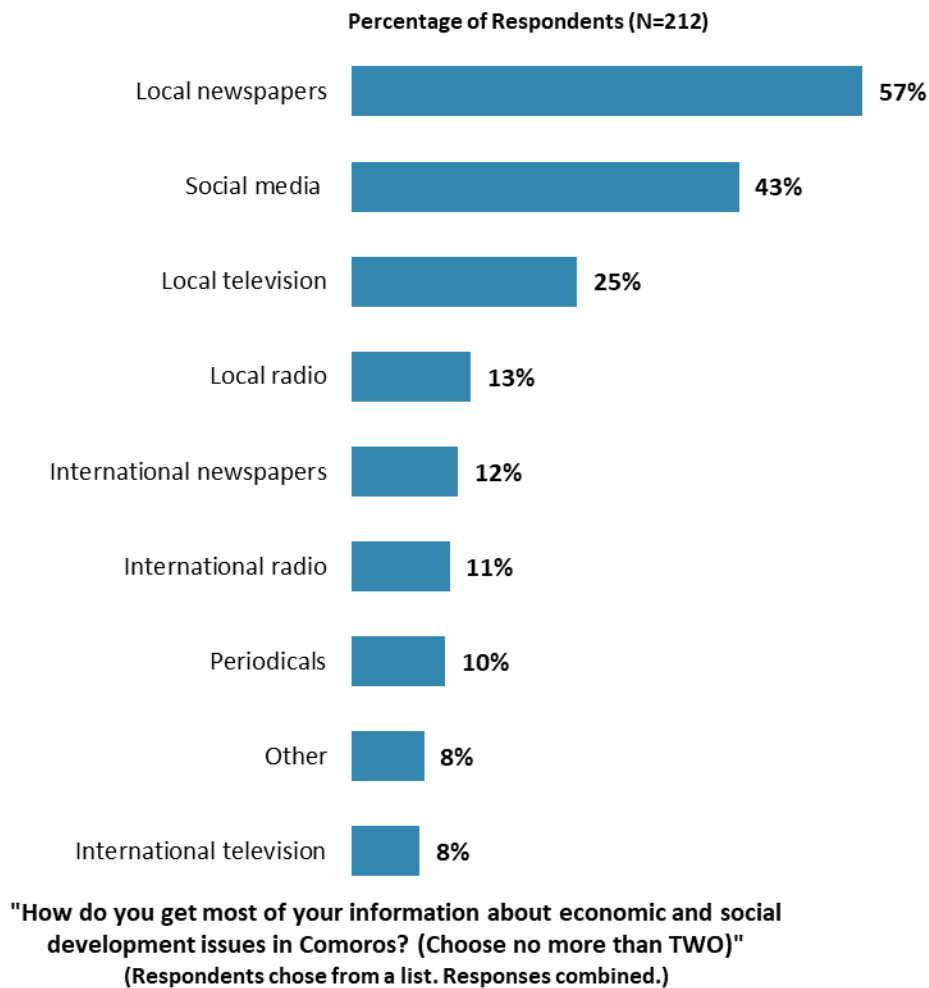

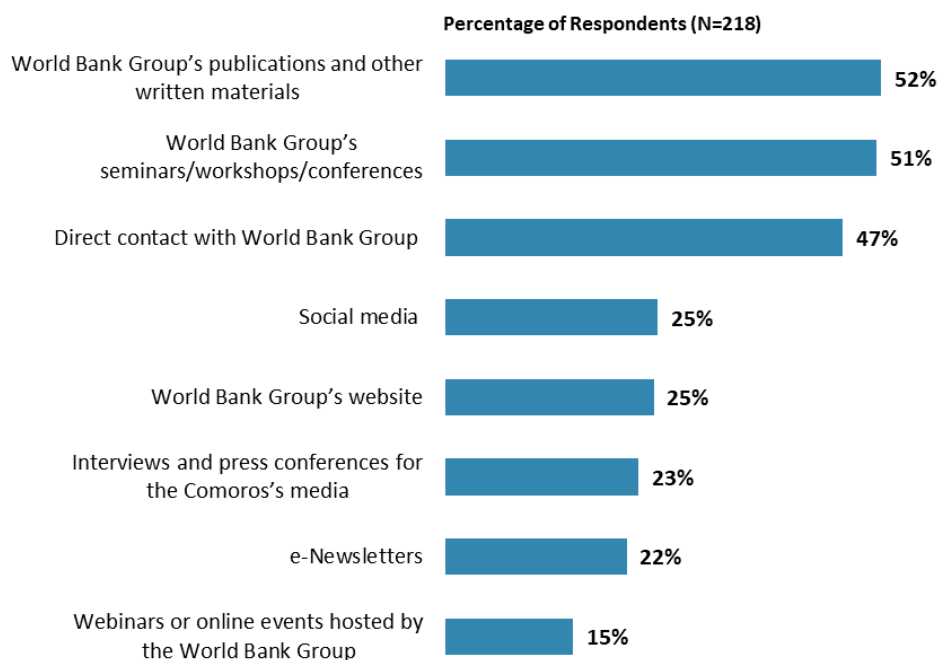

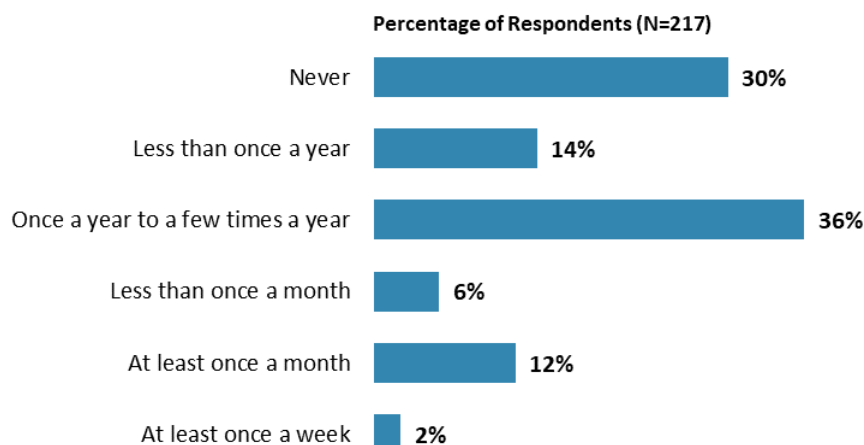

### WBG Interaction Frequency

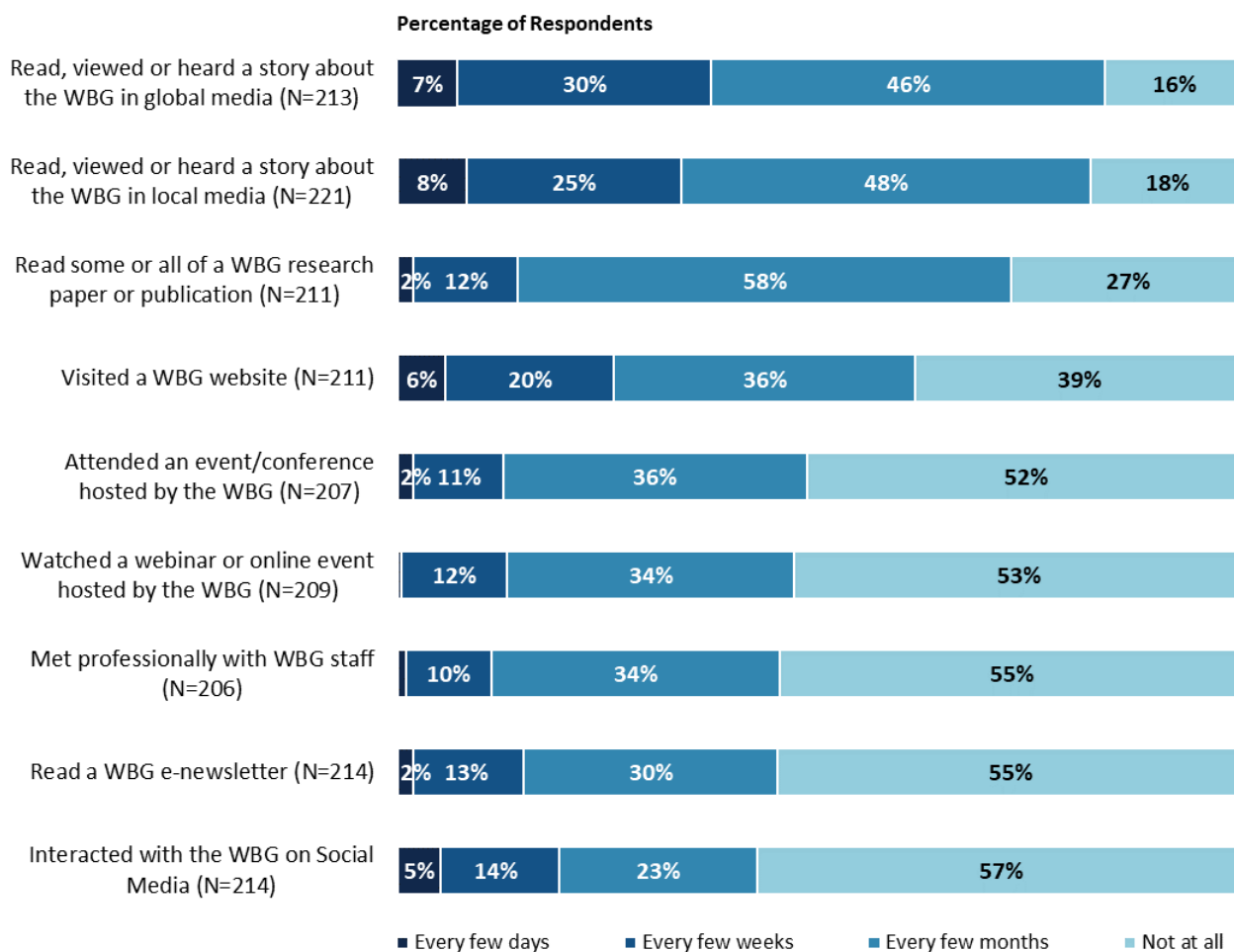


"How frequently do you interact with the World Bank Group now in Comoros?"
