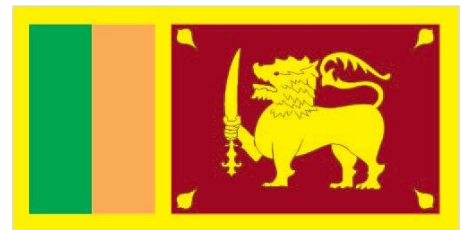

I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Sri Lanka perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Sri Lanka*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From June to August 2021, 541 stakeholders of the WBG in Sri Lanka were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a Minister; office of a Parliamentarian; employees of ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judiciary; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector and private banks; private foundations; NGOs and community-based organizations; faith-based groups; youth groups; academia/research institutes/think tanks; and the media.

A total of 253 stakeholders participated in the survey (47% response rate). Respondents received the questionnaire via a courier or via email and returned it accordingly, or they completed the questionnaire online.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'19 (response rate was 31%, N=191). The data were weighted to reach similar stakeholder compositions across both survey years, allowing for more statistically reliable comparisons. Note, stakeholders who identified themselves as "Other" in the stakeholder category options were not included in these comparisons. Due to this weighting, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'19 COS report and the non-weighted data presented in this report. 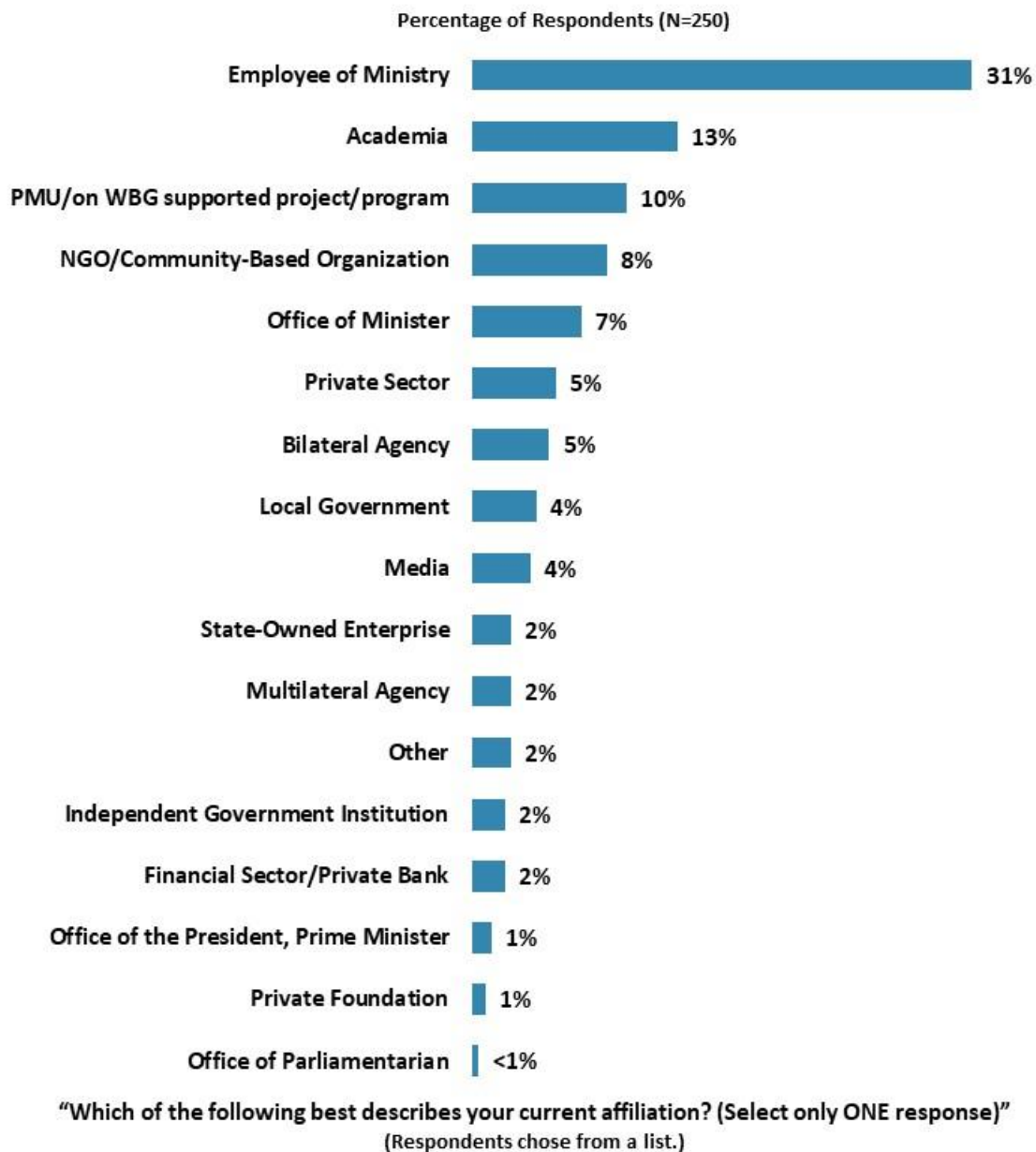

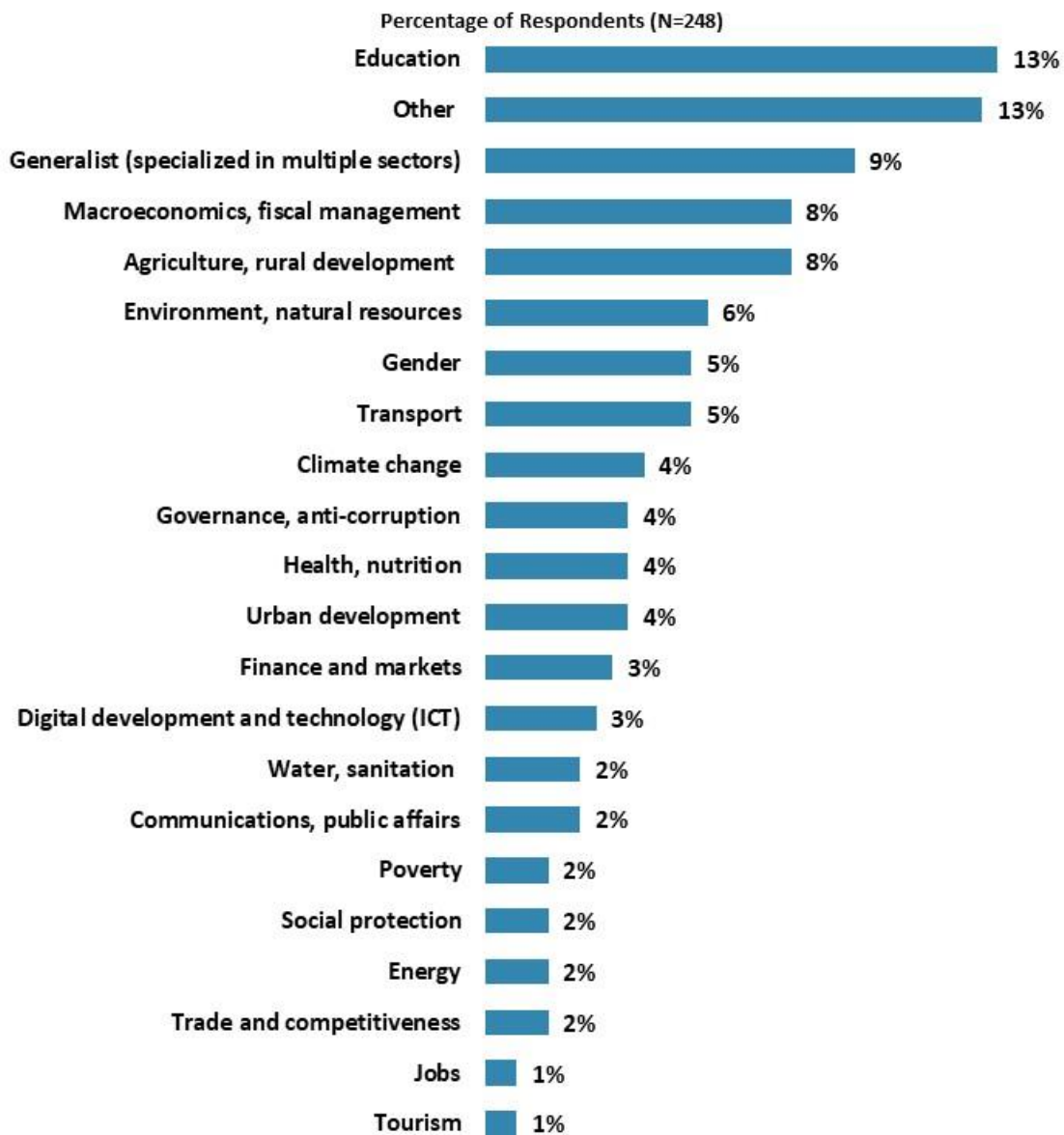

Area of Primary Specialization

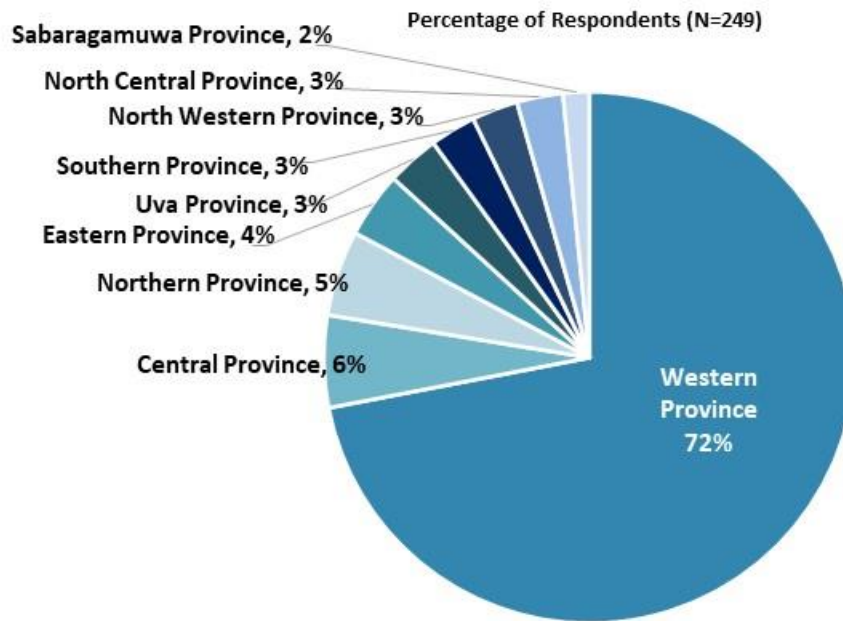


"Please identify the primary specialization of your work. (Select only ONE response)"

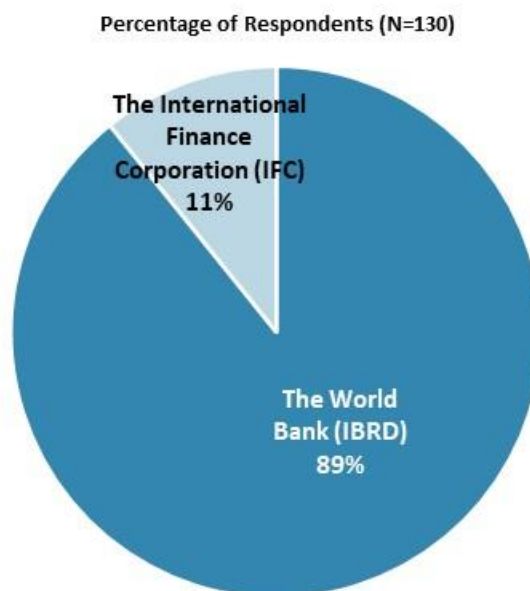

Exposure to Agencies within the World Bank Group



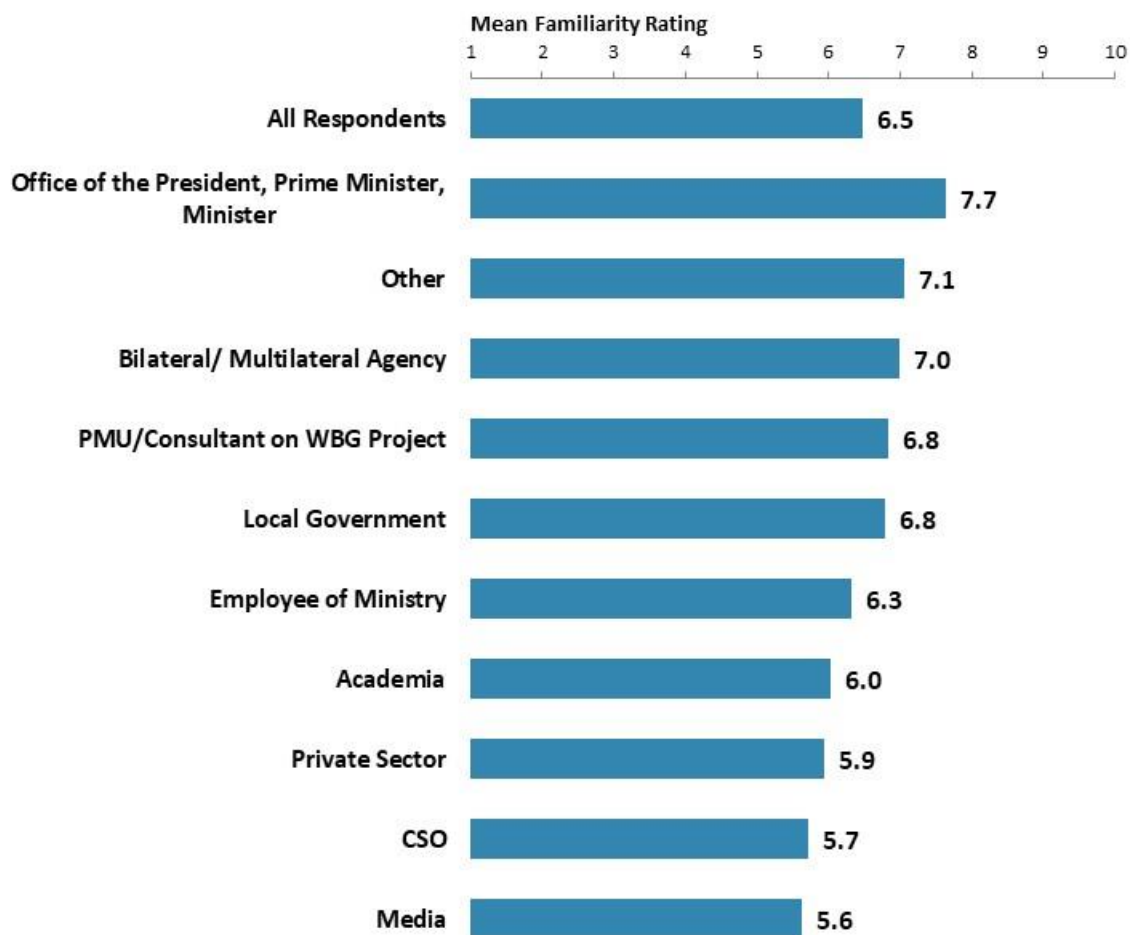

III. Demographics of the Sample (continued)

Familiarity with the World Bank²

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of familiarity with the WB compared to respondents in the FY'19 Country Survey (weighted mean in FY'21 = 6.5; weighted mean in FY'19 = 5.9).
- **Impact of familiarity:** Respondents' ratings of familiarity with the WB were significantly, strongly correlated with their ratings for the WB's overall effectiveness in Sri Lanka, and significantly, moderately correlated with their agreement that the WBG plays a relevant role in Sri Lanka's development, and with their ratings of the extent to which the WBG's work helps achieve development results in Sri Lanka.

(1 - "Not familiar at all", 10 - "Extremely familiar")

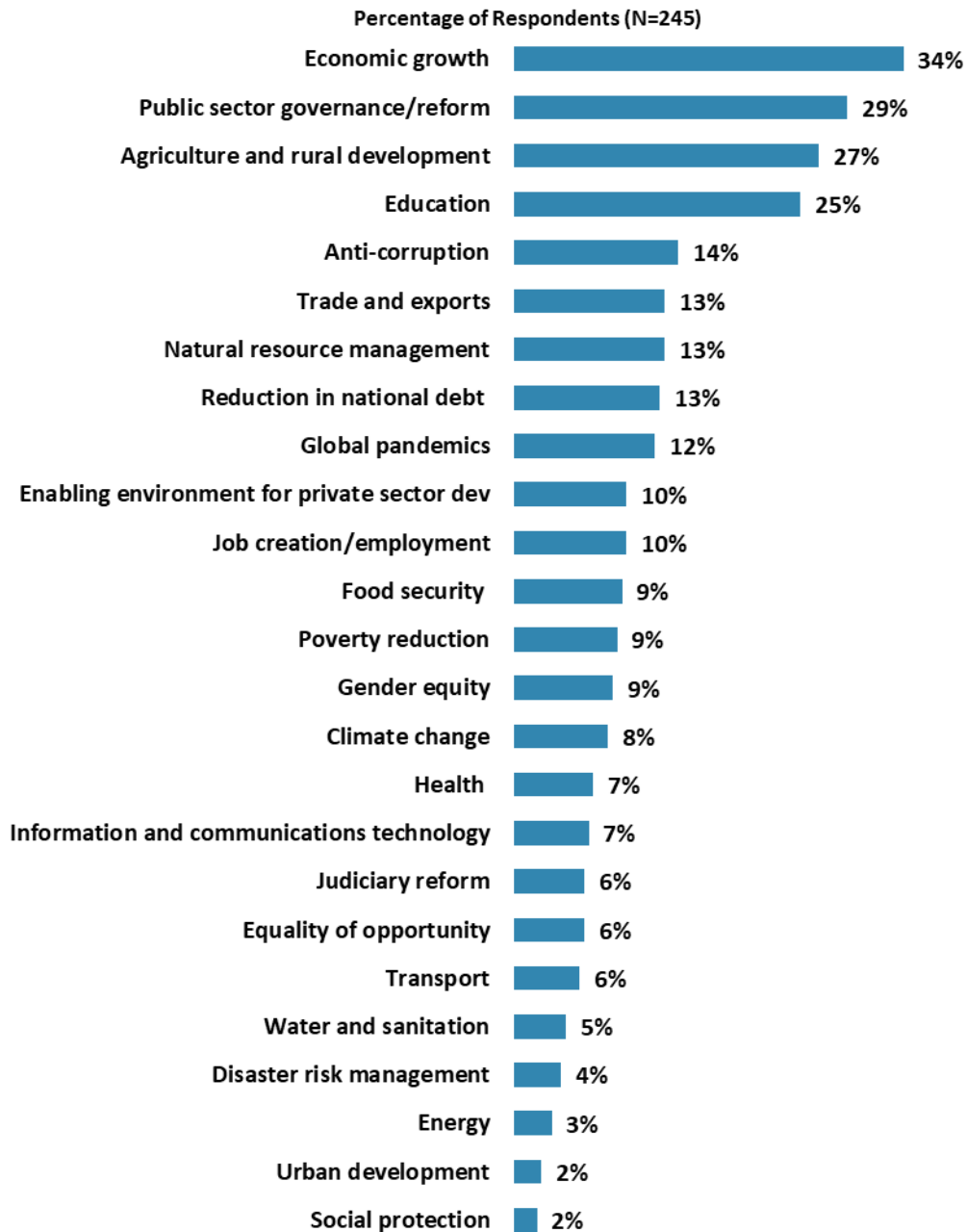

Development Priority

- **Year comparison:** Respondents in the FY'19 Country Survey indicated that the most important development priorities in Sri Lanka were “*public sector governance/reform*” (42%), “*economic growth*” (31%), “*education*” (31%), “*anti-corruption*” (19%), and “*health*” (16%).

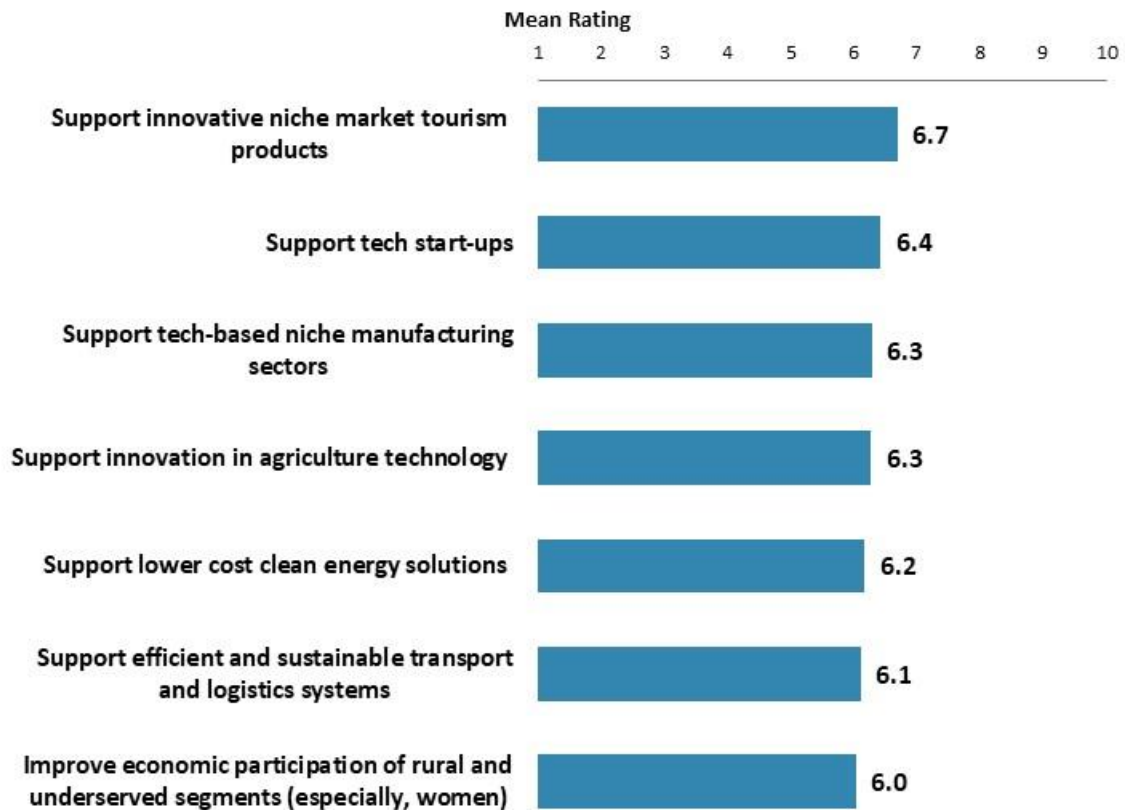

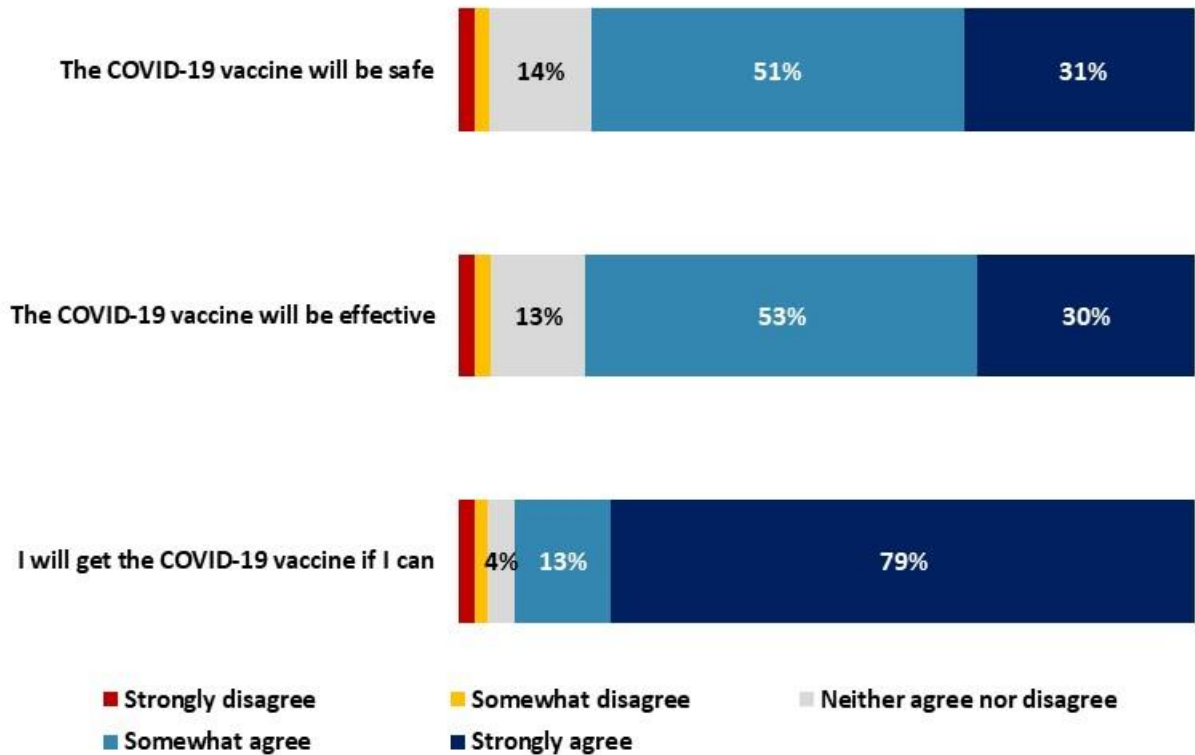
"To what extent do the following focus areas contribute to Sri Lanka's development through private sector intervention?"

"Thinking more specifically about an eventual coronavirus/COVID-19 vaccine that is made available in your country, please indicate whether you agree/disagree with each of the following statements."



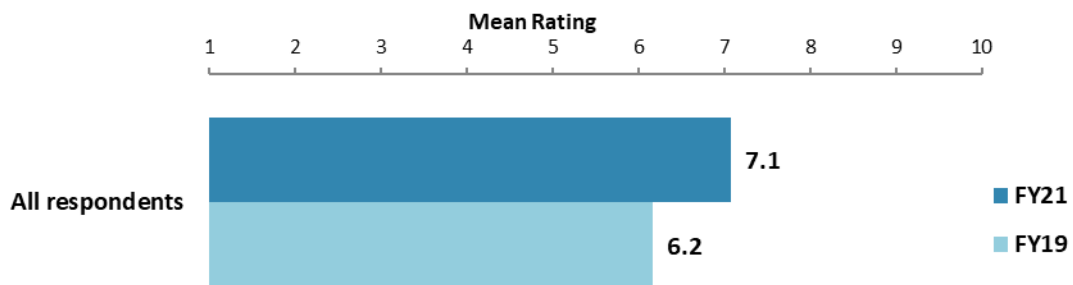

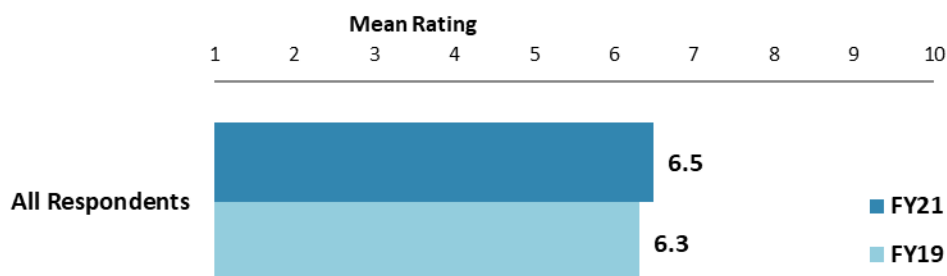

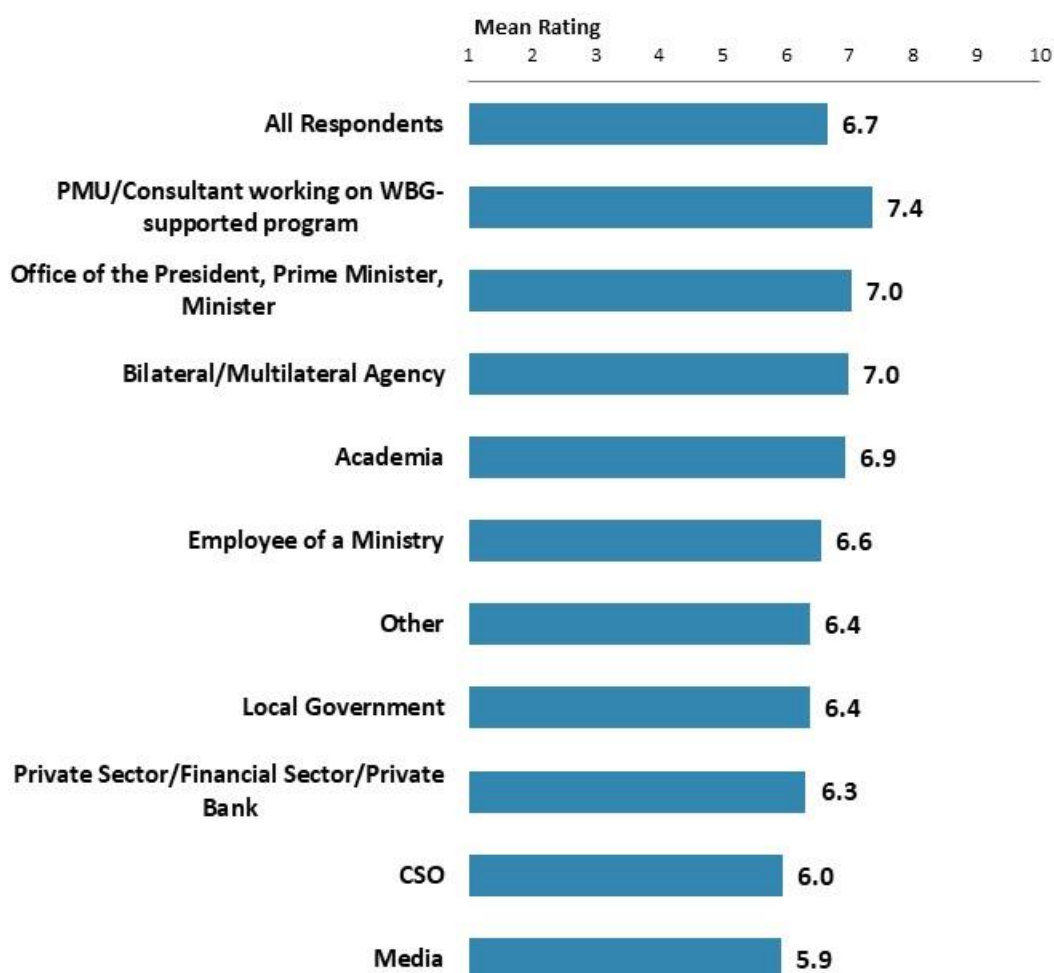

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-nine COS indicator questions (mean rating = 7.1) compared to respondents who do not collaborate with the WBG (mean rating = 6.2).
- **Stakeholder groups:** Respondents from PMU/Consultants on WBG-supported projects had the highest mean ratings for the aggregated responses to the twenty-nine COS indicator questions whereas respondents from CSOs and the media had significantly lower mean ratings. 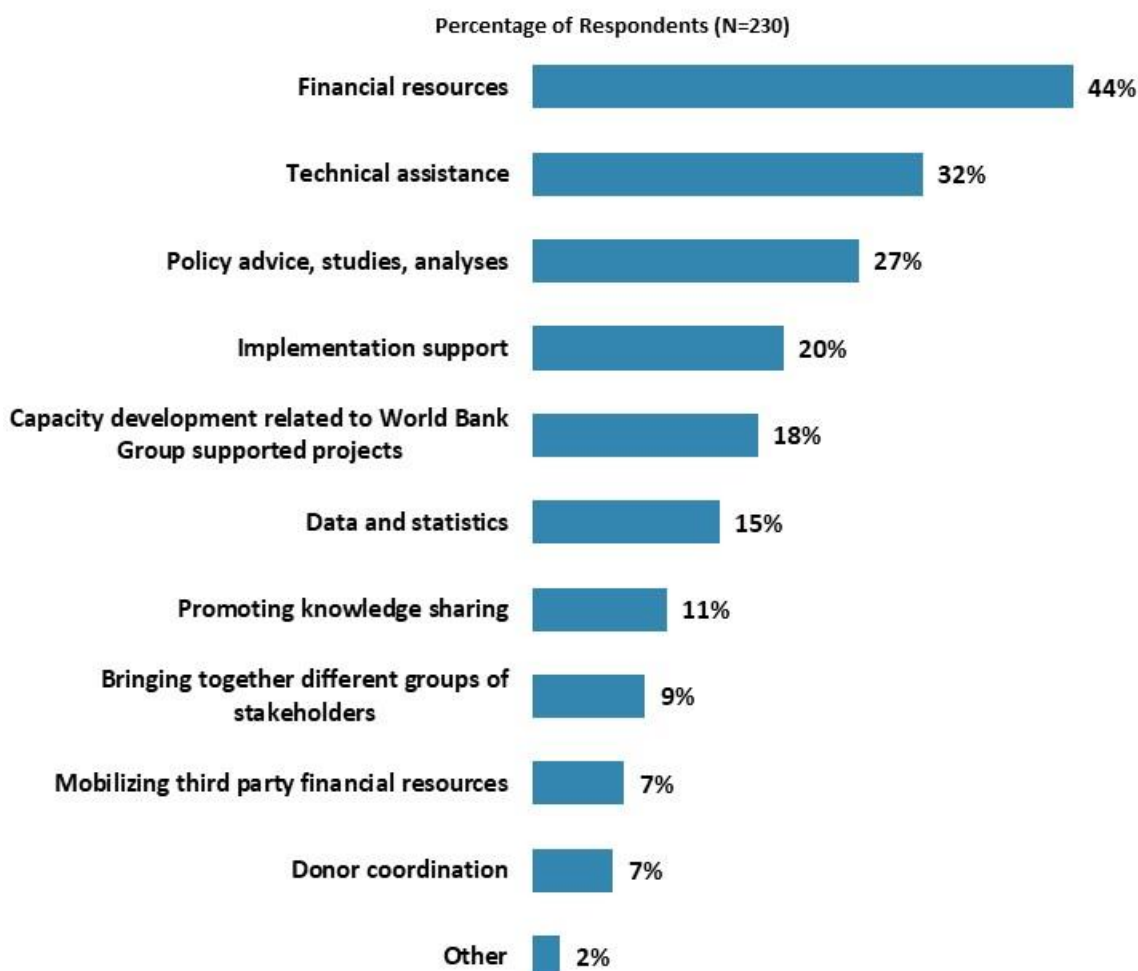
Mean Ratings for All Indicator Questions by Collaboration on a Scale from 1 to 10

Greatest Value

- **Year comparison:** Respondents in the previous FY'19 Country Survey indicated that the WBG's greatest values to Sri Lanka were "*financial resources*" (42%), "*capacity development related to WBG supported projects*" (29%), "*technical assistance*" (29%), and "*policy advice studies, analyses*" (25%).



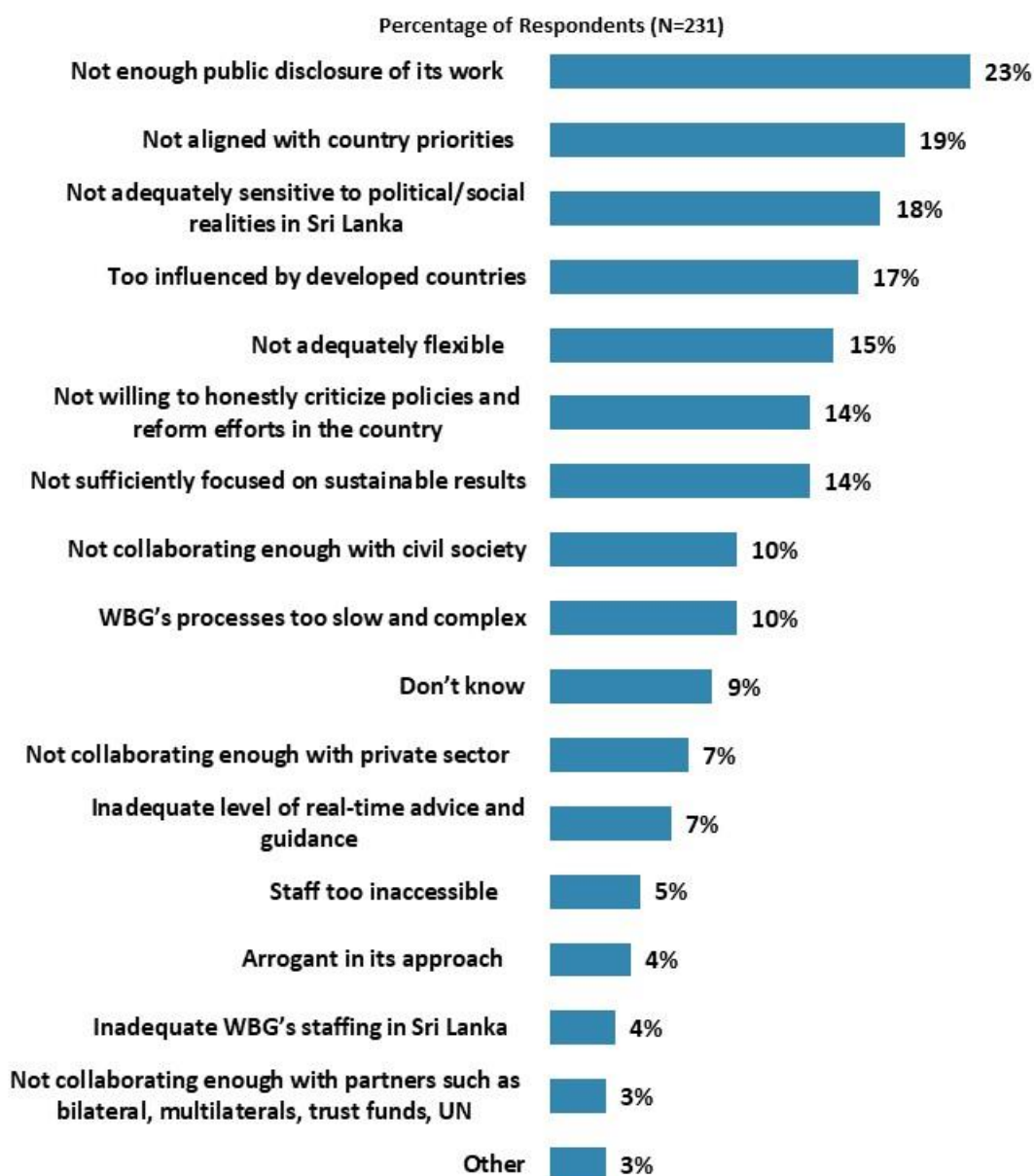

Greatest Weakness

- **Year comparison:** Respondents in the previous FY'19 Country Survey indicated that the WBG's greatest weaknesses in its work in Sri Lanka were "*not enough public disclosure of its work*" (26%), "*Too influenced by developed countries*" (16%), and "*Not aligned with country priorities*" (16%).

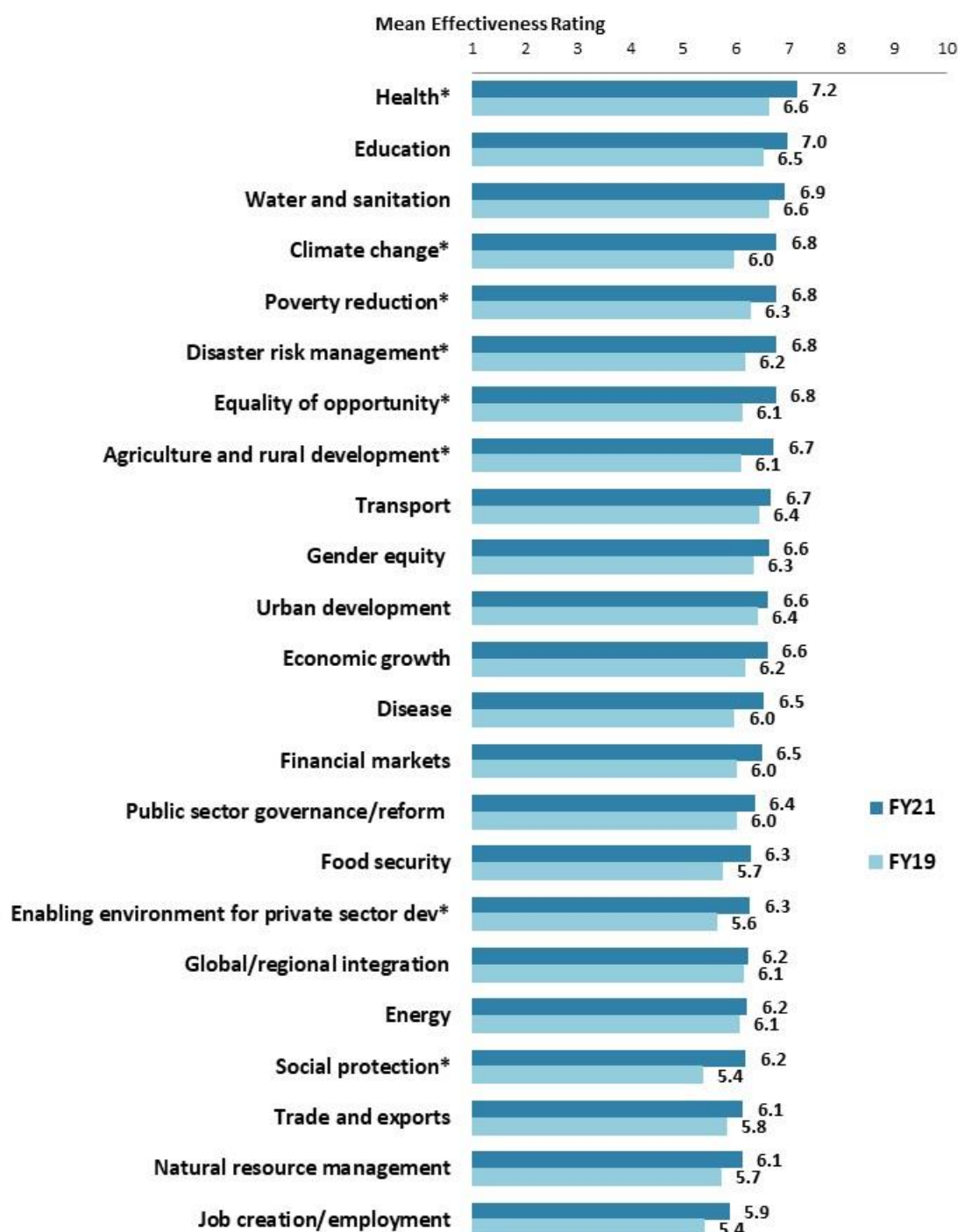

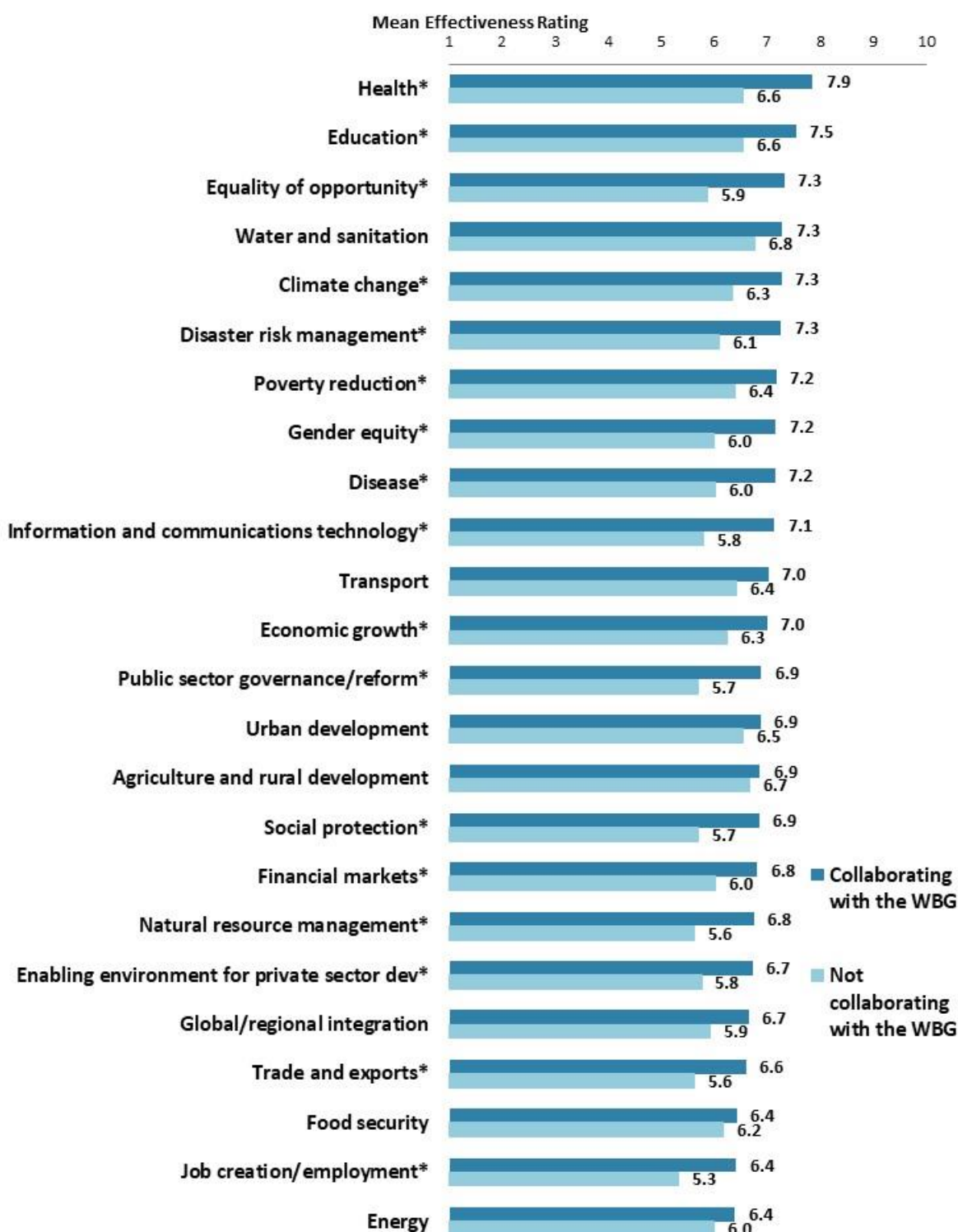

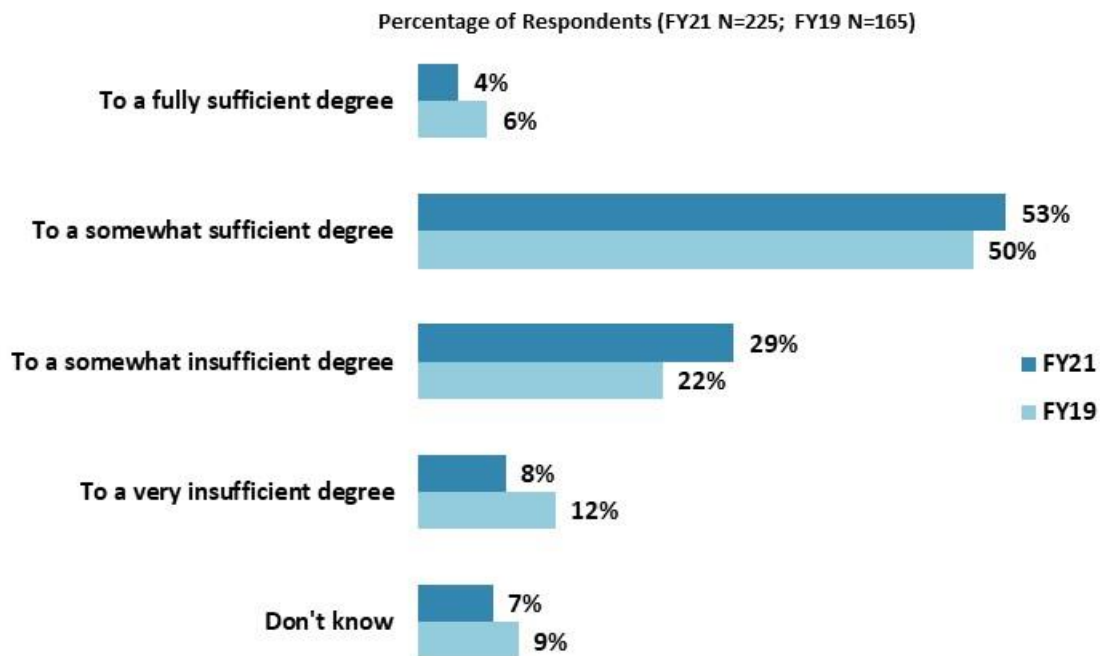

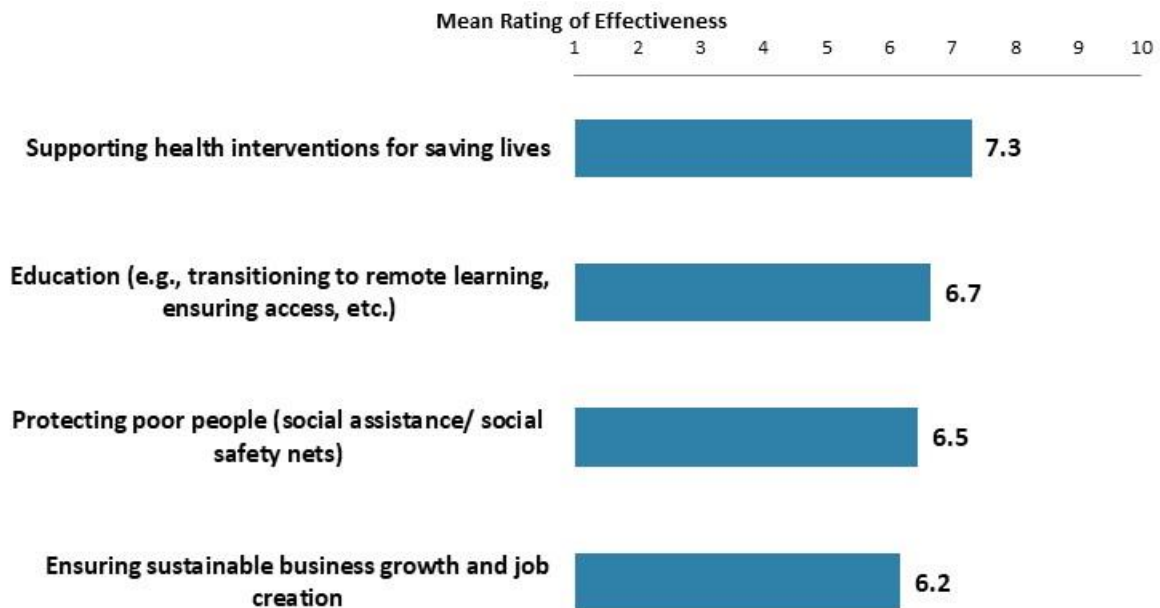
Helping the Poorest

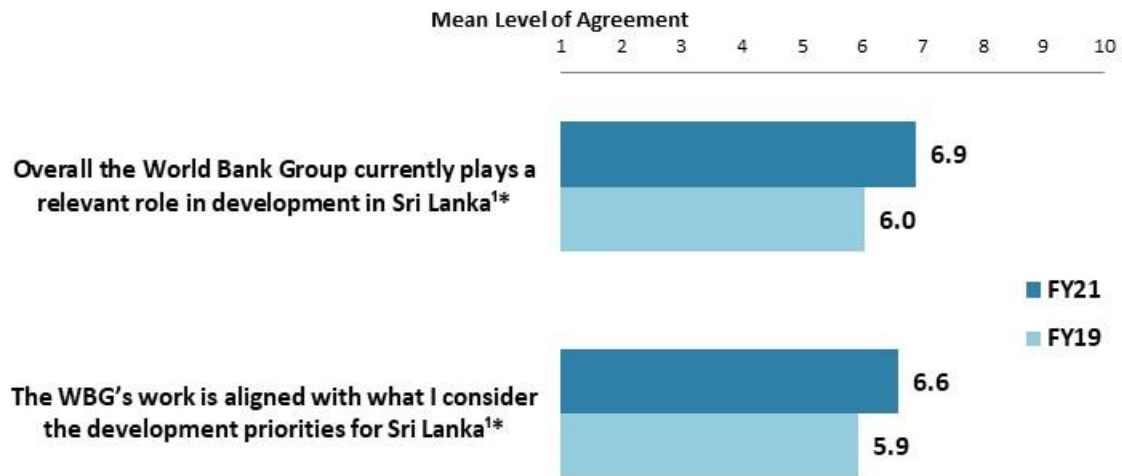

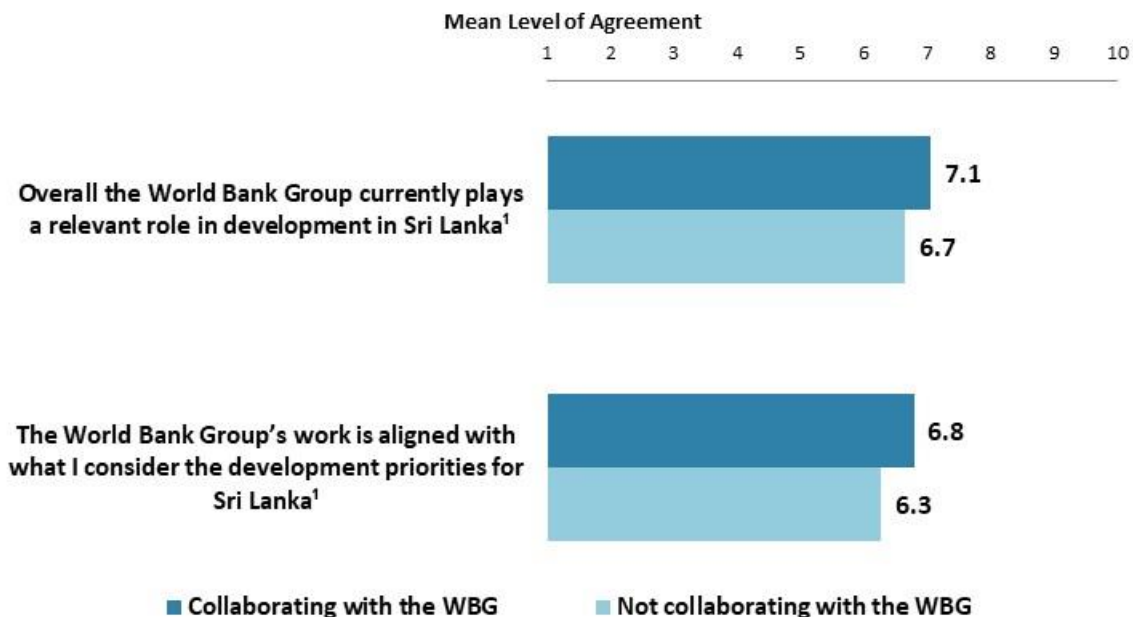

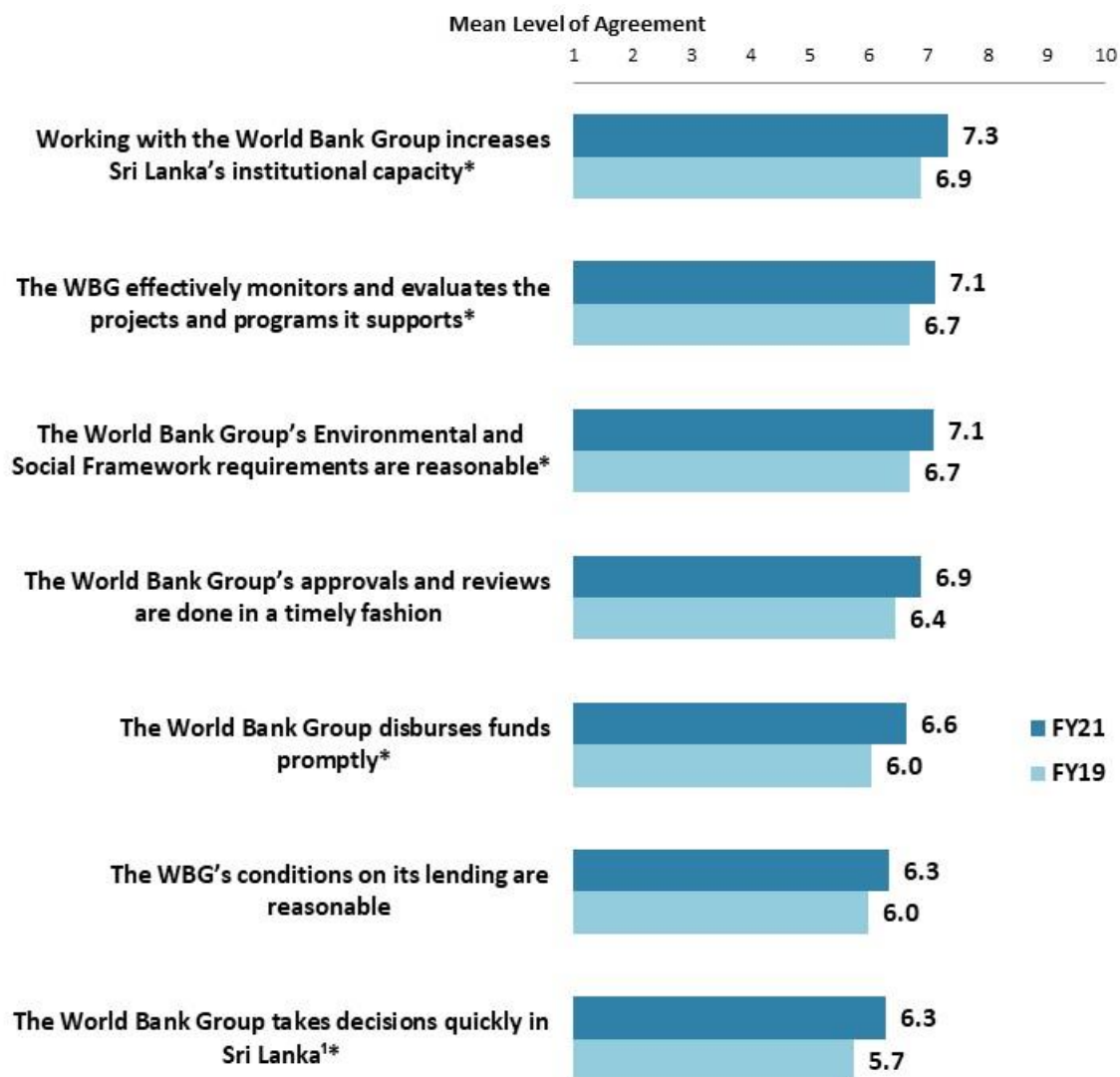

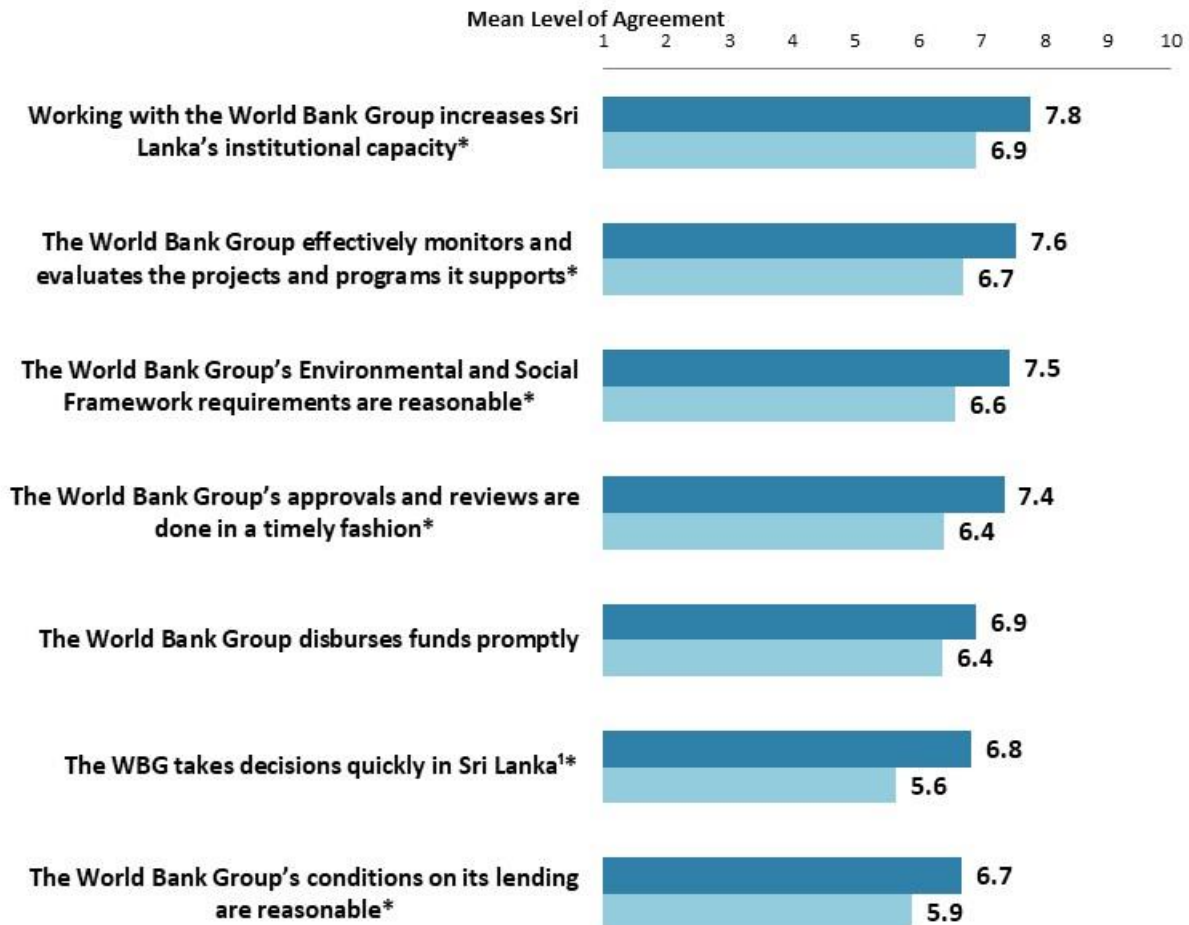

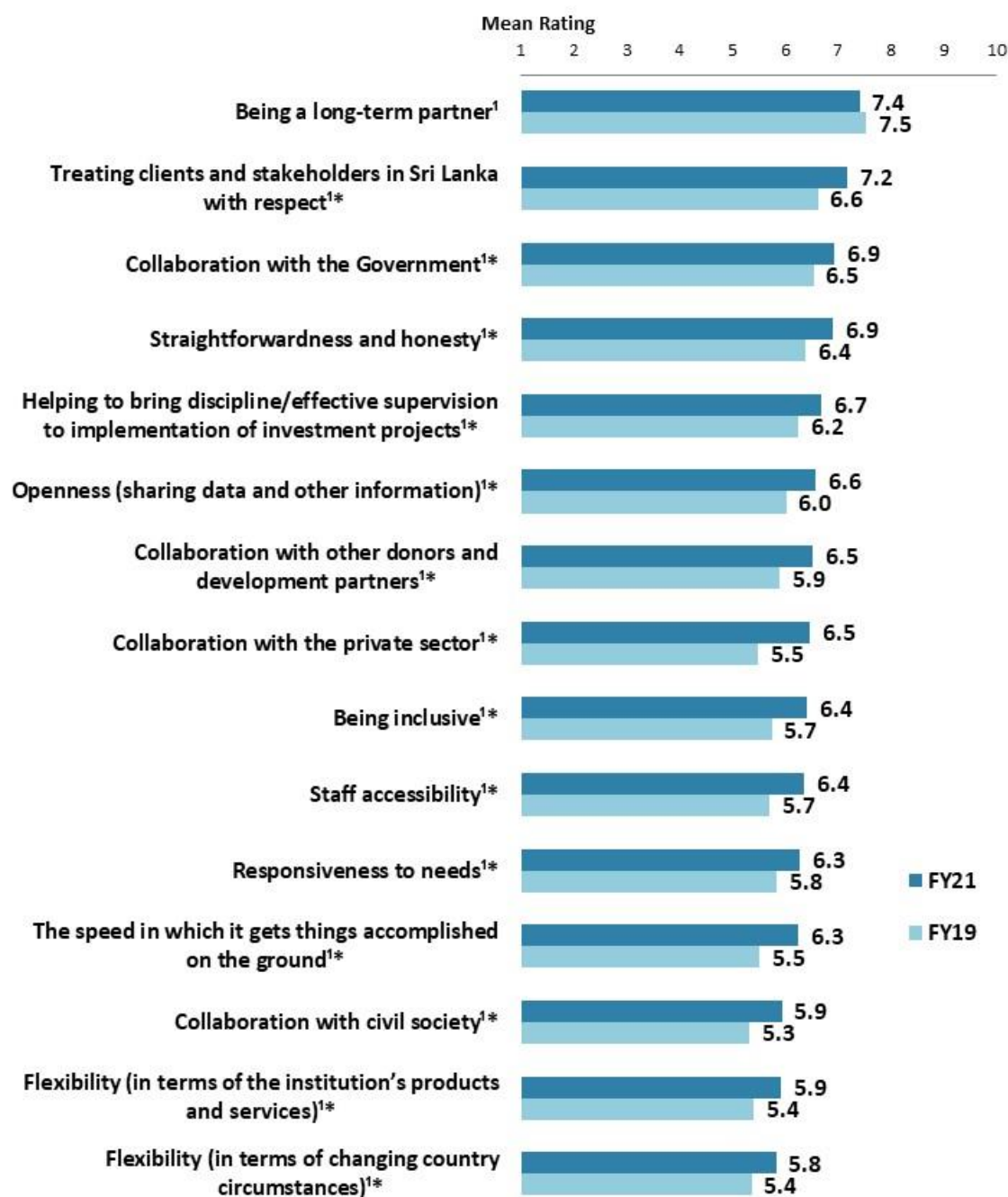

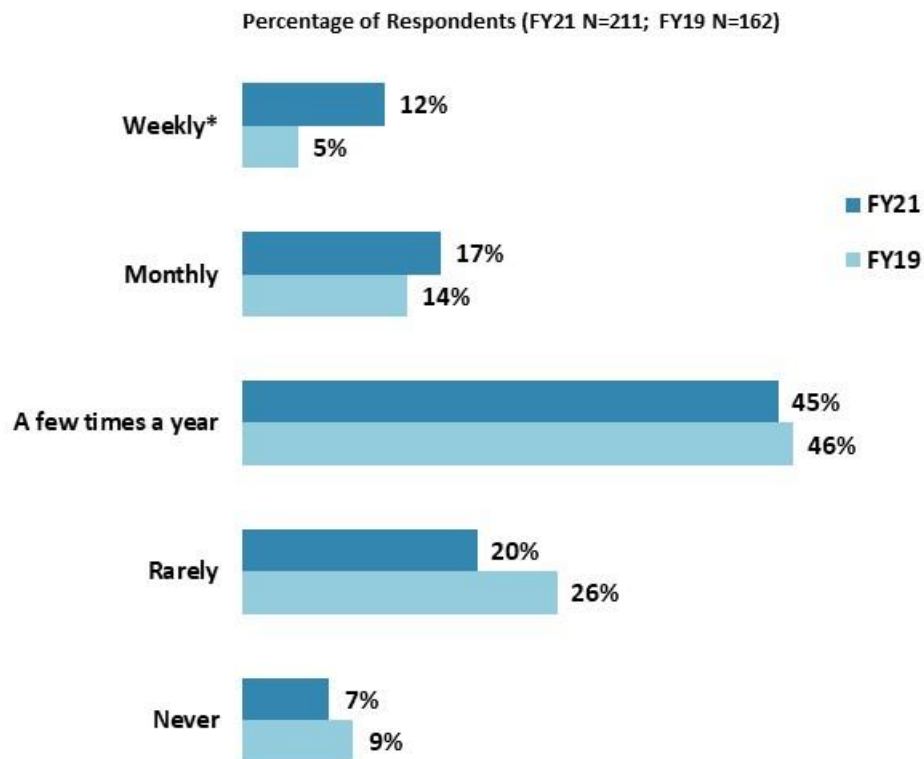

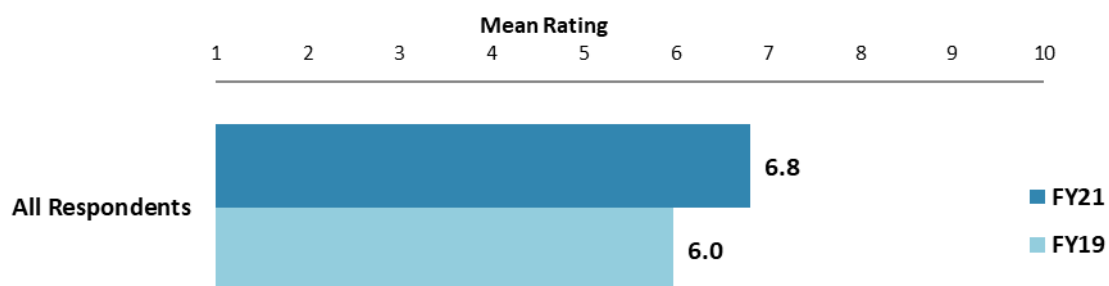

Meeting Sri Lanka's Knowledge Needs (Indicator Question)

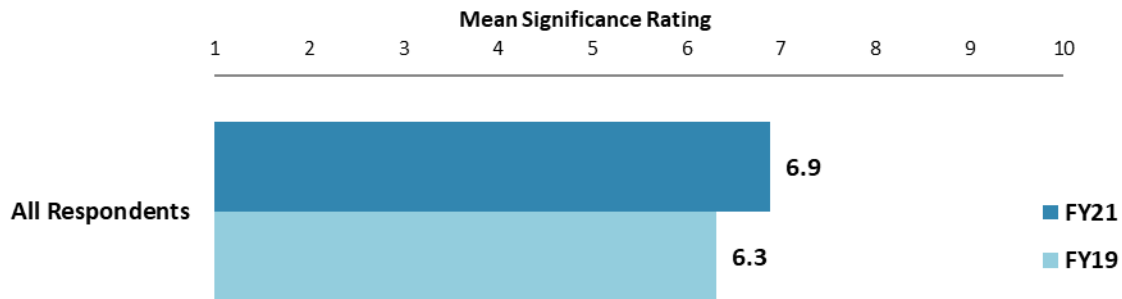

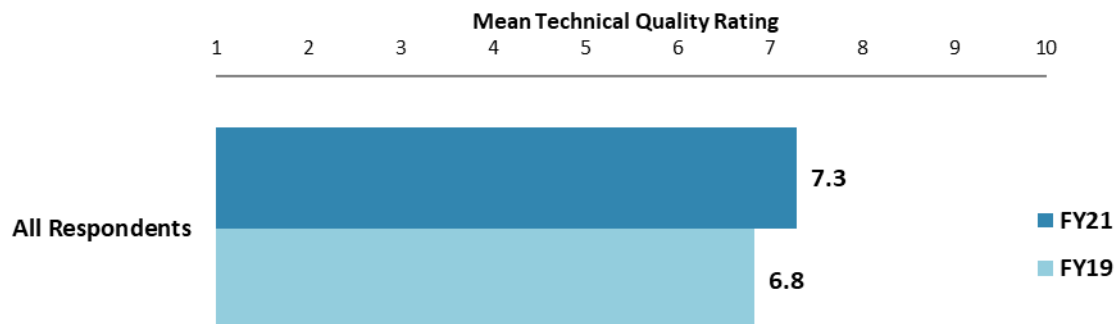
Contribution of the WBG's Knowledge Work and Activities (*Indicator Question*)

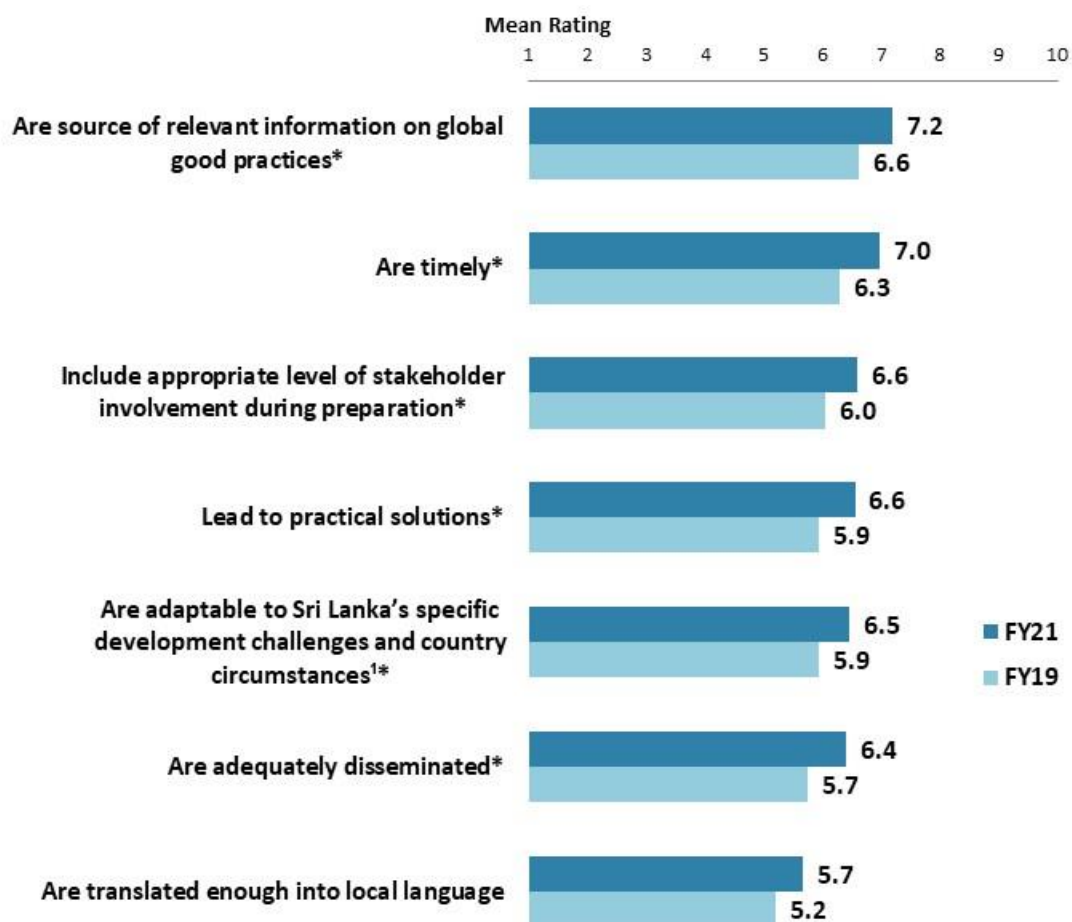

Qualities of the WBG's Knowledge Work and Activities: Year Comparison

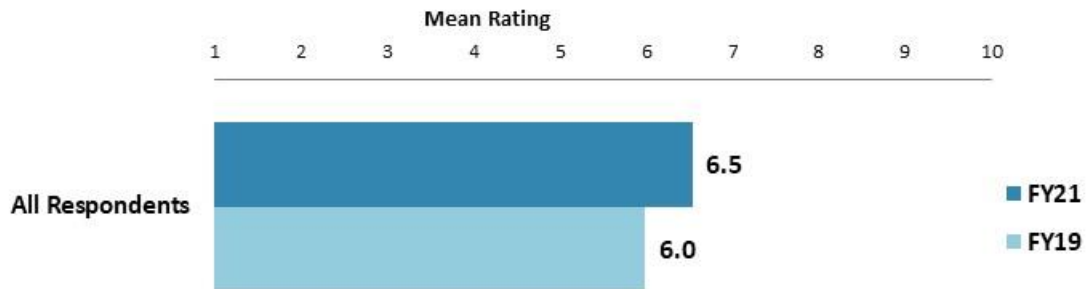

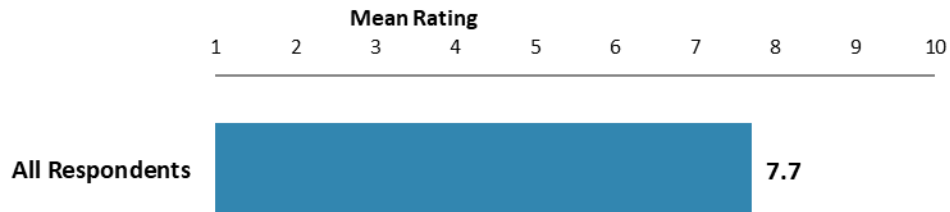

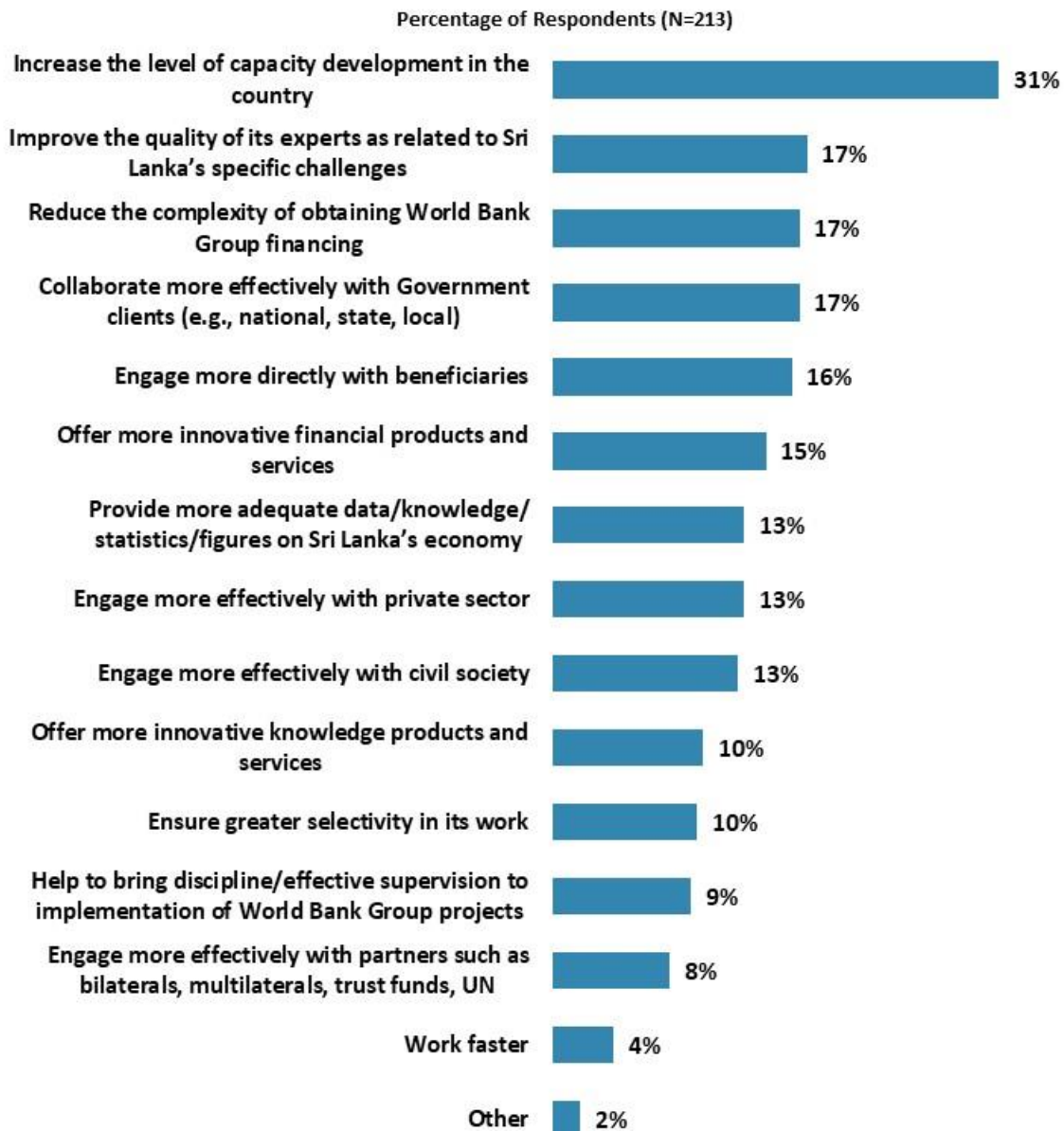
"How important is the World Bank Group's global advocacy role in areas such as climate, health, gender, and debt?" (1-"Not important at all", 10-"Very important")

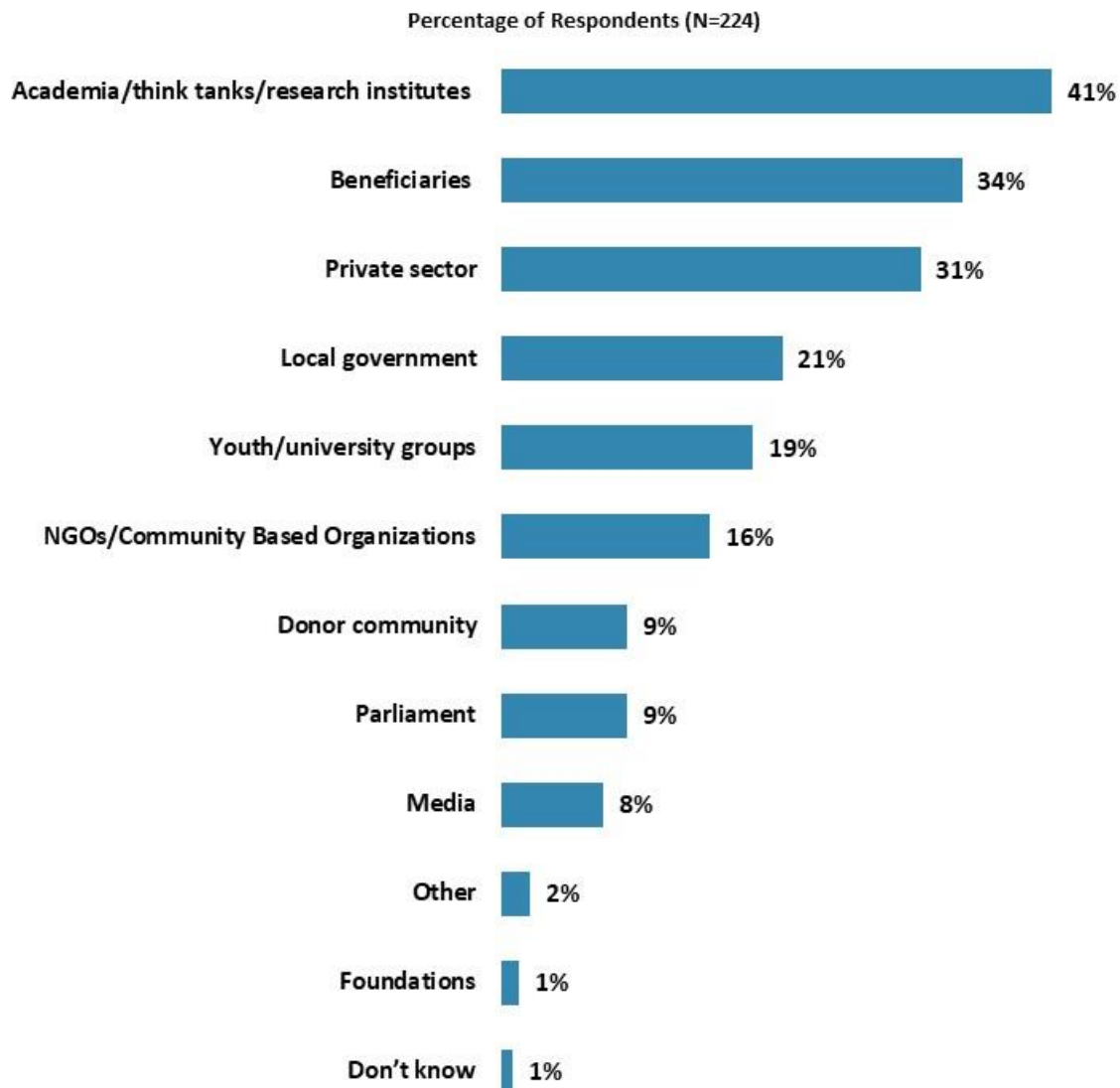

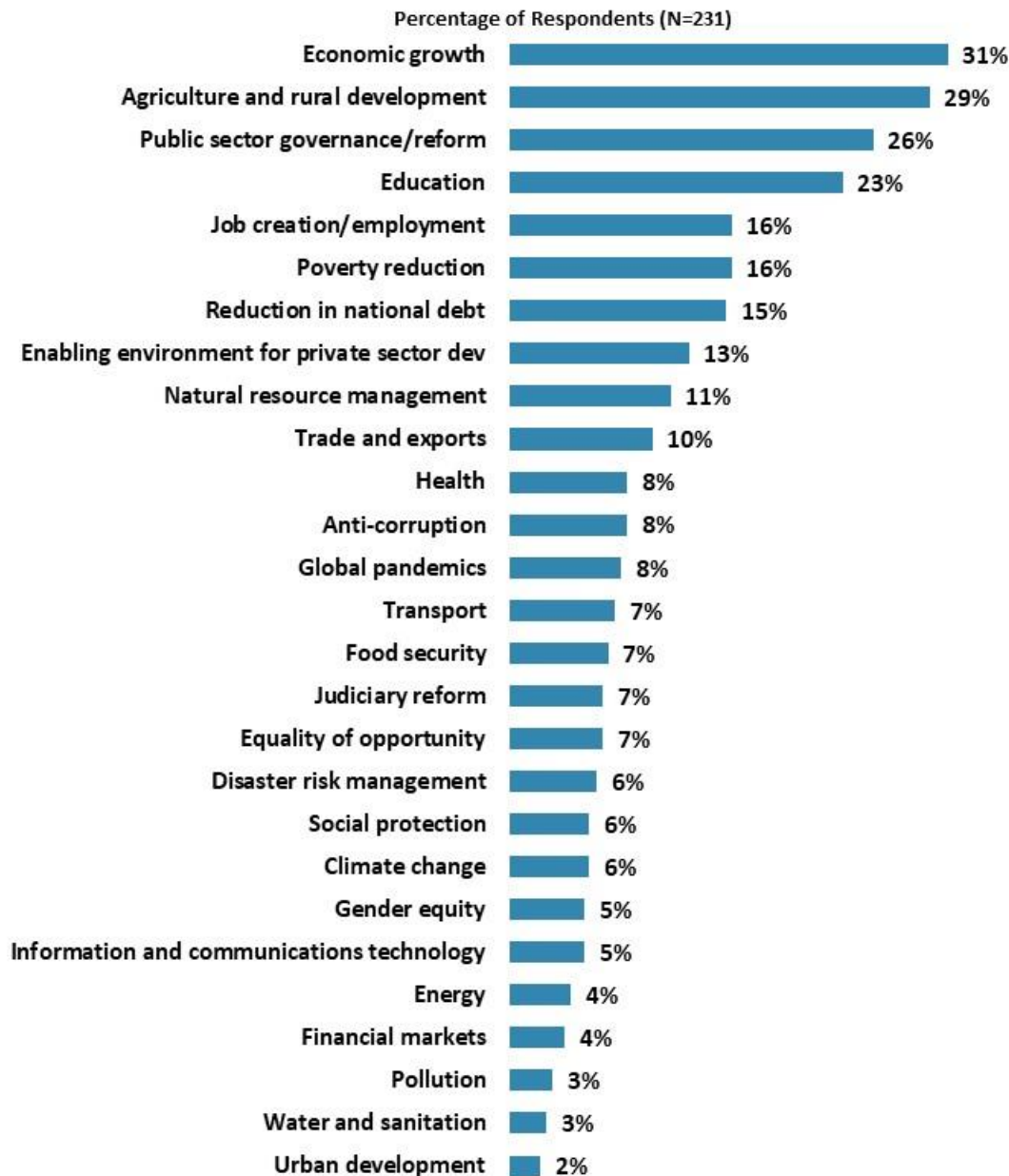

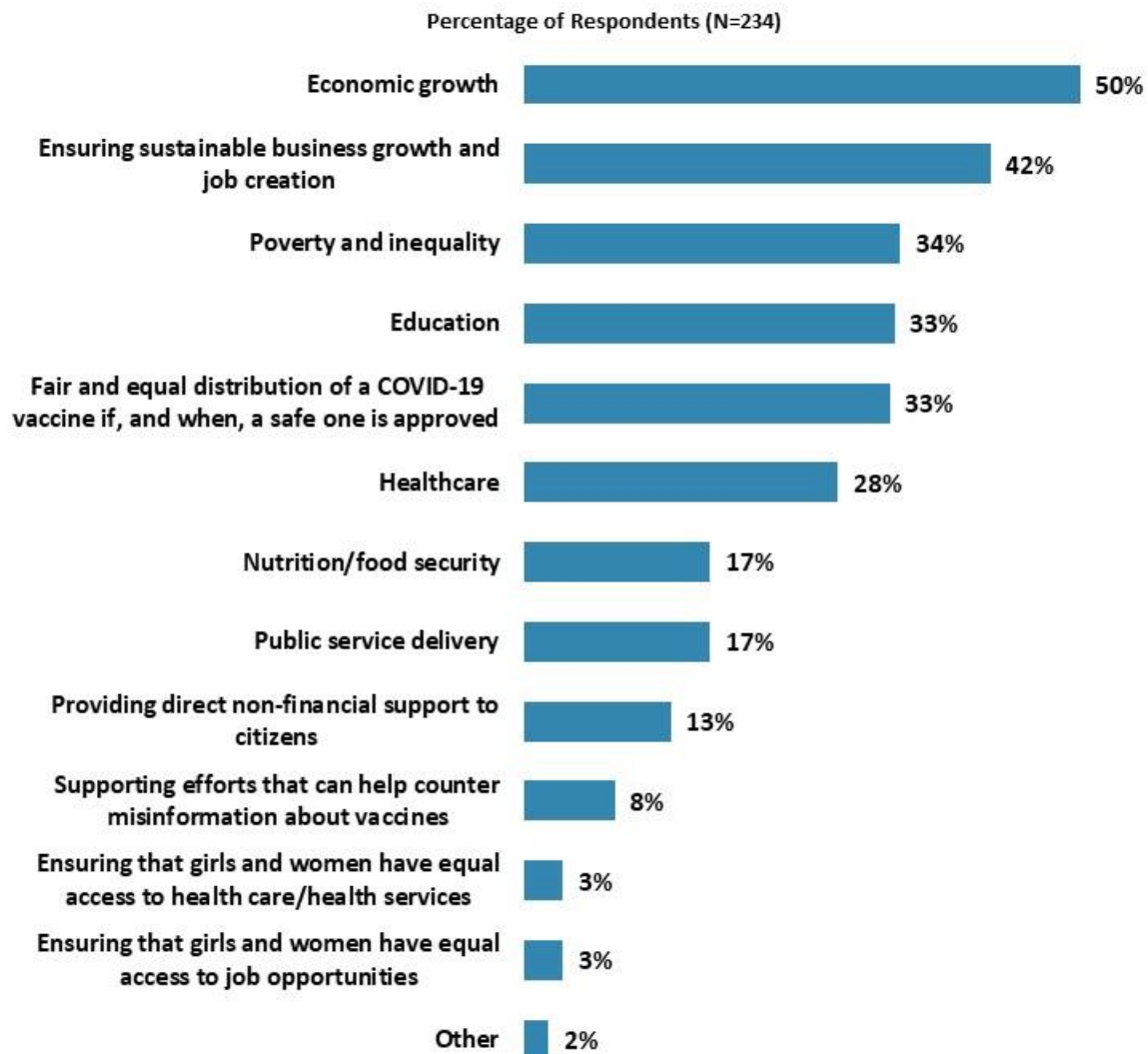

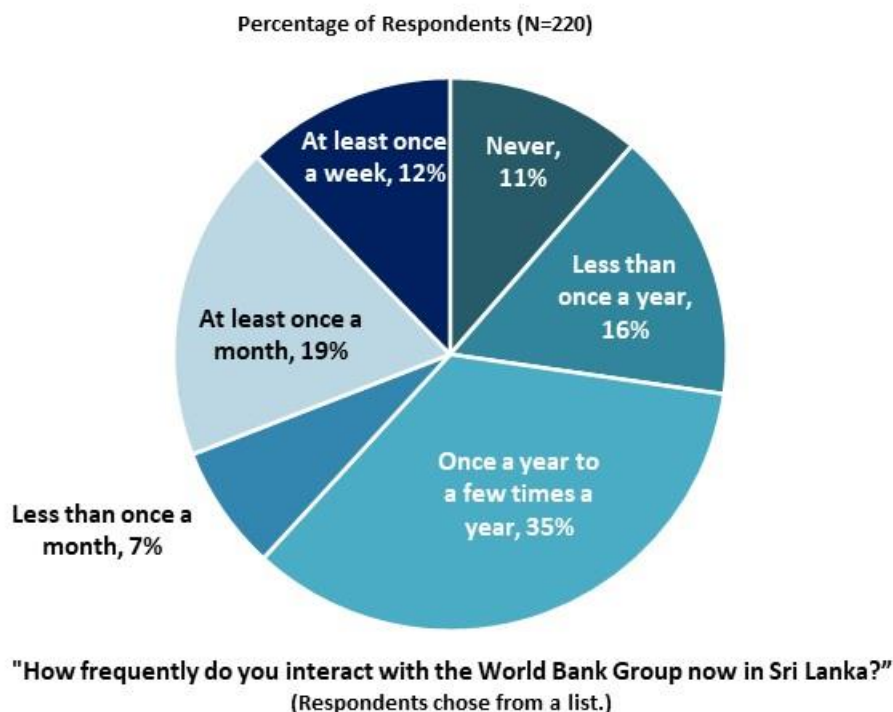

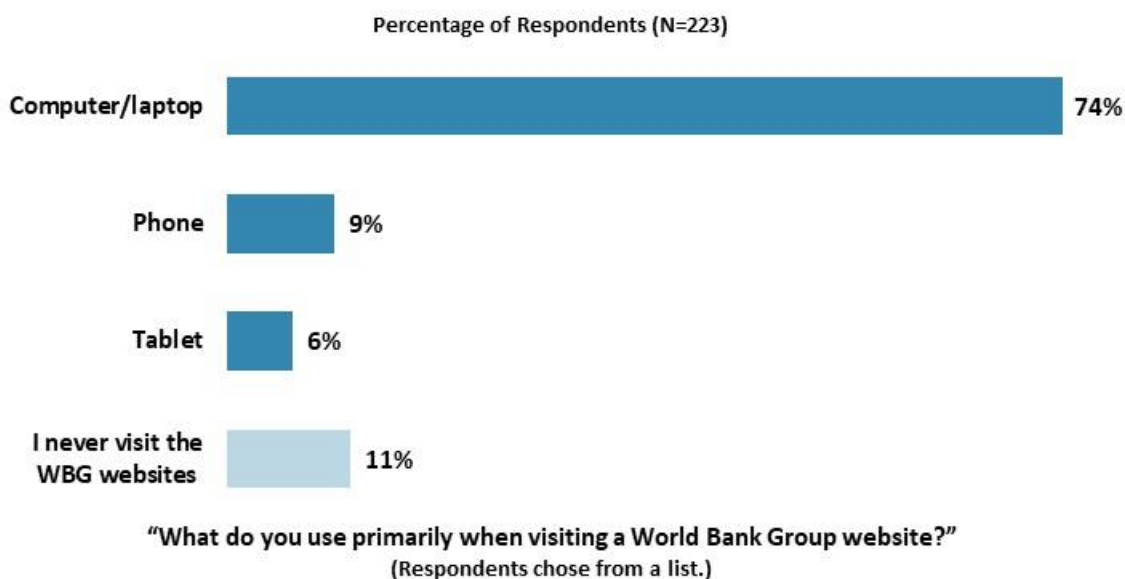

Devices used to access WBG website

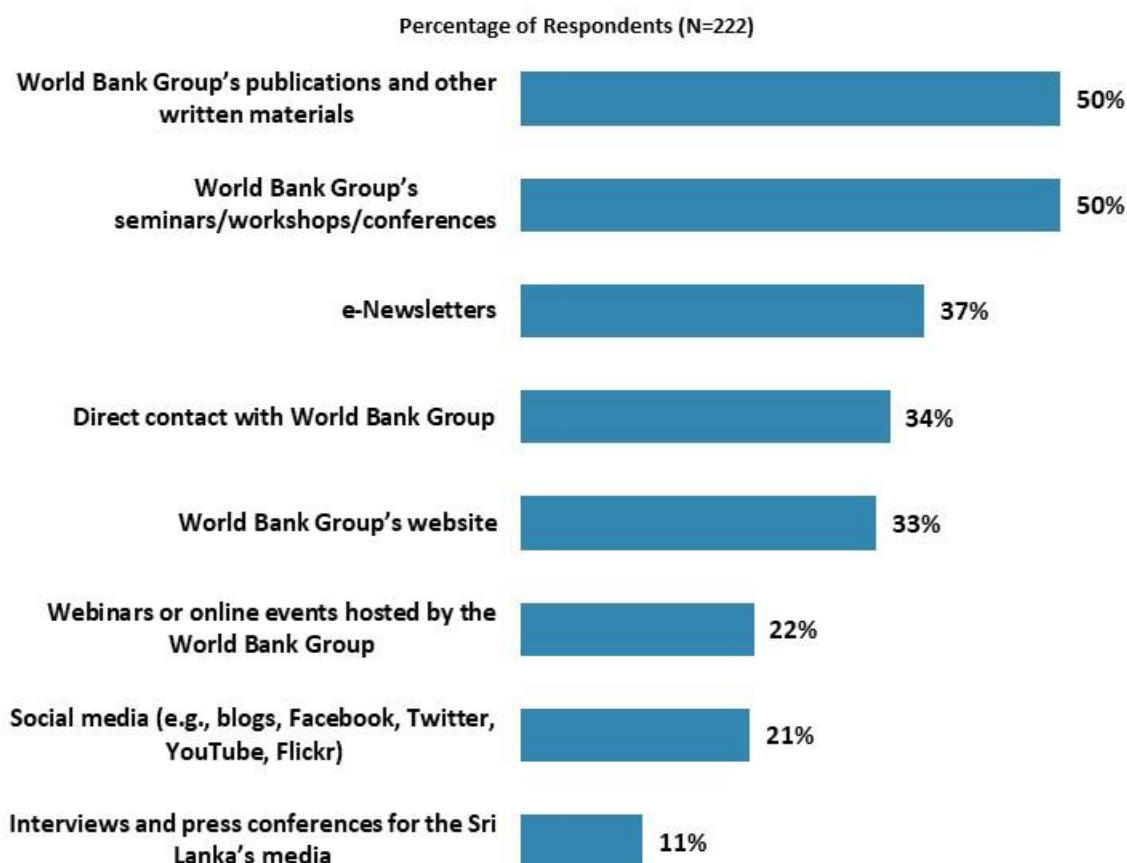

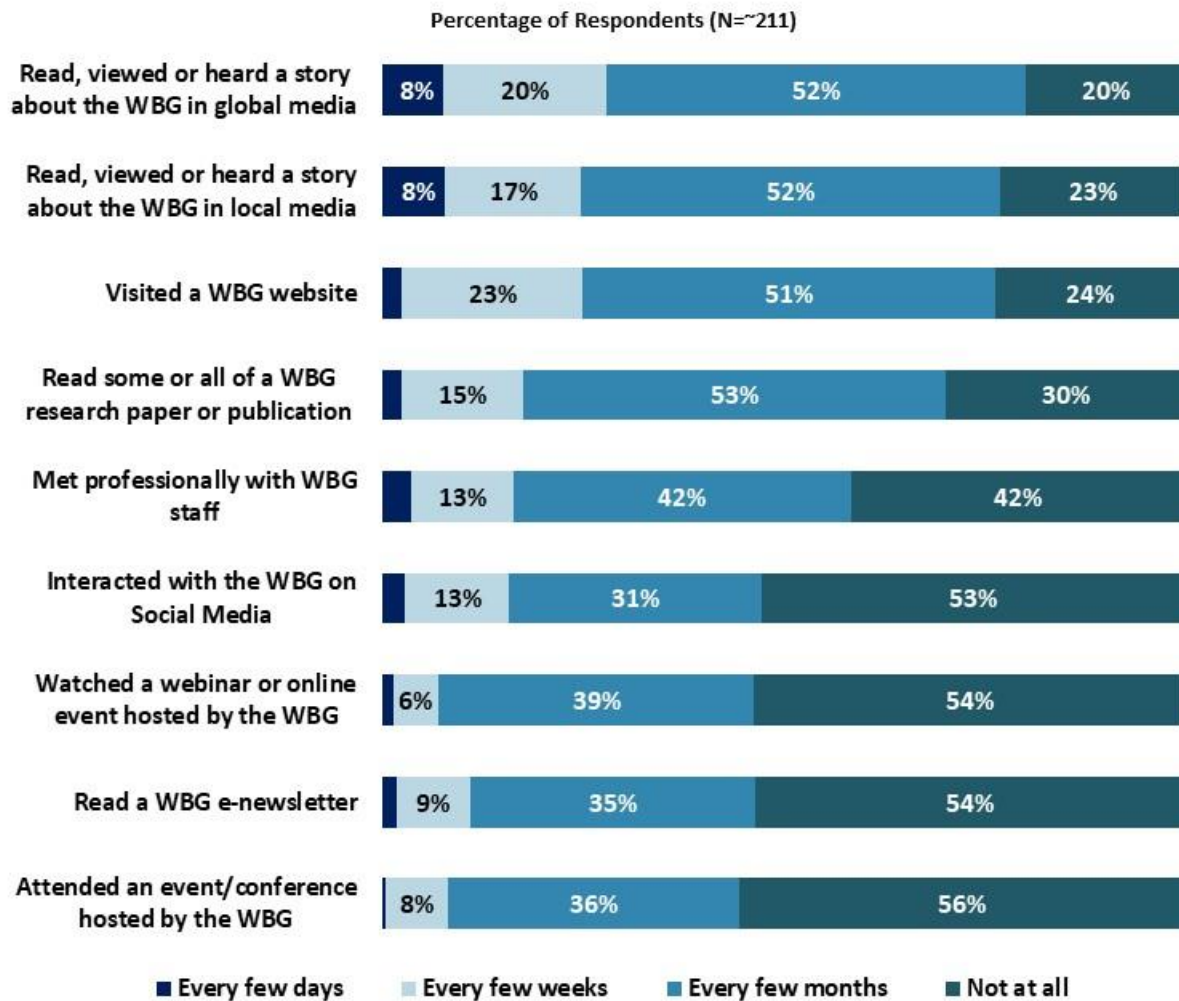


"How would you prefer to receive information from the World Bank Group?
