Objectives

This survey was designed to assist the World Bank Group (WBG) in better understanding how stakeholders in Cambodia perceive the WBG. The survey explored the following questions:

- 1. Overall Context:** How familiar are stakeholders with the WBG? How much do they trust the WBG?
- 2. Key Indicators:** What opinion do key stakeholders have of the WBG regarding its effectiveness, relevance, alignment with Cambodia's development priorities, and other key indicators? Are opinions improving or declining?
- 3. Development Priorities:** What areas of development are perceived to be the most important? Have the priorities changed over the past three years? How effective is the WBG perceived to be in these areas?
- 4. Engagement on the Ground:** How is the WBG perceived as a development partner in Cambodia? Are opinions improving or declining?
- 5. Financial Instruments and Knowledge Work:** What do key stakeholders value the most regarding the WBG's work in Cambodia? What opinion do key stakeholders have of WBG financial instruments and knowledge products? Are opinions improving or declining? What are stakeholders' suggestions for improving WBG's effectiveness?
- 6. Communication and Outreach:** What are the preferred communication channels? Are there differences among stakeholder groups in terms of preferred channels?
- 7. Message Recall:** What key topics that the WBG communicates do stakeholders recall? Is there a relationship between message recall and views of the WBG's work?



Methodology Overview

■ Fielded February – April 2024

- 410 potential participants were asked to complete a mostly quantitative survey
- Respondents completed the questionnaire online and on paper
- List of names provided by the WBG country team and supplemented by the fielding agency
- Process managed on the ground by the fielding agency


■ 185 participants (45% response rate)

- 79% from Phnom Penh
- 56% currently collaborate with the WBG

■ Compared to FY21 Country Survey

- 147 participants (44% response rate)
- Respondents completed the questionnaire online and on paper
- 42% collaborated with the WBG



Stakeholders Most Familiar with the UN, ADB, and WBG

- Respondents in this year's Country Survey were asked to indicate their familiarity with the work of several international organizations and the World Bank Group (WBG). Of these organizations, respondents in Cambodia indicated the highest levels of familiarity with the work of the United Nations, followed by the Asian Development Bank (ADB) and the World Bank Group. Respondents were least familiar with the work of the International Monetary Fund (IMF) and Asian Infrastructure Investment Bank (AIIB).
- Respondents' familiarity with the WBG in this year's survey was significantly higher than in FY21.



Increased Familiarity with the World Bank Group


- Comparison of FY21 and FY24:** Respondents in this year's Country Survey reported significantly higher levels of familiarity with the World Bank compared to respondents in the FY21 Survey:

Mean familiarity: **FY24 = 6.7**
 FY21 = 5.8

- Collaboration with the WBG:** Respondents who indicated that they collaborate with the WBG reported significantly higher levels of familiarity with the institution's work:

Mean familiarity: **Collaborate with WBG = 7.9**
 Do not collaborate = 5.3

- Stakeholders:** Respondents from the private sector indicated relatively higher familiarity with the WBG than respondents from other groups, though it is not statistically significant.



Government Institutions included respondents from the Office of the Prime Minister, Minister, and Government Institutions.
Broader Civil Society included respondents from civil society organizations, academia/research centers, and the media.




The WBG is Among the Most Trusted Institutions in Cambodia

Respondents in Cambodia gave the highest trust ratings for **the United Nations, bilateral organizations, and the World Bank Group**. Trust ratings in many institutions were significantly higher in FY24 compared to the FY21 survey.

According to respondents this year, **the media, the private sector, and the parliament / legislative branch** were among the least trusted institutions.

- Of note, respondents from the private sector and subnational government reported significantly higher trust ratings in the WBG (mean = 8.3, 8.1, respectively) than respondents from other groups.




In your opinion, what is the most important thing the WBG could do to help increase its effectiveness in Cambodia? (N=182)

WBG's Influence and Effectiveness Significantly Improved

In FY24, respondents gave the highest ratings for the WBG's **relevance** to development in Cambodia. The ratings for WBG's positive **influence** on shaping development policy in Cambodia and its **effectiveness** in helping Cambodia achieve development results have been significantly improved compared to FY21.

Although the ratings were relatively lower, respondents still expressed modest to positive views about the World Bank Group's work **helping end extreme poverty** in Cambodia.



Stakeholders from the Private Sector Have More Positive Perceptions of WBG


Comparisons of key performance indicators ratings between stakeholder groups show that respondents from **the private sector** gave higher ratings across all KPIs. In contrast, respondents from **bilateral/multilateral agencies** and **broader civil society organizations** had lower ratings. This difference was significant in trust, effectiveness, and influence ratings.



Familiarity Leads to More Positive Perceptions

Comparing key performance indicators ratings among respondents highly familiar with the WBG (ratings of 8-10 on a 10-point scale) and those with little familiarity with the WBG (ratings of 1-4 on a 10-point scale), one can see that the more familiar stakeholders are with the WBG, the more positive perceptions they have of the WBG and its work.

Meaningful engagement and outreach can continue to increase positive perceptions.

■ High Familiarity (8-10) ■ Some Familiarity (5-7) ■ Low Familiarity (1-4)



Cambodia's Key Performance Indicators are Higher than those of East Asia and Pacific countries and IDA Countries Surveyed in FY23



Aggregated Performance Indicators

Respondents from subnational governments had the highest mean rating across the aggregated responses to the nineteen COS indicator questions, whereas respondents from bilateral/multilateral agencies had significantly lower ratings.

- **Collaboration with the WBG:** Respondents who indicated that they collaborated with the WBG reported significantly higher ratings across the aggregated indicator questions than respondents who did not collaborate with the WBG.

Mean rating: **Collaborate with WBG = 7.6**

Development Areas for WBG Focus

In FY24, **education**, **jobs**, and **agriculture/food security** were the top areas where stakeholders would like the WBG to focus its resources.


While the top areas were similar to the FY21 findings, **climate change** and **social protection / social inclusion** were of much greater priority in FY24. The perceived importance of WBG focusing its resources on private sector development has decreased compared to FY21.

Of note, **macroeconomic stability** was a much higher priority to respondents from the private sector (67%), and **digital infrastructure development** was of a higher priority to respondents from the sub-national government (50%).




Effectiveness of WBG's Sectoral Support

The WBG's work on **education, water supply and sanitation infrastructure** received the highest effectiveness ratings. Of note, respondents from the subnational government had higher mean ratings in most areas compared to respondents from other groups.



The WBG is Consistently Seen as a Long-term Partner

In FY24, respondents perceived the WBG as a **long-term partner** in Cambodia. Ratings for **flexibility** have improved significantly compared to FY21; ratings for **openness**, **responsiveness to needs**, and **staff accessibility** also improved slightly, though not significantly.

Respondents from **sub-national governments** tended to be more positive compared to other respondents.


To what extent is the WBG an effective development partner in terms of the following?

The WBG is seen as Effectively Collaborating with the National Government

In FY24, respondents perceived the WBG as collaborating better with the **national government, other development partners, and civil society** compared to FY21; perceptions of the WBG’s collaboration with **the private sector** remain relatively moderate.


In addition to its partnership with the national government, the WBG should collaborate more with **sub national government** and **the private sector**.



WBG is Perceived as Effectively Monitoring and Evaluating Projects

Regarding the WBG’s financial instruments, respondents had the highest levels of agreement that the WBG **effectively monitors and evaluates the projects** it supports in Cambodia, and it has been significantly improved since FY21. Ratings for the **timeliness** of the financial support also significantly increased.

As in other questions, sub national government respondents tended to be more positive; the **private sector** respondents reported significantly higher ratings on the WBG’s effectiveness in monitoring and evaluating the projects it supports in Cambodia.









Perceptions Regarding WBG Knowledge Work Significantly Improved

Respondents had the highest levels of agreement that the WBG **brings global expertise to Cambodia**. In addition, respondents this year had significantly higher levels of agreement that the Bank's knowledge work **increases Cambodia's institutional capacity** and is **tailored** to the country's context.

- Notably, respondents from **bilateral/multilateral agencies** were significantly less likely to report they know how to find the WBG's knowledge work when they need to consult it (mean = 6.0). Since knowledge and analytical products are the Bank's most valued activity for these stakeholders (see slide 27), **more outreach to this group regarding WBG's products and how to find them is recommended.**



In your opinion, what is the most important thing the WBG could do to help increase its effectiveness in Cambodia?

It should focus on developing exclusive specially-tailored solutions for the enhancement of healthcare and education sectors in the country.”

“Cambodia is a young population country, so please have holistic program approaches to empower young people (social, political, and economic empowerment to young people) to ensure that young people are accepted as key development stakeholders of Cambodia country. They have adequate support from the government and all development partners.”

“World Bank should increase more loans to help Cambodia in the development of sectors such as infrastructure and irrigation system for the agriculture sector.”

Respond to sectoral needs by cooperating, identifying, and evaluating the situation clearly before jointly setting out a framework for cooperation.”

WBG Events and Direct Contact were Most Preferred for Receiving WBG Communication

Half of the respondents preferred receiving the Bank's communications at the WBG **events** (in person or online) and through **direct contact with staff**. Respondents from sub national government significantly preferred **direct messaging** more than the other respondents.

7 in 10 of Respondents Recalled Seeing or Hearing Information About the WBG, Most Often Through the WBG's Events or on Social Media

73% of respondents recalled seeing or hearing something about the WBG recently. Respondents who collaborated with the WBG were significantly more likely to recall something (90%), whereas respondents who did not collaborate were less likely to do so (51%).


Respondents most often reported seeing that information through the WBG's events / conferences / seminars, as well as on **social media**.



WBG Economic Forecasts was the Most Commonly Recalled Topic

Respondents most frequently recalled **WBG economic forecasts**. They also frequently recalled WBG's work or research on **climate change**, **human capital**, and **food security**.

WBG's work to or research on...




What topics were included in what you saw or heard about WBG's work or research? (Select ALL that apply)


Climate Change Communications can be More Impactful when Related to Stakeholders' Top Concerns: Food Insecurity and More Frequent and Severe Droughts

Two-thirds of respondents were very concerned about **decreased crop yields / increased food insecurity**, and **more frequent and severe droughts** as potential impacts of climate change in Cambodia. **Unsafe drinking water** and **more frequent / severe floods** were also of great concern to respondents. These key areas of concern should be considered to make communications about climate change more impactful.

Message Recall is Associated with Higher Familiarity and More Positive Perceptions of the WBG and its Work




These findings suggest that respondents who are more frequently exposed to information about the WBG or who actively engage with WBG staff and knowledge work (read research papers, etc.) are also more likely to hold more positive views about the WBG’s work.



What is the primary specialization of your work? (N=163)




Do you collaborate/work with the World Bank Group (WBG) in Cambodia? (N=181)



Respondents from government institutions were significantly more likely to indicate that they collaborate with the WBG (72%) compared to respondents from other stakeholder groups.




Which of the following WBG agencies do you collaborate/work with in Cambodia? (N=102)

Detailed Methodology

From **February 2024 to April 2024**, a total of 410 stakeholders in Cambodia and Somaliland were invited to provide their opinions on the WBG’s work by participating in a Country Opinion Survey (COS). A list of potential participants was compiled by the WBG country team and the fielding agency. Participants were drawn from the Office of the President, Prime Minister, Minister, and Parliament, government institutions, local governments, bilateral and multilateral agencies, the private sector, civil society, academia, and the media.

Of these stakeholders, **185 participated in the survey (45% response rate)**. Respondents completed the questionnaire on paper or via an online platform.

This year’s survey results were compared to the FY21 Survey, which had a response rate of 44% (N=147).

Comparing responses across Country Surveys reflects changes in attitudes over time and changes in respondent samples, methodology, and the survey instrument itself. To reduce the influence of the latter factor, only those questions with similar response scales/options were analyzed. This year’s survey saw much greater outreach to and/or response from civil society organizations and academia but a decrease from government principals and the private sector. These differences in stakeholder composition between the two years should be considered when interpreting the results of the past-year comparison analyses.

Key statistically significant findings (tested at the research standard of $p < .05$) are noted throughout the report.
