

Living in Bosnia and Herzegovina data

Structure of folders

There are two main folders:

- **Wave 1** This is the first wave data from the LSMS, but just for those who were then carried onto the second wave.
- **Wave 2** This is the second wave data.
- **Wave 3** This is the third wave data.

These folders may be sub-divided into other folders.

Wave 1

- **Panel data** This is the sub-sample of the LSMS data for the respondents who were taken through to wave 2 but reorganised into 5 different data files. The files are renamed to be consistent with the wave 2 data. The files included are:

Sub_ABHCFHH	Control form – household level (renamed version of ACFHHOLD).
Sub_ABHCFIND	Control form – individual level (renamed version of ACFIND), <u>includes weights.</u>
Sub_ABHHHPOS	Household possessions (part of module 2), a2c_45 to a2c_48 (renamed version of AHHPOS)
Sub_ABHIIND	Individual questionnaire (taken from AALLIND and AADIND), <u>includes weights.</u>
Sub_ABHIHH	Household questionnaire (renamed version of AIHHOLD)

- **Cross-sectional data (W1 LSMS)** These are the other files from the sub-sample of the LSMS which were not used in the reorganisation.

Sub_AAGLAB	Agricultural activities (not in Wave 2). Part of module 13 – a13_c4 – hiring of labour, by work code.
Sub_AAGMACH	Agricultural activities (not in Wave 2). Part of module 13 – a13_c5 – hiring of machinery, by type of work code.
Sub_AANFEED	Animal feed - a13_d2 – by feed code.
Sub_AANFP	Gift item, use, value – a11c2 (not in Wave 2). By gift code.
Sub_ACROPS	Agricultural activities (not in Wave 2). Part of module 13: a13_b2 and a13_c1, by crop code.
Sub_AFARMCAP	Agricultural activities (not in Wave 2). Part of module 13: a13_e. Farm capital assets.
Sub_AFERTUSE	Agricultural activities (not in Wave 2). Part of module 13: a13_c2. Fertiliser use.
Sub_AFOODC1	Food consumption (not in Wave 2), a11b1, by food code.

Sub_AFODC2	Food consumption (not in Wave 2), a11b2, by food code.
Sub_AFORUSE	Agricultural activities (not in Wave 2). Part of module 13: a13_b1.
Sub_AFUELUSE	Agricultural activities (not in Wave 2). Part of module 13: a13_c3. By fuel code.
Sub_AHHBUS	Non-agricultural business or activities (not in Wave 2). Module 12.
Sub_ALANDOWN	Agricultural activities (not in Wave 2): a13_2, renting out plots, by plot.
Sub_ALANDUSE	Agricultural activities (not in Wave 2): a13_1, cultivating plots, by plot.
Sub_ALSTOCK	Agricultural activities (not in Wave 2): a13_d, livestock, by animal code.

Wave 2

BBHCFIND	Control form. Individual information. Reasons for joining household. Household relationships. <u>Includes weights.</u>
BBHHHPOS	Household possessions (b2_49 to b2_52)
BBHIIHH	Household questionnaire (module 2).
BBHIIND	Individual questionnaire (modules 1, 3, 4, 5, 7, 8, 9, 10). <u>Includes weights.</u>
BBHJHIST	Individual job history – by spell (module 6).

CBHIIND	Individual questionnaire (modules 1, 3, 4, 5, 7, 8, 9, 10). <u>Includes weights at BiH level only.</u>
CBHJHIST	Individual job history – by spell (module 6).
