

Labour Force Survey

September 2003

The Labour Force Survey 2003:2 data is in five files. The files are flat, ASCII, fixed field files, with one line of given length per record. This format was chosen so as to make the data usable with as many statistical programs as possible, and thus accessible to as wide a range of people as possible.

Other important information for users is found in the: Questionnaire Additional code lists (occupation, industry, place names) Relevant publications Web-site (http://www.statssa.gov.za/)

THE DATA FILES

The files and the corresponding sections of the questionnaire are as follows: **PERSON**: Data from Flap and Section 1 **WORKER**: Data from Sections 1,2, 3, 4 and 5 **MIGRANT**: Data from Section 6 **HOUSE**: Data from section 1 and 7 **STRATUM_ PSU**: Stratum and PSU numbers

The files also contain some derived variables.

The information in each file contains the following:

- Nature of records in the file and population covered
- Description of variables

Description of variables

The description of the variables comprises the following information:

Descriptive name: This is a short English description plus the variable name in the original file used by Stats SA to construct the ASCII file.

Position of the variable: The position of the data within the record, recorded in the format (@xxx y.). "@xxx" indicates that the data begins at position (i.e. column) xxx and "y." indicates that it is y digits wide. All data is numeric. All data is right-justified.

Source: This is either the question in the questionnaire or, for derived variables, the method of derivation. Derived variables are usually found towards the end of a record.

Valid range: The range of valid values for the variable. For continuous variables this reflects the upper and lower limits as found in the data.

Not applicable: The code for not applicable is provided for each variable. These are now numeric.

Missing value: A code for "missing"/unspecified values is given for each variable.

Notes: Specific observations to be noted by users.

Most questions in the Labour Force Survey questionnaire are pre-coded, i.e. there is a set number of choices from which one or more must be selected. For open-ended 'write-in' questions, the description will note that post-coding occurred and explain how this was done. Most variables have been pre-coded from the questionnaire and is not repeated in the variable description. Where the coding is not apparent, the description either provides the codes or indicates where code lists are to be found.

Linking files

The data from different files can be linked on the basis of a record identifier. The record identifier is the first field/s in each file. Each record contains a number (UqNr) which constitutes a unique household identifier. All records with a given household identifier, no matter which file they are in, belong to the same household. For individuals, a further two digits constitute the Person number (PersonNr). When these are added to the household identifier, a unique individual identifier is created. Again, these can be used to link records from the PERSON and WORKER files. The syntax needed to merge information from different files will differ according to the statistical package used.

METHODOLOGY

Sample design

Social Statistics Component uses two-stage complex sampling. The first stage involves the selection of PSU per province per stratum with Probability Proportional to Size (PPS). From every PSU several clusters of ten dwelling units can be formed with Systematic Sampling but only one cluster is drawn per survey. We use the same PSUs constituting the Master Sample for all our Labour Force Survey (LFS) and related surveys. To deal with the problem of respondent fatigue we use a rotating panel. For each survey 20% of the clusters from previous survey is rotated, i.e. a different set of dwelling unit clusters is drawn. For the remaining 80% of PSUs the same clusters of dwelling units are drawn.

Rotational panel survey is a combination of cross-sectional and longitudinal studies. Cross-sectional study is about a group of elements at some point in time and longitudinal study is about the same group of elements over time usually to study the changes in the circumstances of the elements over time.

It is important after sampling weight adjustment to check that the weights are consistent with the Master Sample estimates. There is an inherent inconsistency between Master Sample update and Population Census 1996. When the Master Sample's PSU size is updated, it is in terms of dwelling units but the Population Census 1996 PSU size is in terms of households. When we sample, we sample dwelling units per PSU but in the field we enumerate all the households in the selected dwelling units. In the case of multiple households, the number of enumerated units is more than the number

of sampled units. The dwelling unit inclusion probability is given as $P_1 = \frac{n_{SS}}{T_{PSU}}$ where n_{SS} is the dwelling unit sample

size per PSU and T_{PSU} is the number of dwelling units per PSU according to the Master Sample information at some point in time. This procedure is called systematic sampling. The PSU inclusion probability is $P_2 = n_{PSU} \frac{N_{PSU}}{N_{QU}}$ where

 n_{PSU} is the PSU sample size per stratum, N_{PSU} is the number of households in the selected PSU, and N_{Strat} is the number of households in the selected stratum. This procedure is called Probability Proportional to Size (PPS_SYS). The sampling weight is given by $W = \frac{1}{PP_2}$

Weights

During field operations of every survey, some of the sampled elements do not respond as expected. Non-response can take different forms like non-contact, refusal, unreliable information, sampling error, etc. This kind of non-response is termed unit non-response. Sometimes respondents do not respond to all the questions. This kind of non-response is termed item non-response. These kinds of responses have negative effects on the estimates, thus it is necessary to account for them. For unit non-response, we adjust the sampling weights and for item non-response we impute the missing values. Before we can do any re-weighting, we must have a clear understanding of the sampling procedure. The sampling procedure is a two-stage complex sample. The first stage is the selection of PSUs from the Master Sample with probability proportional to size. The Master Sample is based on the 1996 Population Census list of EAs and the measure of size is the number of households per PSU. The second stage involves the systematic selection of 10 dwelling units from each of the selected PSUs. The Master Sample is stratified into 18 strata, i.e. 9 province and 2 area type per province.

From the survey data we calculate:

The number responding PSUs per stratum and call it n_{PSU} ,

The number of responding households and call it n_{HH}

From the sample frame or Master Sample we need:

Number of households per responding PSU and call it h_{PSU}

Updated number of households per responding PSU and call it h_{UPDATE}

Number of household per stratum and call it h_{STRAT}

We then calculated the adjusted PSU selection probability according to probability proportional to size as

 $P_{PSU} = n_{PSU} \frac{h_{PSU}}{h_{STRAT}}$, and the household selection probability according to systematic sampling as $P_{HH} = \frac{n_{HH}}{h_{UPDATE}}$

The adjusted weight is given by $W_{ADJ} = \frac{1}{P_{PSI}P_{HH}}$

The adjusted weight is then post-stratified by age, gender, and age group using the SAS macro CALMAR.

Estimation and use of standard errors

The published results of the Labour Force Survey are based on representative probability samples drawn from the South African population, as discussed in the section on sample design. Consequently, all estimates are subject to sampling variability. This means that the sample estimates may differ from the population figures that would have been produced if the entire South African population had been included in the survey. The measure usually used to indicate the probable difference between a sample estimate and the corresponding population figure is the *standard error (SE)*, which measures the extent to which an estimate might have varied by chance because only a sample of the population was included.

There are two major factors which influence the value of a standard error. The first factor is the sample size. Generally speaking, the larger the sample size, the more precise the estimate and the smaller the standard error. Consequently, in a national household survey such as the LFS, one expects more precise estimates at the national level than at the provincial level due to the larger sample size involved. The second factor is the variability between households of the parameter of the population being estimated, for example, the number of unemployed persons in the household.

Example below can be used in determining standard errors of unemployed and unemployment rates. Given the size of the estimate and the population parameter under consideration, an approximate value of the relative standard error of the estimate can be obtained (read off) from the relevant graph. Multiplication of this approximate value of the relative standard error with the estimate itself gives an approximate value of the SE of the estimate, viz.

(1) SE(estimate) = CV(estimate) x estimate

The formula in this form, however, is not applicable to ratio estimates, such as the unemployment rate, and has to be changed to:

(2) SE(ratio estimate) = CV(ratio estimate) x (numerator of ratio estimate)

For example:

(3) SE(Unemployment rate) = CV(Unemployment rate) x (est. no. of unemployed persons)

Note that there are different graphs to be used for the different population parameters for obtaining the CV estimate.

The 95% confidence intervals of a population parameter can be obtained as follows:

lower 95% *confidence limit of a population parameter* = *estimate* - 1.96**SE(estimate)*

and


upper 95% confidence limit of a population parameter = estimate + 1.96*SE(estimate).

The *confidence coefficient*, i.e. 95%, of a 95% confidence interval of a population parameter could be interpreted as the success rate of the calculated confidence interval, viz.

{*estimate* - 1.96*SE(*estimate*); *estimate* + 1.96*SE(*estimate*)}

to include or to contain the value of the population parameter.

Example: Calculating the standard error of the unemployed according to the official definition



The estimated number of unemployed is 4 570 000. Mark this on the graph and read off the corresponding coefficient of variation. In this case it is 0,021 on the curve for the unemployed. The standard error of the unemployed is approximately therefore $0,021 \times 4570\ 000 = 95\ 970$.

DEFINITIONS OF TERMS

A *household* consists of a single person or a group of people who live together for at least four nights a week, who eat together and who share resources.

A *dwelling unit* is any structure or part of a structure or group of structures occupied by one or more than one household; or which is vacant or under construction but could be lived in at the time of the survey. The dwelling unit is the major listing unit for this survey. However, if multiple households are identified during listing, then each household is listed separately. But the listing unit is not primarily households, as multiple households are sometimes discovered at the time of the survey. In workers hostels, (1) where rooms are occupied by individual persons/households, then each room is treated as

a dwelling unit, and (2) in the case of dormitories/communal rooms, each bed is listed separately and treated as a dwelling unit. It is important to note that the dwelling unit as defined here was also the selection unit for our sample.

Population group describes the racial classification of a particular group of South African citizens. The previous government used legislation to impose this type of classification, to divide the South African population into distinct groupings on which to base apartheid policies. For quite a different reason it remains important for Stats SA to continue to use this classification wherever possible. It clearly indicates the effects of discrimination of the past, and permits monitoring of policies to alleviate discrimination. Note that, in the past, population group was based on a legal definition, but it is now based on self-perceptions and self-classification. An *African/black* person is someone who classifies him/herself as such. The same applies to a *coloured, Indian/Asian or white* person.

A hostel is a communal living quarter for workers, provided by a public organisation such as a local authority, or a private organisation such as a mining company. These were residential dormitories established for migrant workers during the apartheid era, and they continue to house people working in certain industries, such as the mining industry.

Institutions are communal temporary, semi-permanent or permanent living arrangements for people in special circumstances, for example prisons, police cells, school boarding facilities, homes for the aged or the disabled, hotels and hospitals.

The working age population includes all those aged between 15 and 65 years.

The economically active population consists of both those who are employed and those who are unemployed.

The *employed* are those who performed work for pay, profit or family gain in the seven days prior to the survey interview, or who were absent from work during these seven days, but did have some form of paid work during this time.

The official unemployment rate: The unemployed are those people within the economically active population who:

(a) did not work during the seven days prior to the interview, (b) want to work and are available to start work within a week of the interview, and (c) have taken active steps to work or to start some form of self-employment in the four weeks prior to the interview.

The expanded unemployment rate: Same conditions as the official but exclude criterion (c).

The people who are *out of the labour market* or who are *not economically active* are those who are not available for work. This category includes full-time scholars and students, full-time homemakers, those who are retired, and those who are unable or unwilling to work.

The formal sector includes all businesses that are registered in any way.

The informal sector consists of those businesses that are not registered in any way. They are generally small in nature, and are seldom run from business premises. Instead, they are run from homes, street pavements or other informal arrangements.

Primary industries include agriculture, forestry and fishing, and mining and quarrying.

Secondary industries include manufacturing, electricity and other utilities, and construction.

Tertiary industries include trade, transport, financial and business services, and social, personal and community services.

Employment status refers to whether or not the person is self-employed, or works as an employee, or both.

Location refers to whether the person lives in an urban or non-urban area.

• An *urban* area is one that was legally proclaimed as being urban prior to the redemarcation of municipalities. Such areas are towns, cities and metropolitan areas.

• All other areas are classified as *non-urban*, including commercial farms, small settlements, rural villages and other areas, which are further away from towns and cities.

(This definition is currently under review, but applies to this survey as the sample was drawn according to Census 1996 classification.)

Workers include the self-employed, employers and employees.

Labour market dynamics refer to movement into and out of the labour market, and into and out of actual employment, over a specified time period.

The instruction in this question is to end the interview for those who have answered "No" in this question. It is through this question where household members are identified within the selected dwelling.

Note to users

This question is asked for each person found in the selected dwelling. It seeks to find out if the household members who are present in the household during the survey were also present during the survey conducted in September 2002. It is through this question that permanent household members are identified within the selected dwelling.

This question is asked to find out the age of the household members. This is asked for each member of the household. The instruction is to write the years in whole numbers and not in words. Moreover, these years must be completed, thus if a person is two years and six months, the instruction is to write the two completed years. For those children who are less than a year, the instruction is to write 00.

This question is asked to determine the population group of persons from the selected dwelling. The respondent must answer for each member without any assumptions. In this instance the enumerator is also instructed not to make any conclusions, which may be influenced by his observation or using people's names during the interview. This question may seem very sensitive to some respondents especially in this post apartheid era, but it is really important to find out the composition of the South African population.


DATA FILE: STRATUM_ PSU

The LFS' is based on a multistage stratified cluster sample (i.e. complex samples). The sampling population is first stratified into explicit strata, then pre-specified numbers of primary sampling units (i.e. PSU's) are drawn in the strata, whereupon a fixed number of households are drawn in each drawn PSU's. The consequence of this is that statistical techniques of analysis based on a simple random sample design will give liberal (i.e. too significant) results. This is the case with most generally available statistical software packages. However, dedicate software is available which takes the complexity of the of the sample design into consideration and which requires stratum and PSU numbers. The STRATUM_PSU data file is supplied for this type of analysis and can be merged with any of the other three data files i.e. PERSON, WORKER and HOUSE by the variable unique number (UqNr), position 1 to 13.


